### [57] CLAIM

The ornamental design for a tool tote bucket, as shown and described.

FIG. 1 is a front elevational of the tool tote bucket showing our new design;

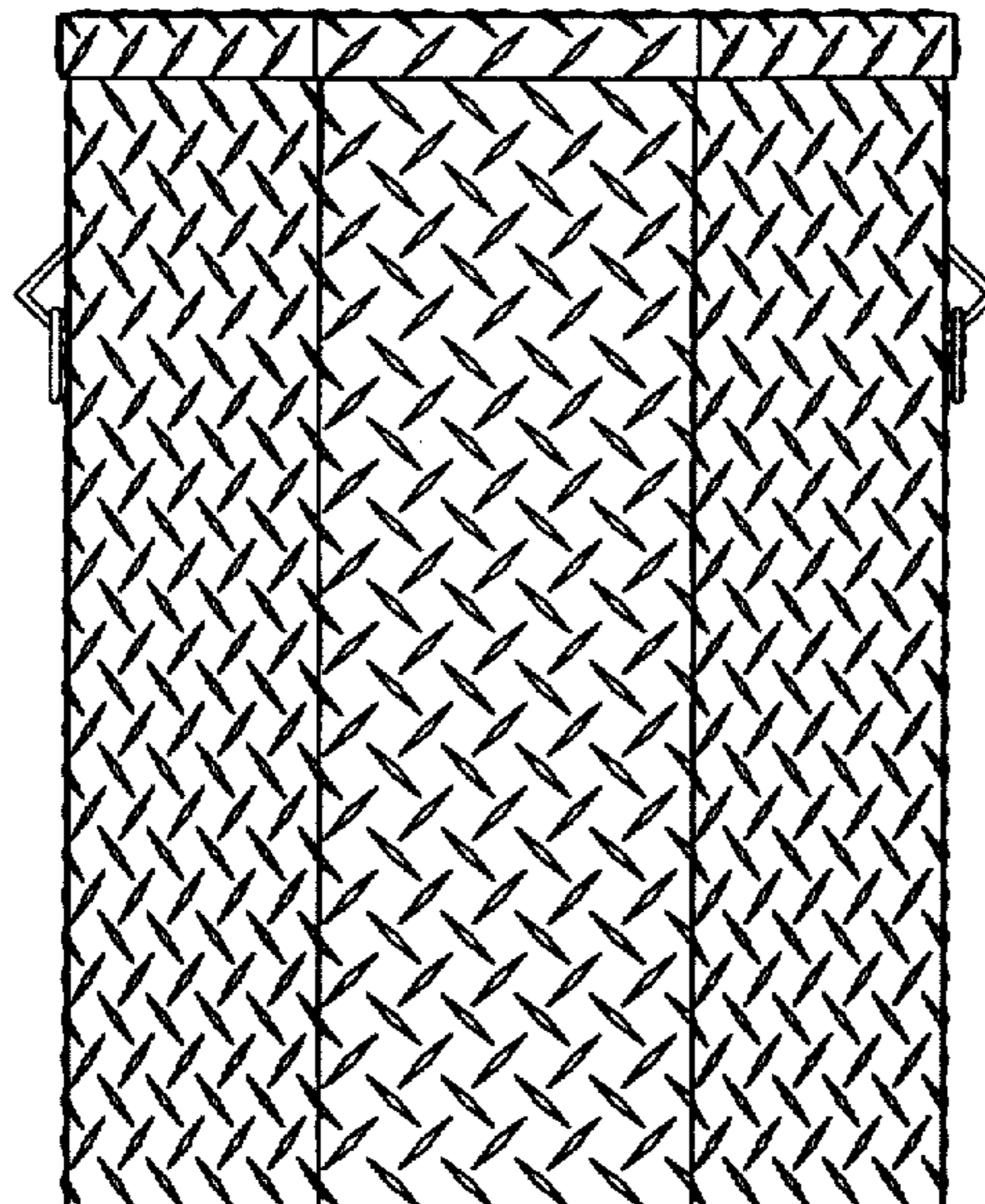

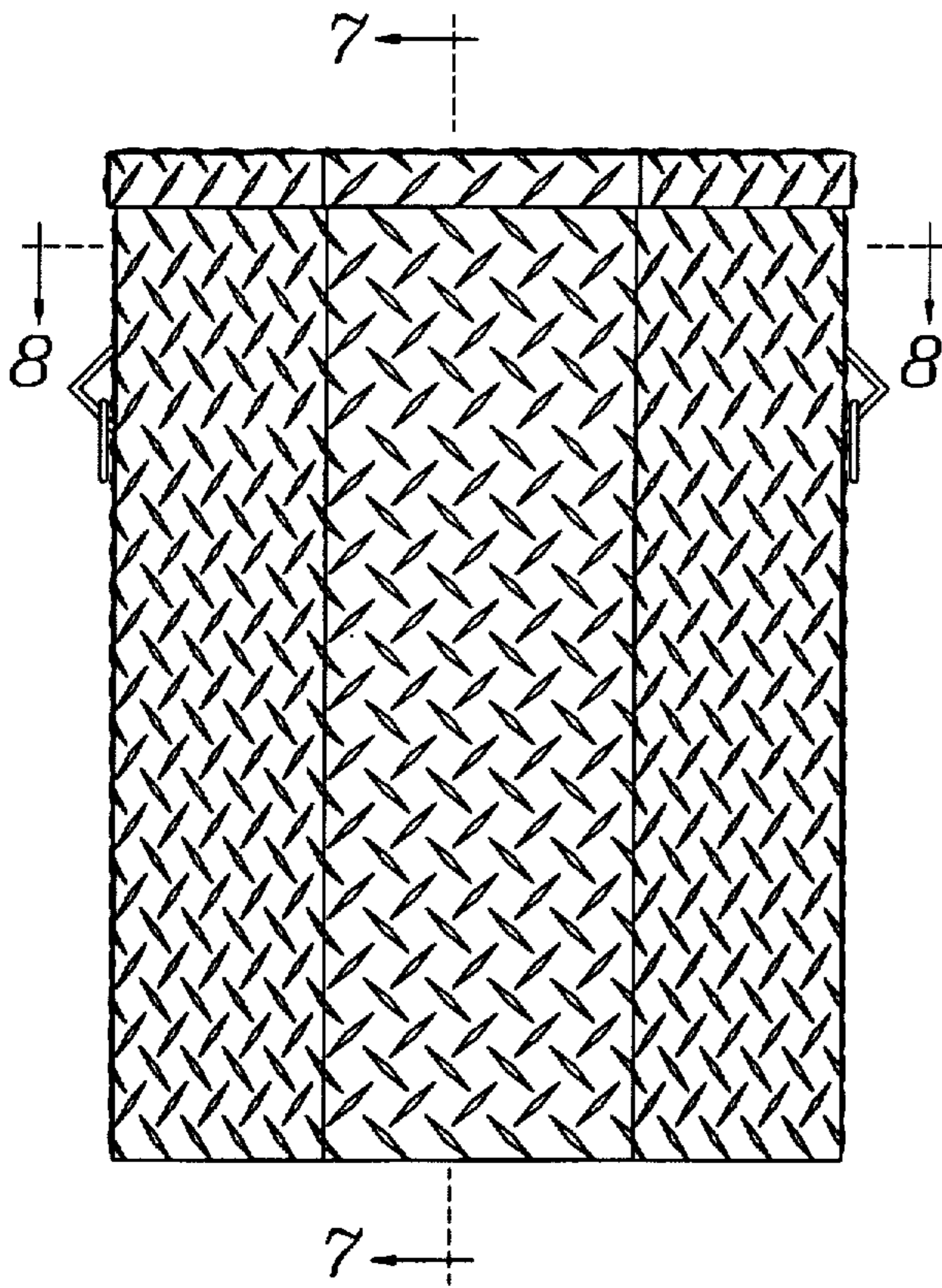

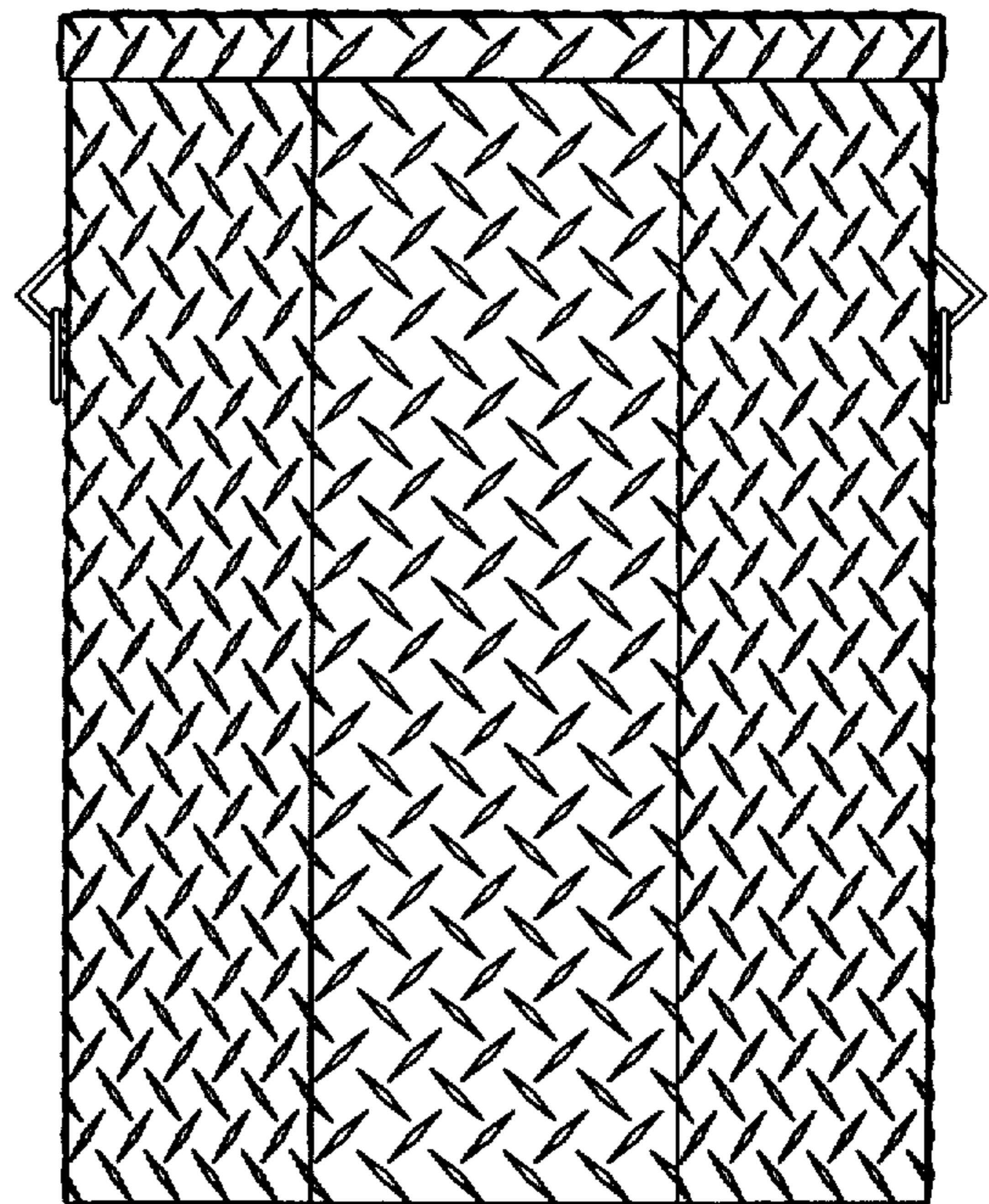

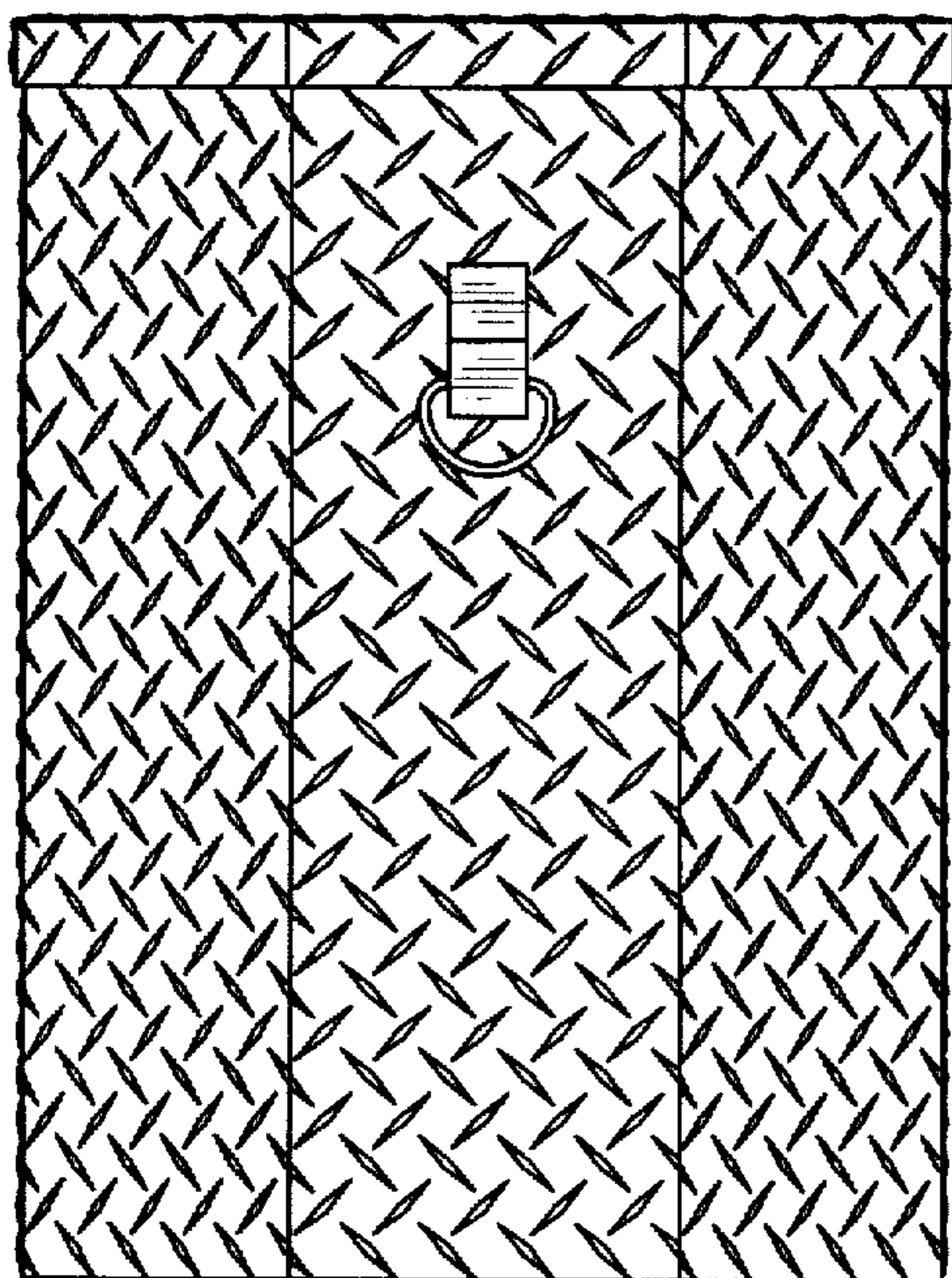

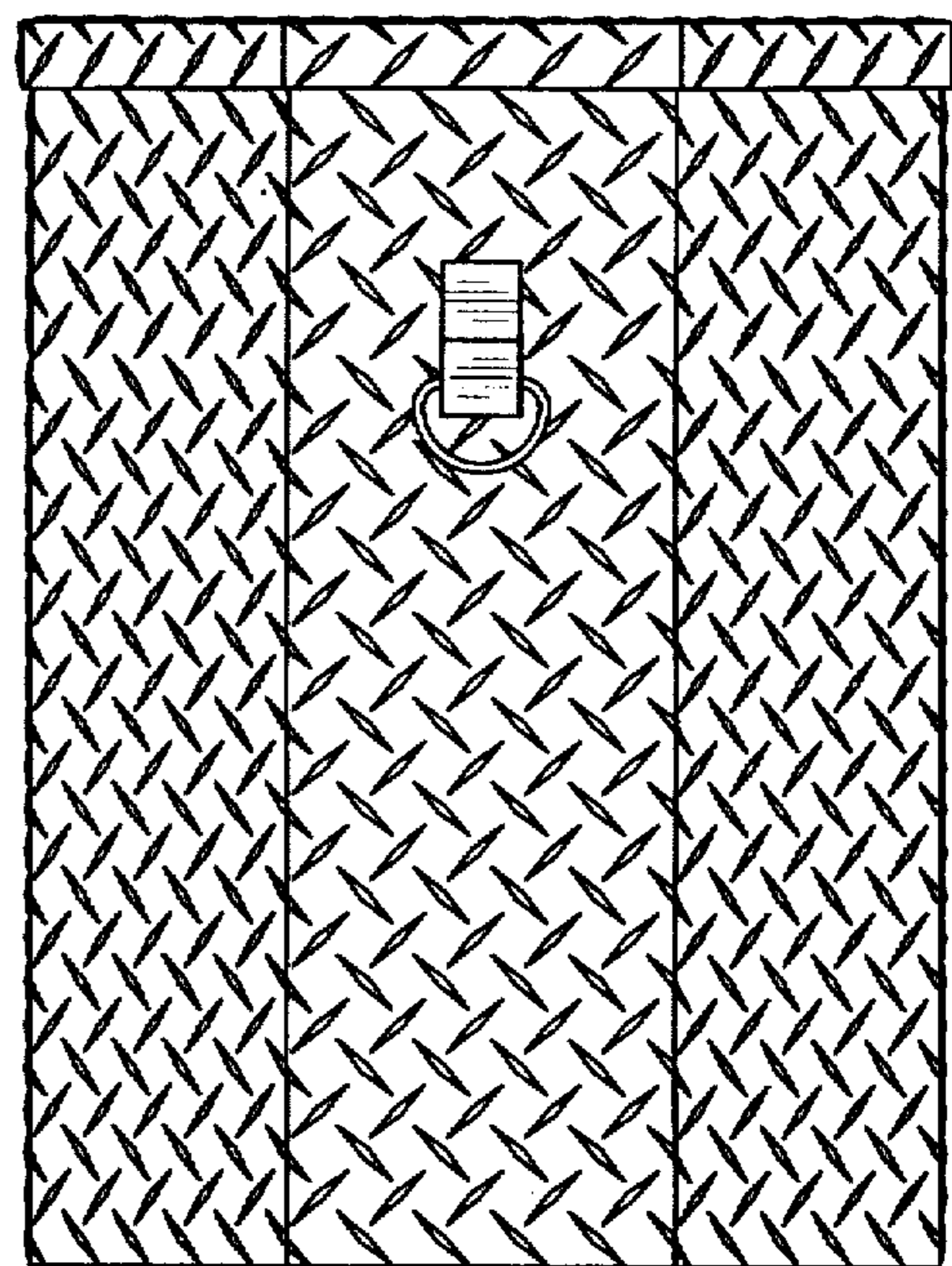

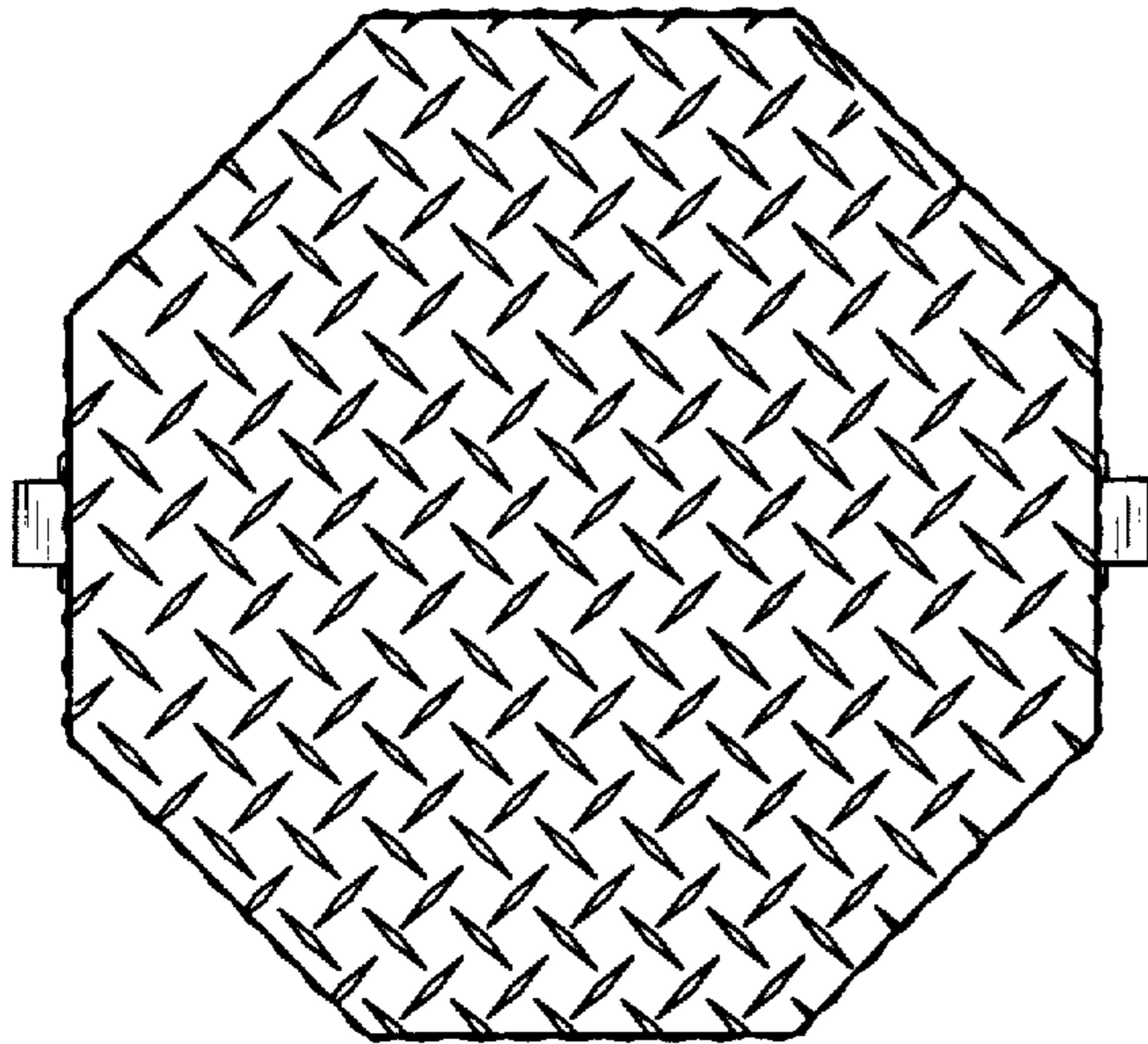

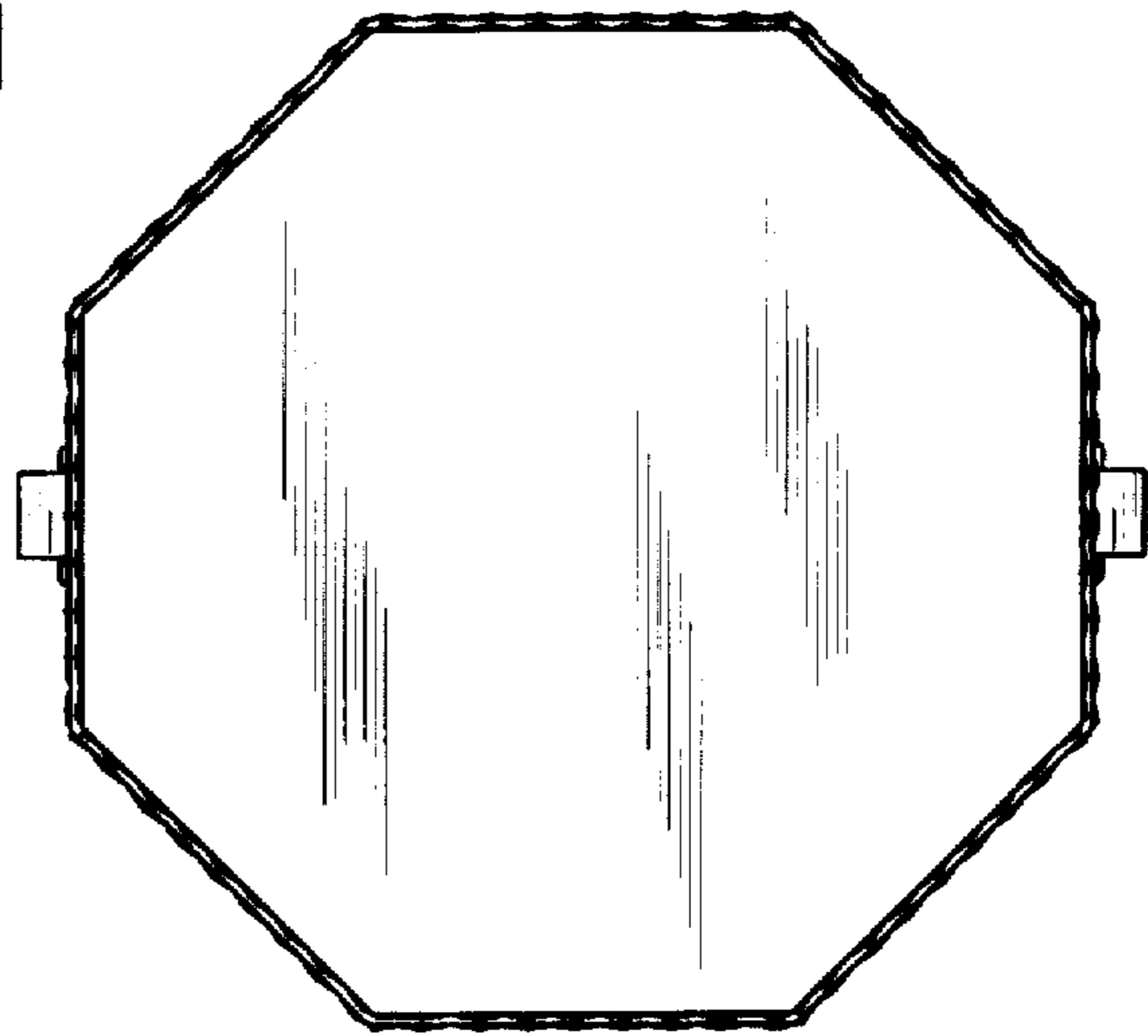

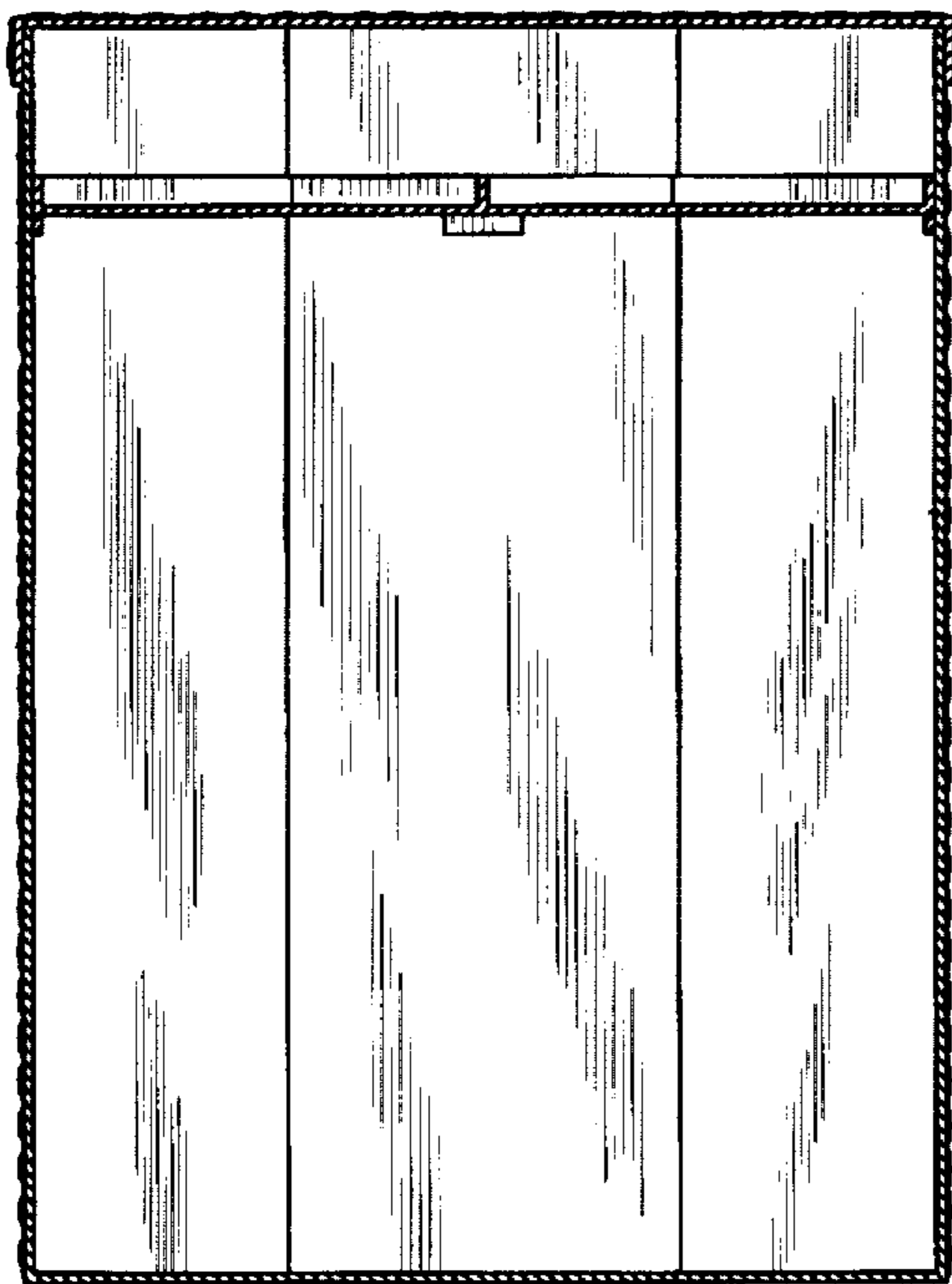

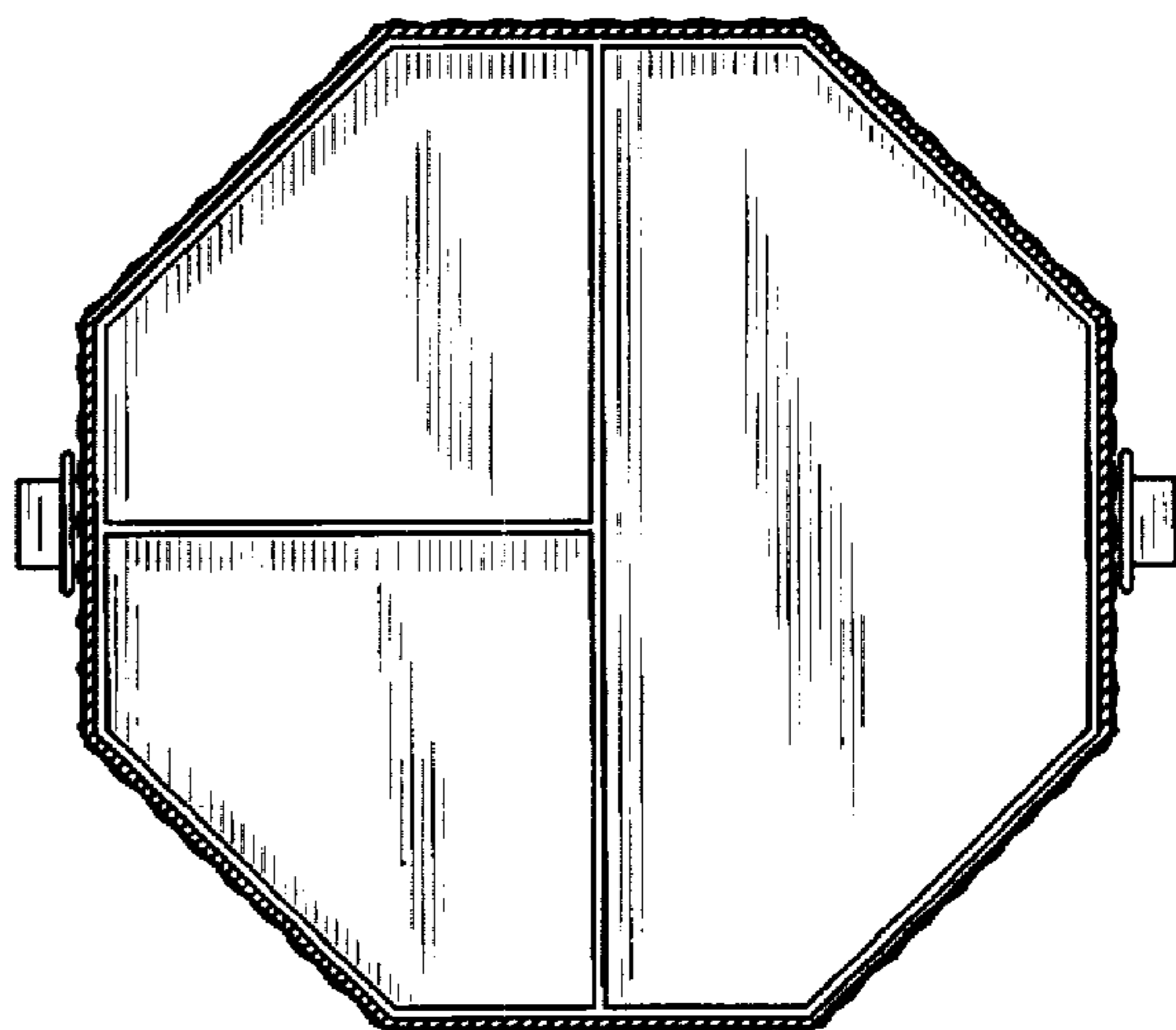

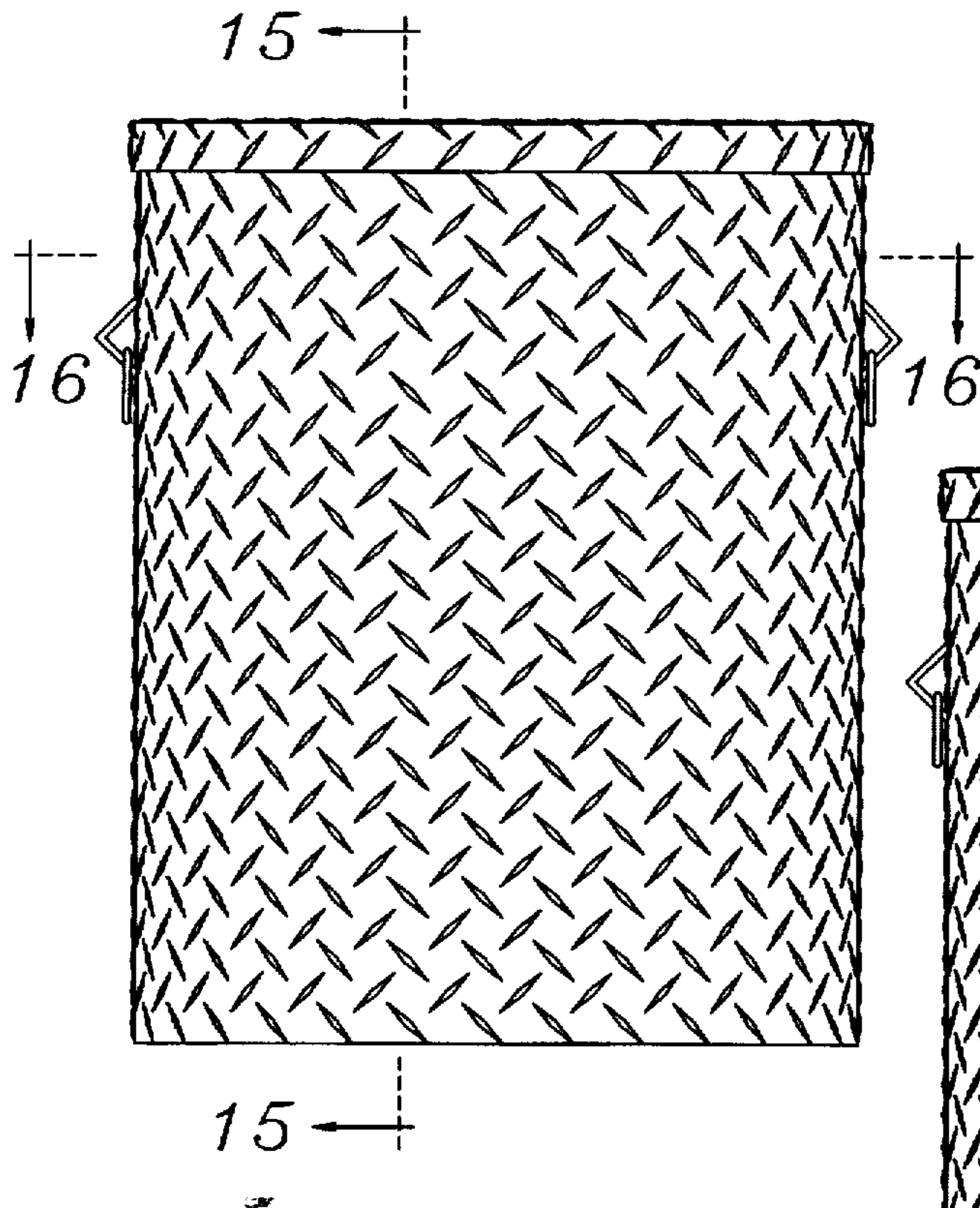

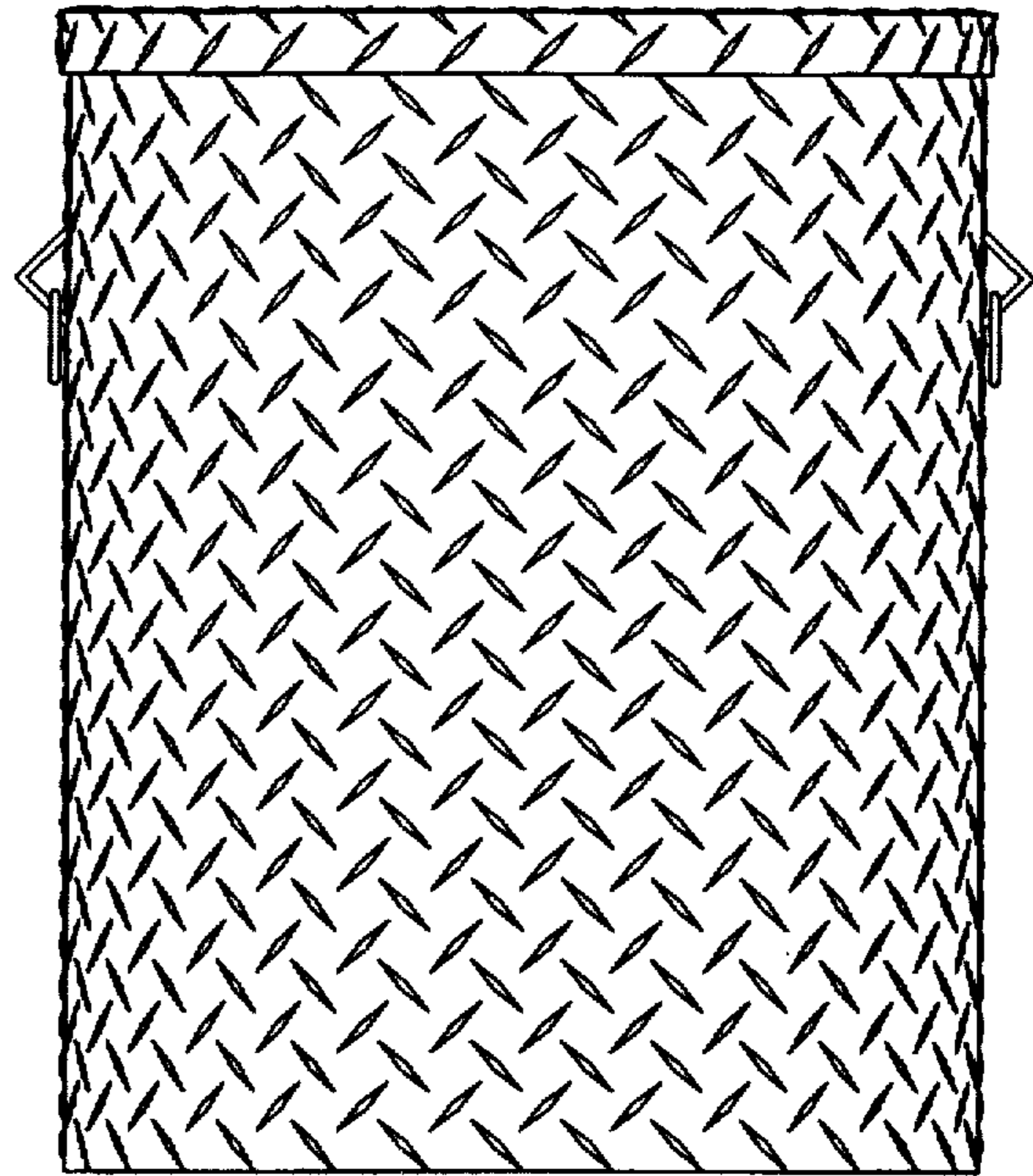

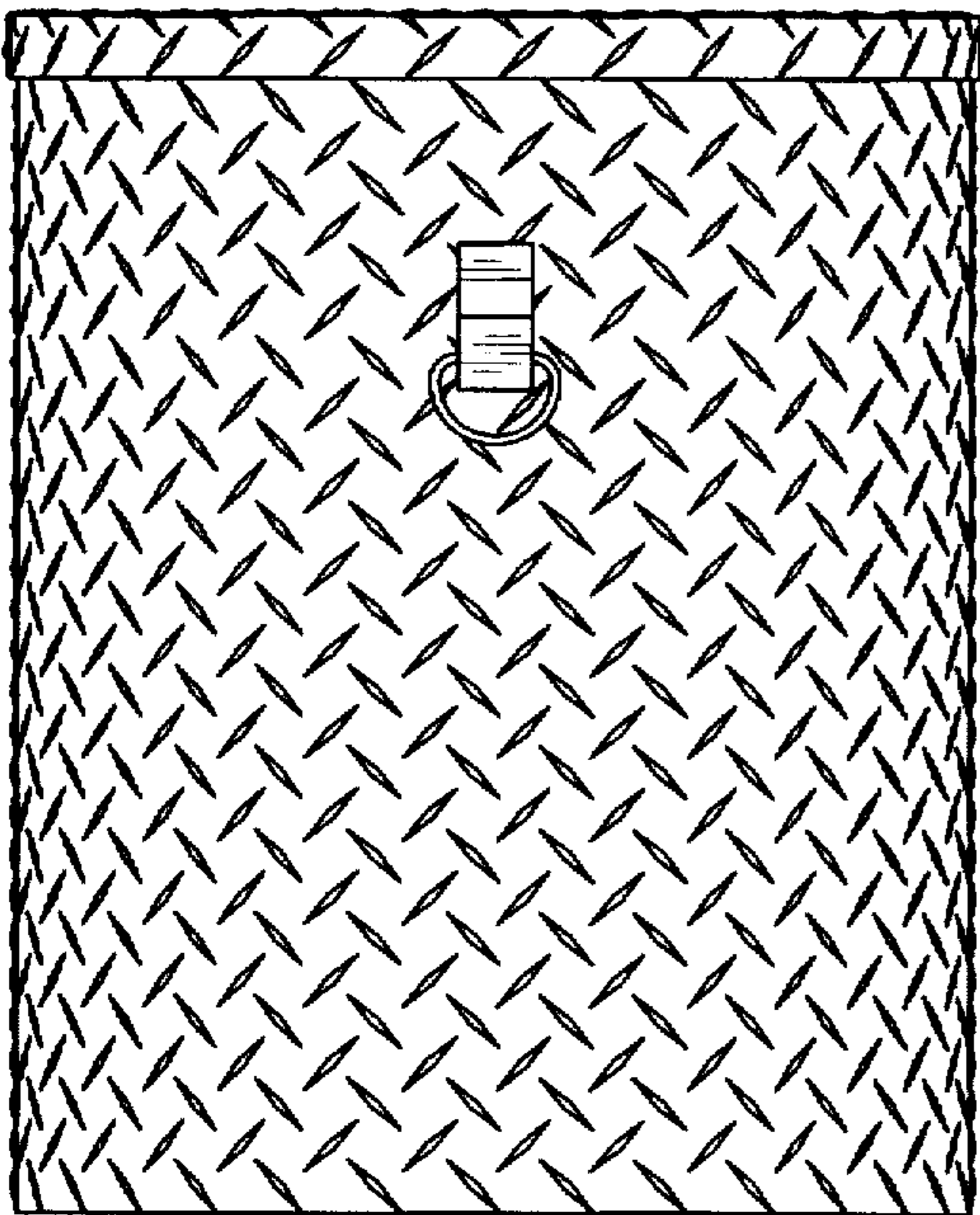

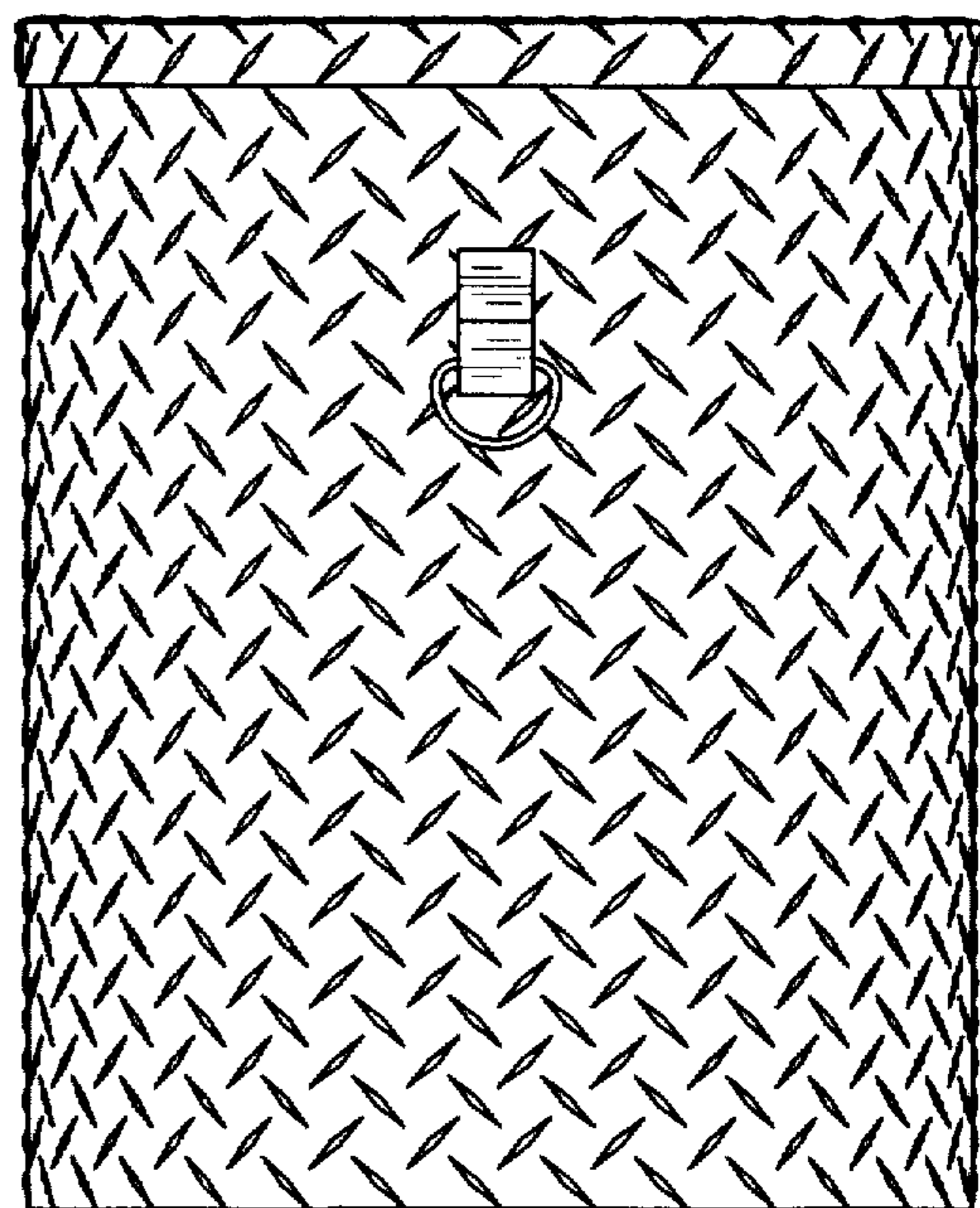

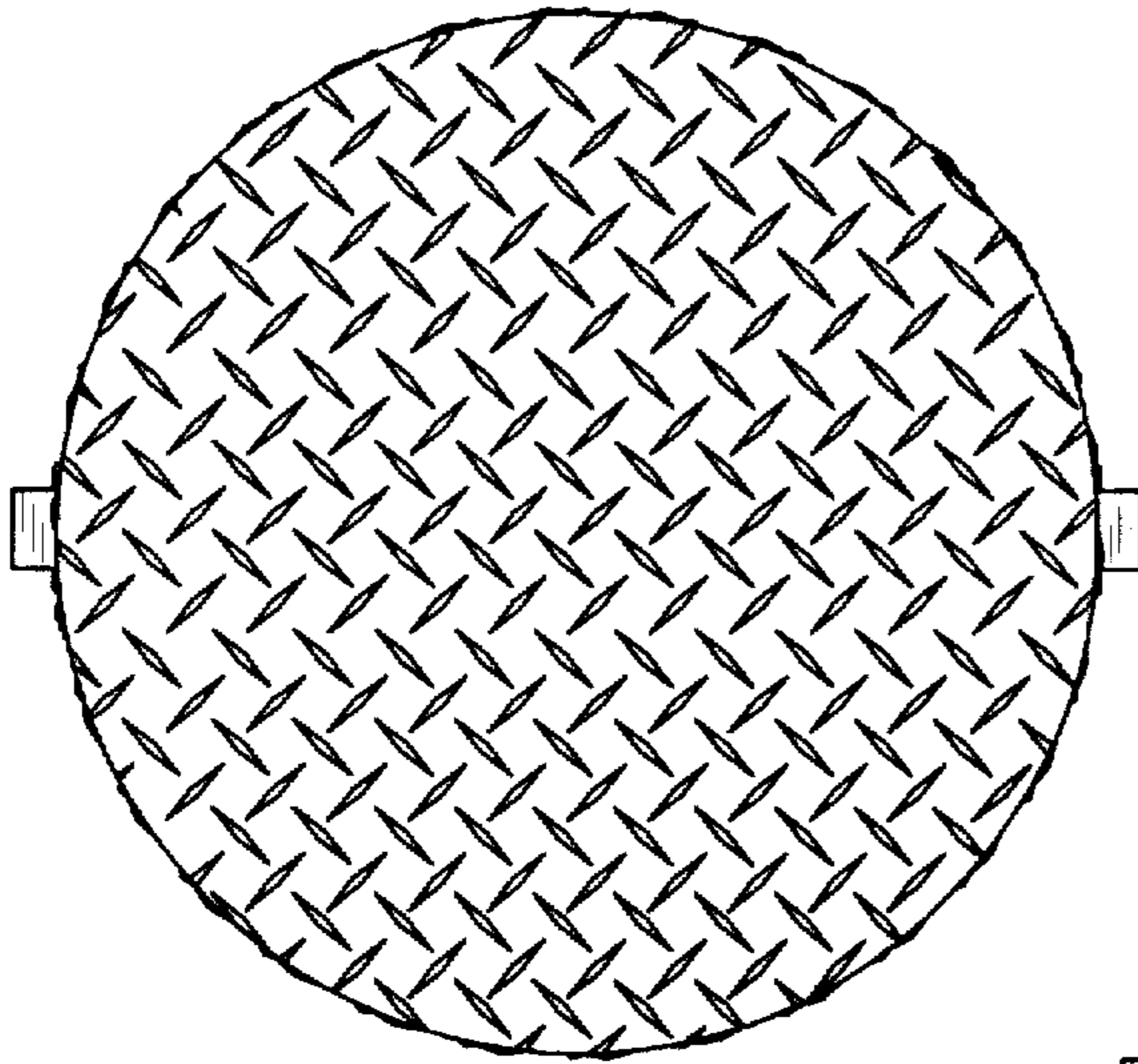

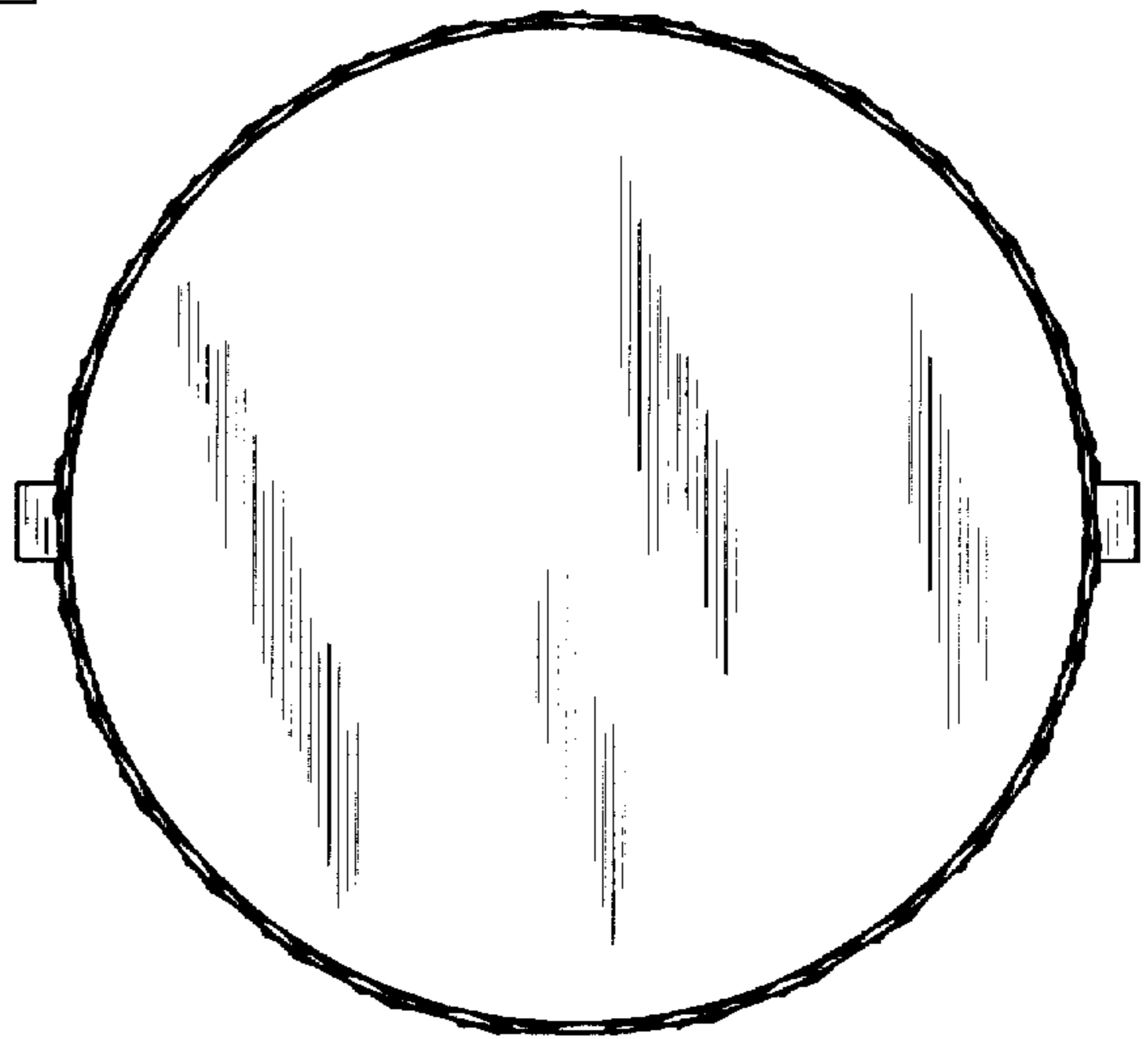

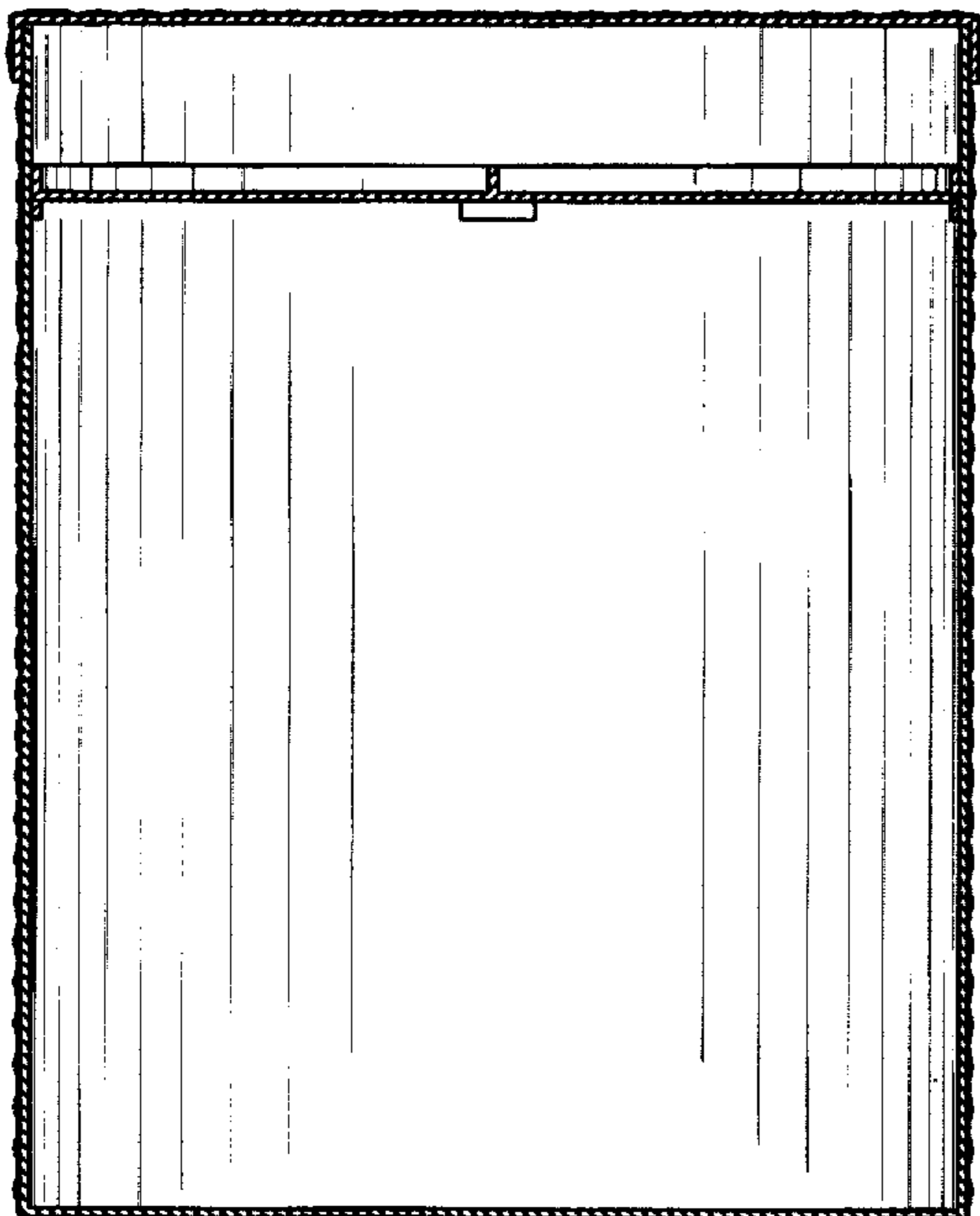

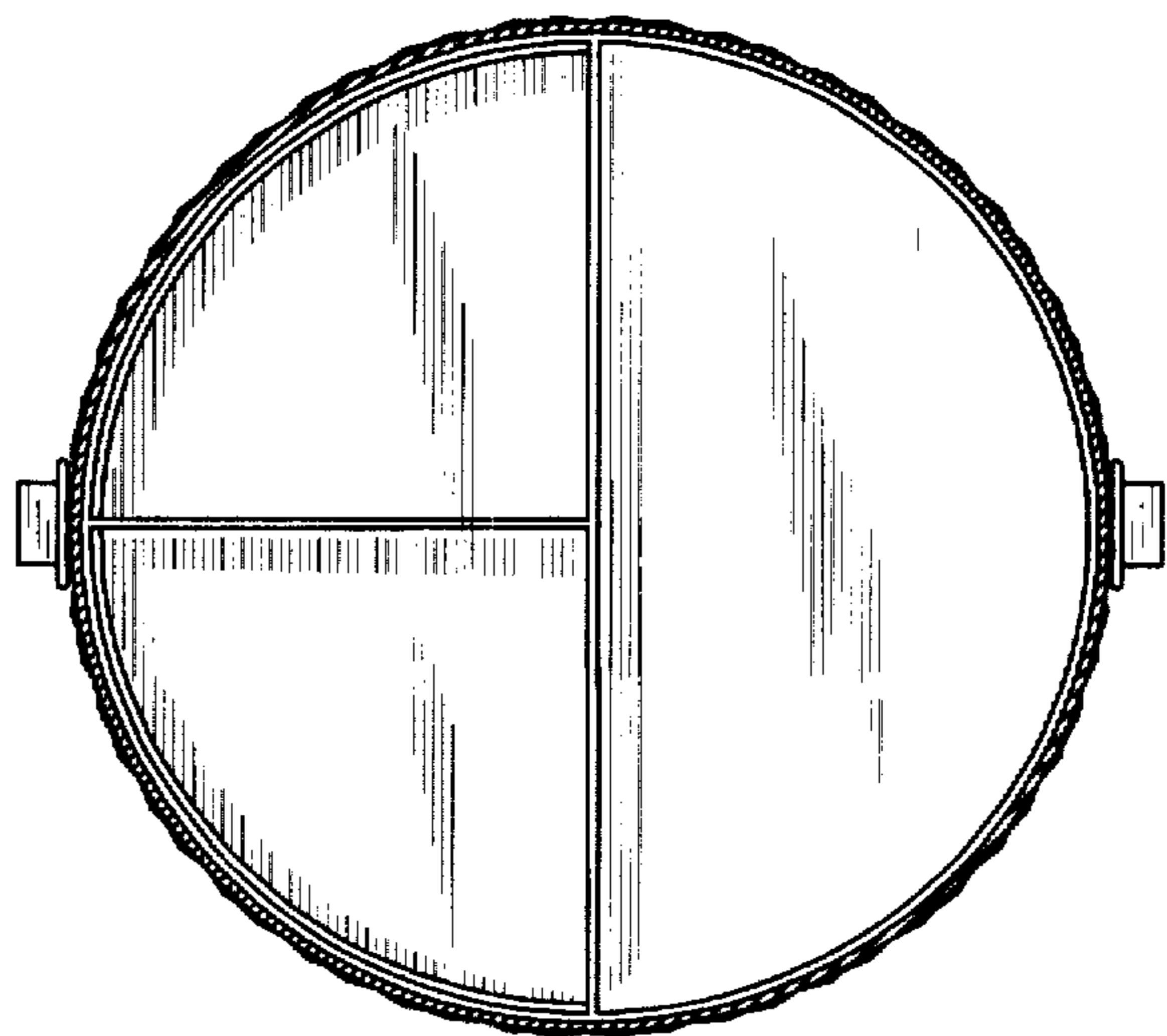

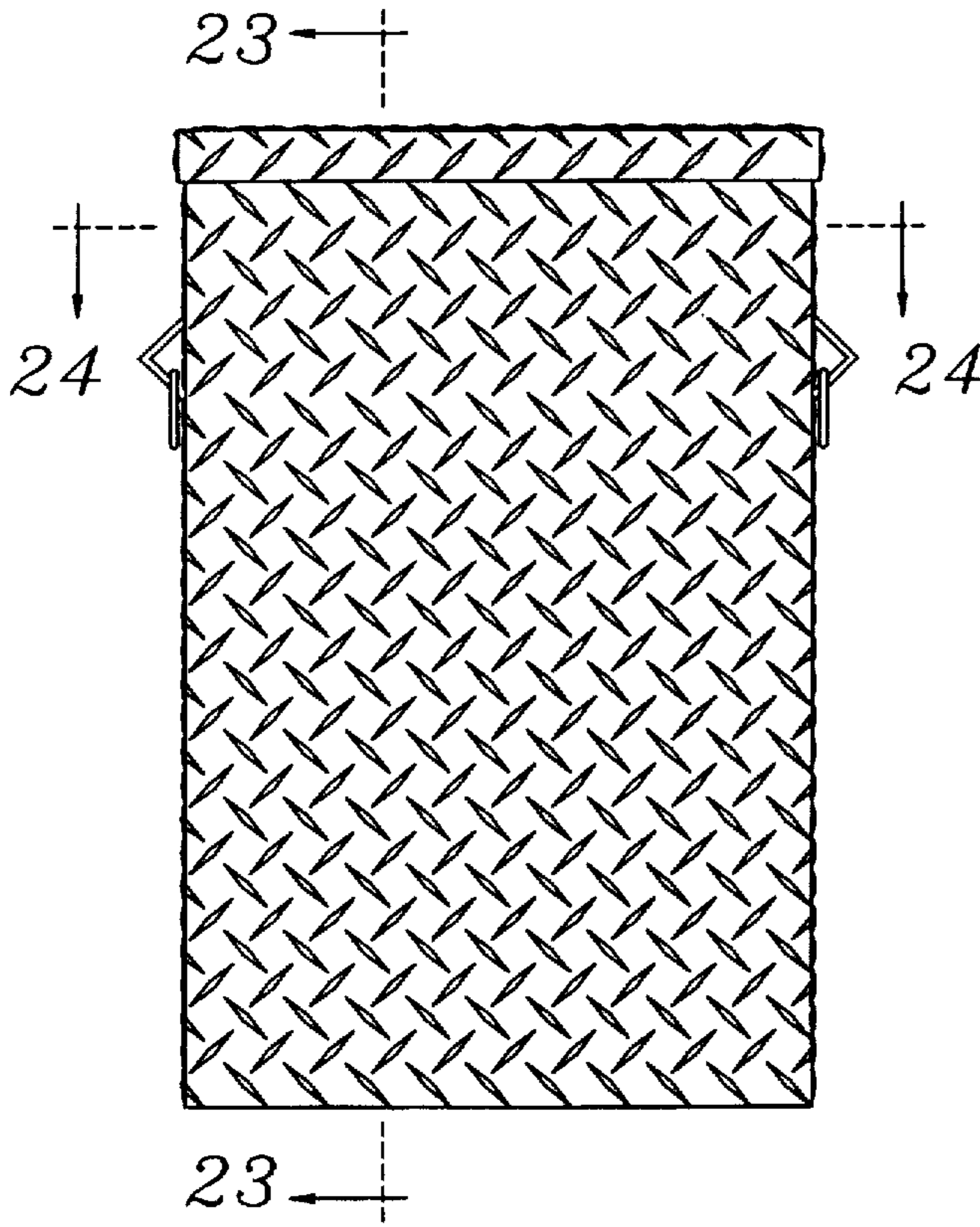

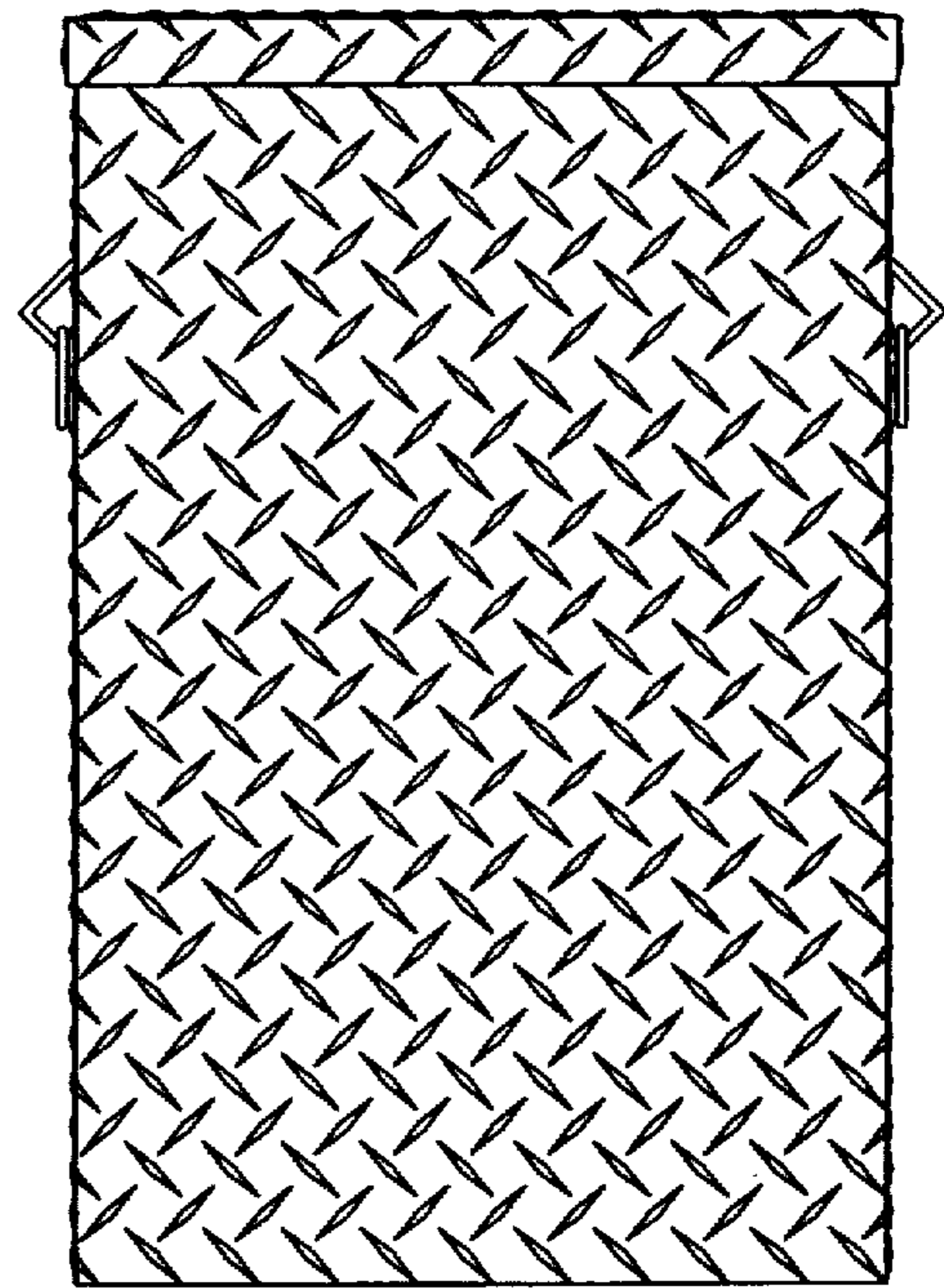

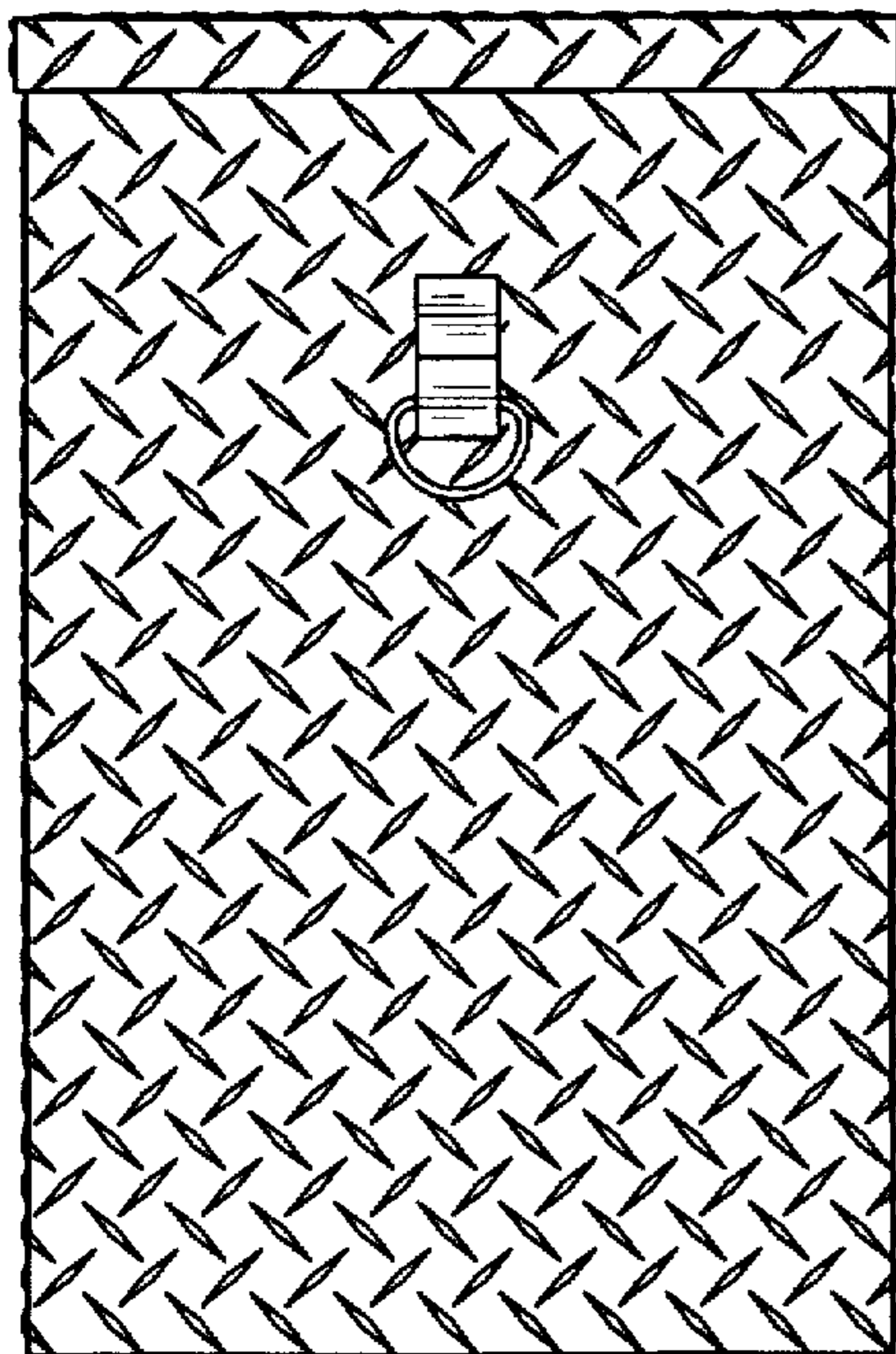

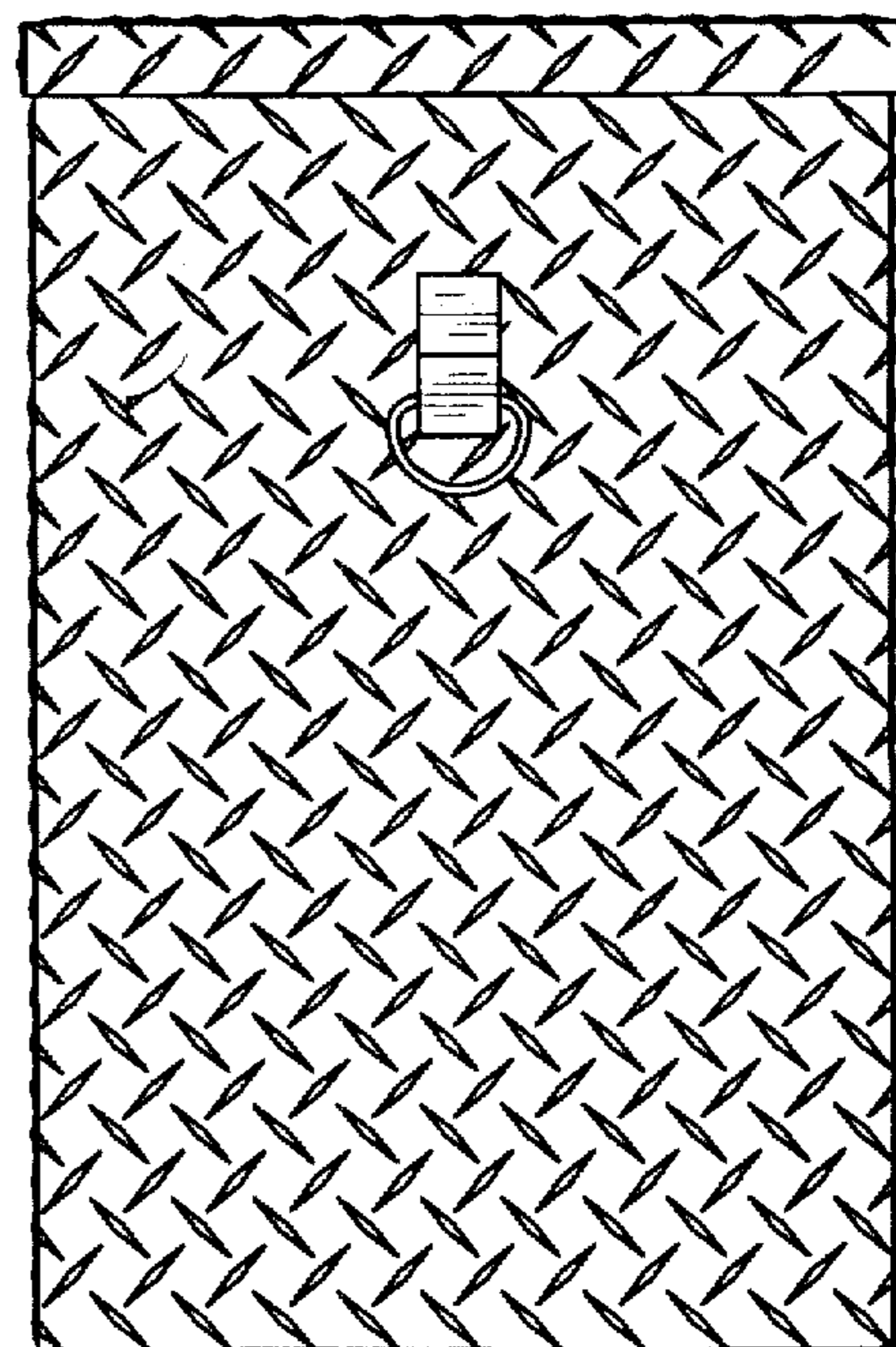

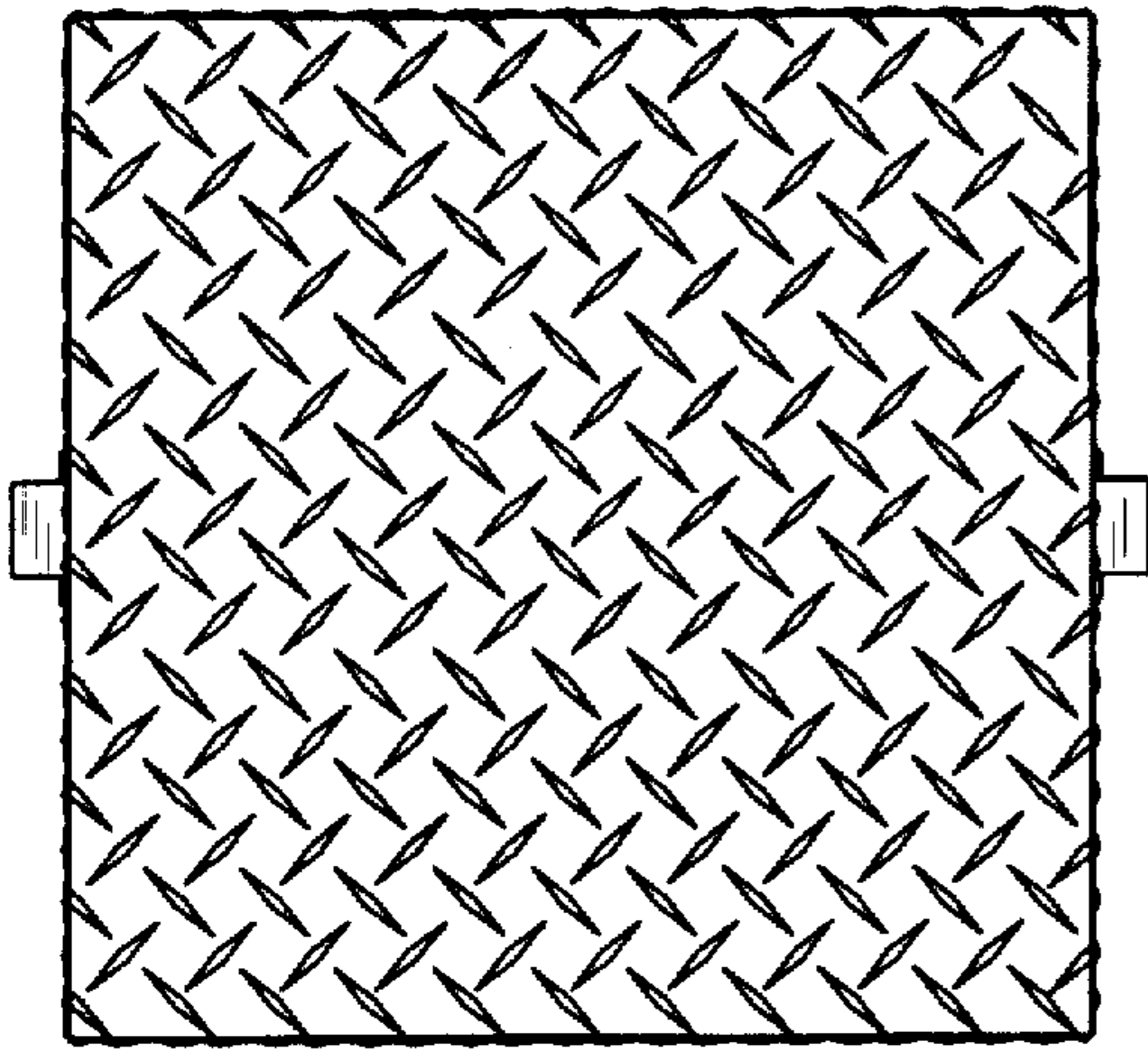

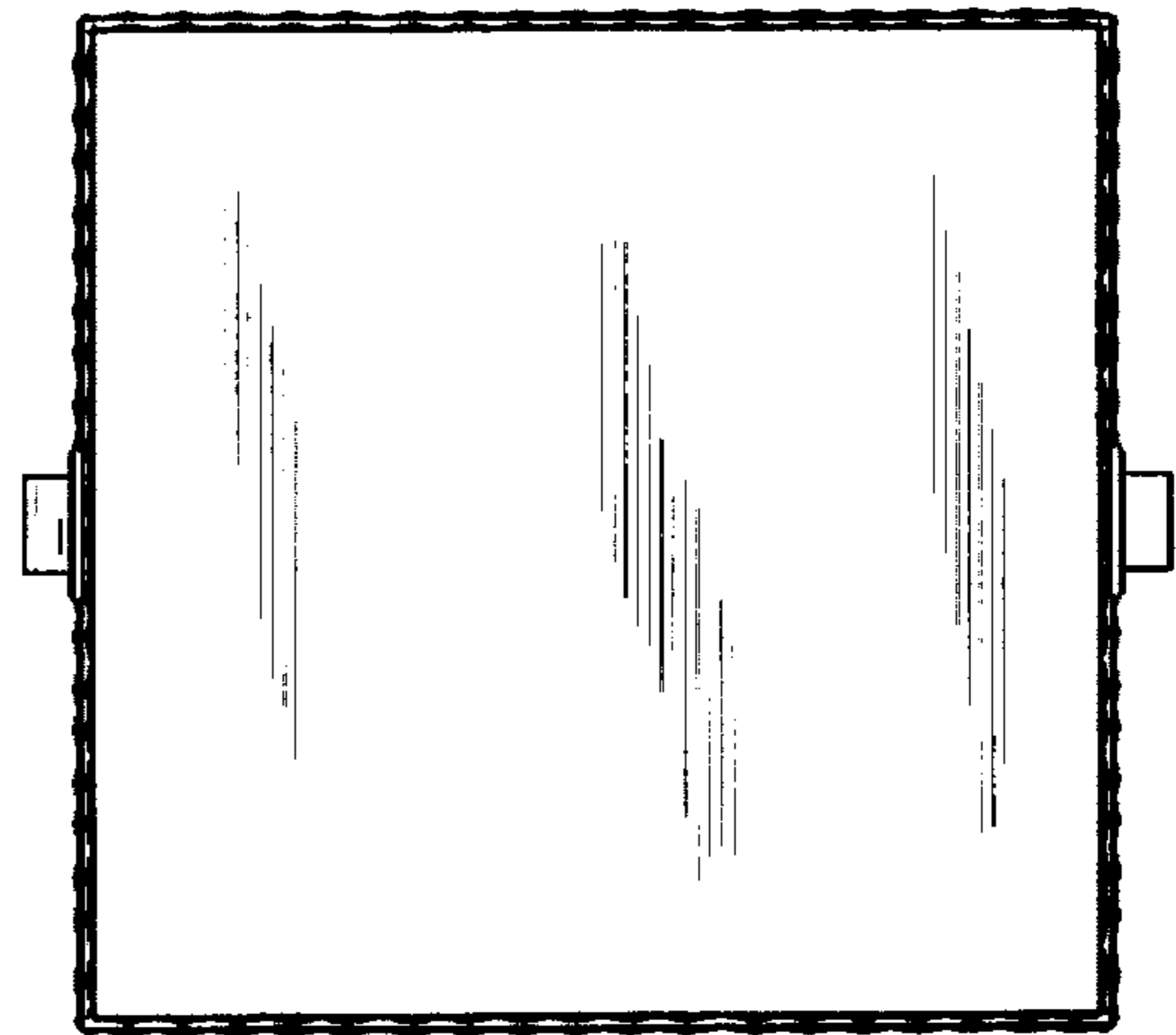

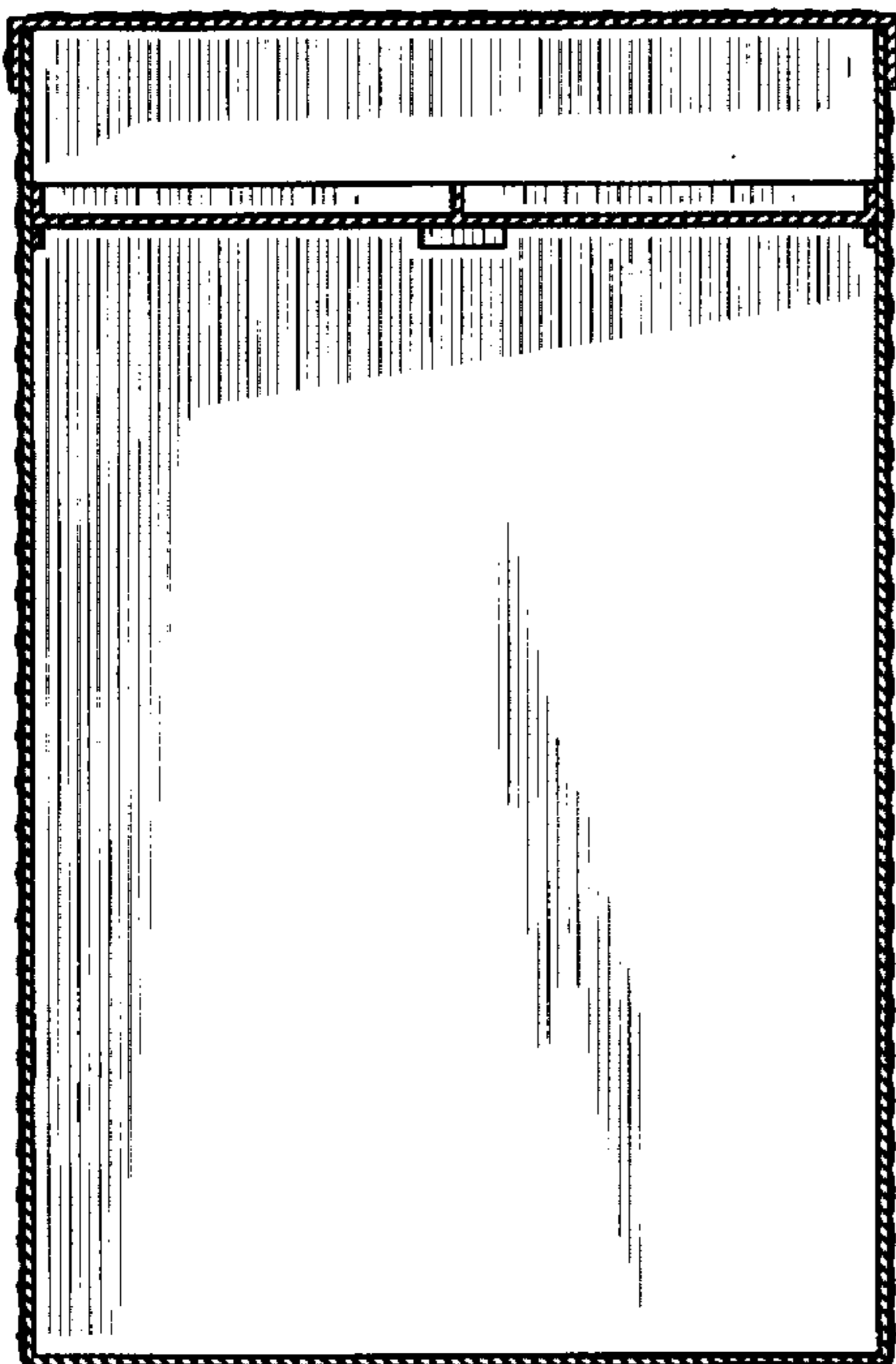
