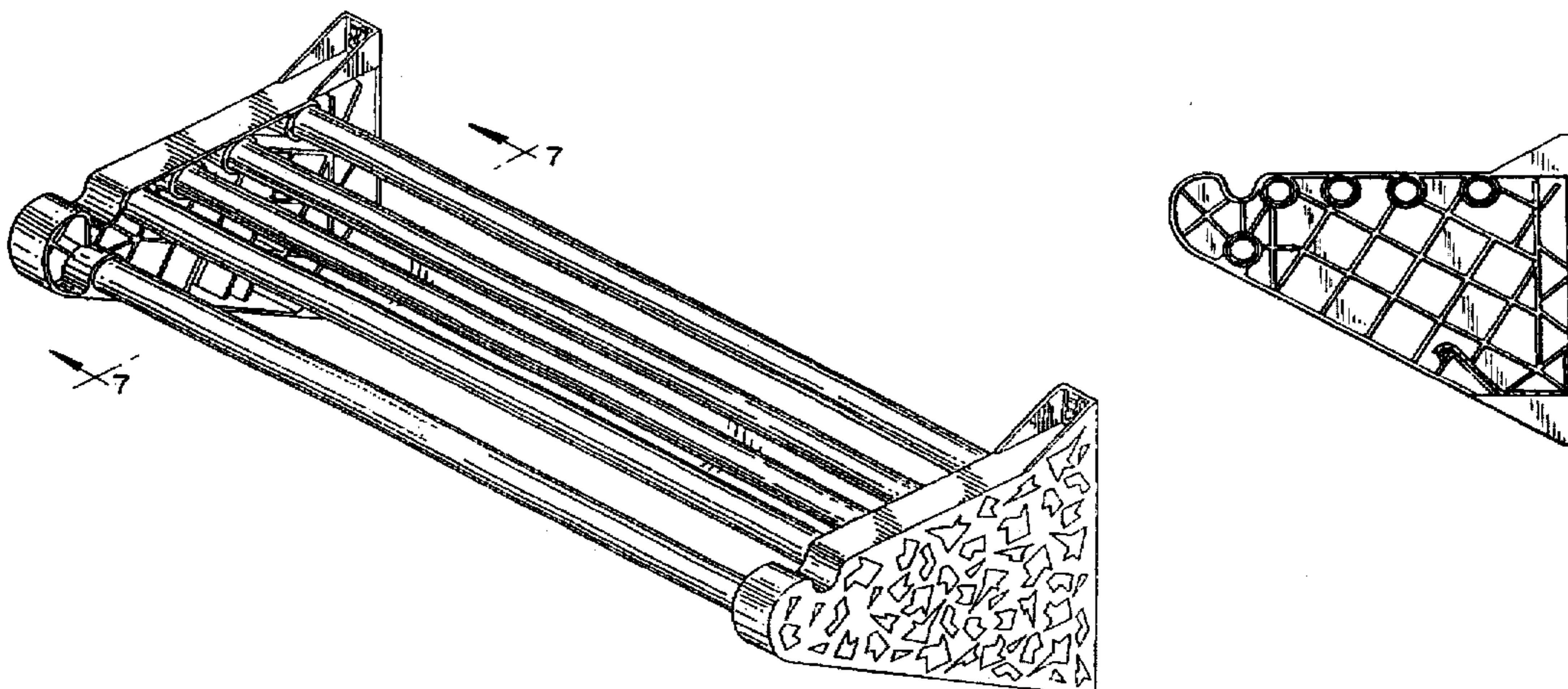
[57] **CLAIM**

The ornamental design for a mini ball rack with five poles, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the mini ball rack with five poles invention;
FIG. 2 is an front view thereof;
FIG. 3 is a top view thereof;
FIG. 4 is a right end view, the left end view thereof forming a mirror image of said right side and thus is not shown; and
FIG. 5 is a bottom view thereof;
FIG. 6 is a back view thereof; and,
FIG. 7 is a cross-sectional view thereof taken along line 7—7 of FIG. 1.

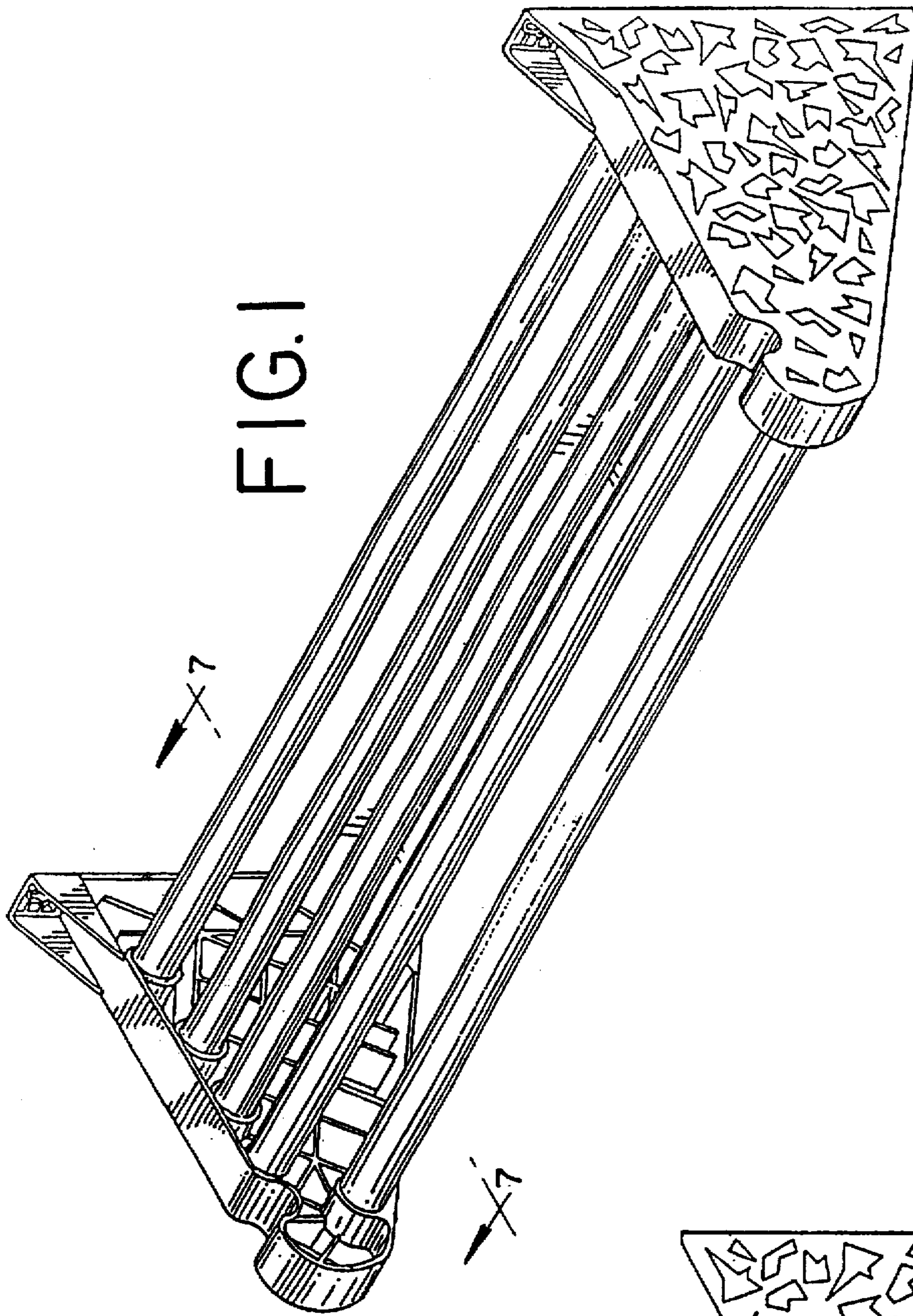

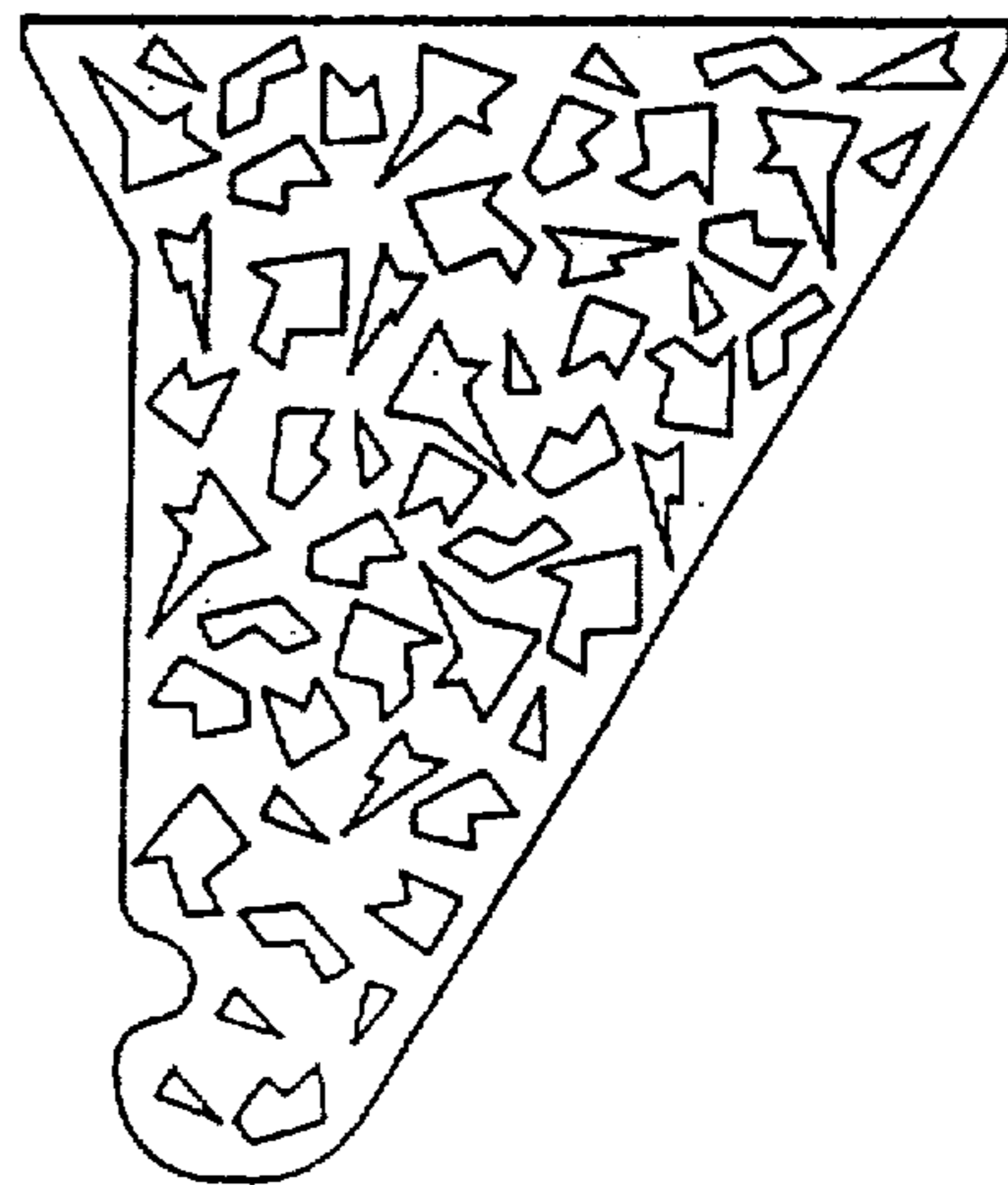

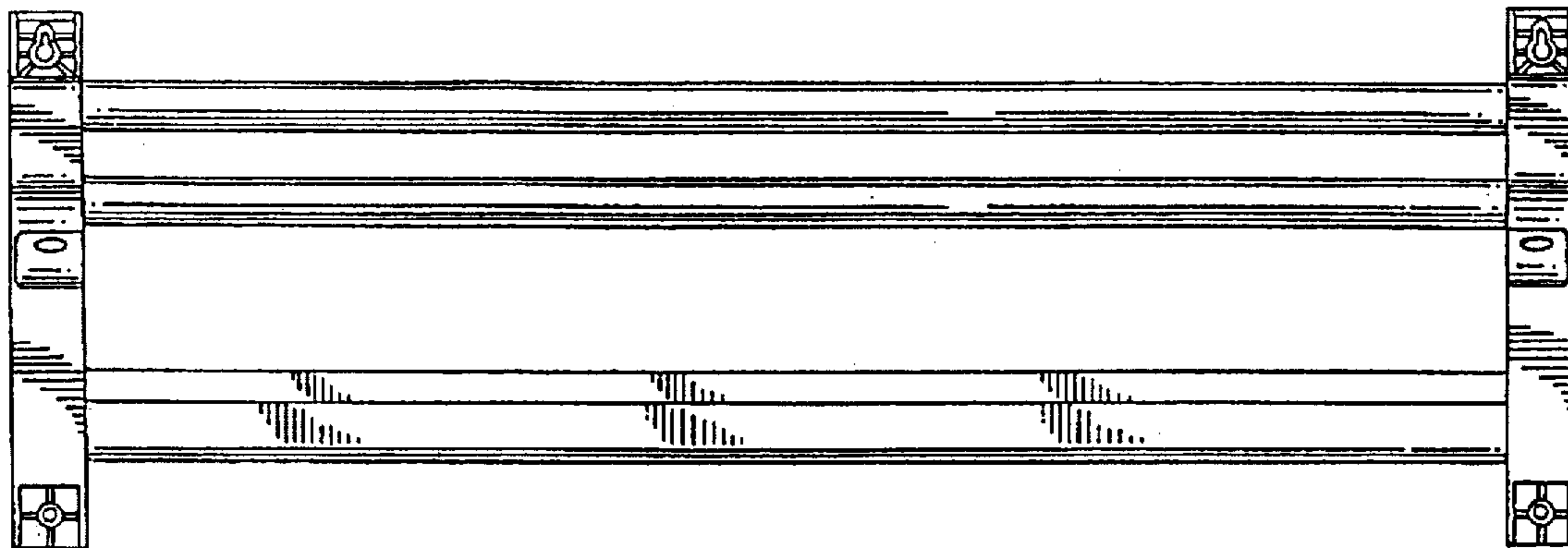

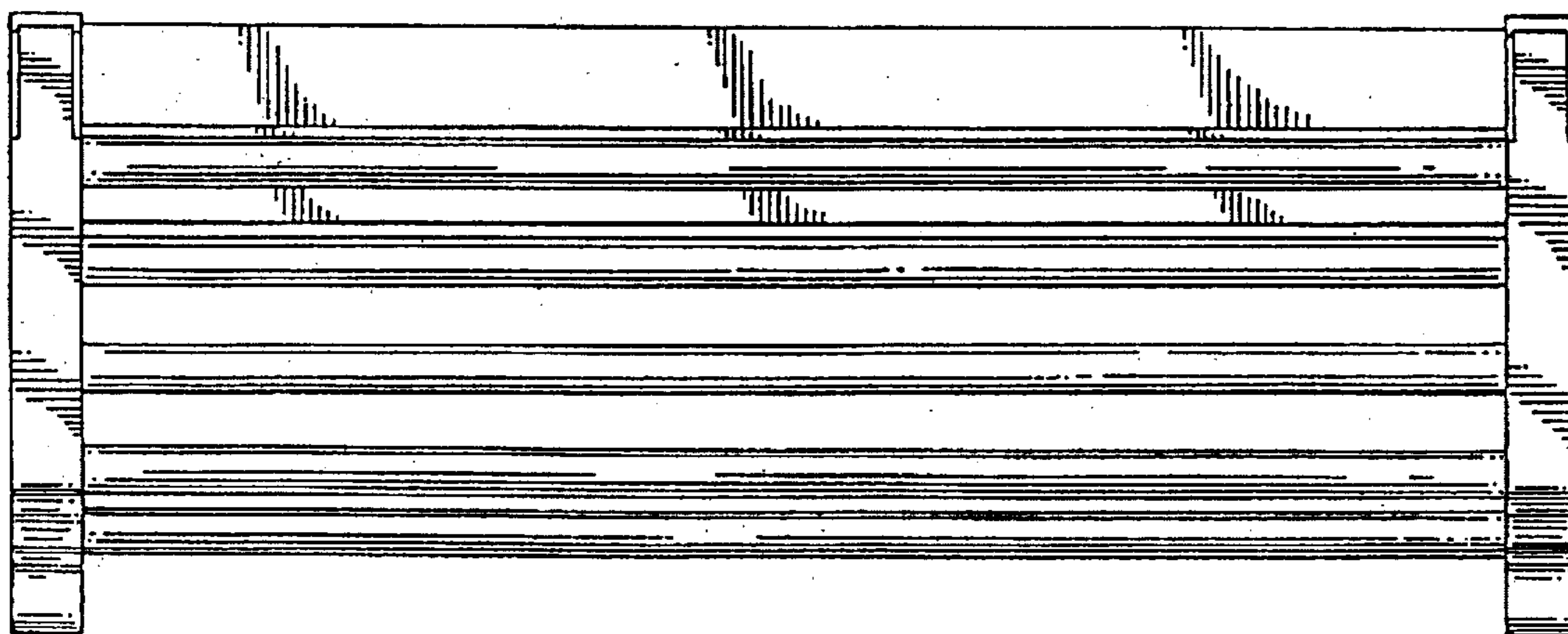

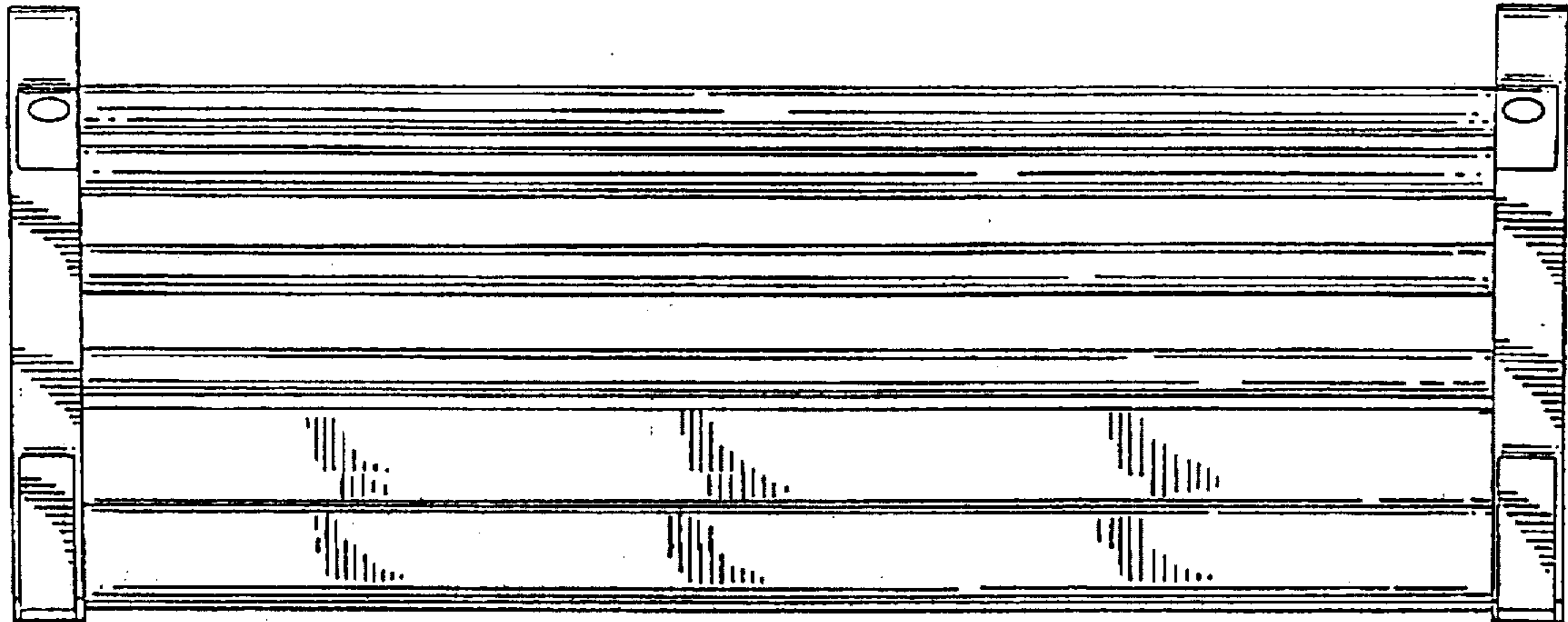

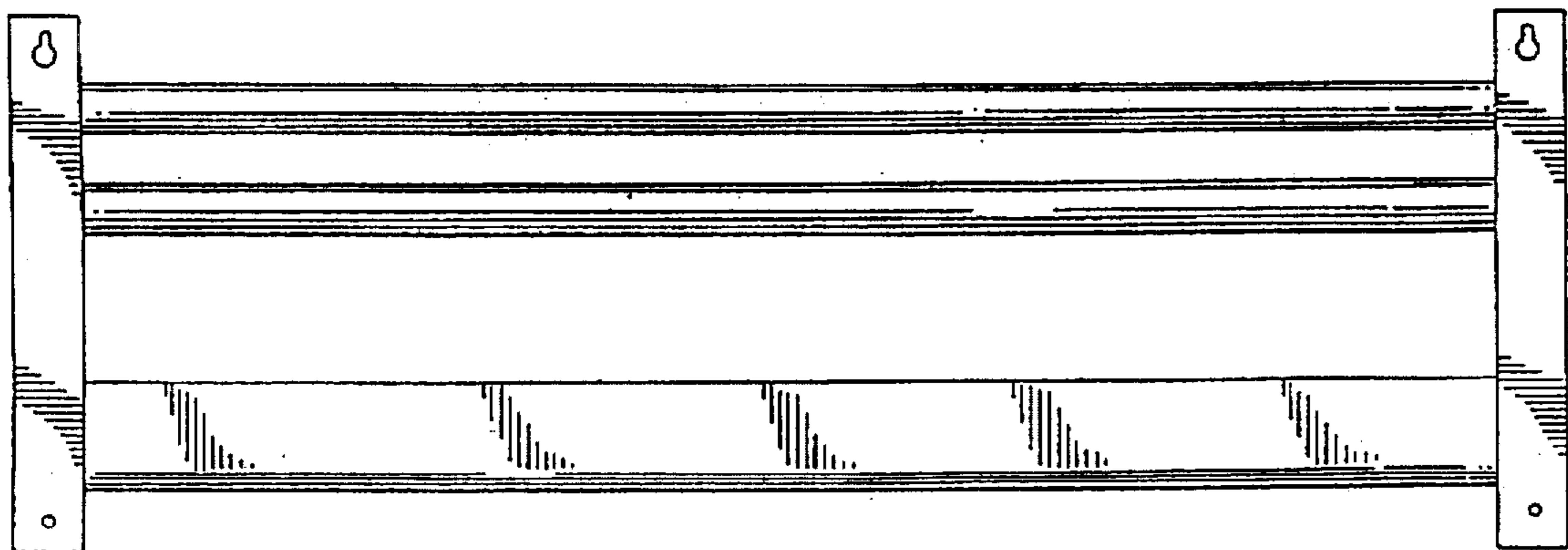
