The ornamental design for an vehicle air intake grille, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an vehicle air intake grille showing our new design, the portions of the truck shown in broken lines are for illustrative purposes only and form no part of the claimed design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a rear elevational view thereof;

FIG. 4 is a top plan view thereof, taken from line 4—4 of FIG. 2;

FIG. 5 is a bottom plan view thereof, taken from line 5—5 of FIG. 2;

FIG. 6 is a side elevational view thereof, taken from line 6—6 of FIG. 2; and,

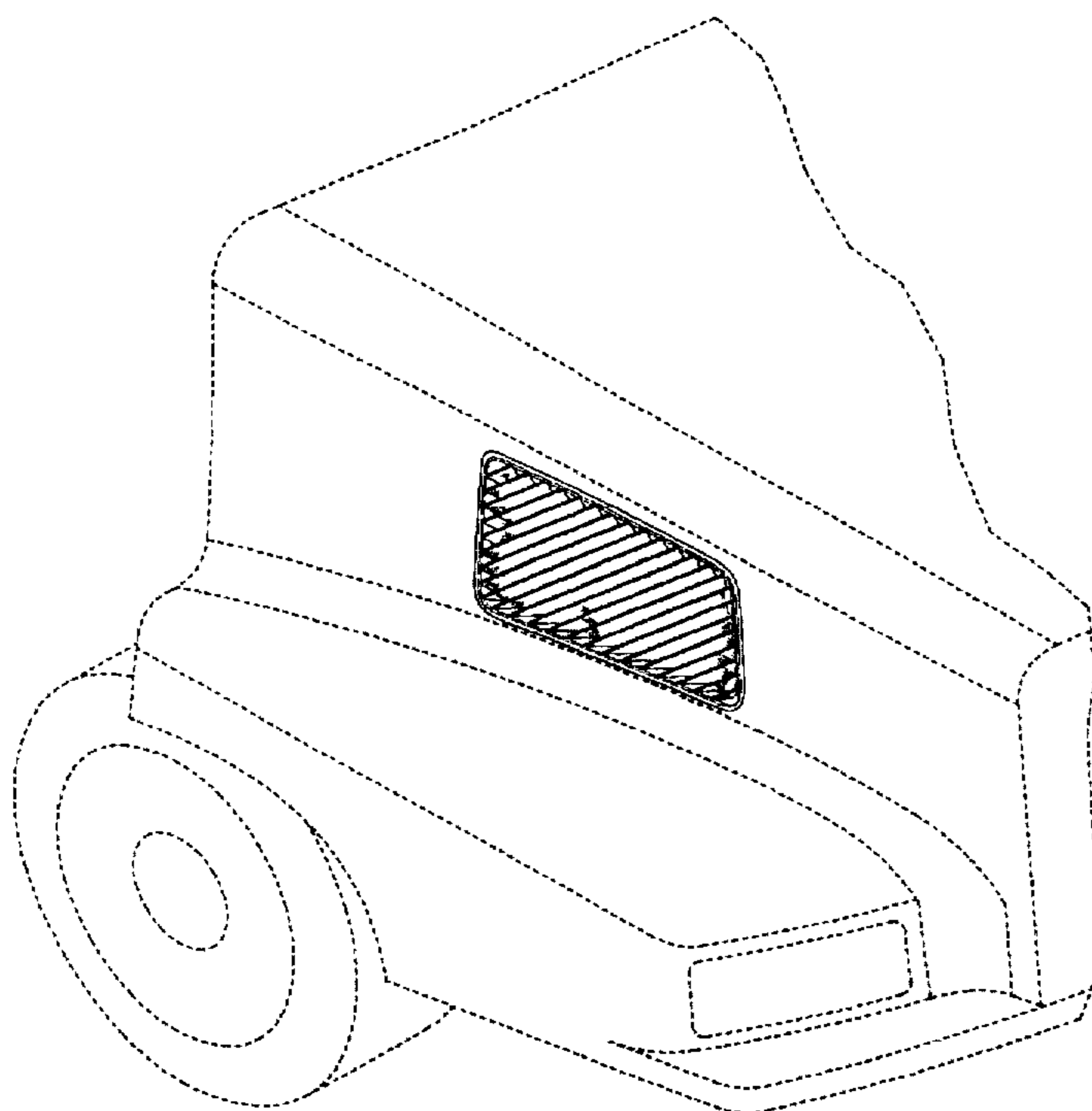
FIG. 7 is an opposite side elevational view thereof, taken line 7—7 of FIG. 2.

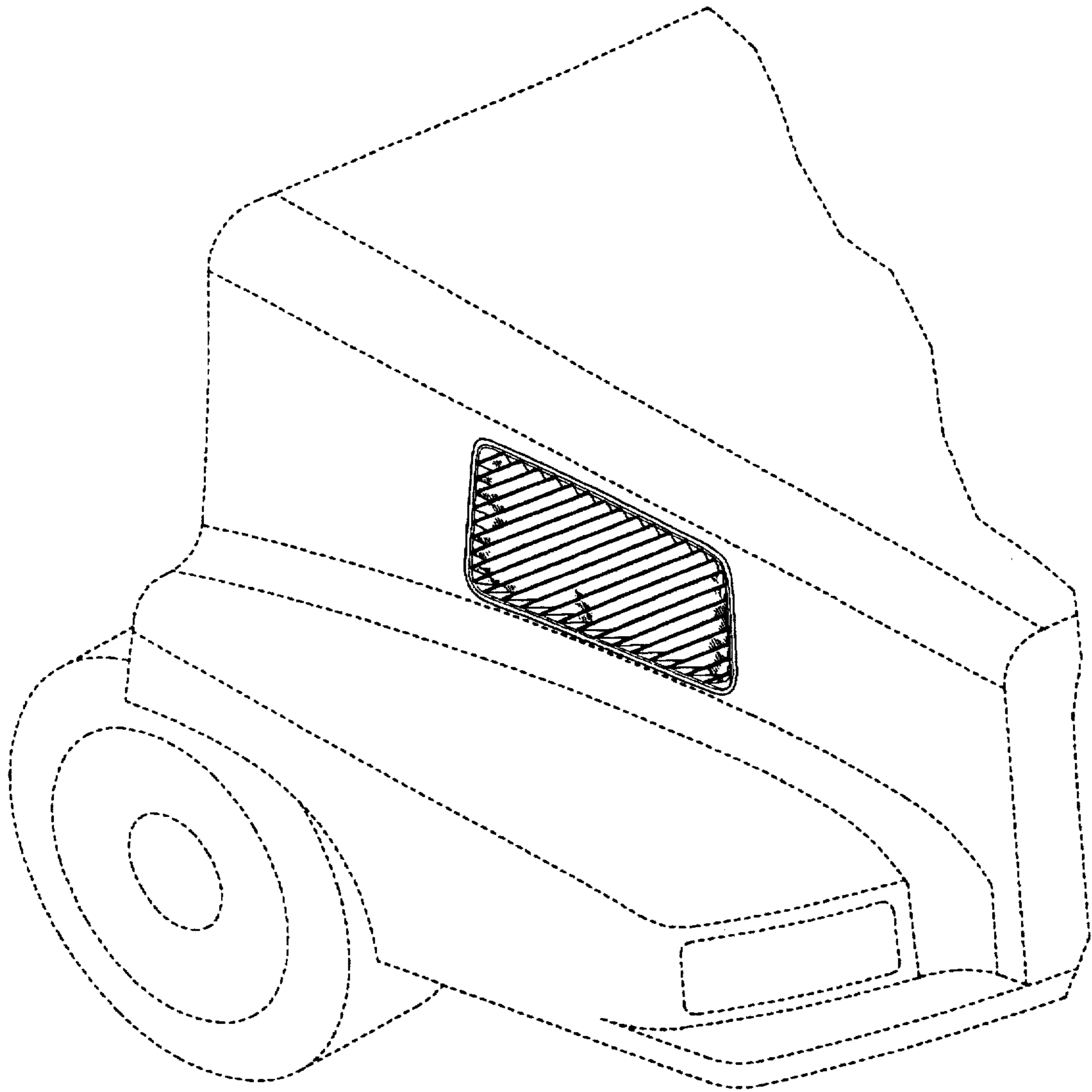

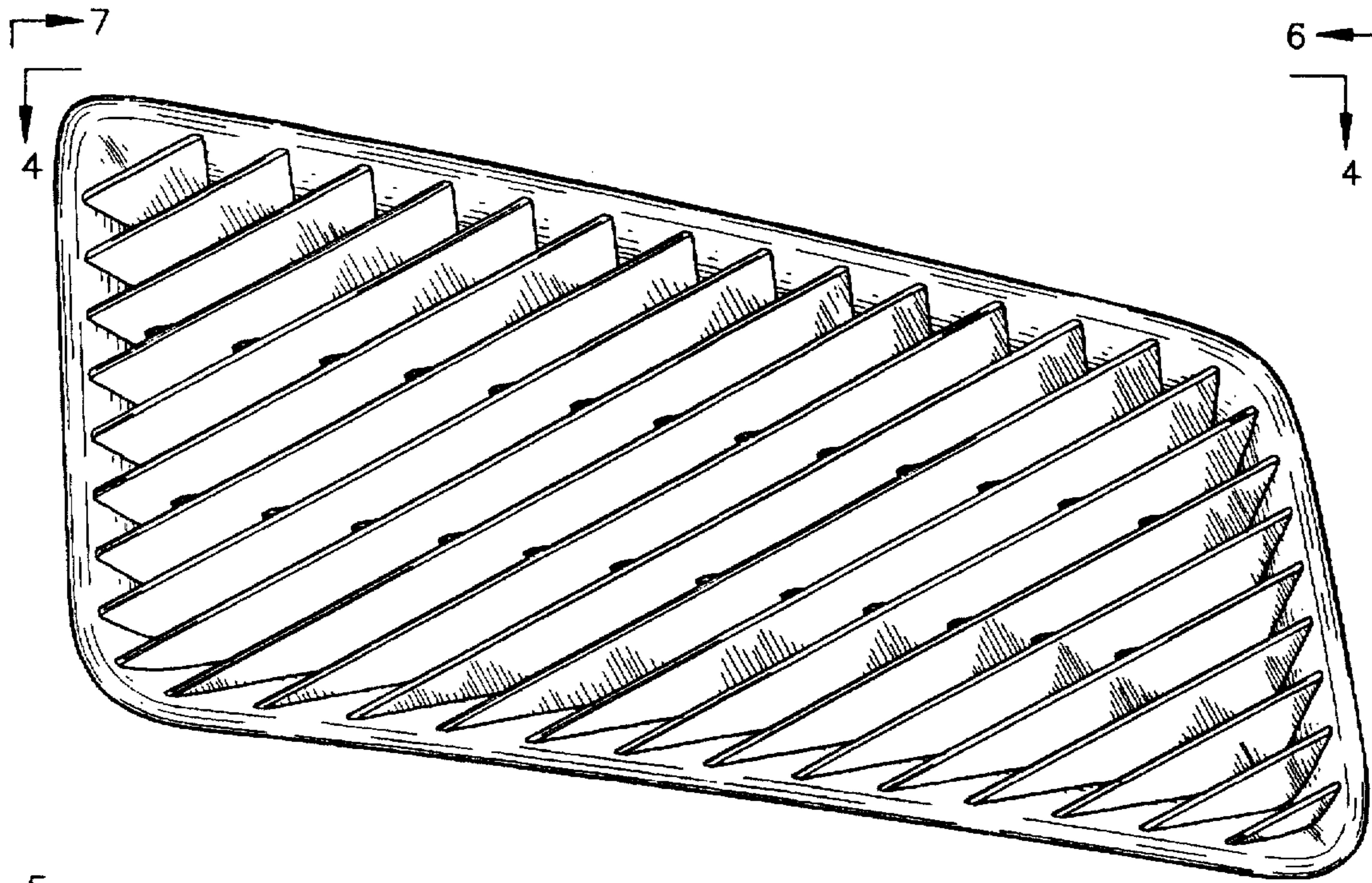

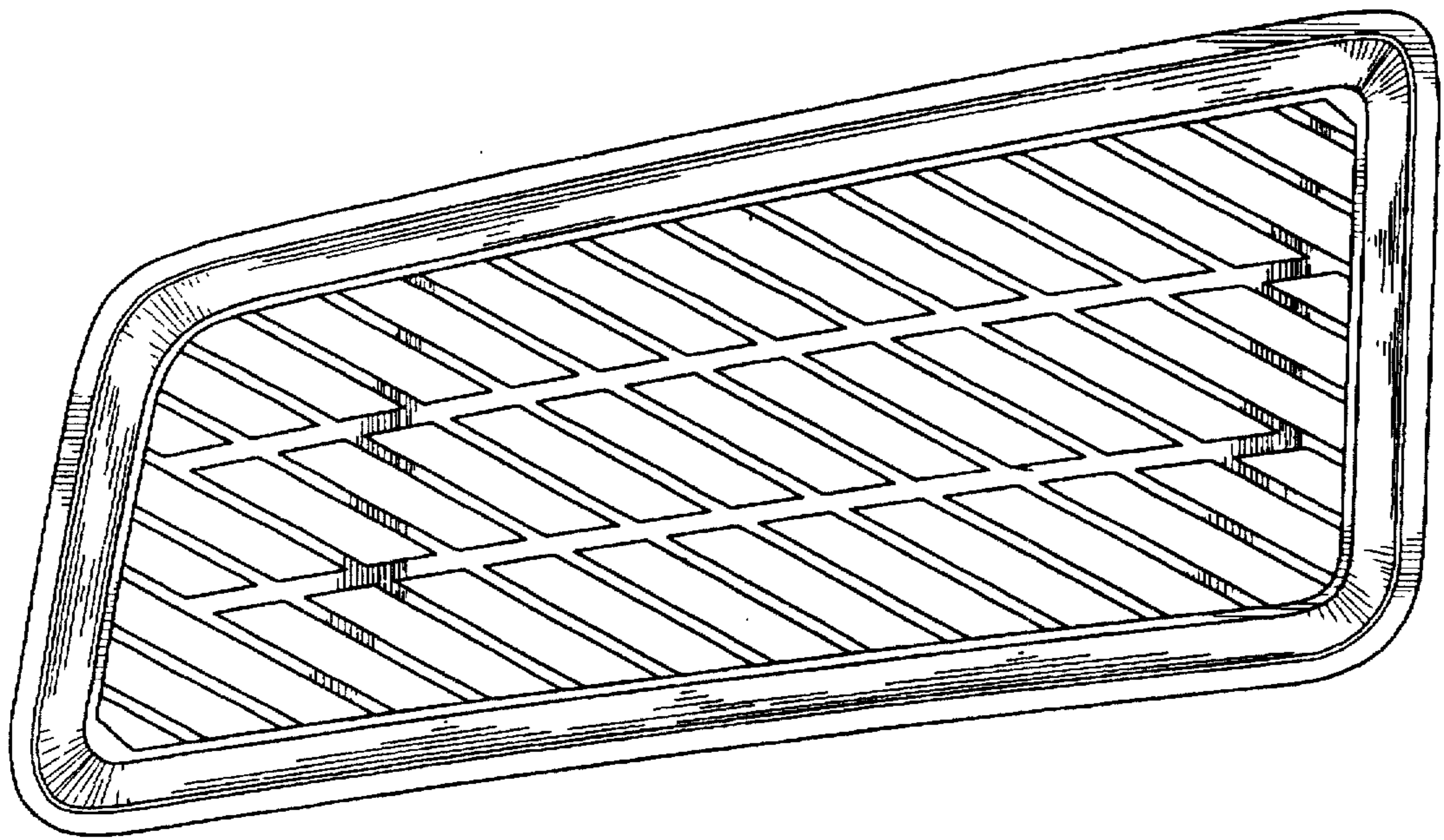

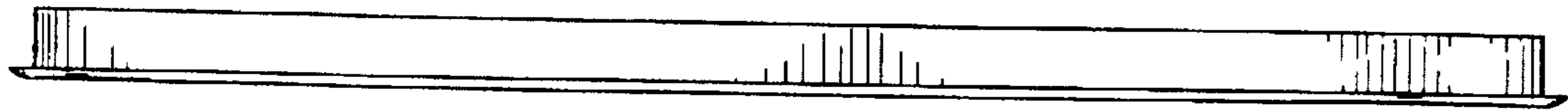

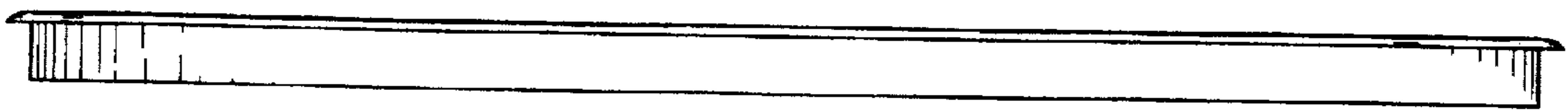
