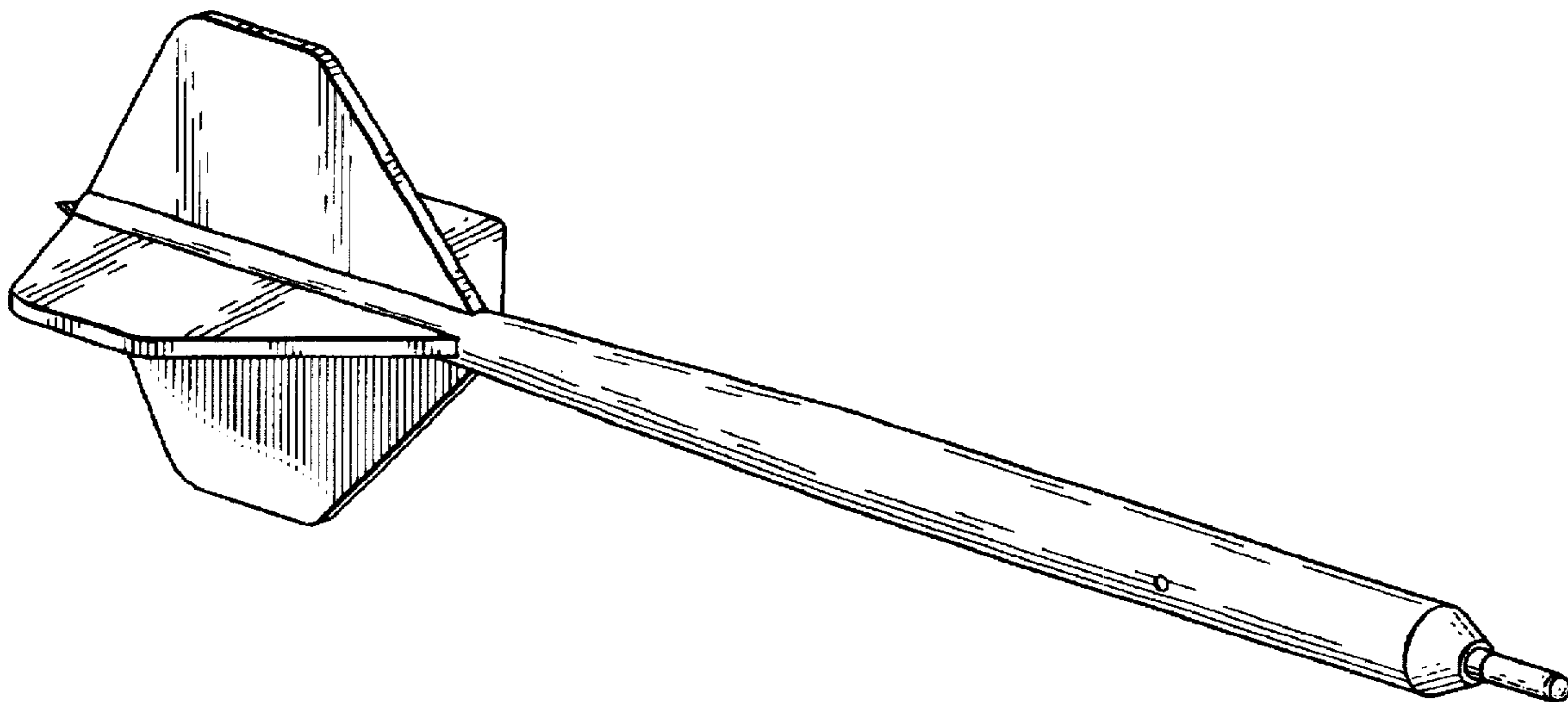

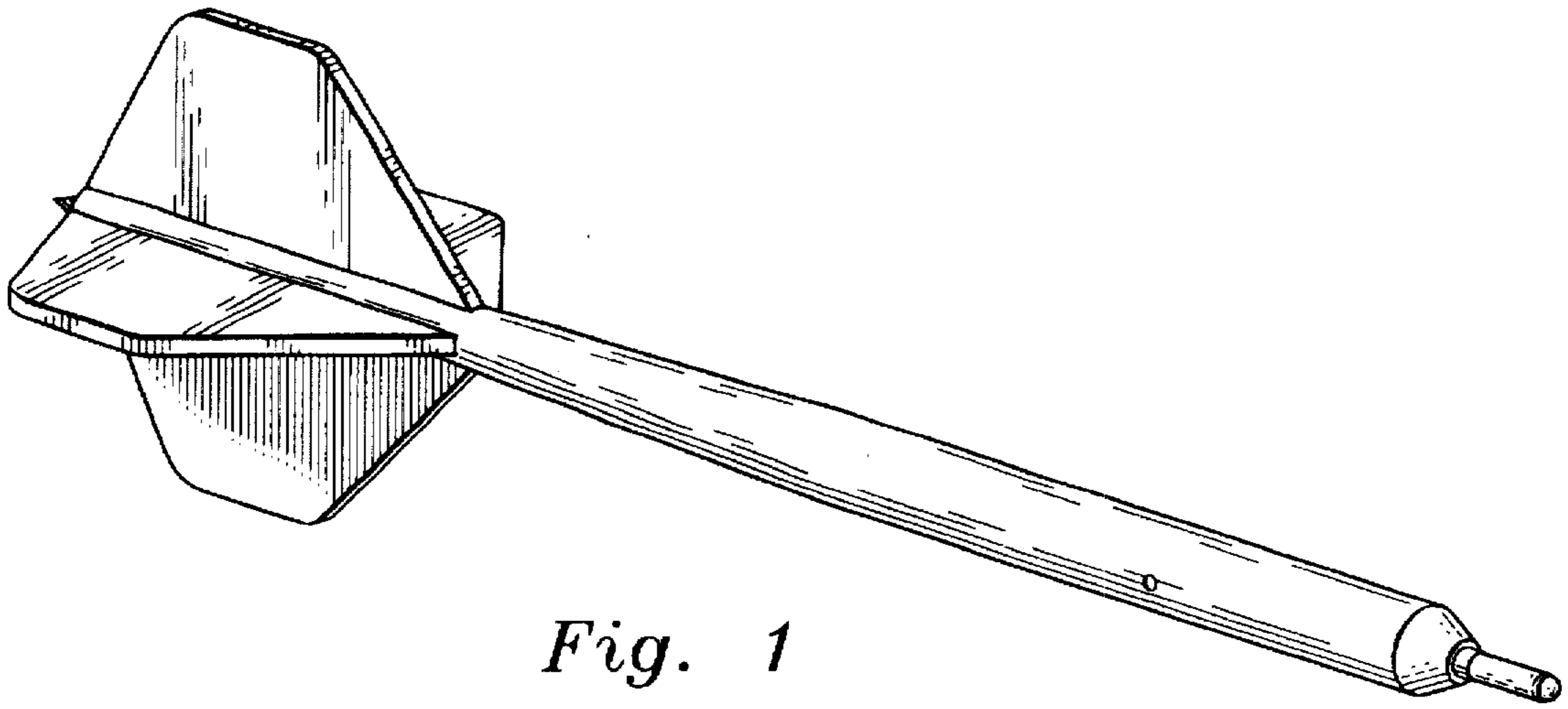
The ornamental design for a dart pen, as shown.

**DESCRIPTION**

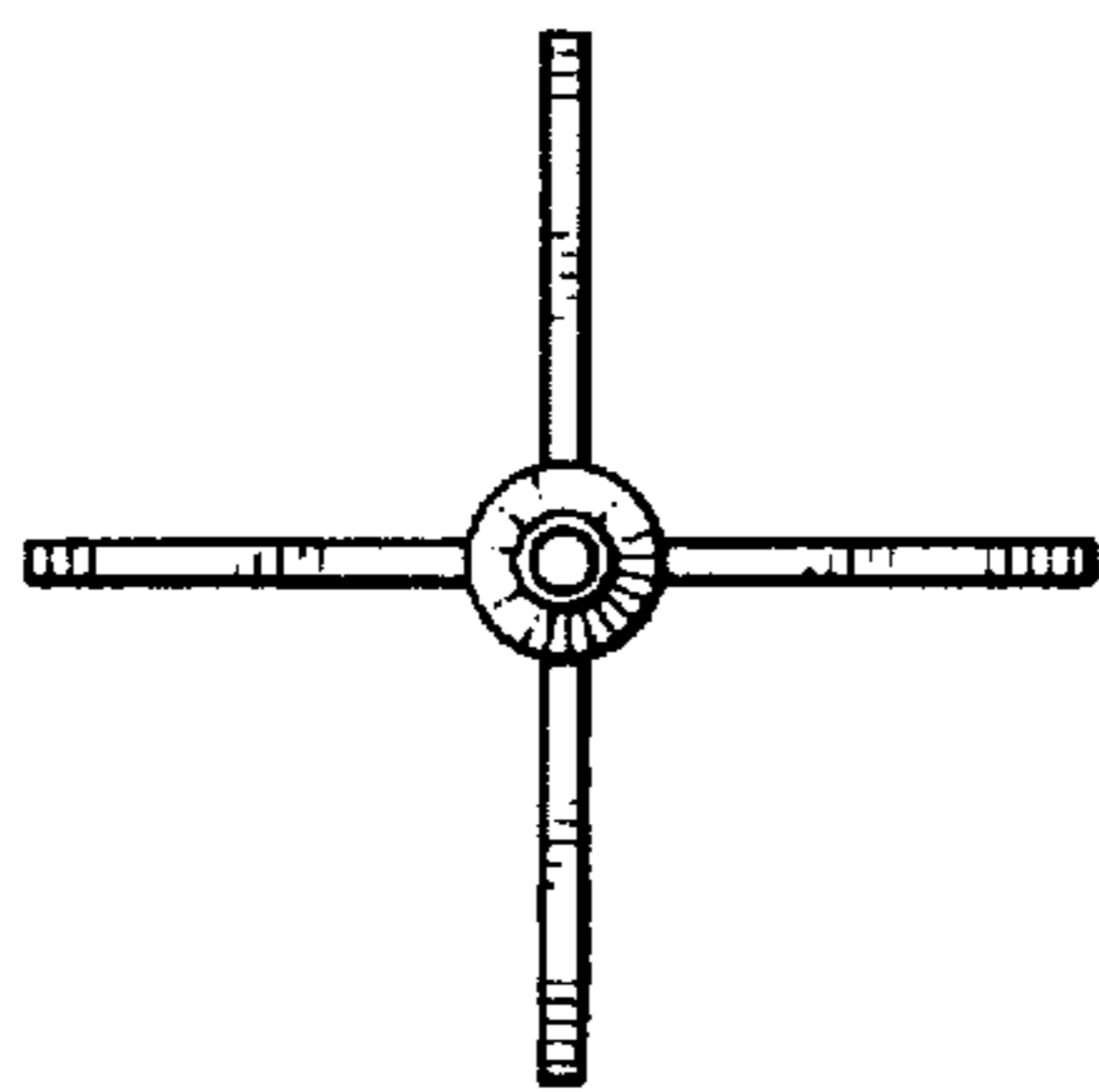
FIG. 1 is an elevated perspective view of the dart pen of the present invention;  
FIG. 2 is a front view of the dart pen of FIG. 1;  
FIG. 3 is a rear view of the dart pen of FIG. 1;  
FIG. 4 is a side view of the dart pen of FIG. 1 as seen from the right-hand side of FIG. 1;  
FIG. 5 is a side view of the dart pen of FIG. 1 as seen from the left-hand side of FIG. 1;

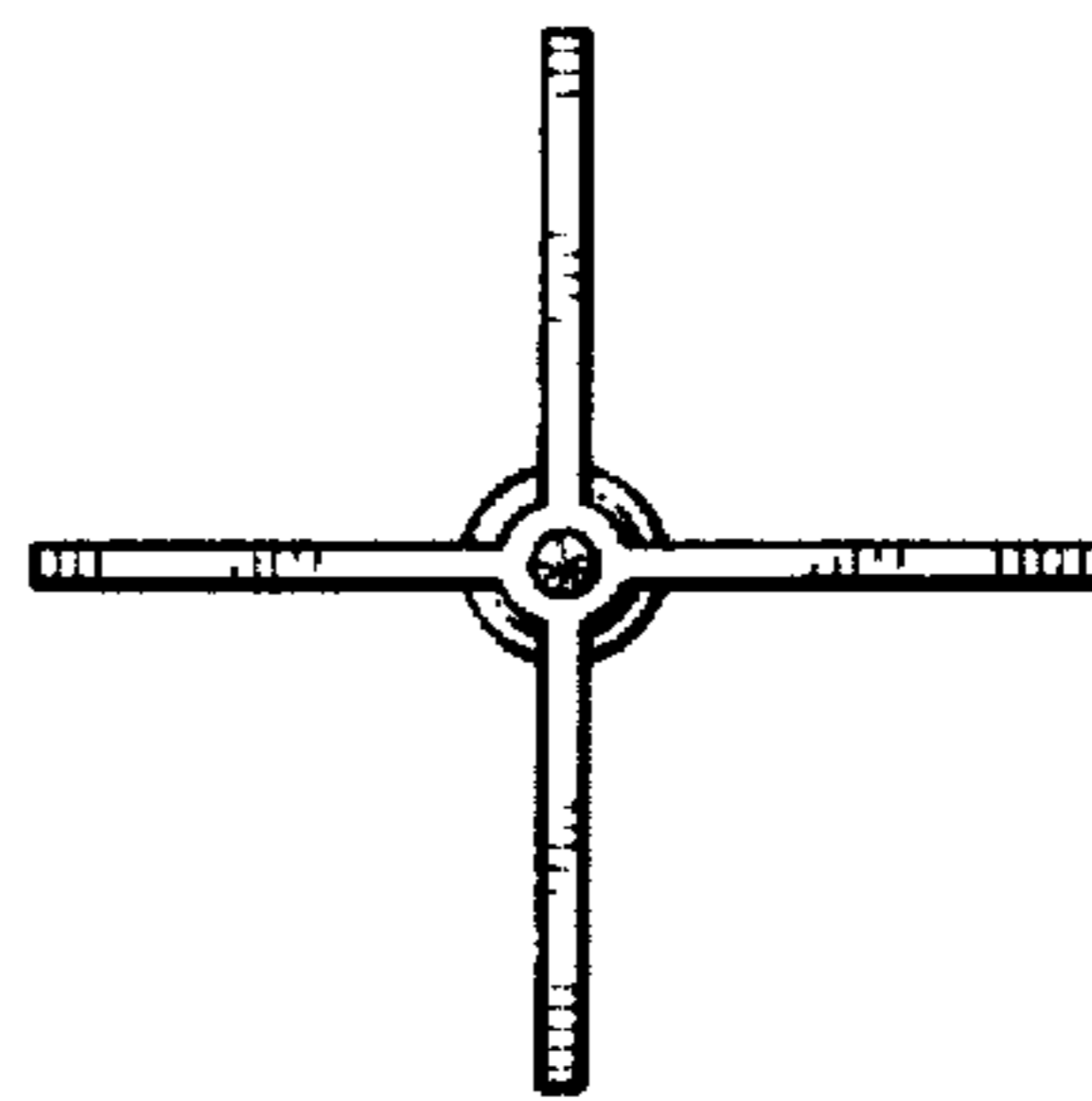




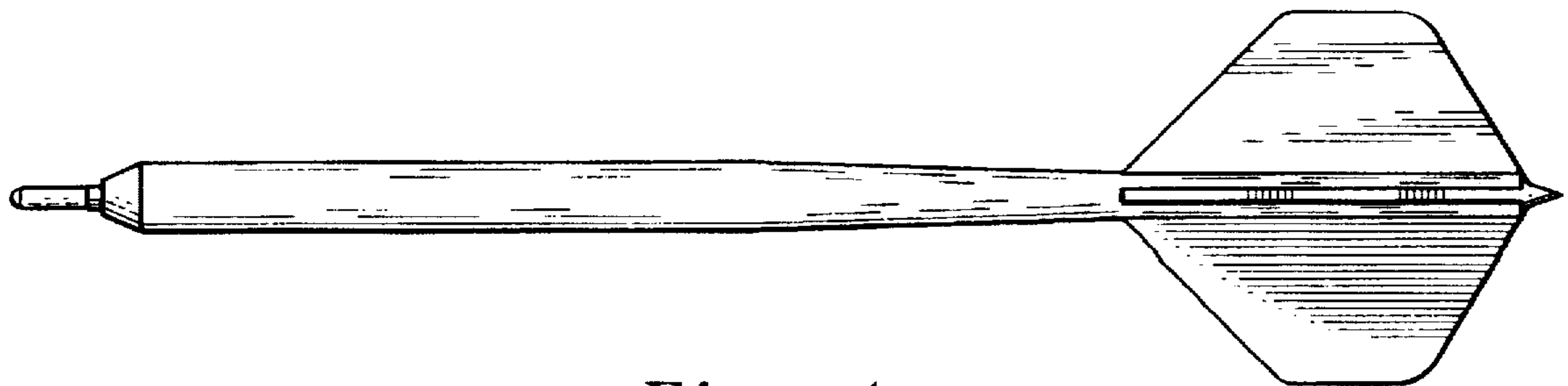

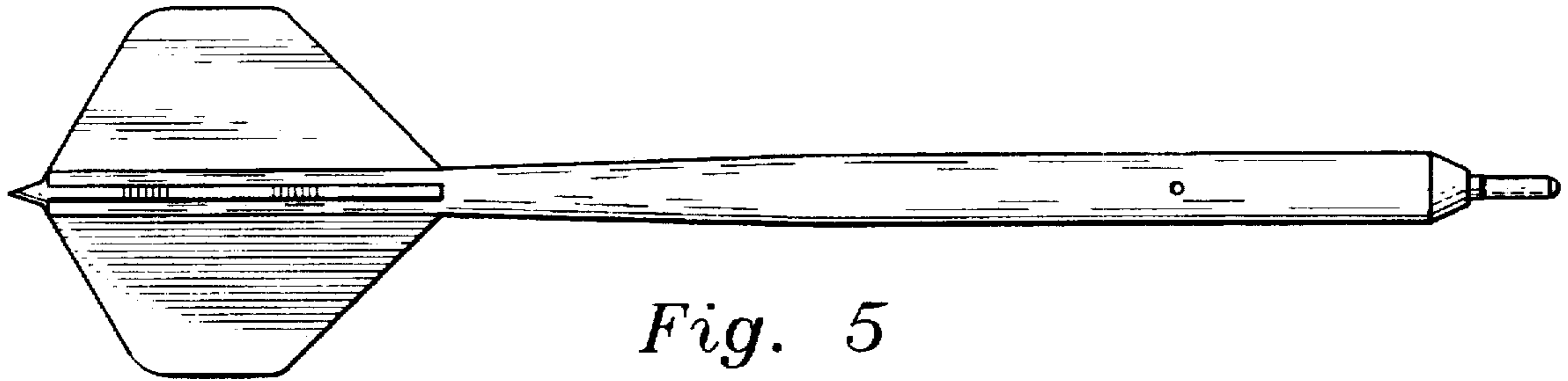

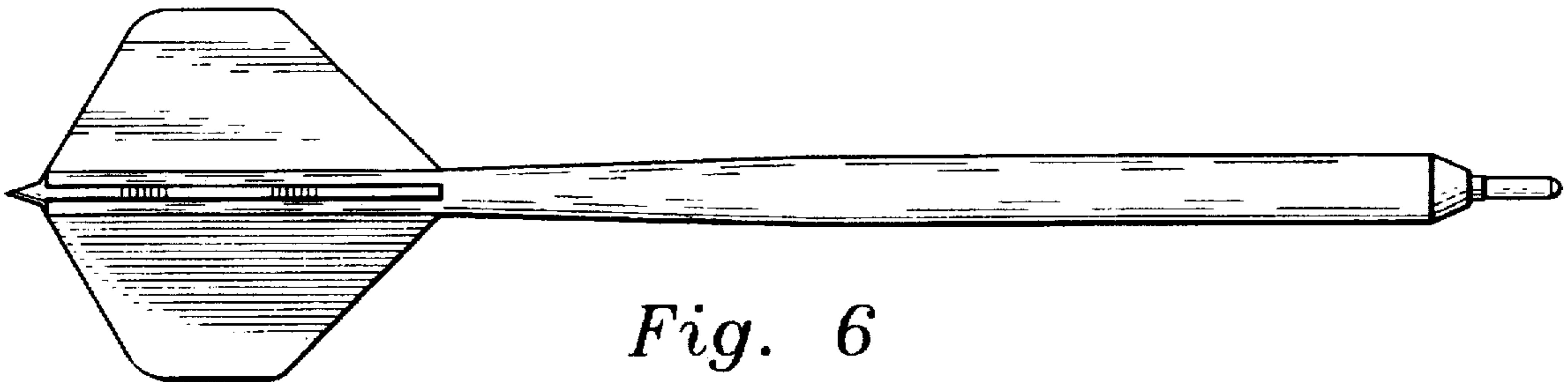

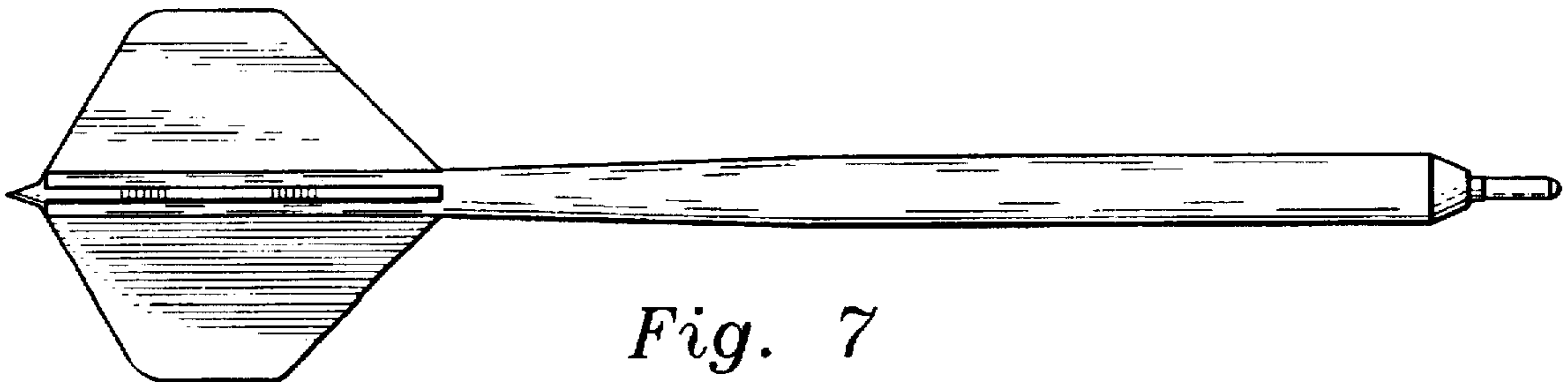
