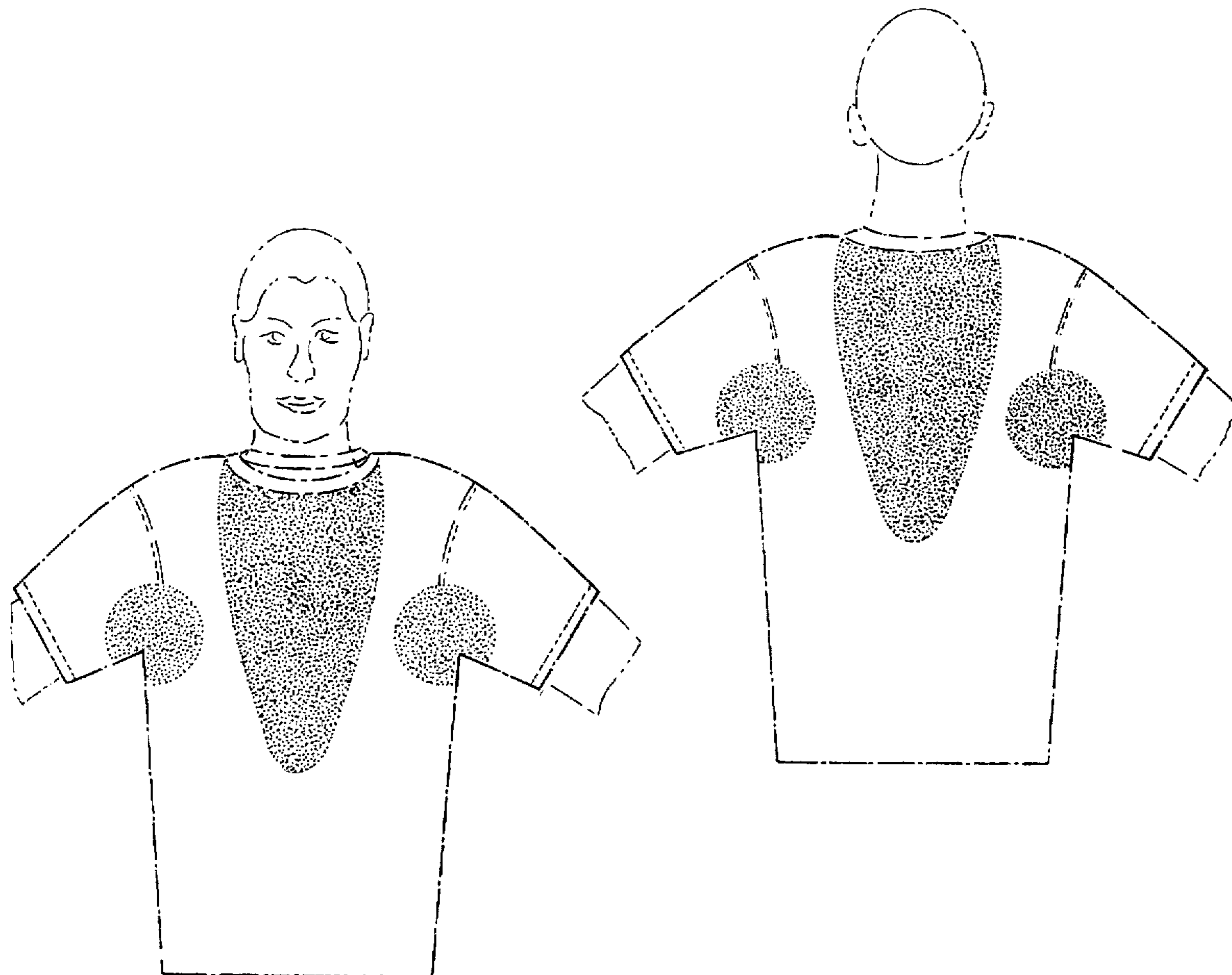
[57] **CLAIM**

The ornamental design for a shirt decoration, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevational view of a first embodiment of a shirt decoration showing my new design;  
FIG. 2 is a rear elevational view thereof;  
FIG. 3 is a front elevational view of a second embodiment thereof; and,  
FIG. 4 is a rear elevational view thereof.  
The broken line showing of the human FIGURE and the shirt in FIGS. 1-4 is for illustrative purposes only and forms no part of the claimed design.

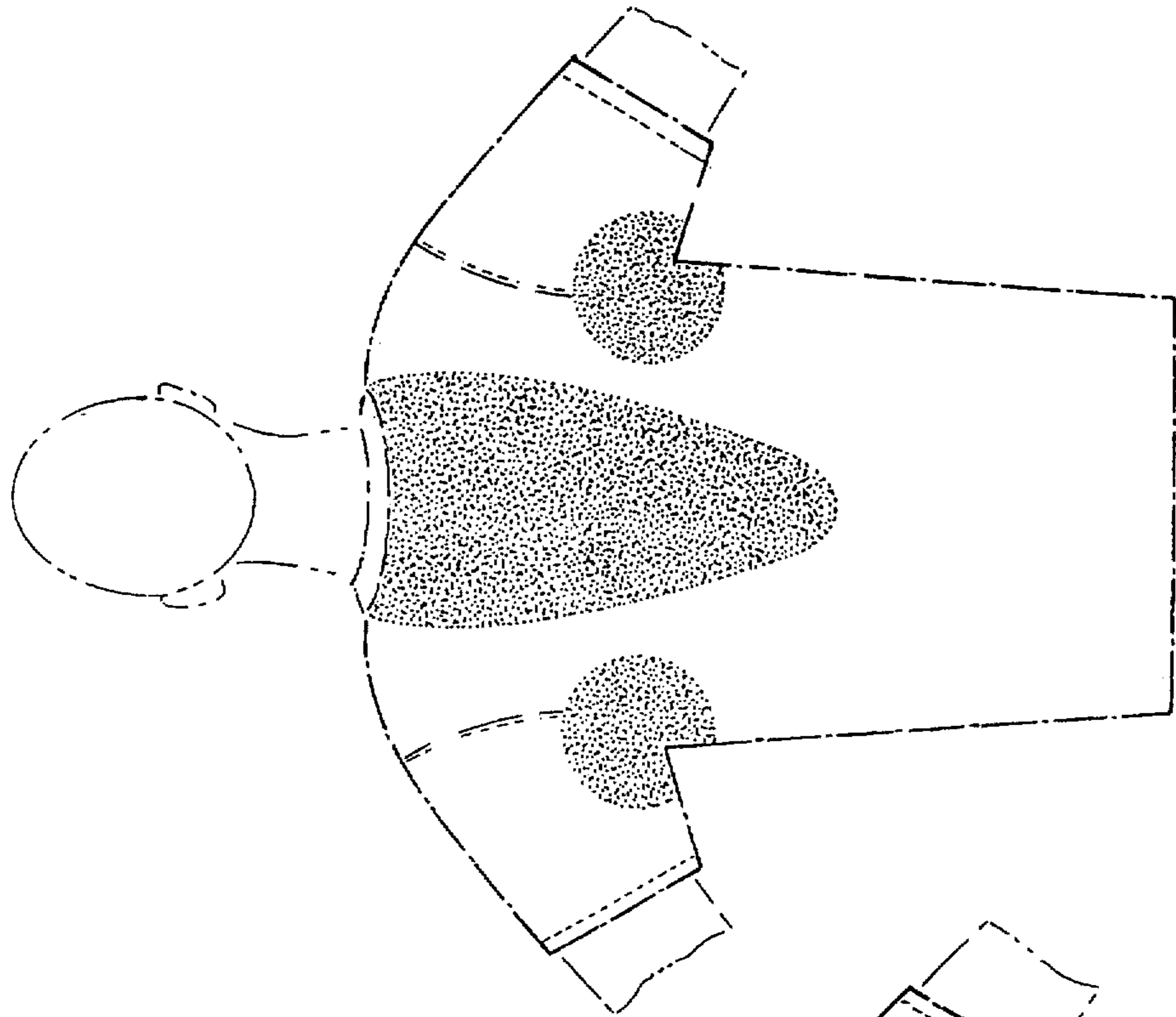

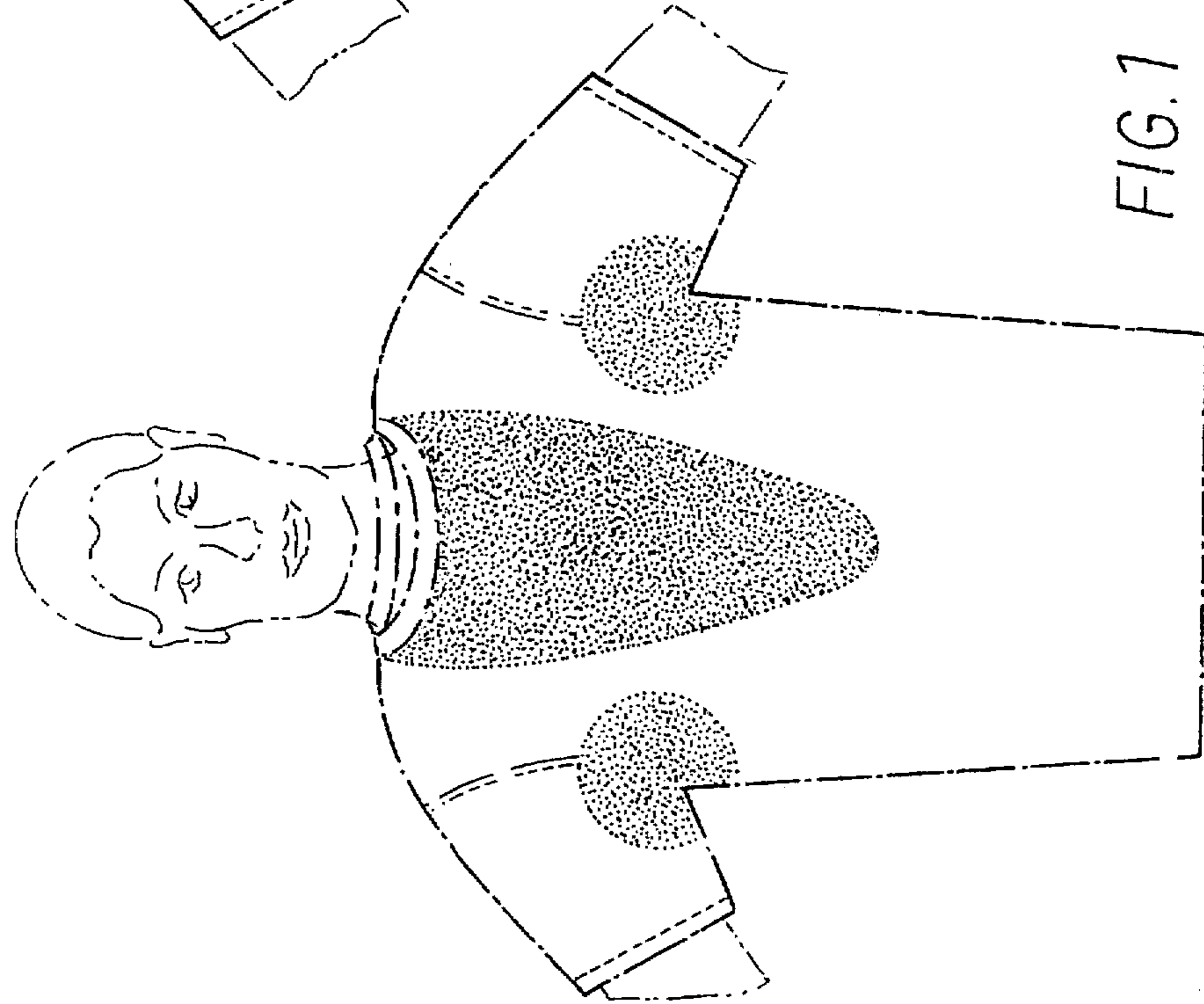

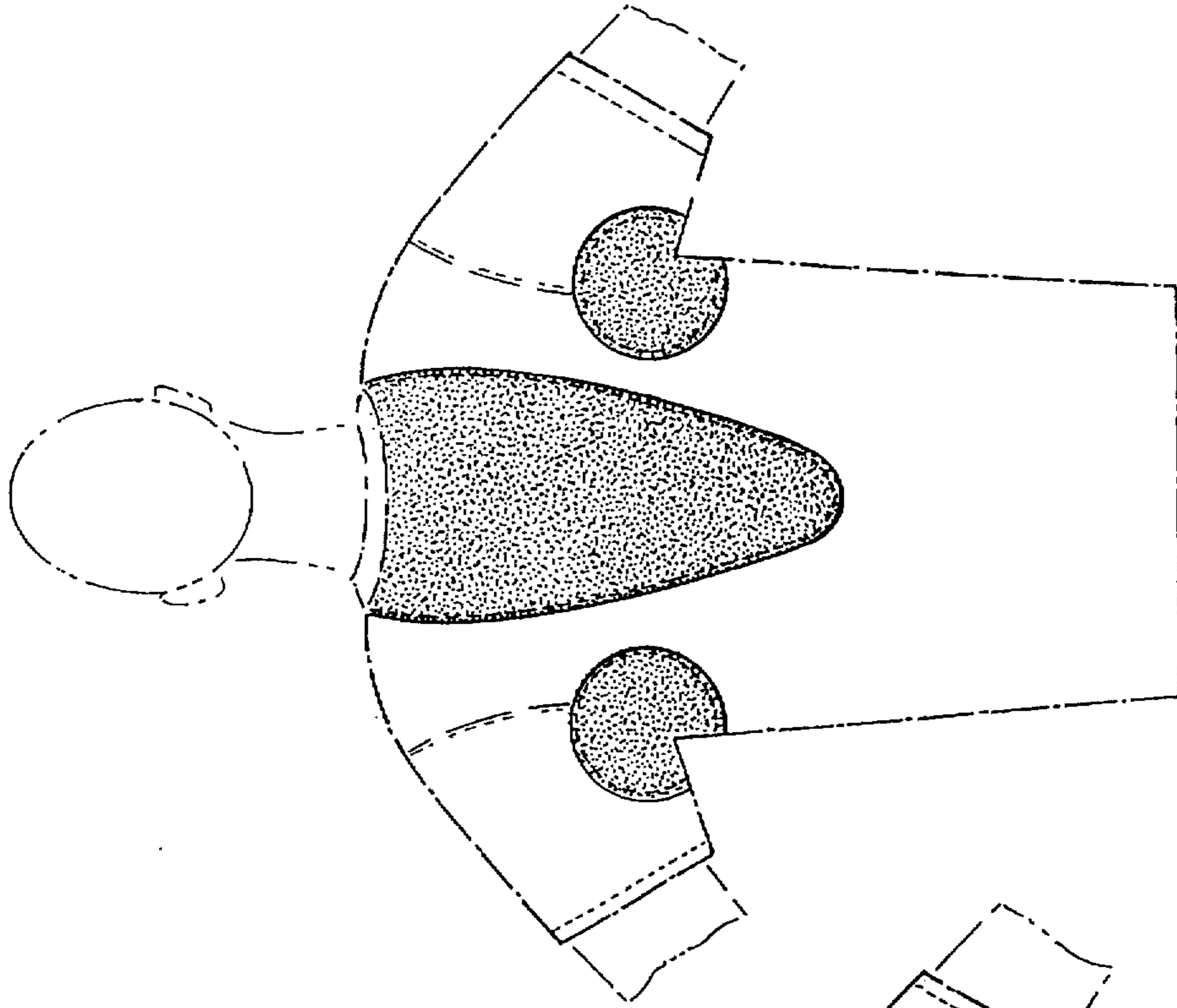

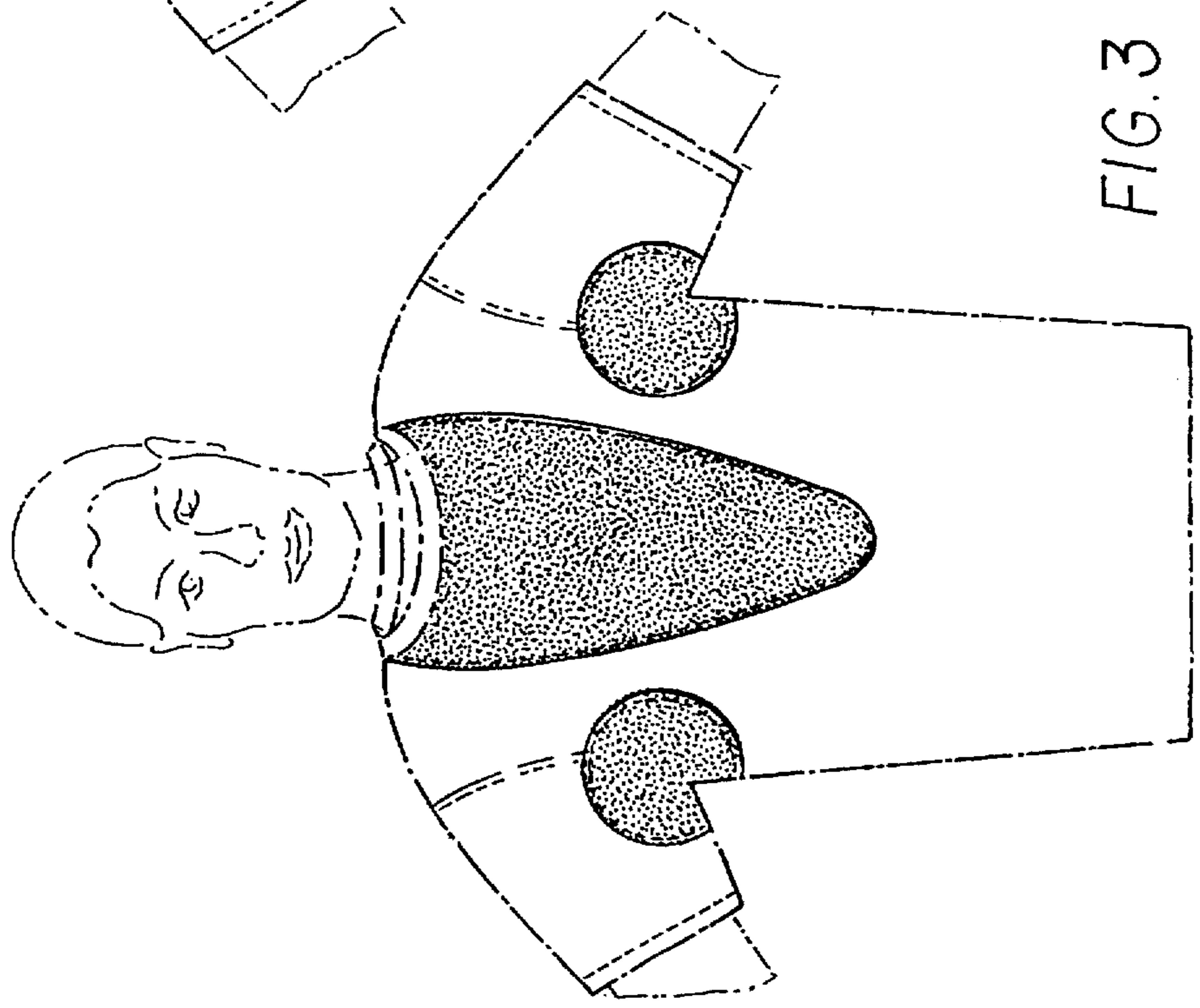
