The ornamental design for the bed, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevational view of a first embodiment of the bed comprising my new design  
 FIG. 2 is a side elevational view thereof, the opposite side elevational view being a mirror image;  
 FIG. 3 is a top plan view thereof;  
 FIG. 4 is a front elevational view of a second embodiment of the bed comprising my new design;  
 FIG. 5 is a side elevational view thereof, the opposite side elevational view being a mirror image;  
 FIG. 6 is a top plan view thereof;  
 FIG. 7 is a front elevational view of a third embodiment of the bed comprising my new design;  
 FIG. 8 is a side elevational view thereof, the opposite side elevational view being a mirror image; and,  
 FIG. 9 is a top plan view thereof.



















