[57] CLAIM

The ornamental design for a pair of ski racks, as shown and described.

#### DESCRIPTION

FIG. 1 is a perspective view of a preferred embodiment of the present invention showing the preferred embodiment mounted to a luggage carrier on top of a vehicle, where the luggage carrier and vehicle are shown in broken lines for illustrative purposes only and form no part of the claim design;

FIG. 2 is a top view, shown at an enlarged scale, of one of the ski racks of FIG. 1;

FIG. 3 is a front view, shown at an enlarged scale, of one of the ski racks of FIG. 1; FIG. 4 is a rear view, shown at an enlarged scale, of one of the ski racks of FIG. 1; FIG. 5 is a bottom view, shown at an enlarged scale, of one of the ski racks of FIG. 1; FIG. 6 is a left end view, shown at an enlarged scale, of one of the ski racks of FIG. 1; and, FIG. 7 is a right end view, shown at an enlarged scale, of one of the ski racks of FIG. 1. The ski rack not shown in FIG. 2-7 is identical to that shown therein.
