The ornamental design for a shoe outsole, as shown and described.

DESCRIPTION

FIG. 1 is a bottom plan view of shoe outsole showing our new design;

FIG. 2 is a right side elevational view thereof;

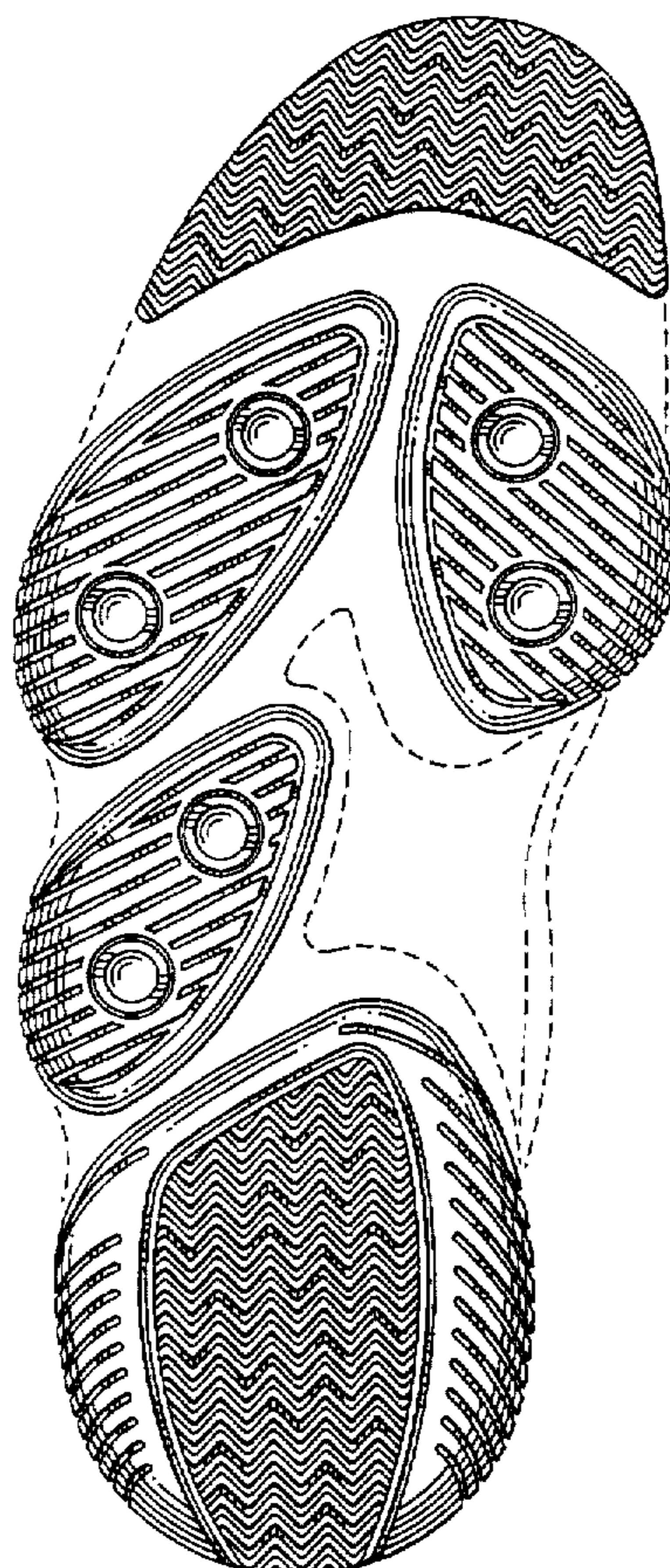
FIG. 3 is a left side elevational view thereof;

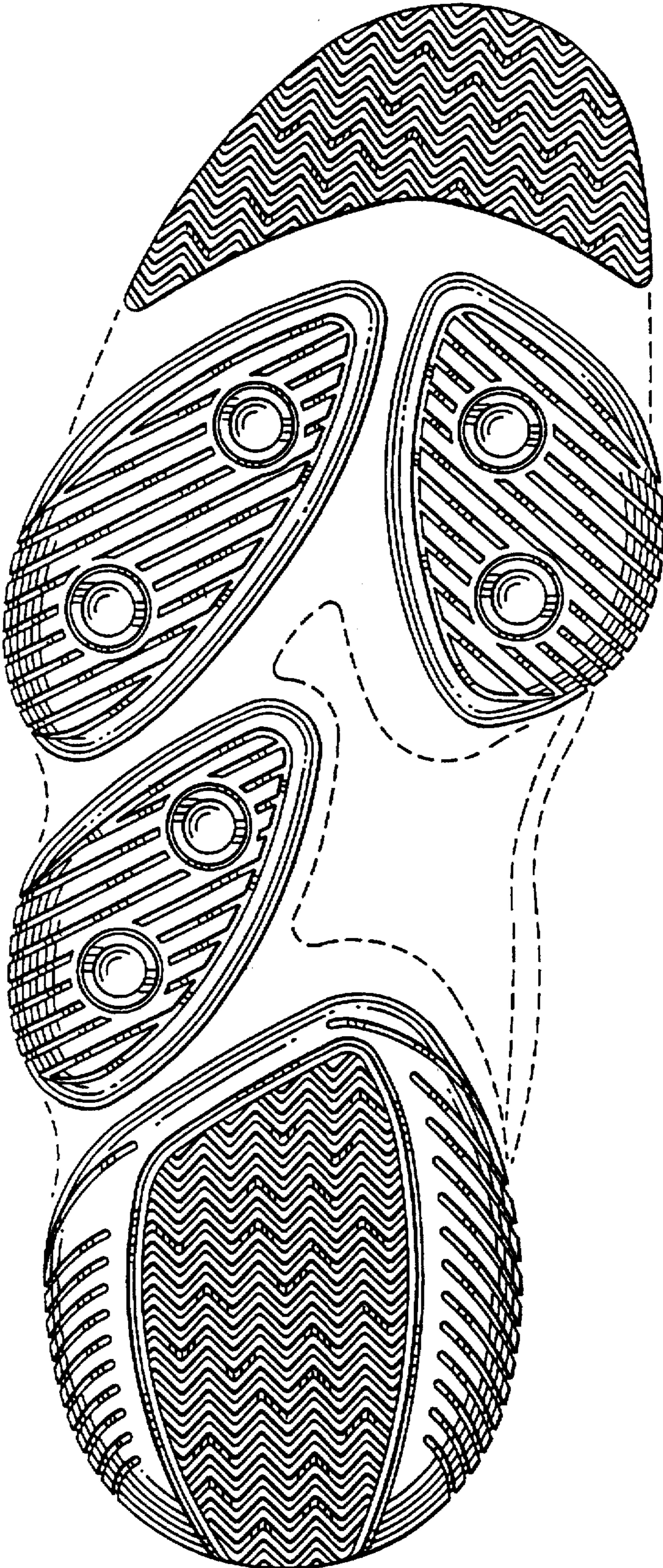

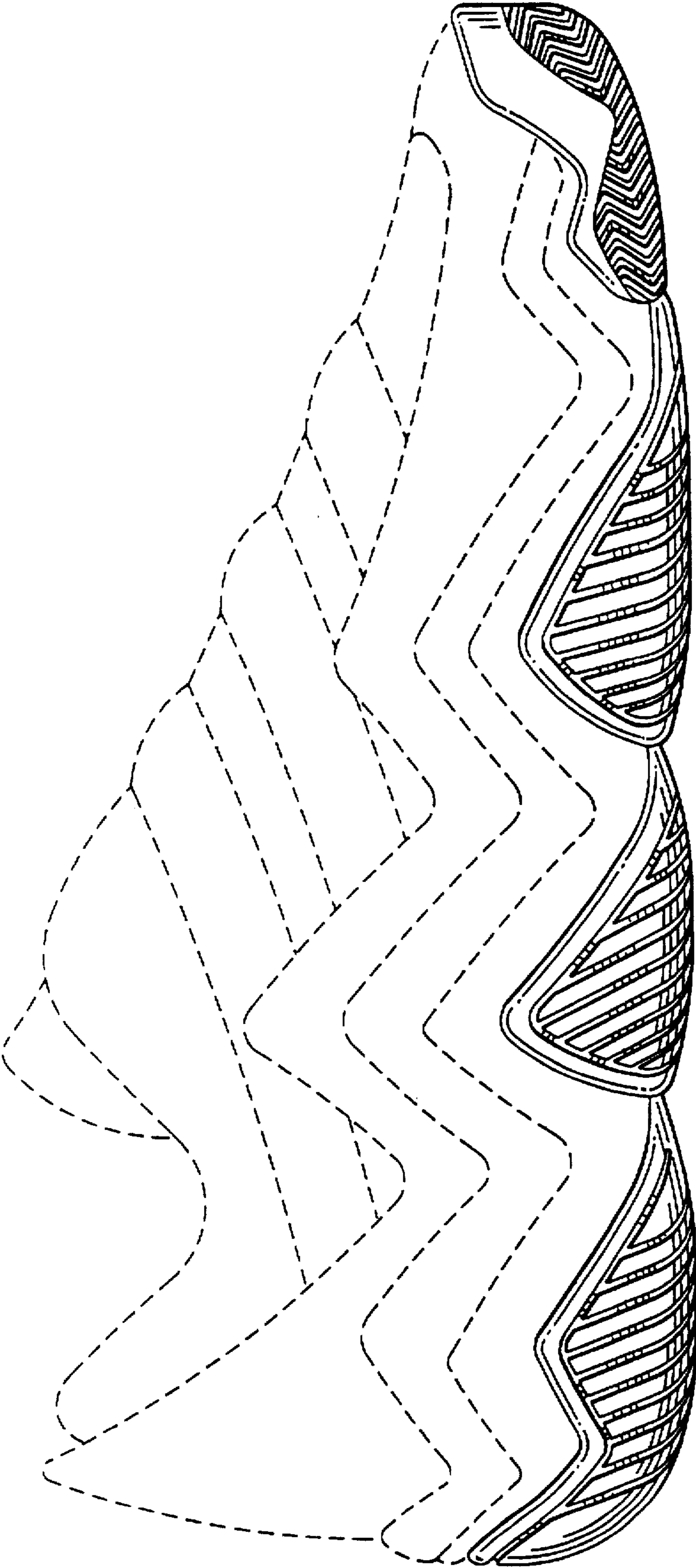

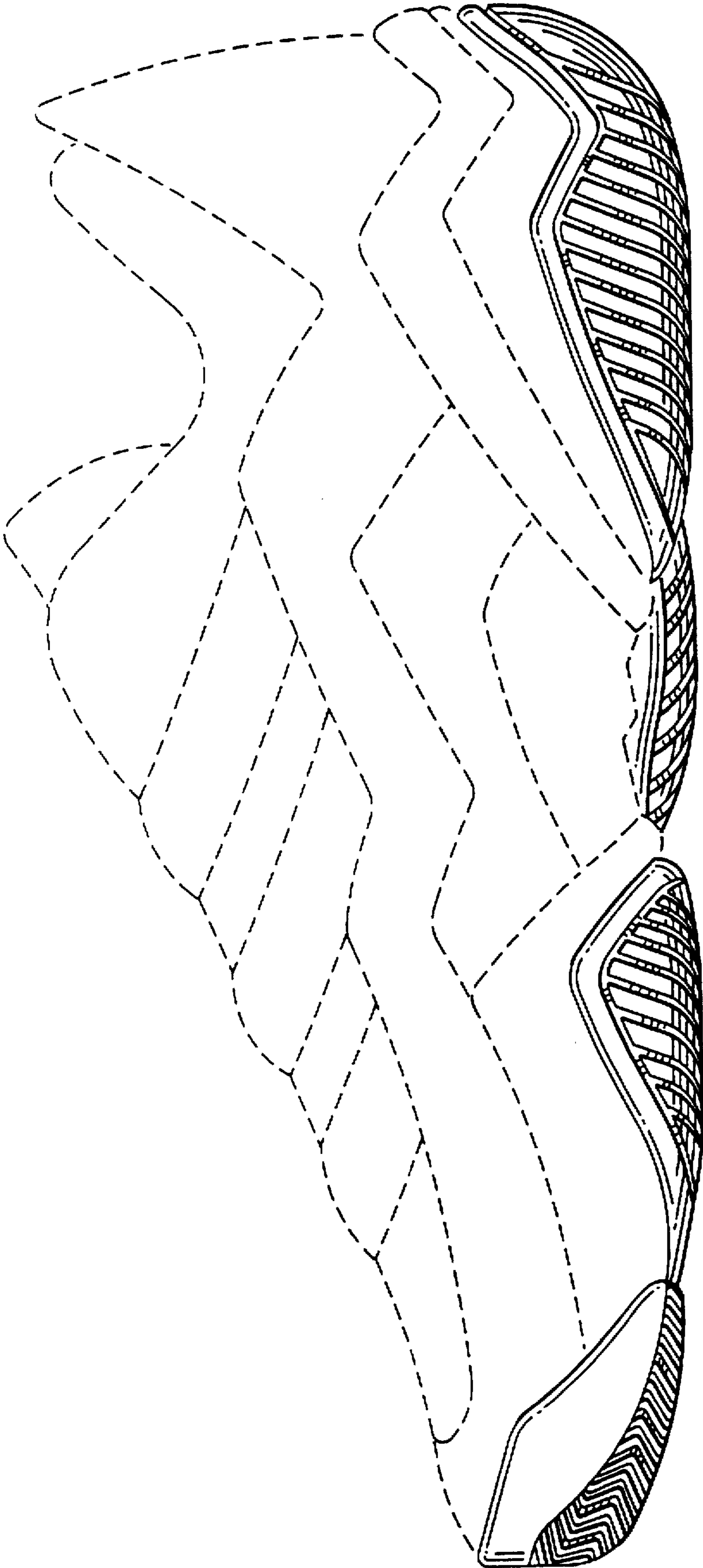

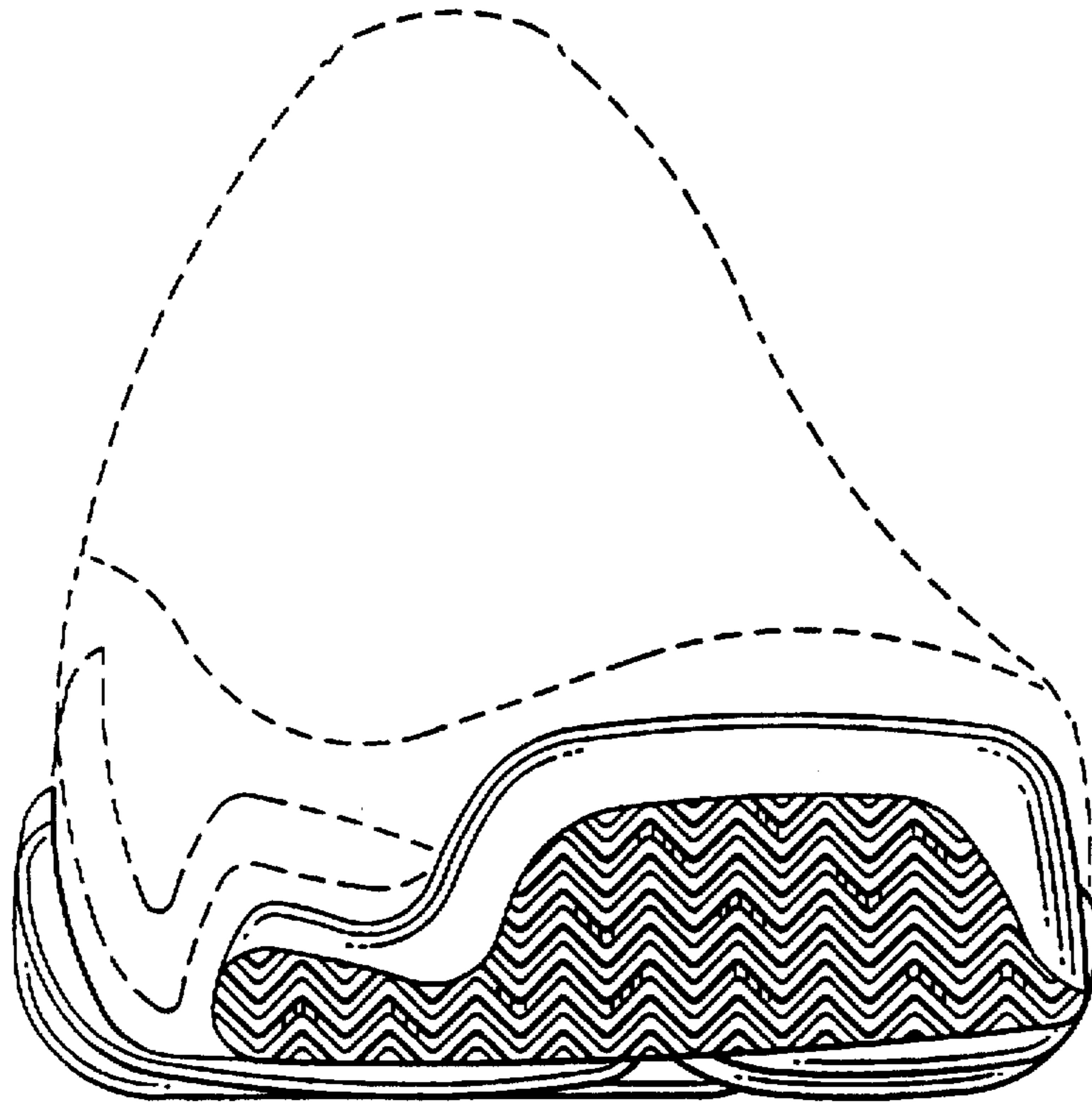

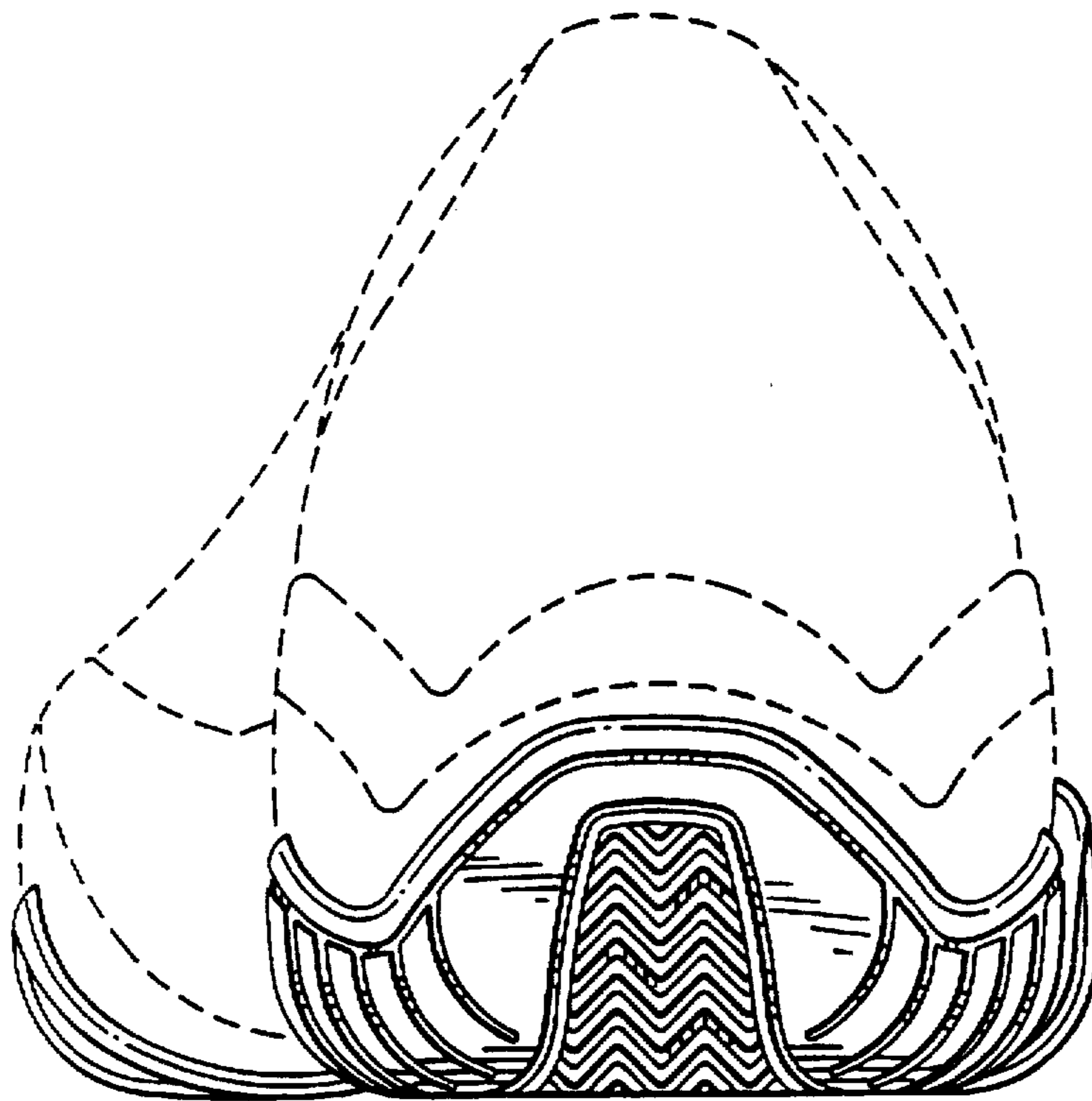
