FIG. 1 is a top perspective view of a preferred embodiment of clamping jaws for a workbench in accordance with the present invention;

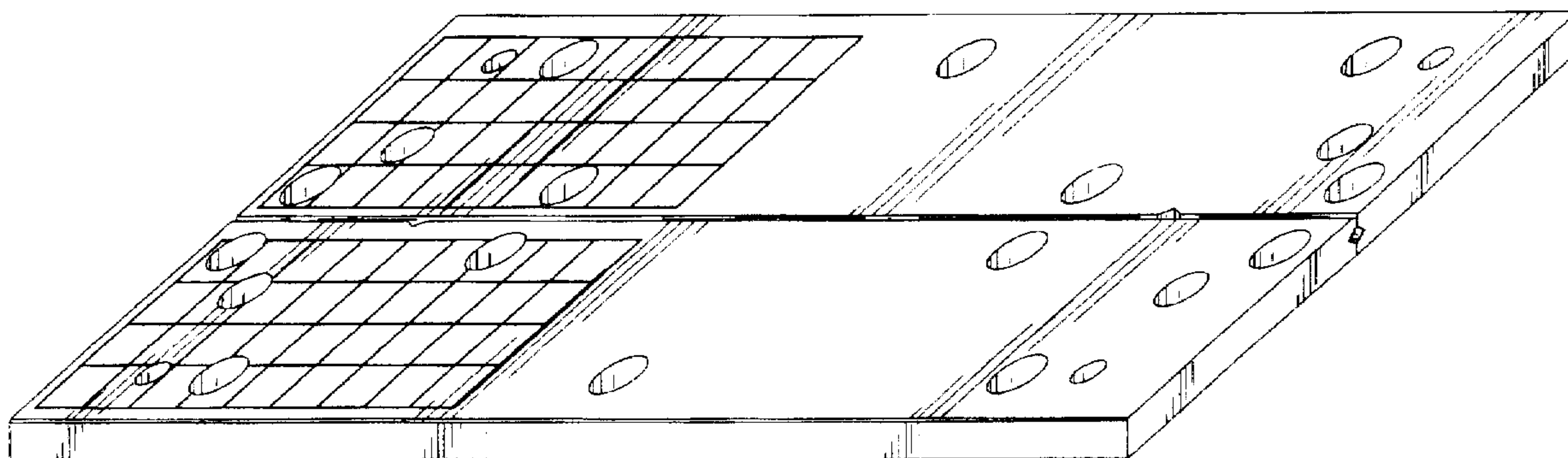
FIG. 2 is a top plan view of the clamping jaws for a workbench of FIG. 1;

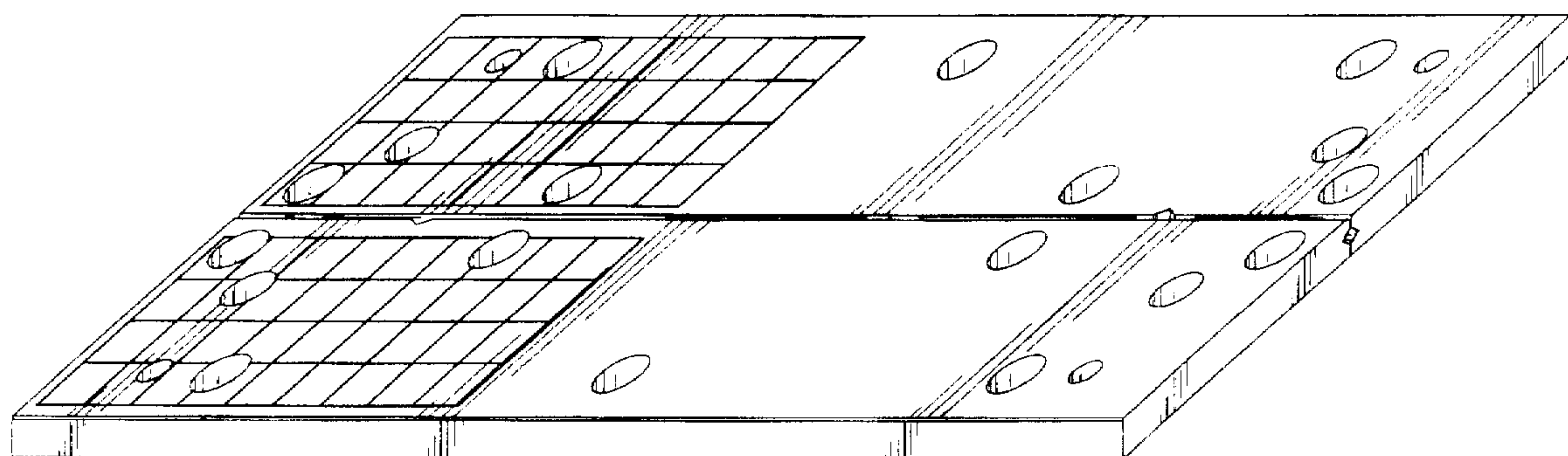

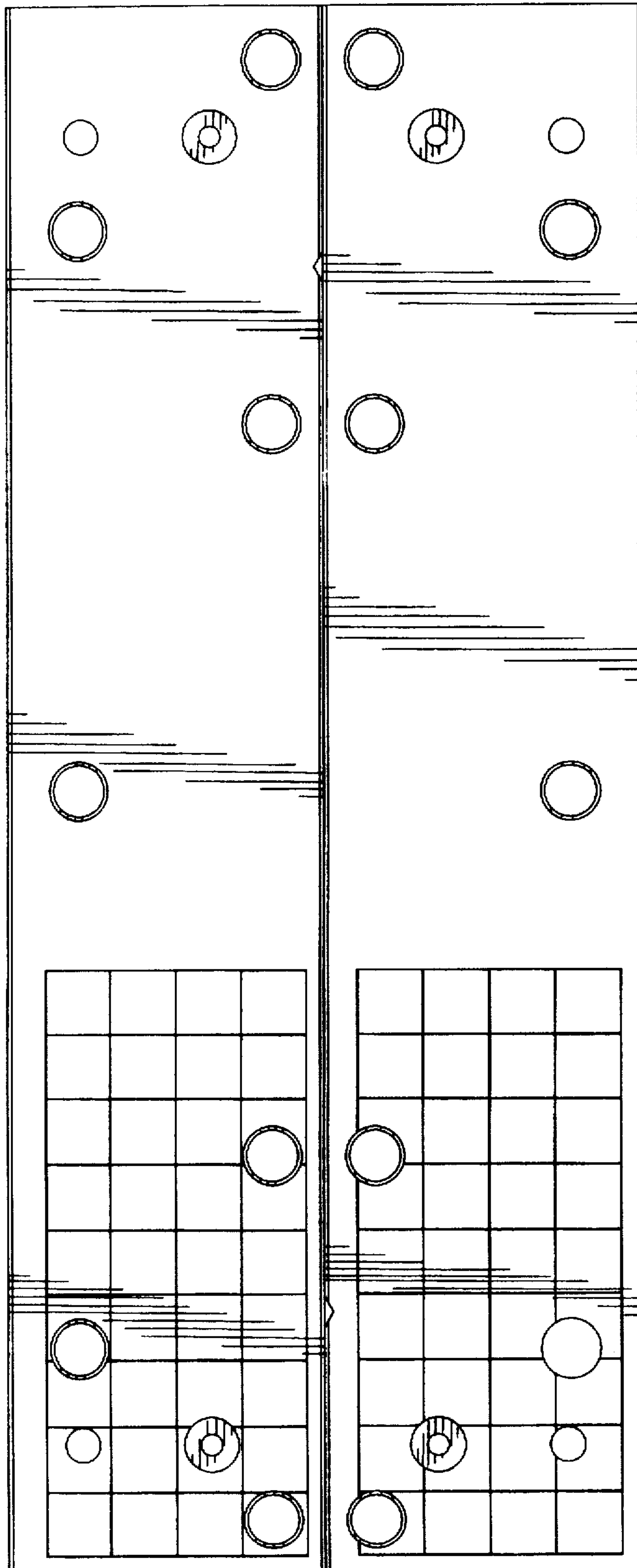

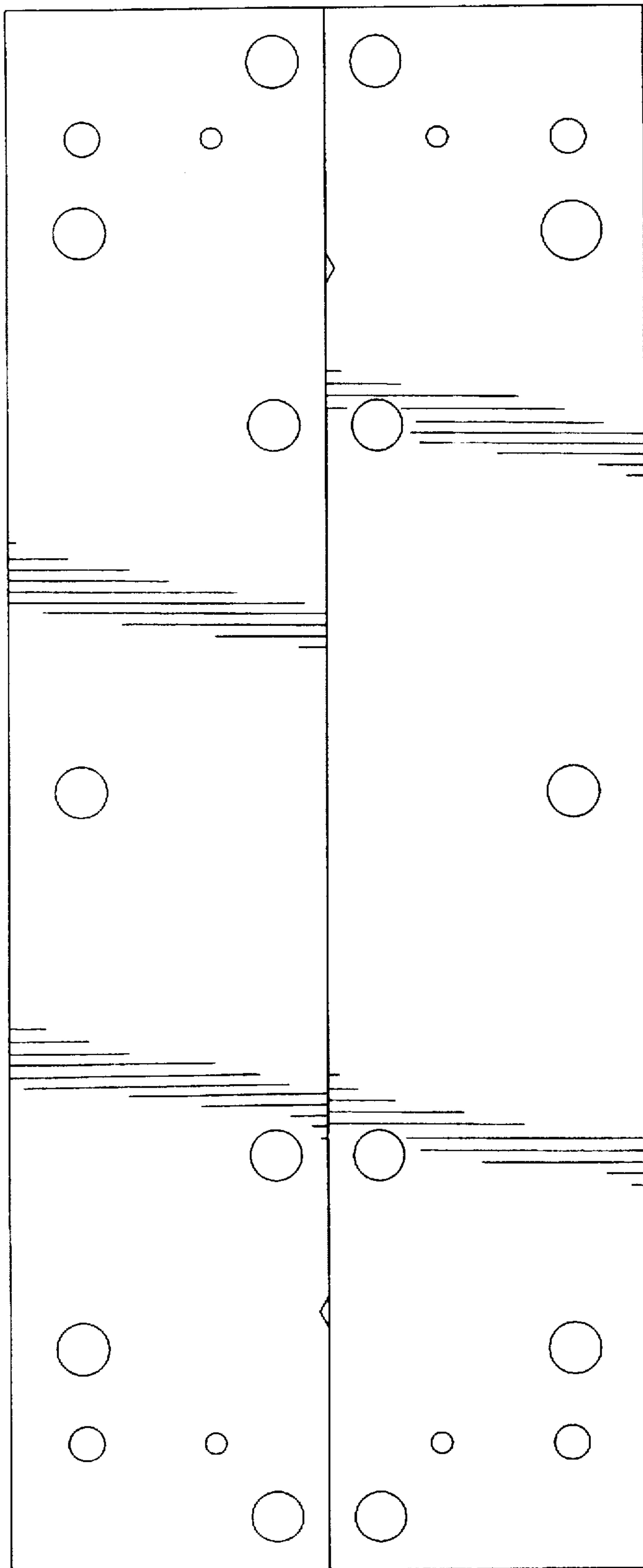

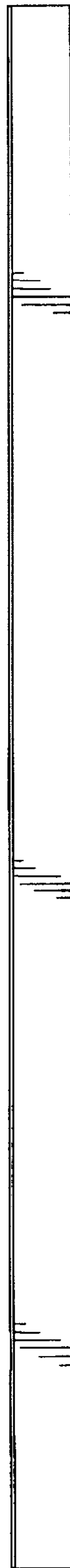
