[57] **CLAIM**

The ornamental design for a stuffed toy iguana, as shown.

DESCRIPTION

FIG. 1 is a top, left perspective view of a stuffed toy iguana showing our new design;

FIG. 2 is a front perspective view thereof;

FIG. 3 is a right side perspective view thereof;

FIG. 4 is a left side perspective view thereof;

FIG. 5 is a top, rear perspective view thereof;

FIG. 6 is a bottom, rear perspective view thereof;

FIG. 7 is a top, left perspective view of an alternate embodiment of the stuffed toy iguana of FIG. 1;

FIG. 8 is a front perspective view of the FIG. 7 embodiment;

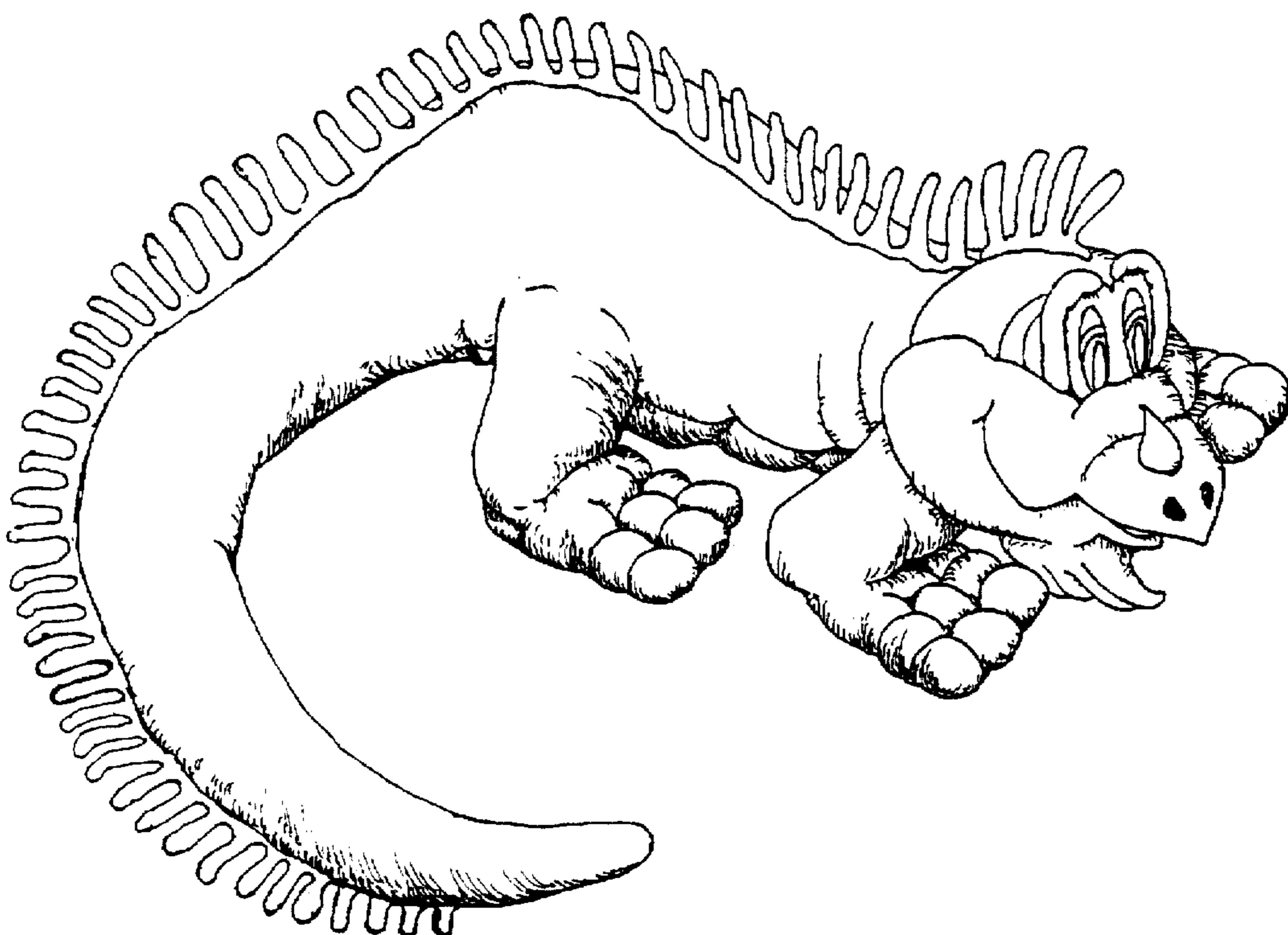
FIG. 9 is a right side perspective view of the FIG. 7 embodiment;

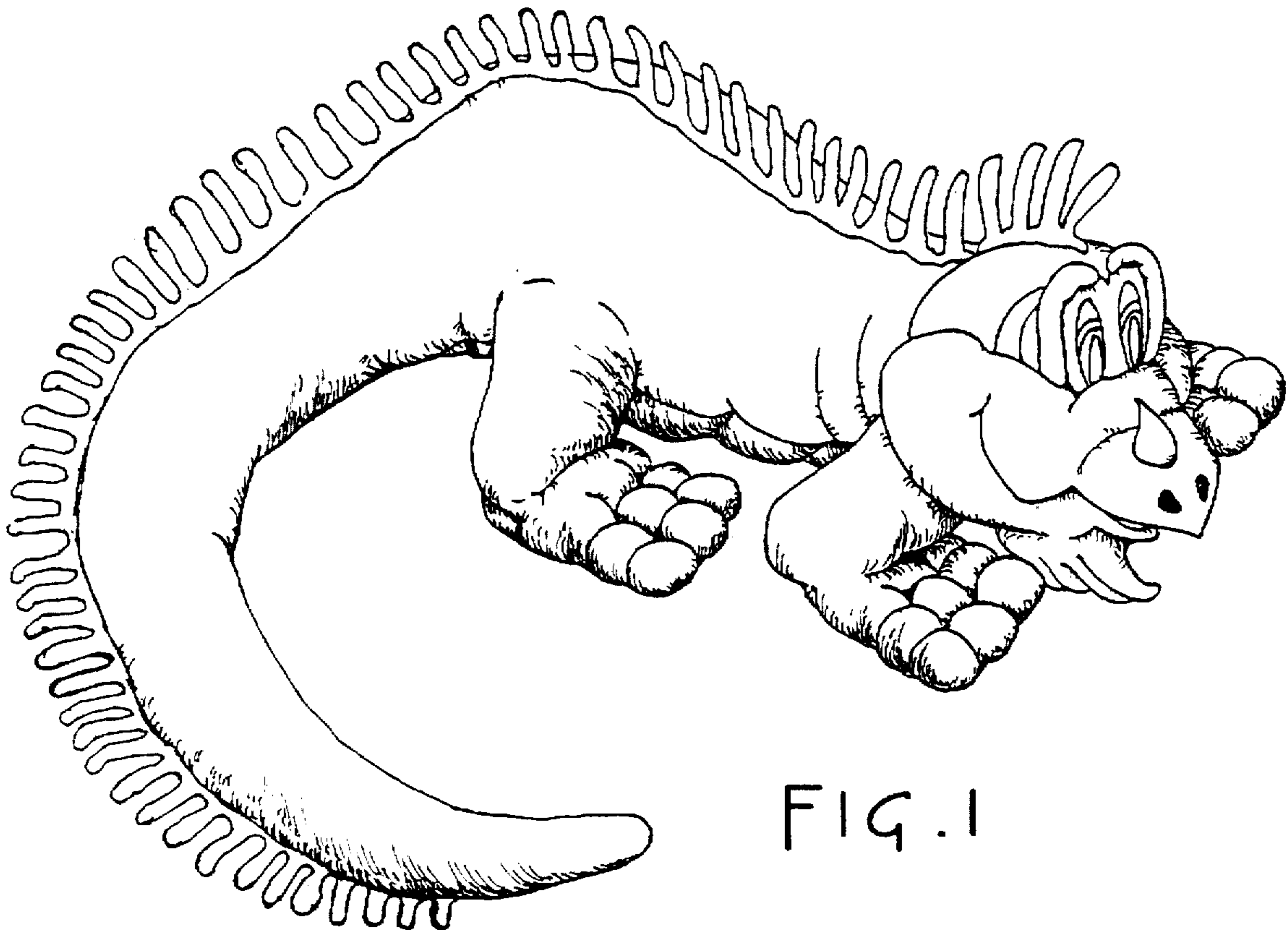

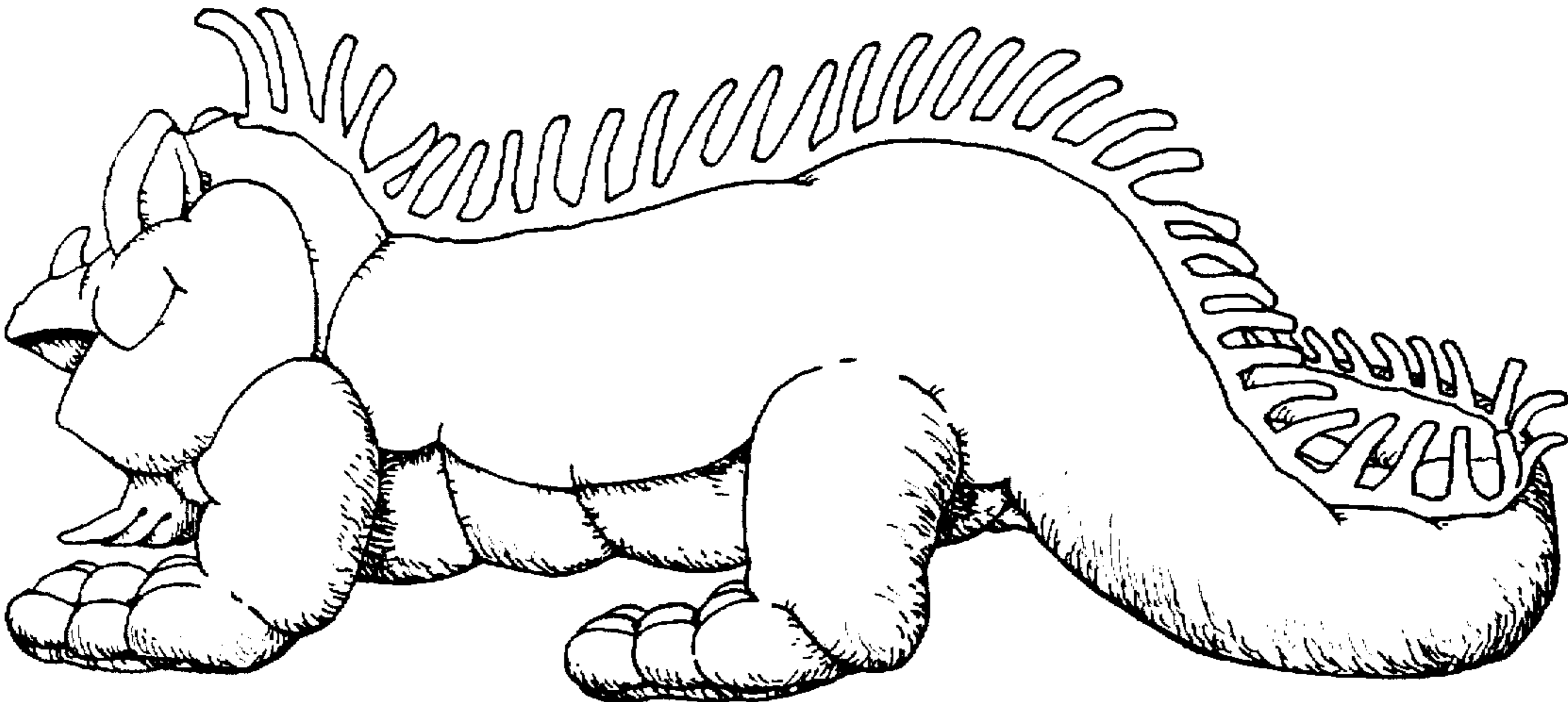

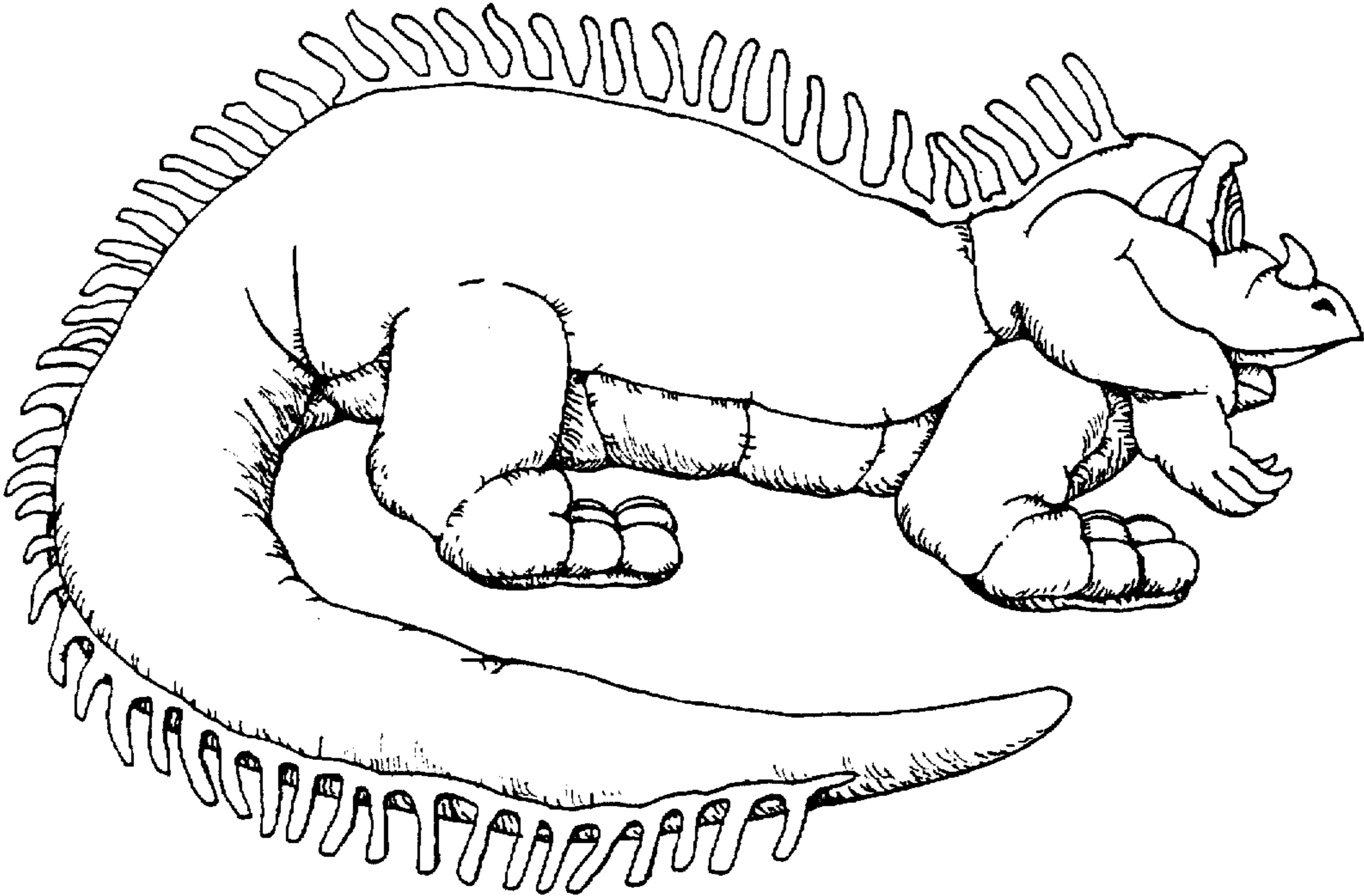

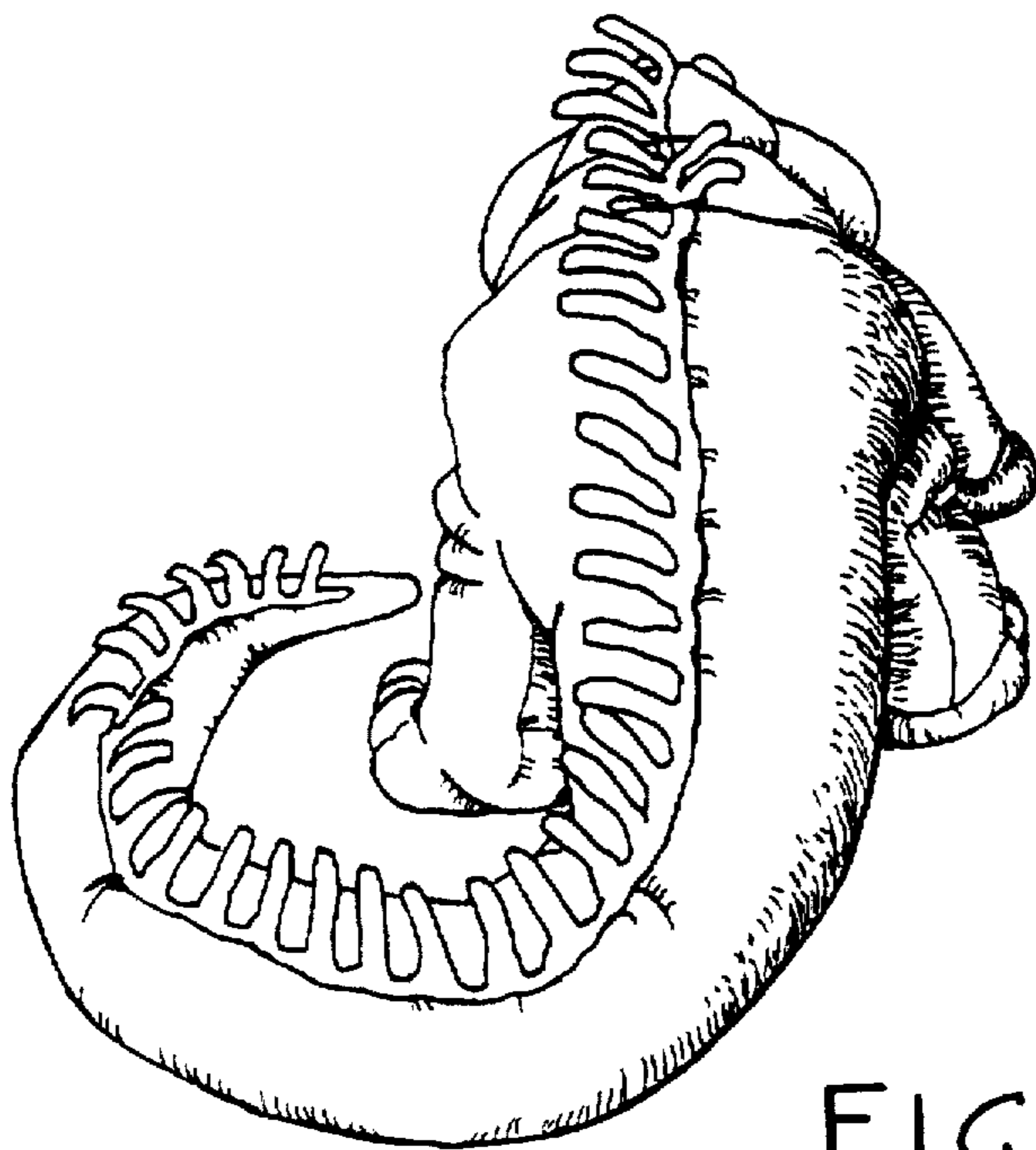

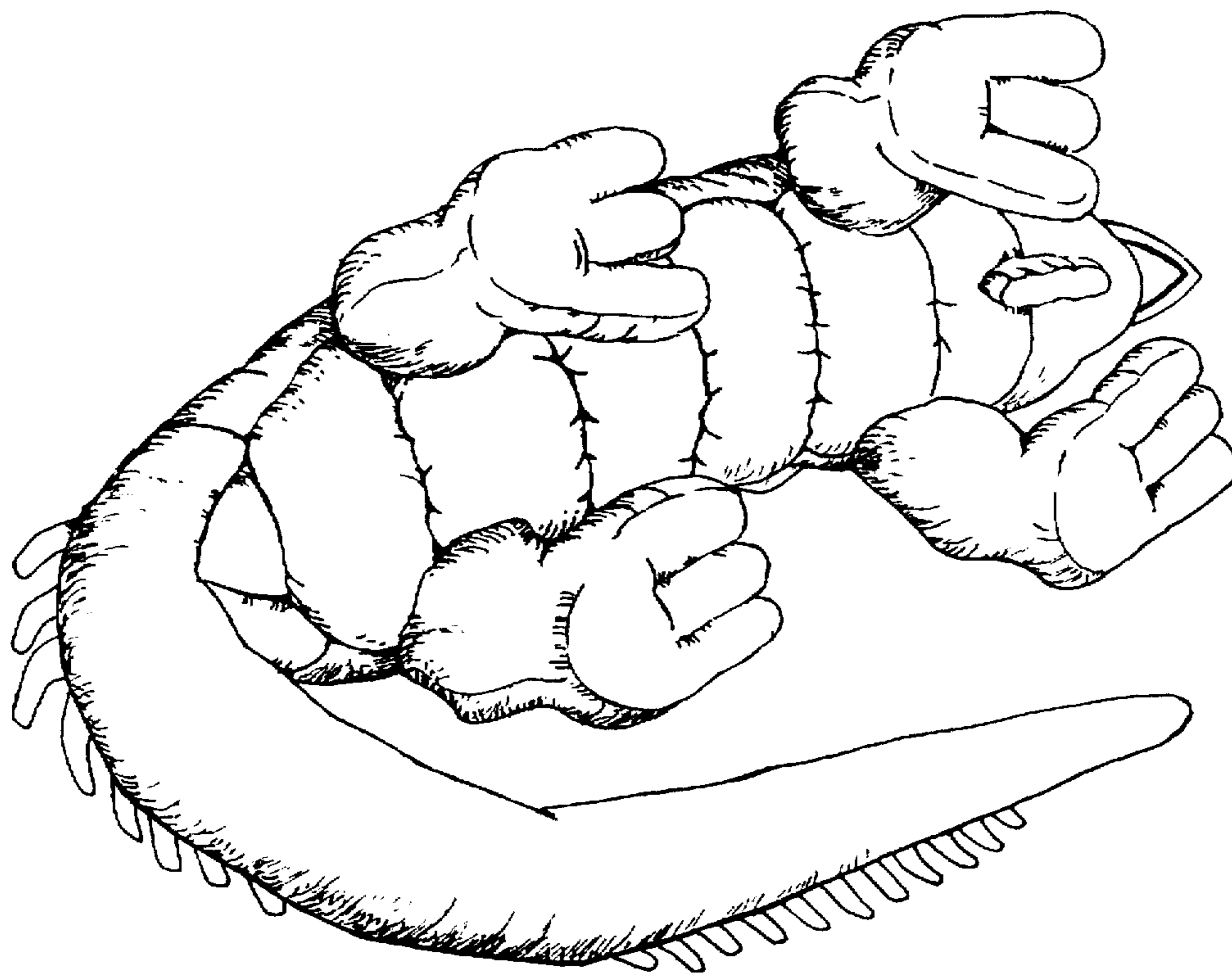

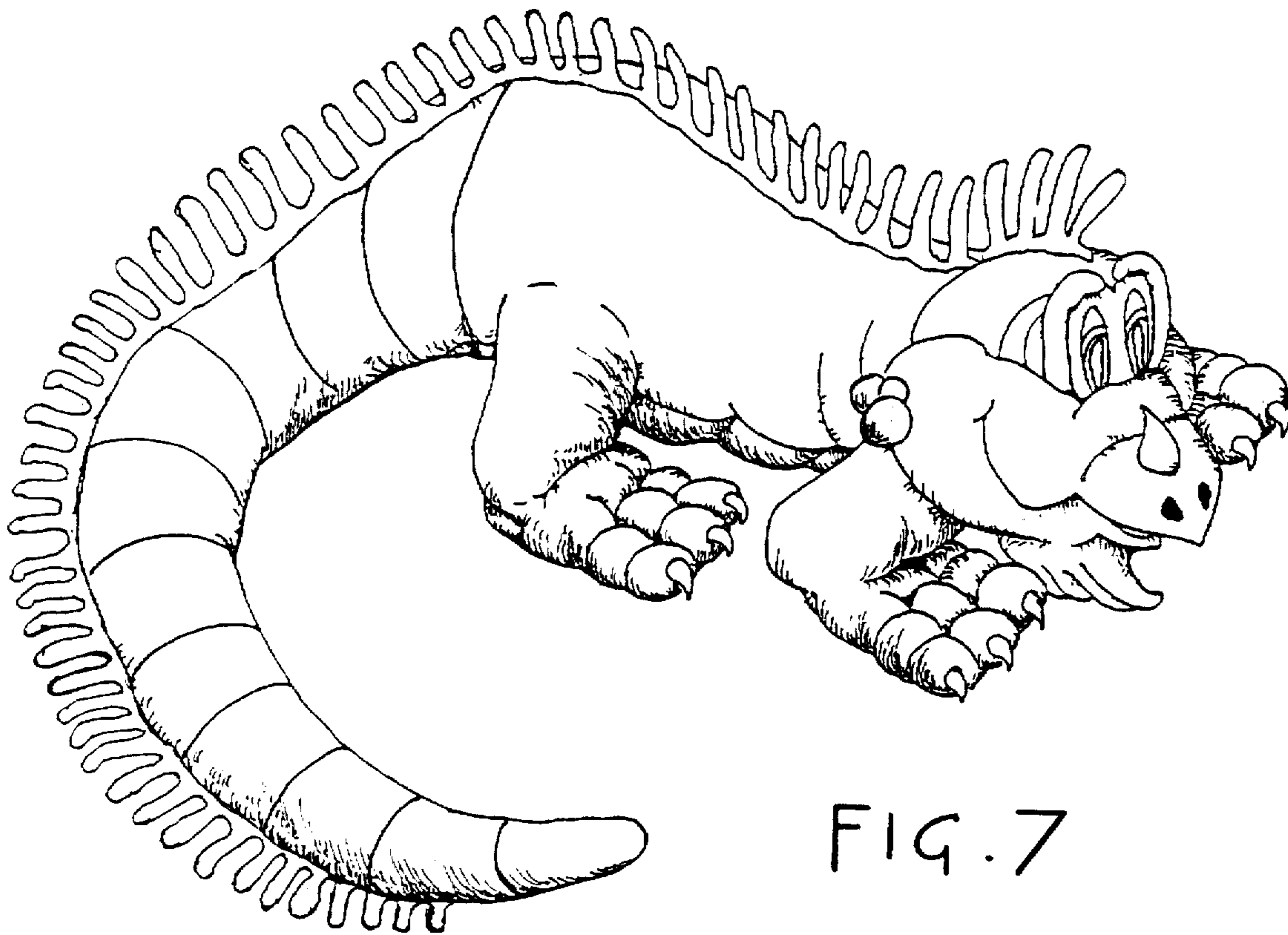

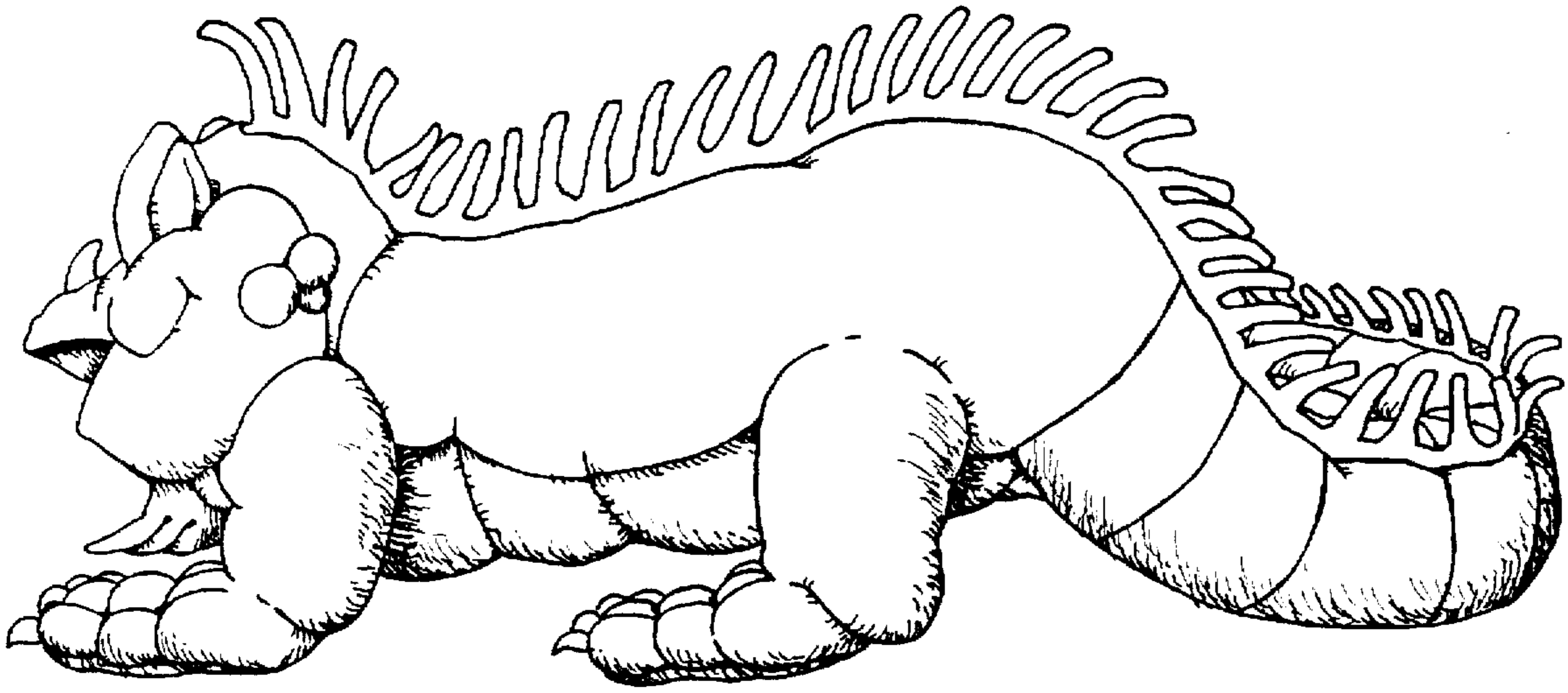

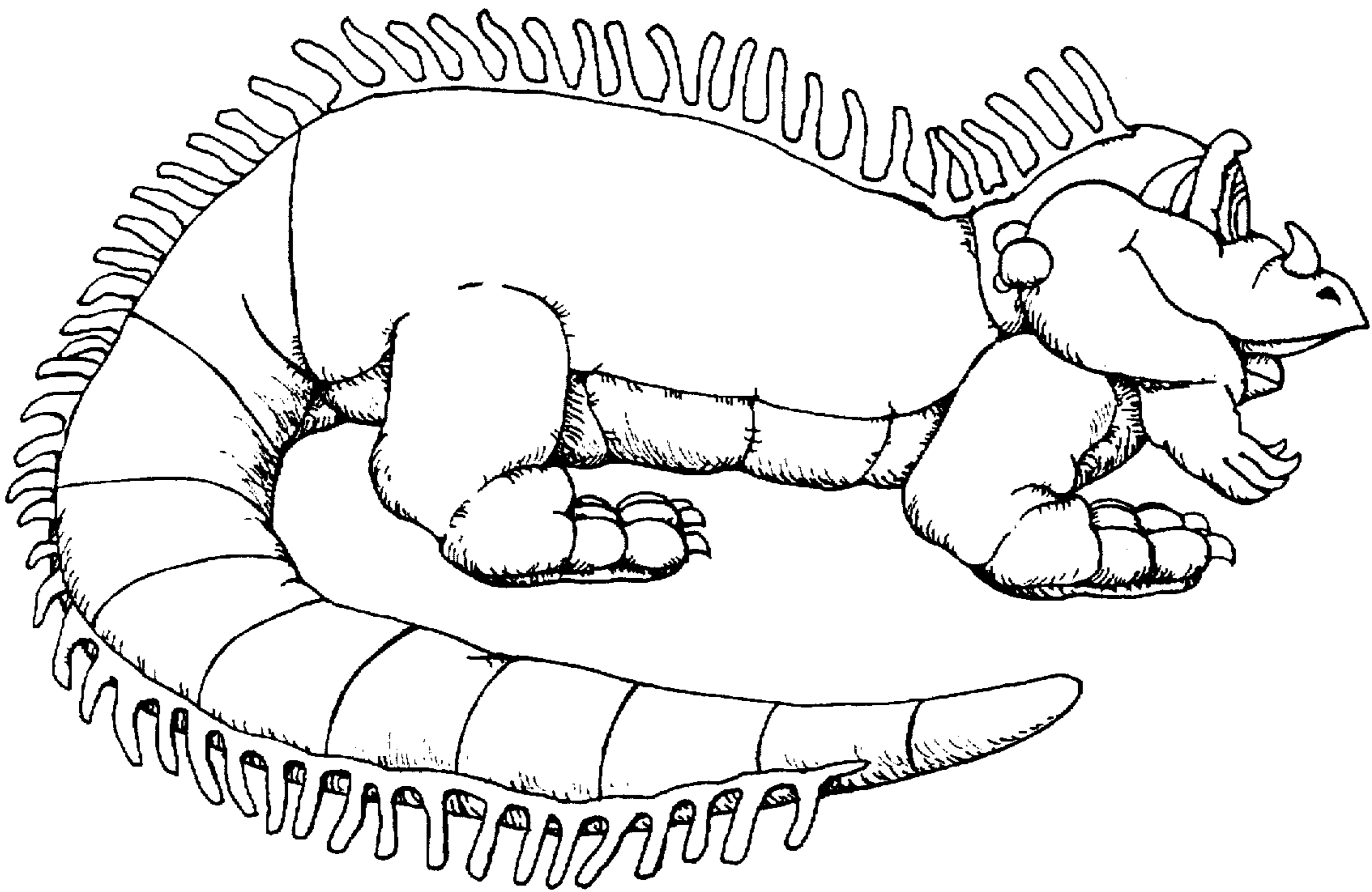

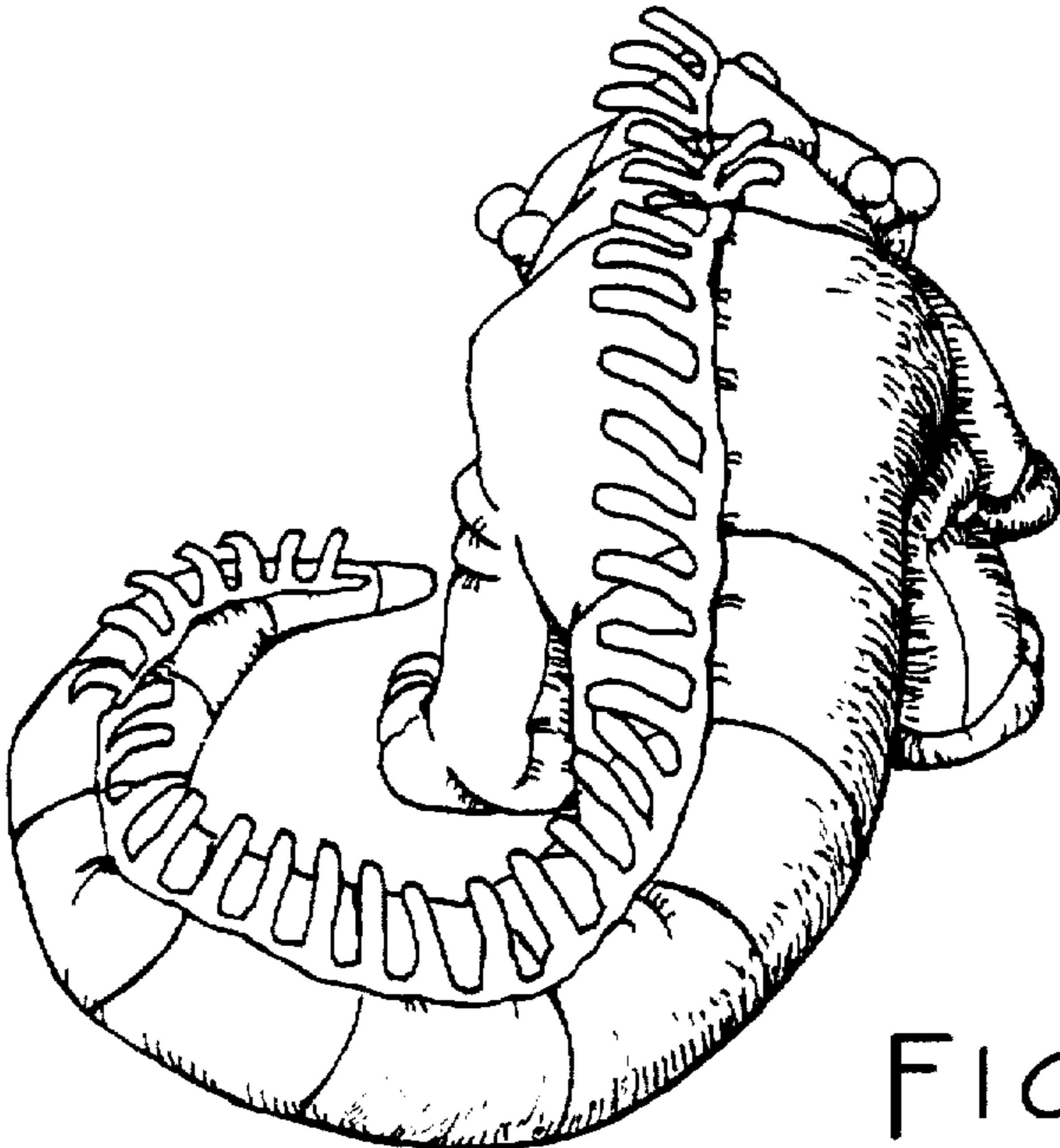

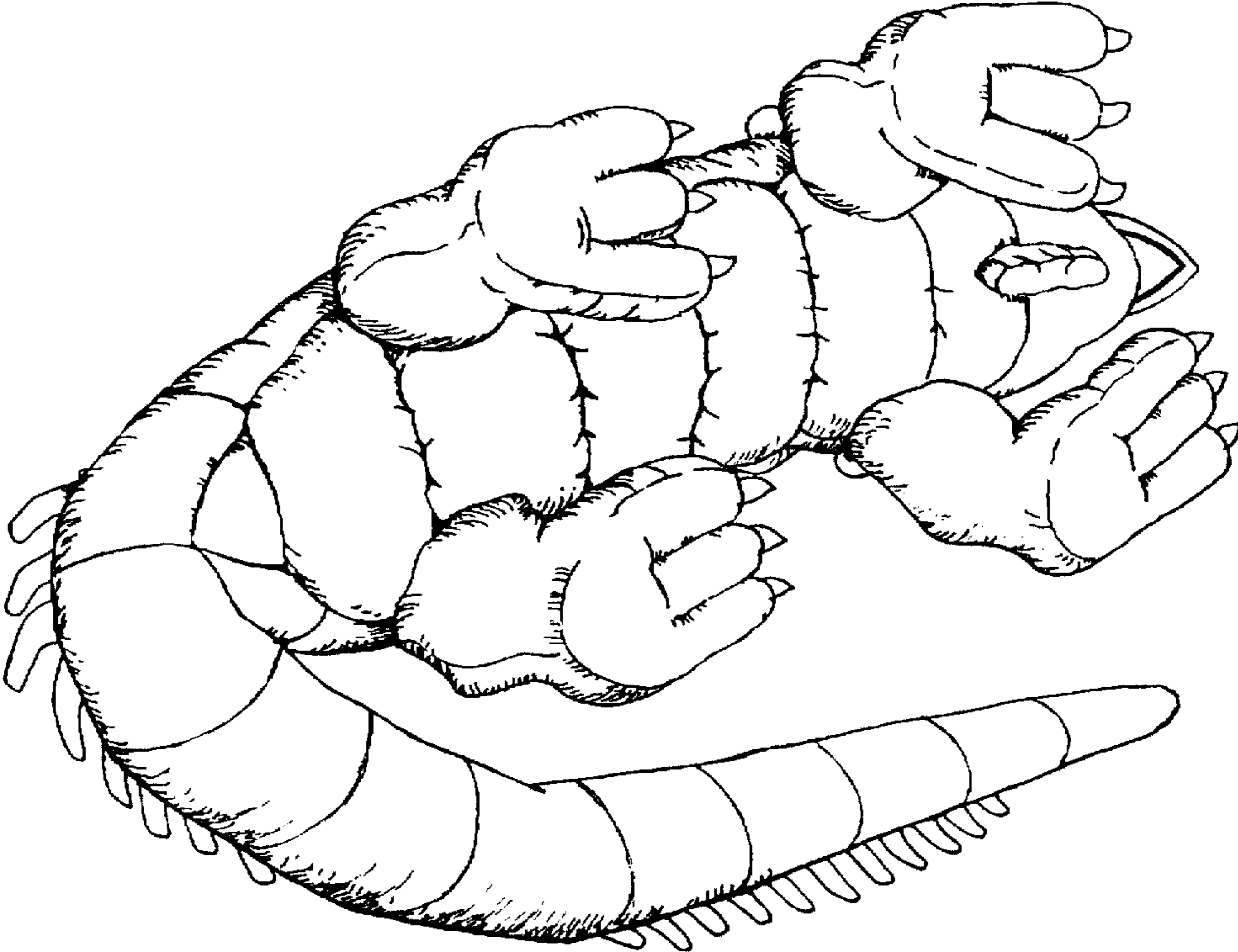
