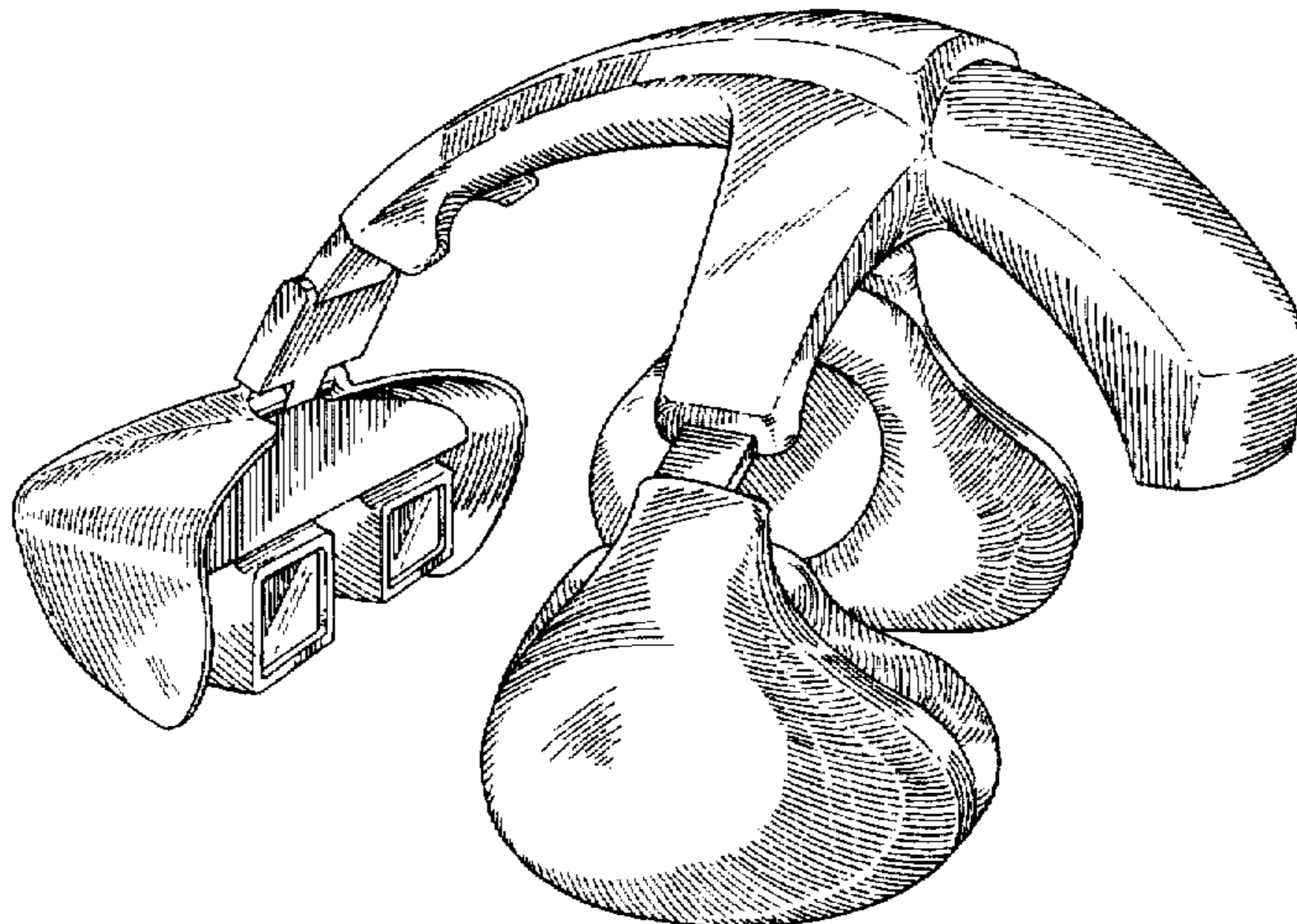
[57] **CLAIM**

The ornamental design for a head-mounted display device, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a head-mounted display device;
FIG. 2 is a left side of the head-mounted display device, the right side view being a mirror image thereof;
FIG. 3 is a bottom view of the head-mounted display device;
FIG. 4 is a front view of the head-mounted display device;
FIG. 5 is a rear view of the head-mounted display device;
and,
FIG. 6 is a top view of the head-mounted display device.

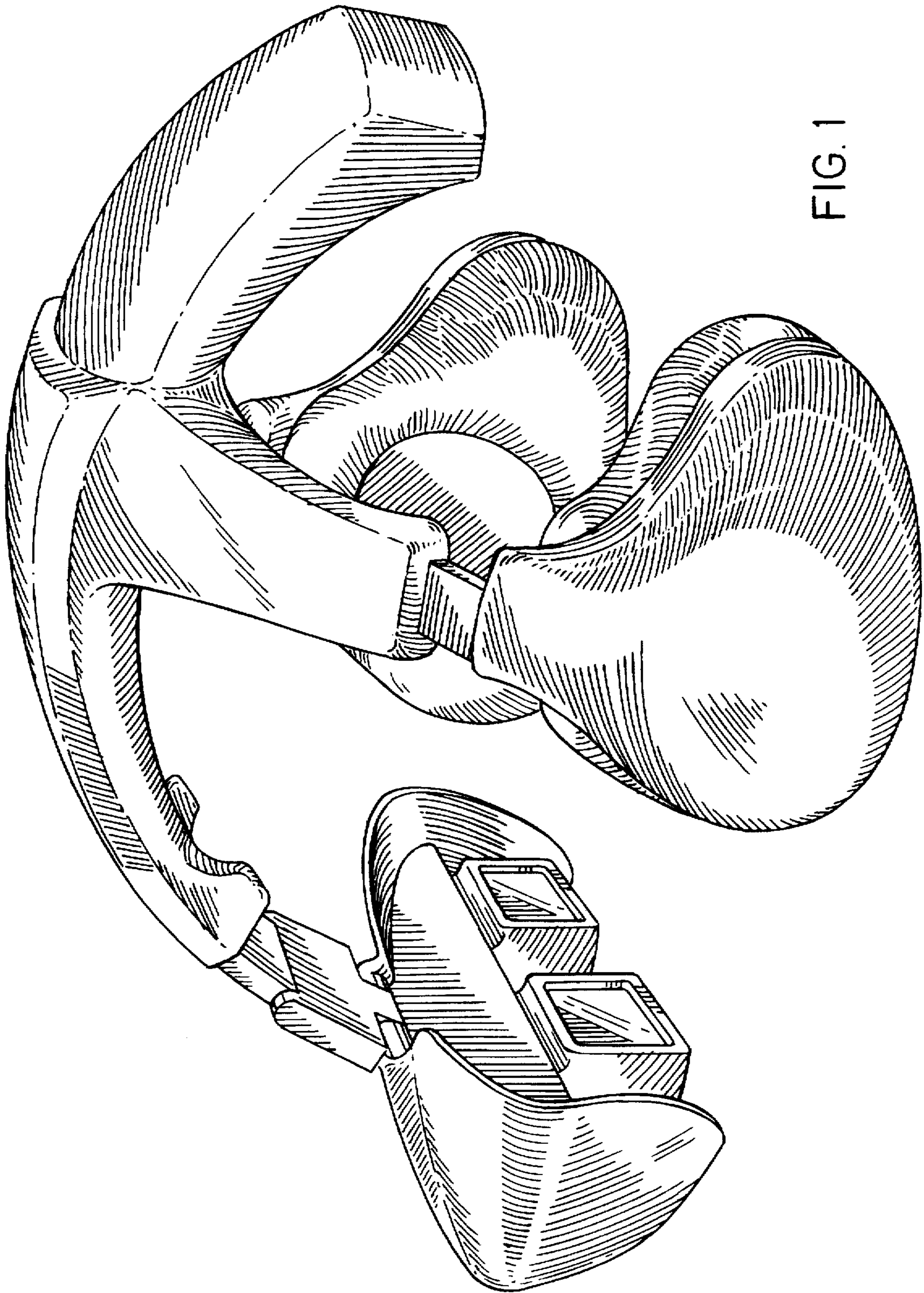
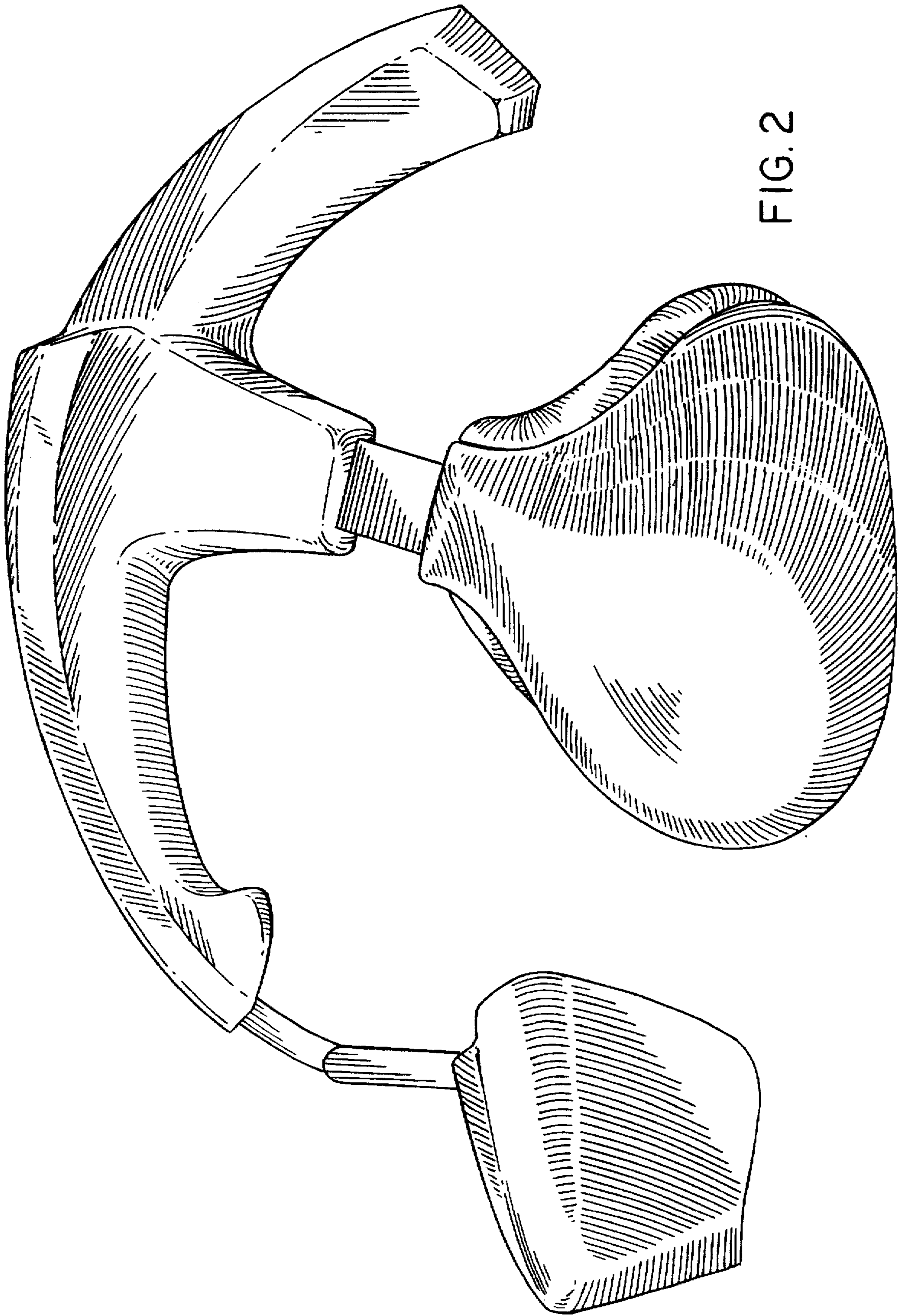

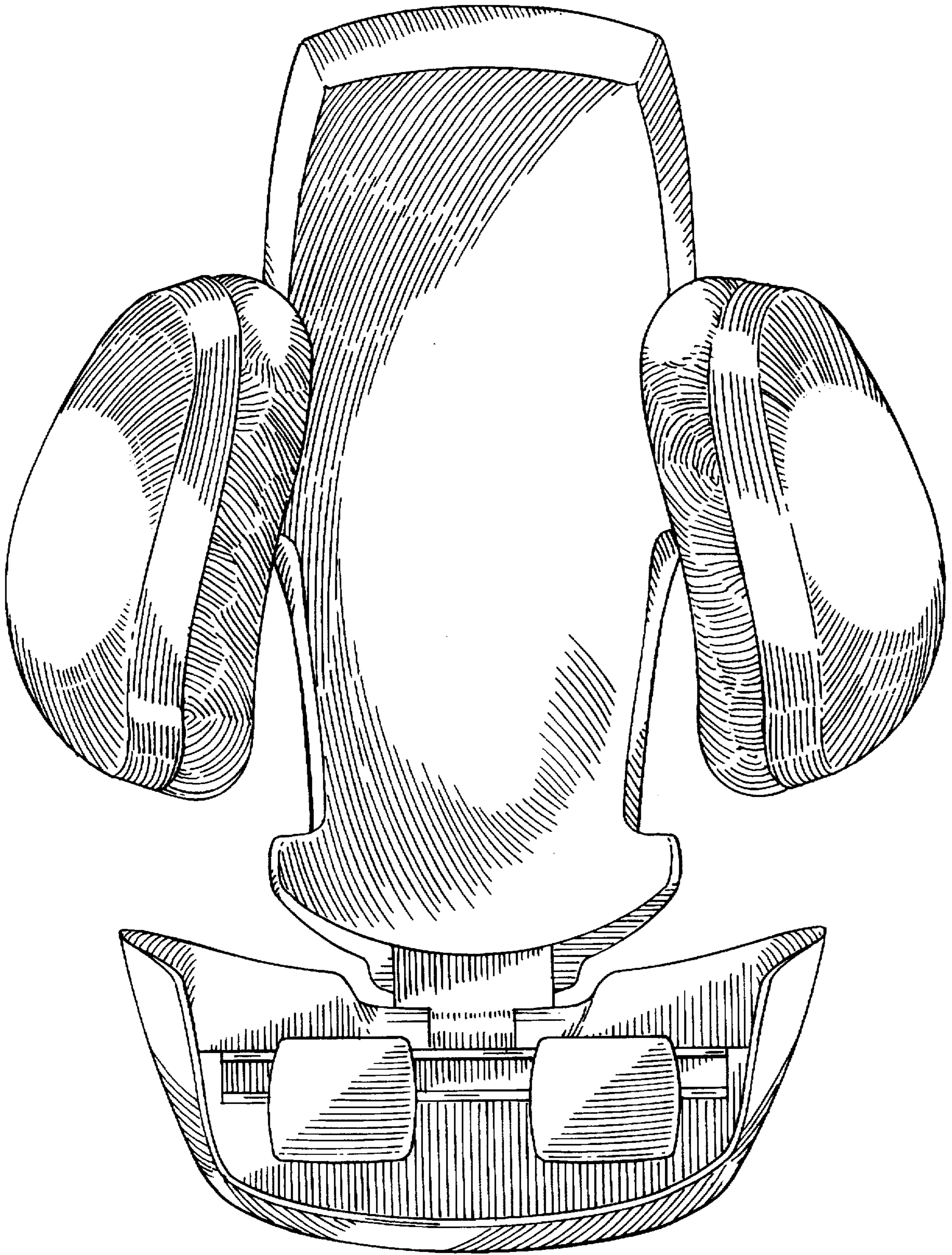

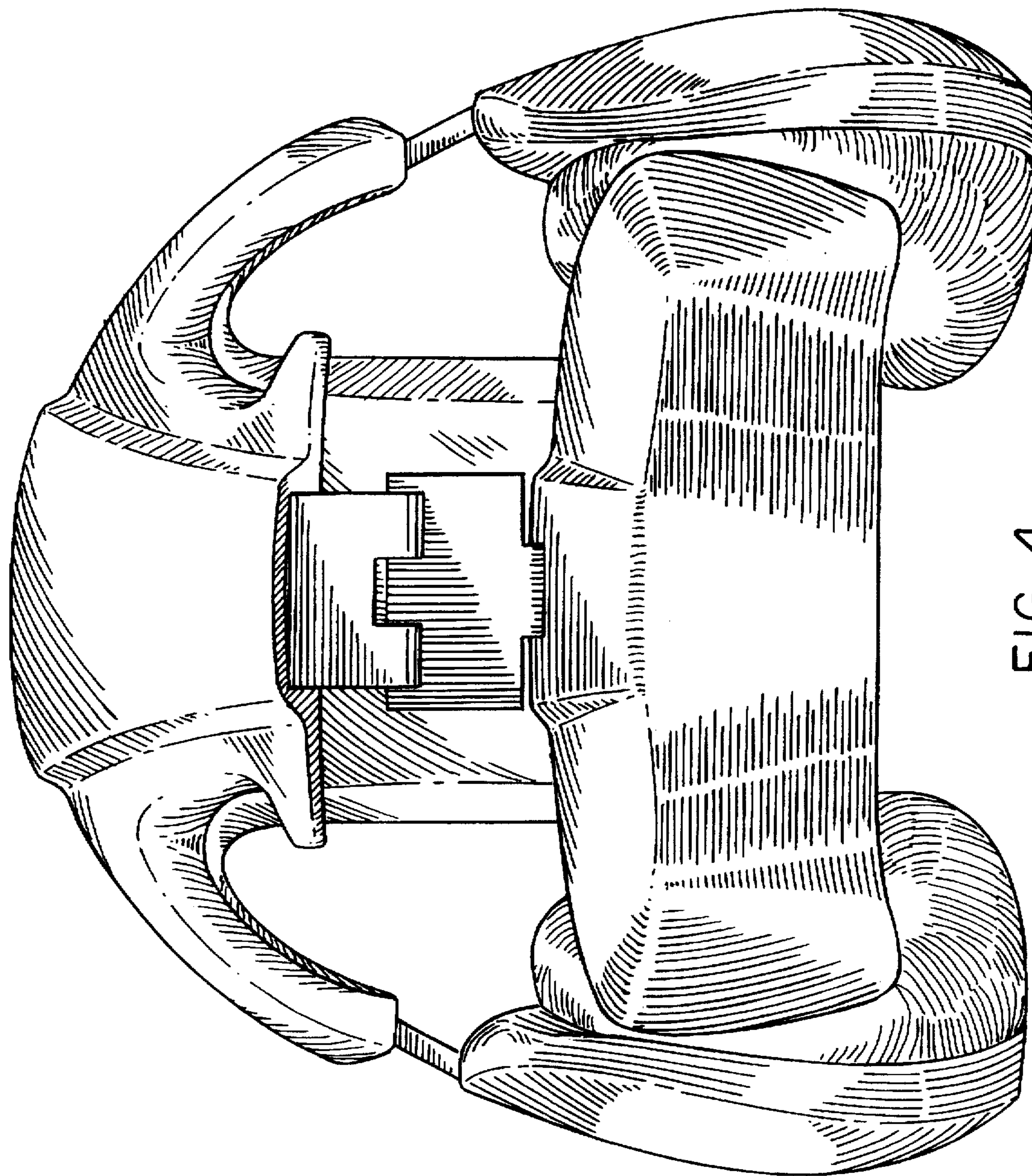

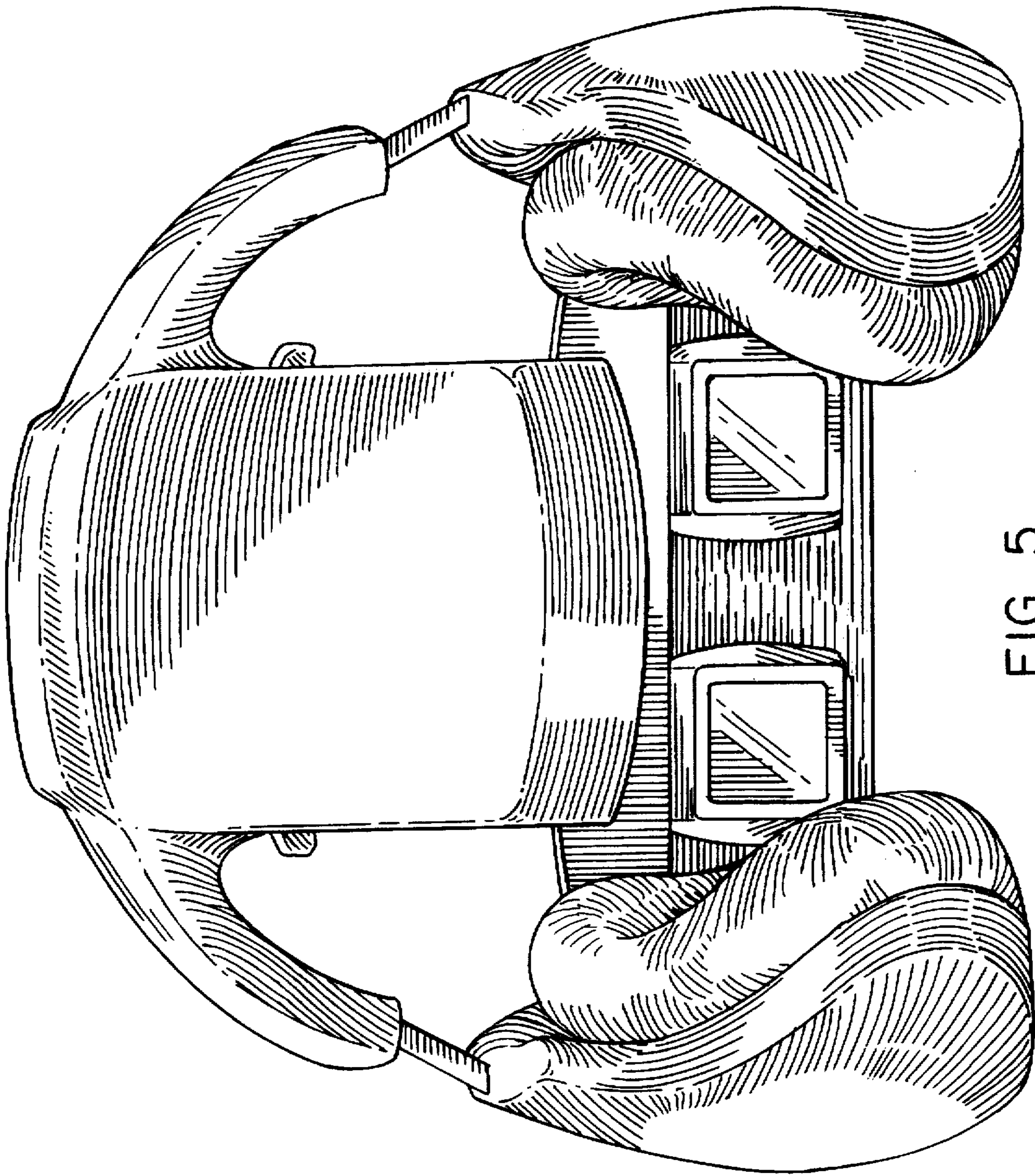

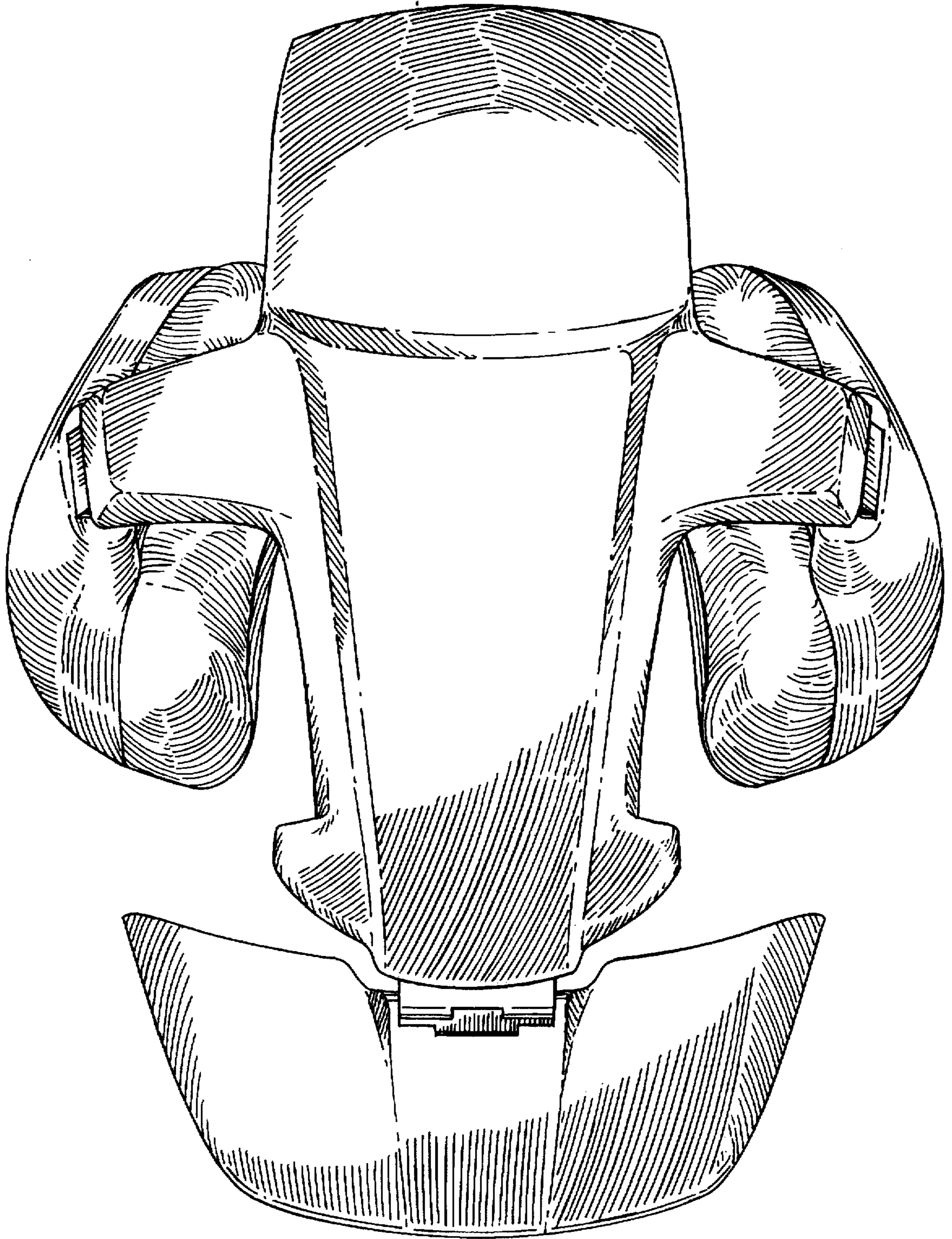
