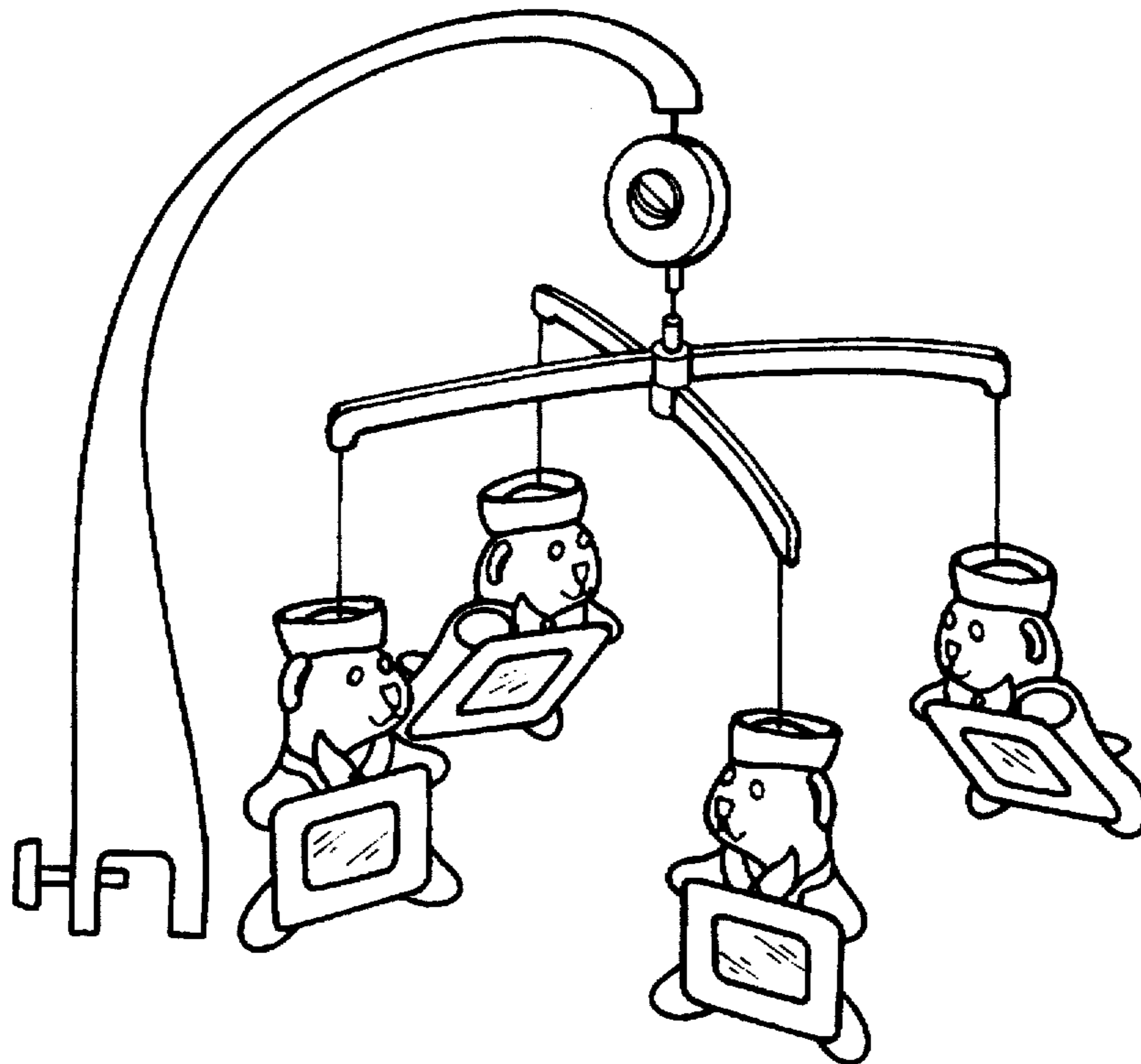

DESCRIPTION

FIG. 1 is a perspective view of a multi-purpose nursery mobile showing my new design;
FIG. 2 is a rear elevational view of a mobile element on an enlarged scale shown separately for clarity of illustration;
FIG. 3 is a front elevational view of FIG. 2;
FIG. 4 is a right side elevational view of FIG. 2;
FIG. 5 is a left side elevational view of FIG. 2;
FIG. 6 is a bottom plan view of FIG. 2; and,
FIG. 7 is a top plan view of FIG. 2.

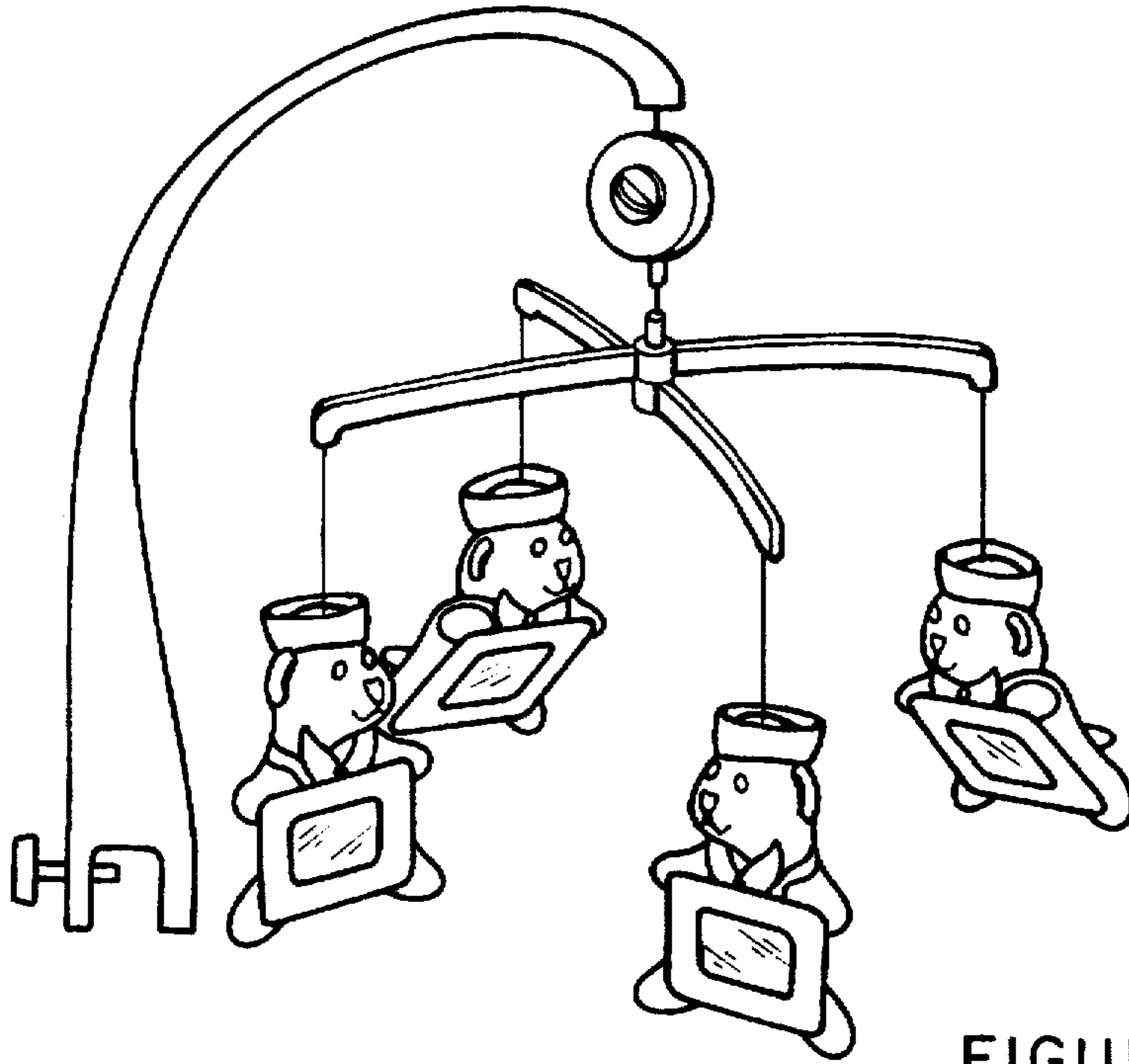

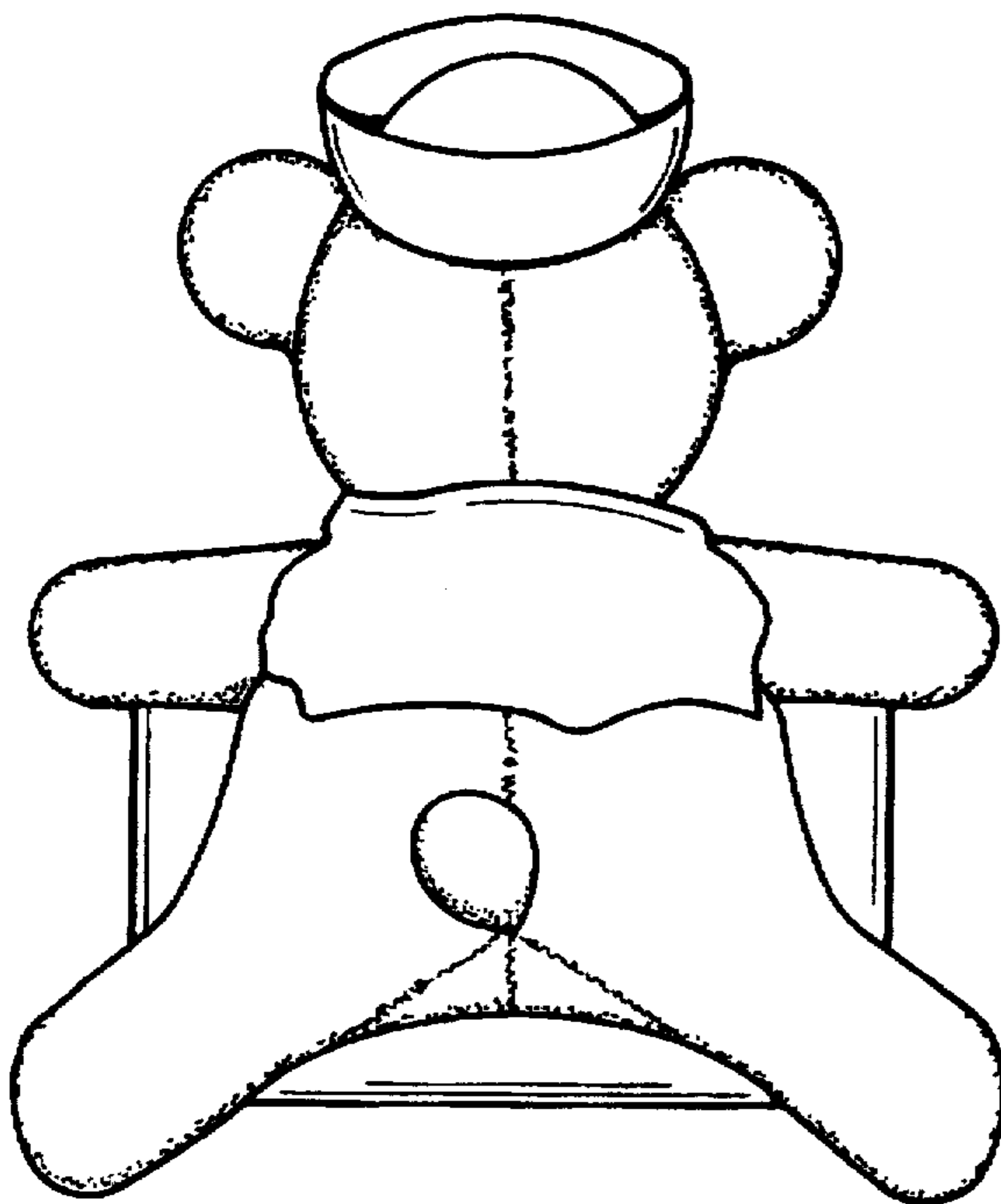

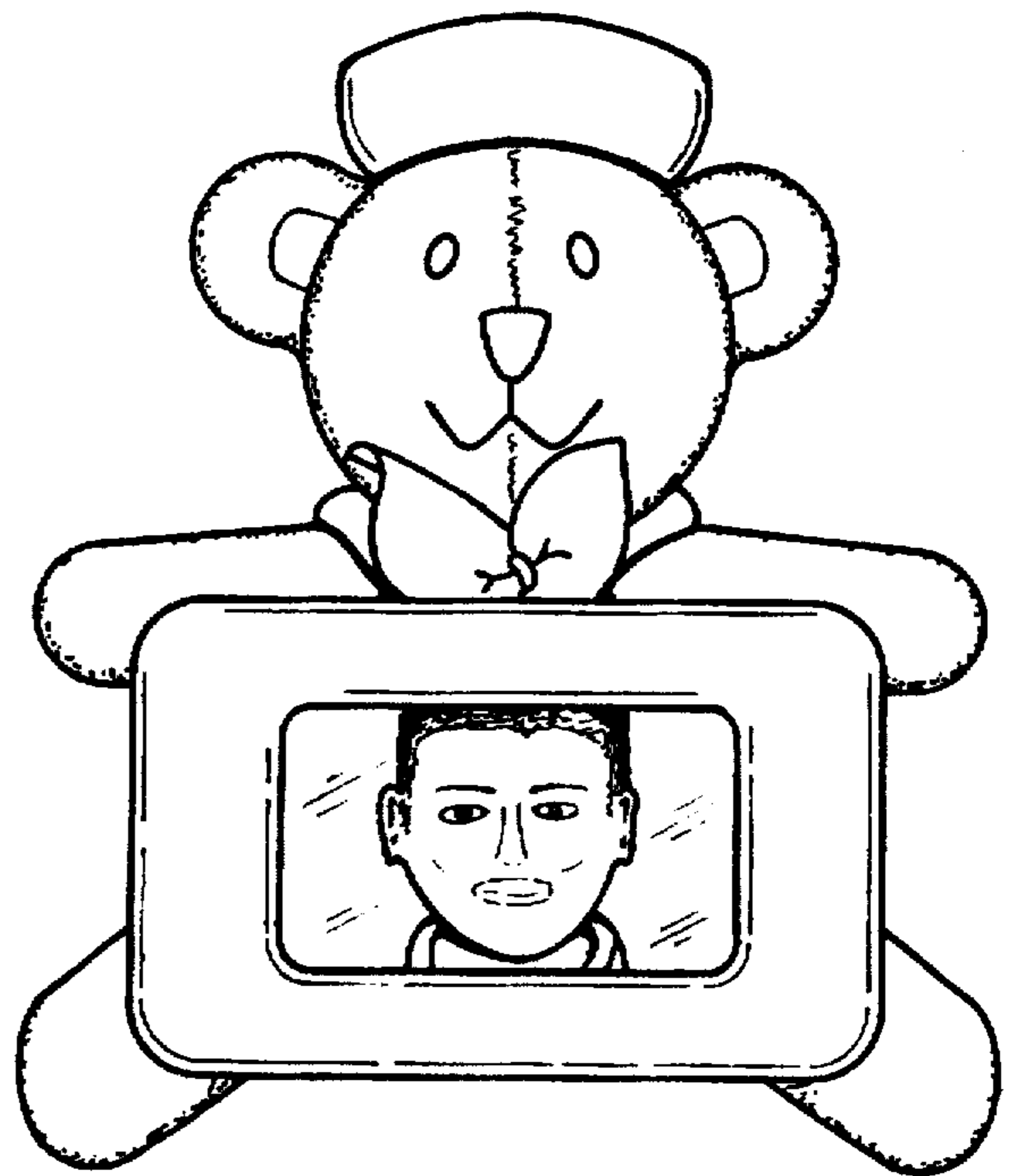

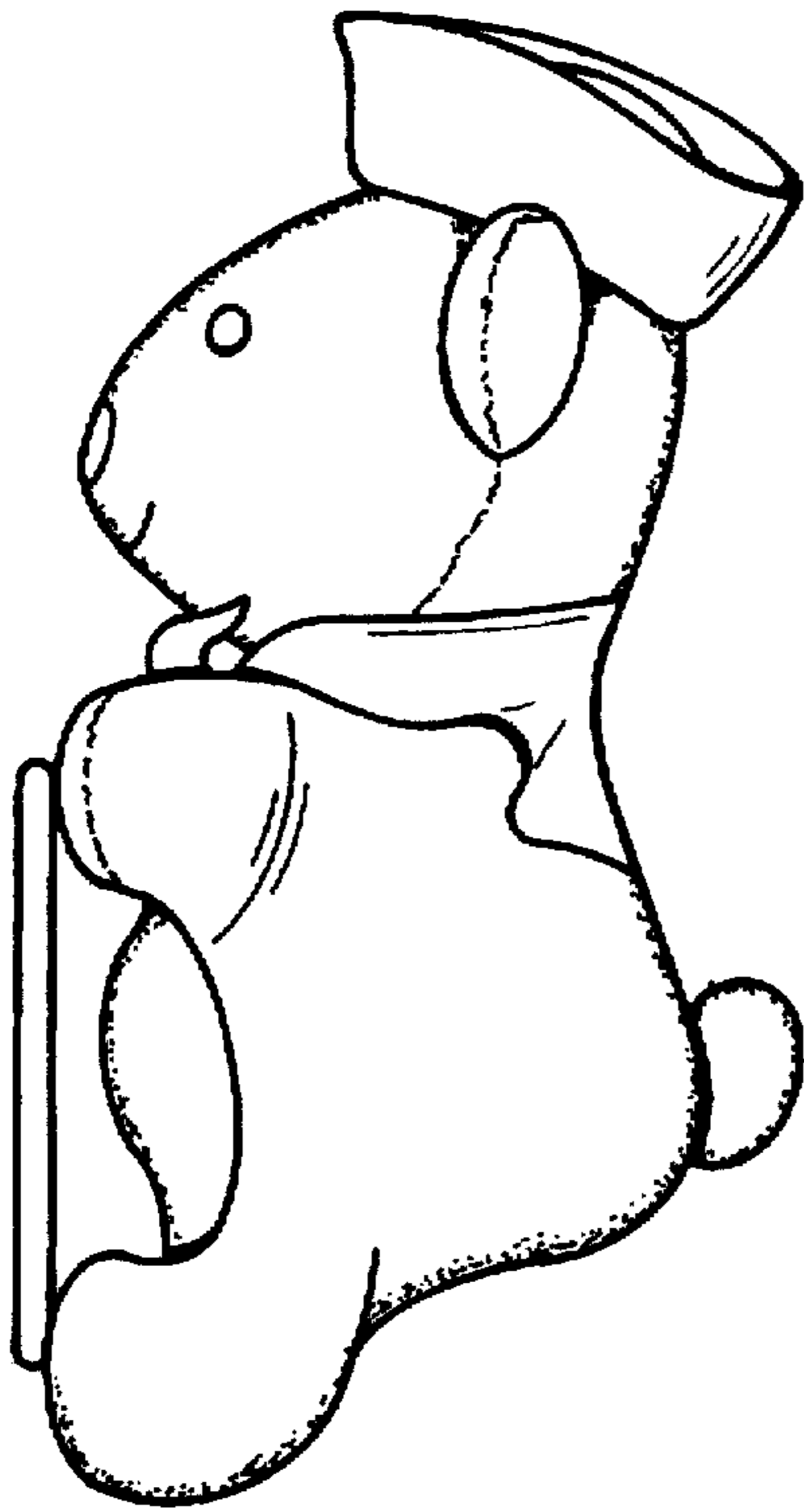

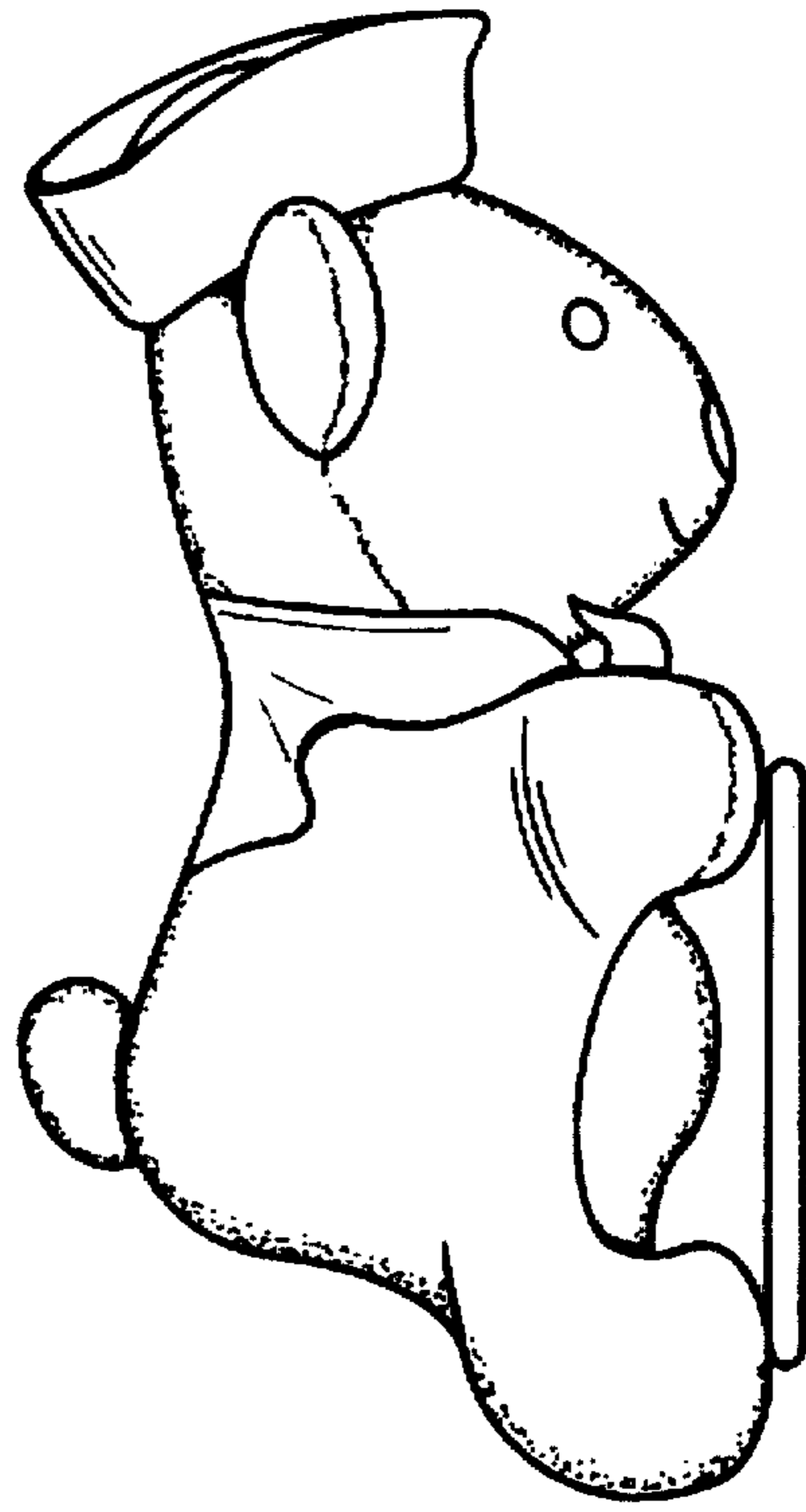

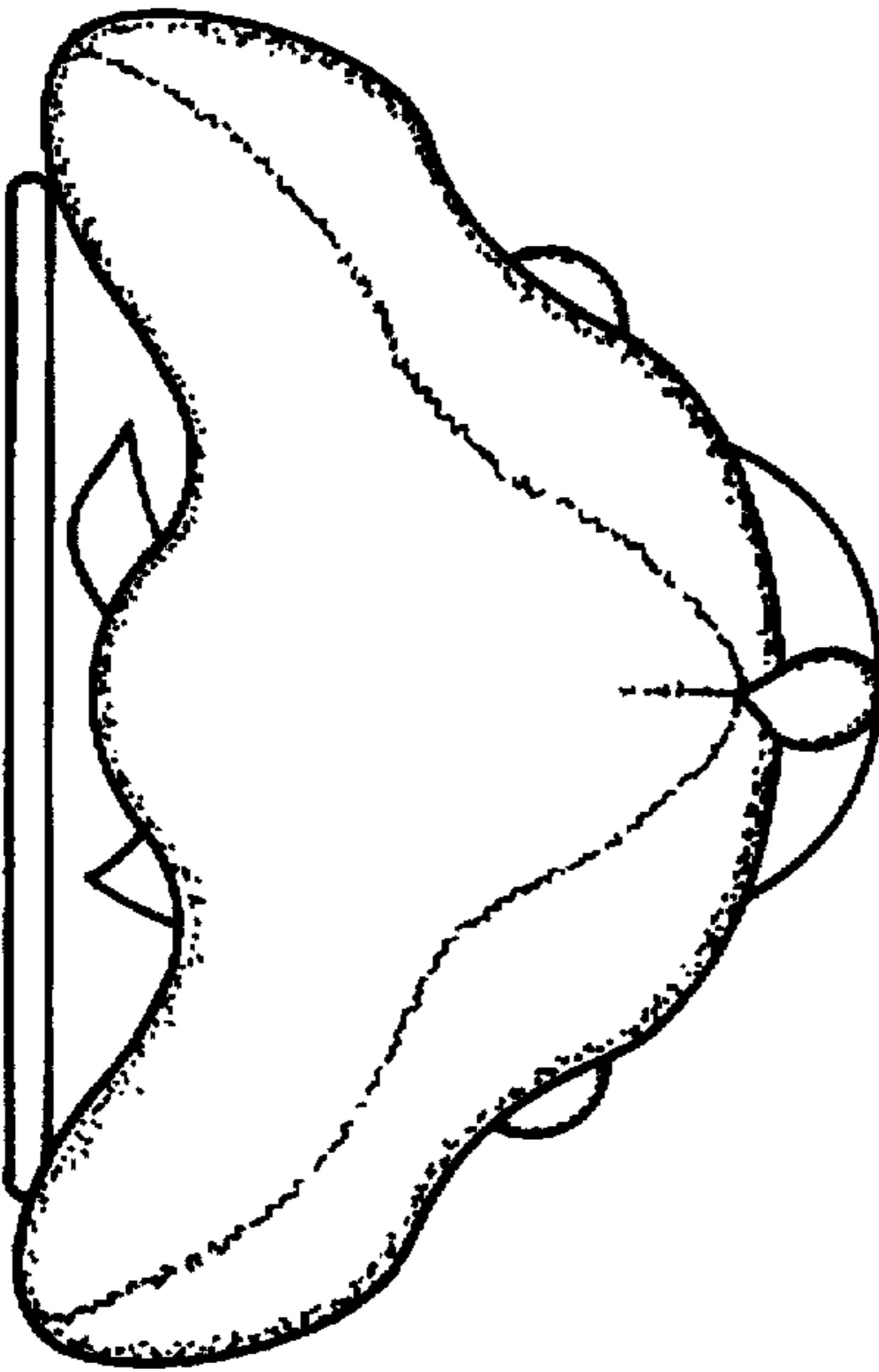

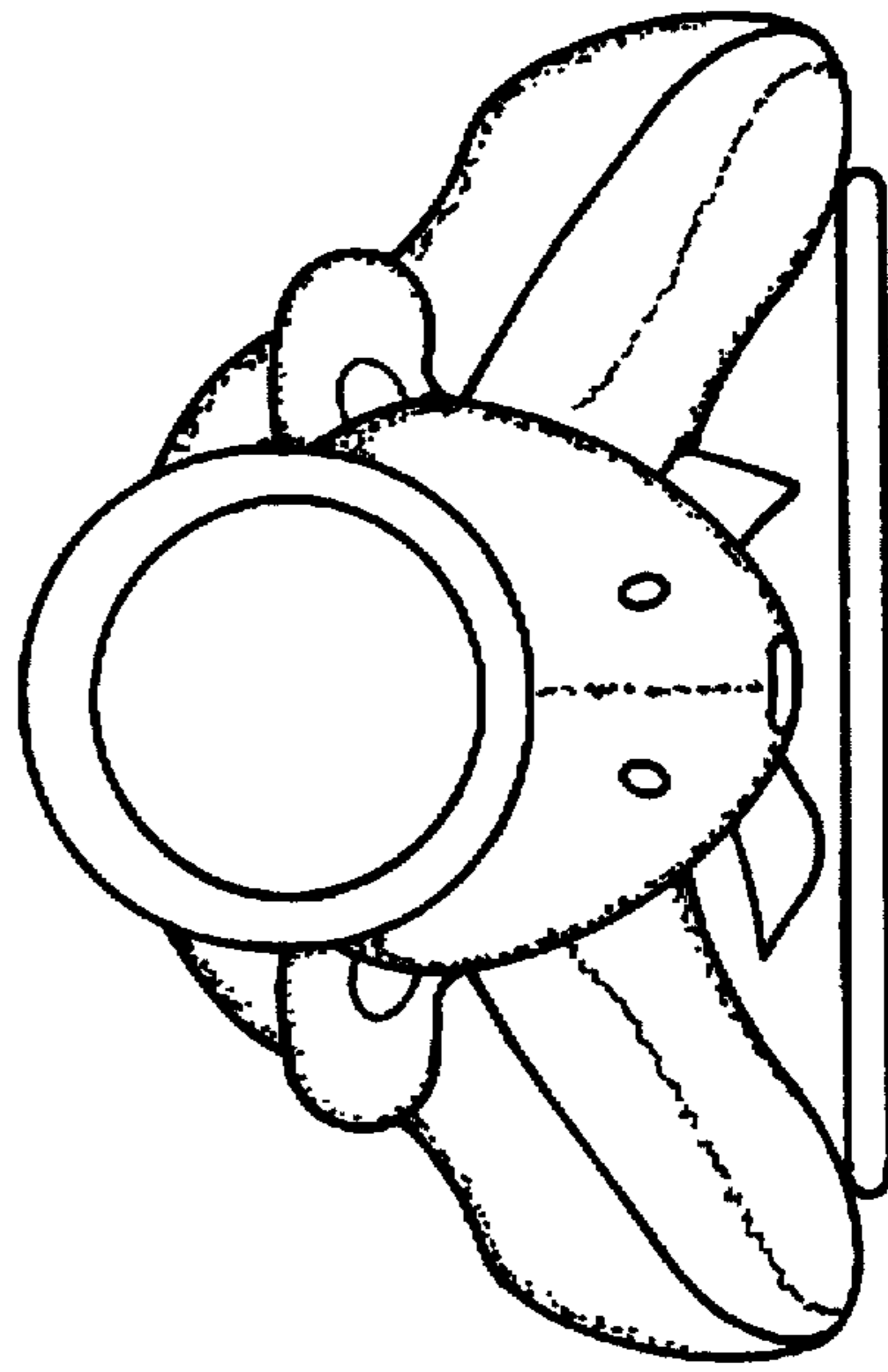
