FIG. 4 is a right side view thereof;

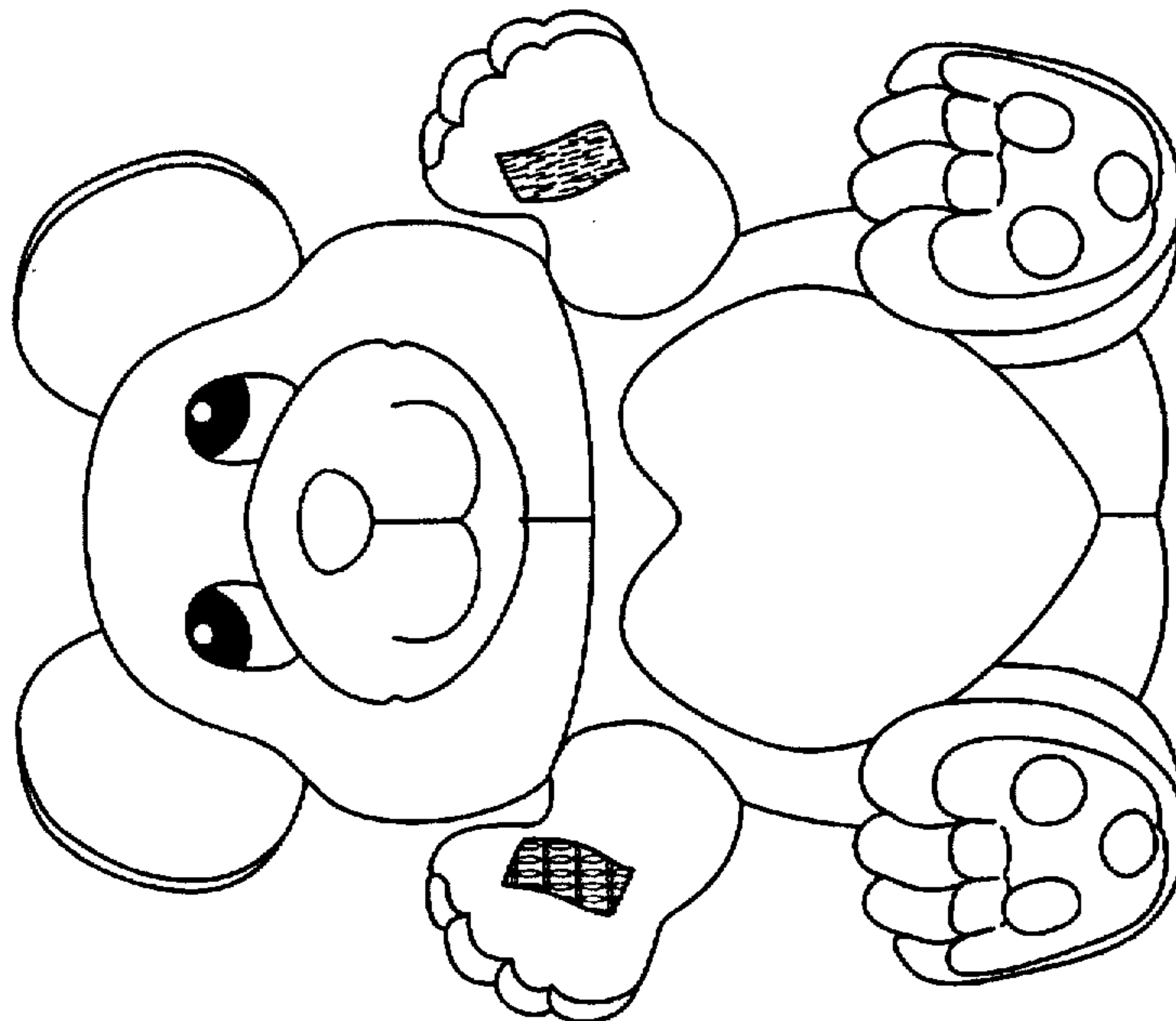
FIG. 5 is a back view thereof;

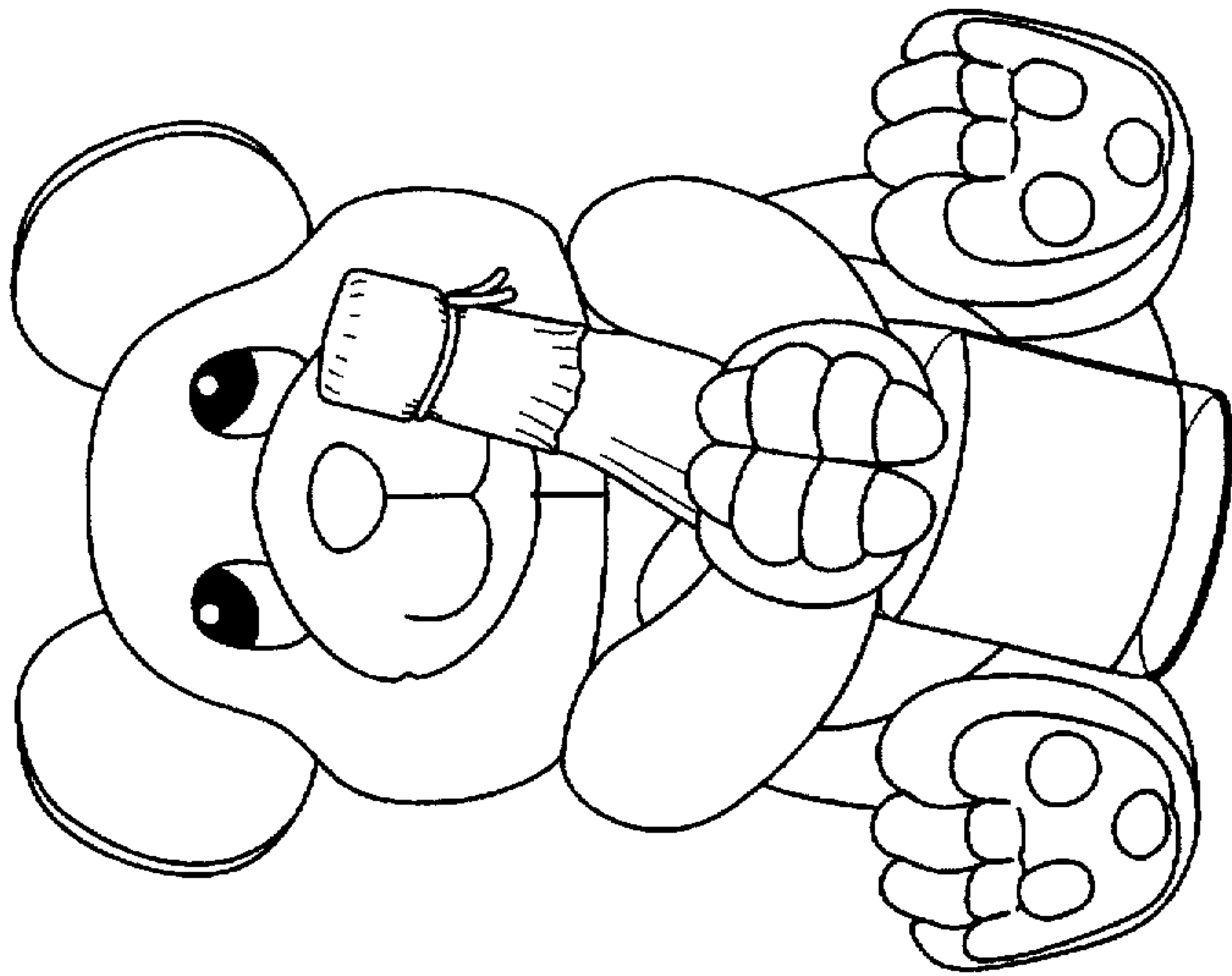
FIG. 6 is a front view of the second embodiment of the stuffed animal;

FIG. 7 is a right side view thereof; and,

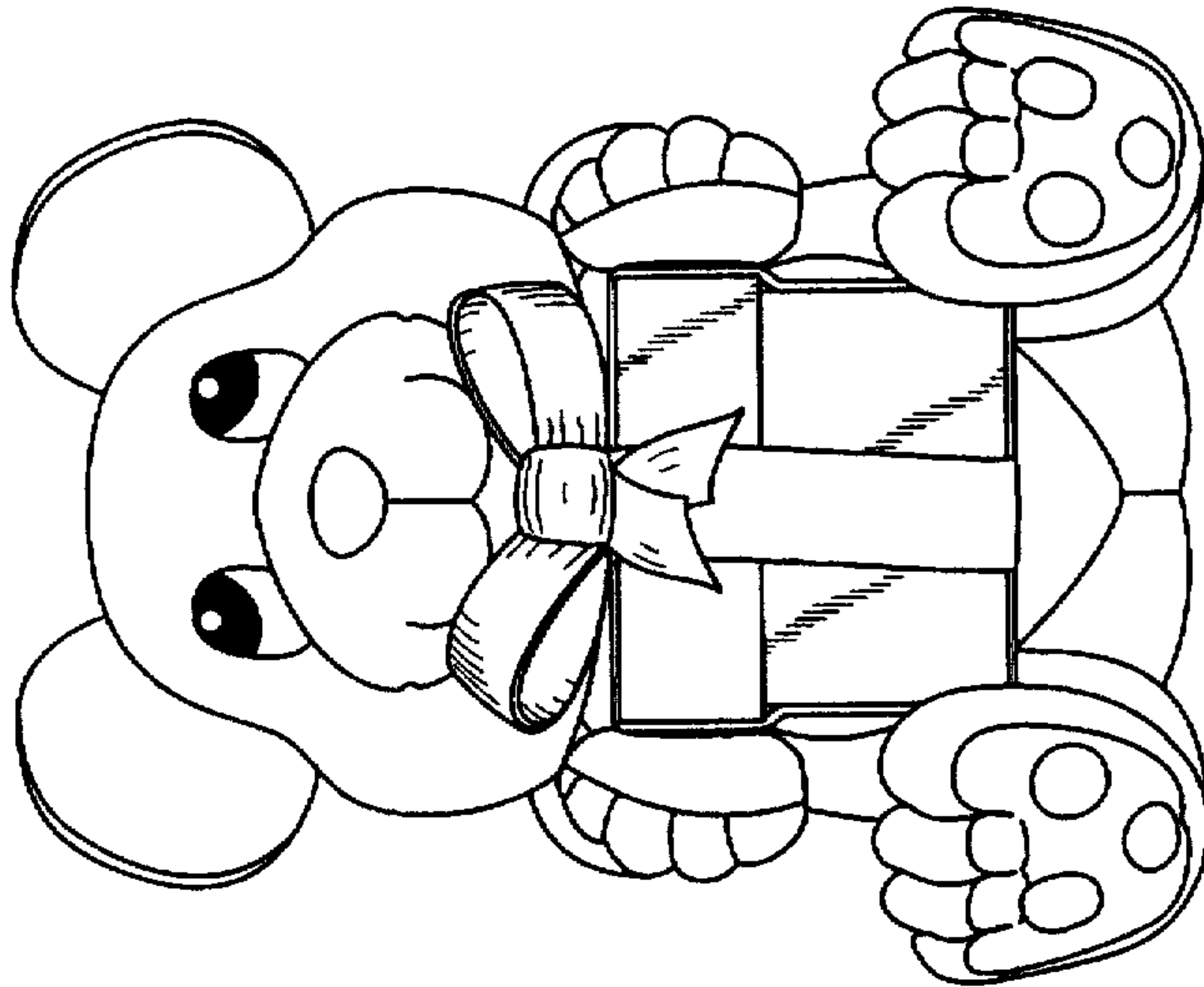
FIG. 8 is a back view thereof.

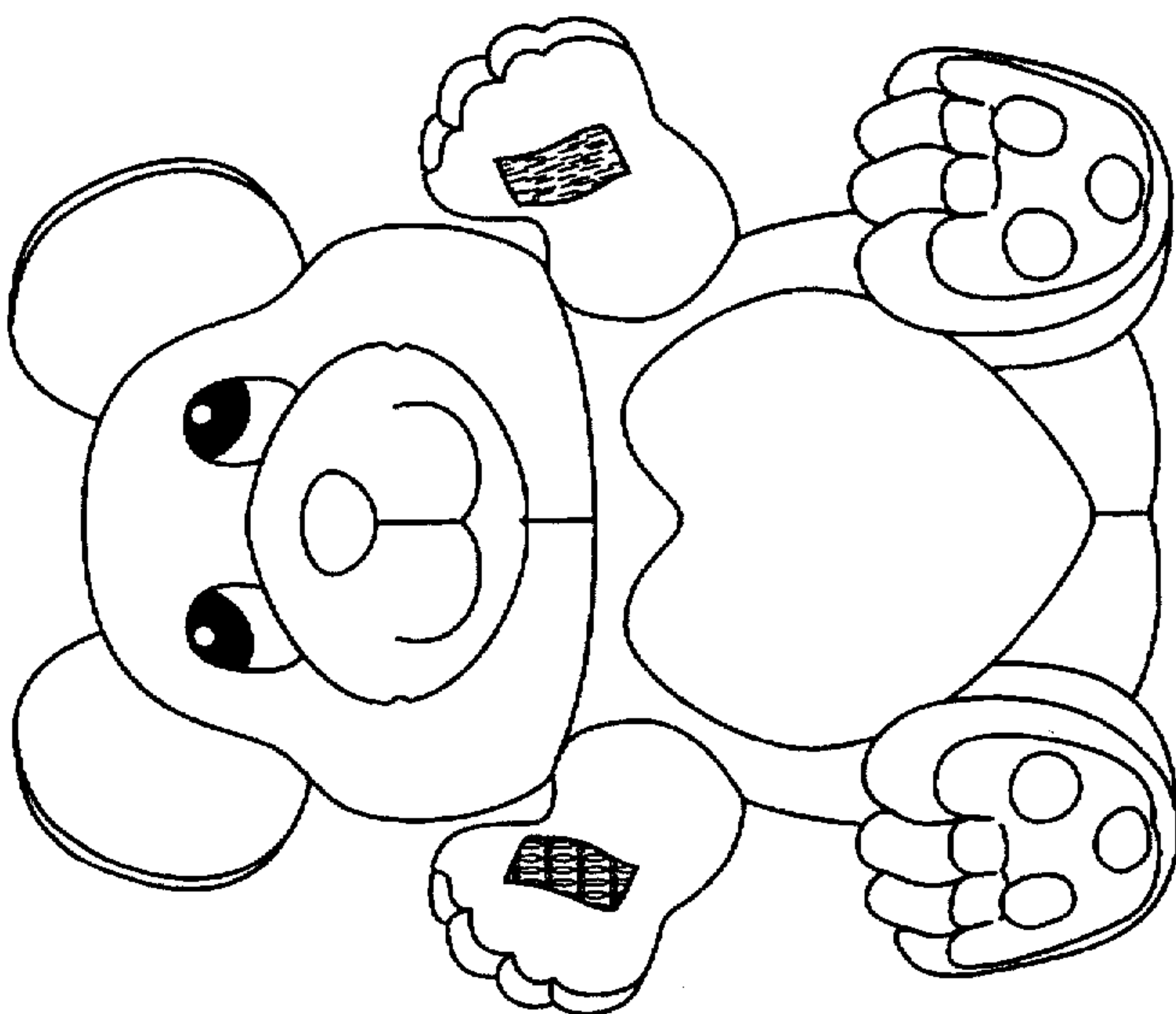




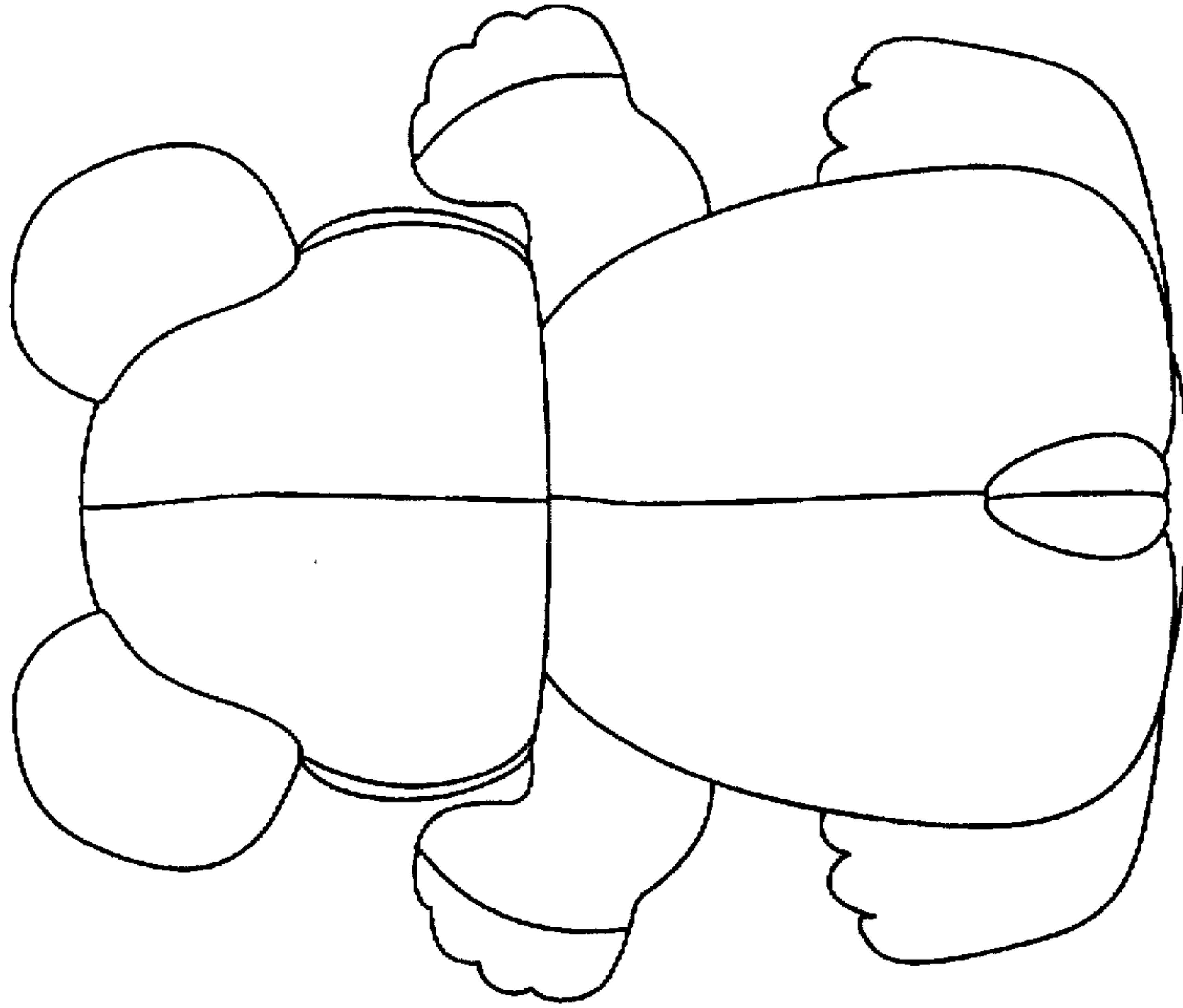

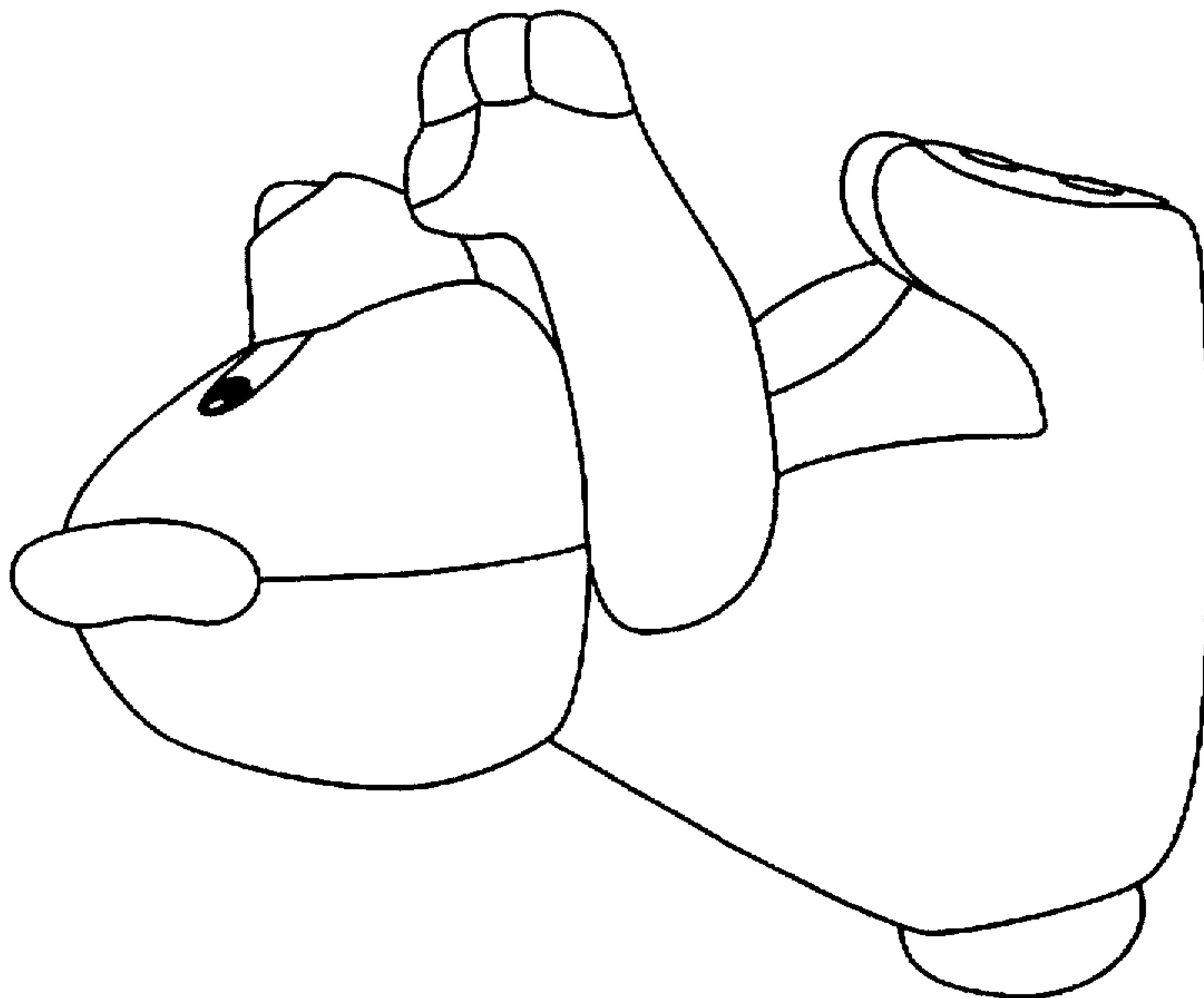

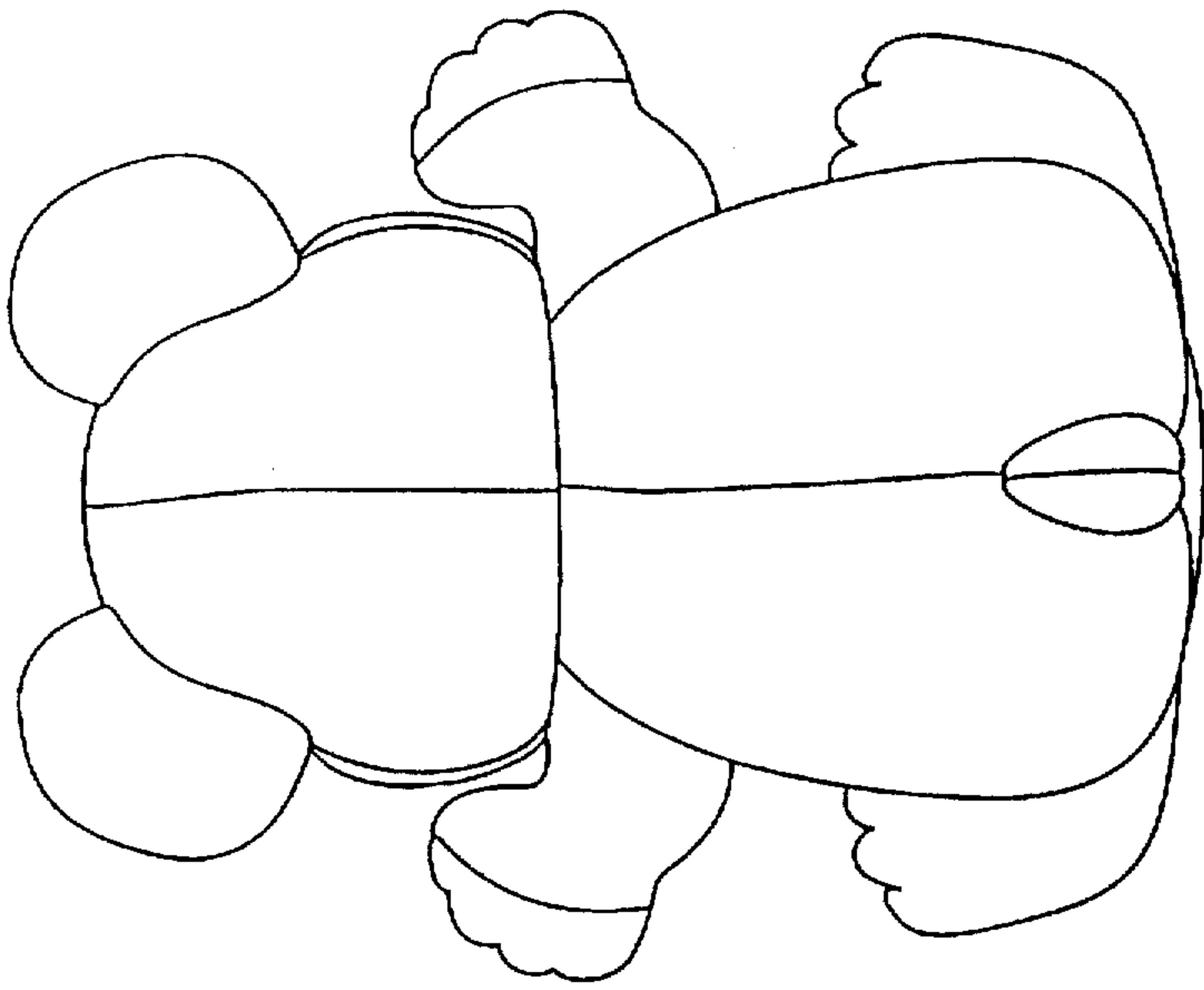

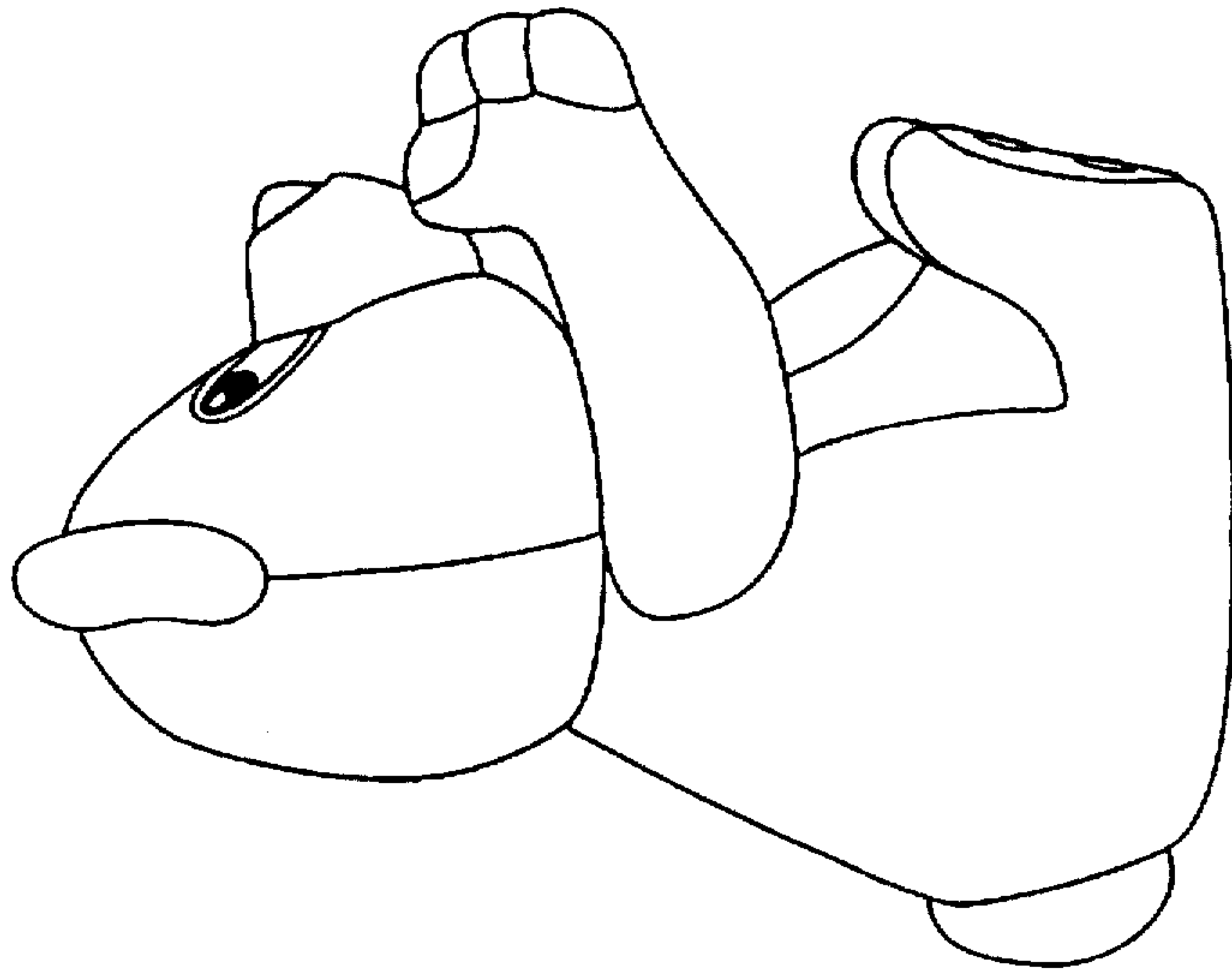

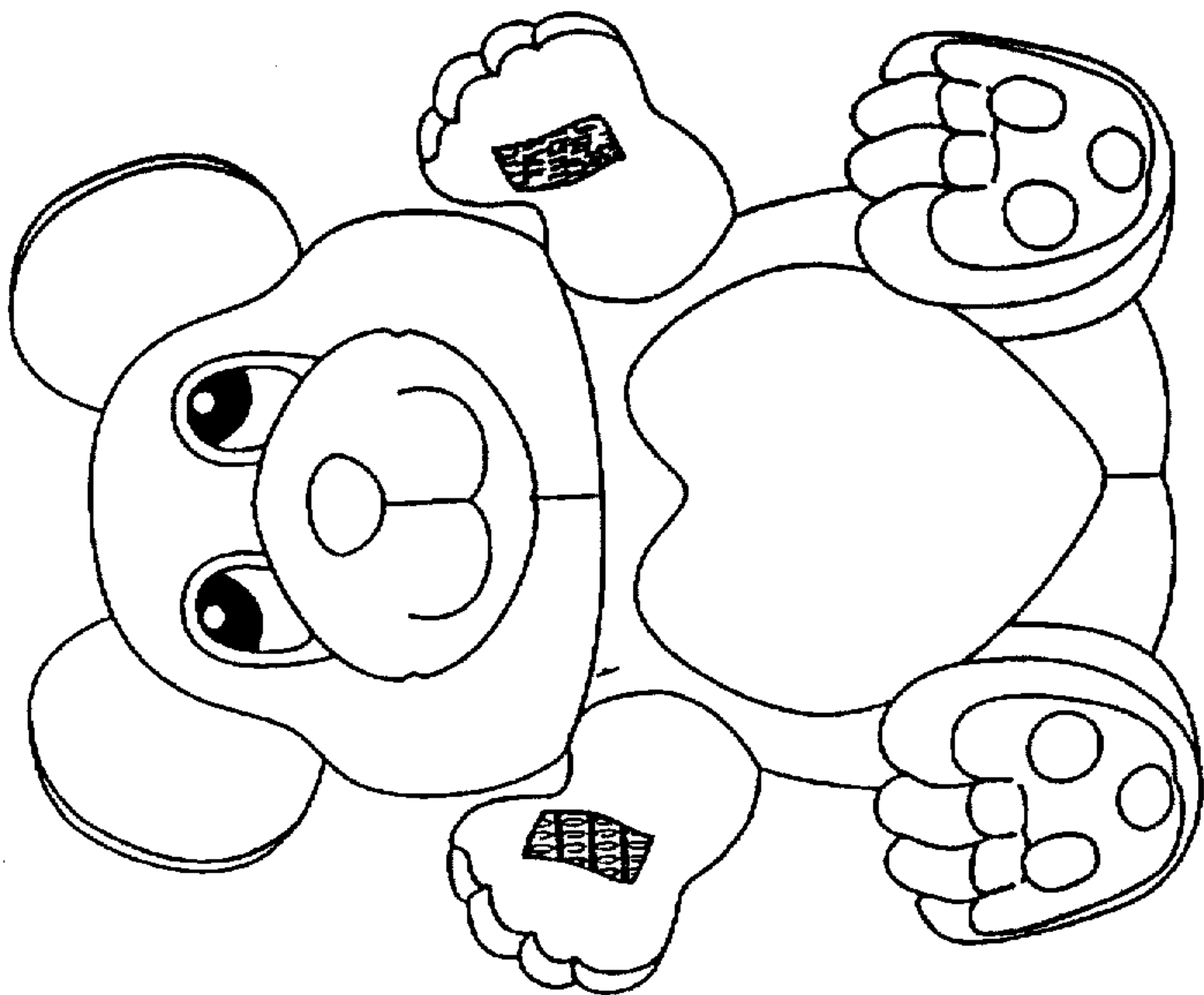
