DESCRIPTION

FIG. 1 is a top right front perspective view of a playground sculpture showing my new design;
FIG. 2 is a front elevational view thereof;

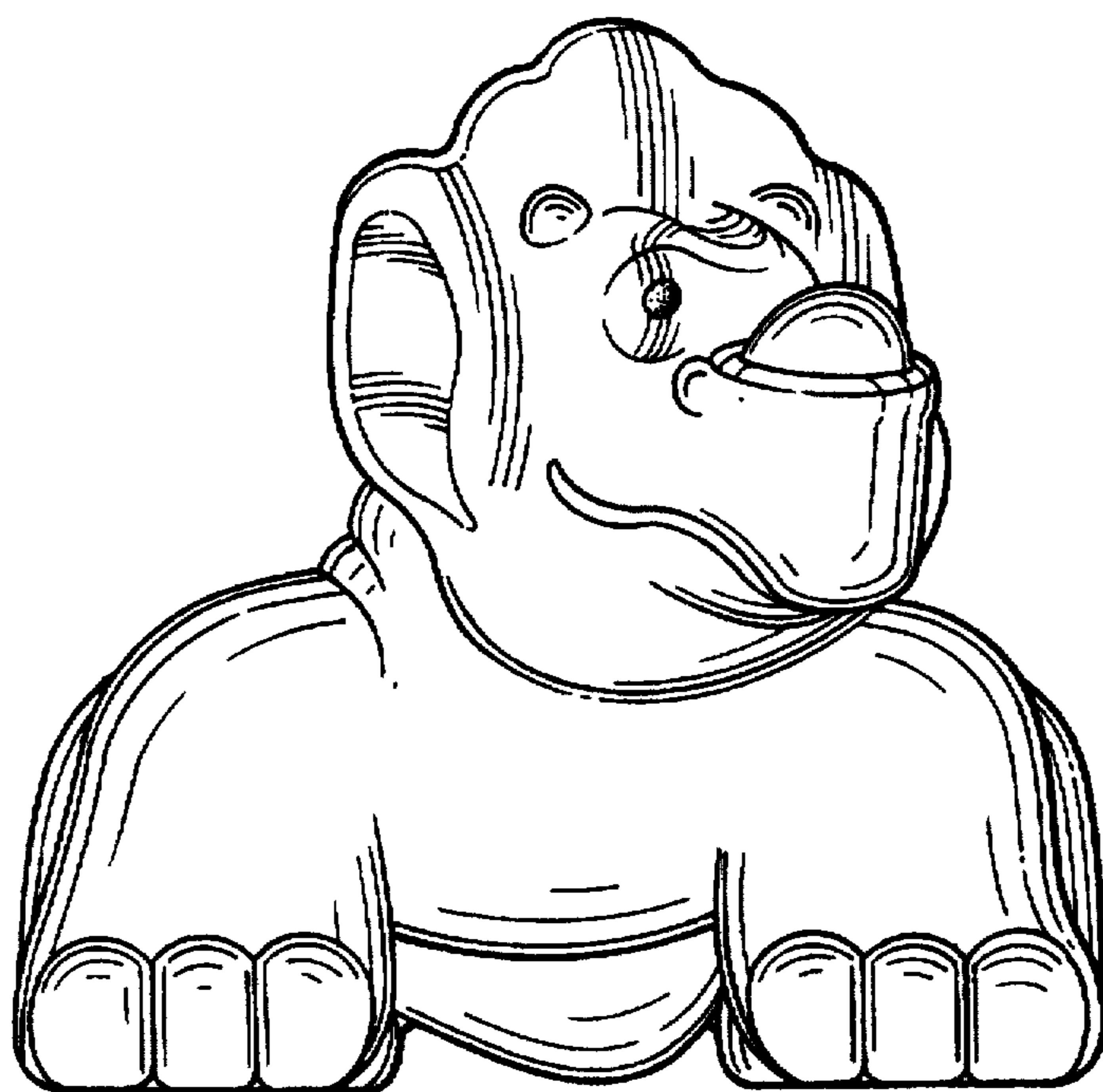

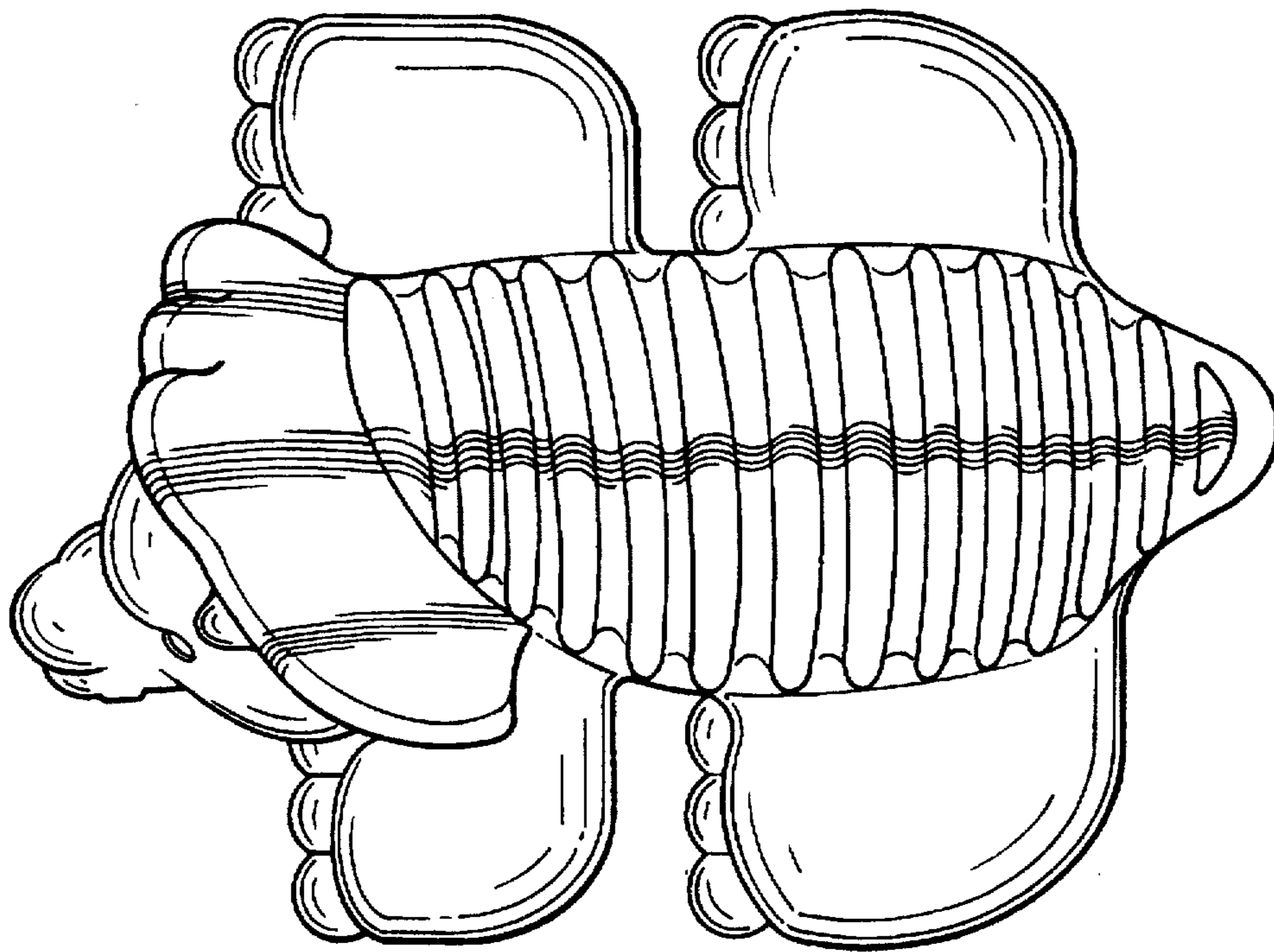

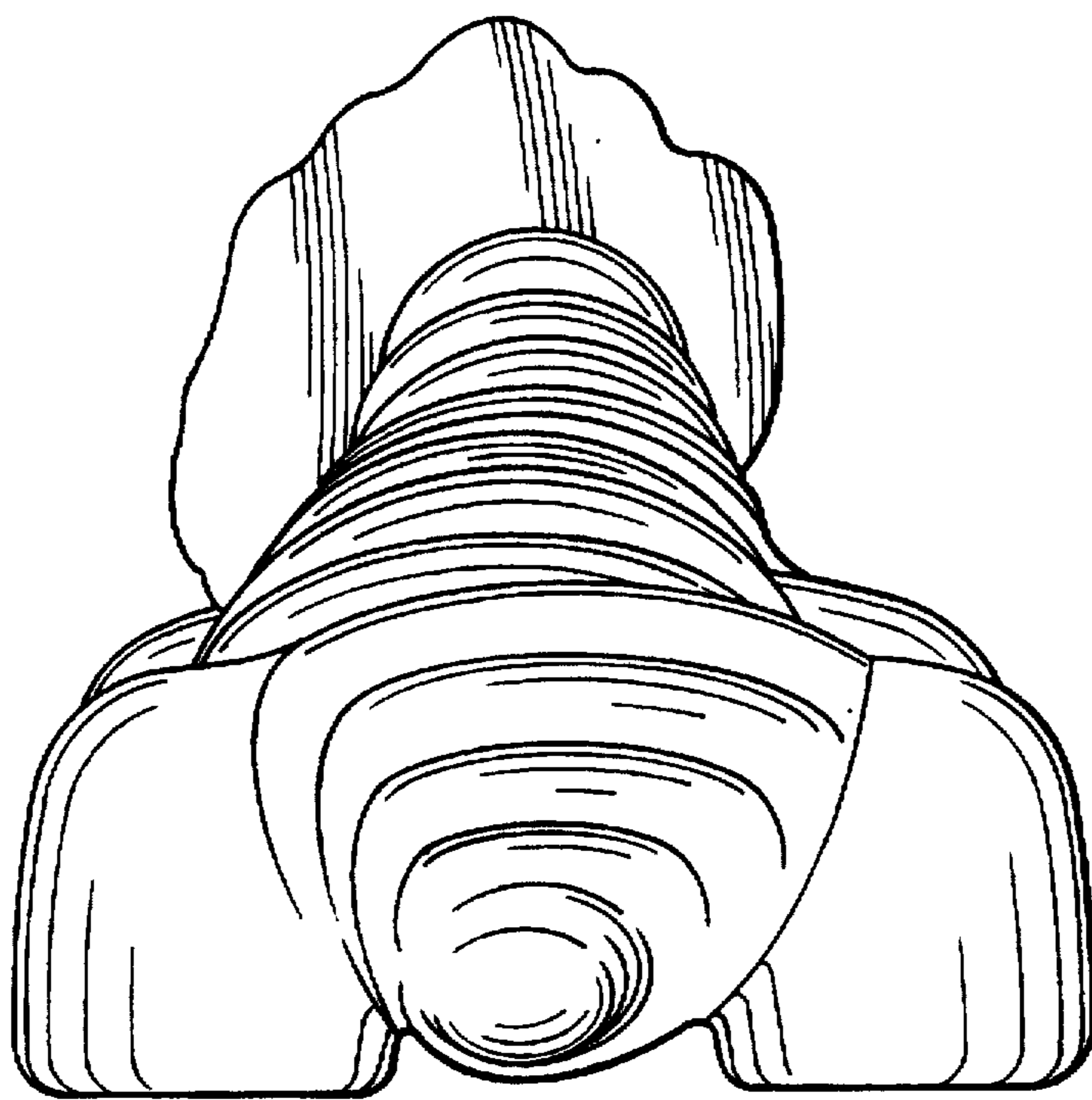

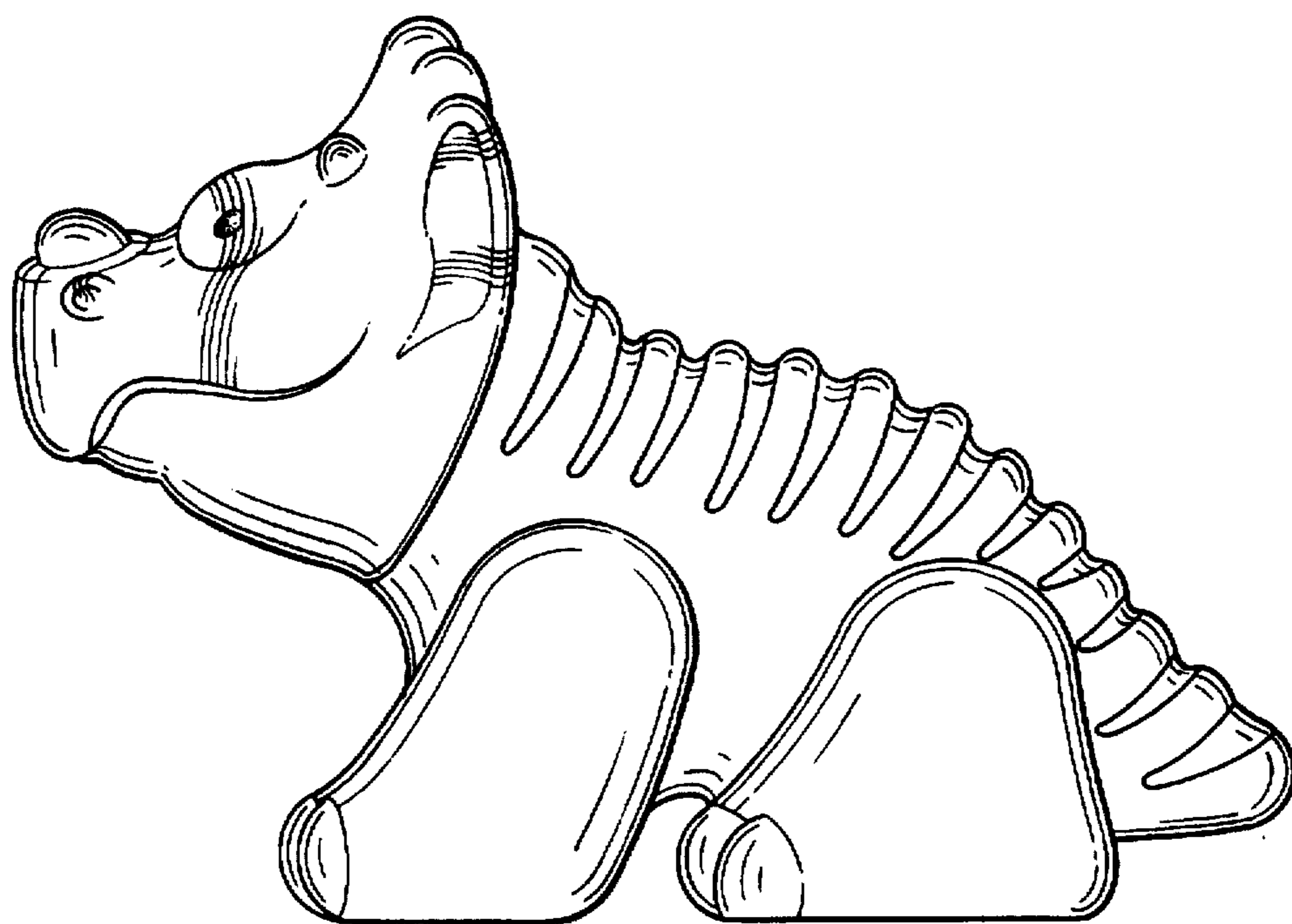

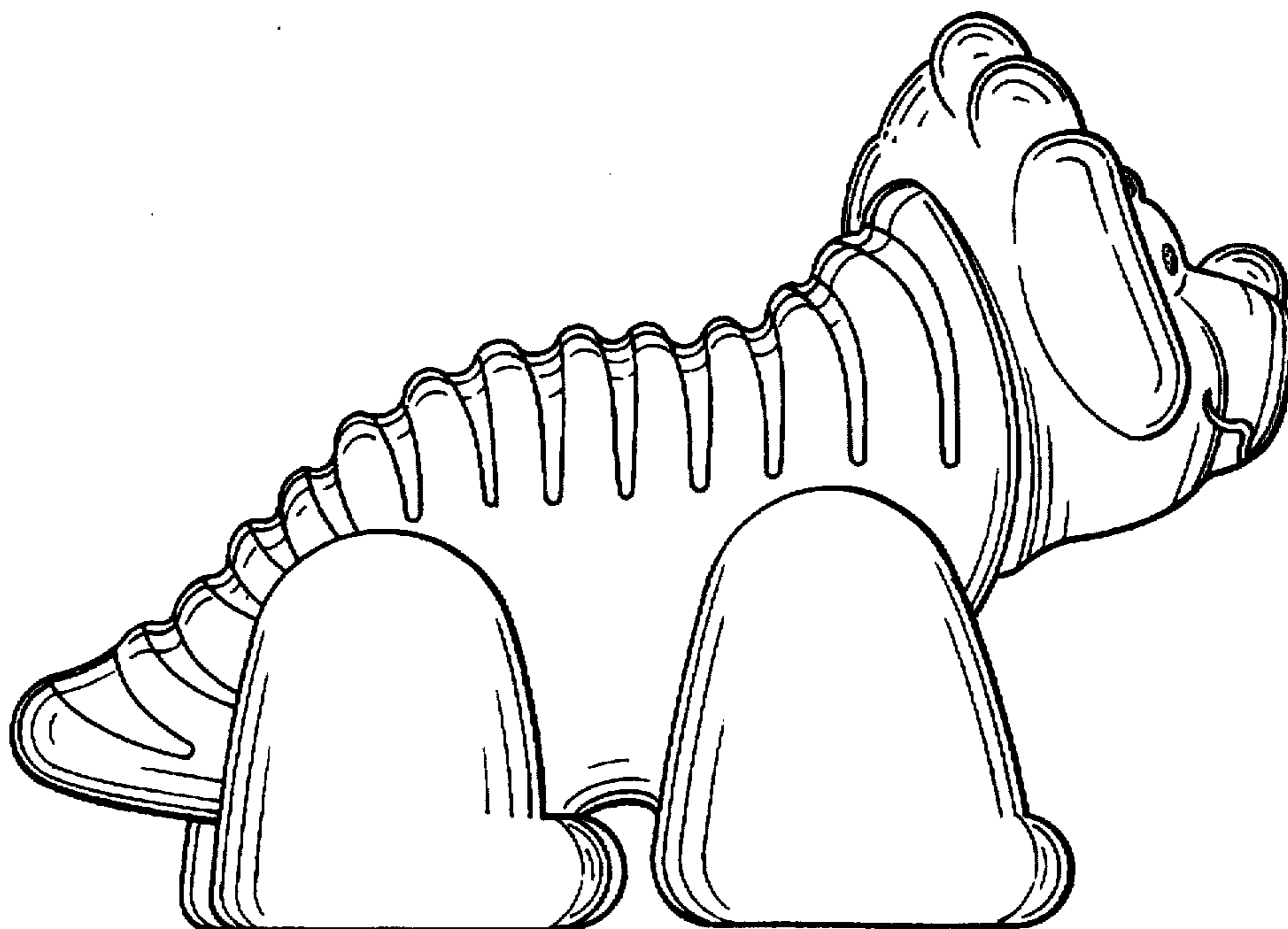

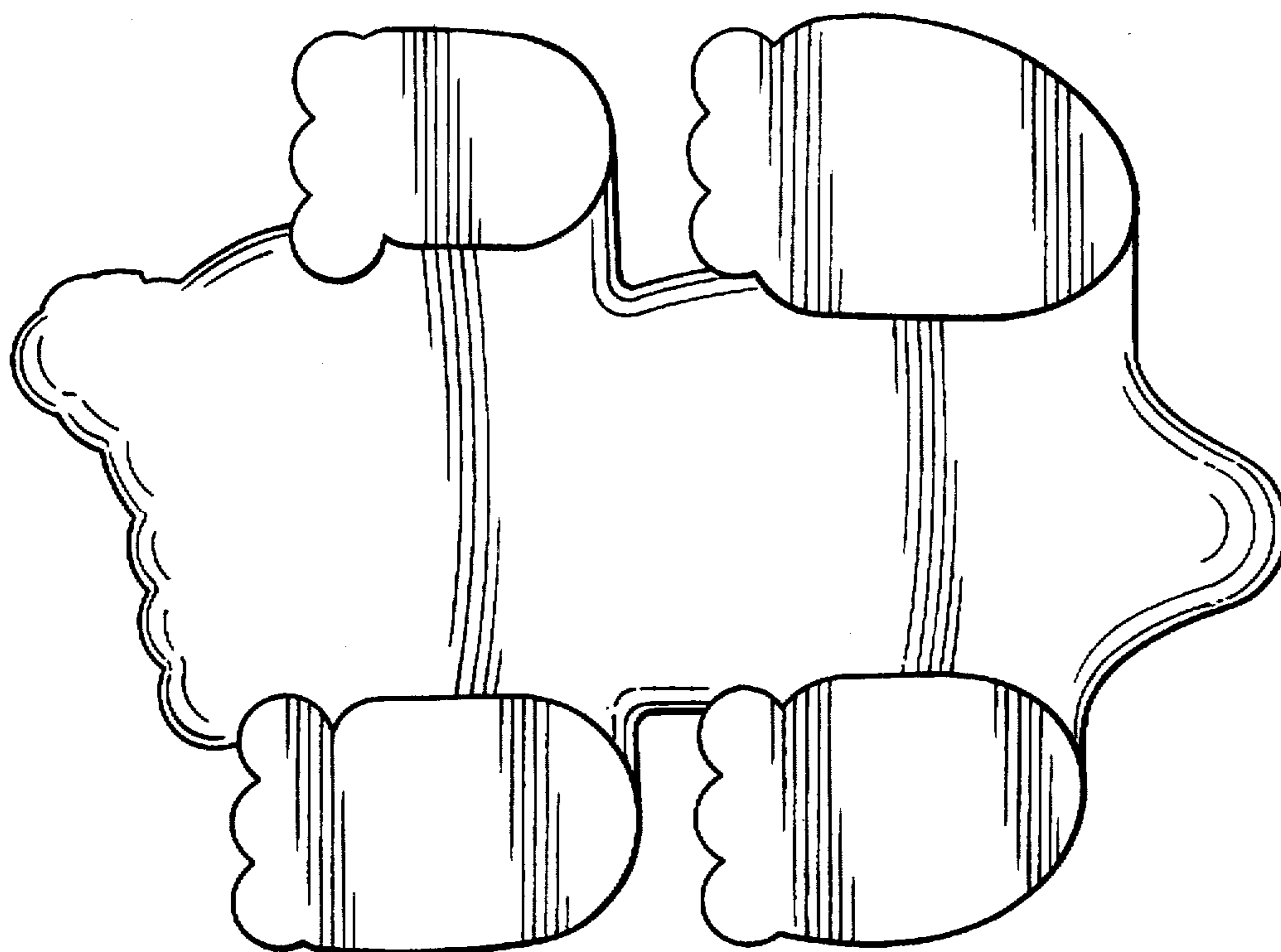
