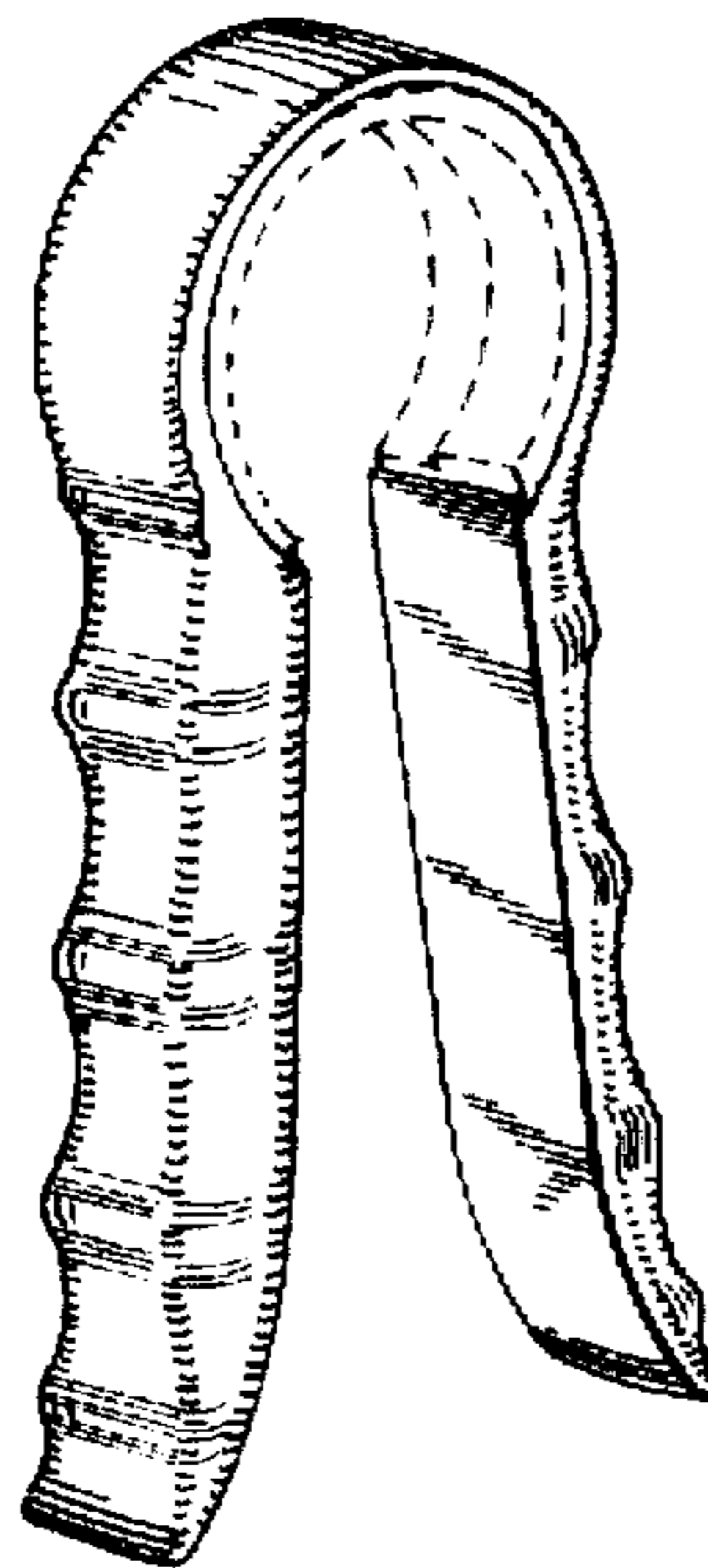
FIG. 1 is a front and left side perspective view of a slip nut wrench showing our new design;

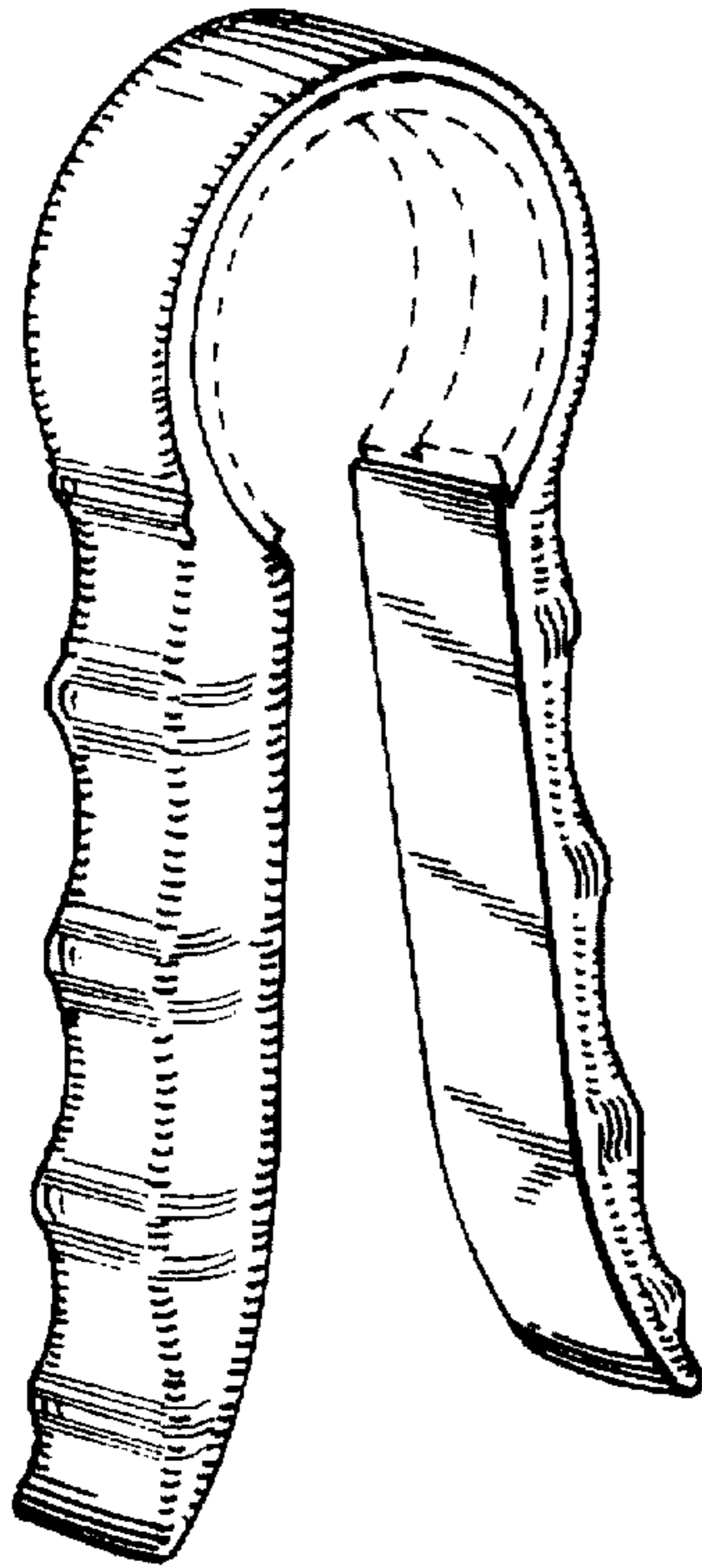

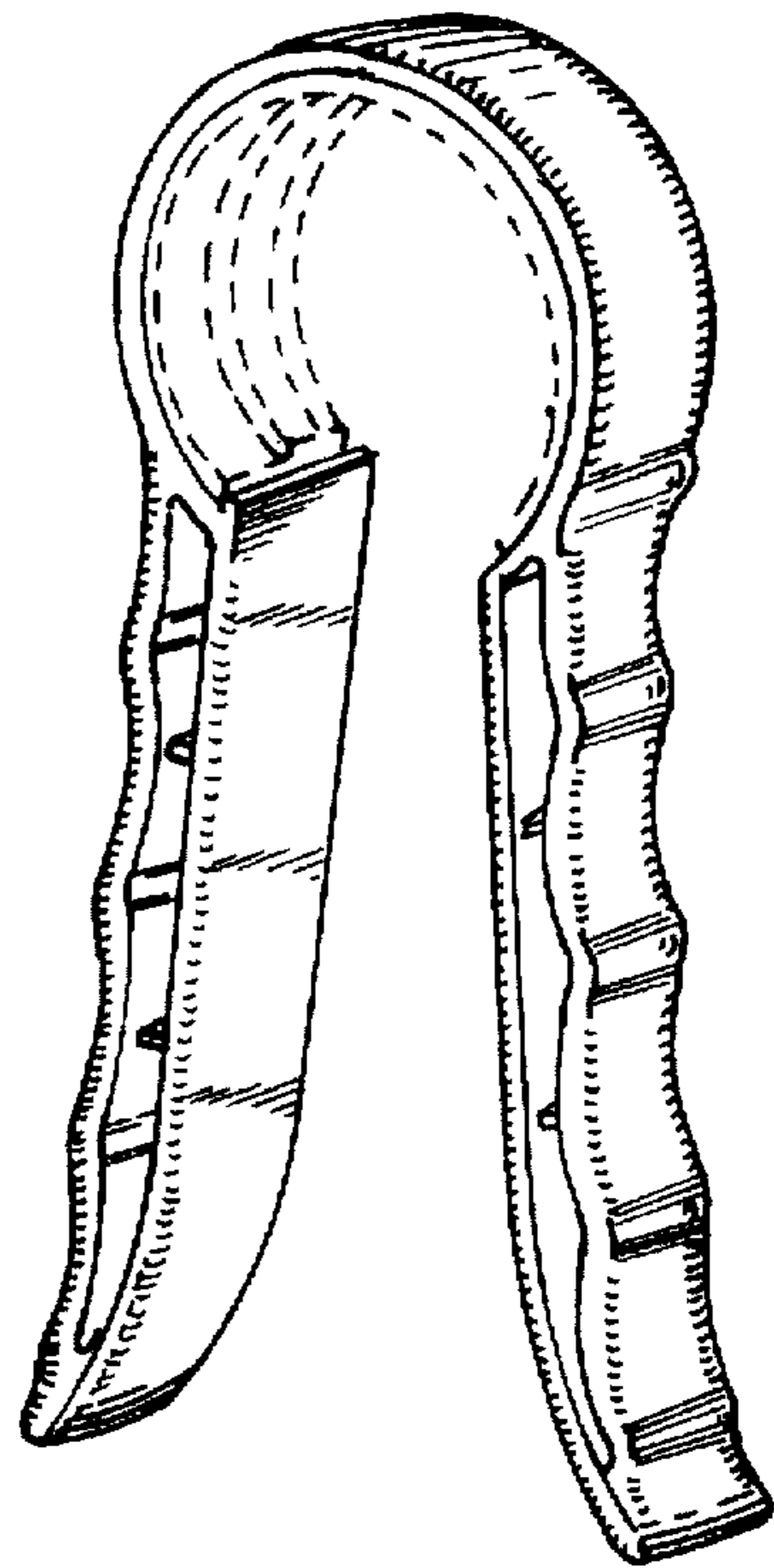

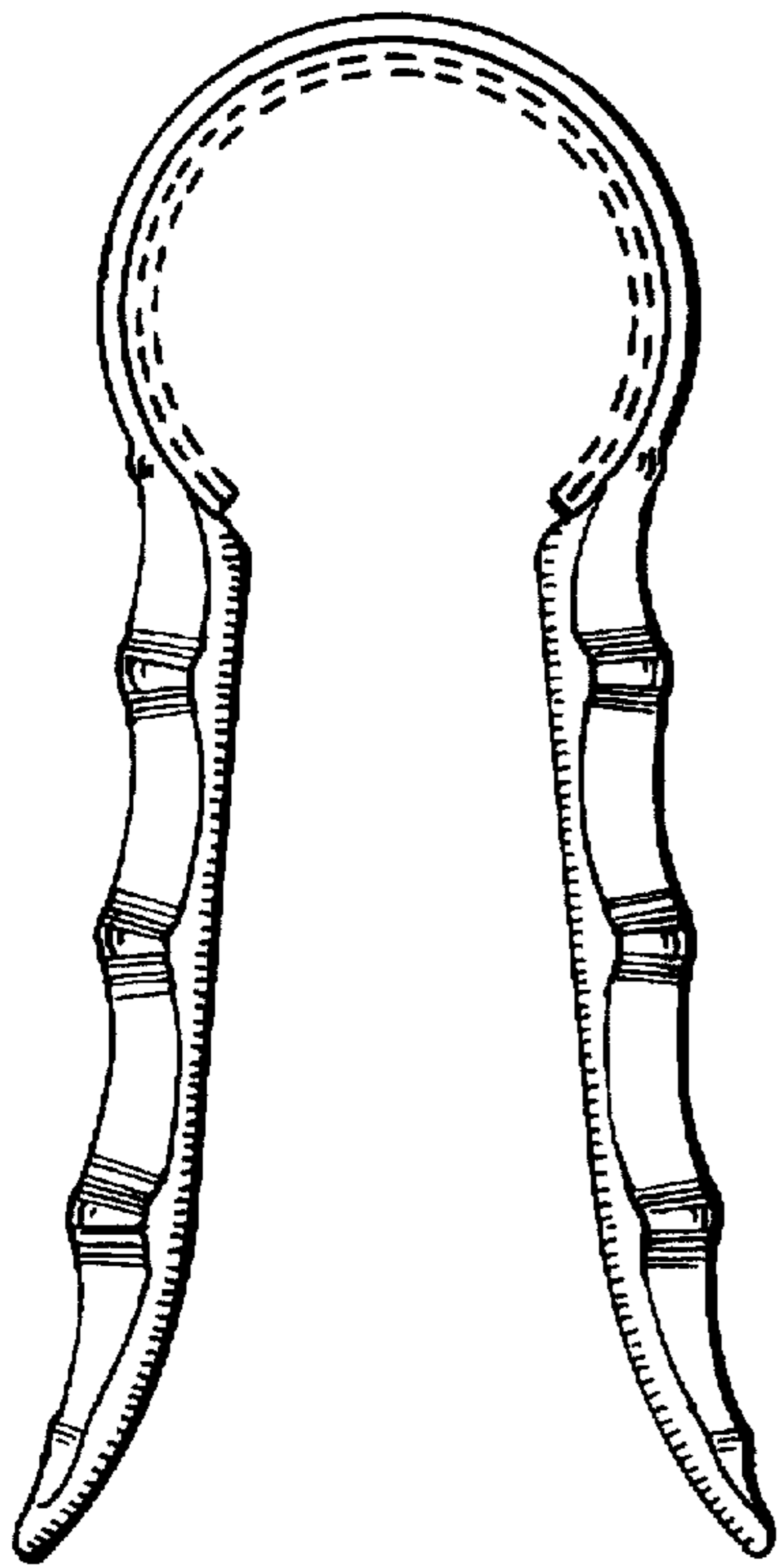

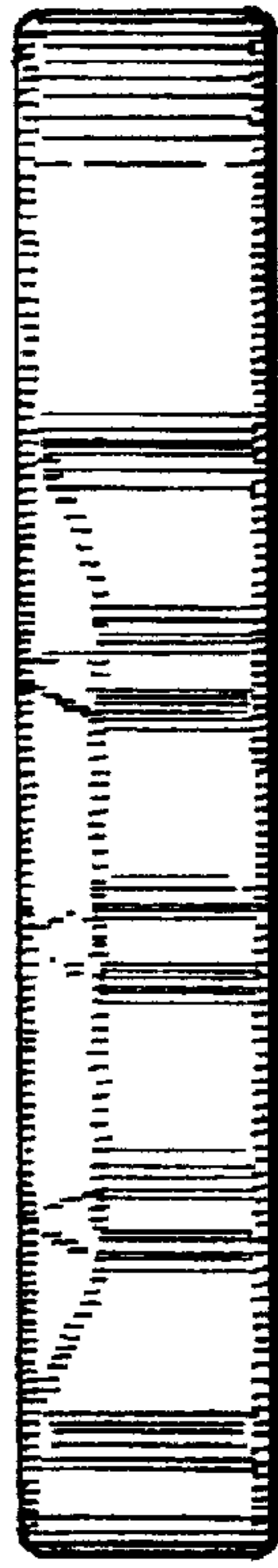

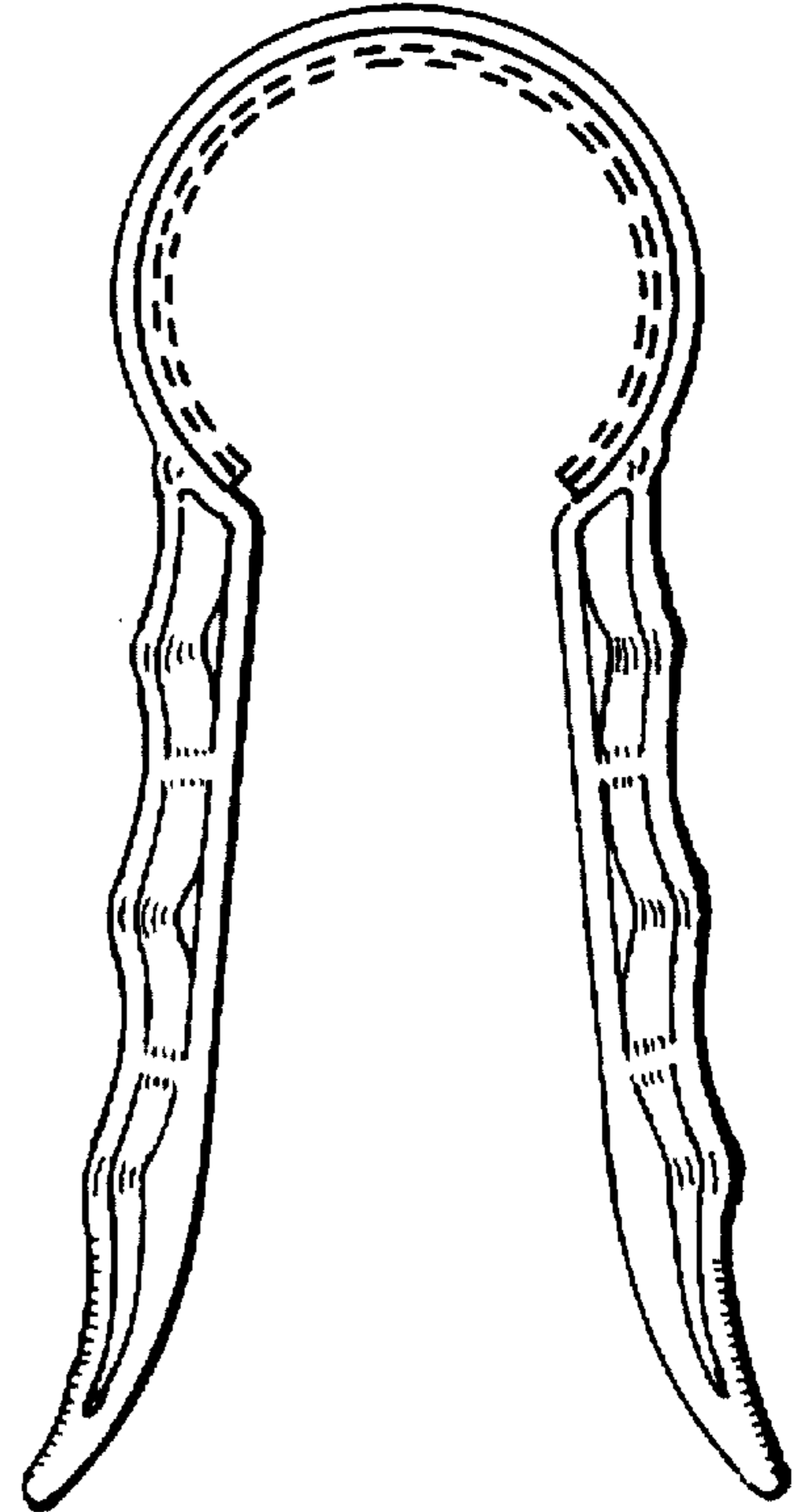

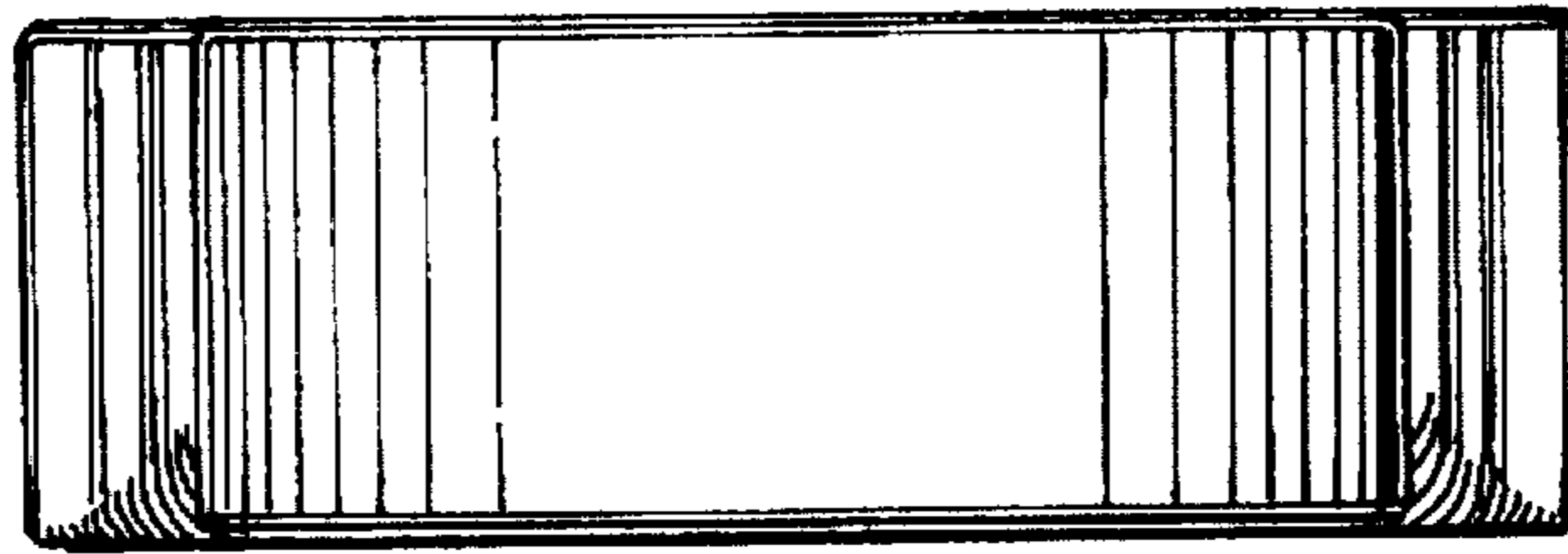

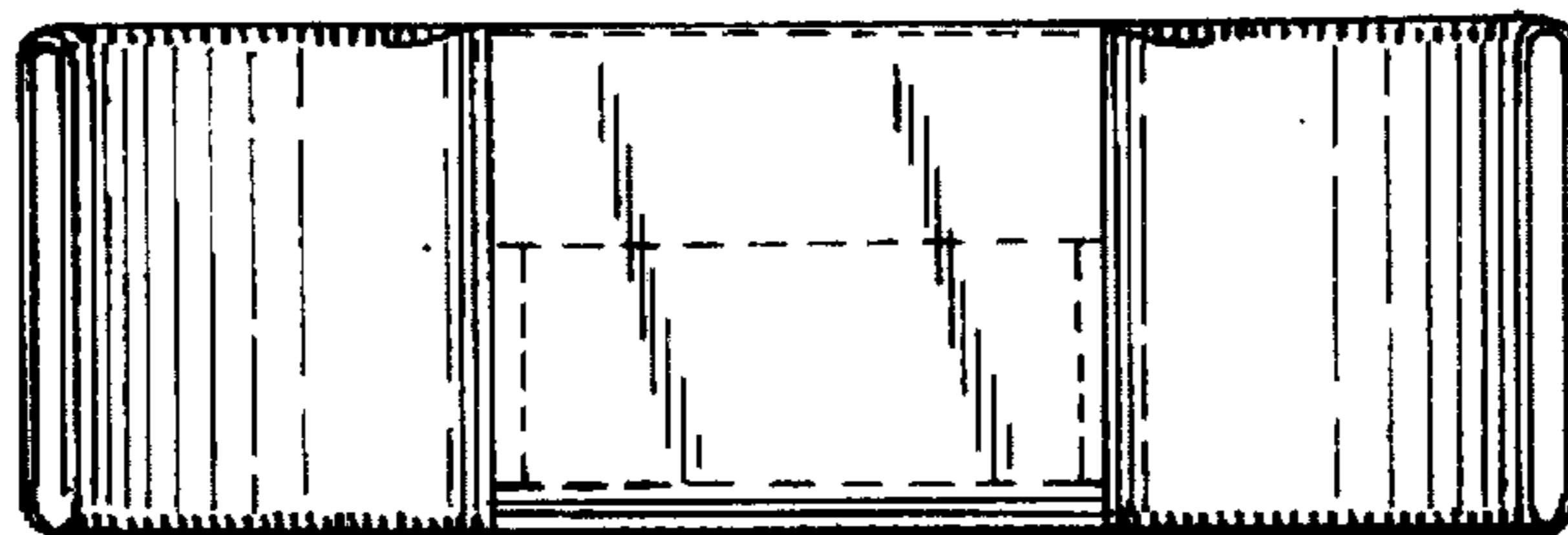
