
[57] **CLAIM**

The ornamental design for a plastic container with handle, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a plastic container with handle embodying our novel design;  
FIG. 2 is a front elevational view, the side opposite being a mirror image thereof;  
FIG. 3 is an elevational view taken from the right in FIG. 2;  
FIG. 4 is a side elevation taken from the left in FIG. 2.  
FIG. 5 is a top plan view; and,  
FIG. 6 is a bottom plan view.












