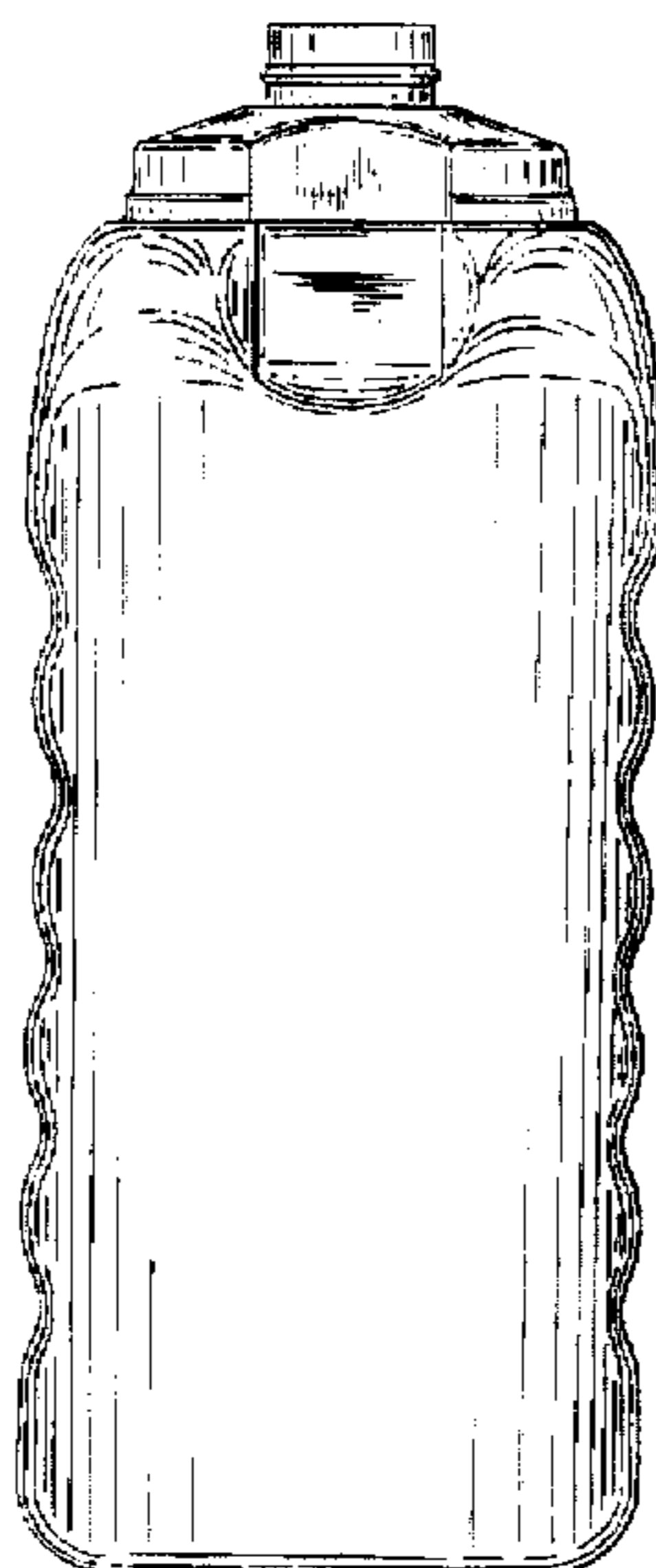
[57] **CLAIM**

The ornamental design for a container, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the container of my design, a closure being shown in phantom lines; FIG. 2 is a front elevational view thereof; FIG. 3 is a rear elevational view thereof; FIG. 4 is a right side elevation thereof, the left side elevation is a mirror image thereto; FIG. 5 is a top plan view thereof; and, FIG. 6 is a bottom plan view thereof. The broken lines showing a closure in FIG. 1 are for illustrative purposes only and do not form a part of the claimed design.

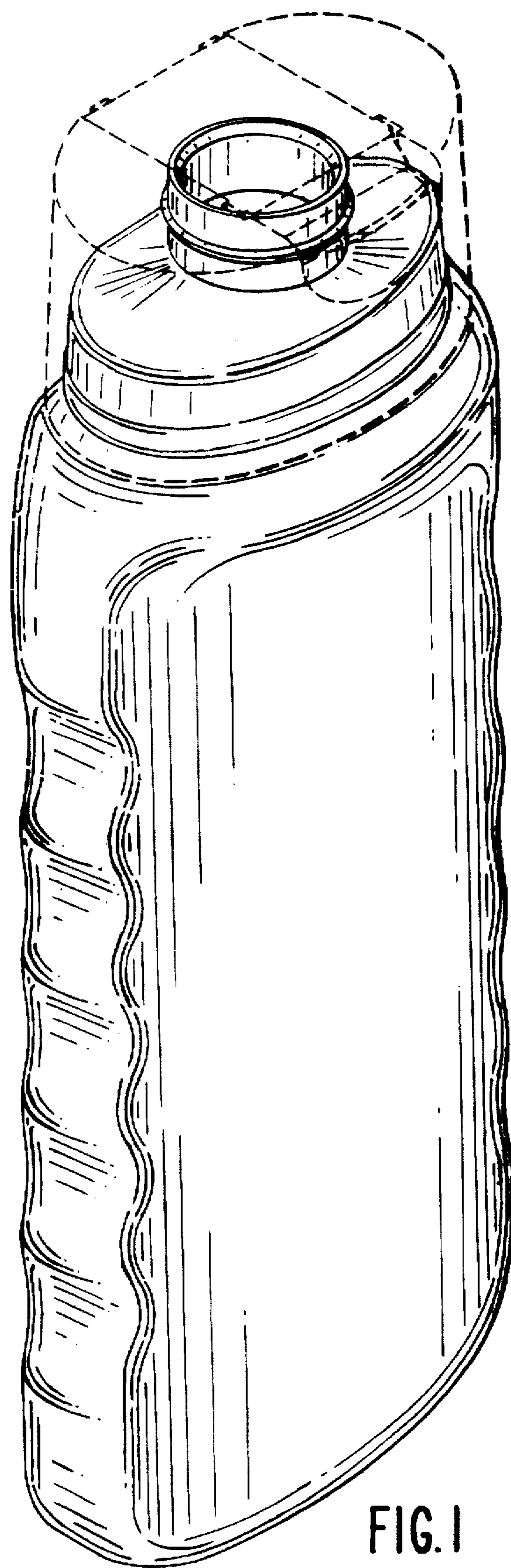

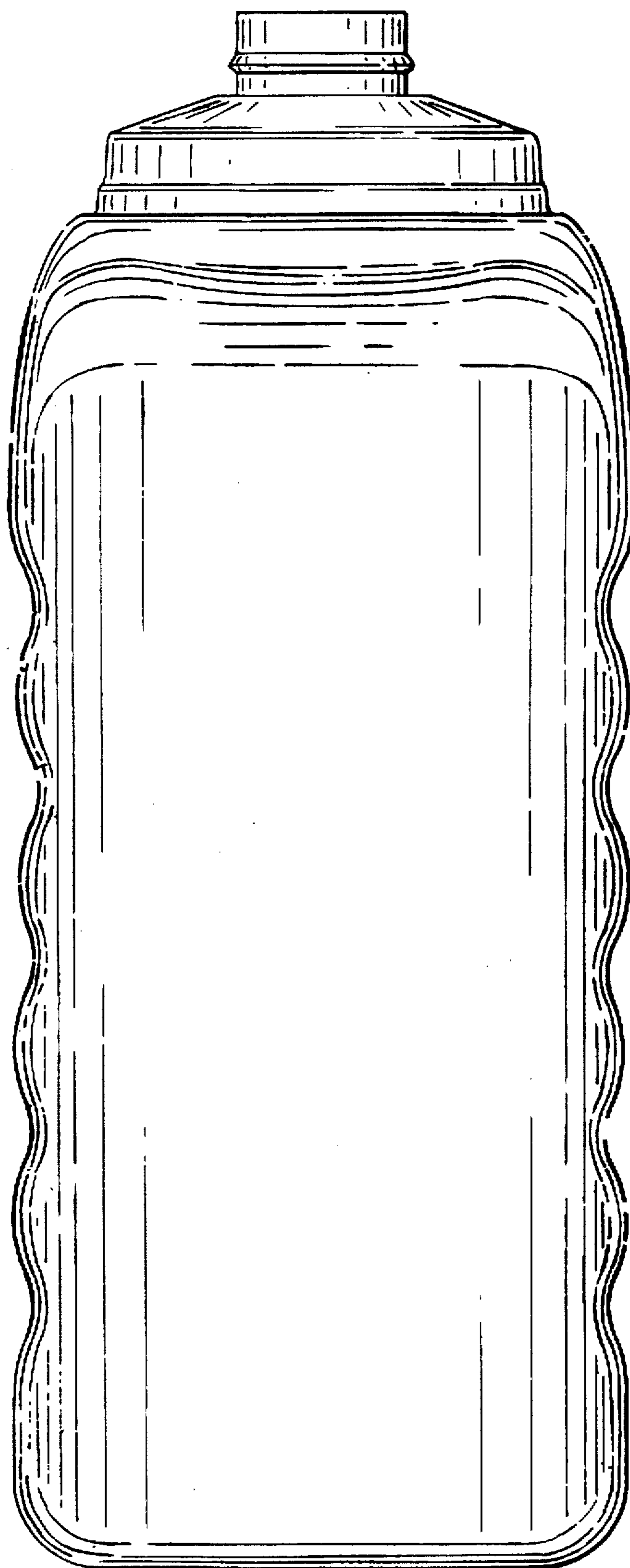

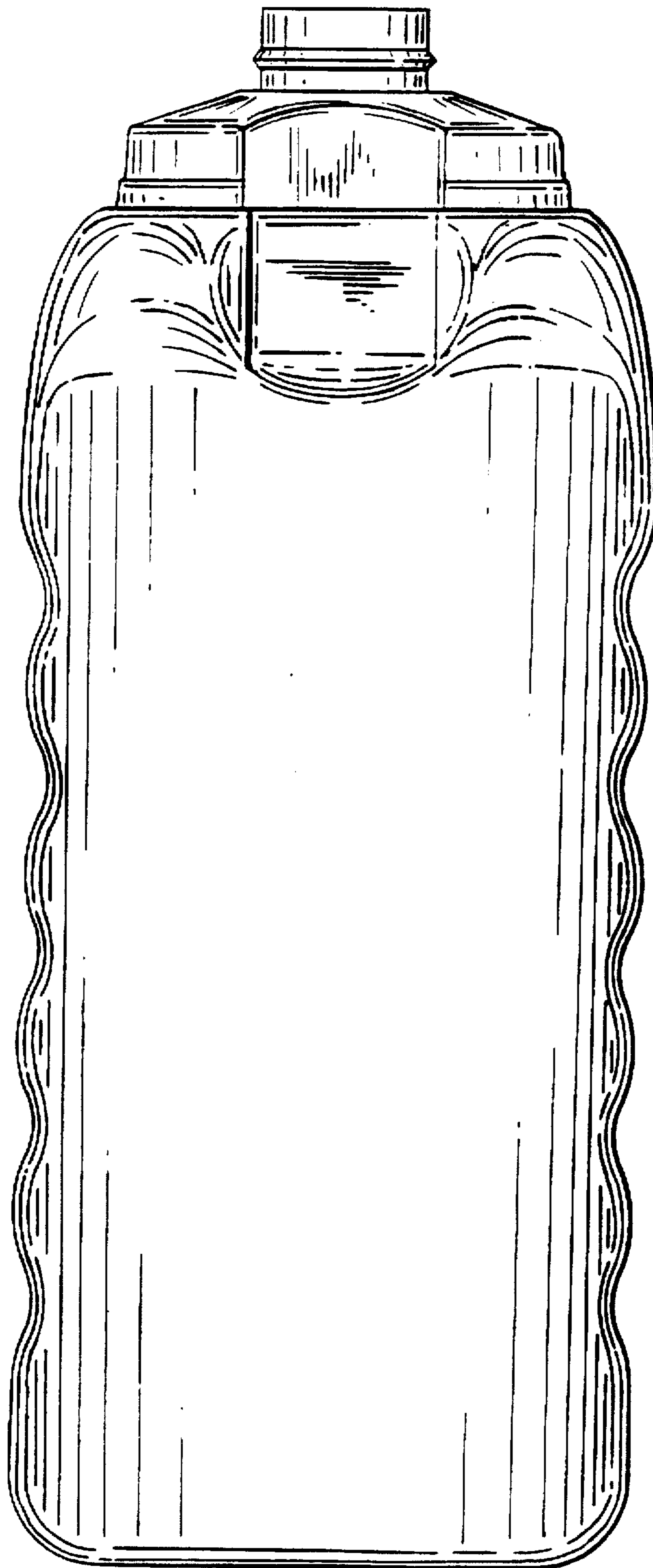

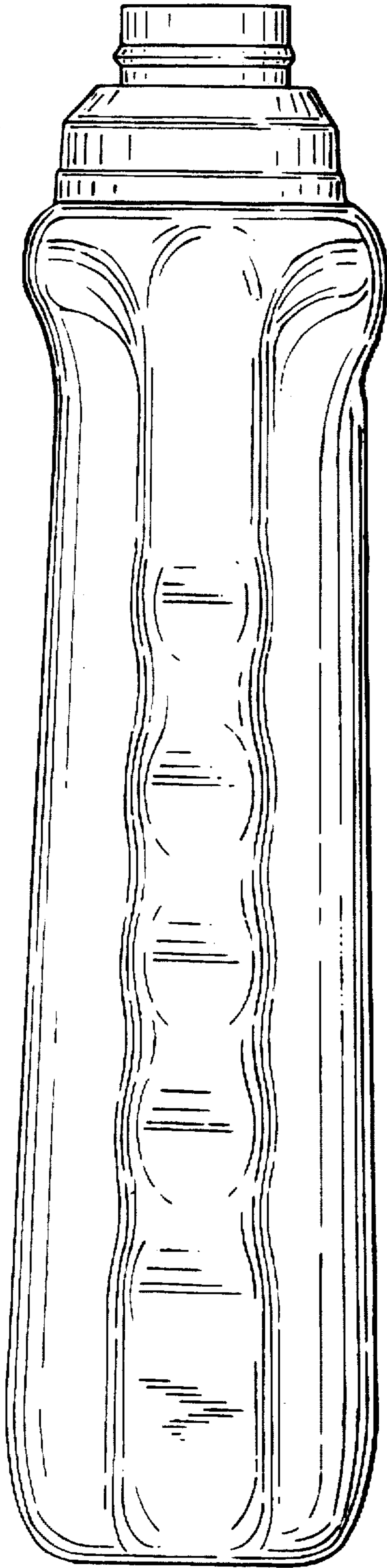

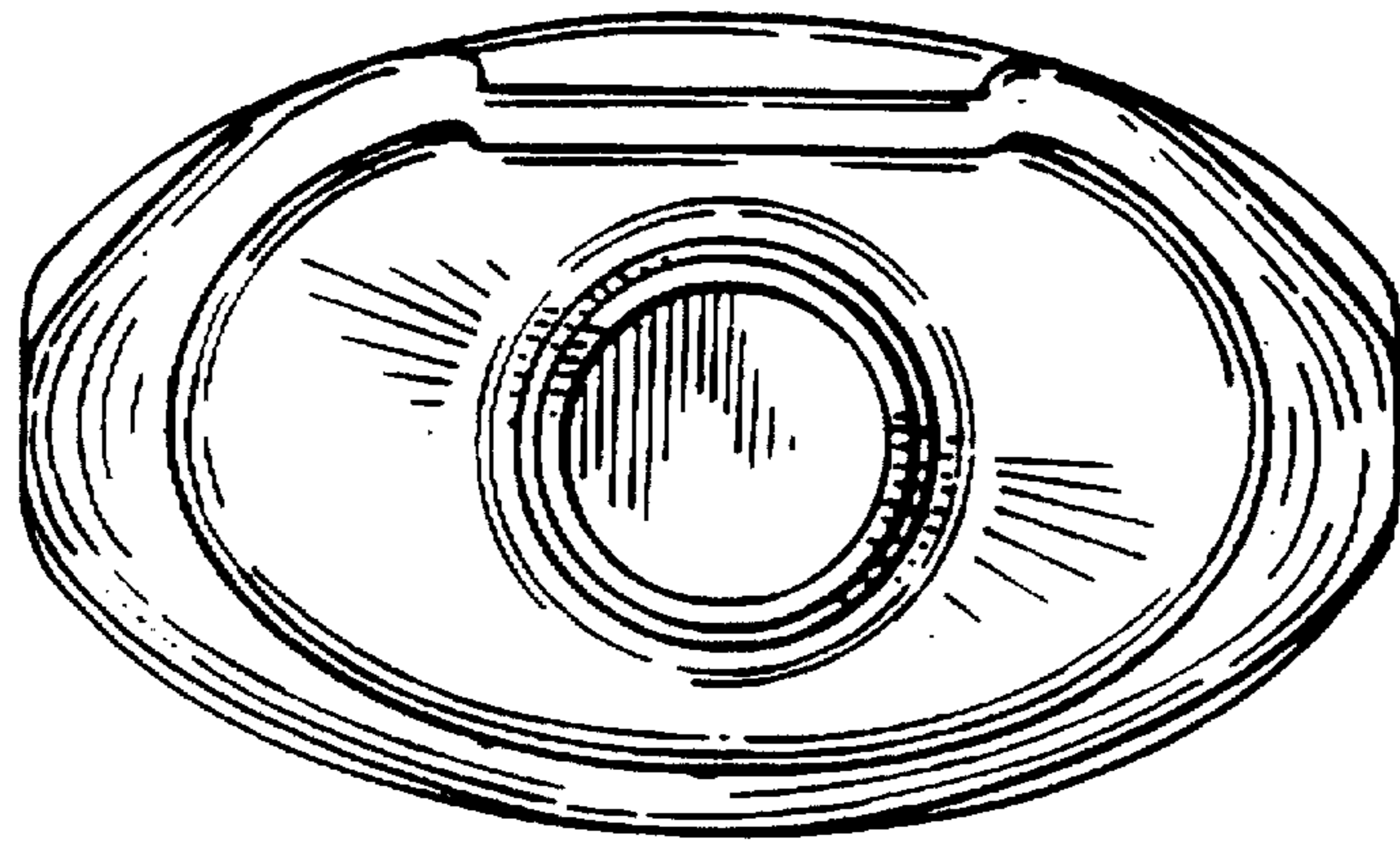

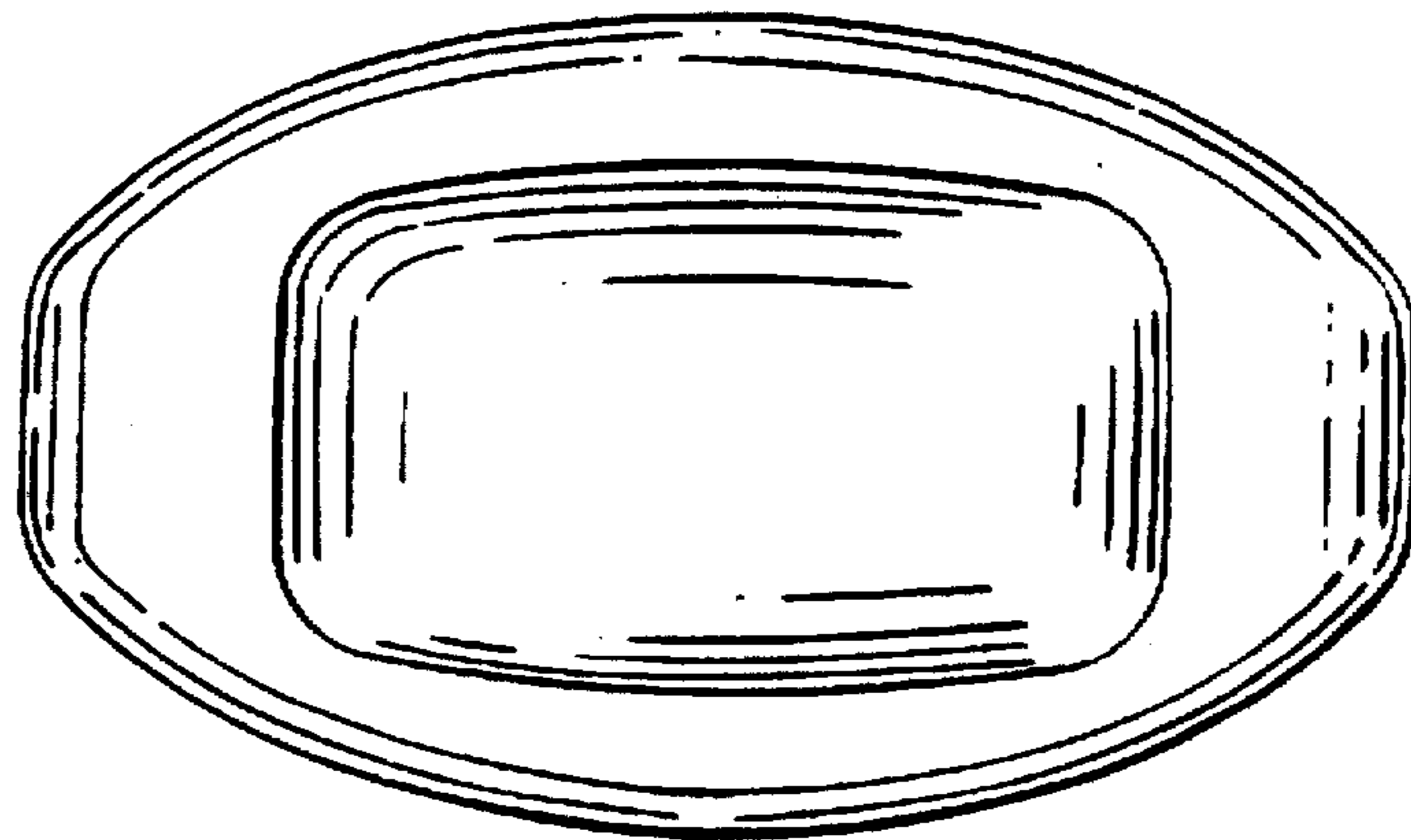
