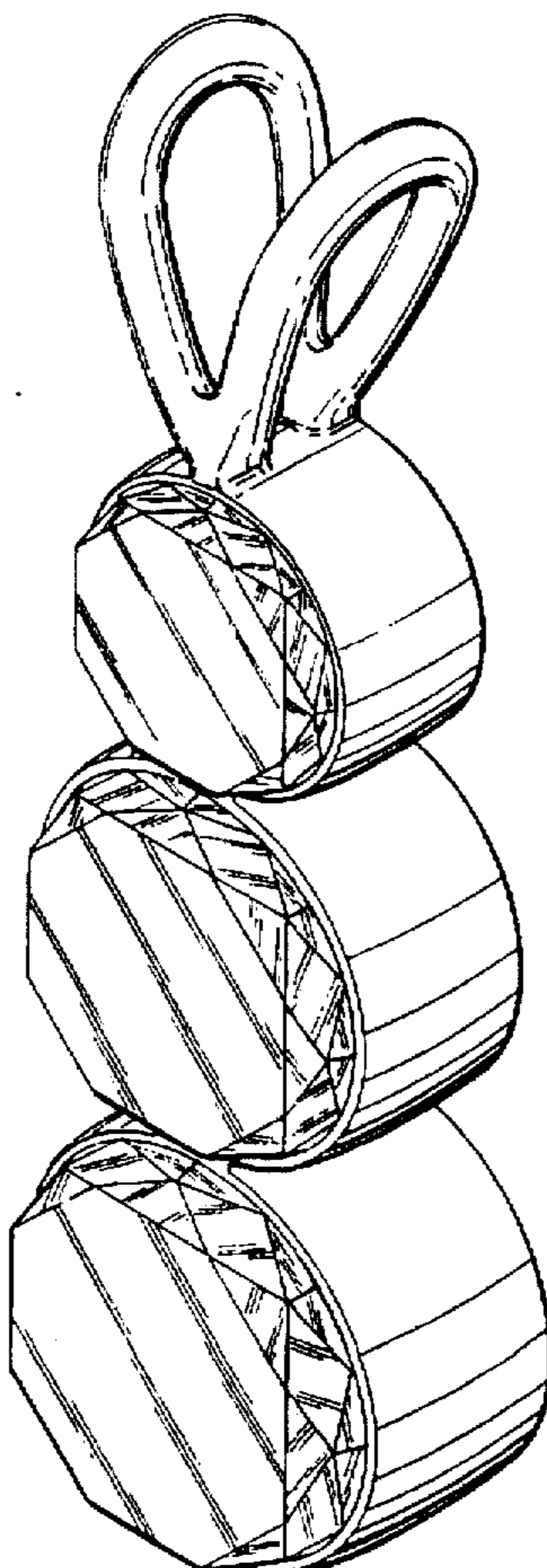
**CLAIM**

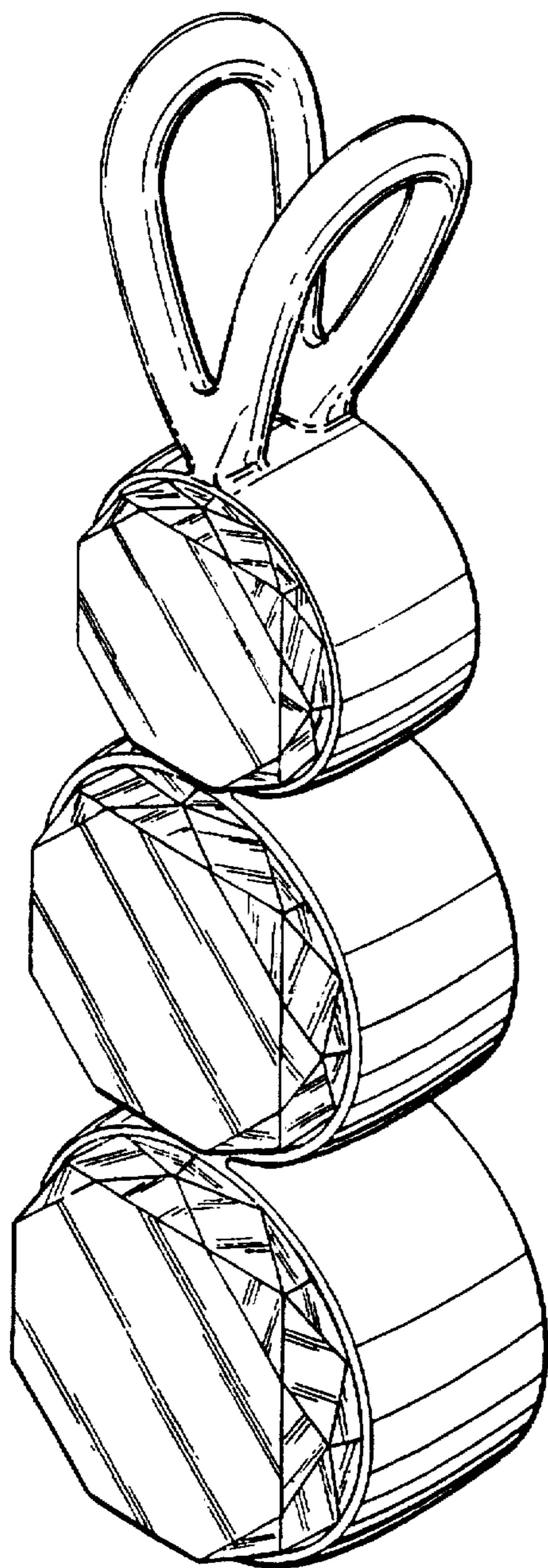

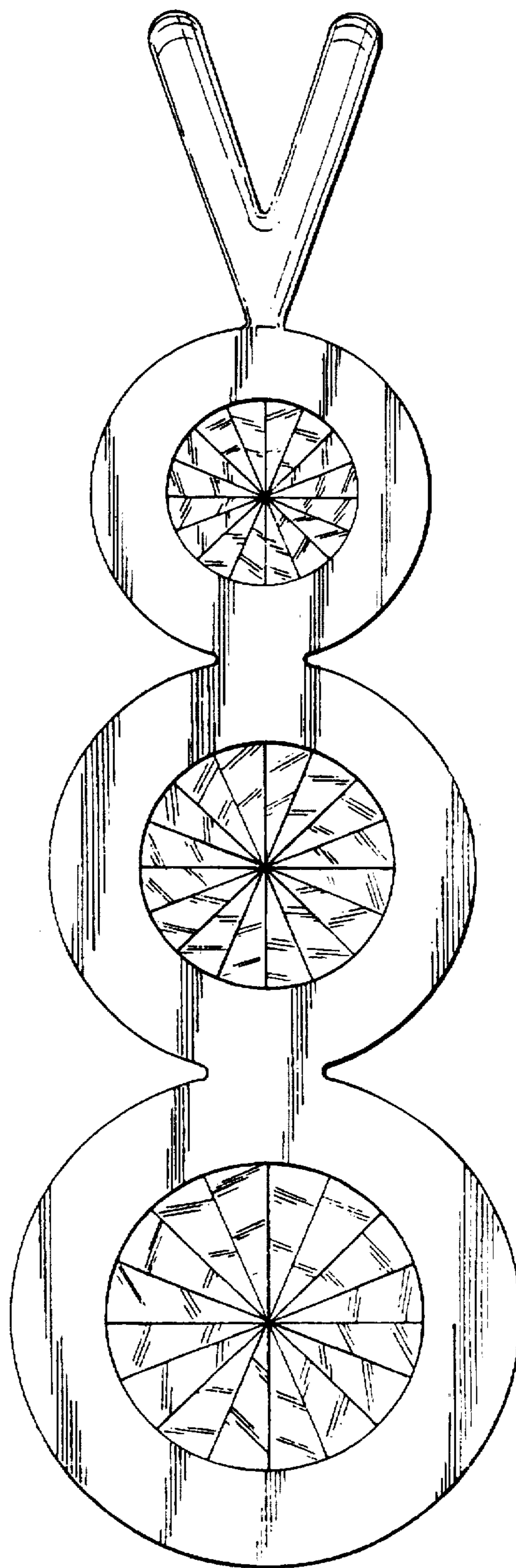

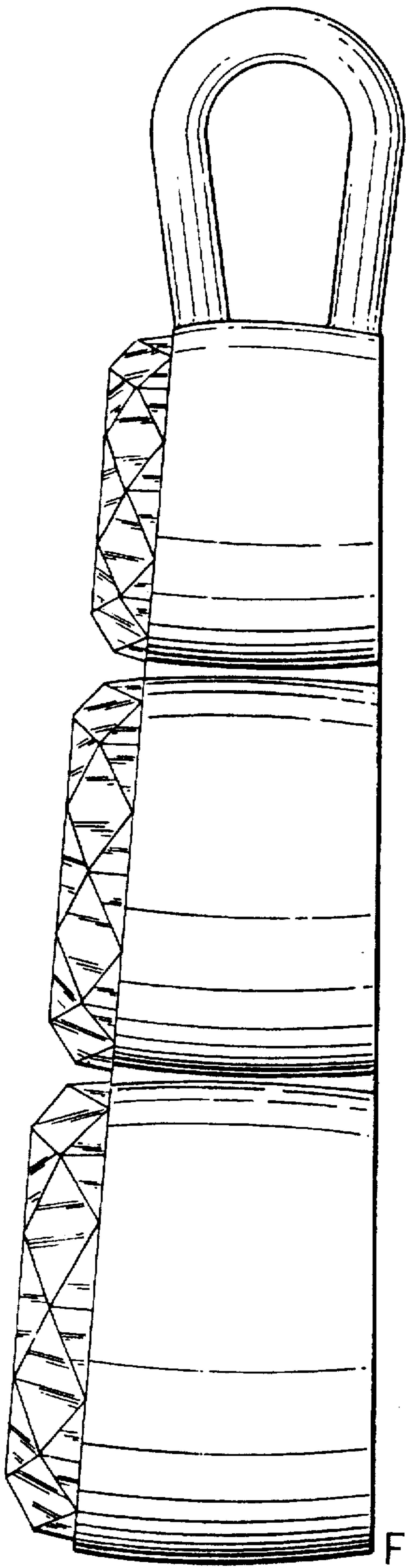

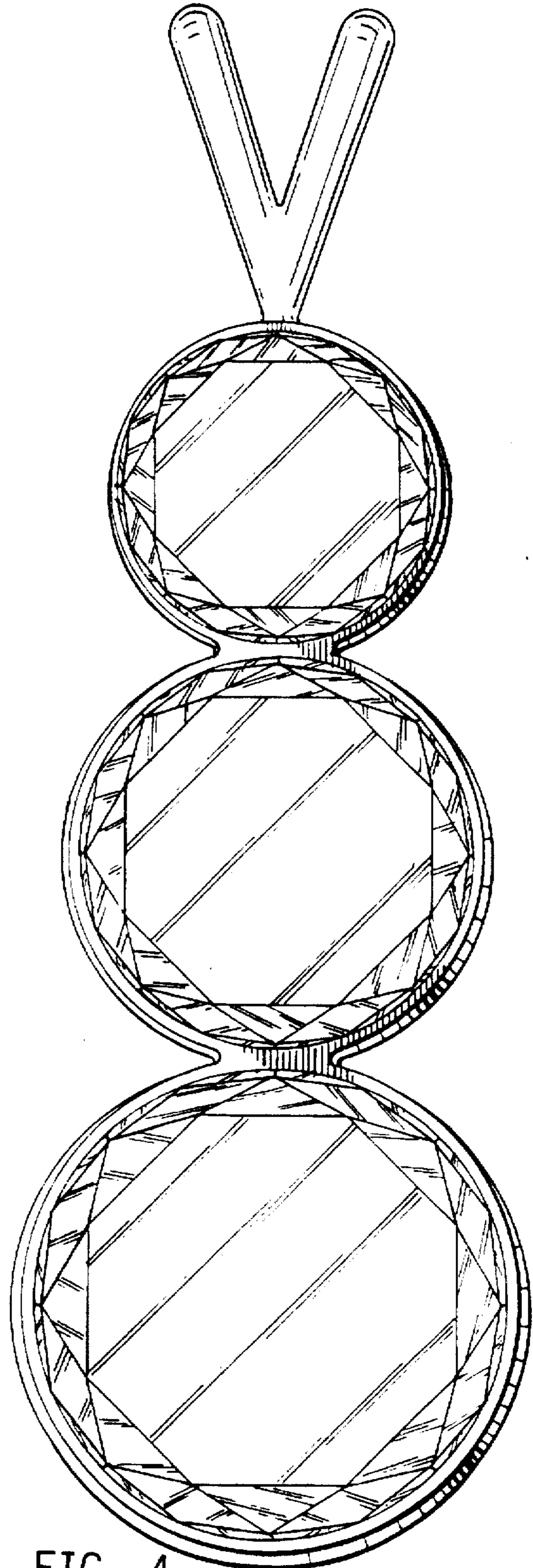
