**DESCRIPTION**

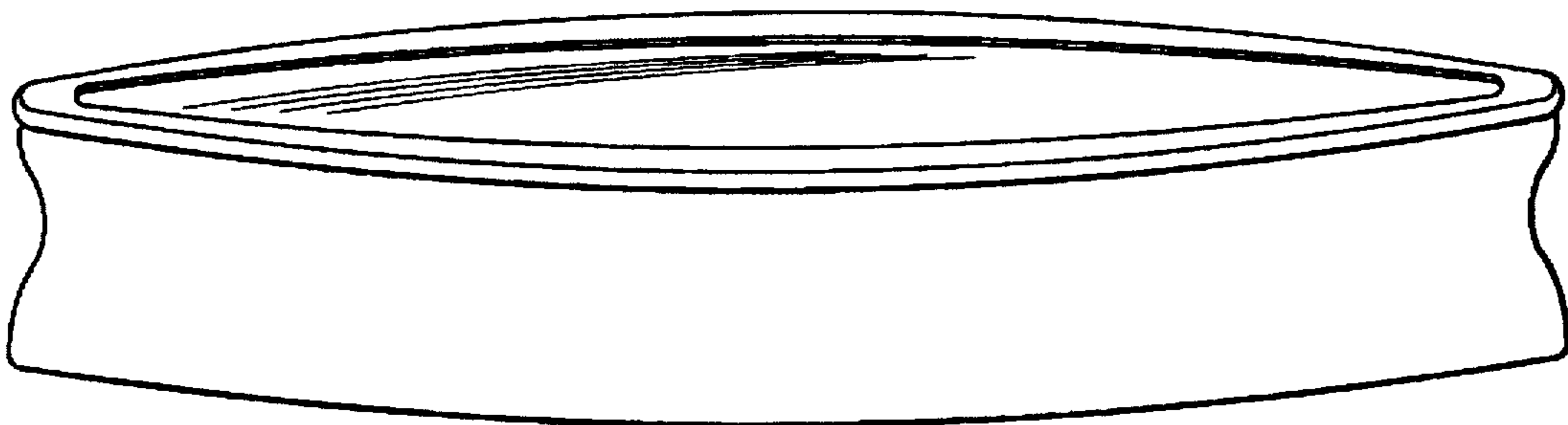
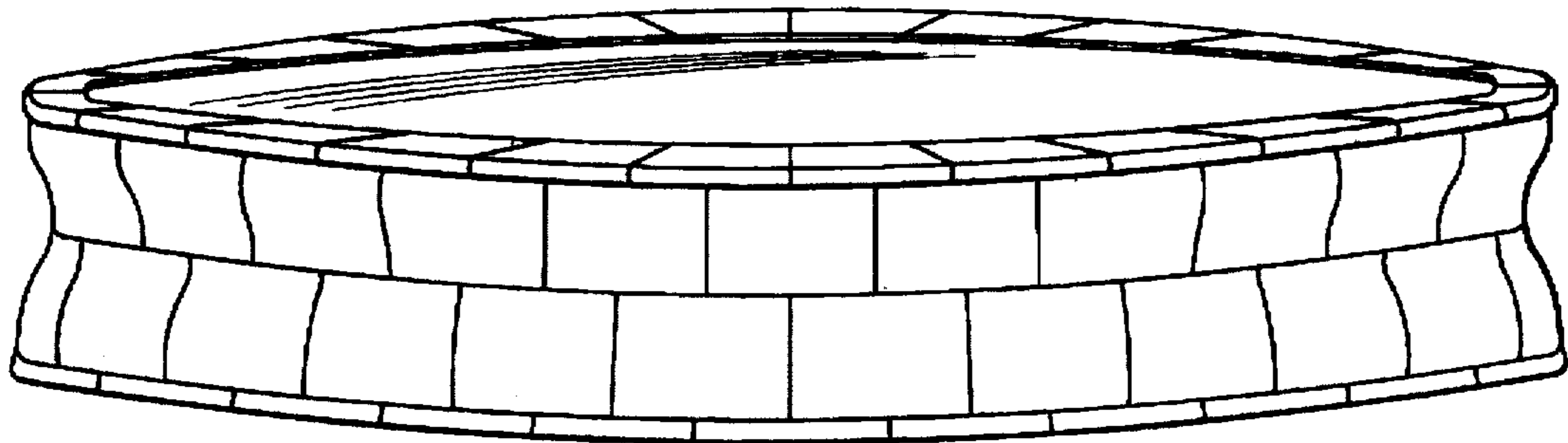
FIG. 1 is an isometric view of one embodiment of a pool showing my new design;

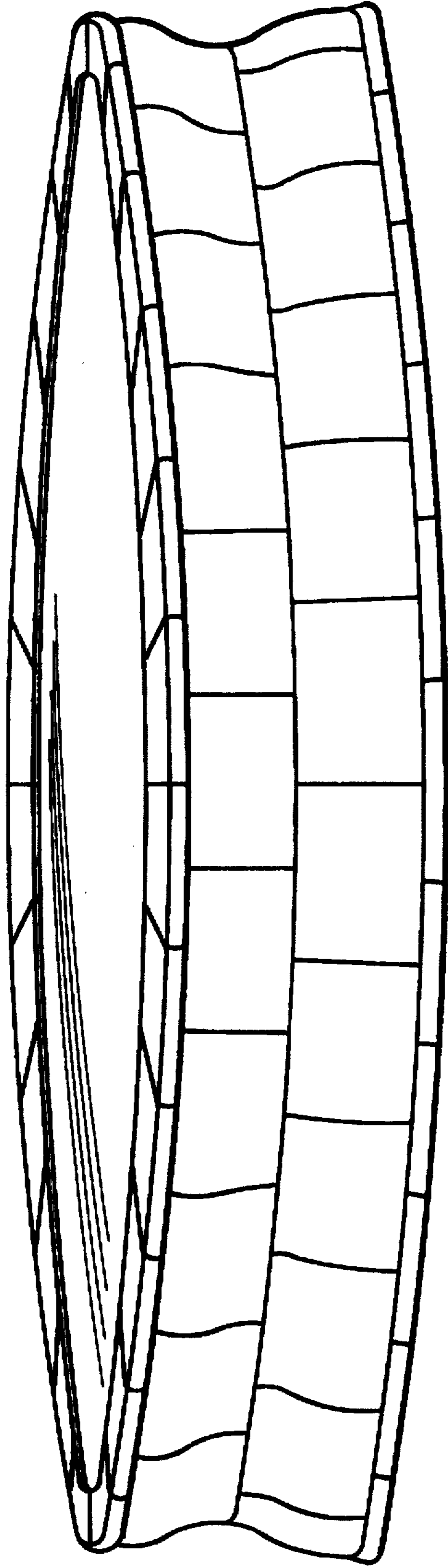

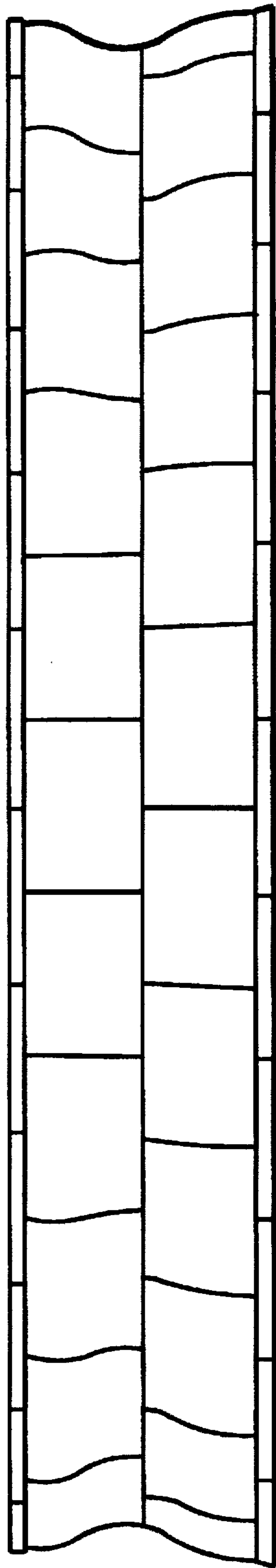

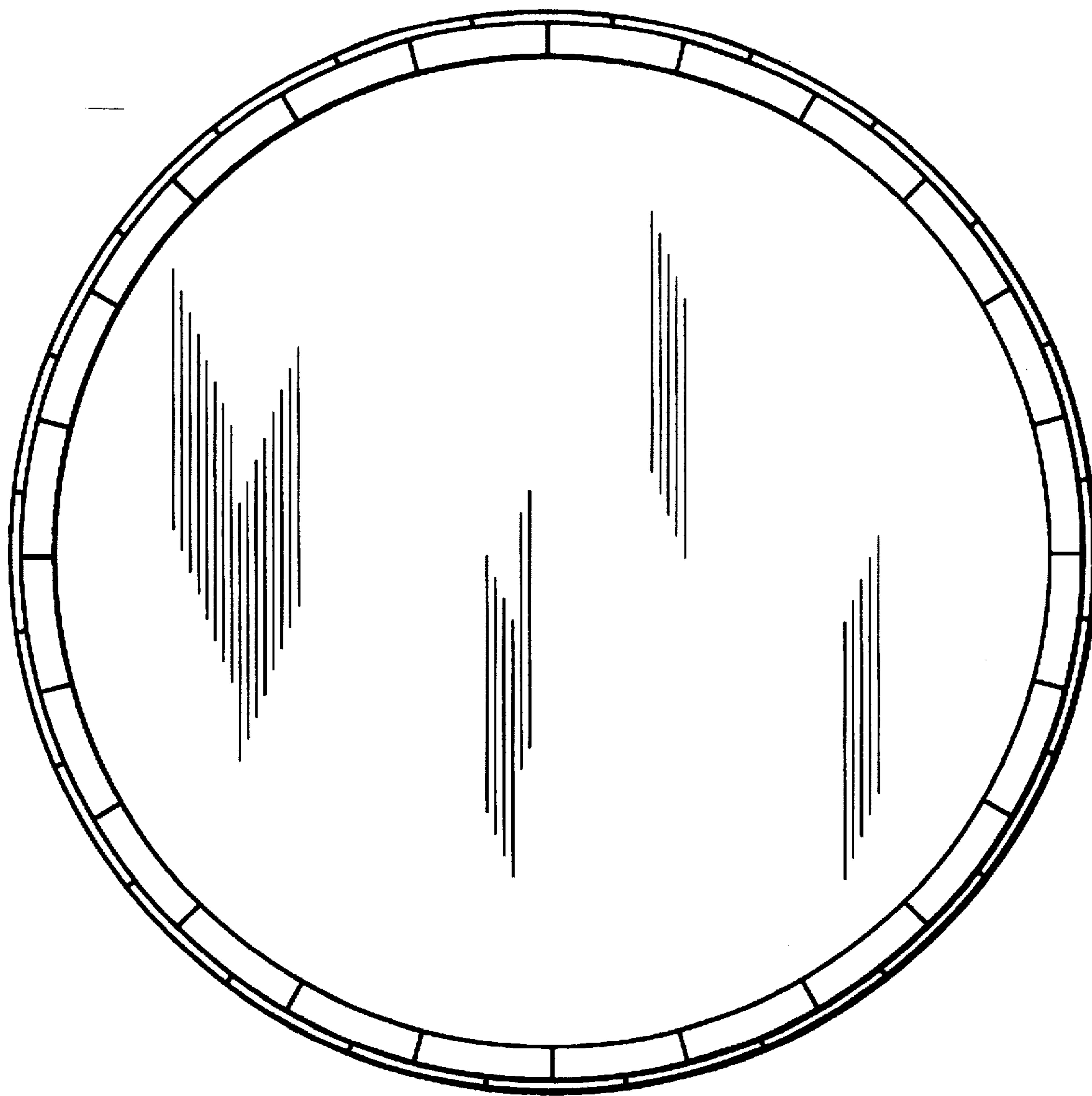




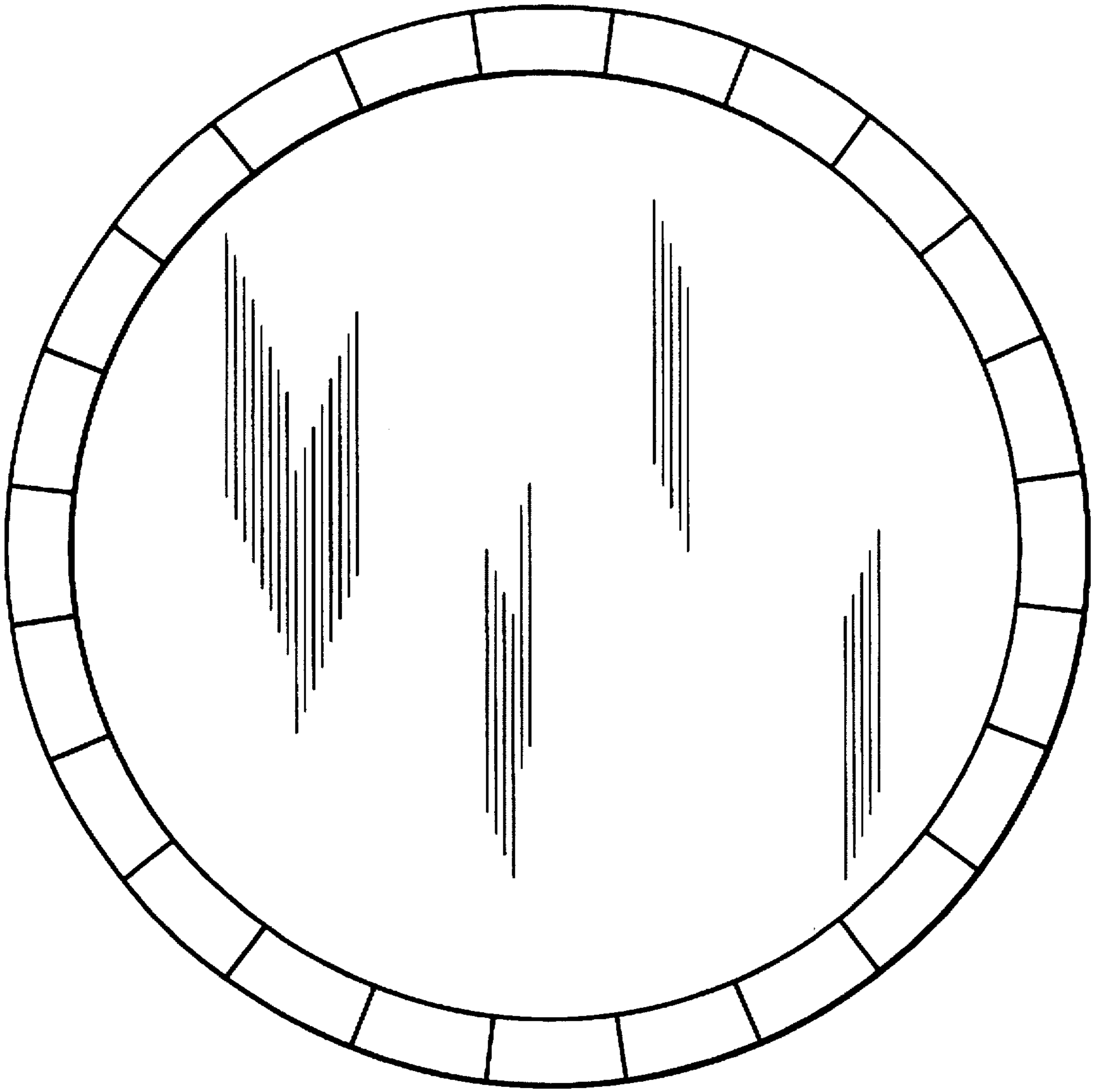

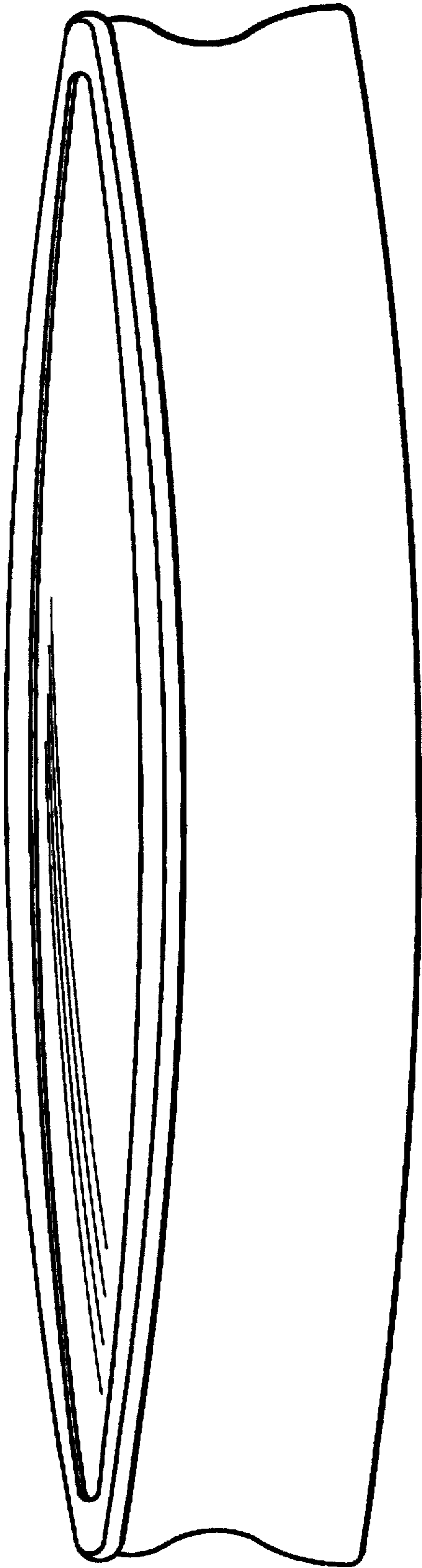
