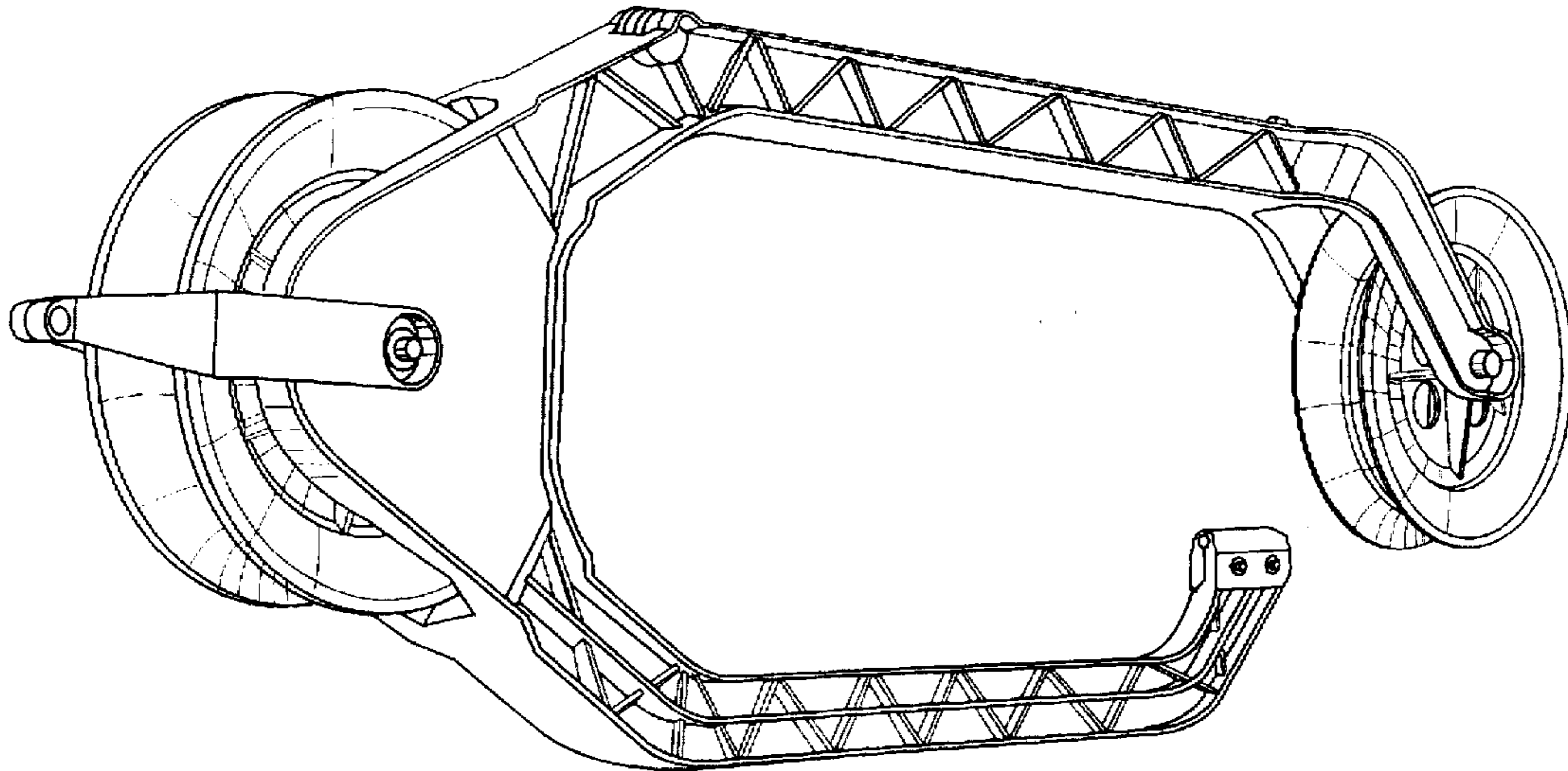

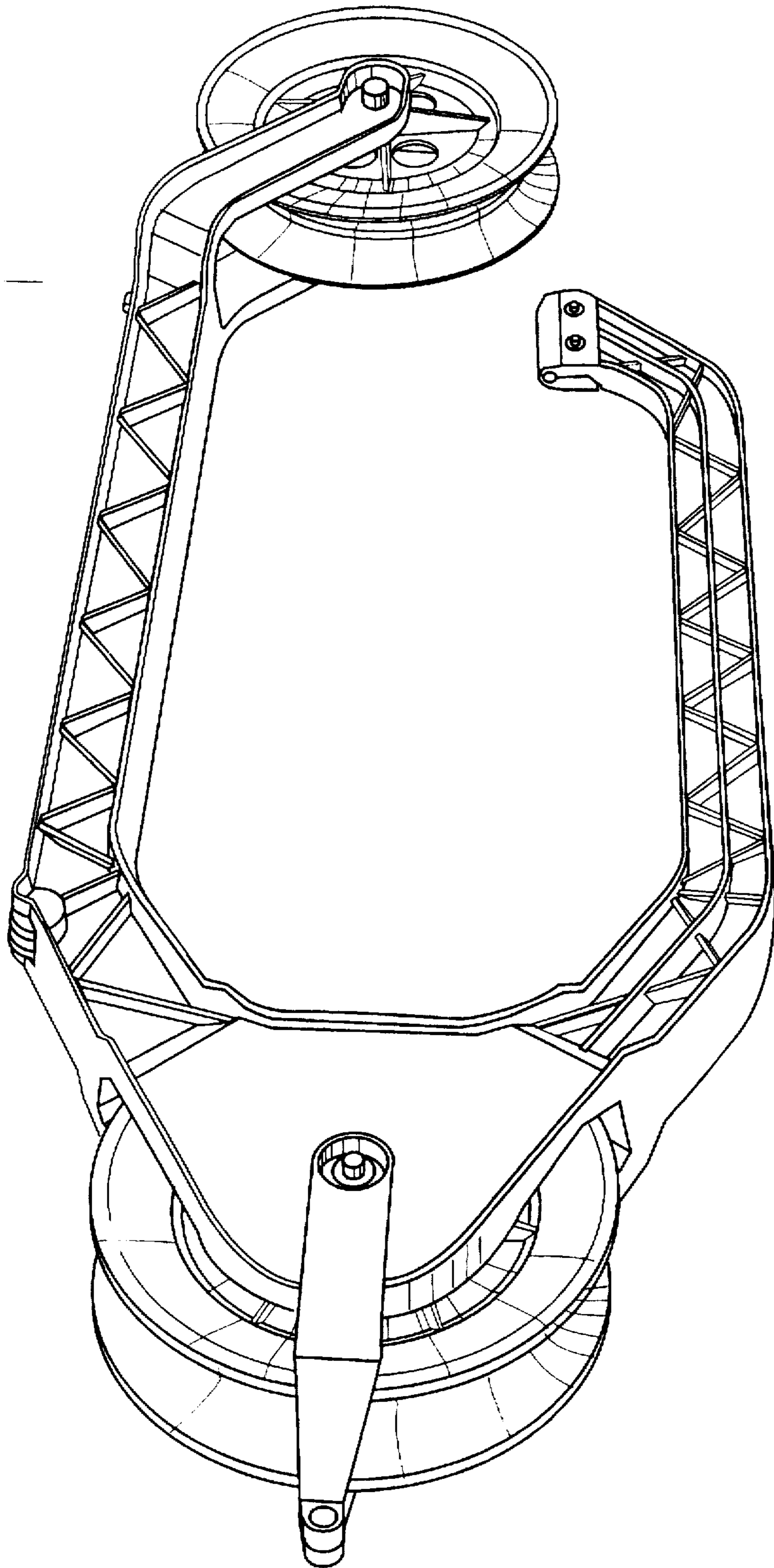
The ornamental design for a clothes line support, as shown and described.

**DESCRIPTION**

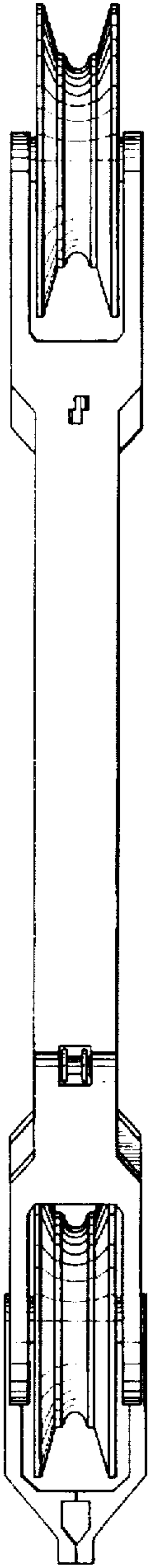
FIG. 1 is perspective view of the design;

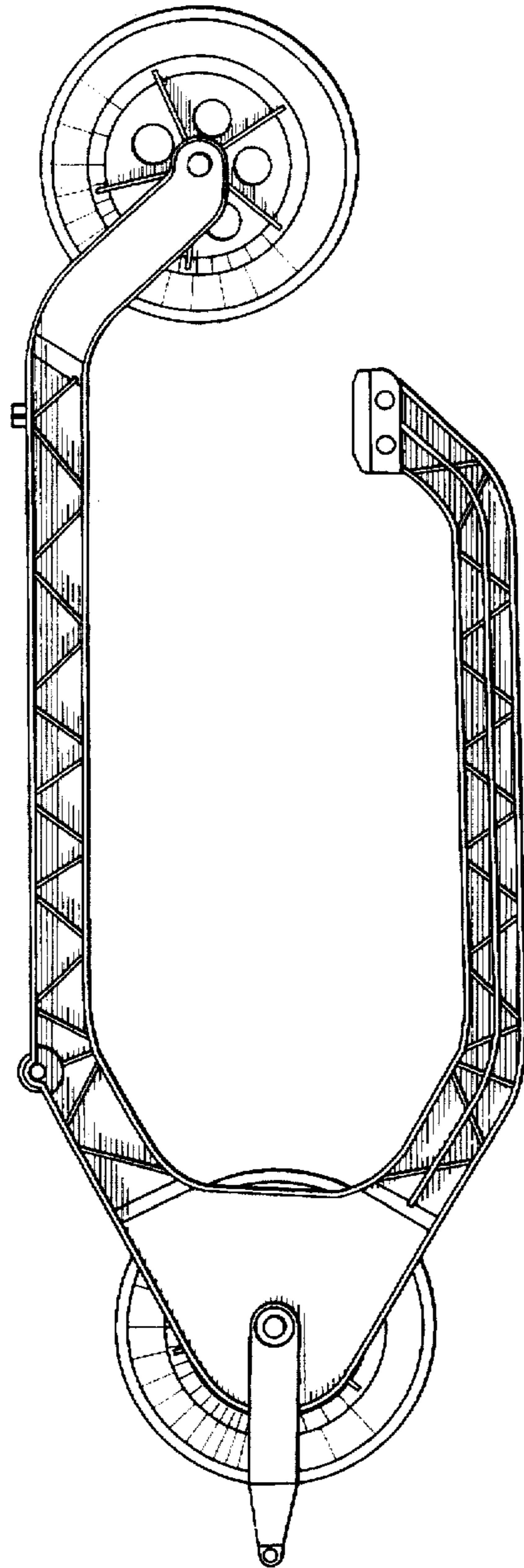




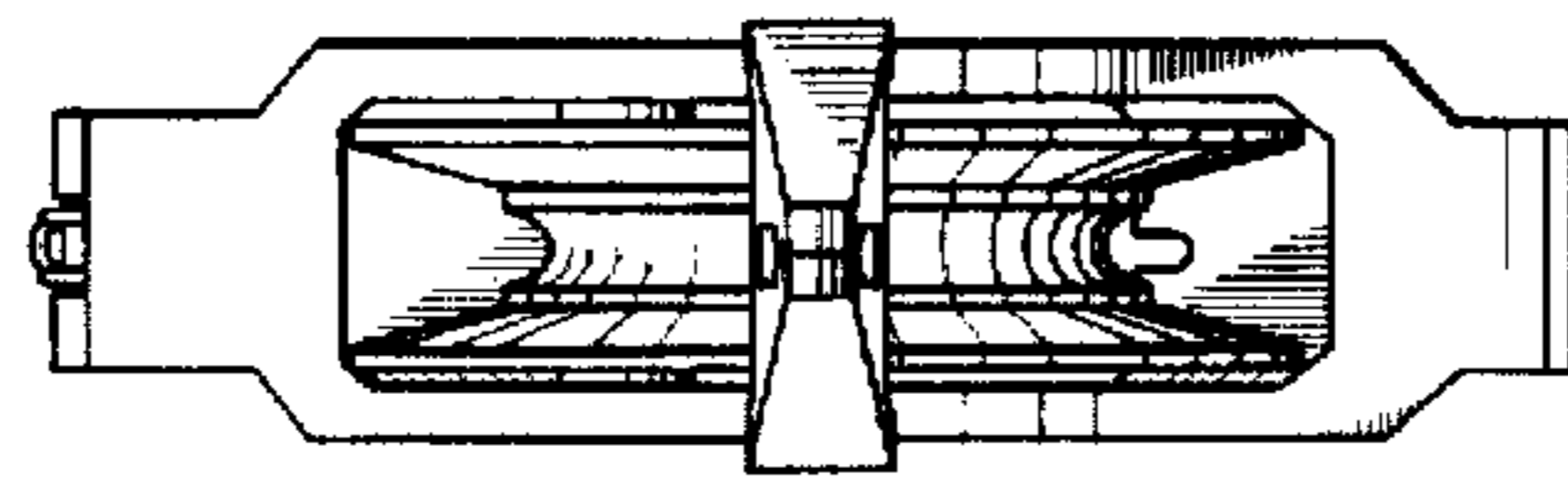

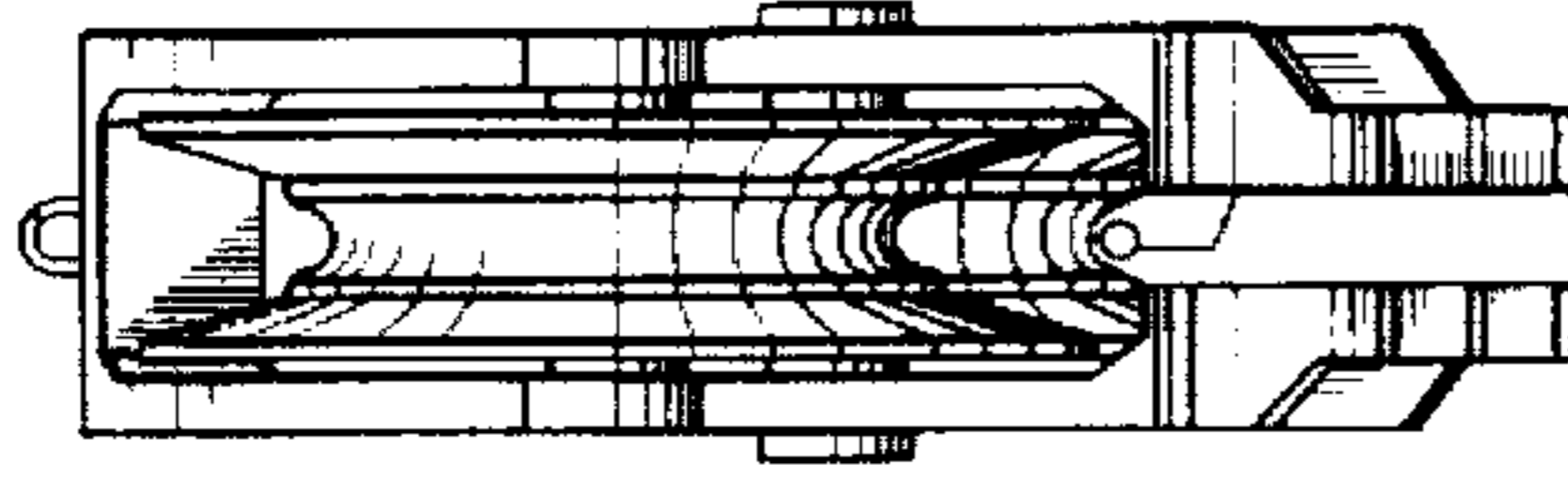

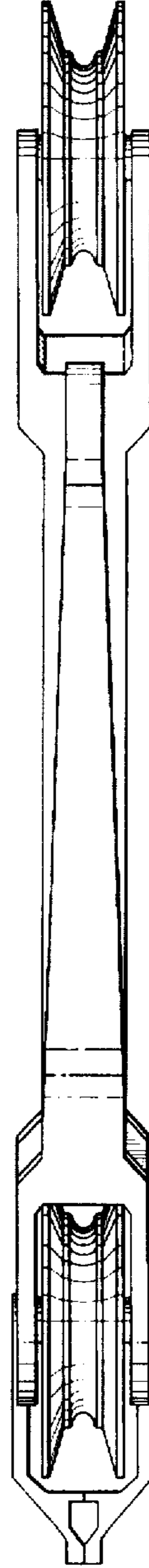
