The ornamental design for a suit jacket lapel, as shown and described.

DESCRIPTION

FIG. 1 is a front prospective view of a suit jacket lapel showing my new design;
FIG. 2 is a top plan view thereof;
FIG. 3 is a front elevational view thereof;
FIG. 4 is a right side elevational view thereof;
FIG. 5 is a rear elevational view thereof;
FIG. 6 is a left side elevational view thereof;
FIG. 7 is a bottom plan view thereof; and,
FIG. 8 is a cross sectional view of FIG. 3 taken along lines 8—8.

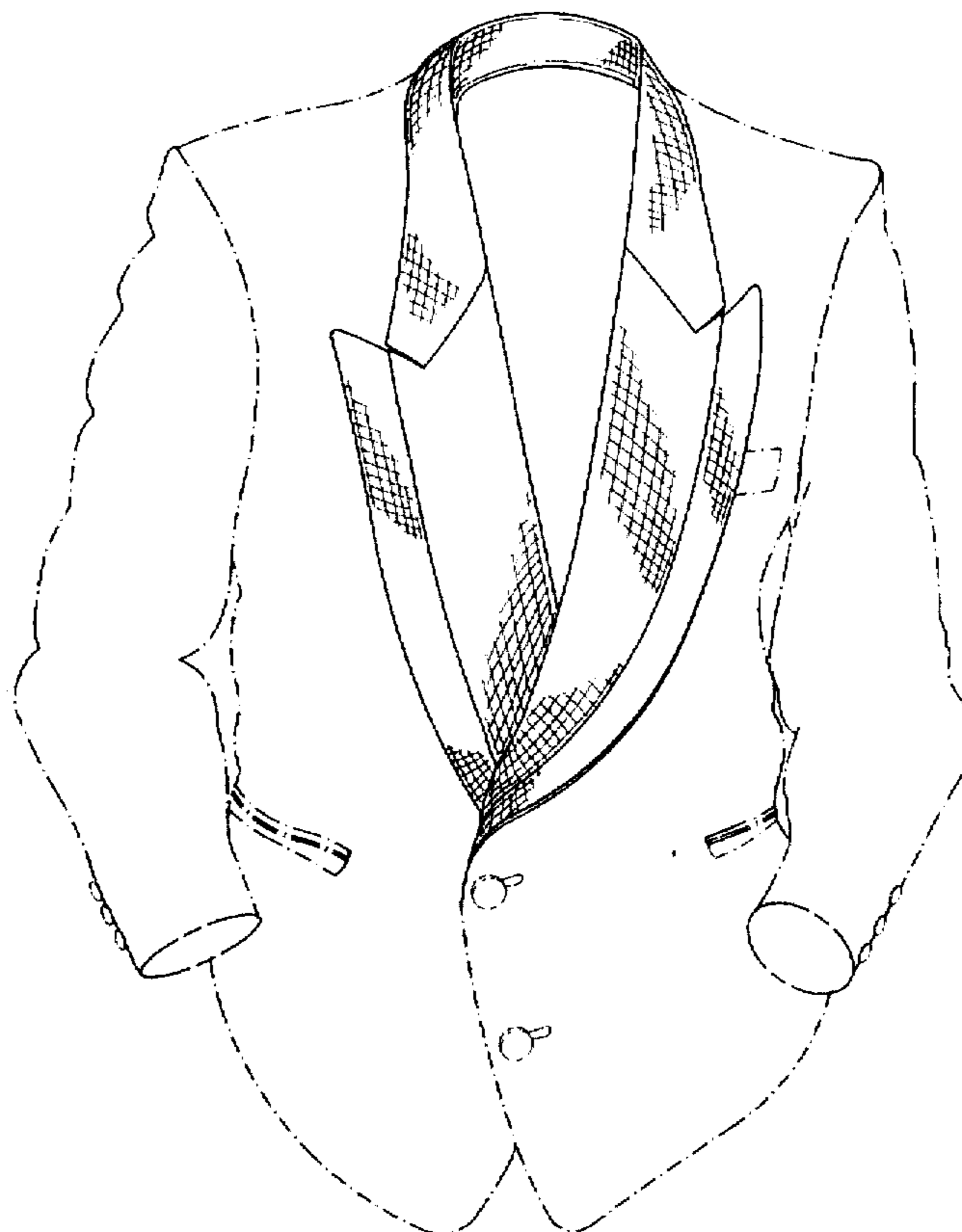

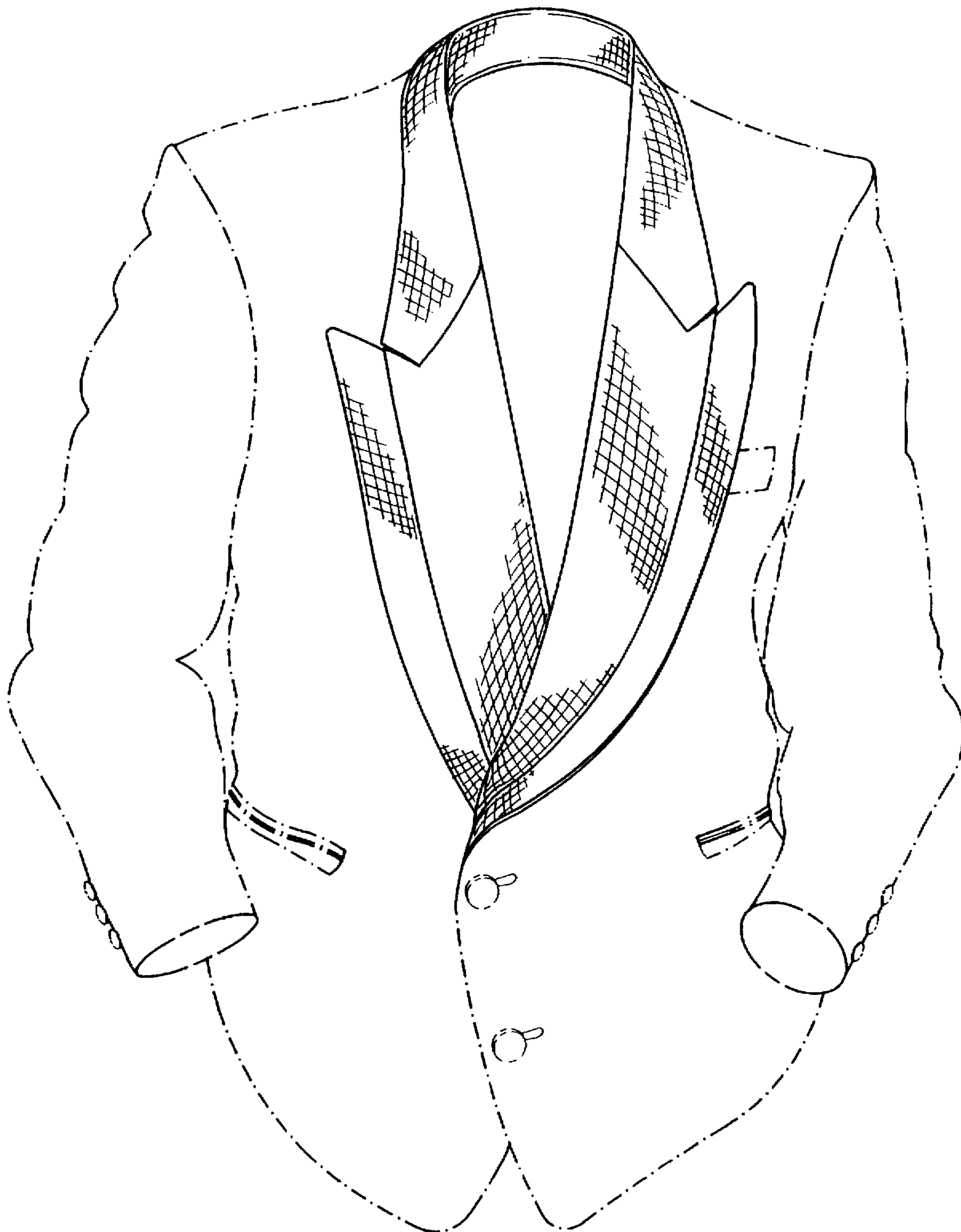

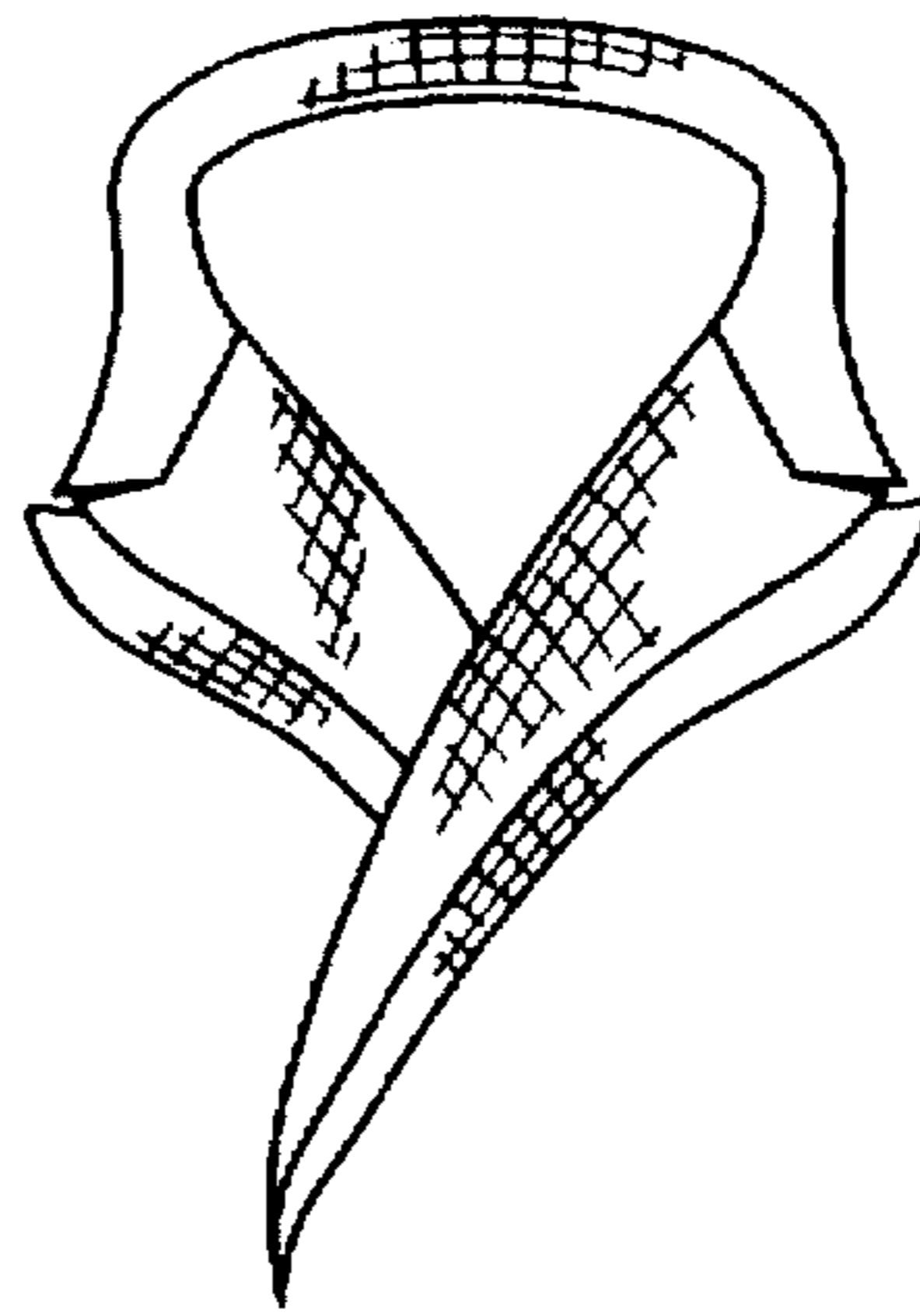

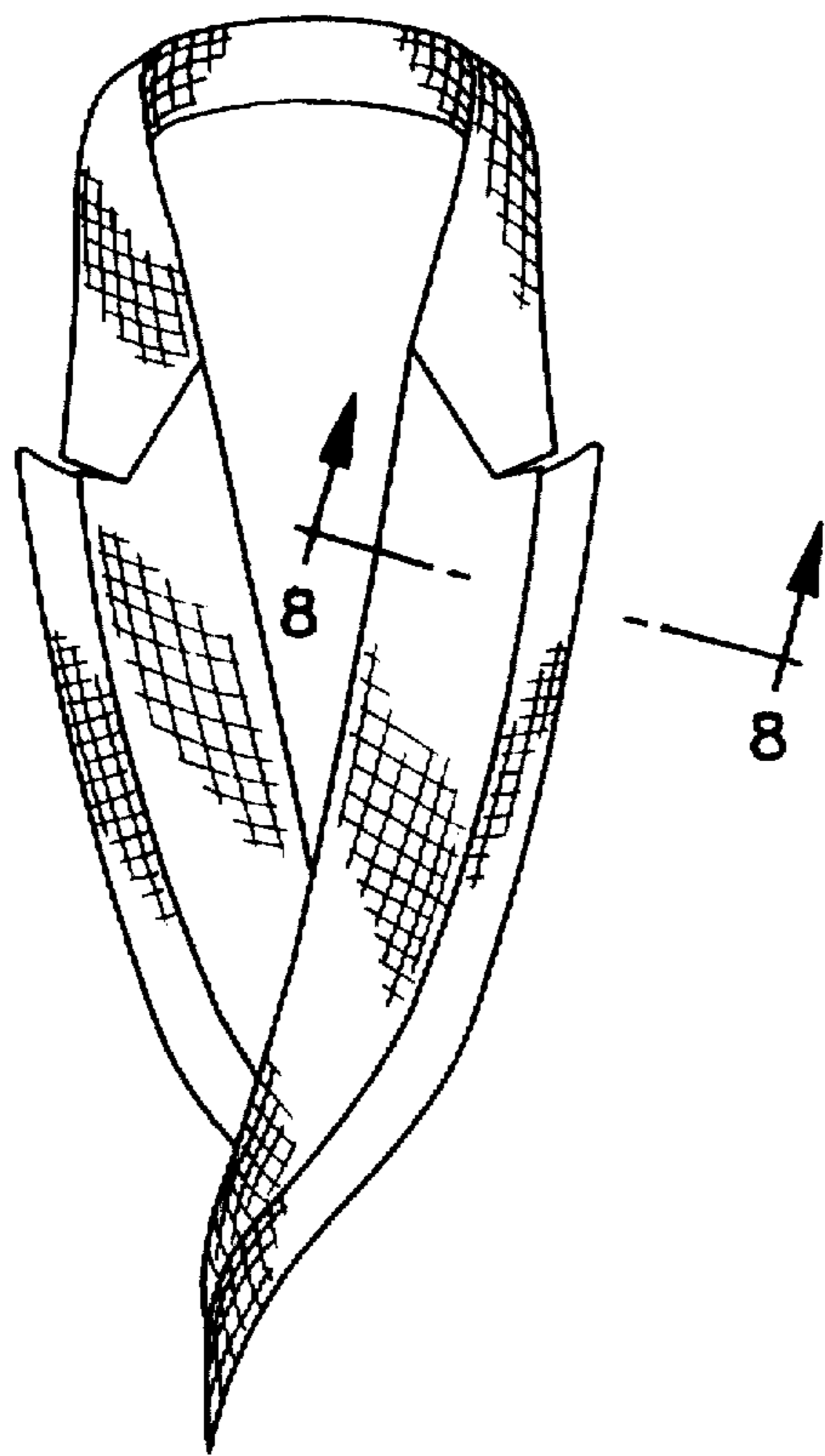

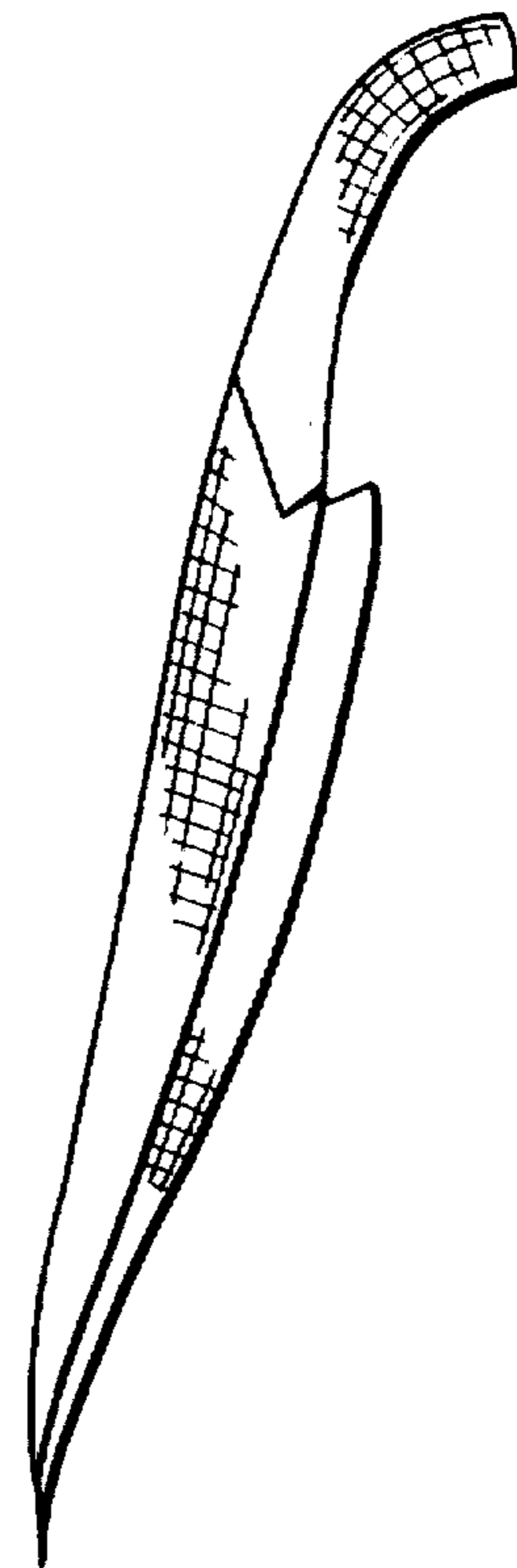

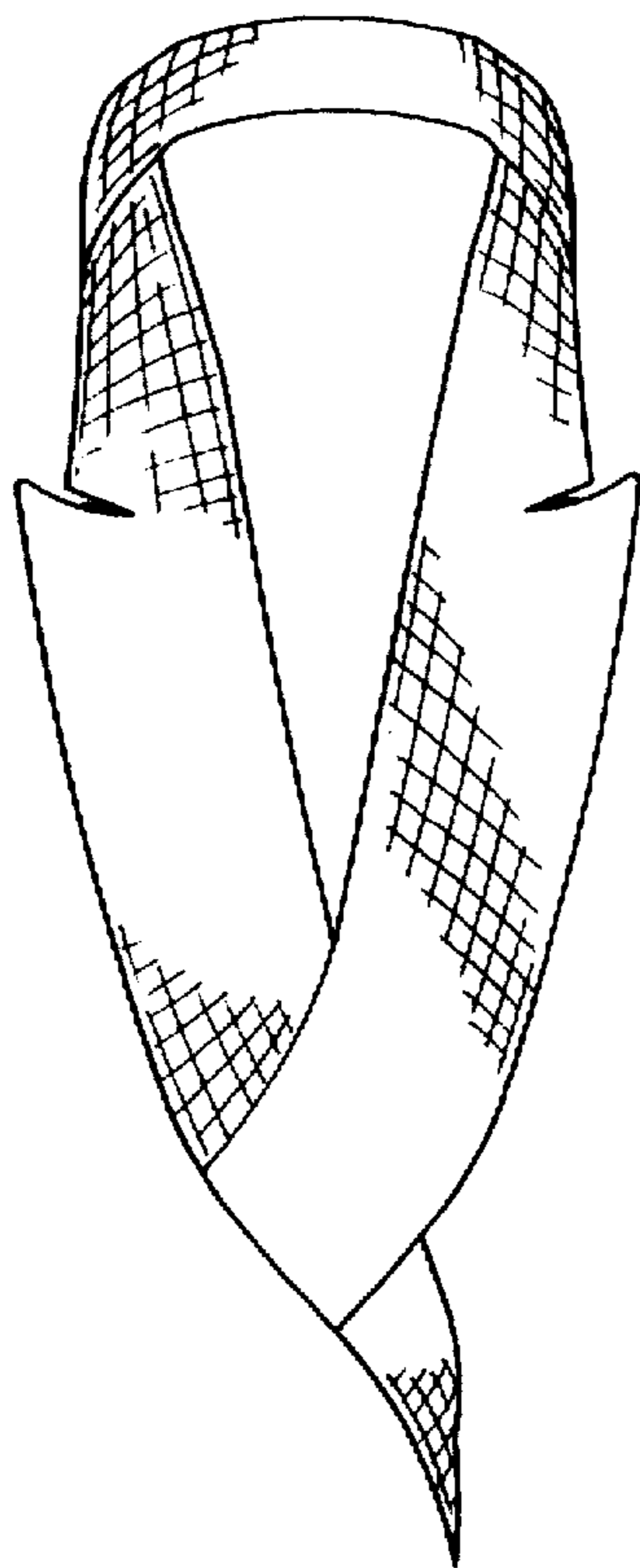

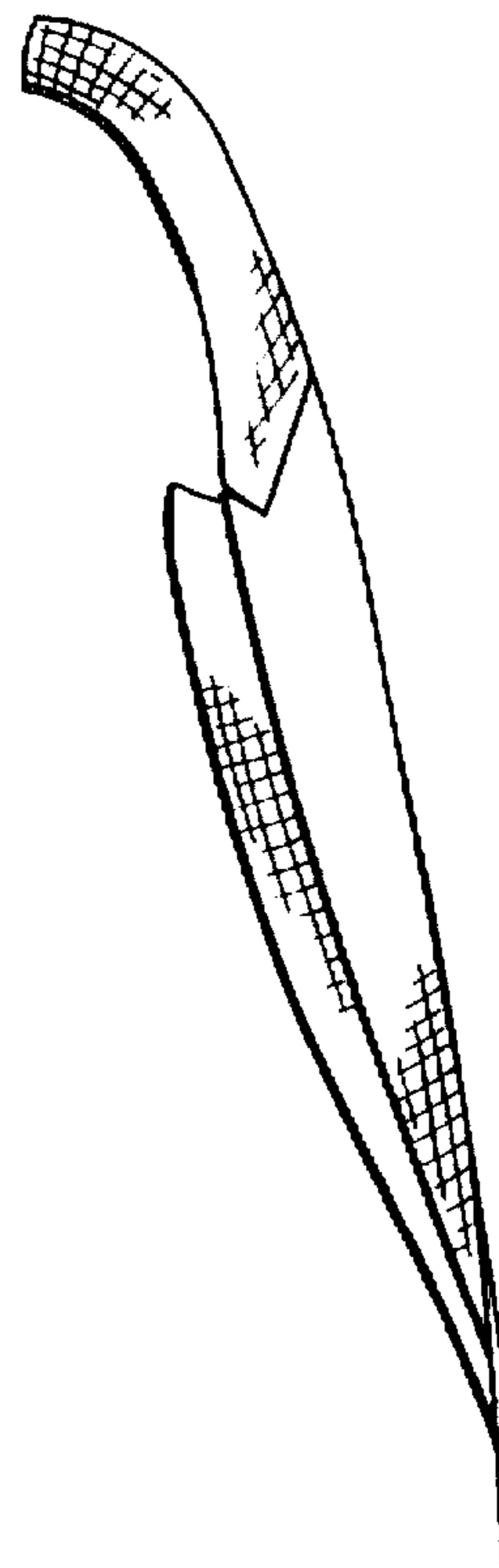

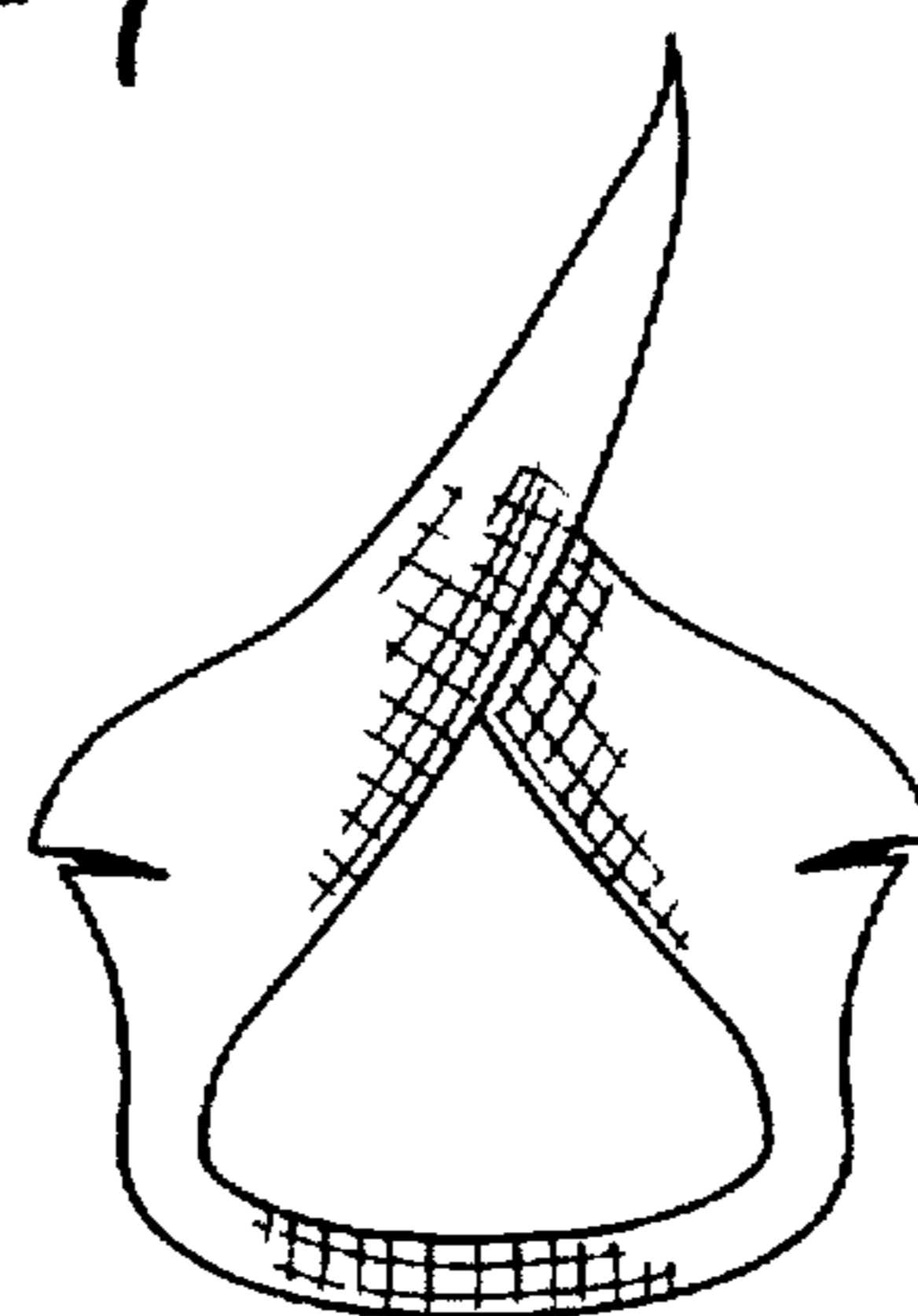
