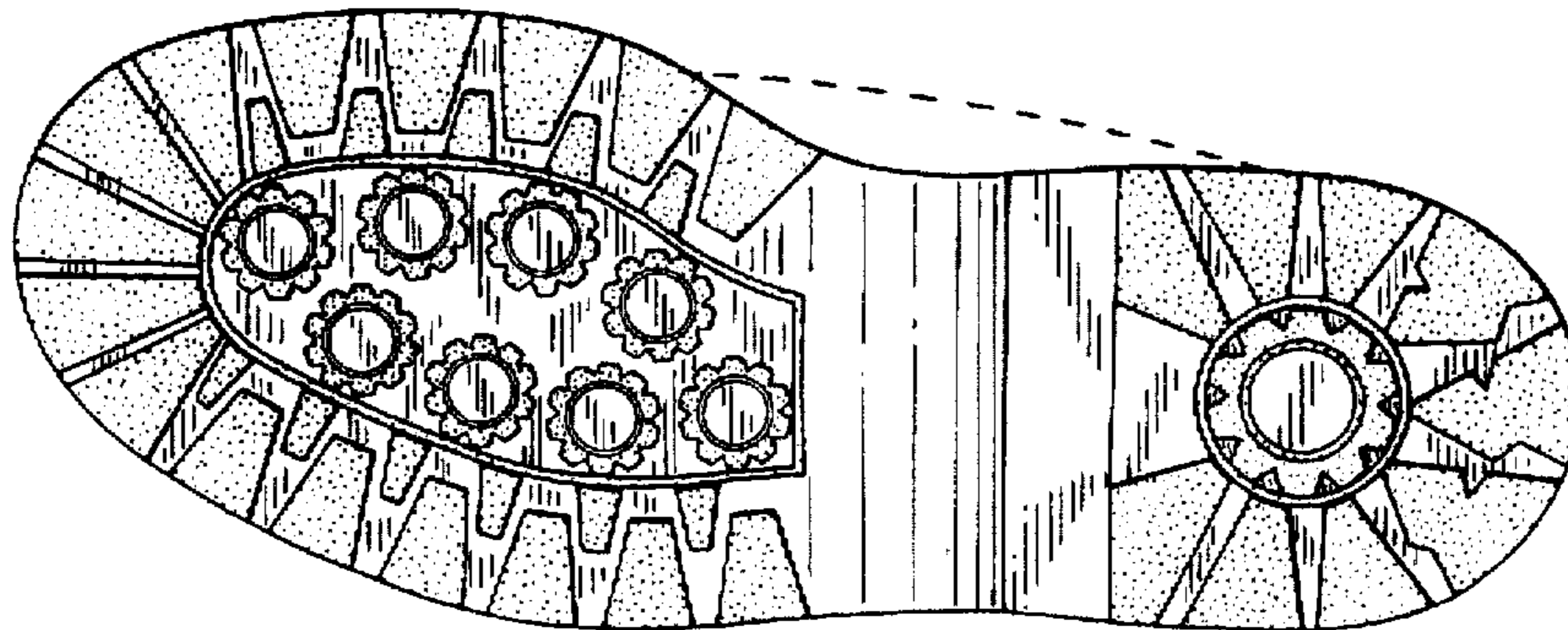
The ornamental design for a footwear sole, as shown and described.

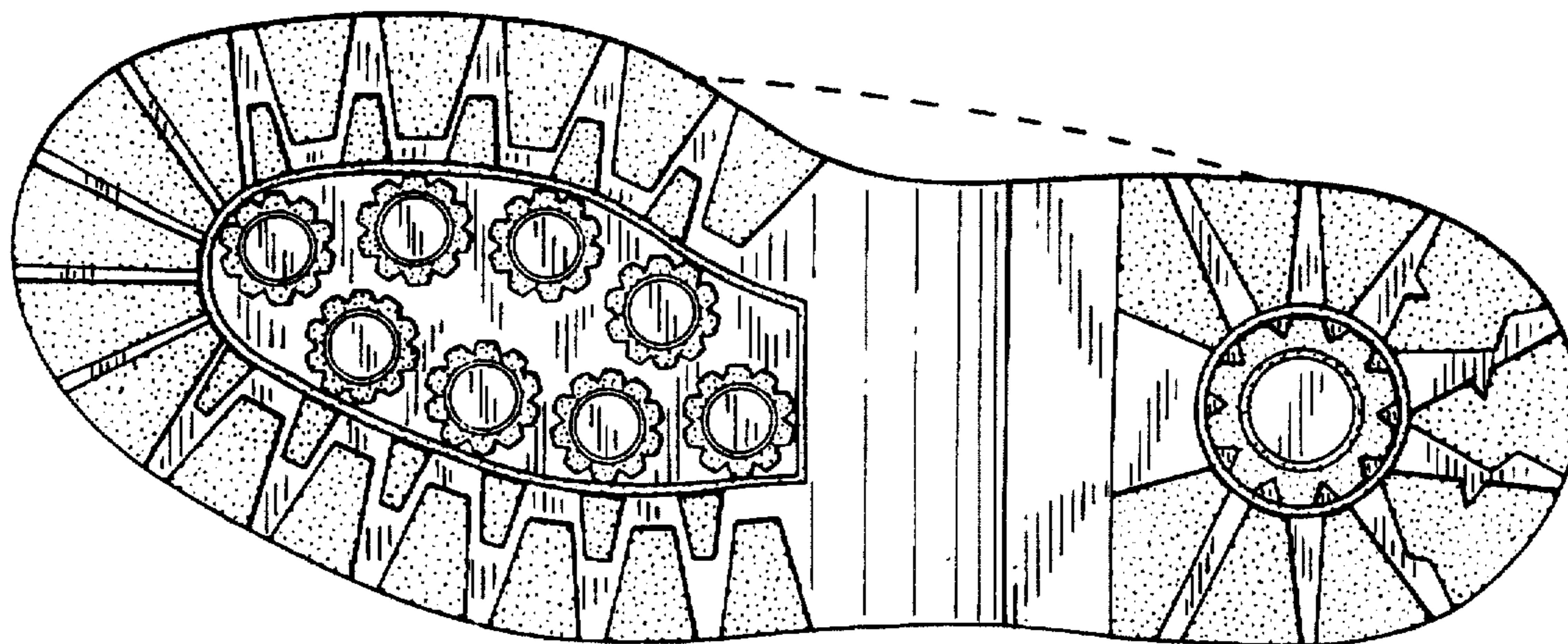

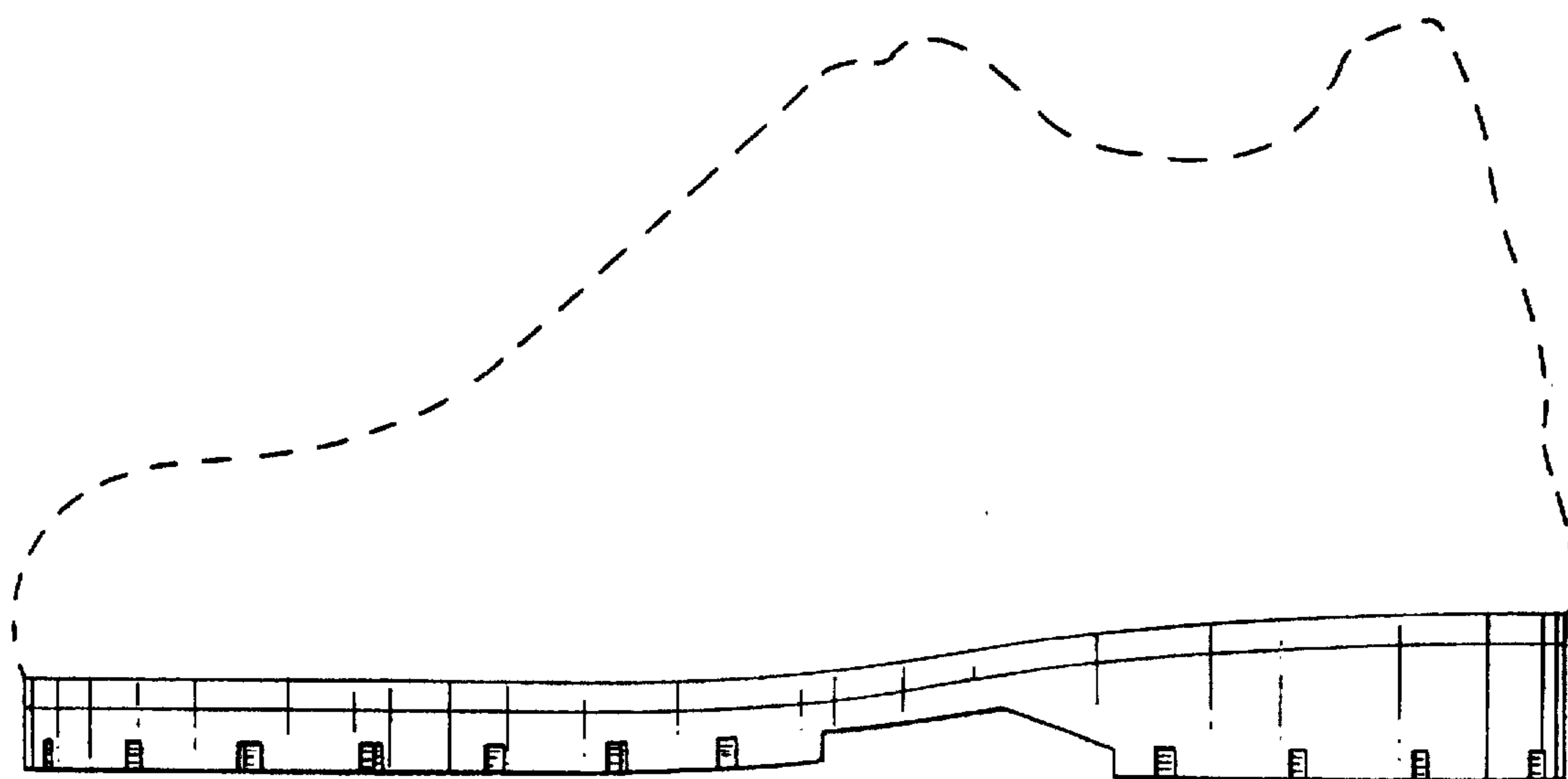

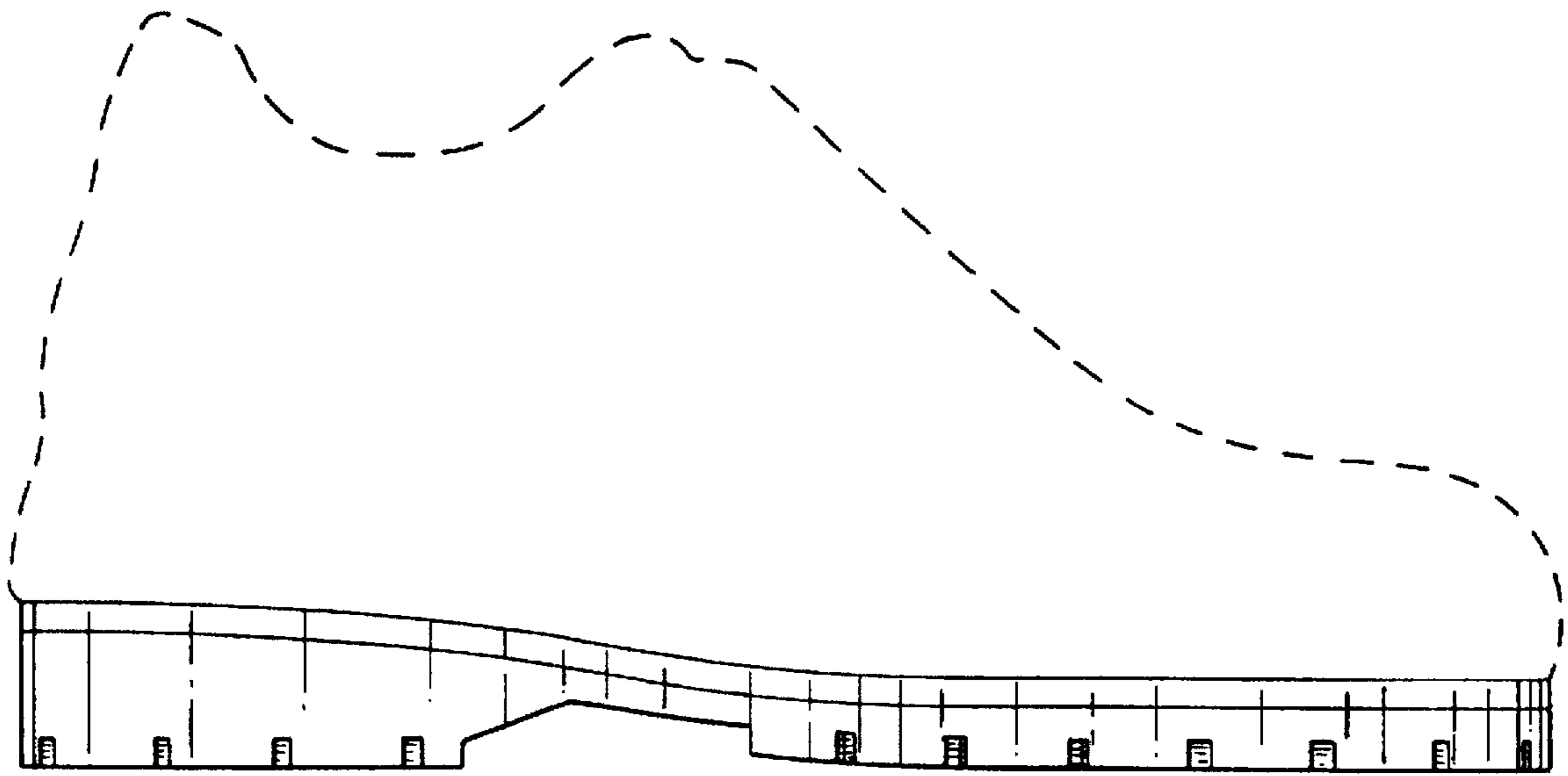

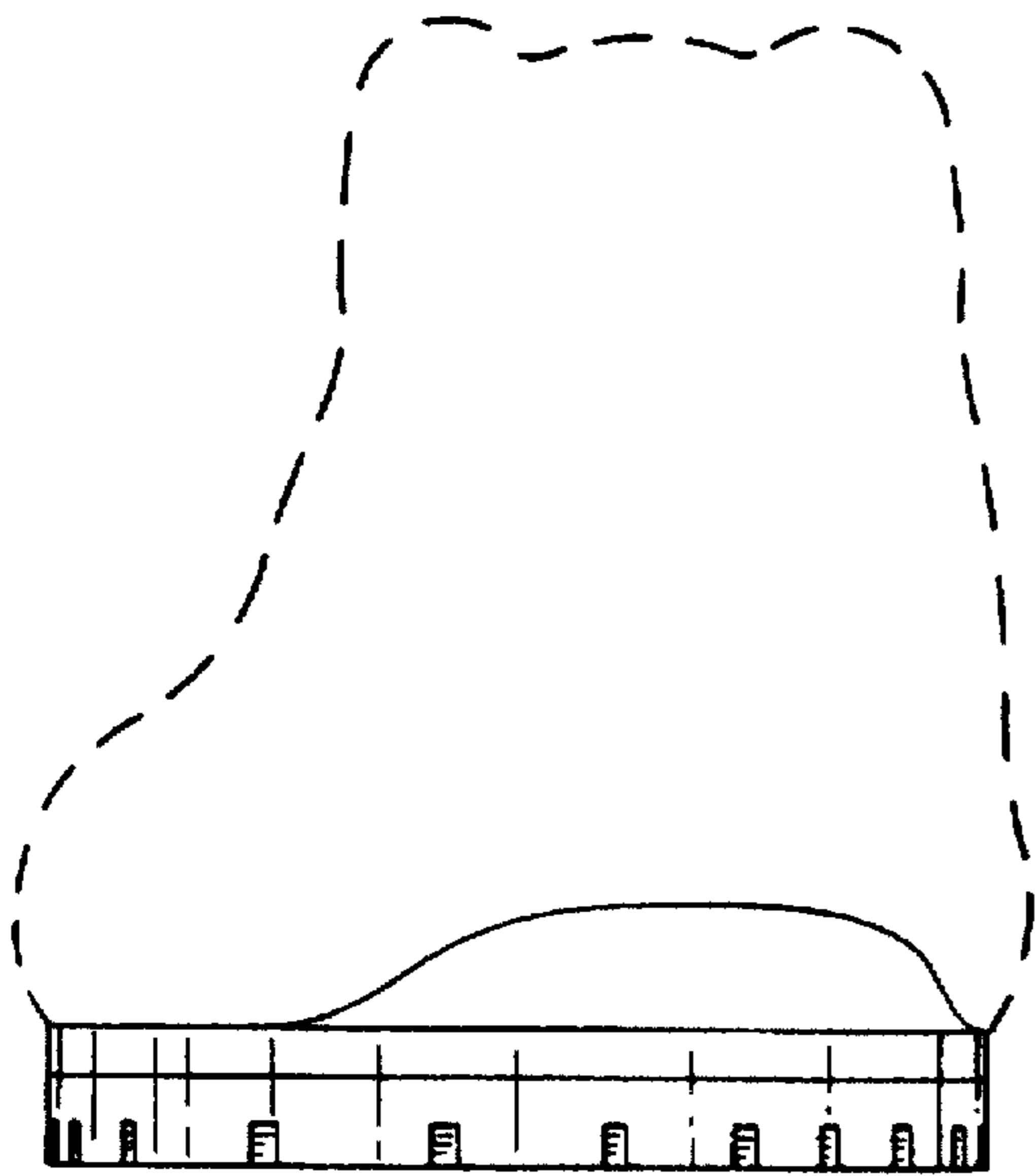

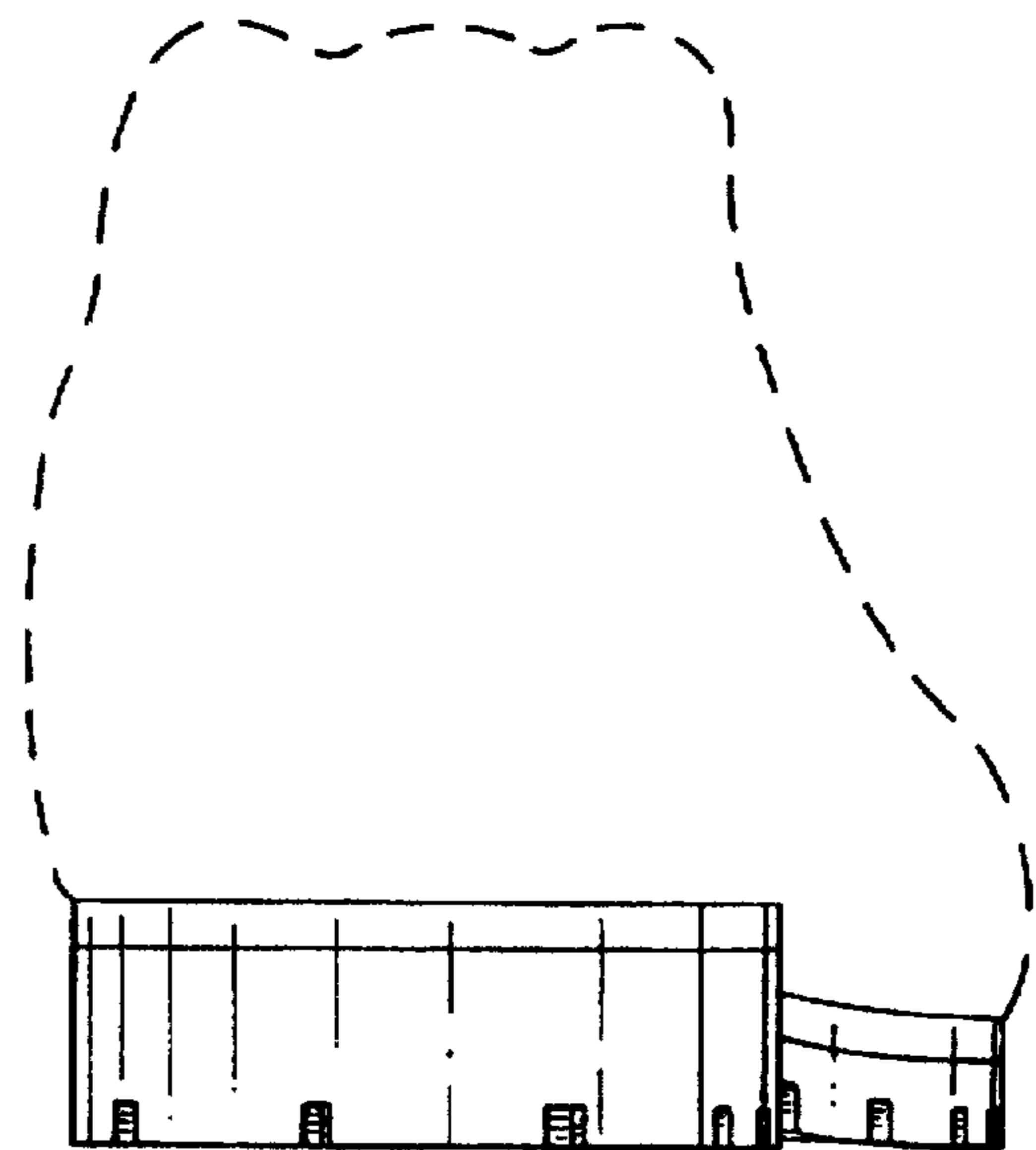

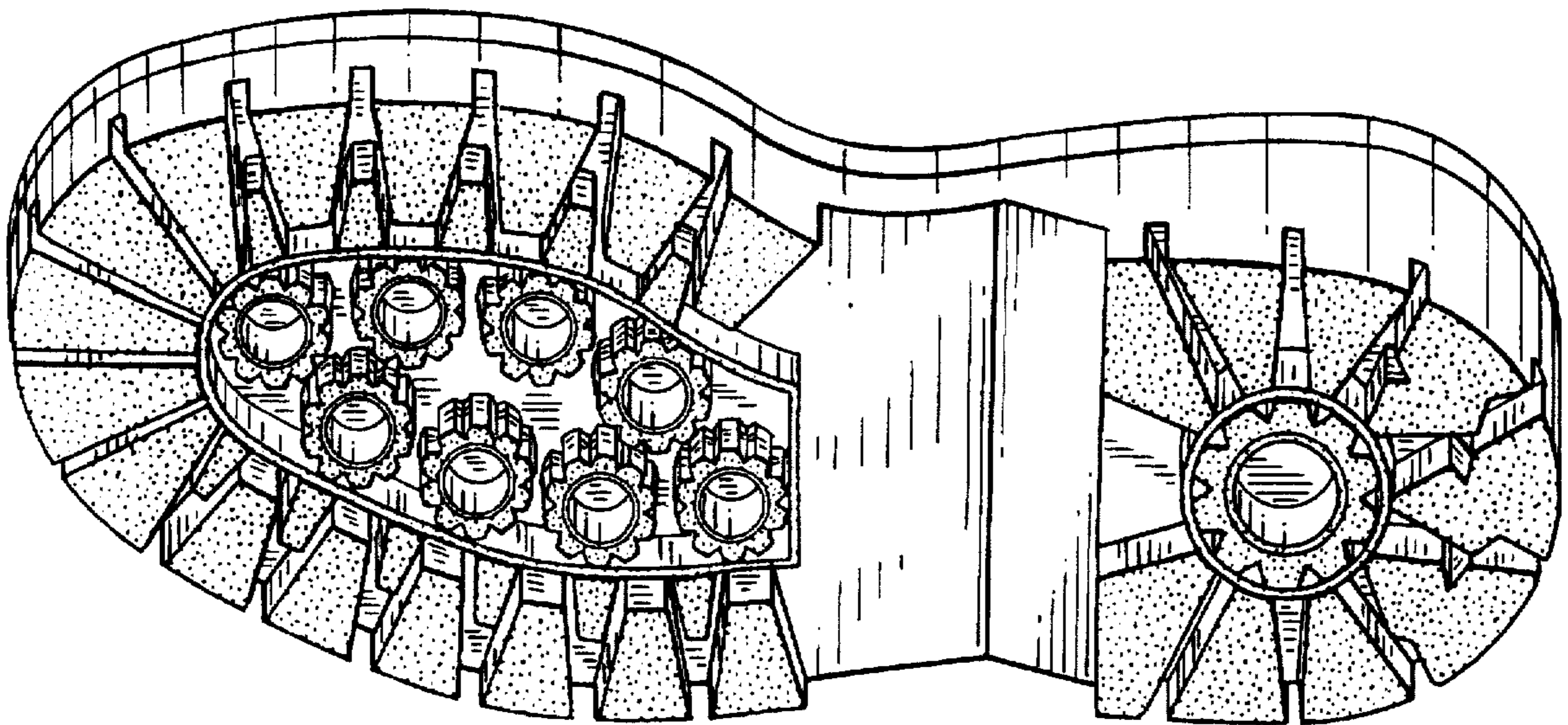
