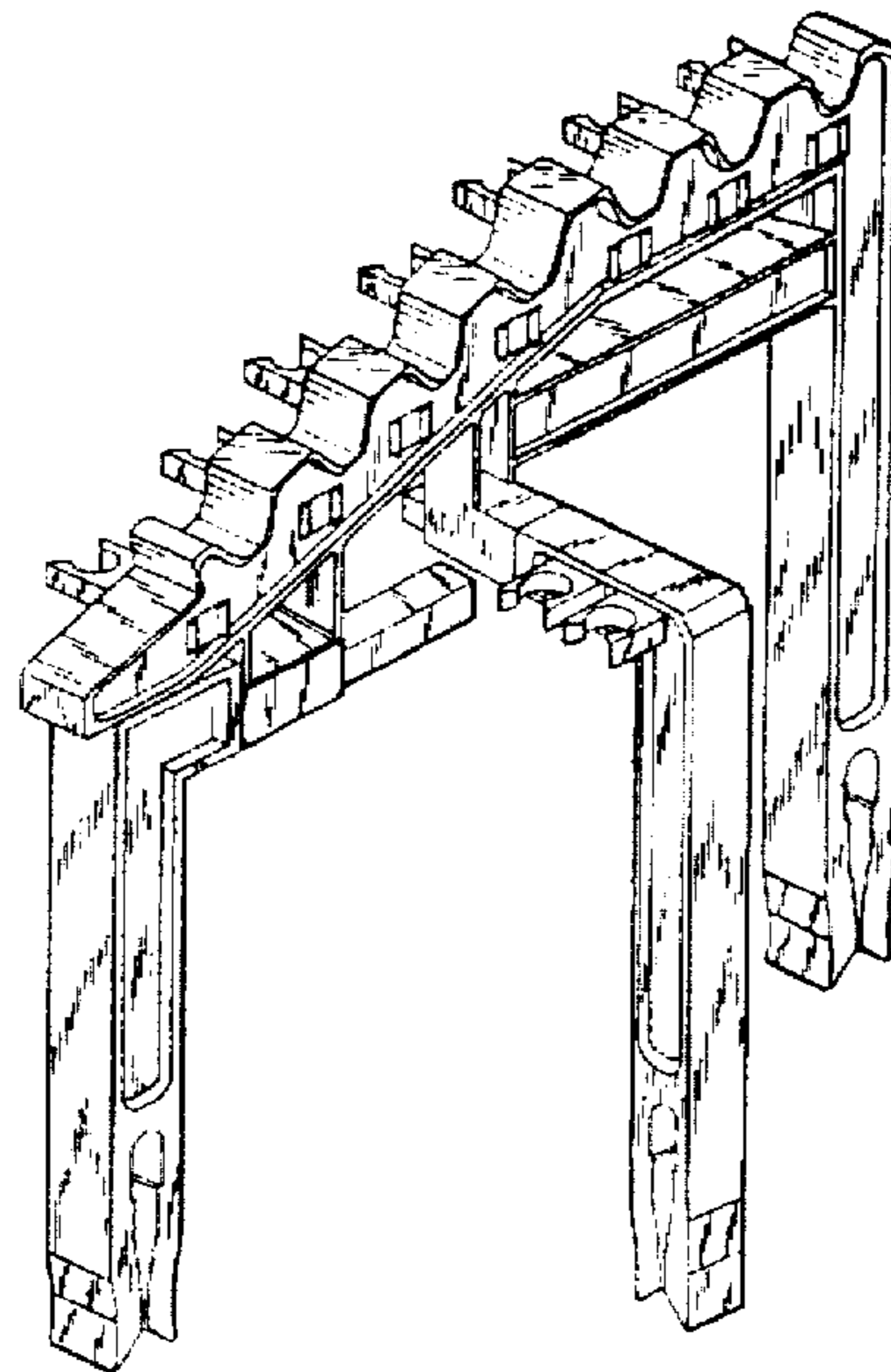
## [57] CLAIM

## DESCRIPTION

FIG. 1 is a top plan view of a golf clubs holder showing our new design;  
 FIG. 2 is a bottom plan view thereof;  
 FIG. 3 is a left side elevational view thereof;  
 FIG. 4 is a right side elevational view thereof;  
 FIG. 5 is a front elevational view thereof;  
 FIG. 6 is a rear elevational view thereof;  
 FIG. 7 is a perspective view thereof;  
 FIG. 8 is an exploded perspective view thereof; and,  
 FIG. 9 is a perspective view thereof; shown in use; the broken line showing of a golf bag and golf clubs is for illustrative purpose only and forms no part of the claim.

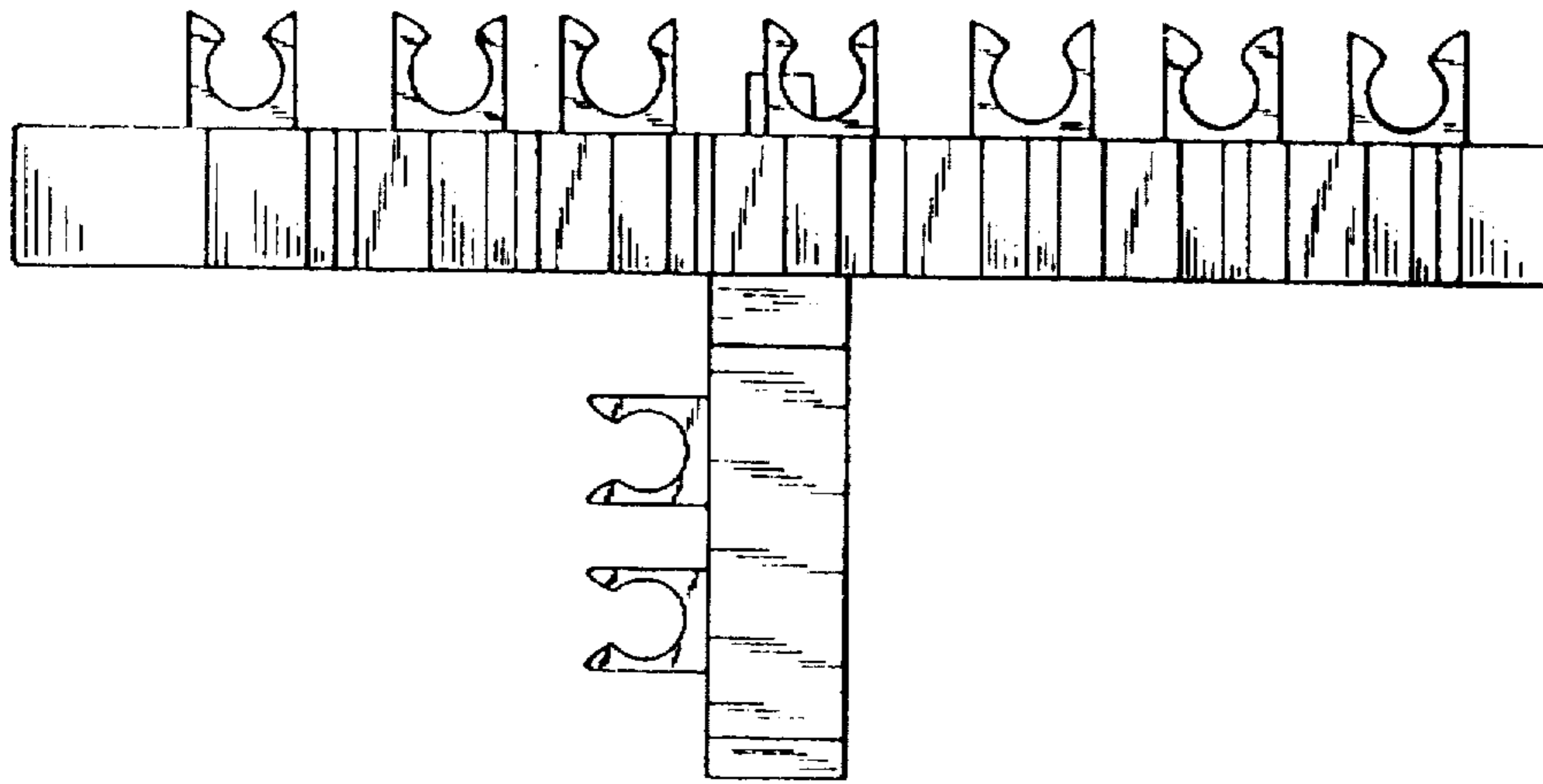

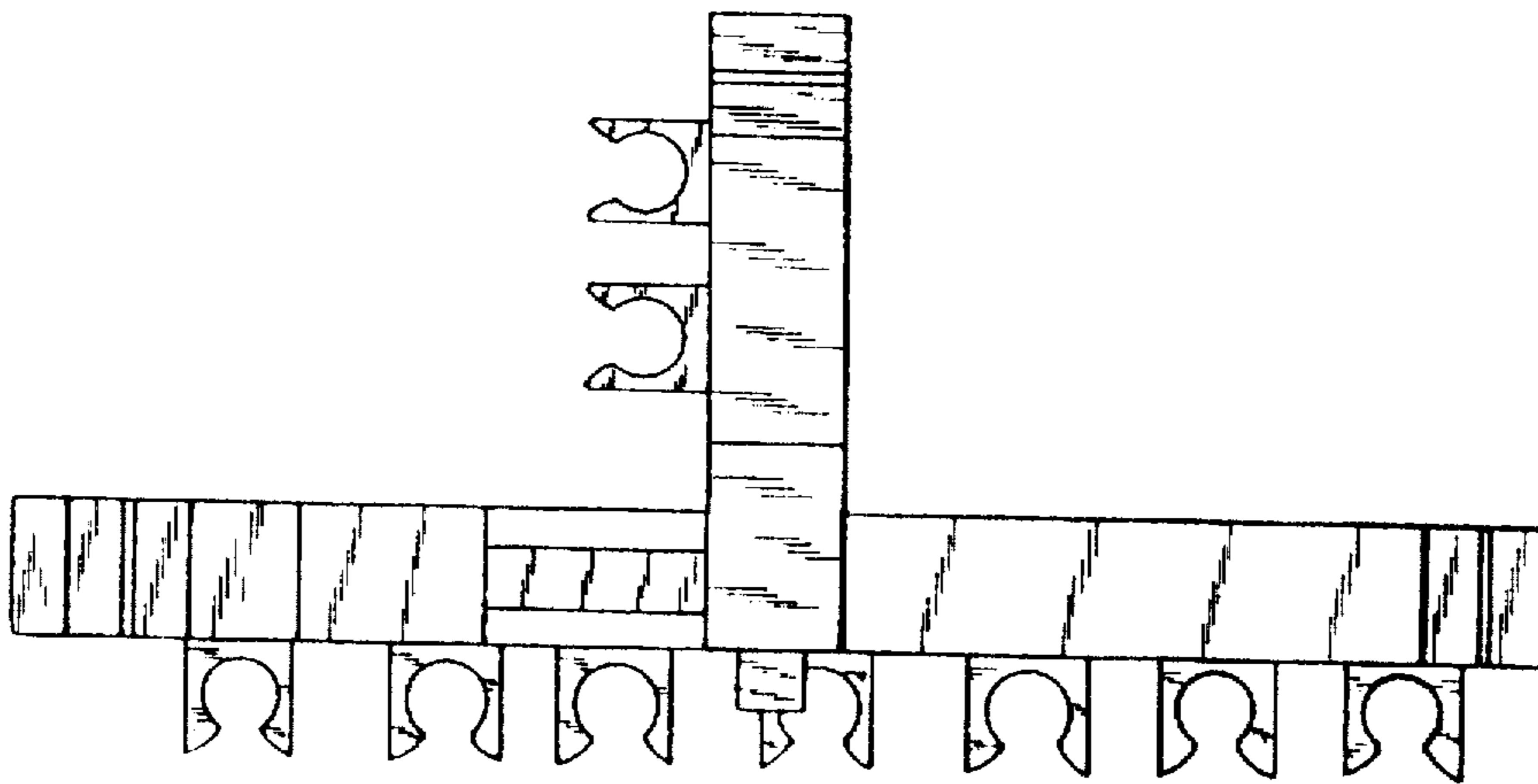

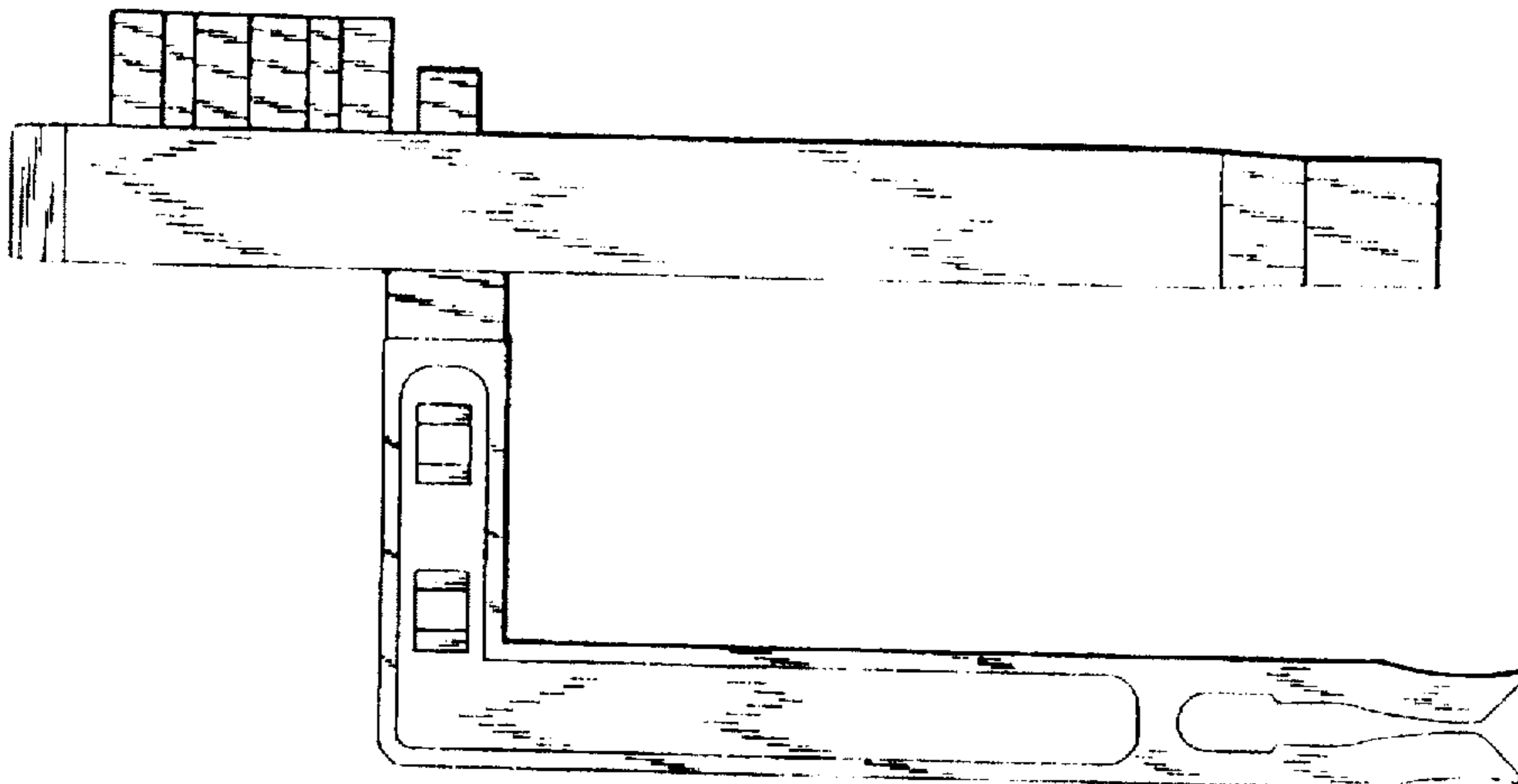

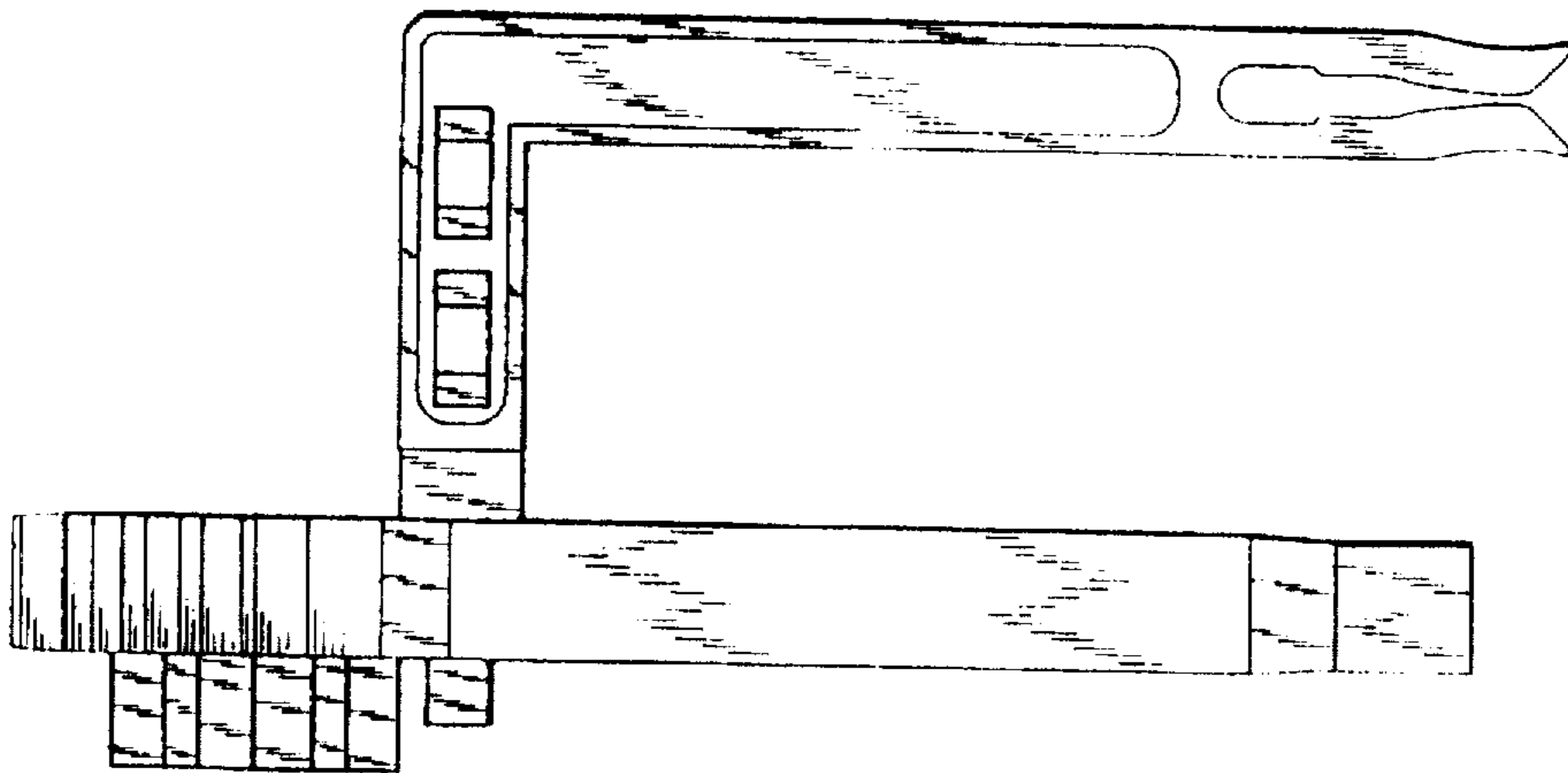

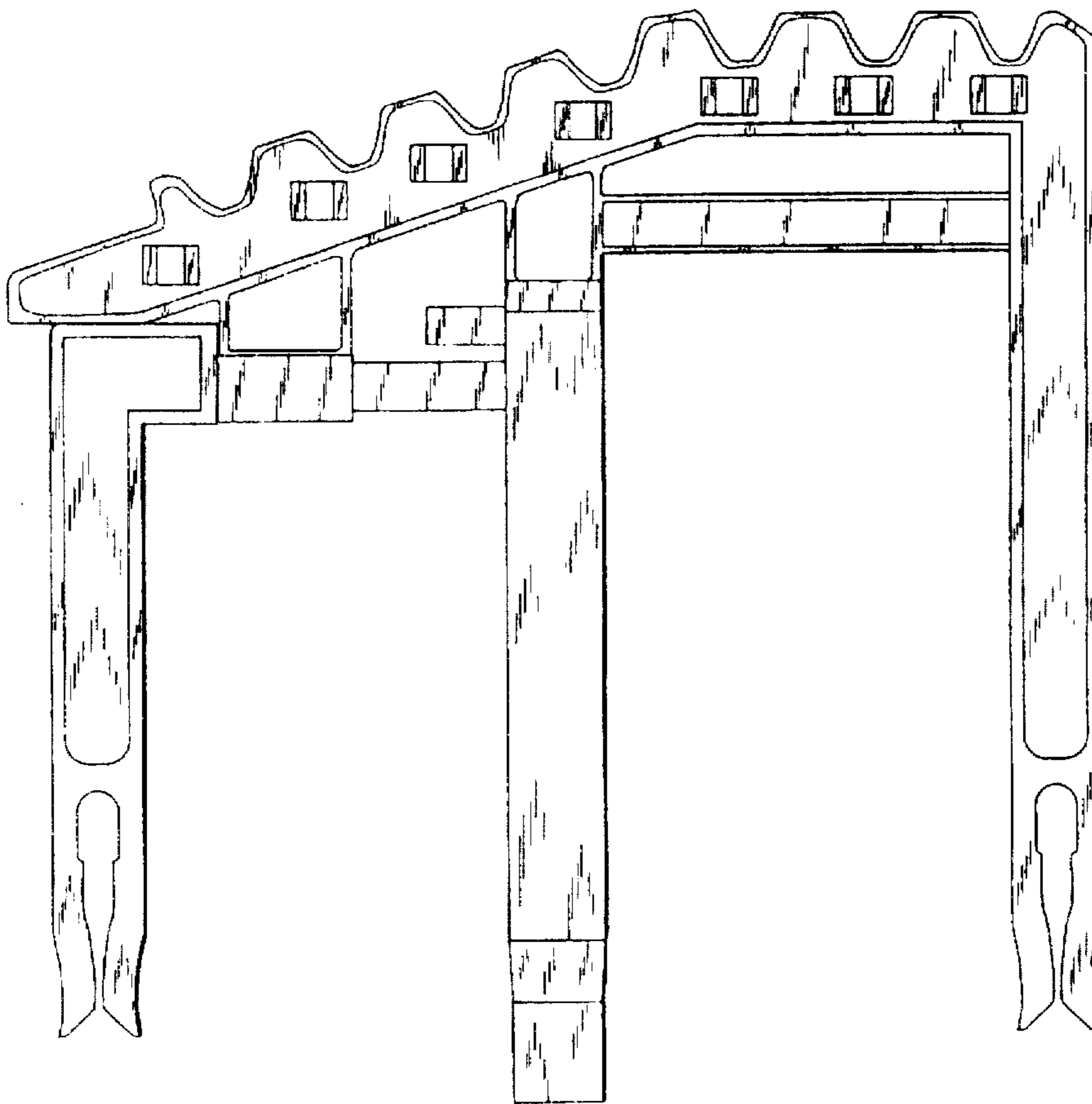

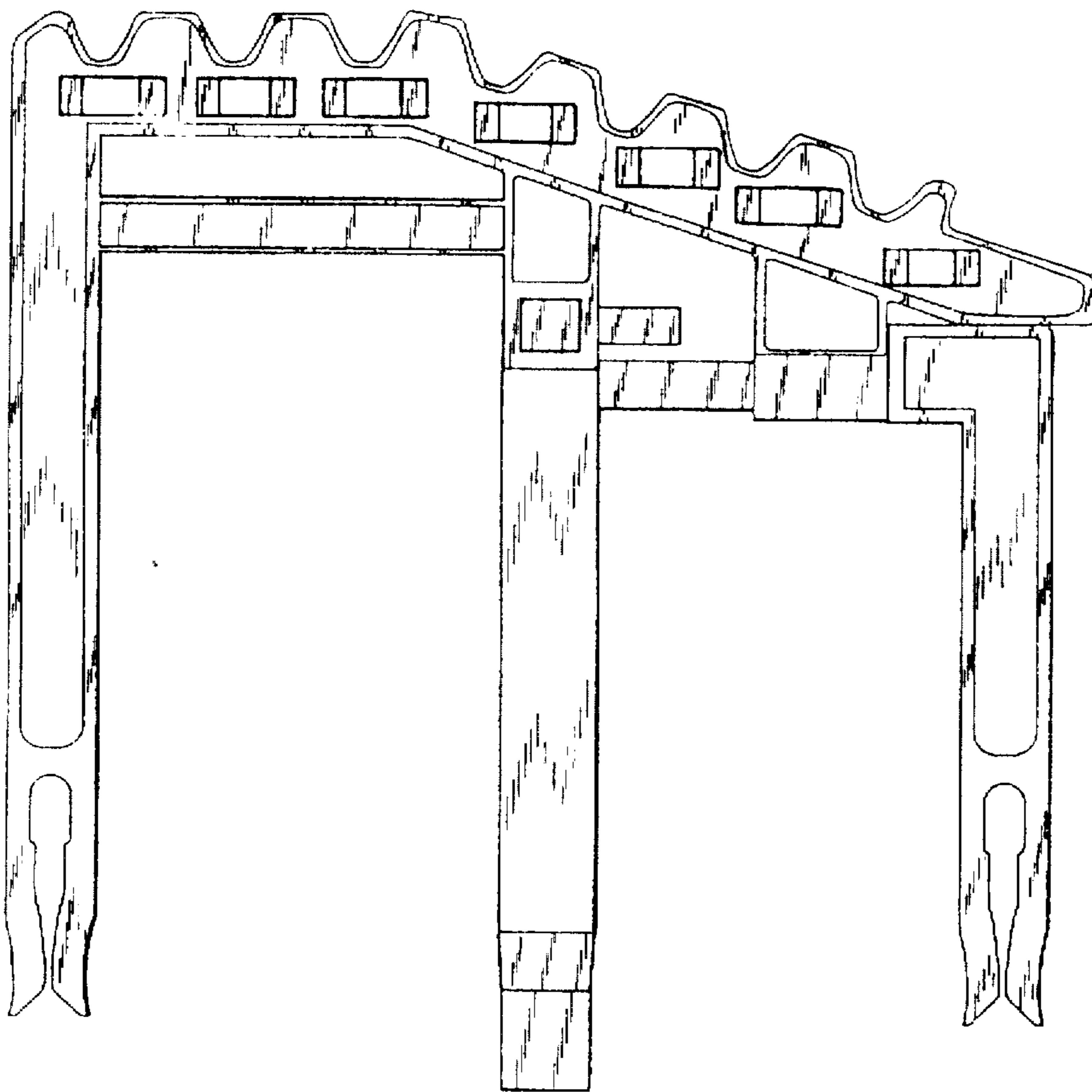

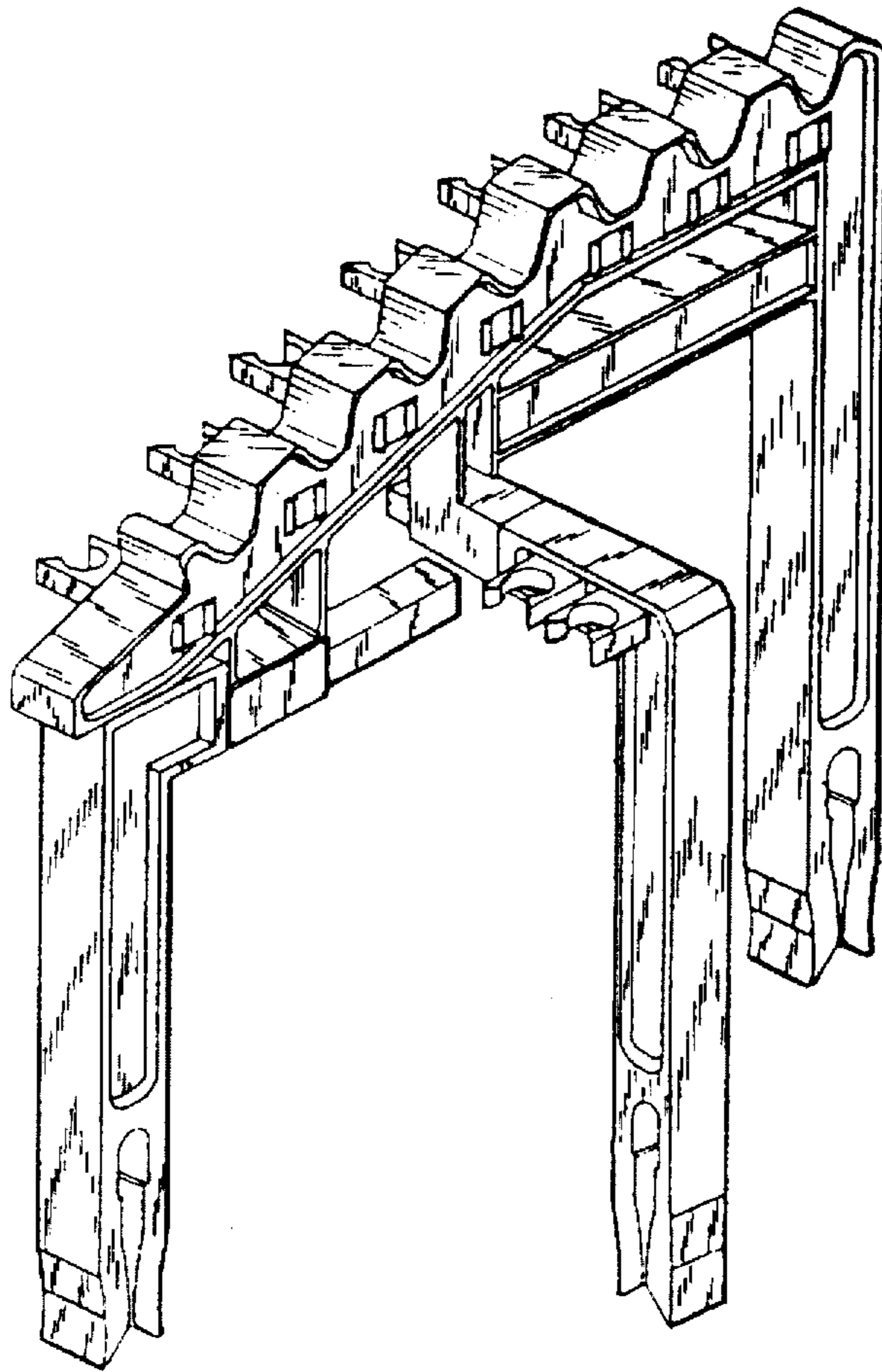

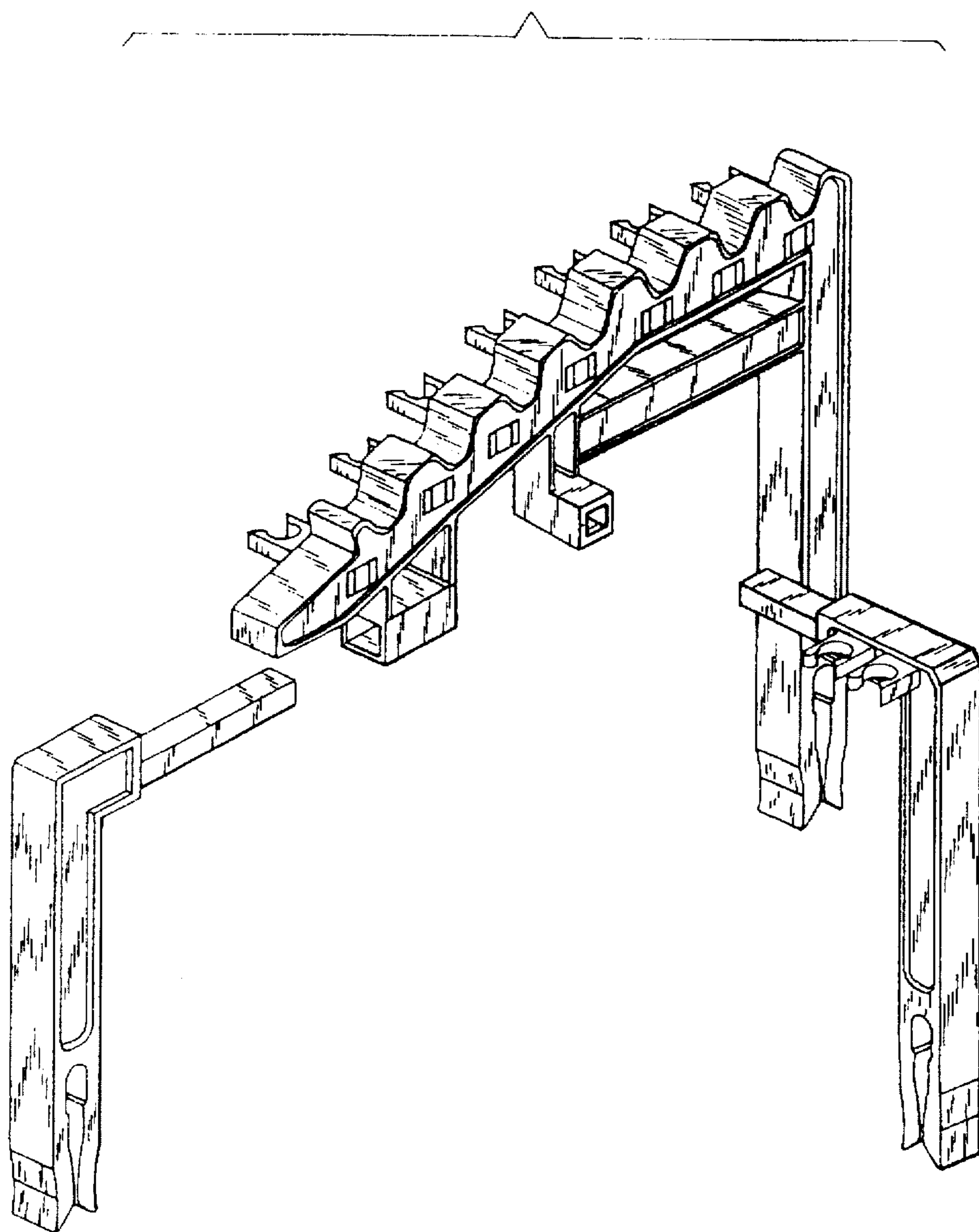

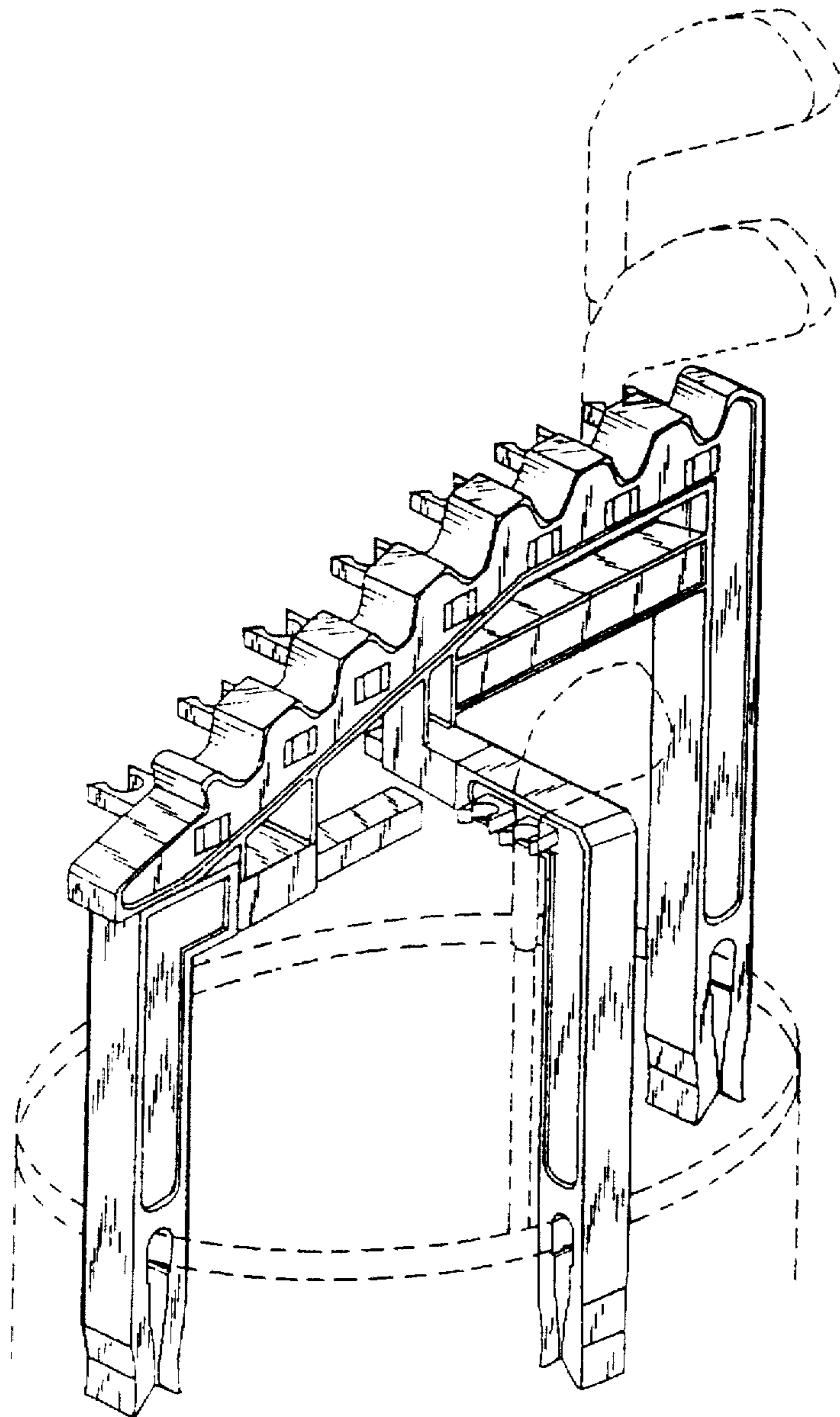
