view being a mirror image thereof;

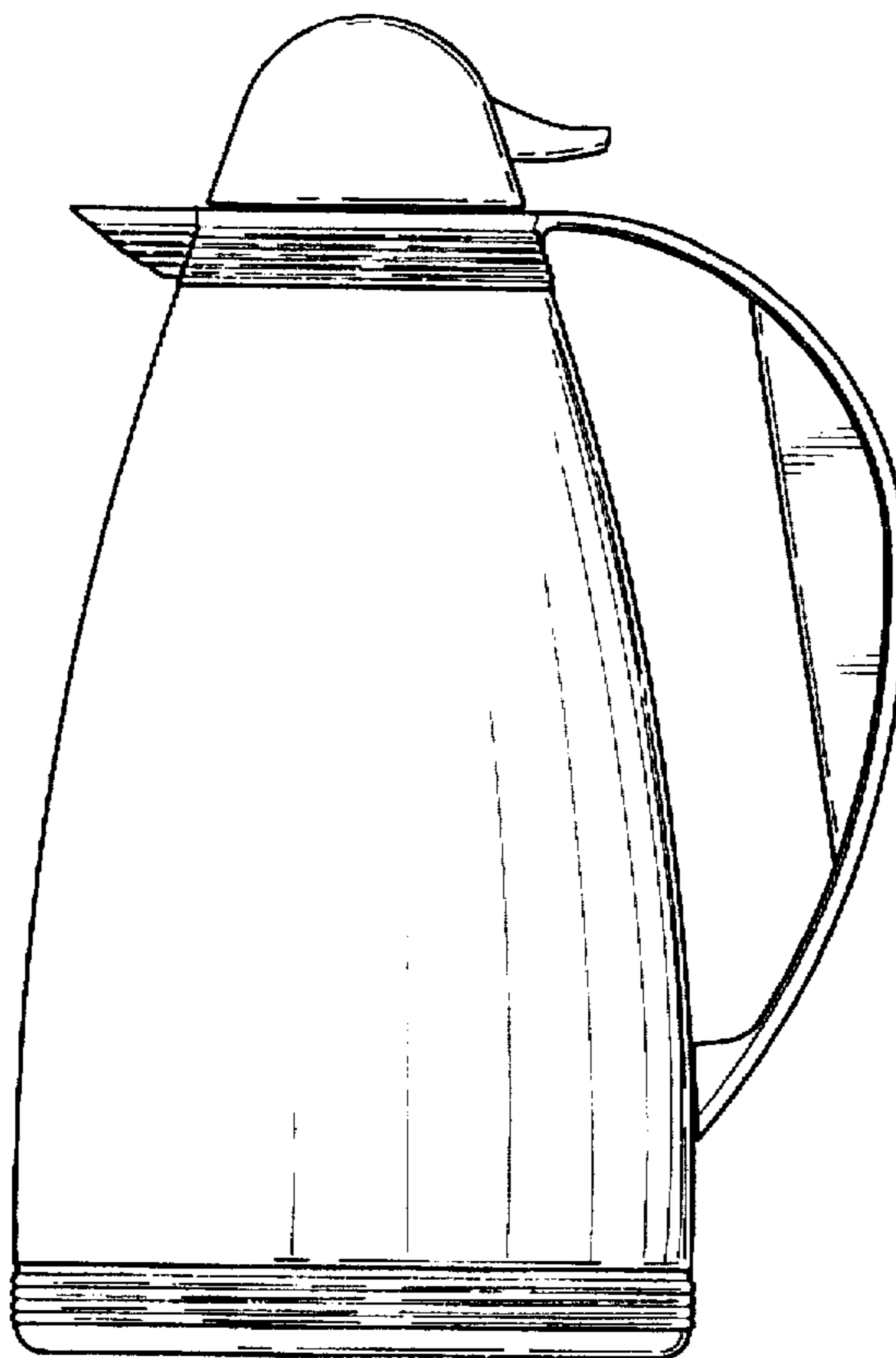
FIG. 3 is a left side elevational view thereof;

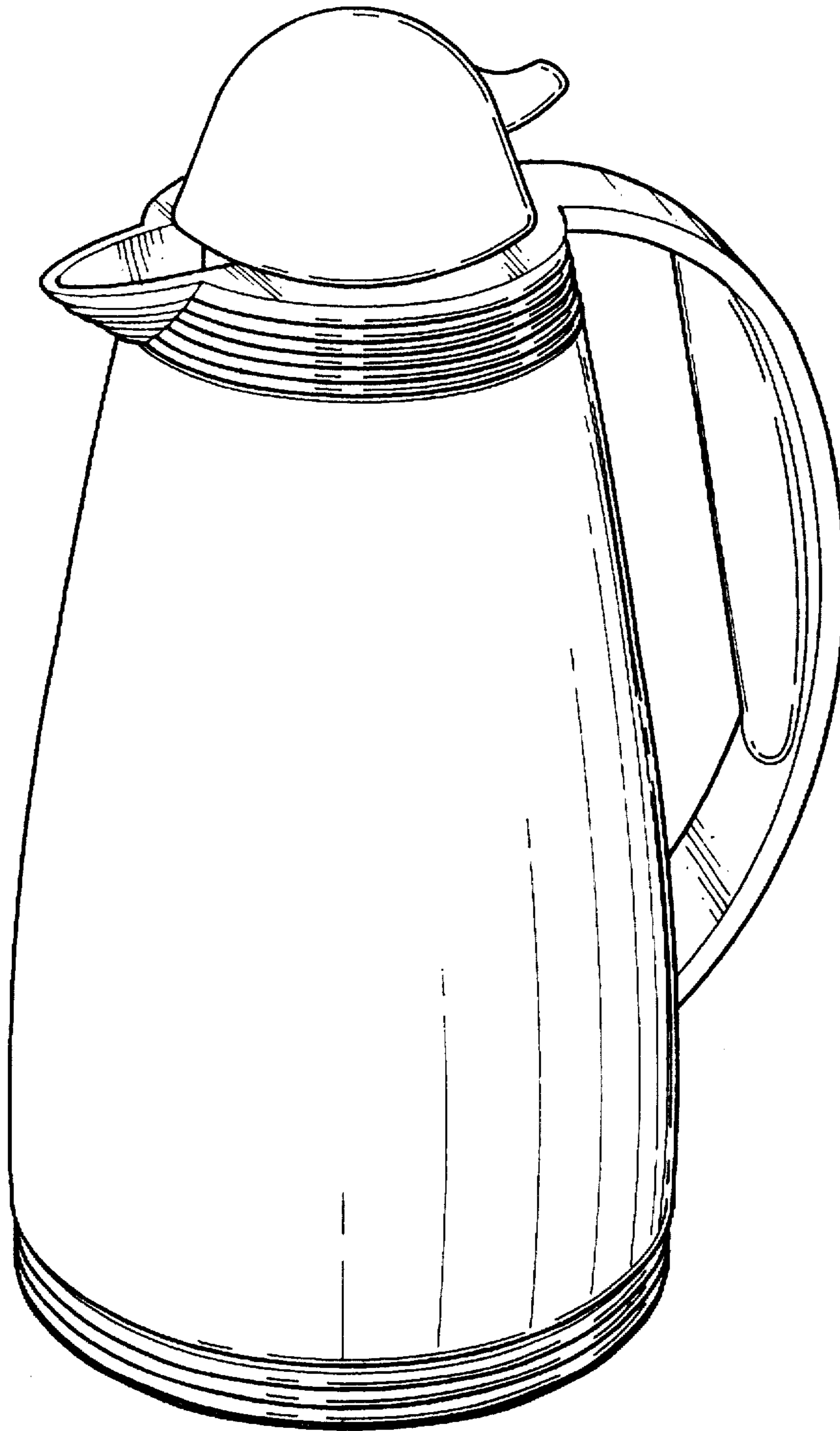

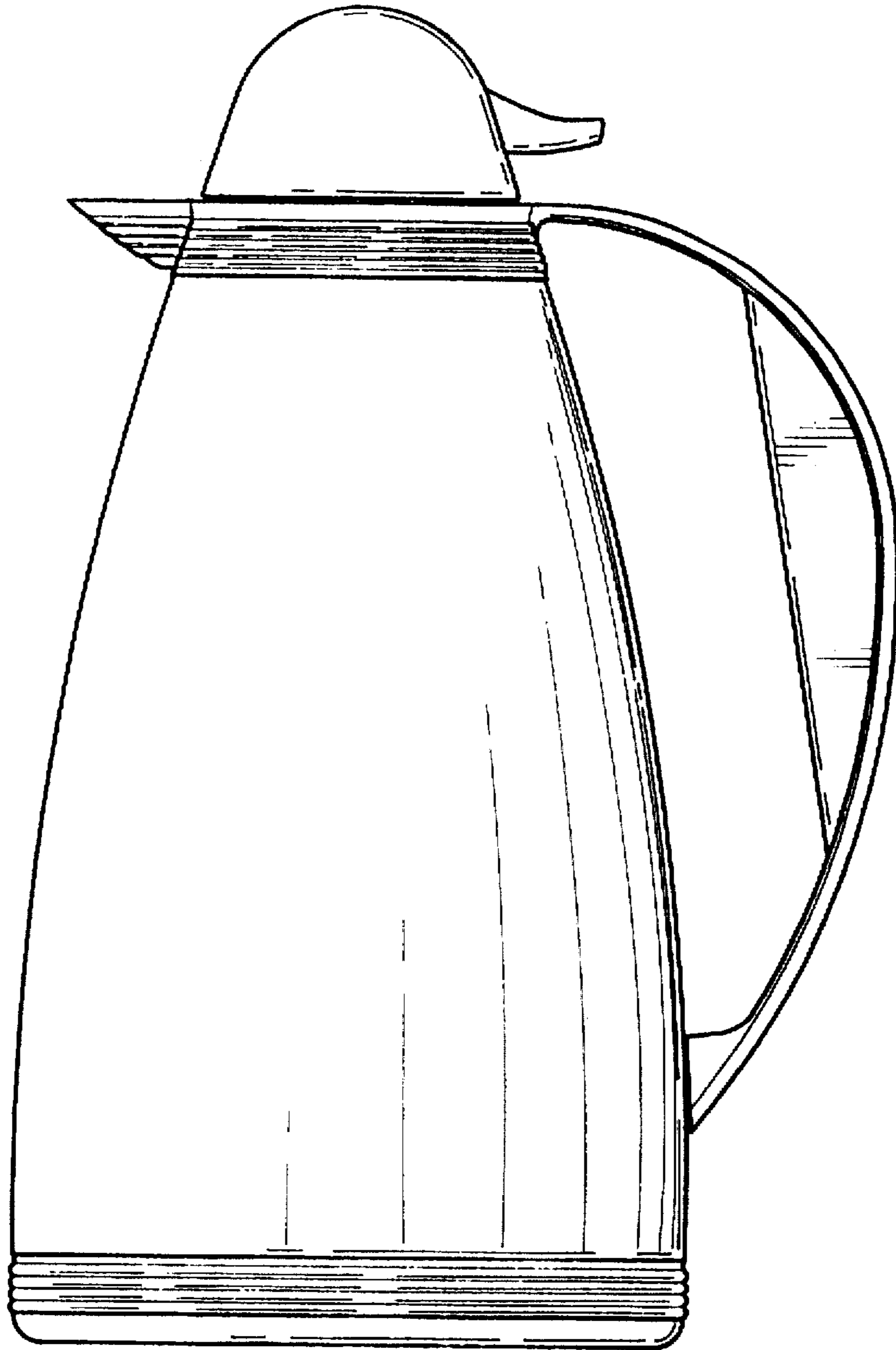

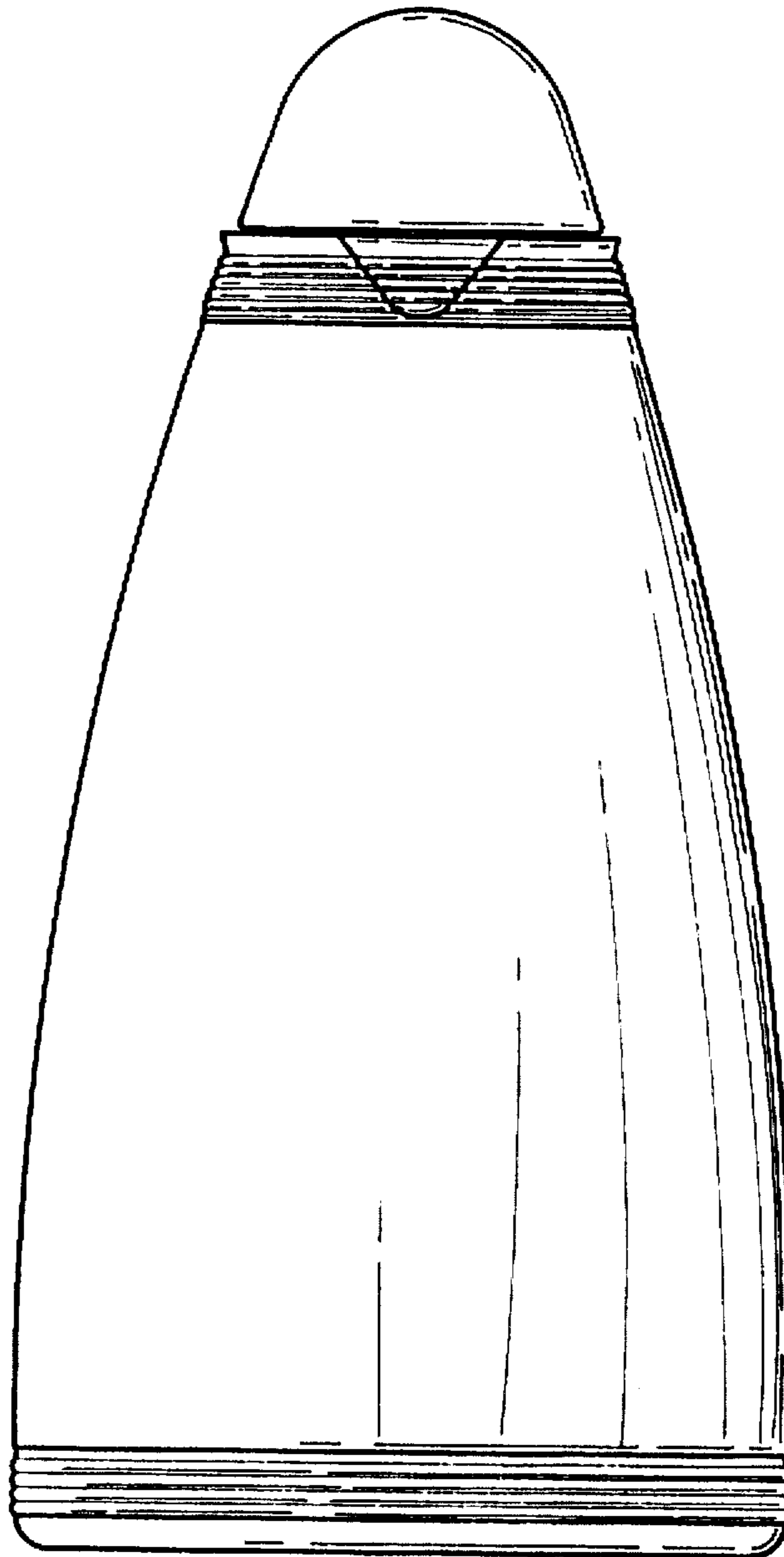

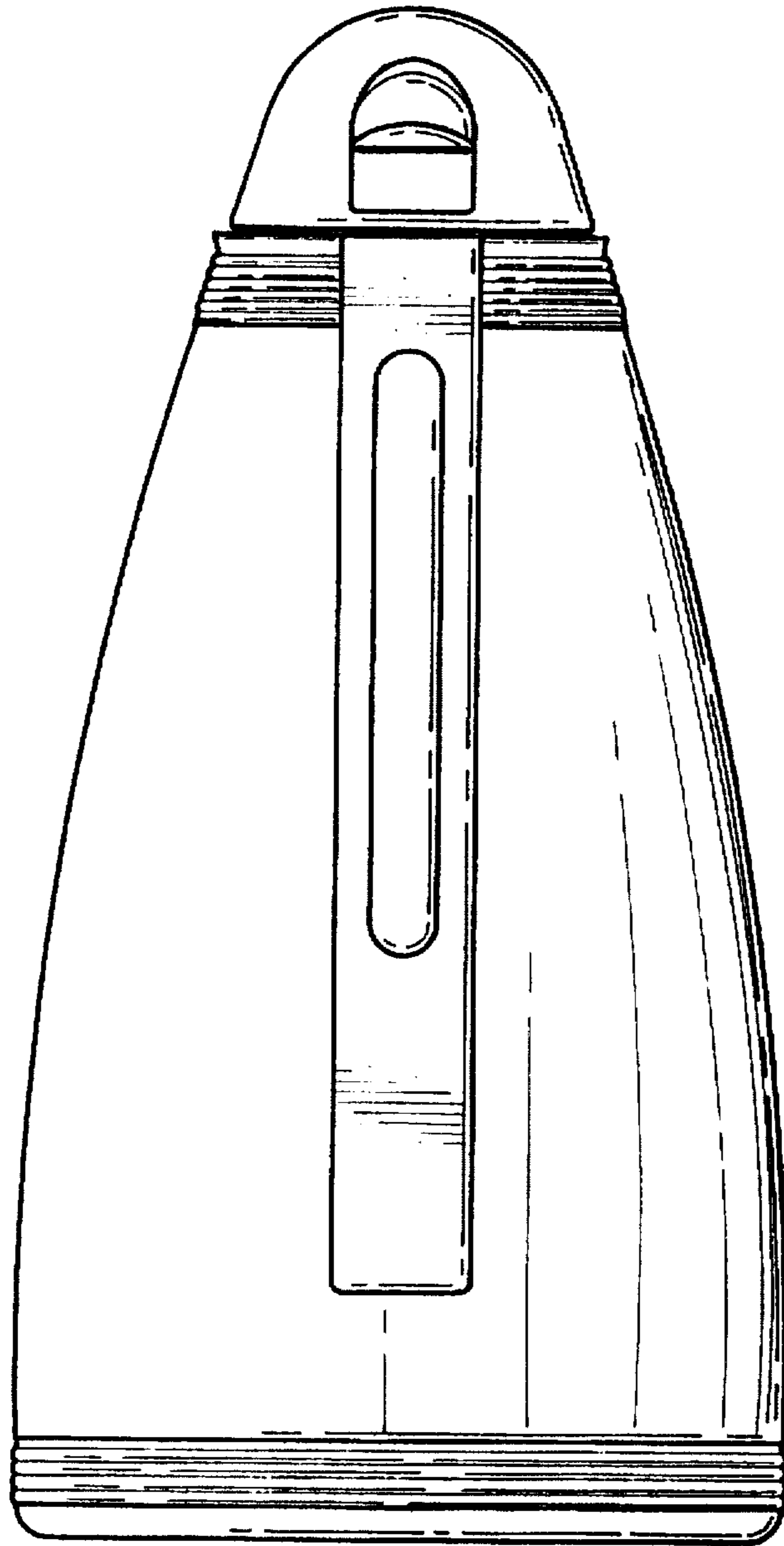

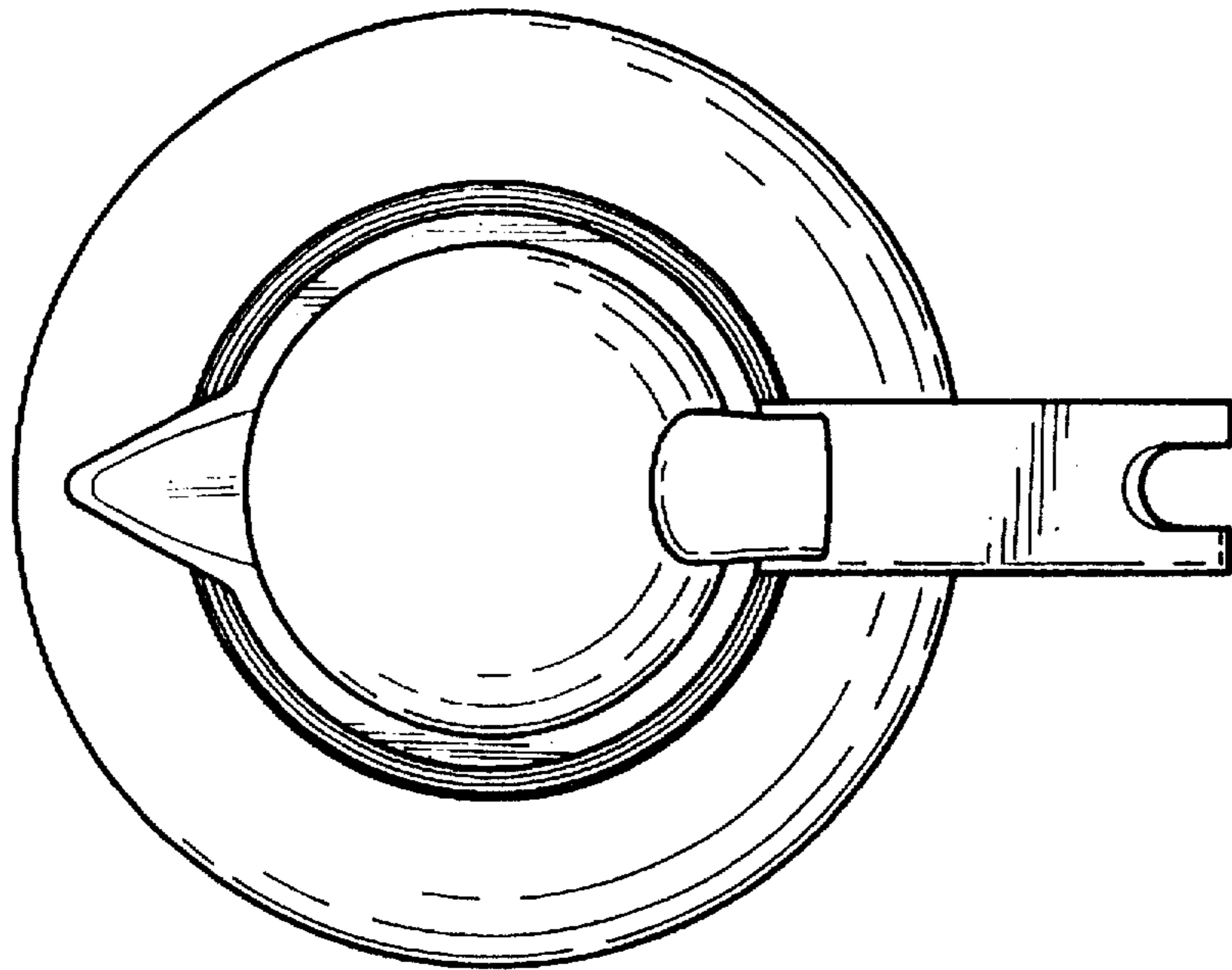

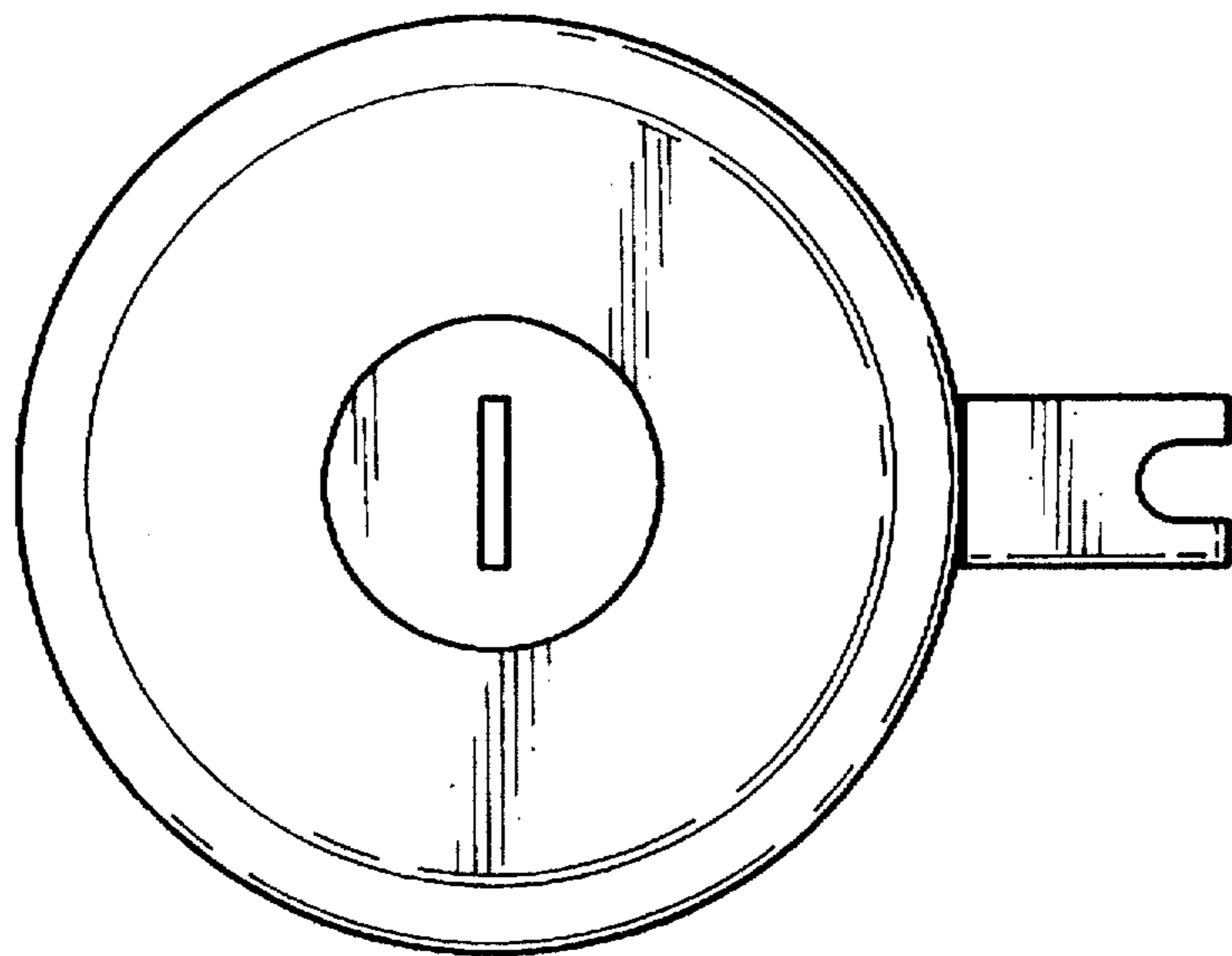
