[57] **CLAIM**

The ornamental design for a ganged cable clip, as shown and described.

DESCRIPTION

FIG. 1 shows a perspective view of the ganged cable clip of one embodiment of the present invention;
FIG. 2 is shows a front view of the ganged cable clip of FIG. 1;
FIG. 3 shows a back view of the ganged cable clip of FIG. 1;
FIG. 4 shows a top view of the ganged cable clip of FIG. 1;
FIG. 5 shows a bottom view of the ganged cable clip of FIG. 1;
FIG. 6 shows a side view of the ganged cable clip of FIG. 1, with the opposite side view being identical;
FIG. 7 shows a perspective view of the ganged cable clip of a second embodiment of the present invention;
FIG. 8 shows a front view of the ganged cable clip of FIG. 7;
FIG. 9 shows a back view of the ganged cable clip of FIG. 7;
FIG. 10 shows a top view of the ganged cable clip of FIG. 7;
FIG. 11 shows a bottom view of the ganged cable clip of FIG. 7; and,
FIG. 12 shows a side view of the ganged cable clip of FIG. 7, with the opposite side view being identical.

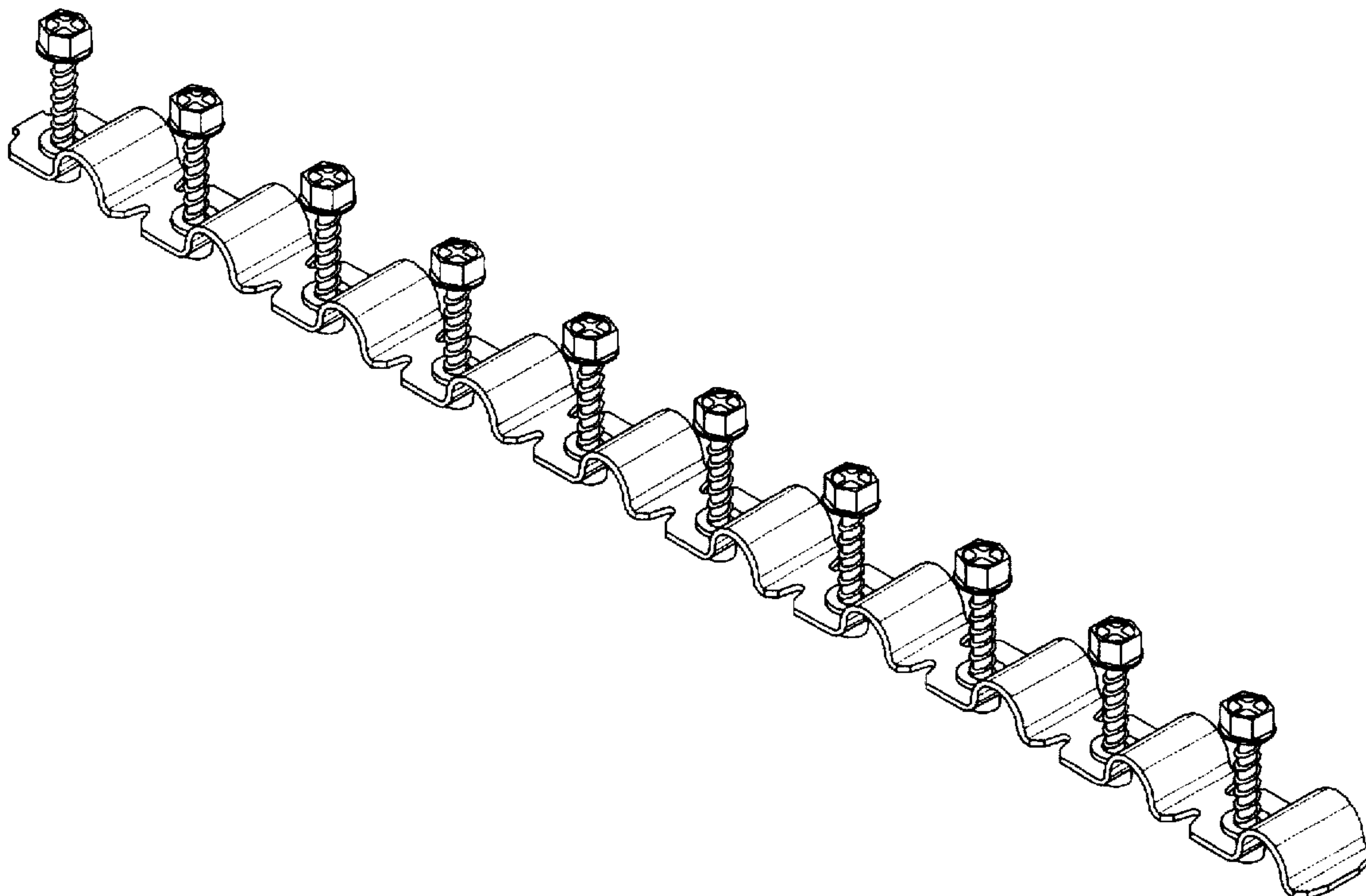

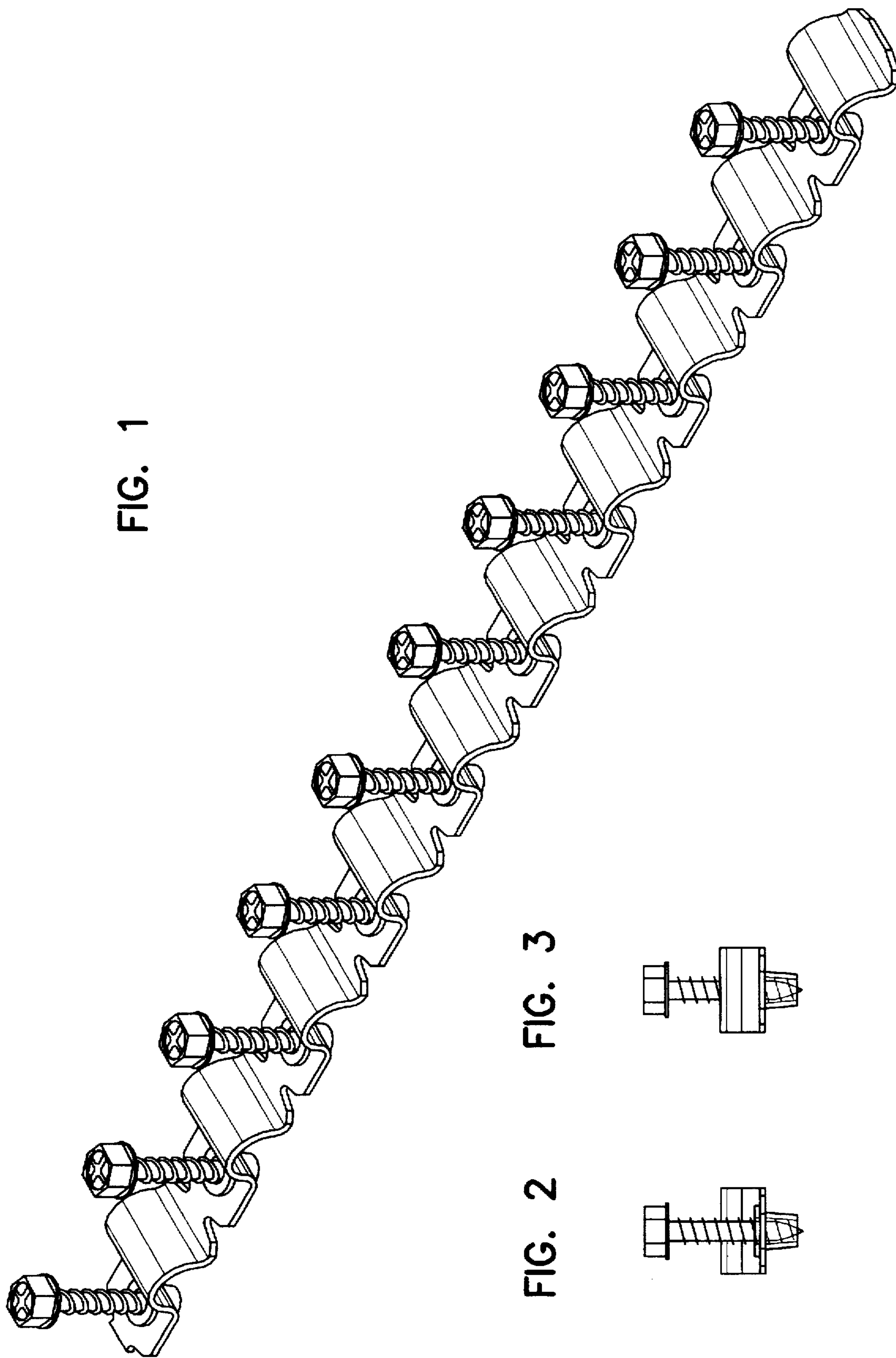

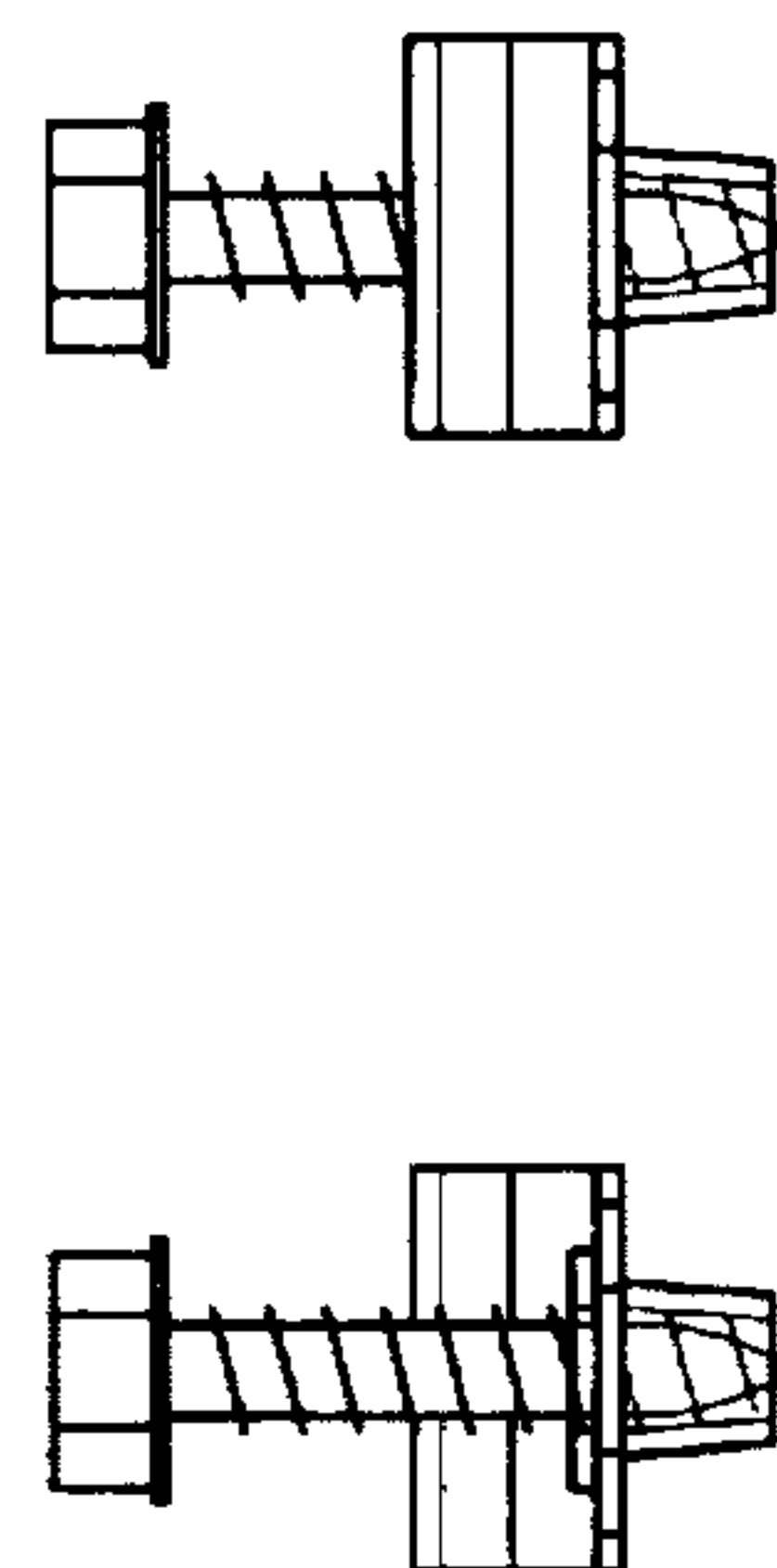

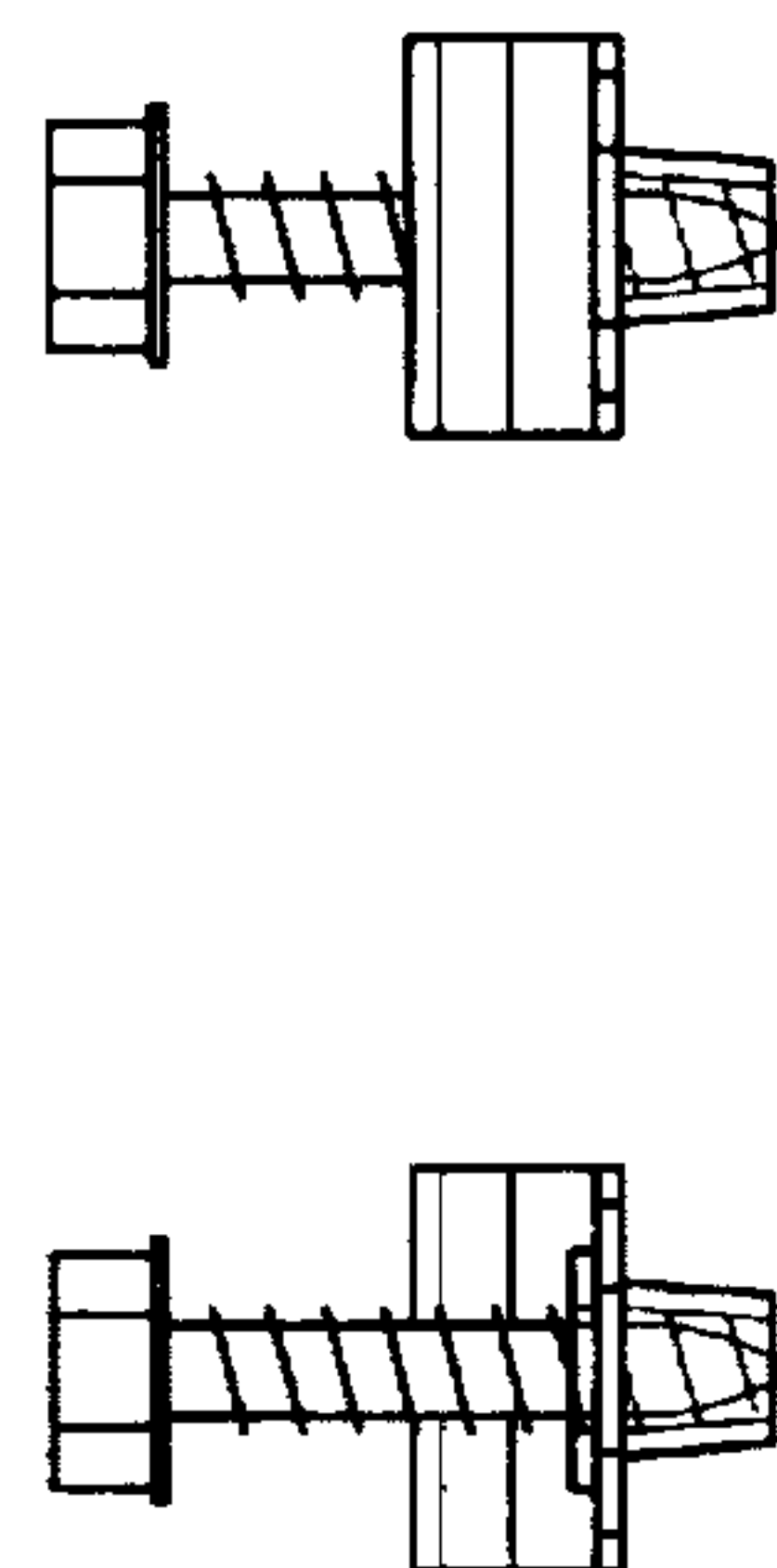

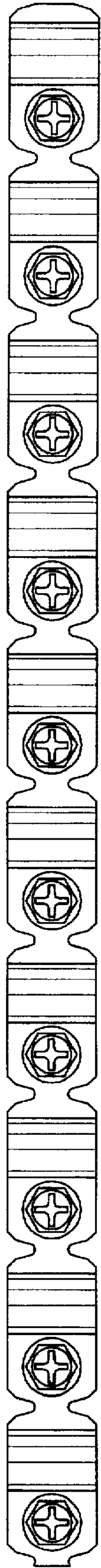

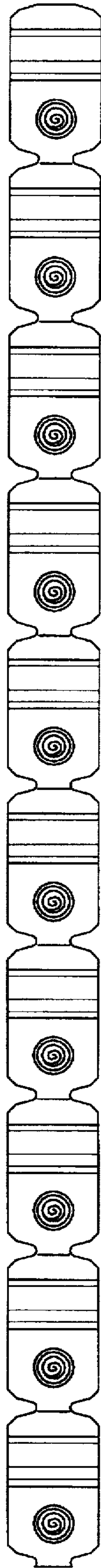

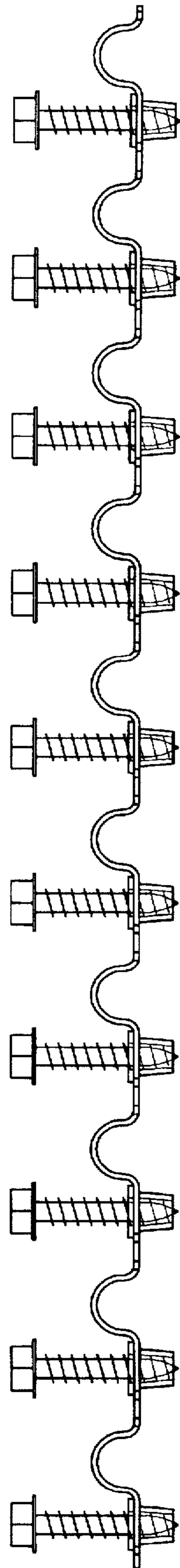

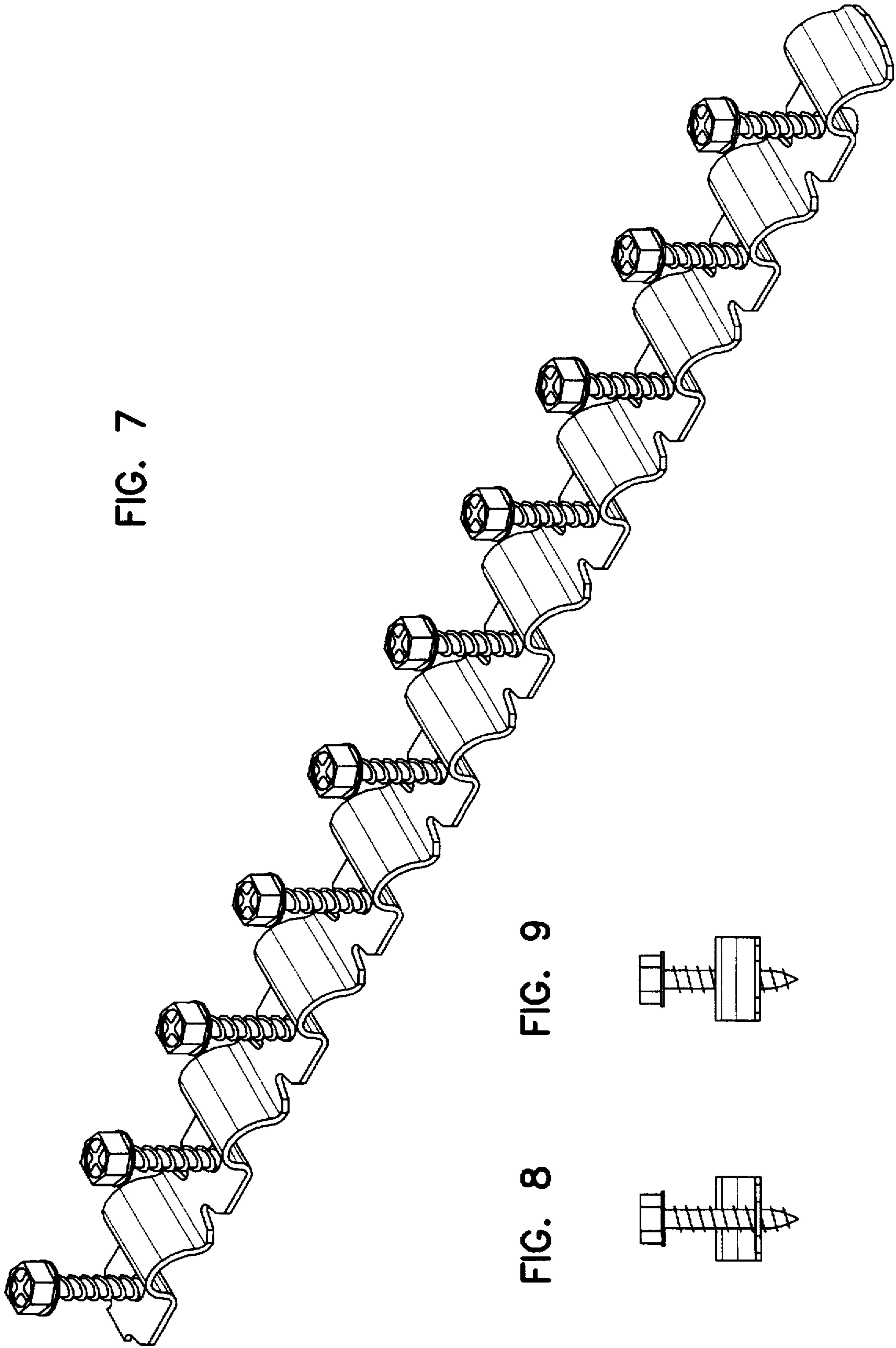

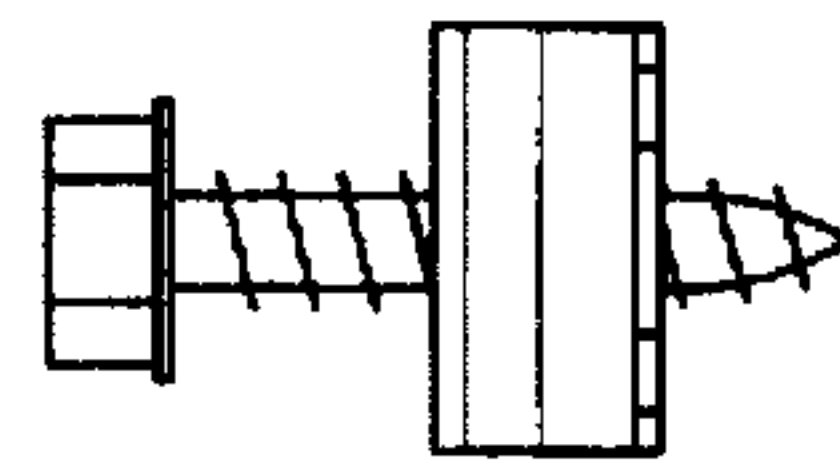

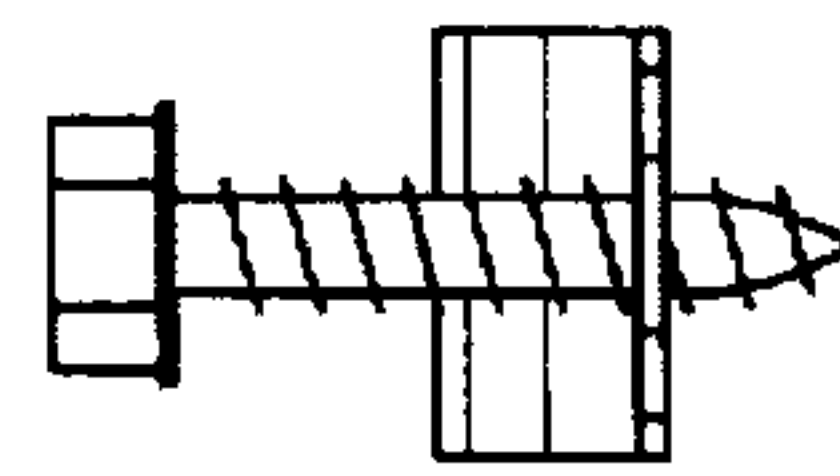

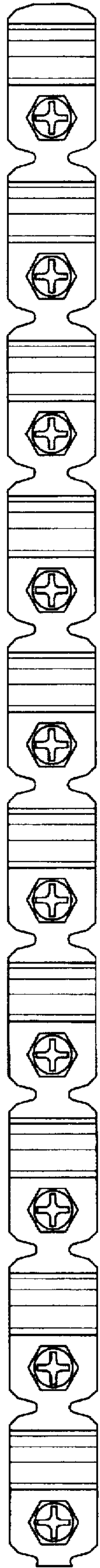

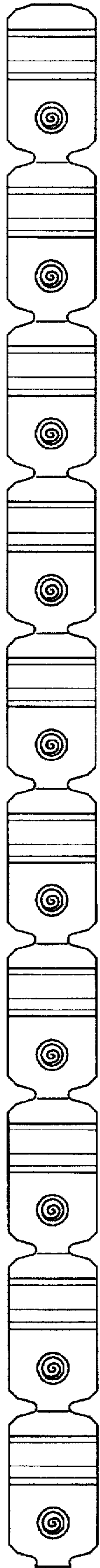
