[57] **CLAIM**

The ornamental design for an interactive video display and select console for vehicle fueling positions, as shown and described.

DESCRIPTION

FIG. 1 is a perspective side view of an interactive video display and select console for vehicle fueling positions embodying our new design;

FIG. 2 is a front side view of the vehicle fueling positions of FIG. 1;

FIG. 3 is a side view of the vehicle fueling positions of FIG. 1;

FIG. 4 is another side view of the vehicle fueling positions of FIG. 1;

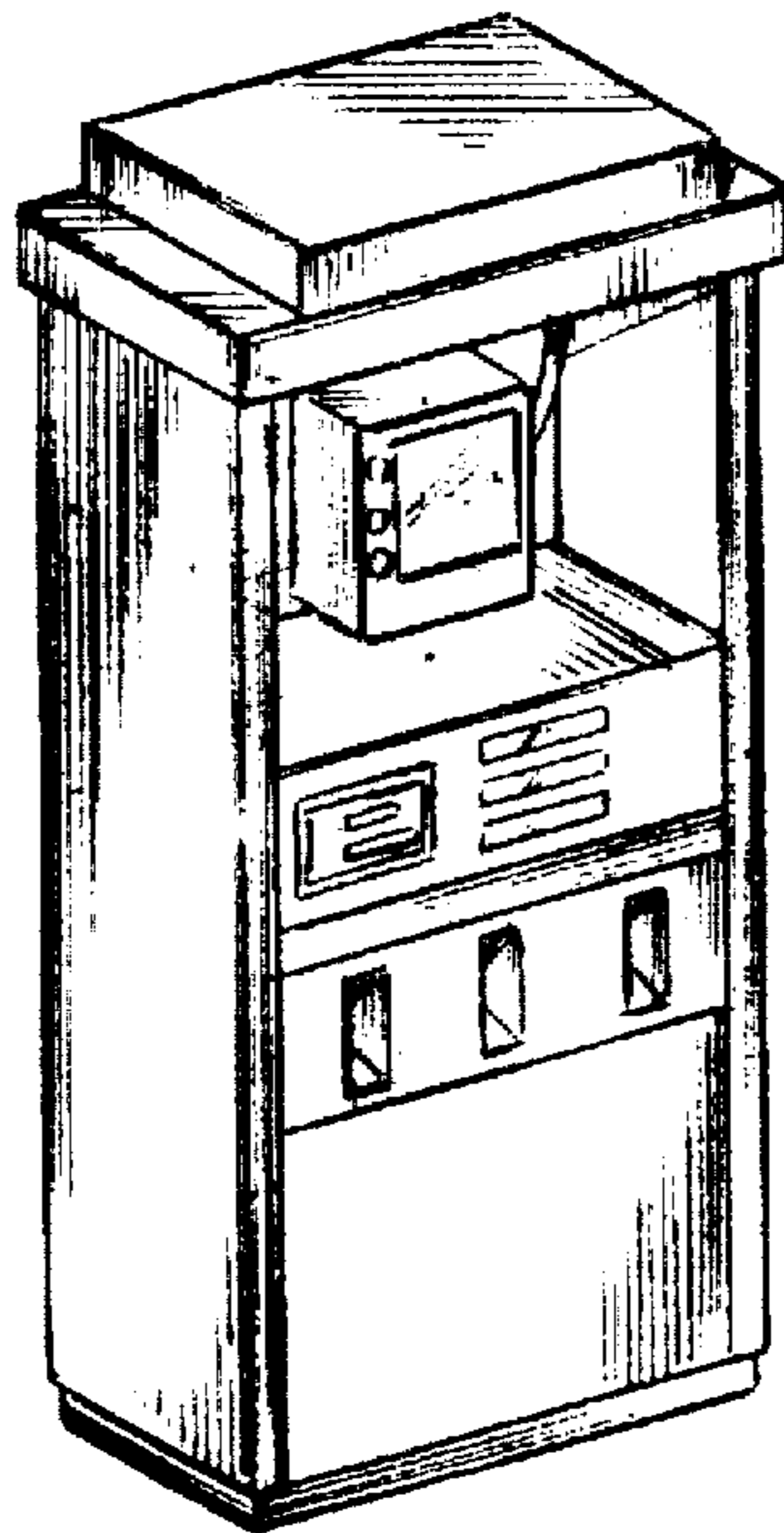
FIG. 5 is a rear side view of the vehicle fueling positions of FIG. 1;

FIG. 6 is a top side view of the vehicle fueling positions of FIG. 1; and,

FIG. 7 is a bottom side view of the vehicle fueling positions of FIG. 1.

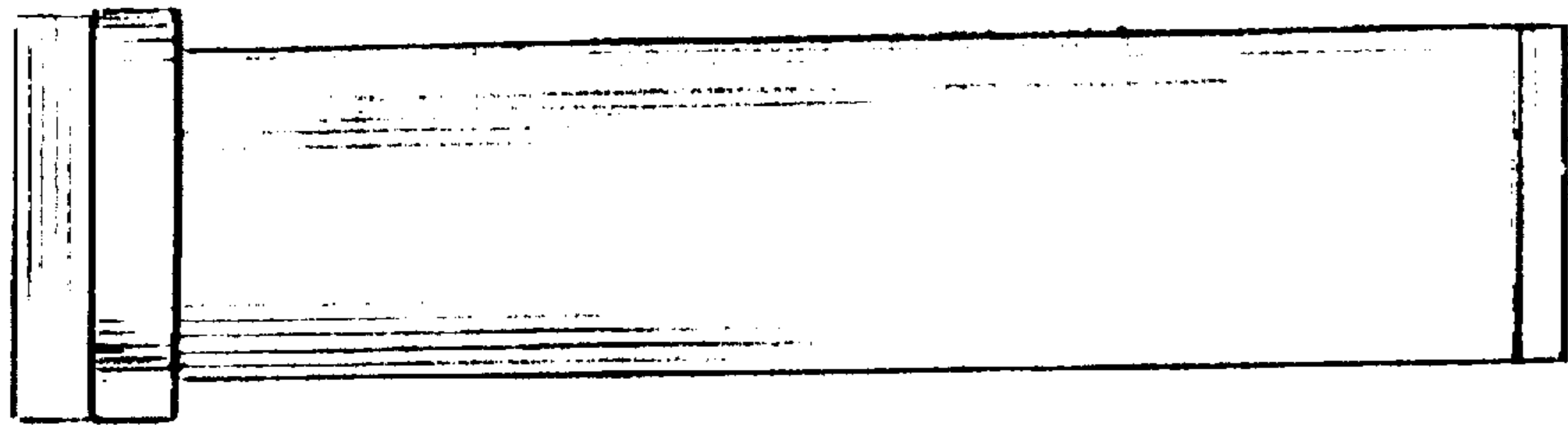

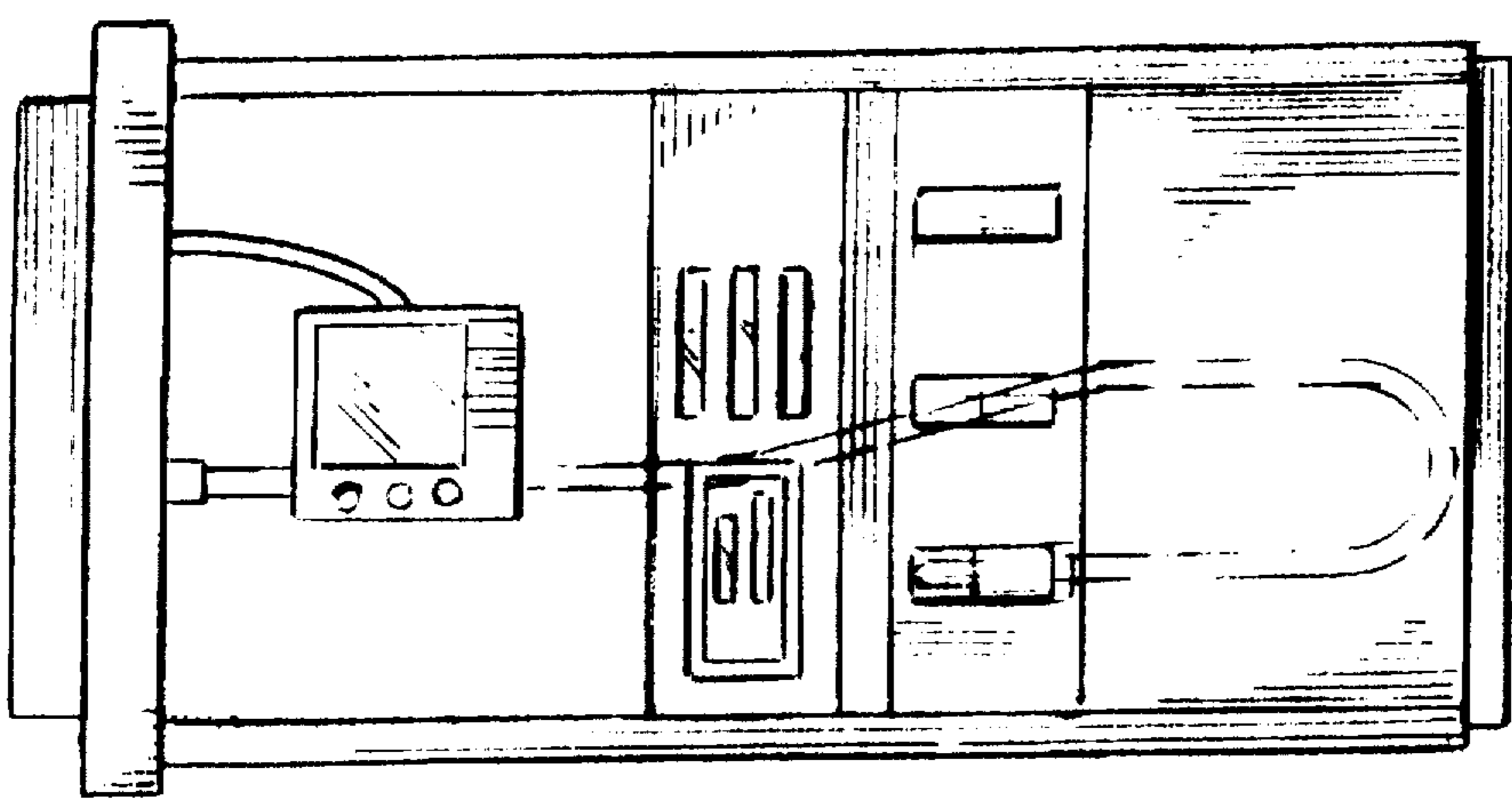

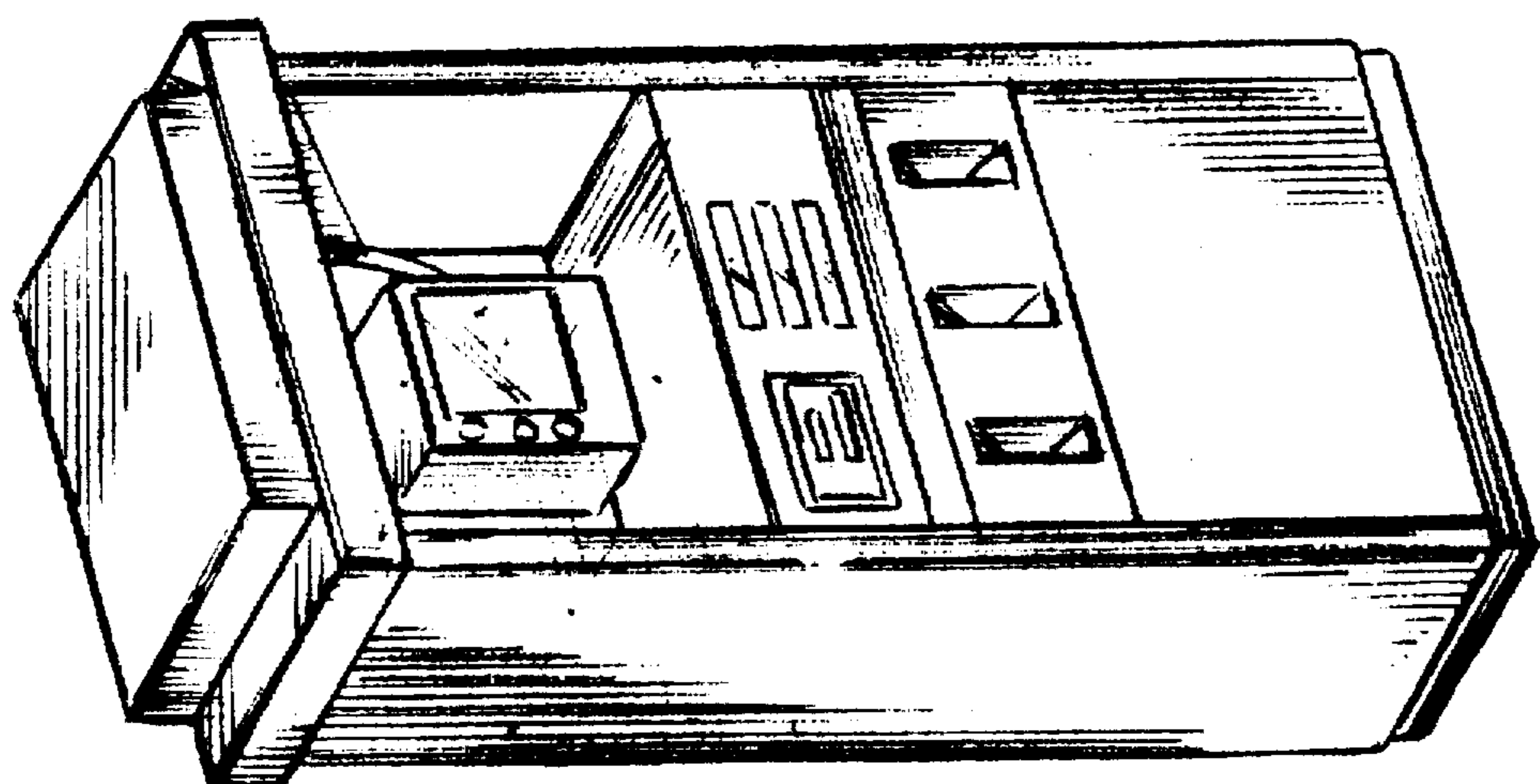

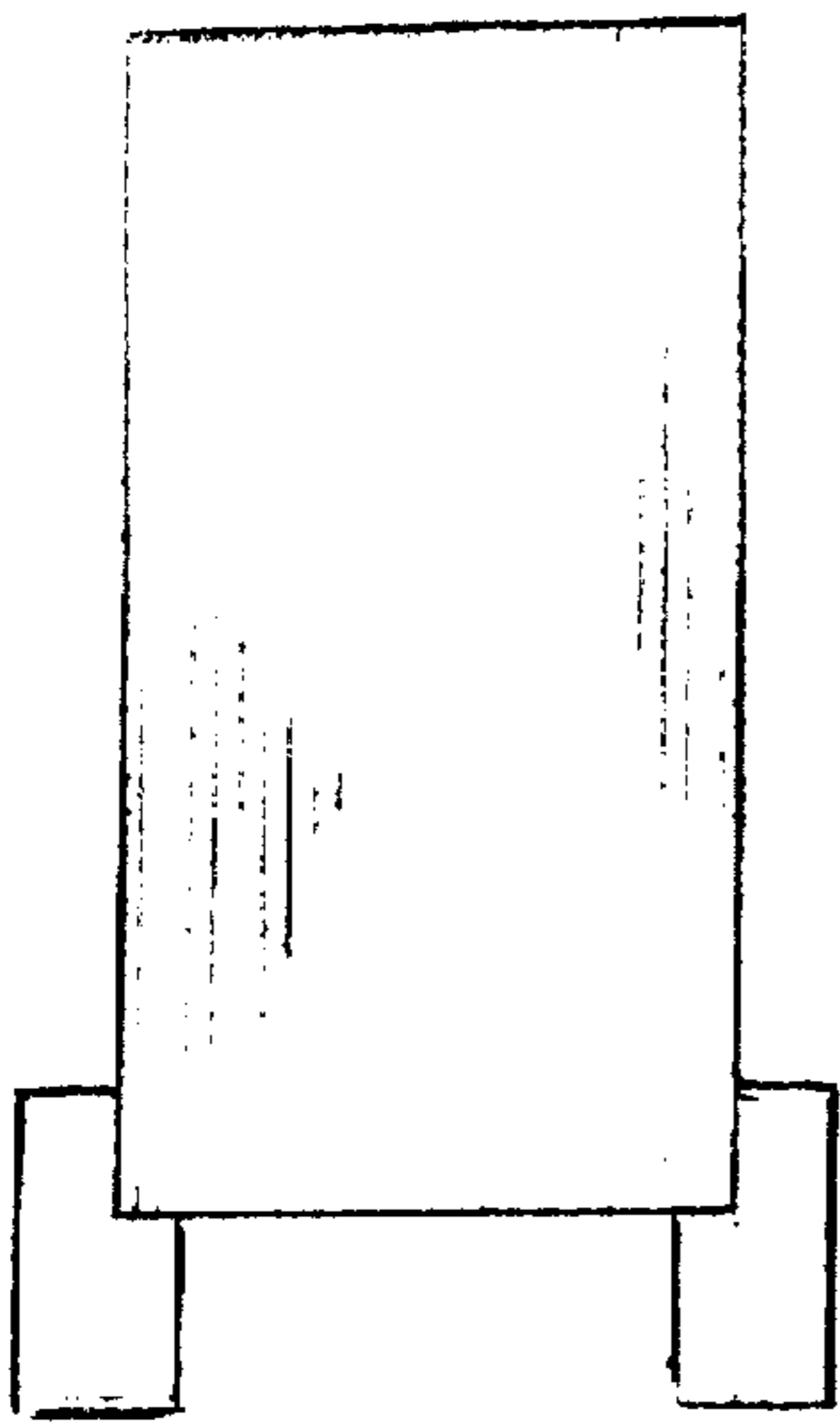

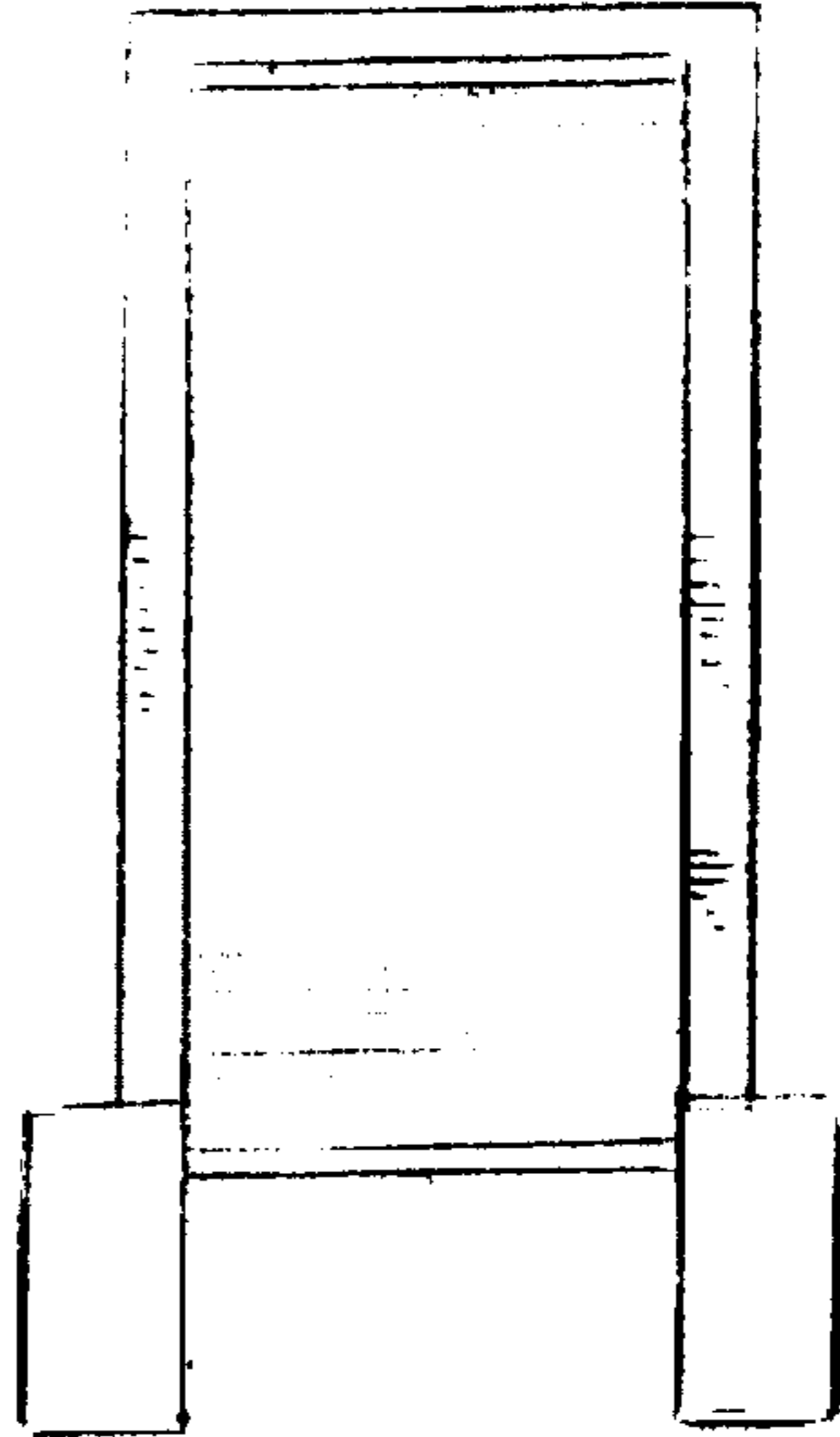

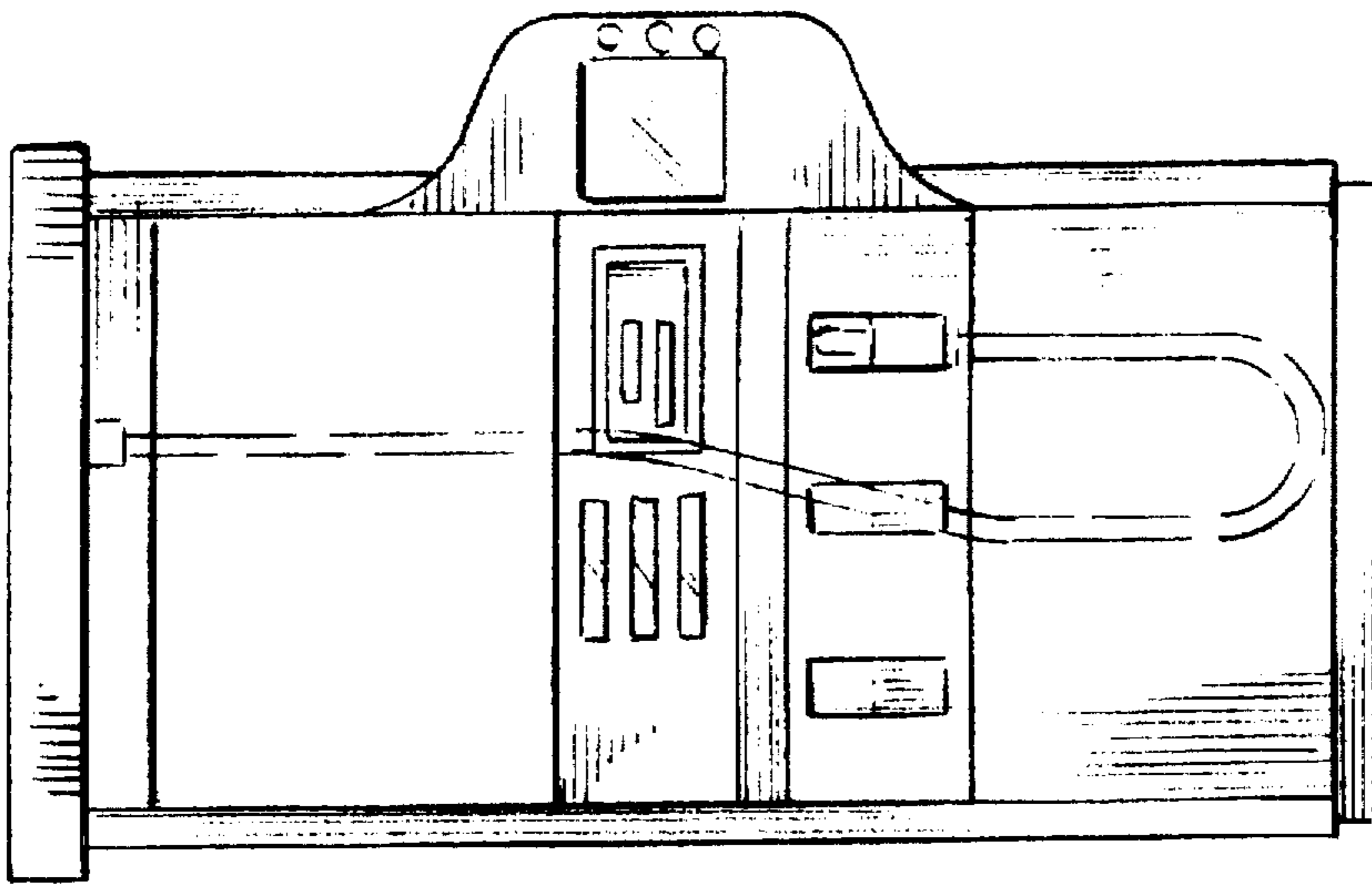

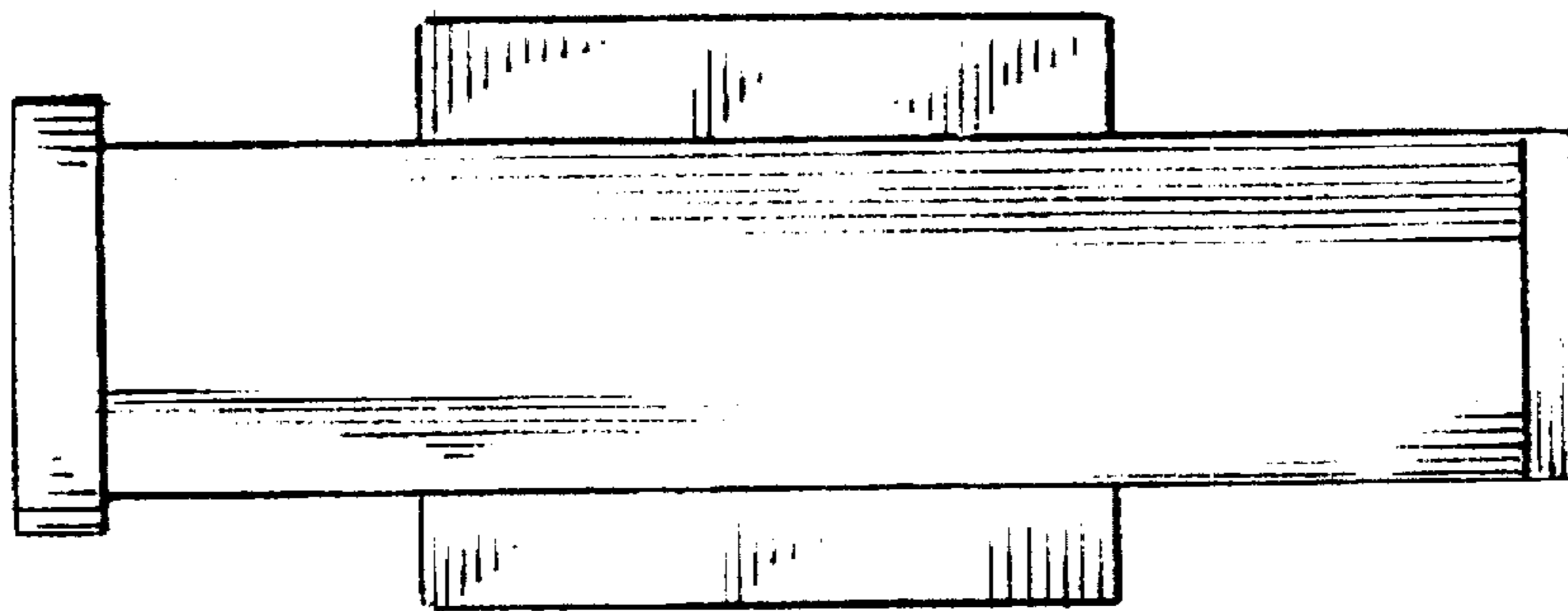
