DESCRIPTION

FIG. 1 is a perspective view of a cushion for pets according to my design;

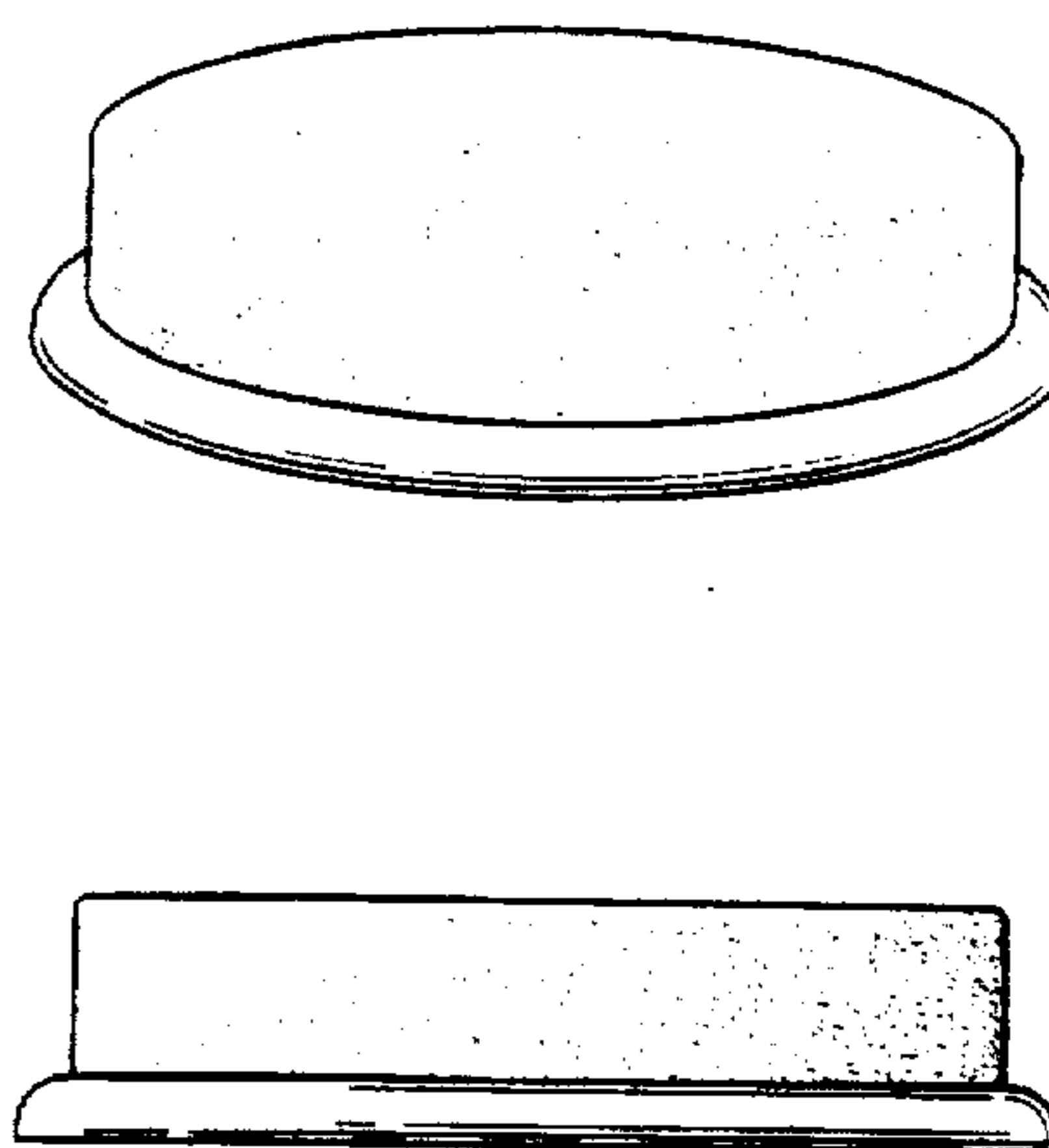
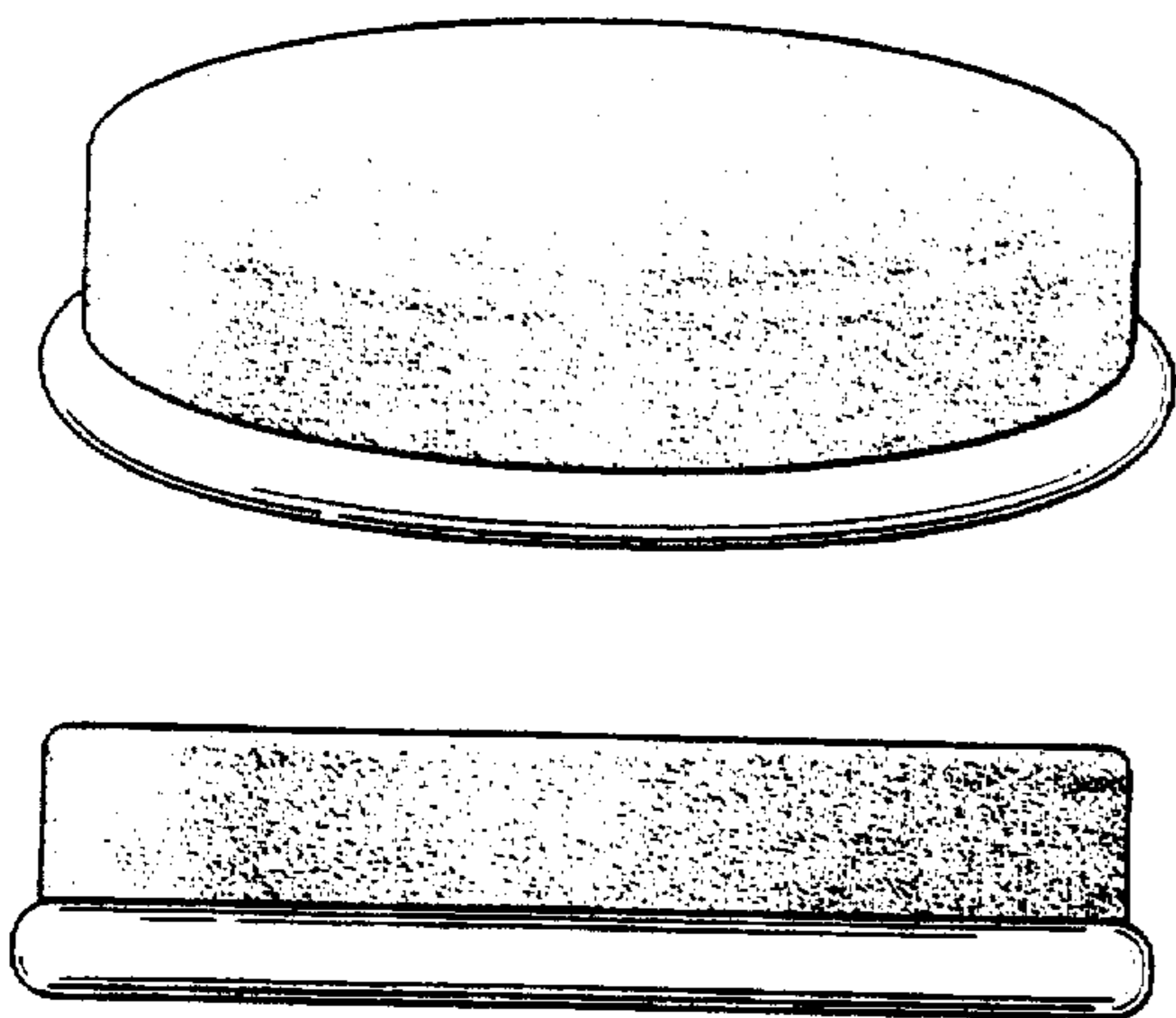

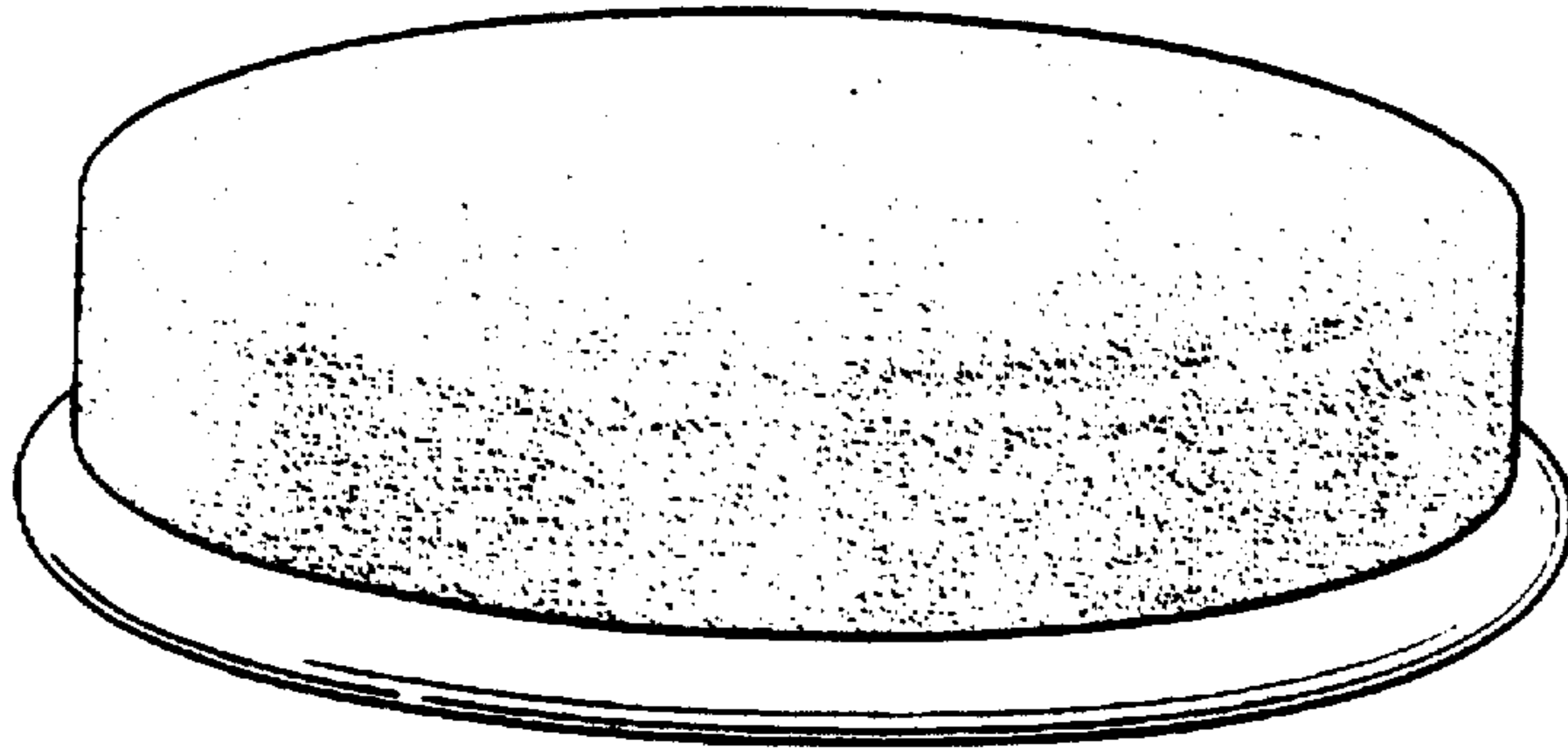

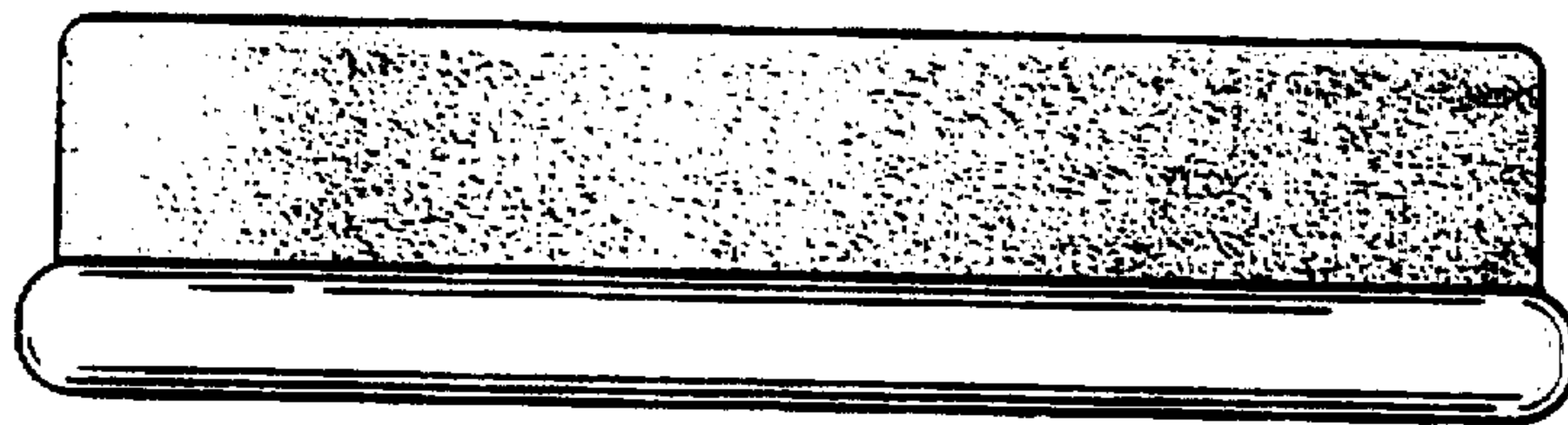

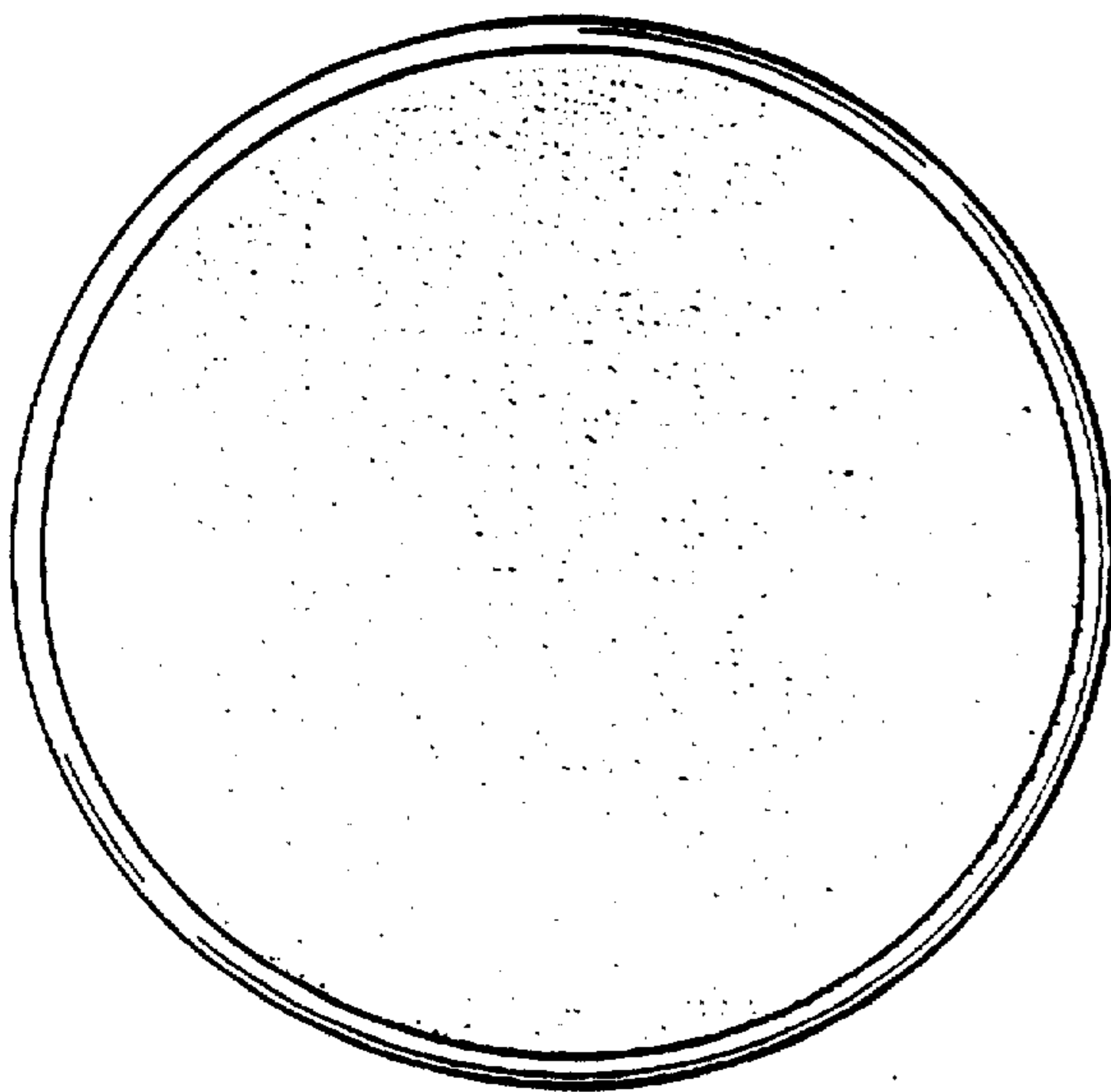

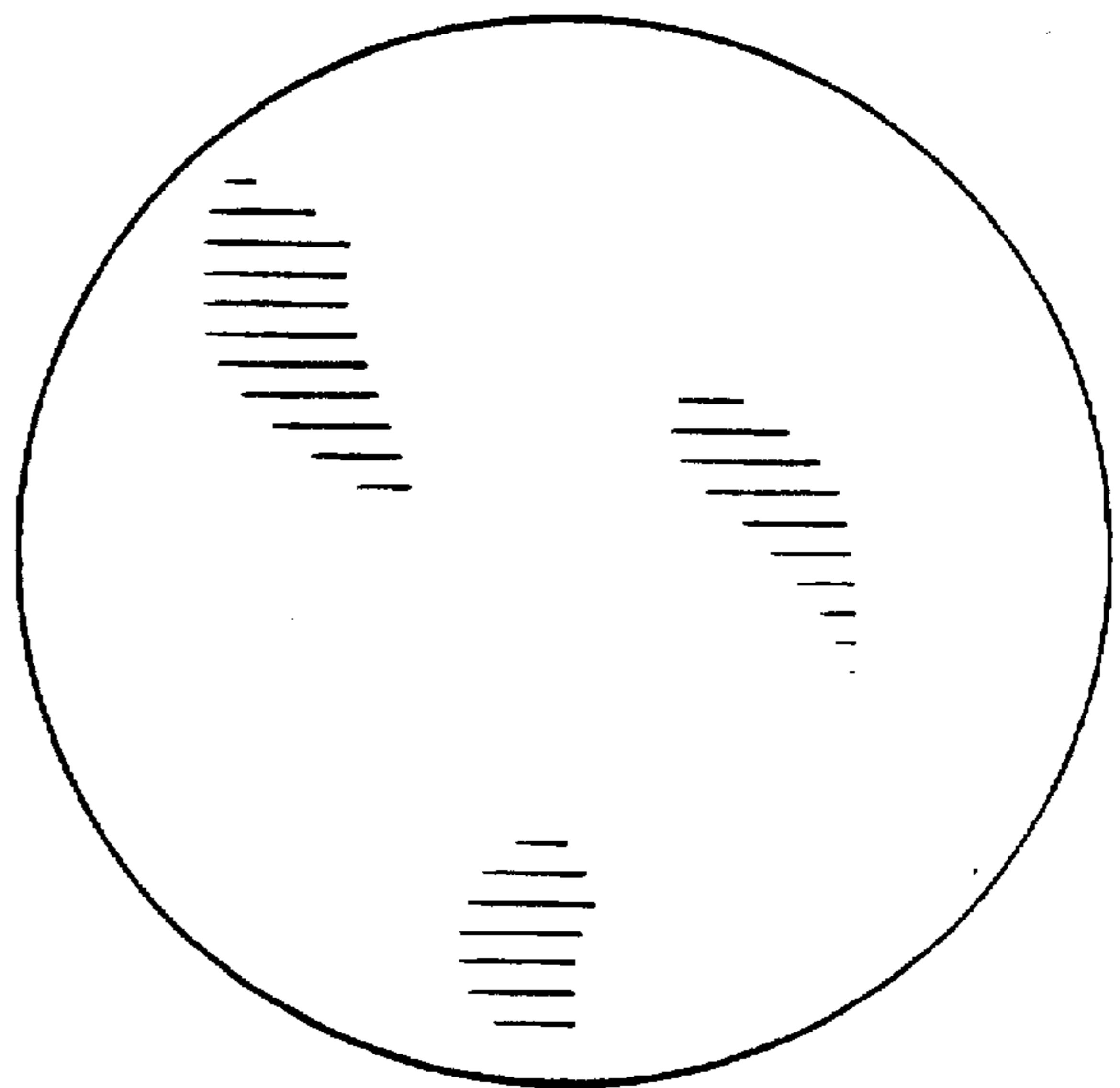

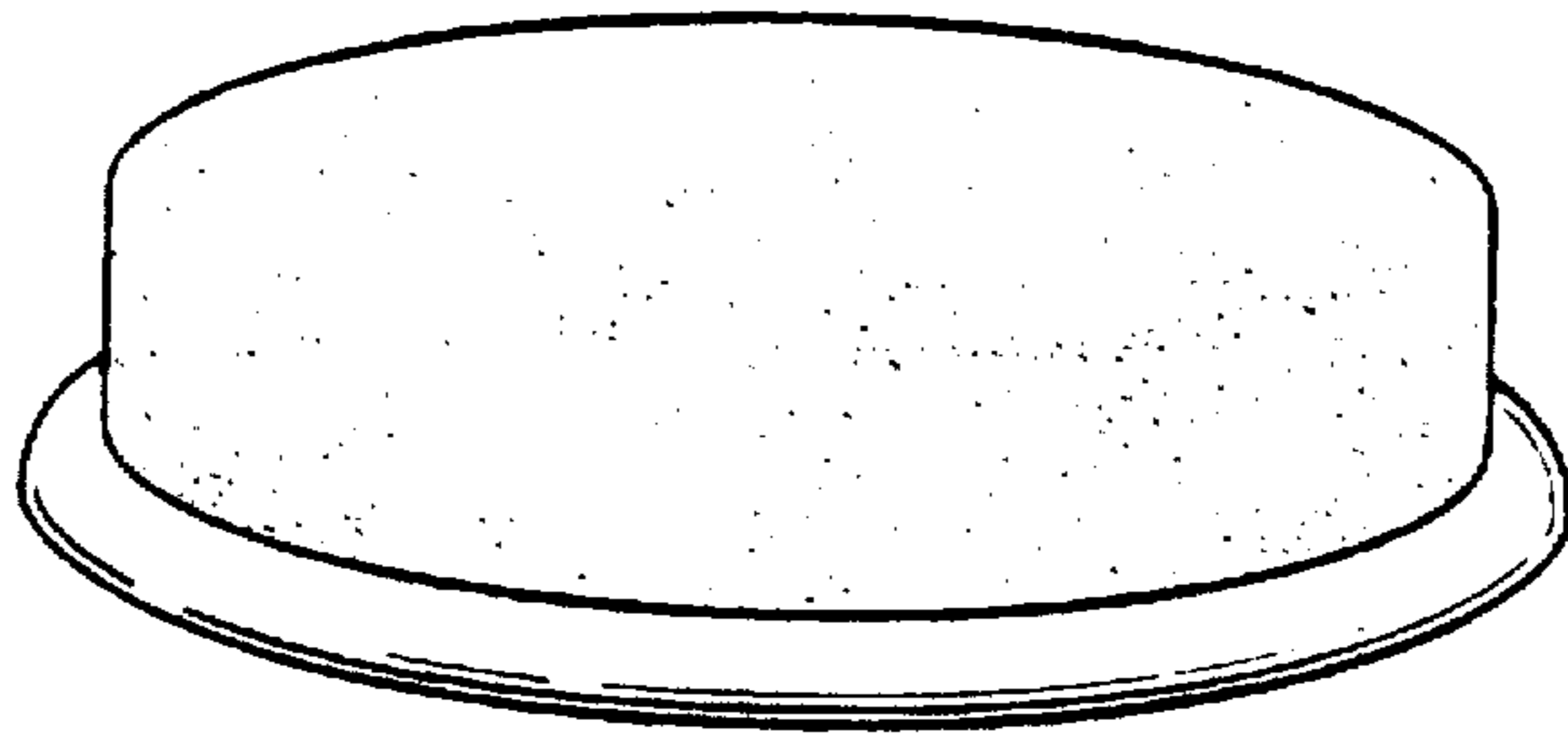

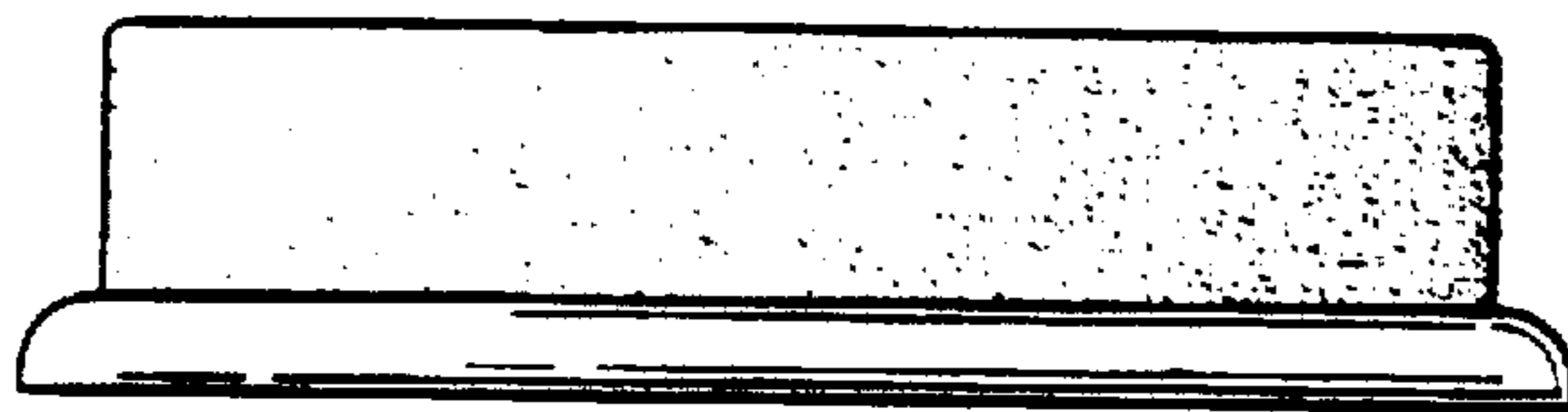

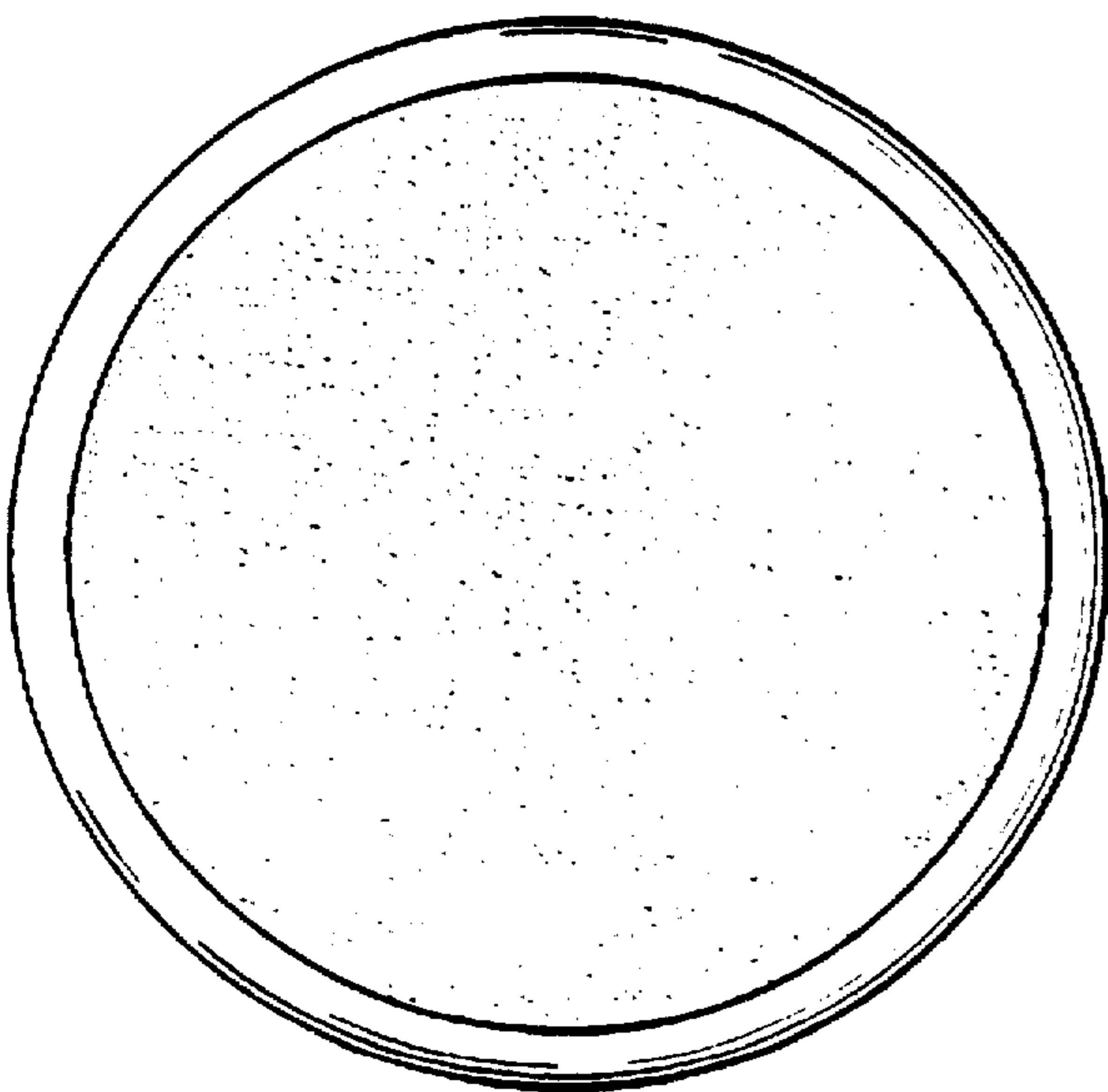
