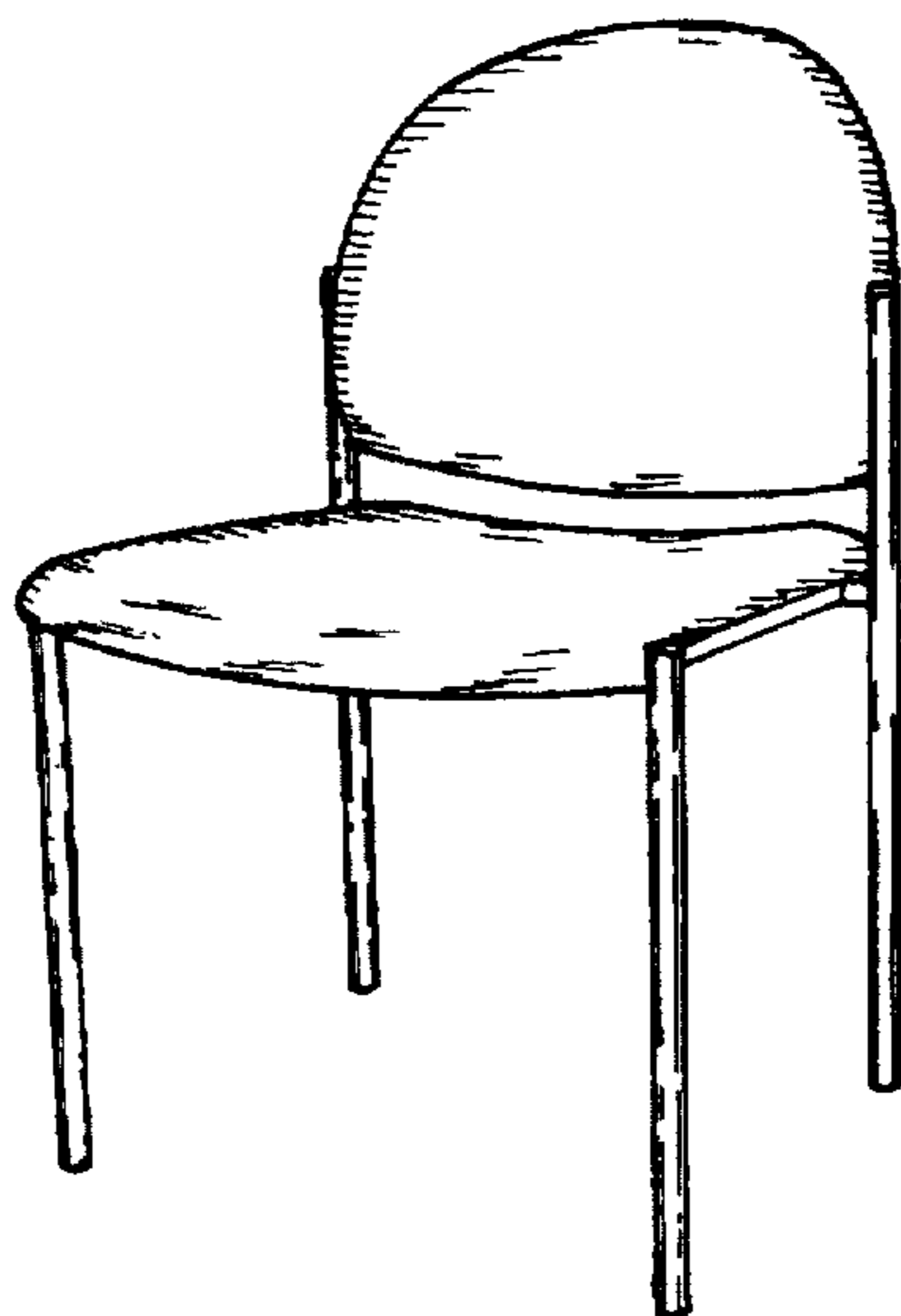
[57] CLAIM

The ornamental design for a chair, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a chair embodying the present invention;
FIG. 2 is a front view thereof;
FIG. 3 is a right side view thereof, the left side view being a mirror image of the right side;
FIG. 4 is a top view thereof; and,
FIG. 5 is a rear view thereof;
FIG. 6 is a perspective view of a second embodiment of the present invention;
FIG. 7 is a front view thereof;
FIG. 8 is a right side view thereof, the left side being a mirror image of the right side;
FIG. 9 is a top view thereof; and,
FIG. 10 is a rear view thereof.

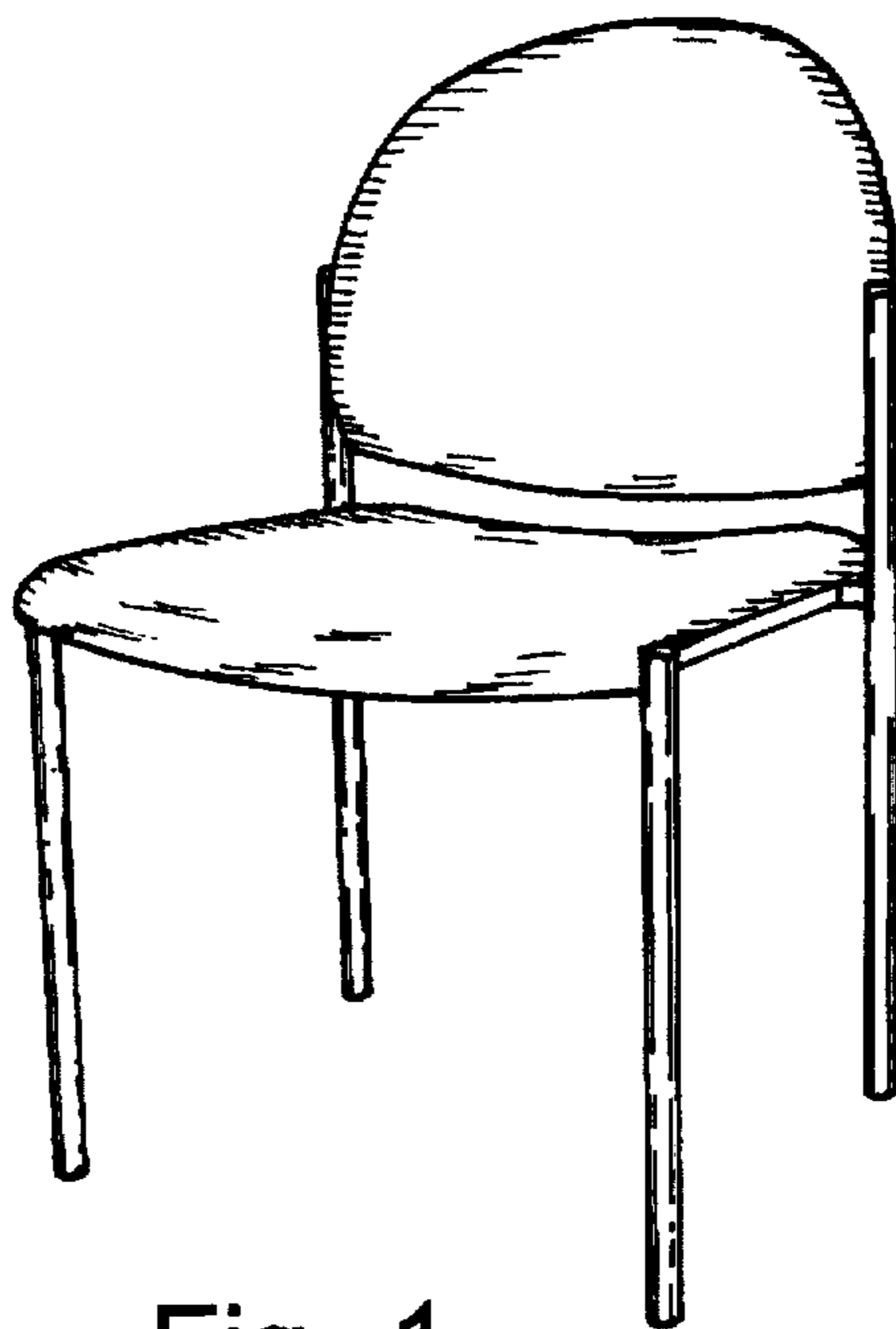

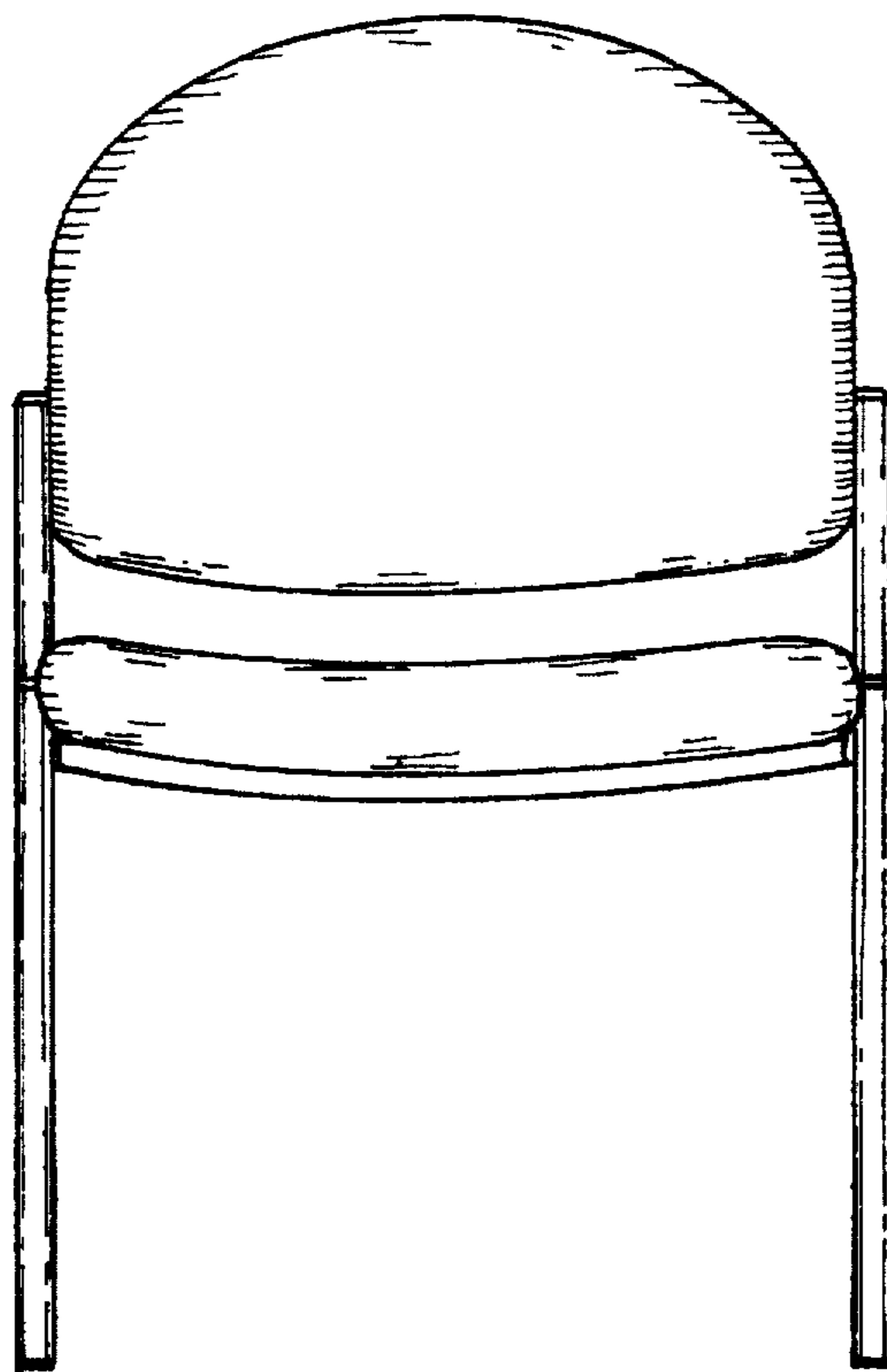

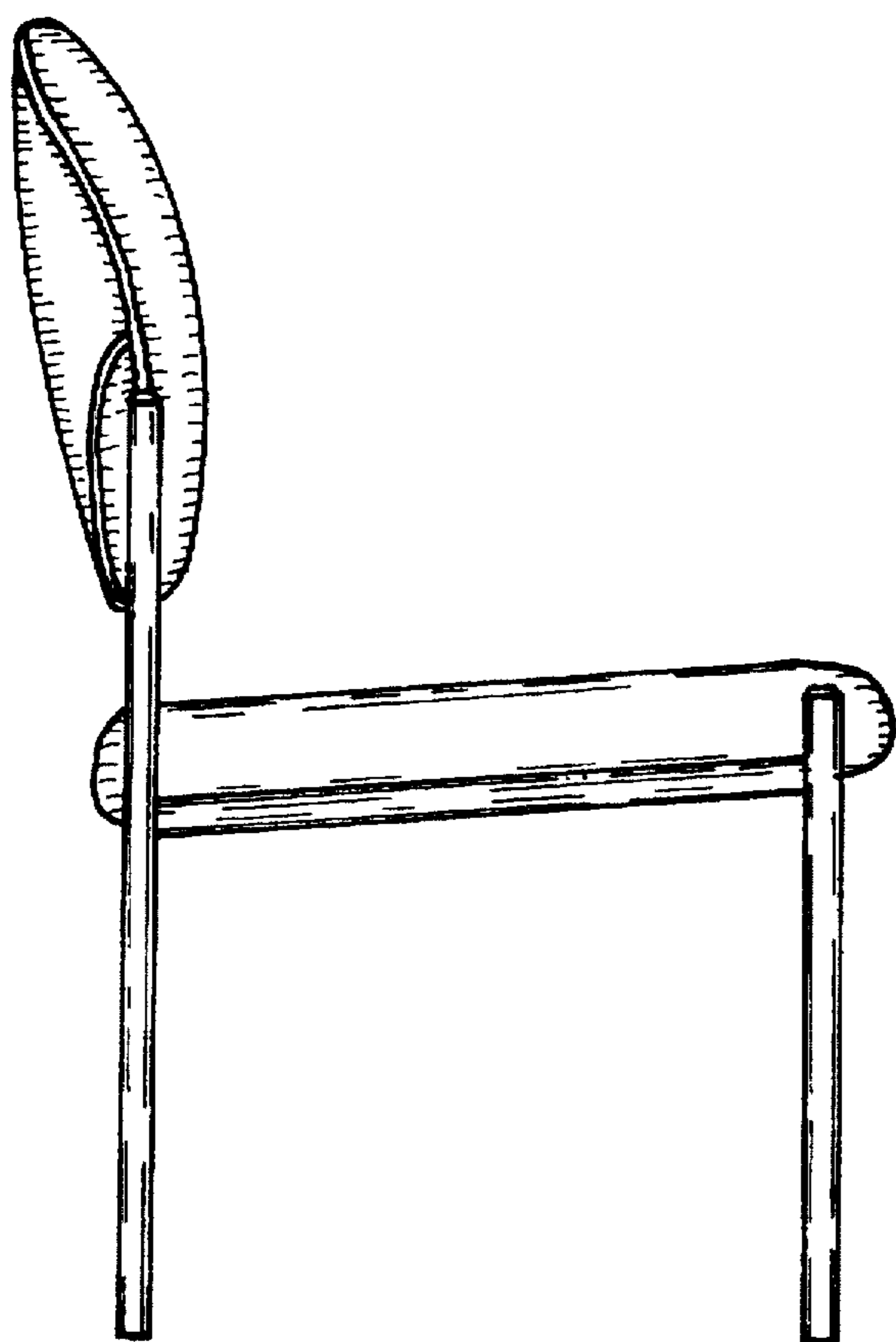

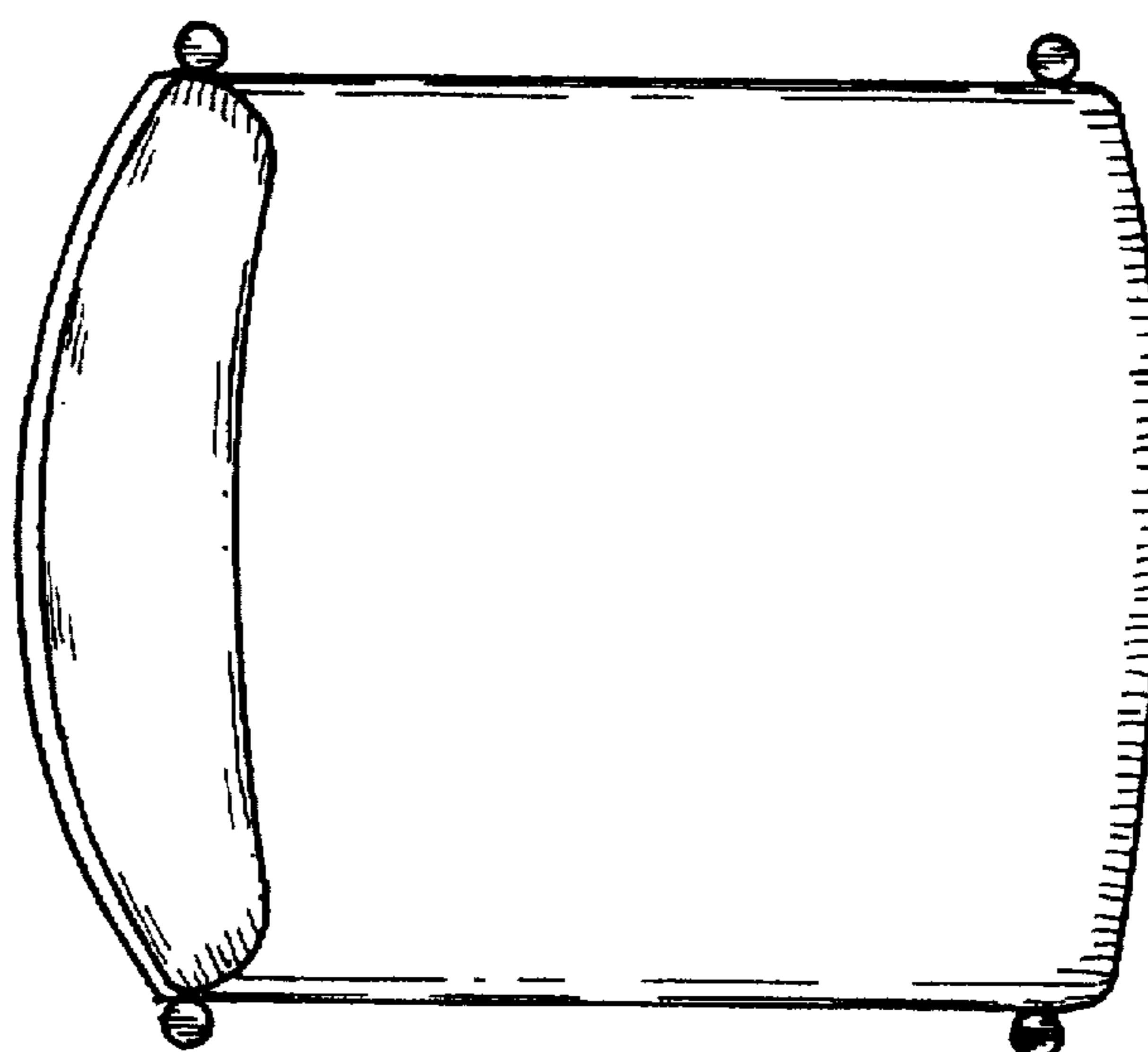

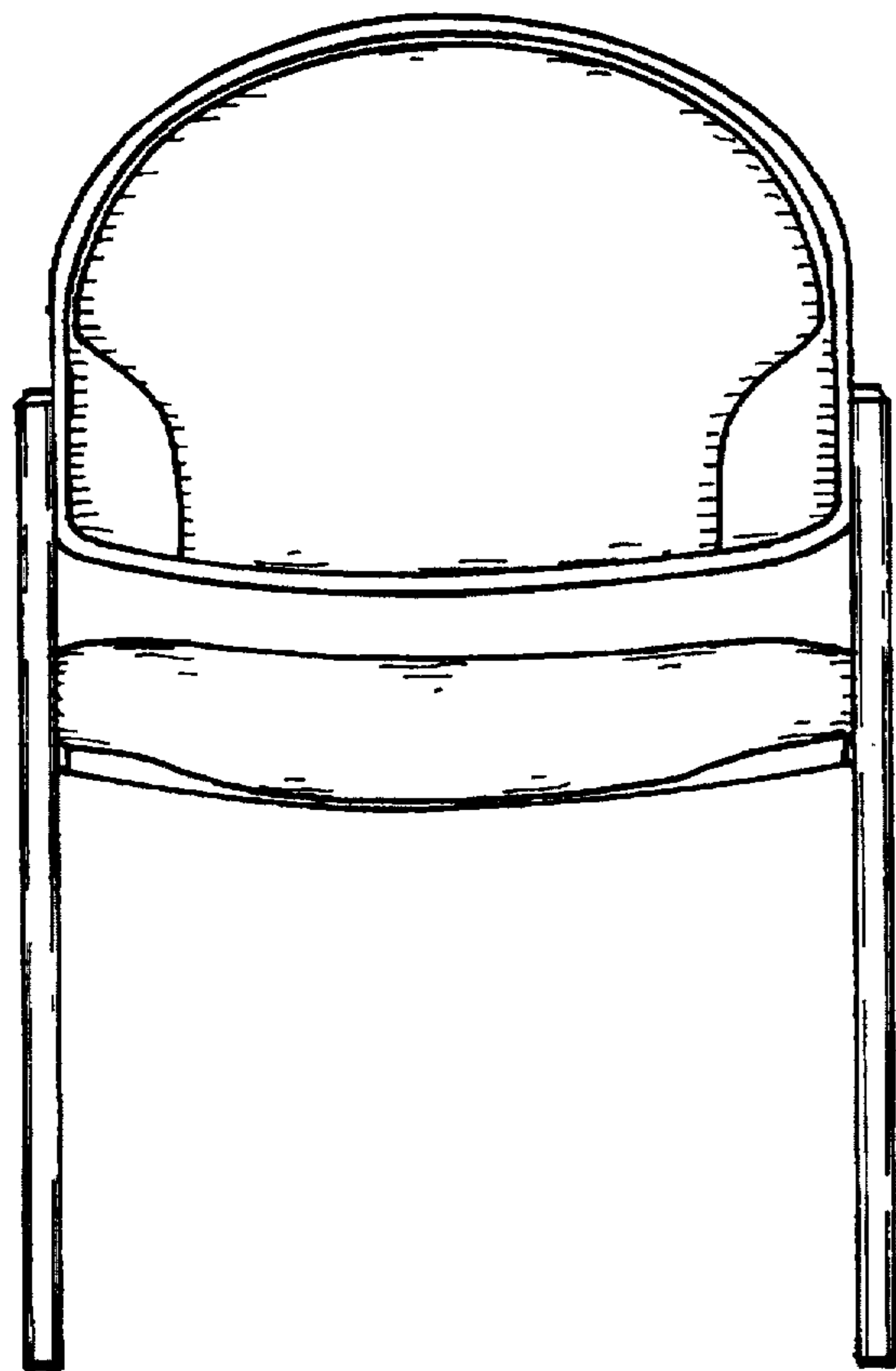

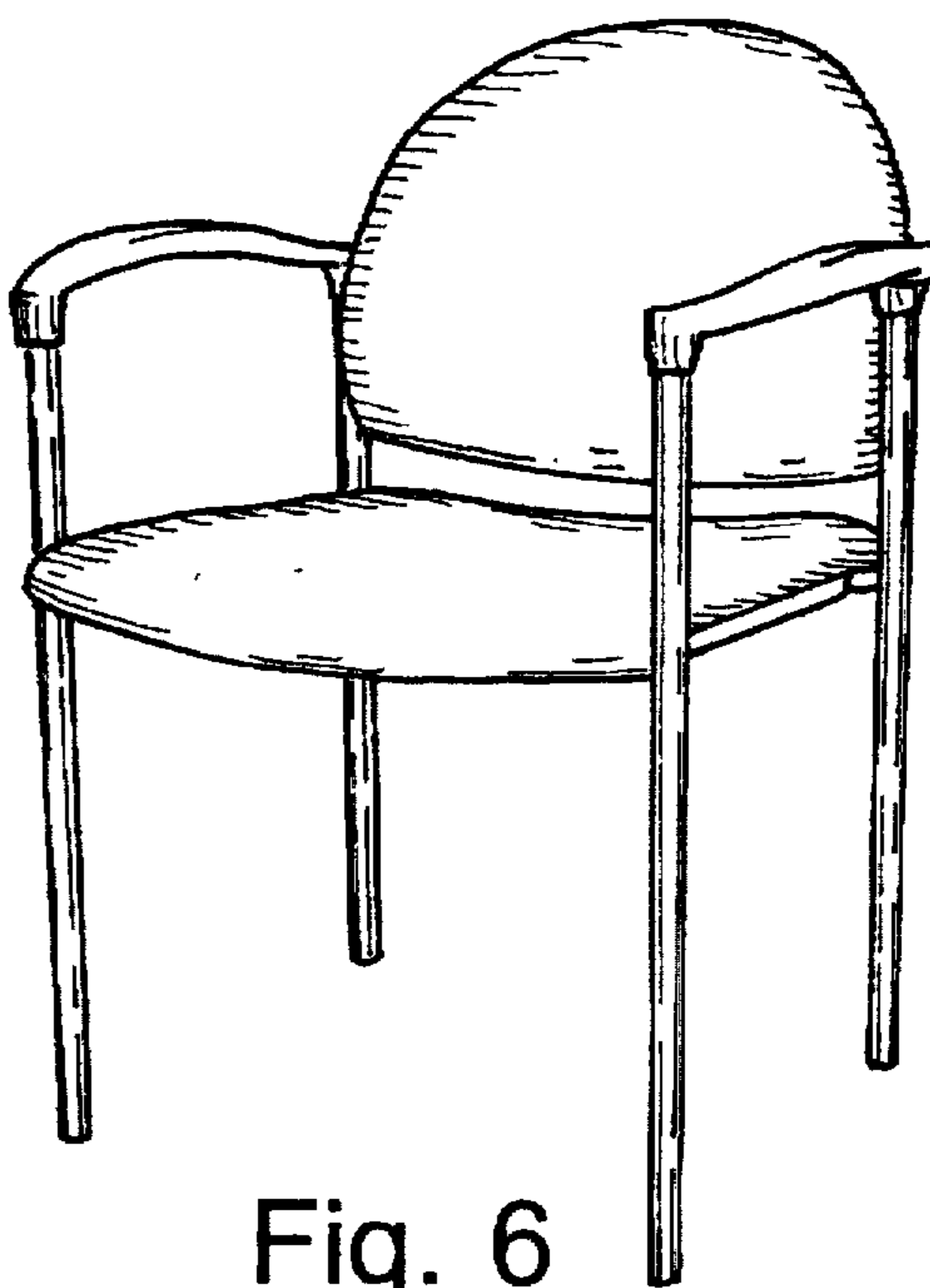

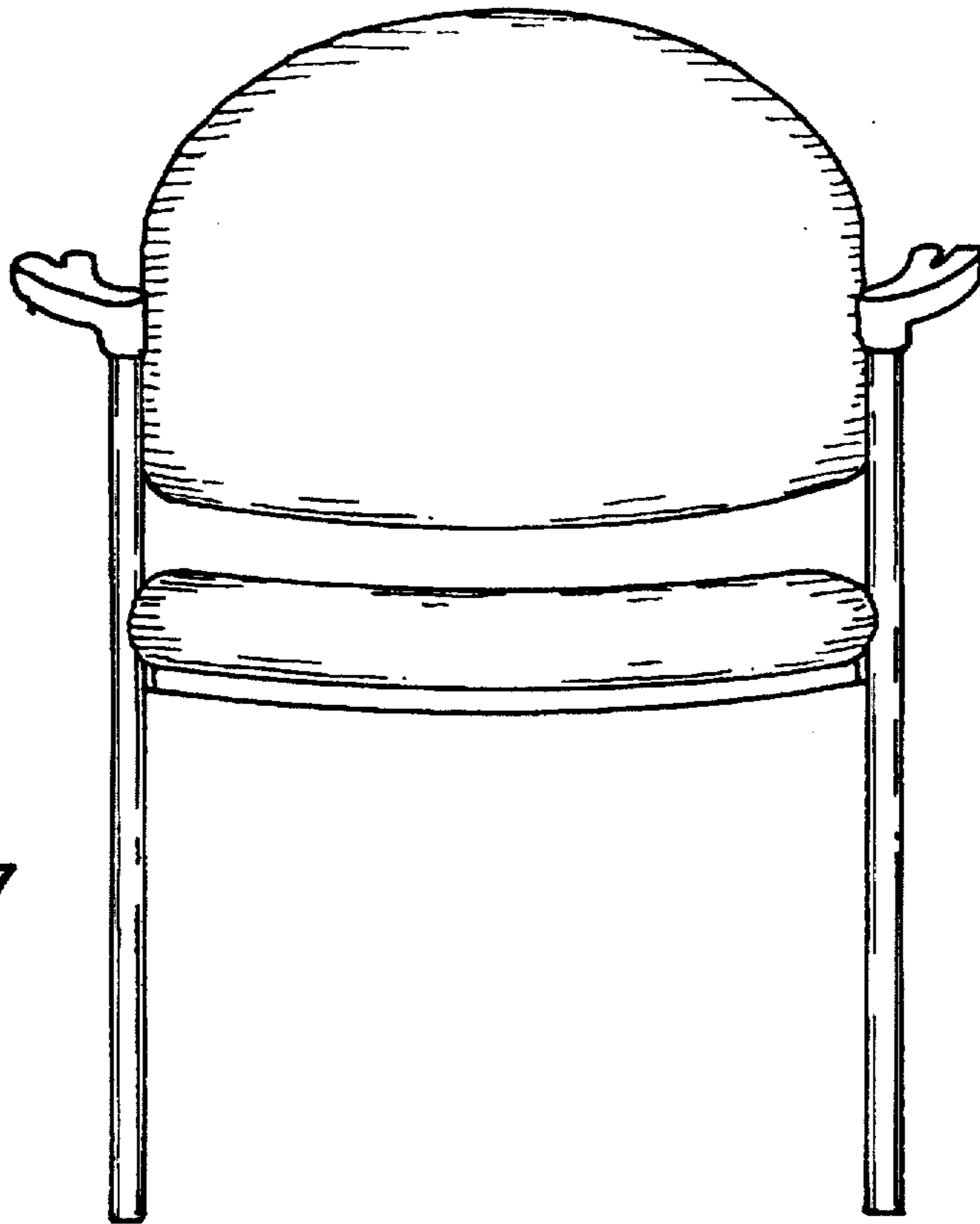

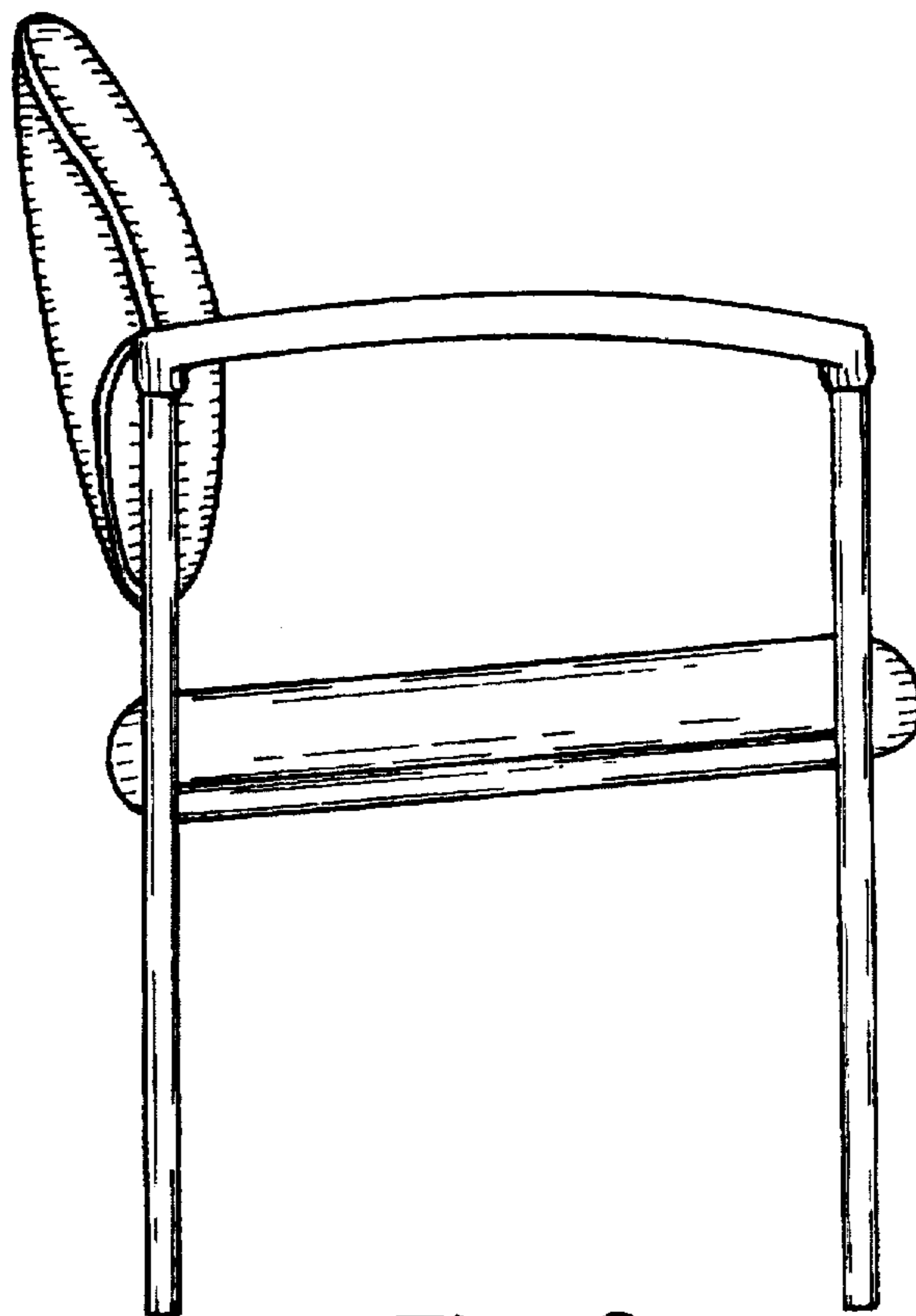

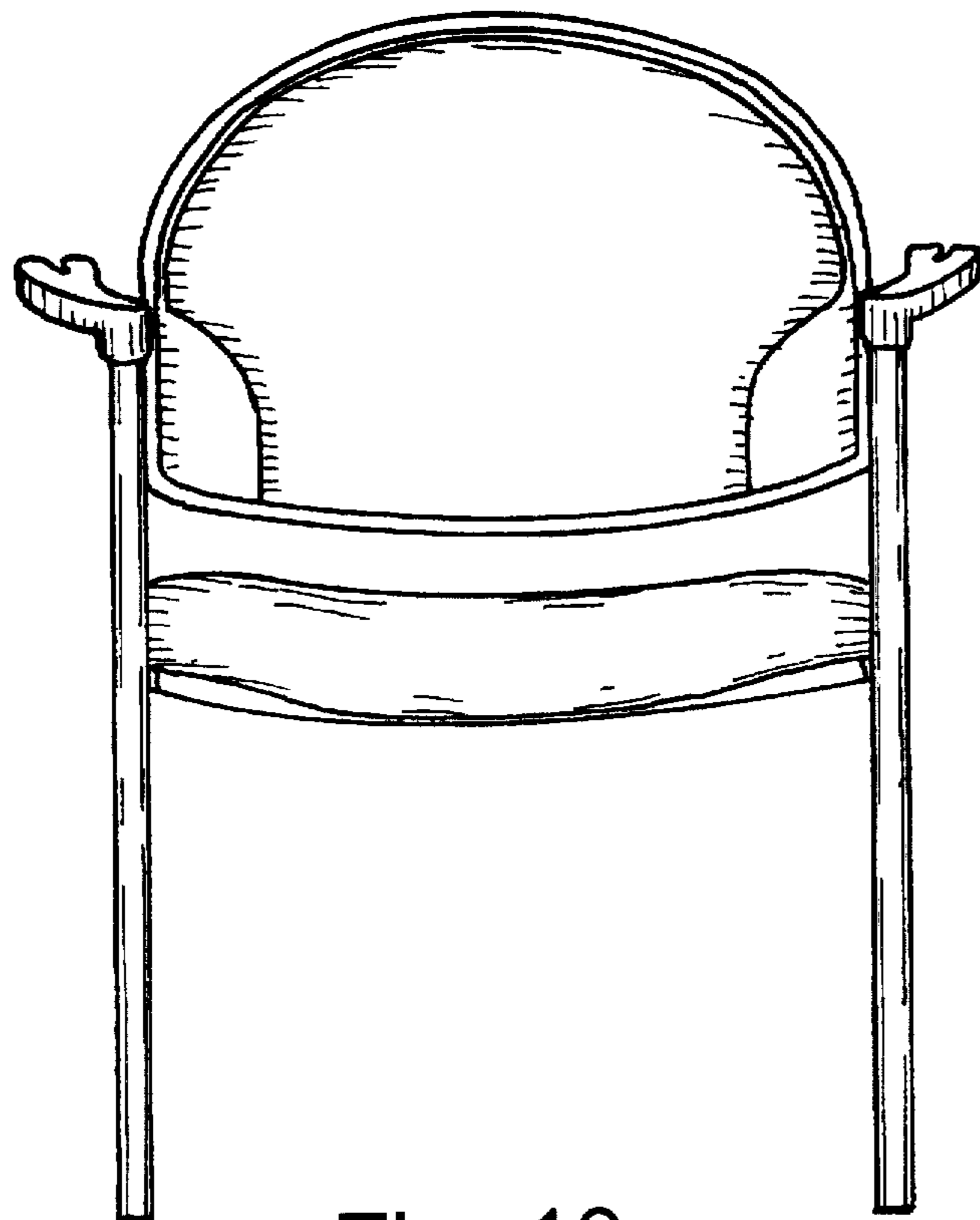
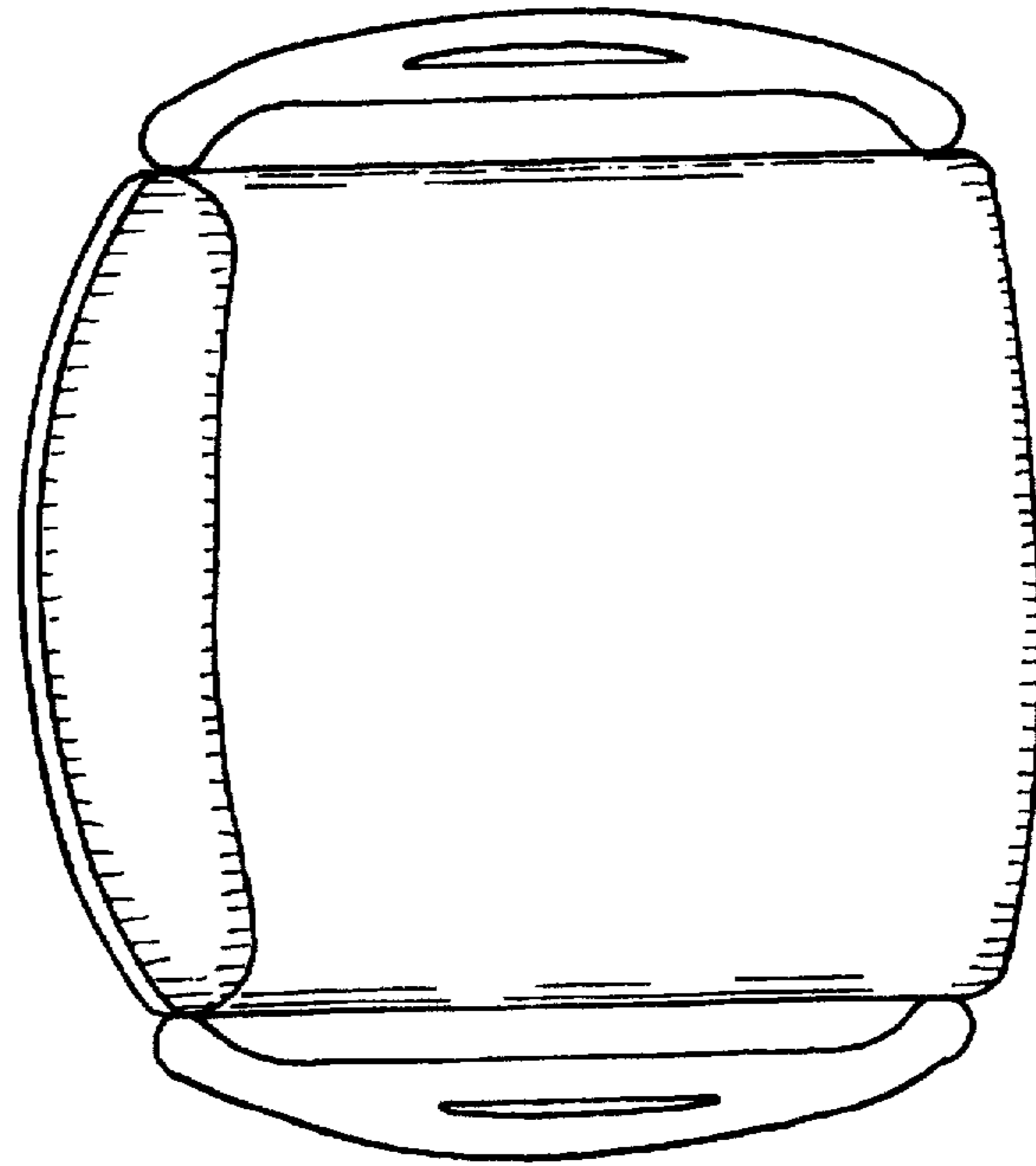
