The ornamental design for a combined hand held communication receiver and GPS device, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of the combined hand held communication receiver and GPS device of the present invention;

FIG. 4 is a front elevational view thereof;

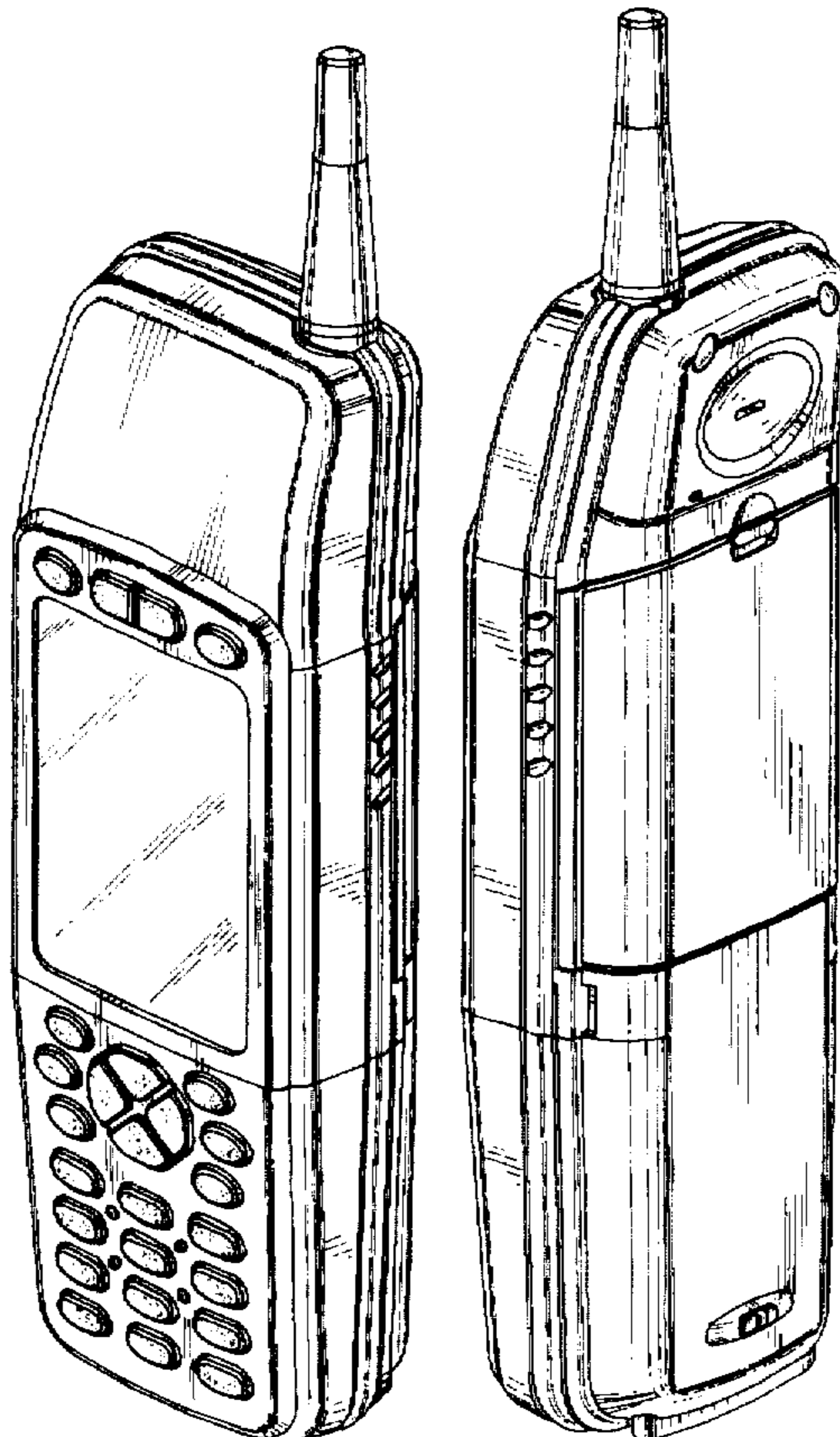

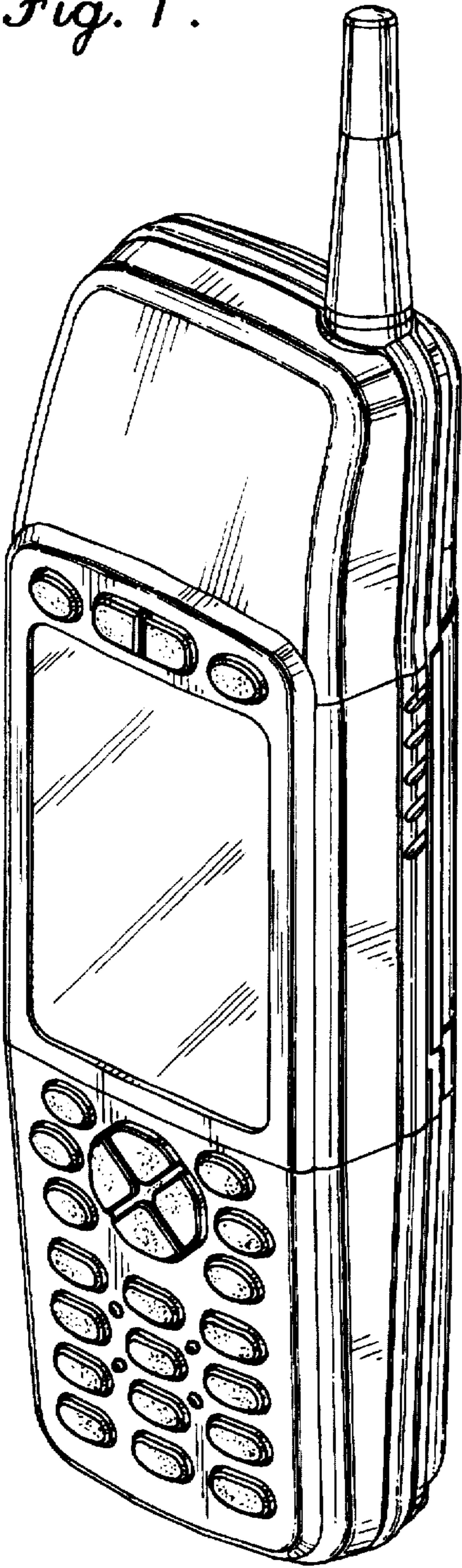
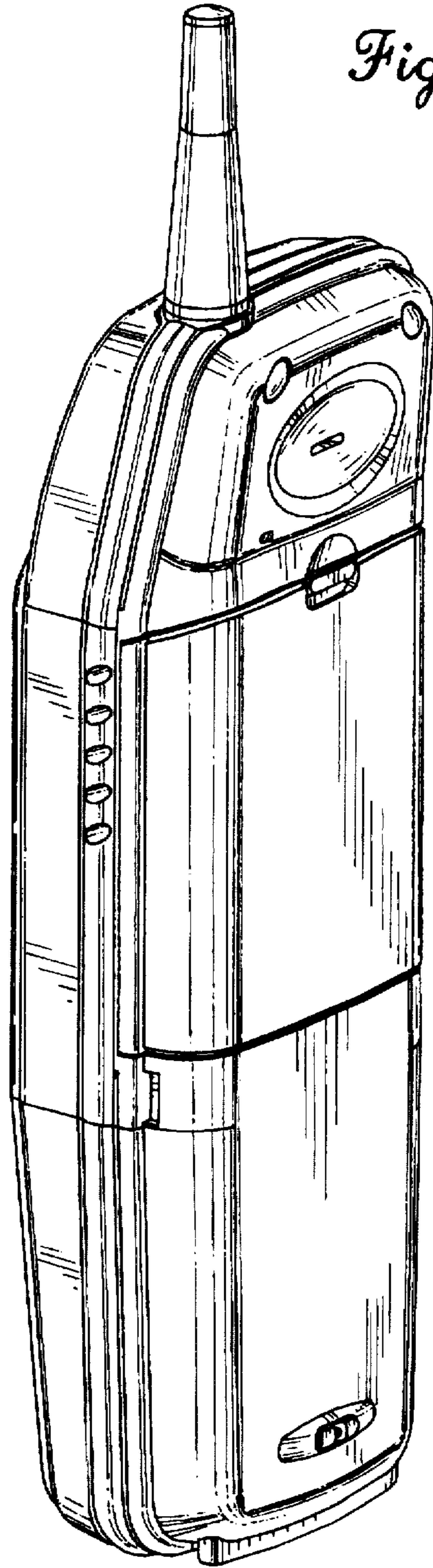

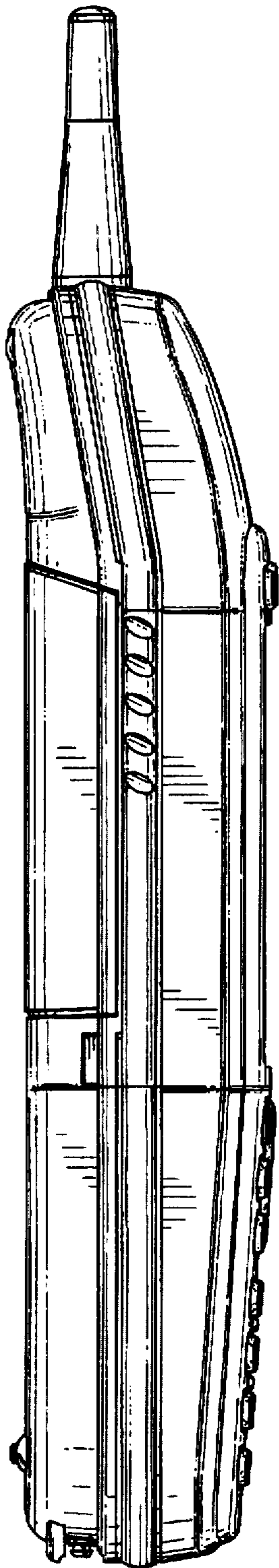

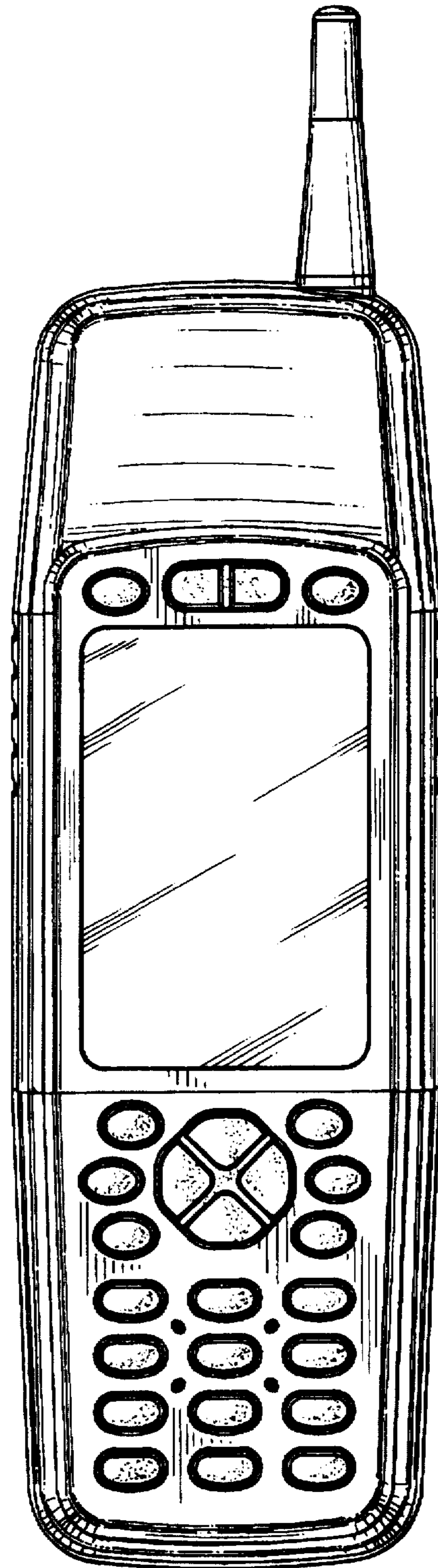

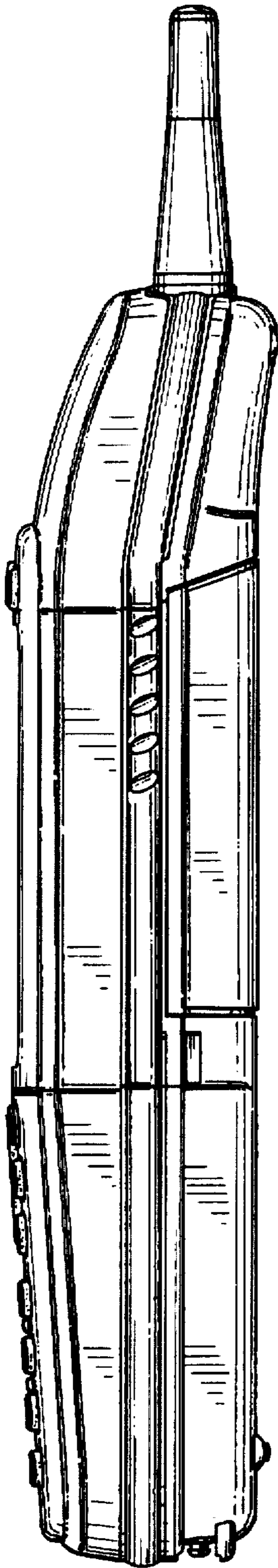

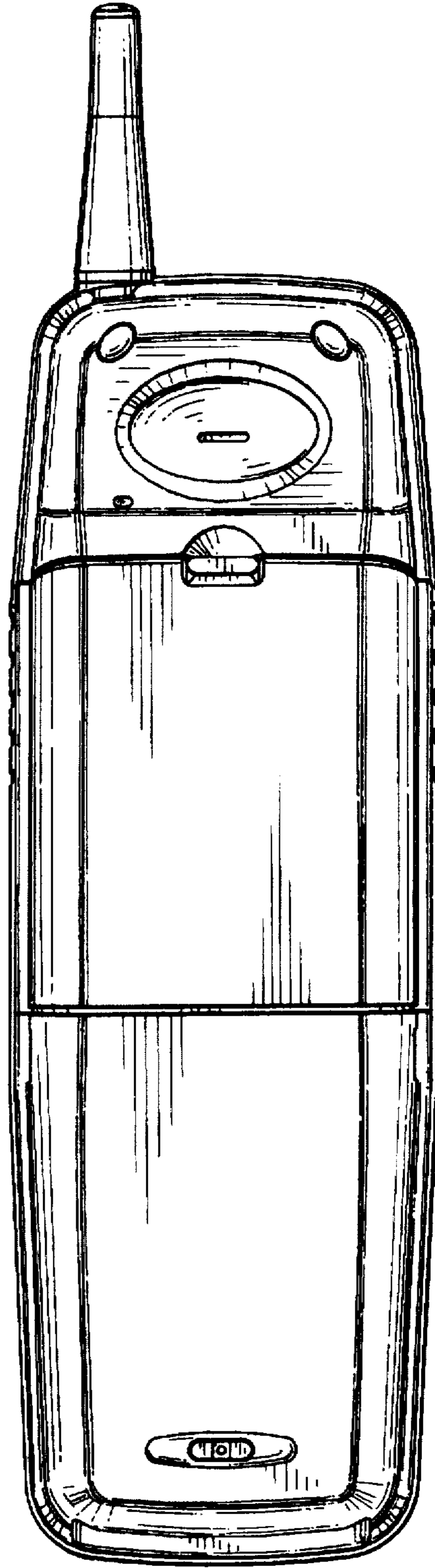

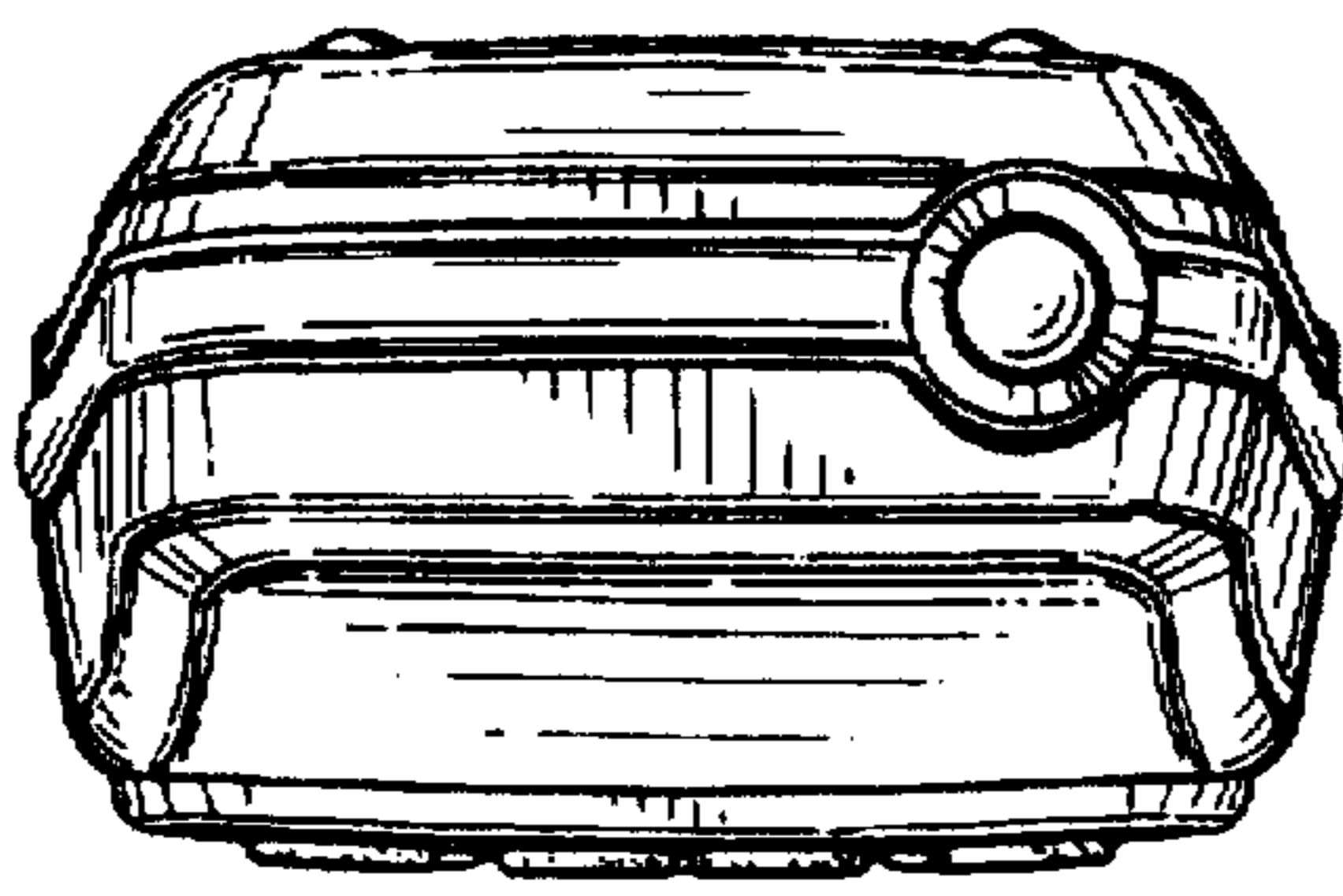

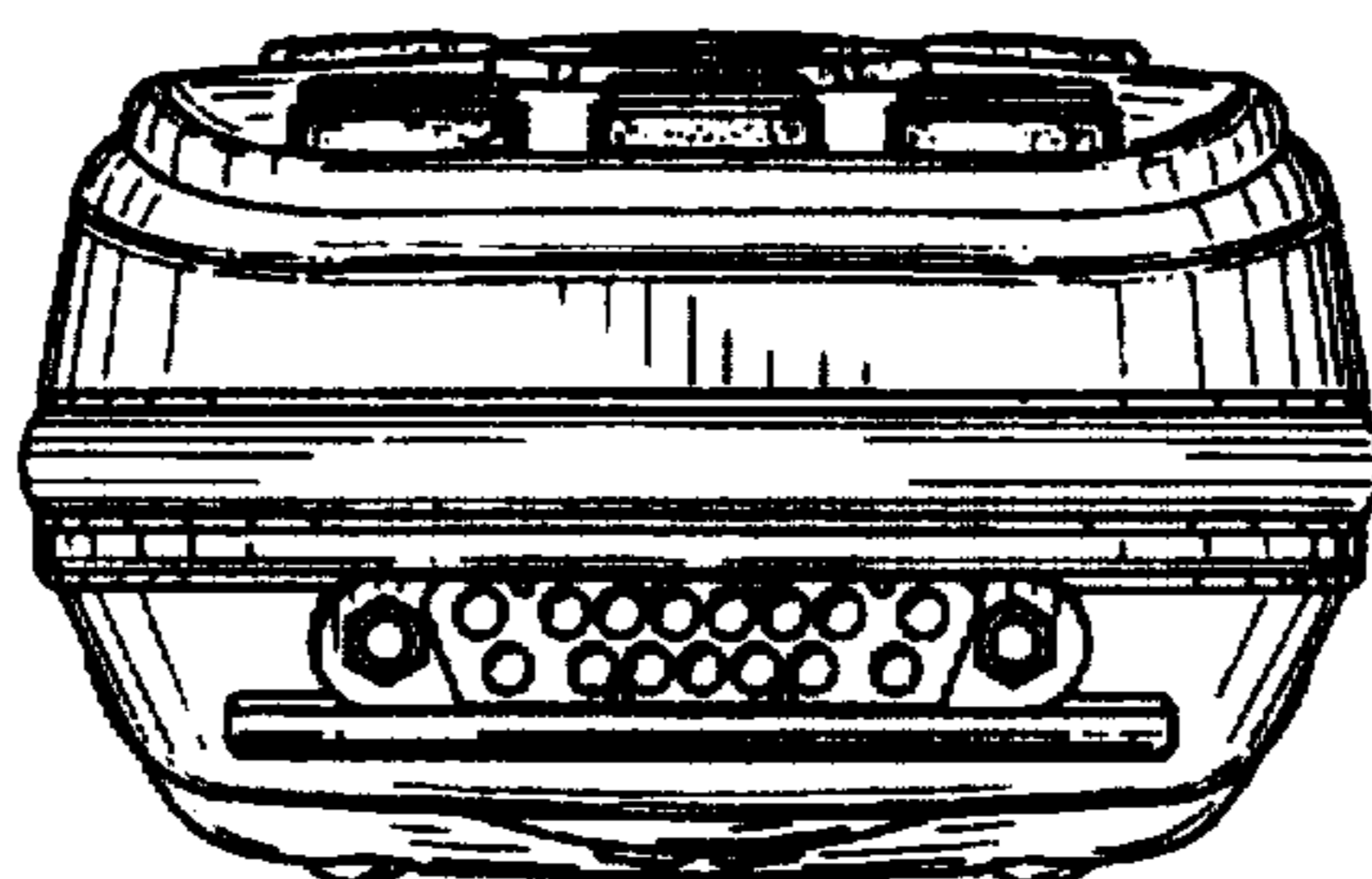
