FIG. 2 is a top plan view thereof;

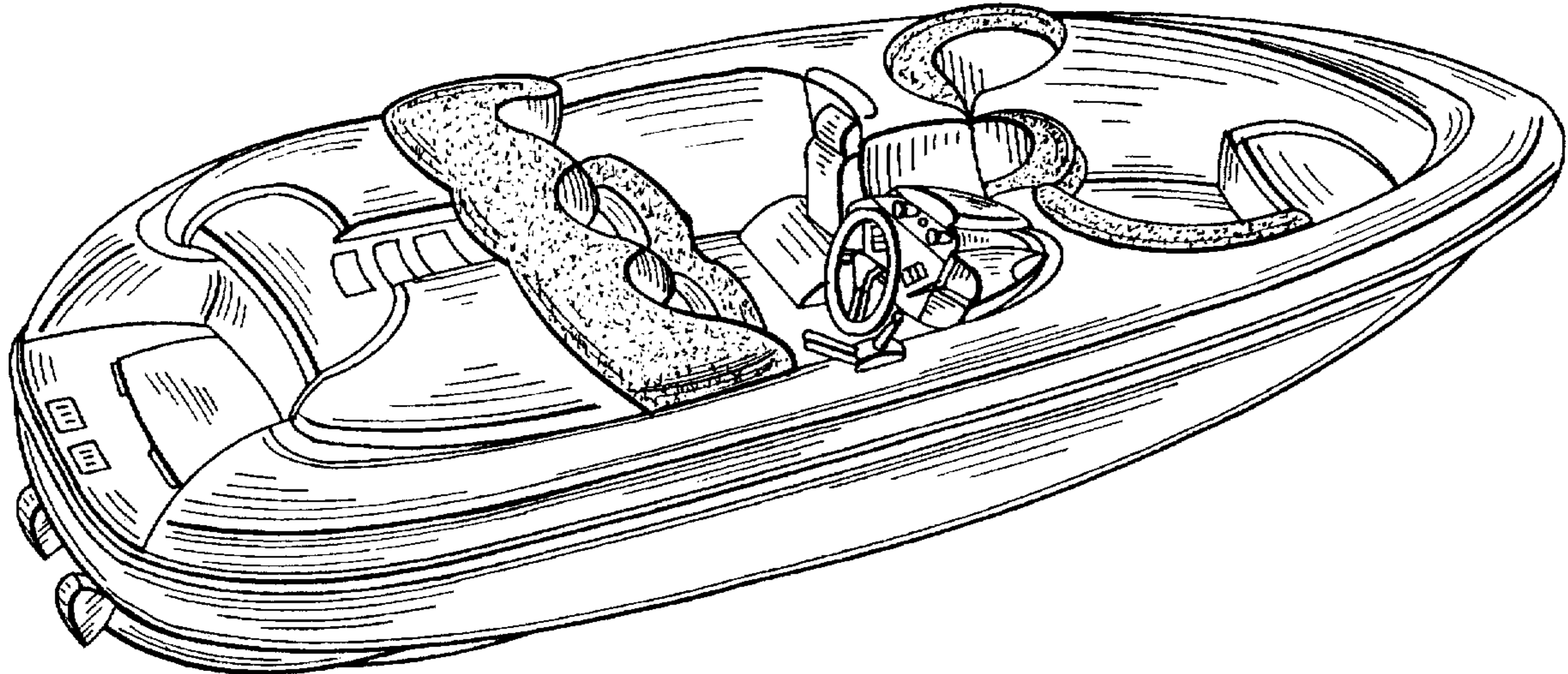
FIG. 3 is a right side plan view thereof, the left hand side plan view being a mirror image thereof;

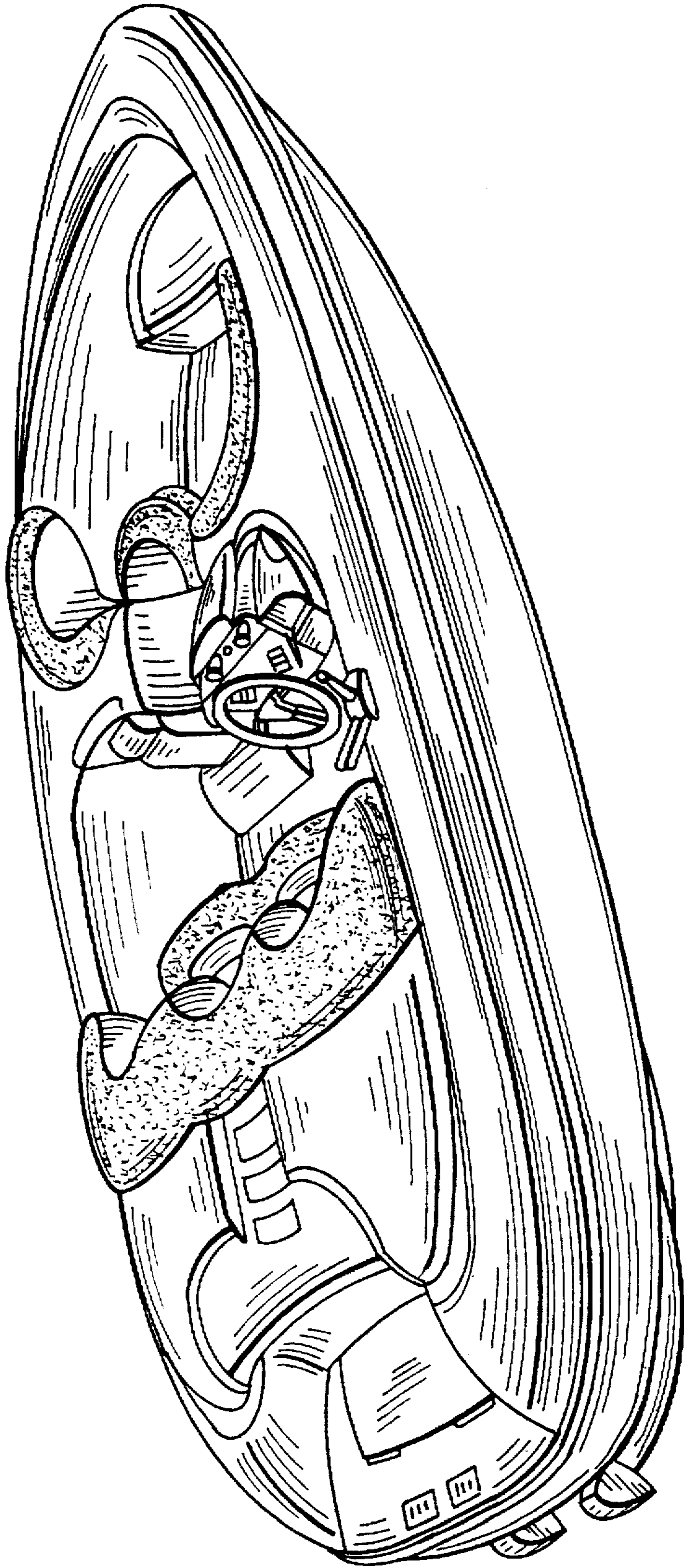

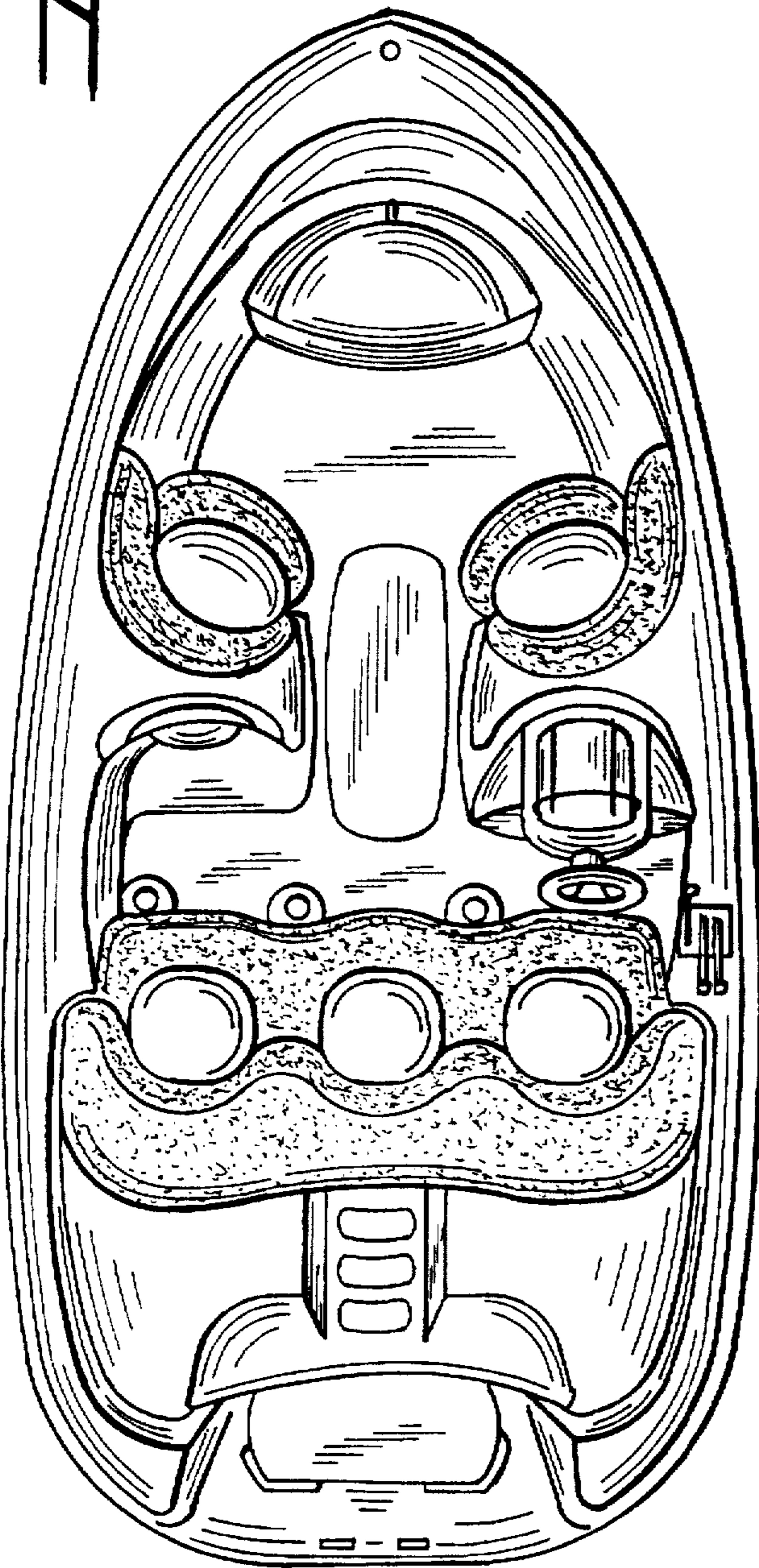

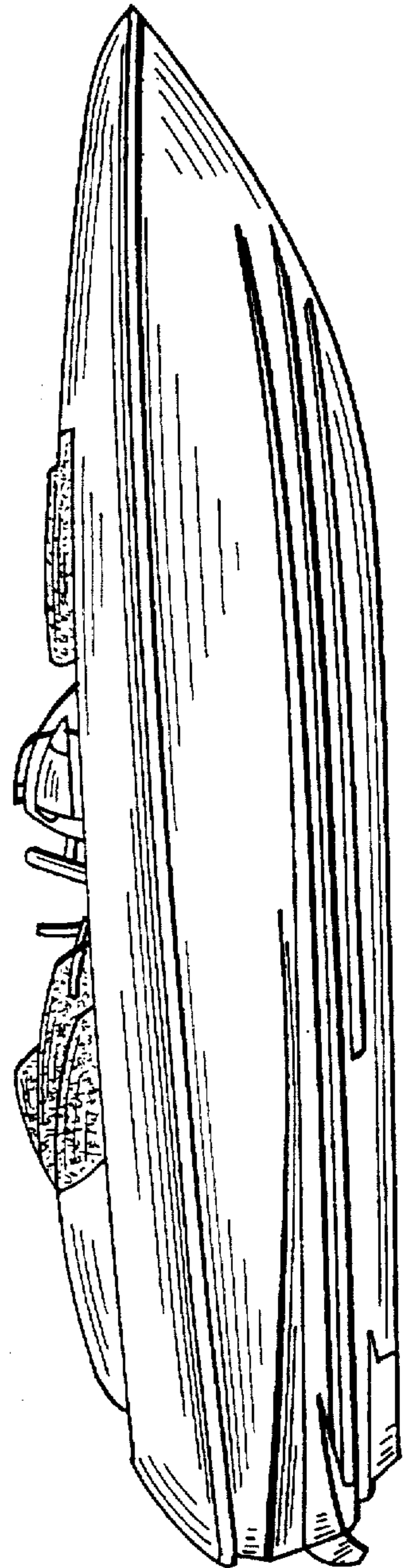

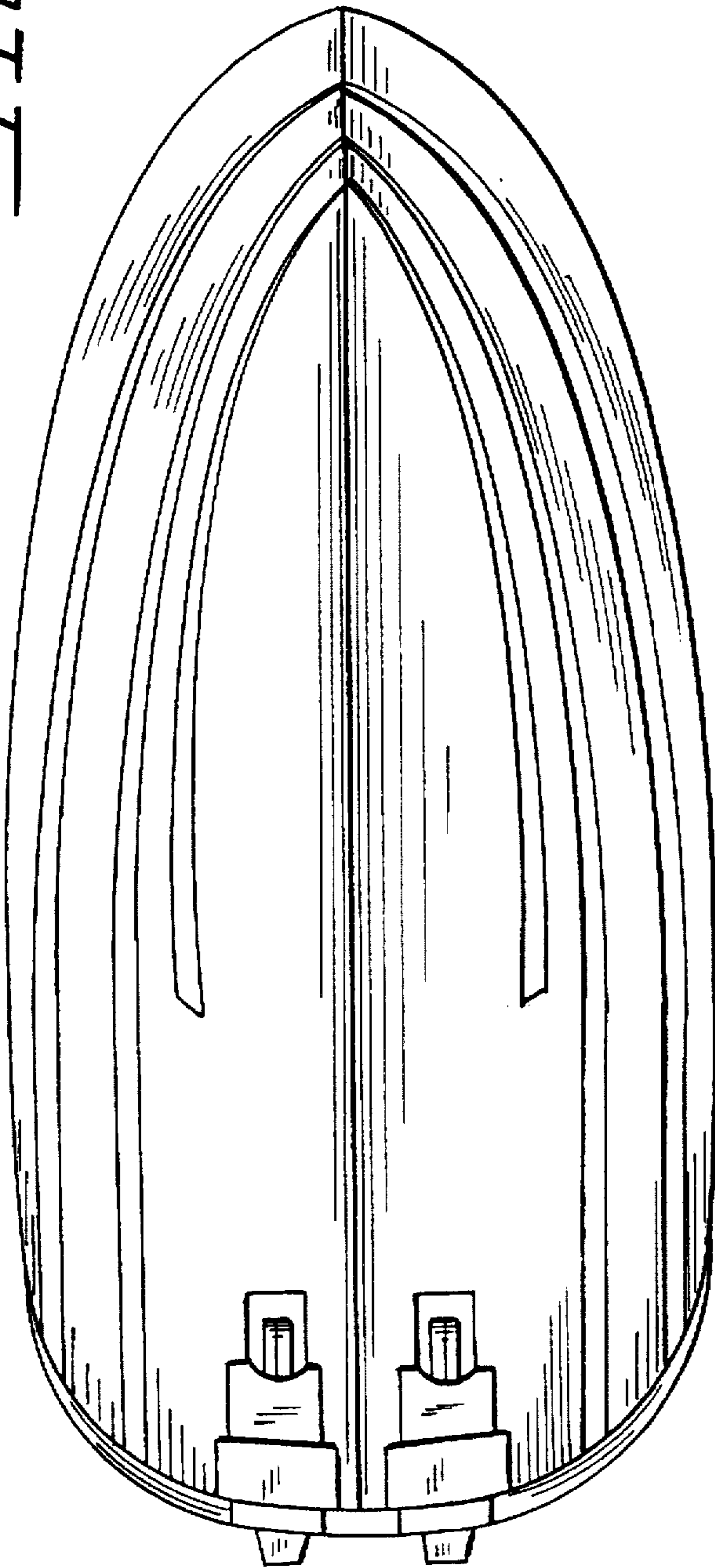

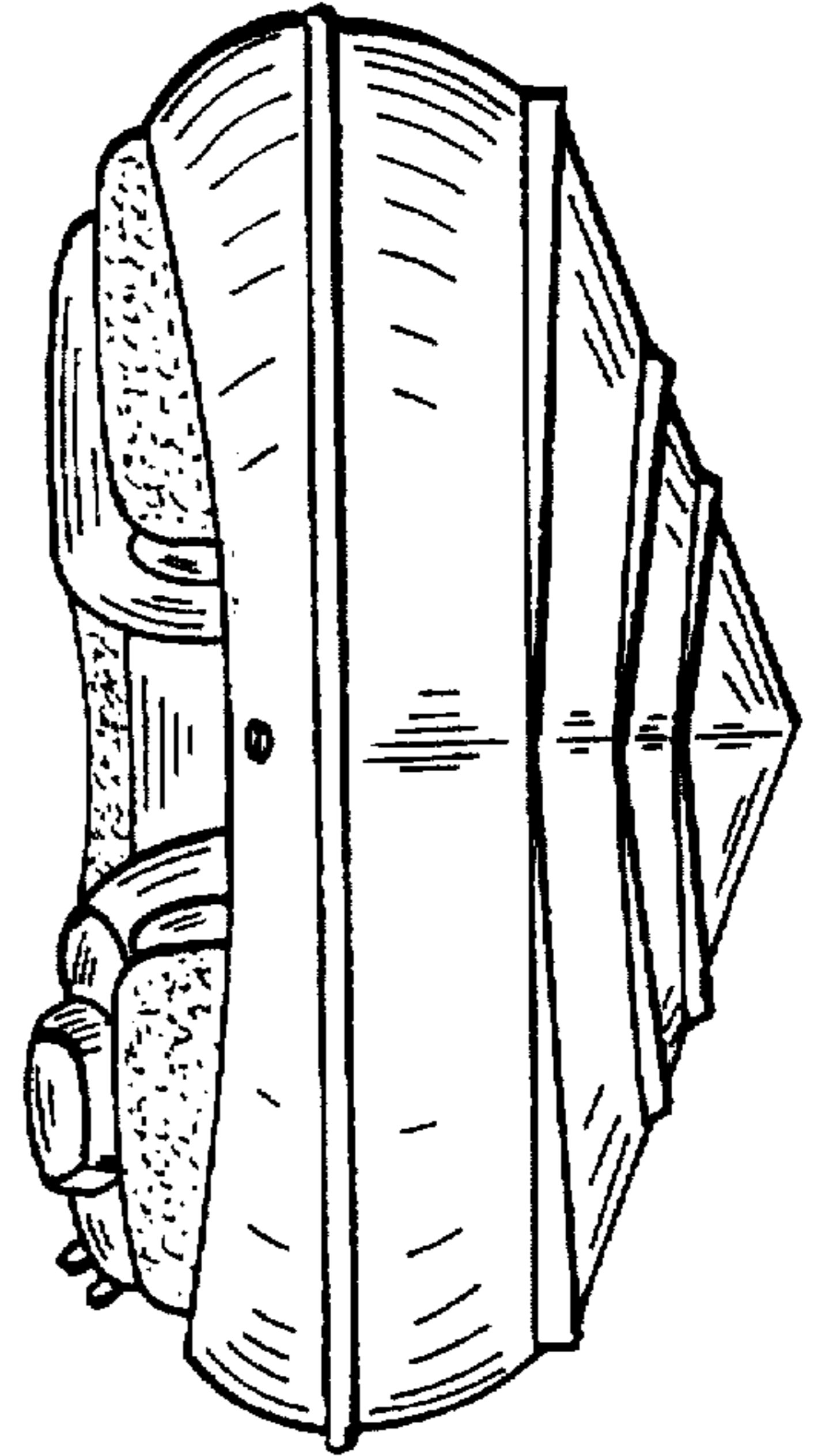
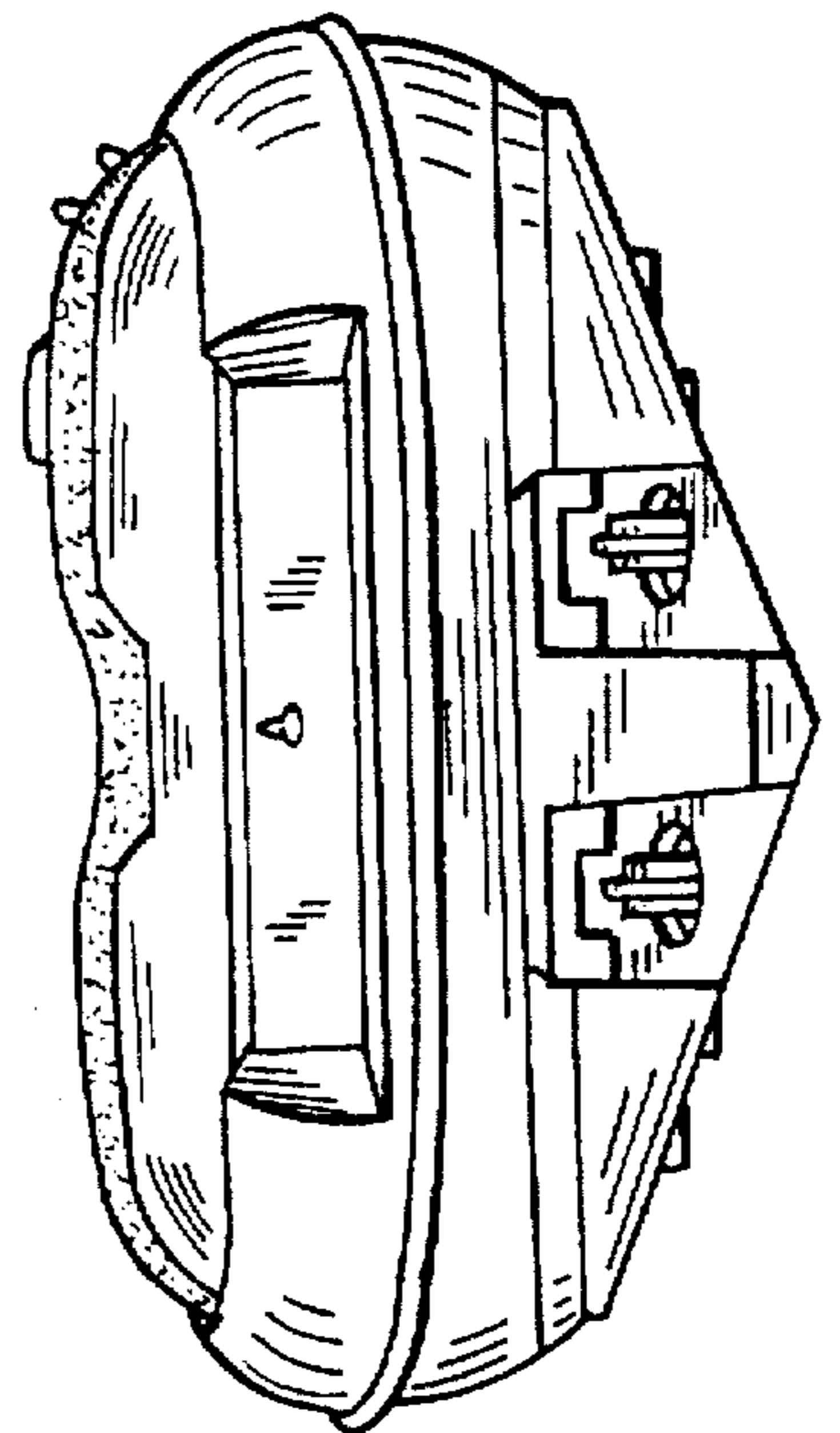
