[57] **CLAIM**

The ornamental design of a telephone stand, as shown and described.

**DESCRIPTION**

FIG. 1 is a top, front and right side perspective view of a telephone stand showing our new design; FIG. 2 is a top plan view thereof; FIG. 3 is a bottom plan view thereof; FIG. 4 is a front elevation thereof; FIG. 5 is a right side elevation thereof; FIG. 6 is a left side elevation thereof; and, FIG. 7 is a rear elevation thereof.

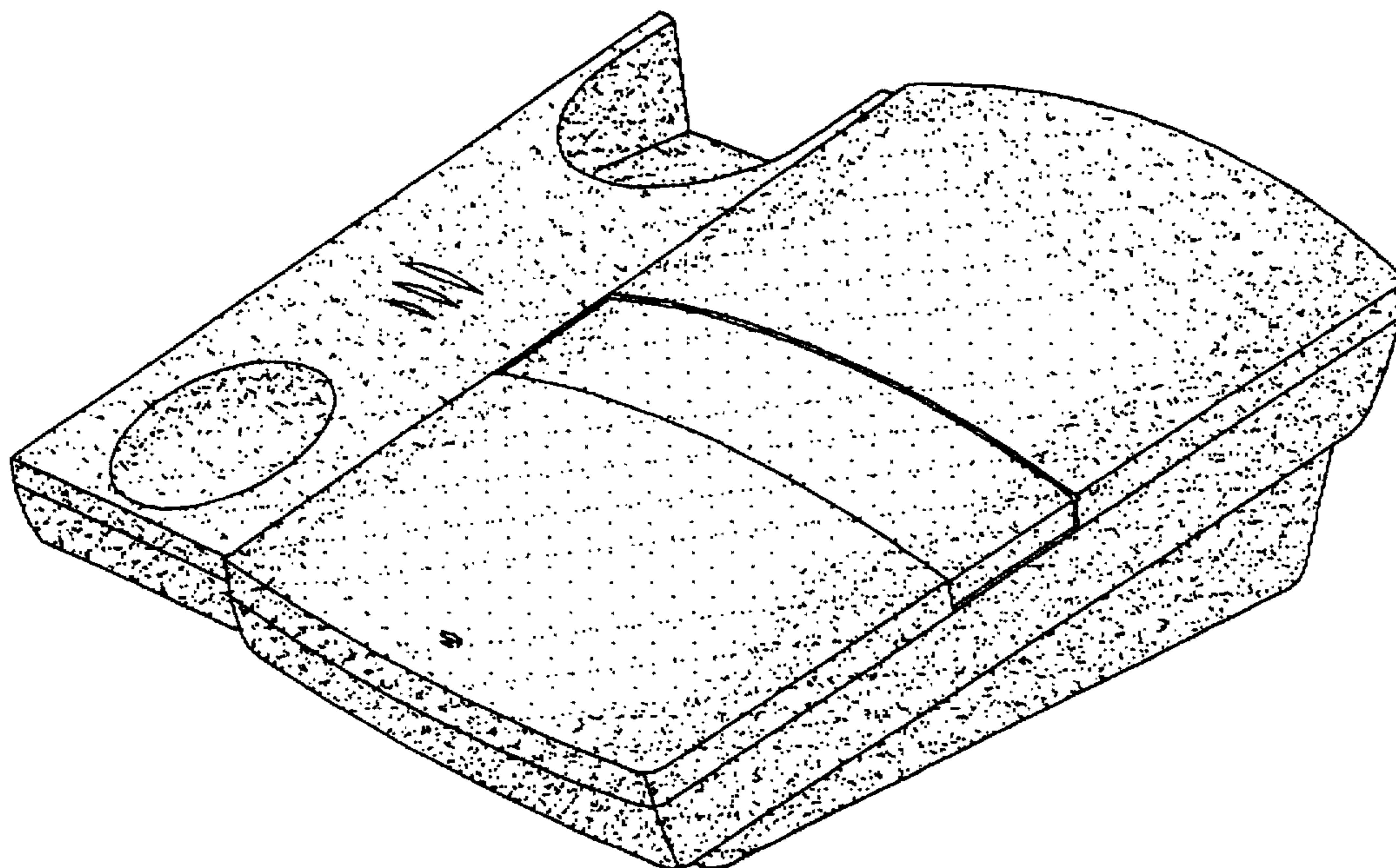

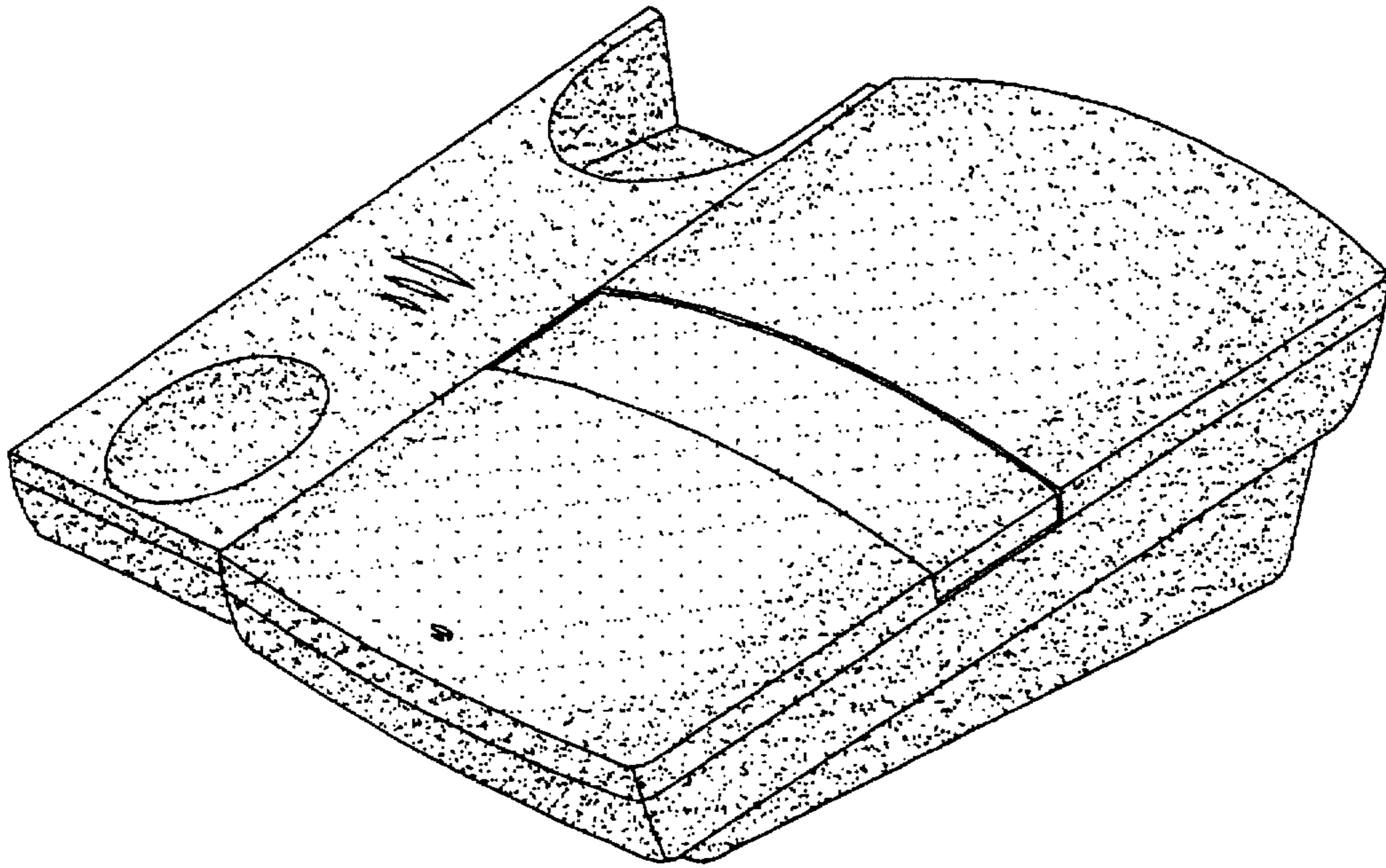
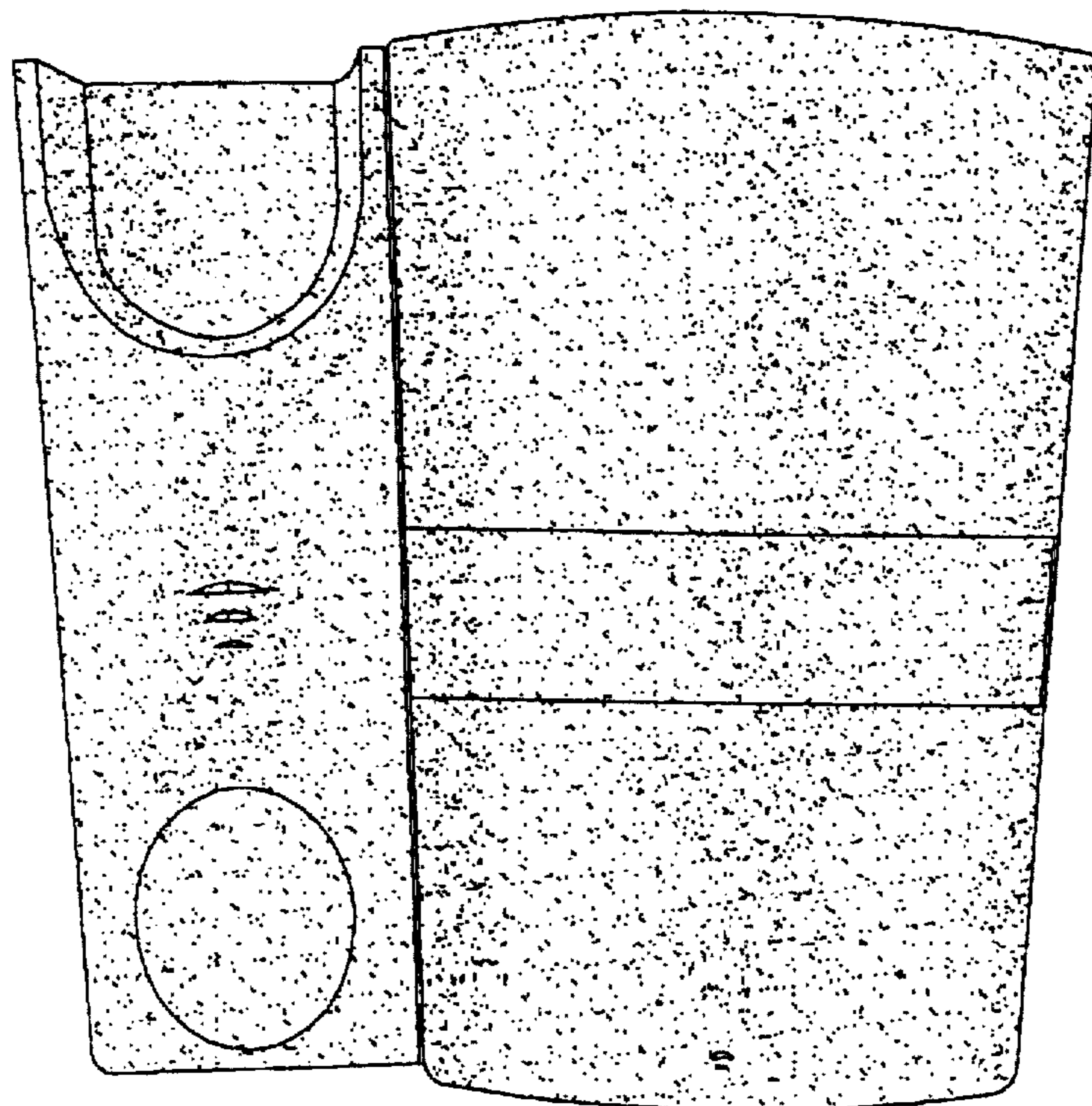
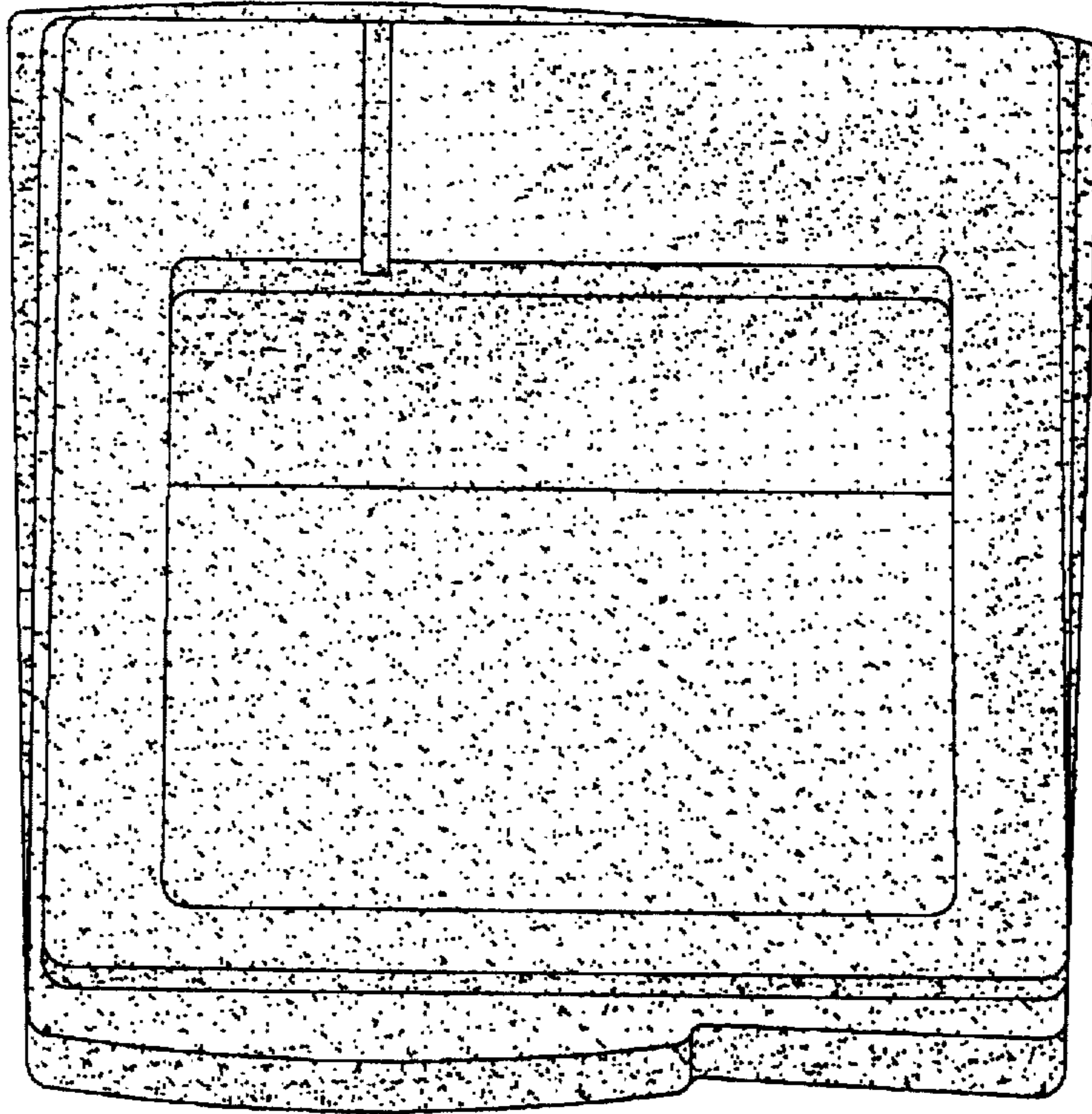

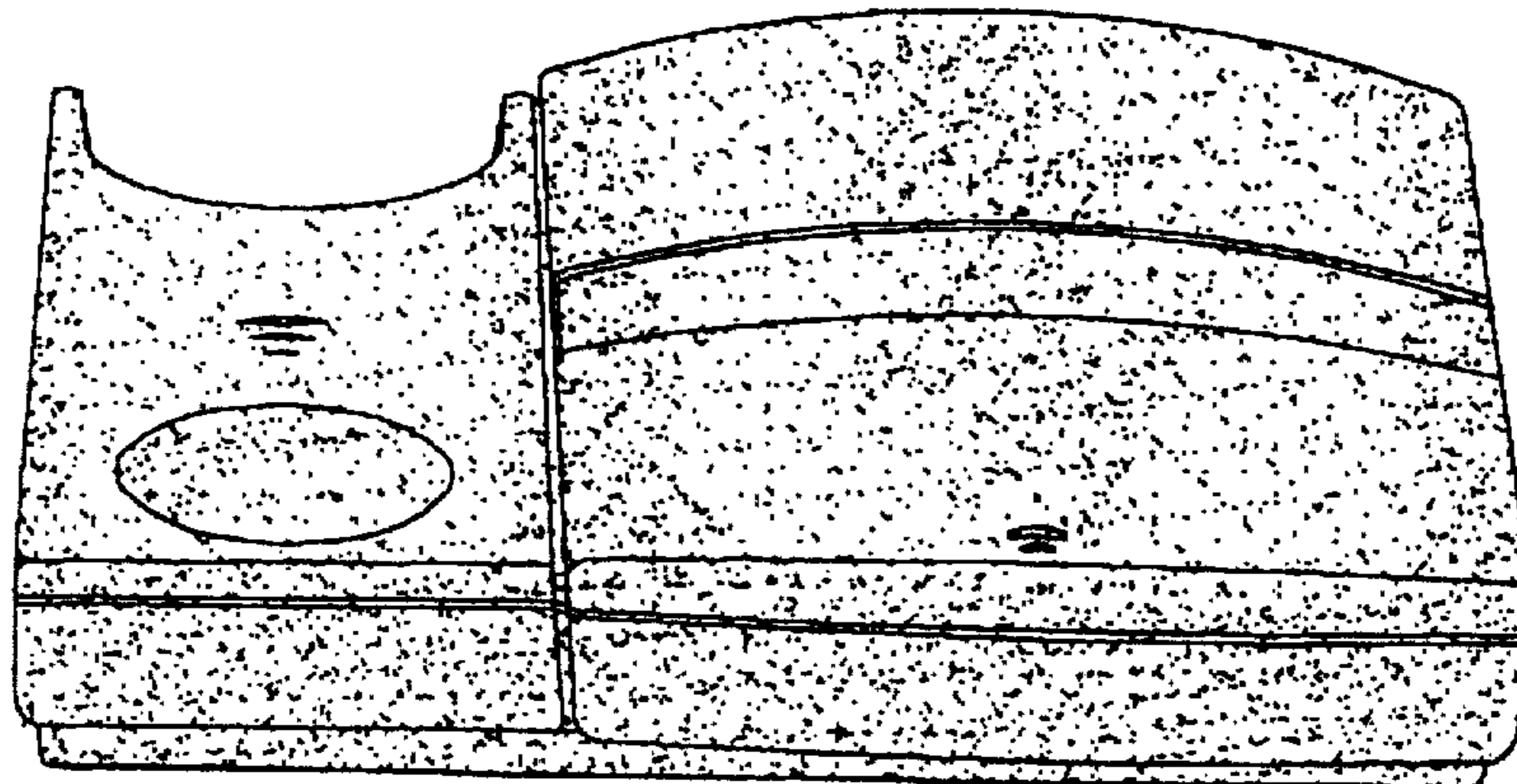




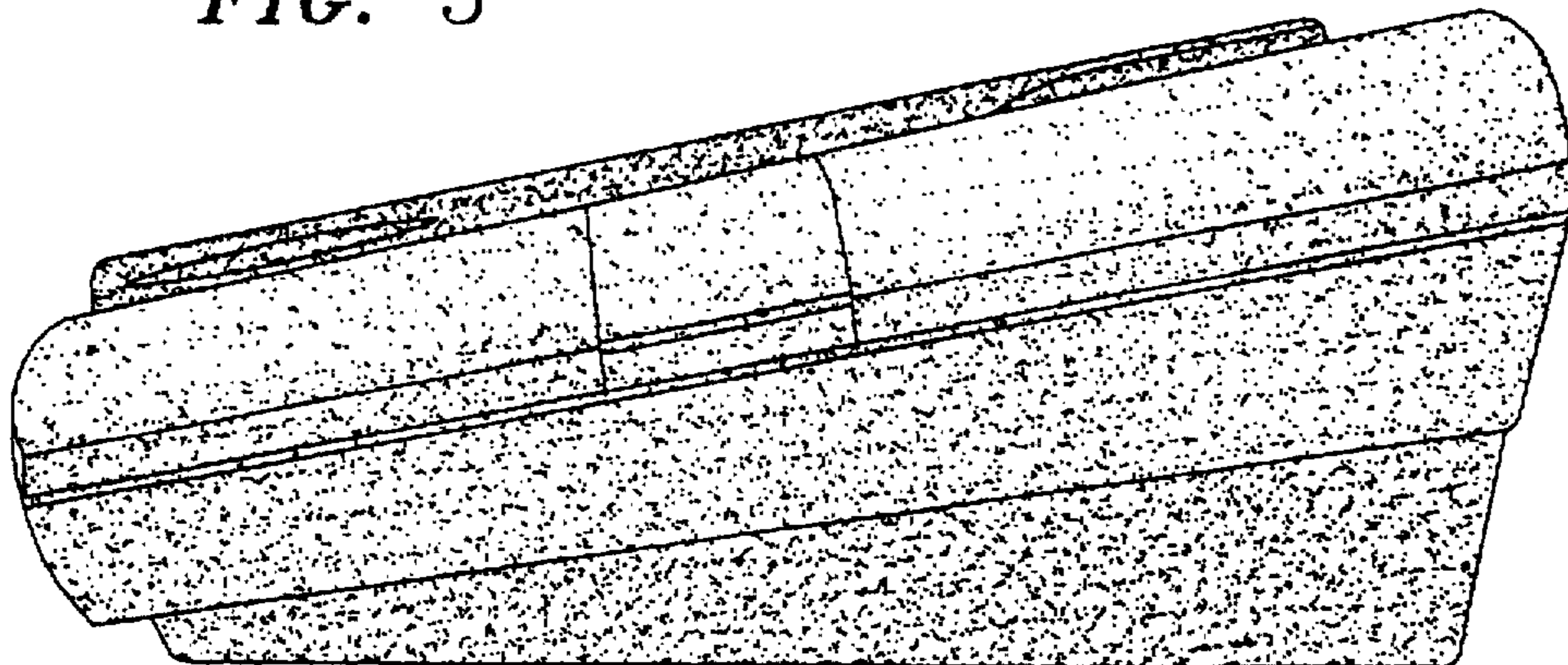

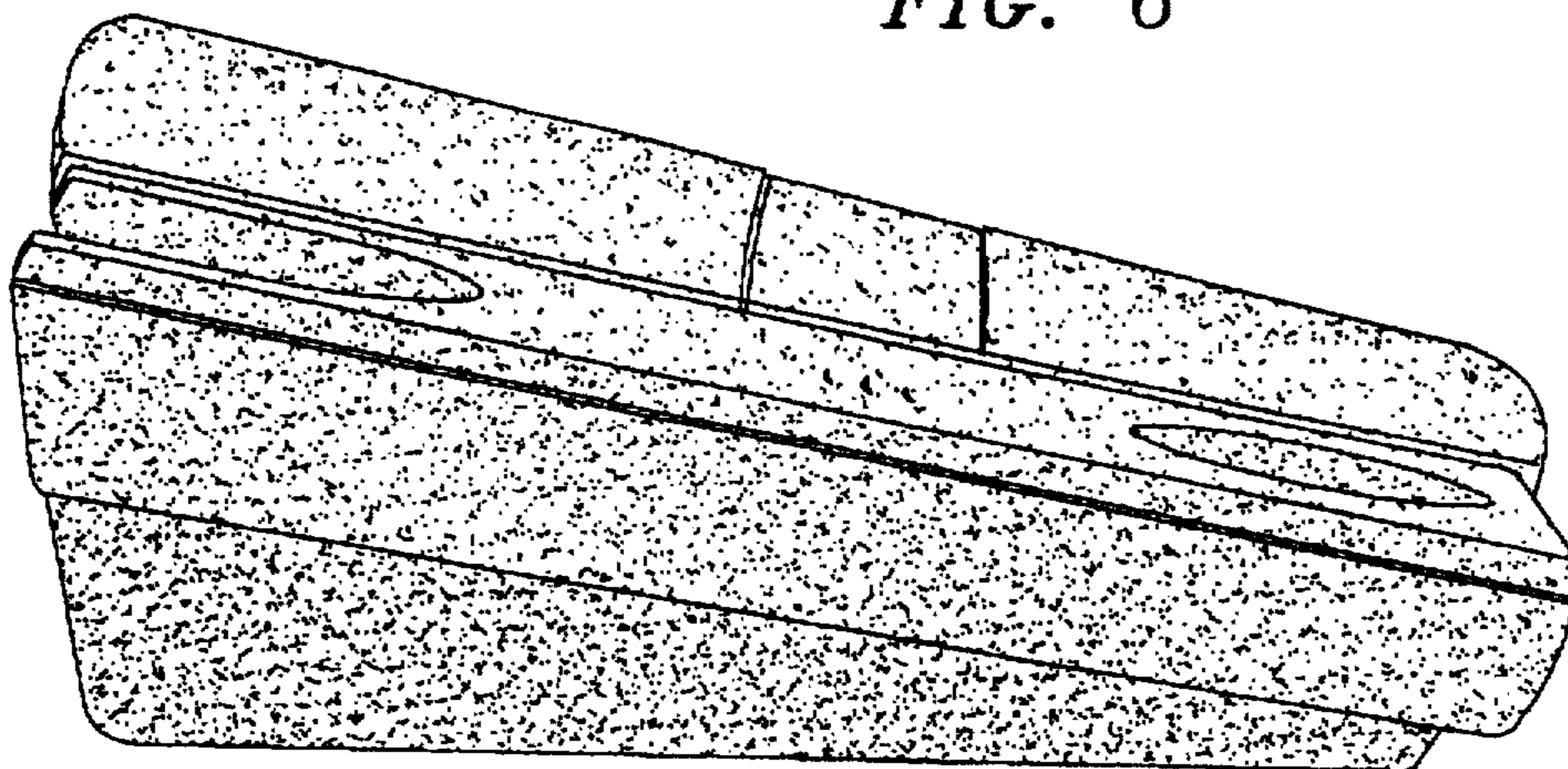
