**DESCRIPTION**

FIG. 1 is a perspective view of a portion of a shoe upper showing my new design;

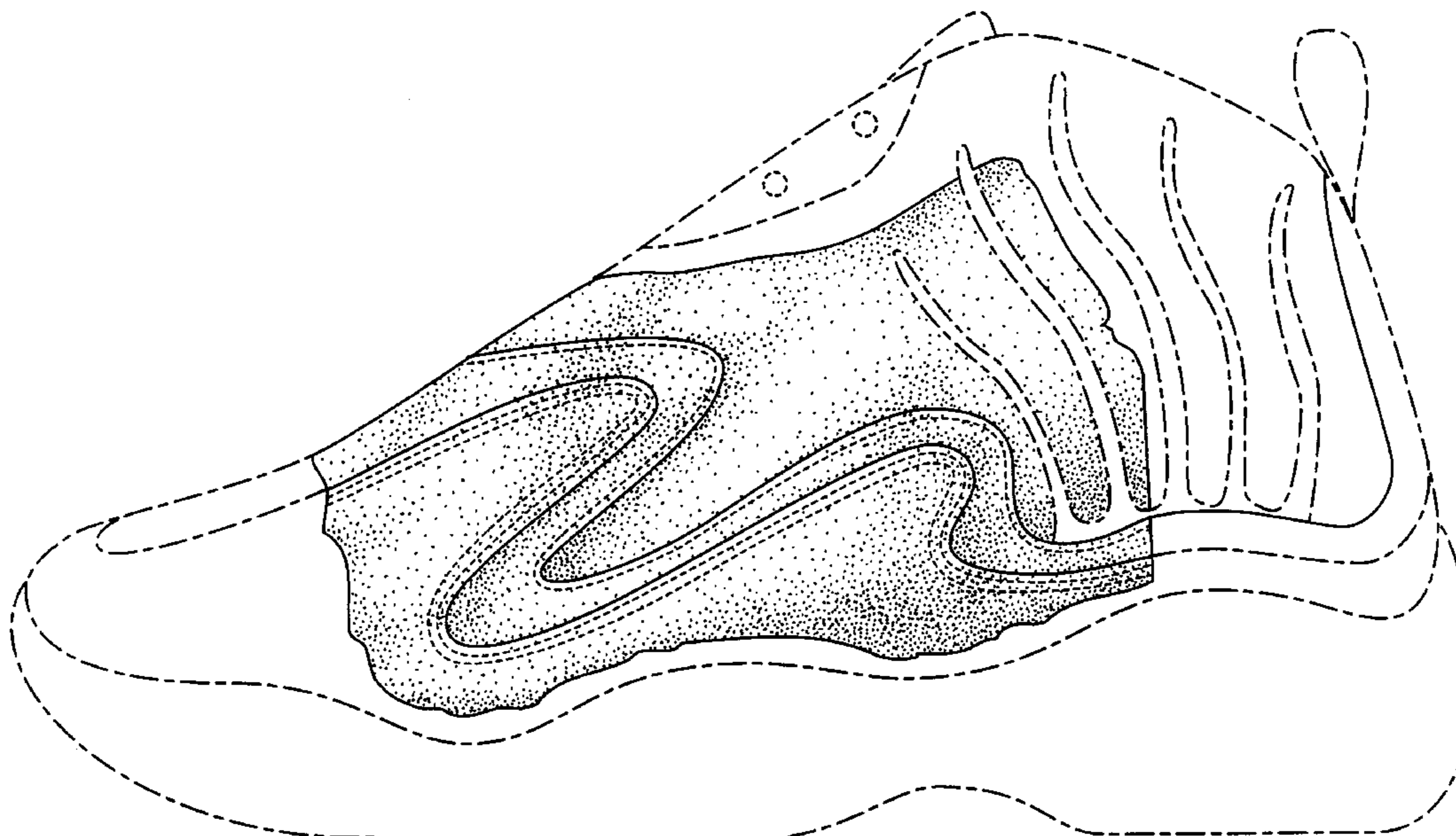
FIG. 2 is a side elevational view the portion of a shoe upper shown in FIG. 1;

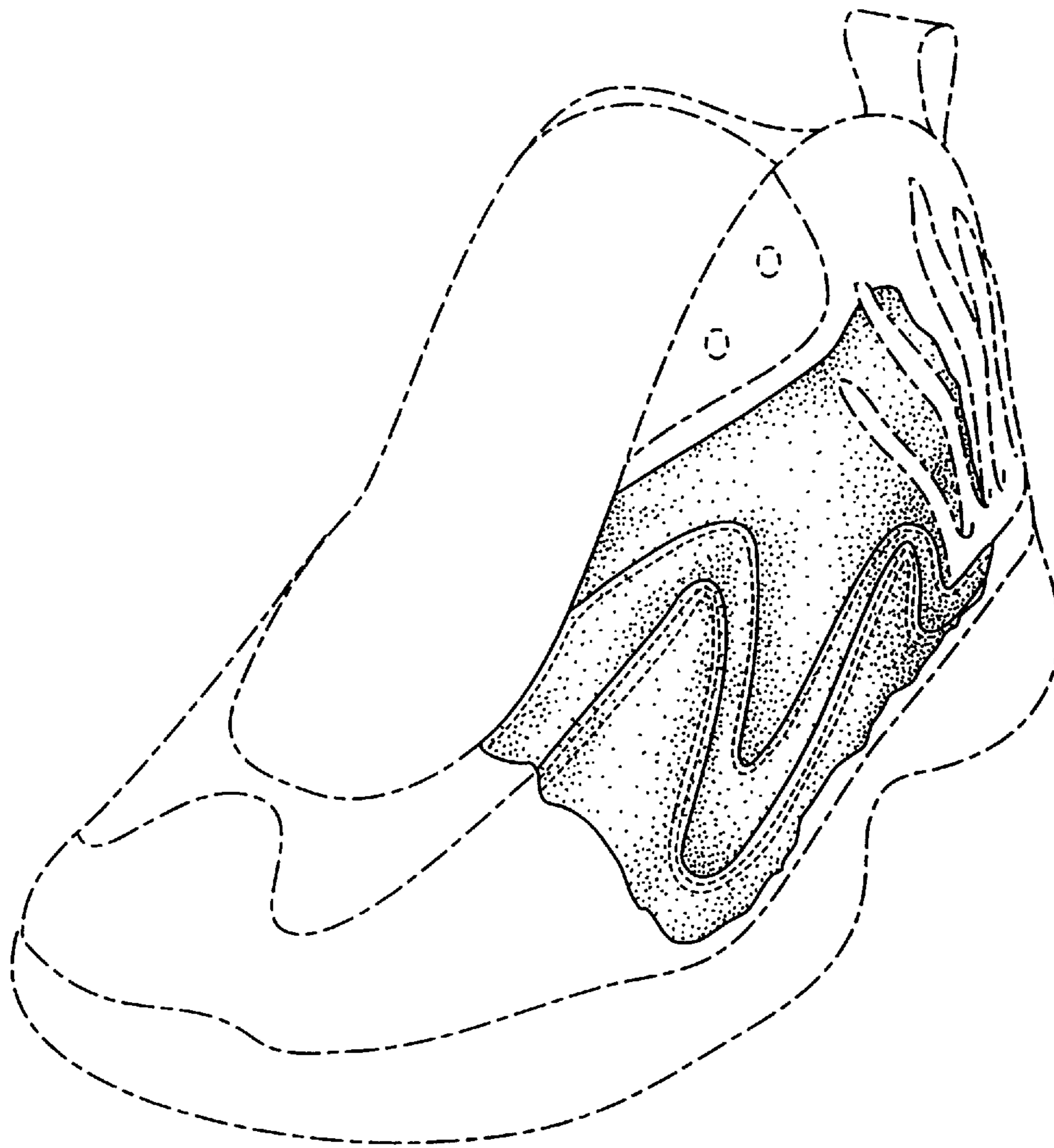

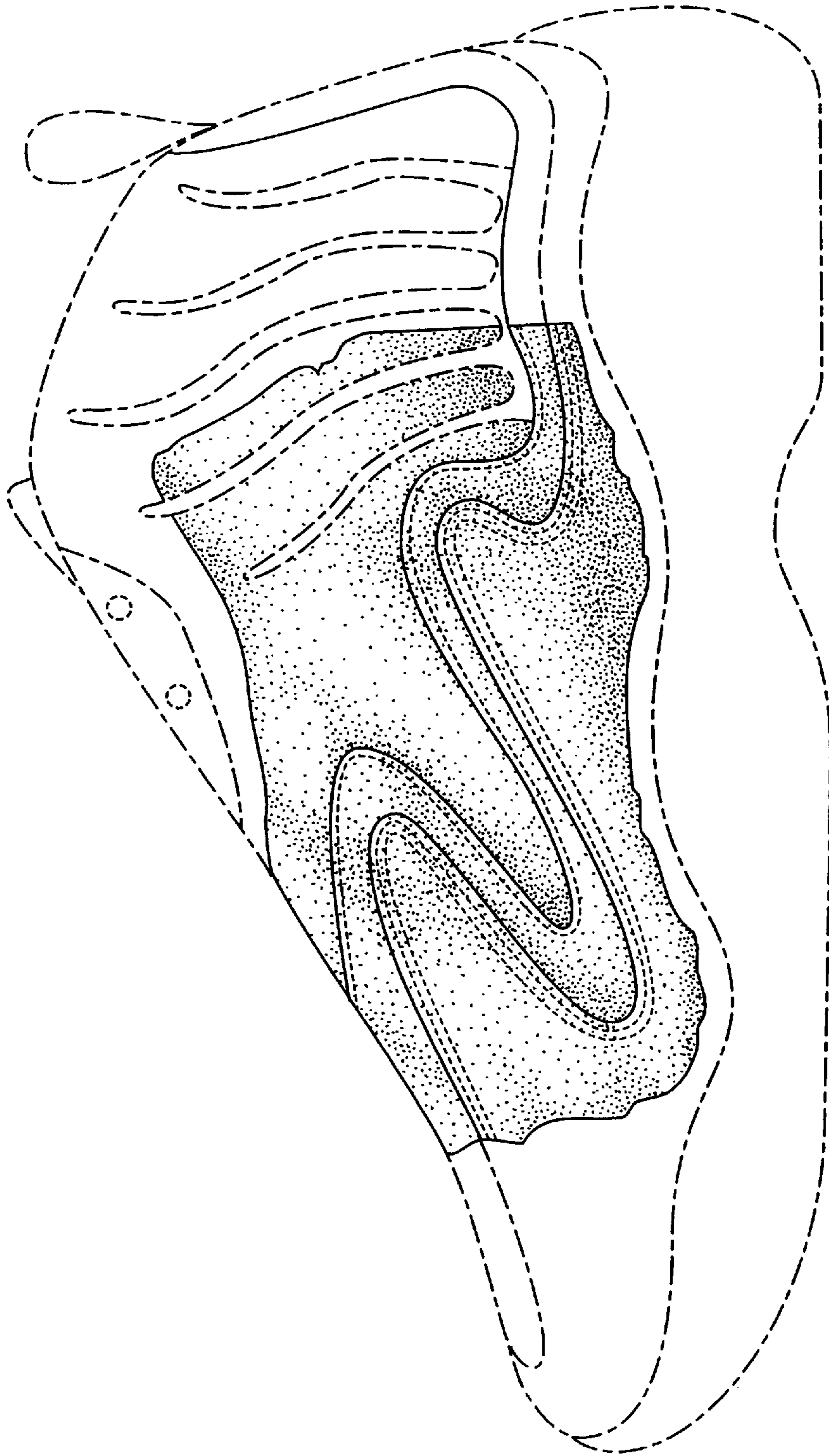

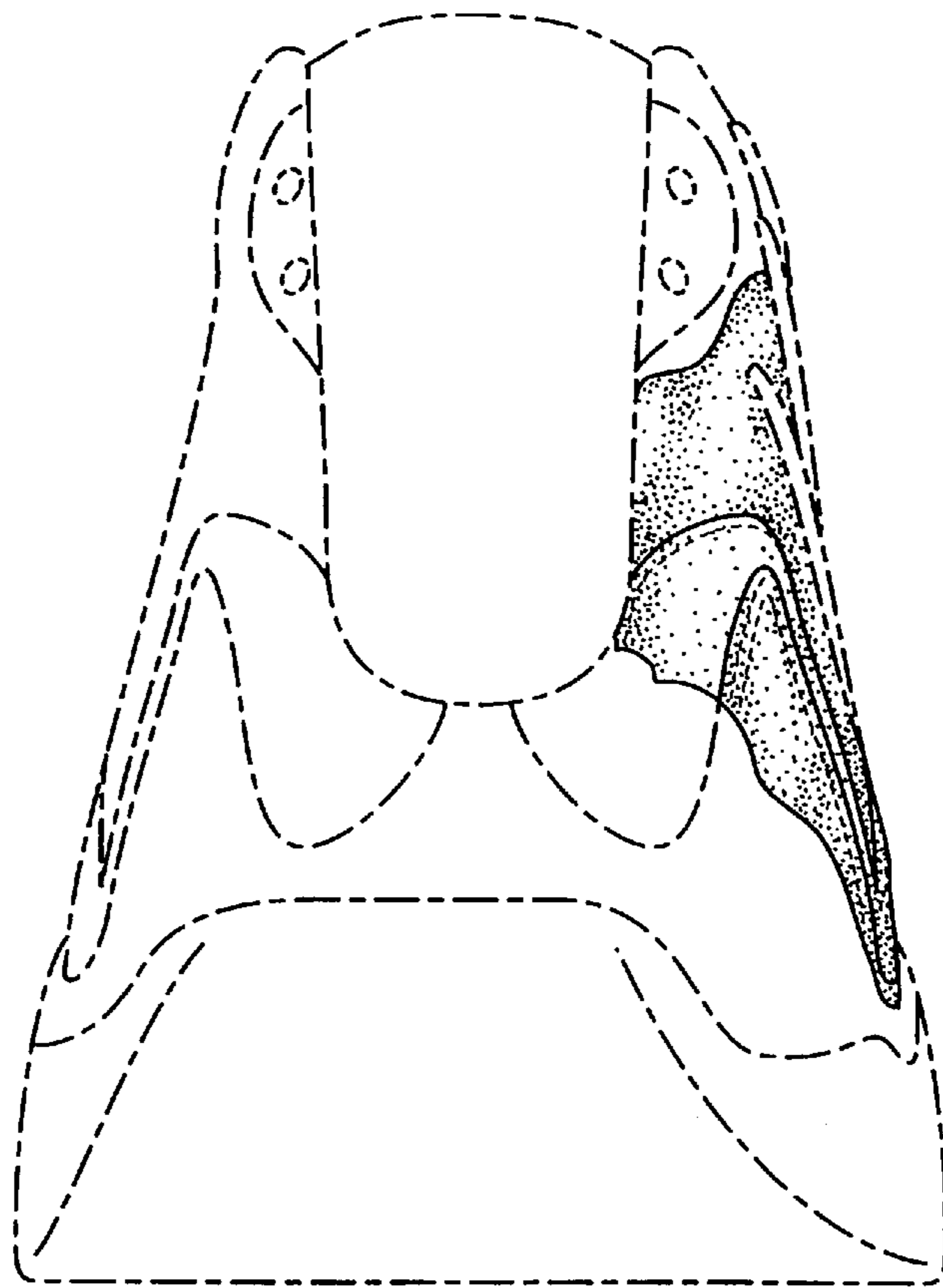

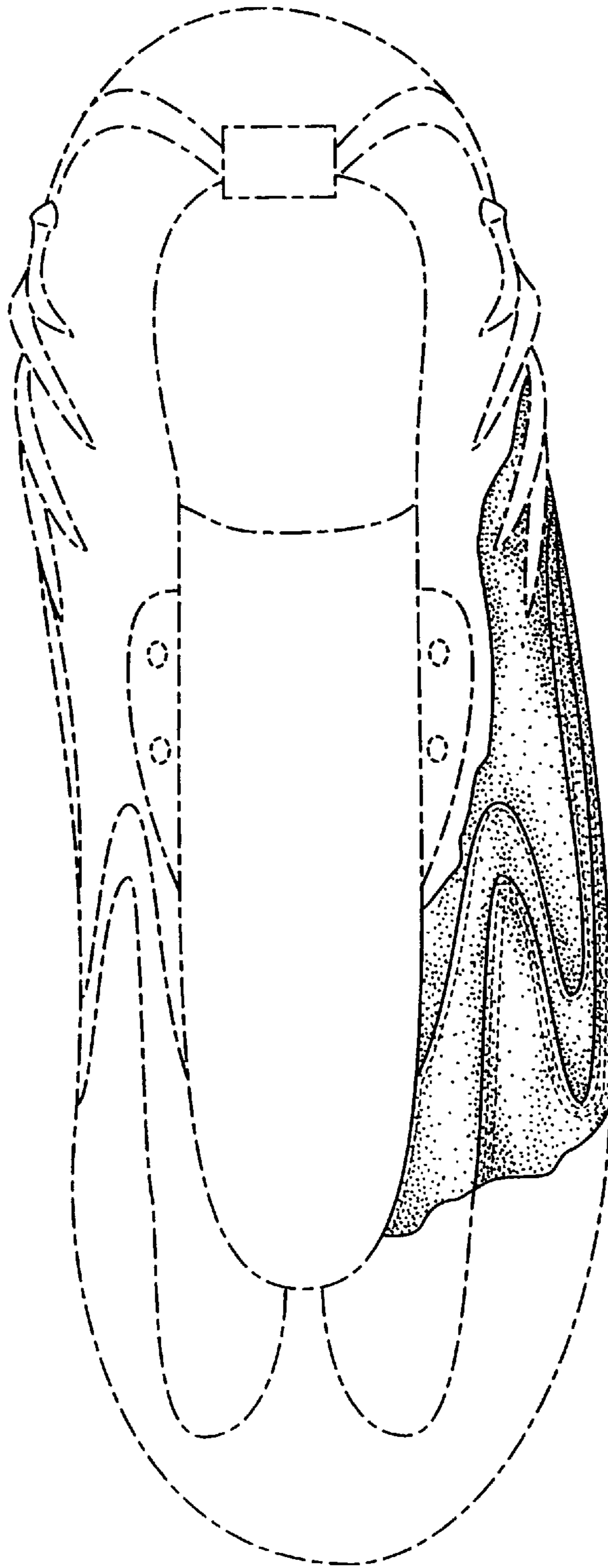
