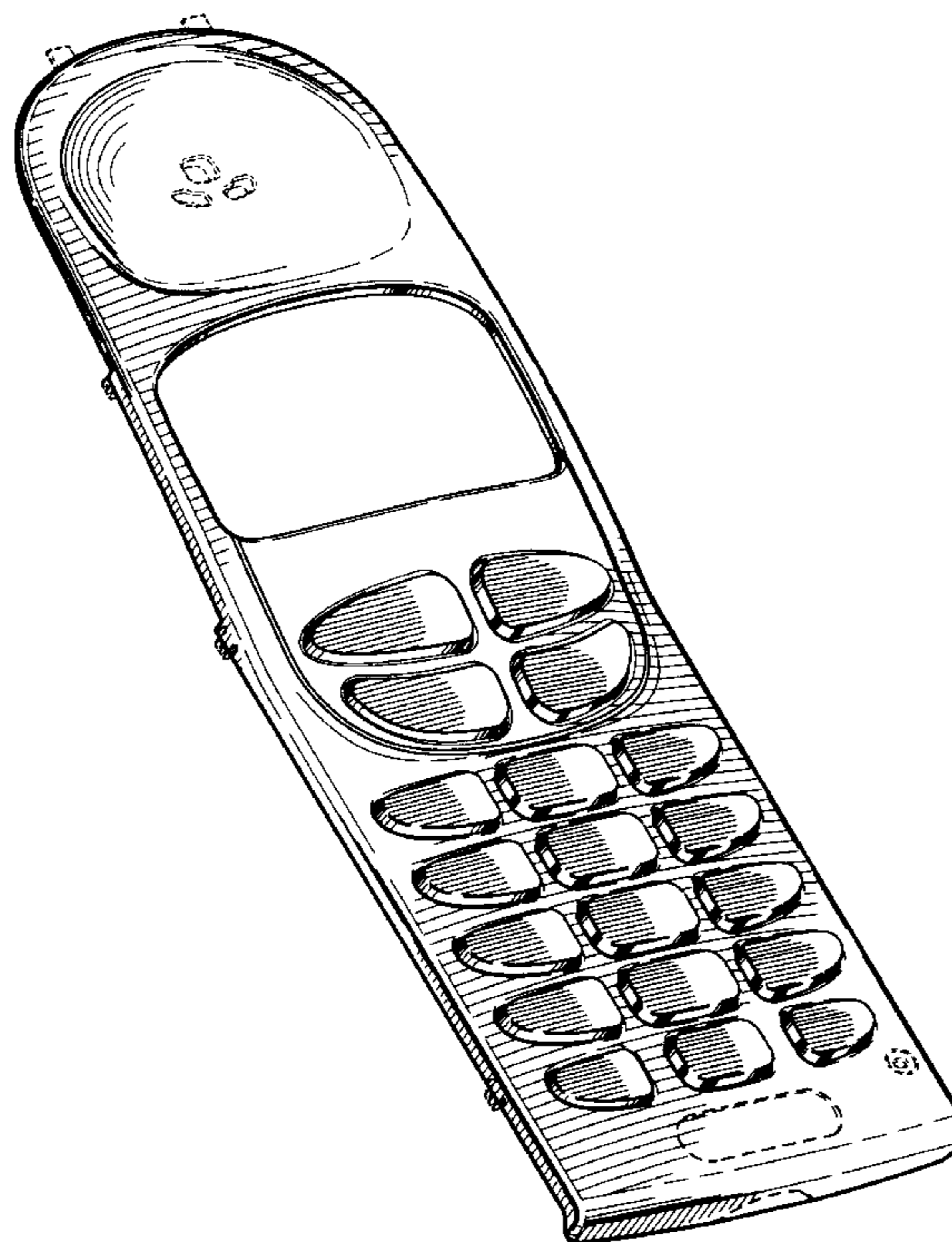
[57] CLAIM

The ornamental design for a faceplate for a portable telephone, as shown and described.

DESCRIPTION

FIG. 1 is a left, front, bottom view of a faceplate for a portable telephone showing our new design; FIG. 2 is a top plan view thereof; FIG. 3 is a rear plan view thereof; and, FIG. 4 is a right side plan view thereof. The broken lines shown in FIGS. 1-4 are for illustrative purposes only and form no part of the claimed design.

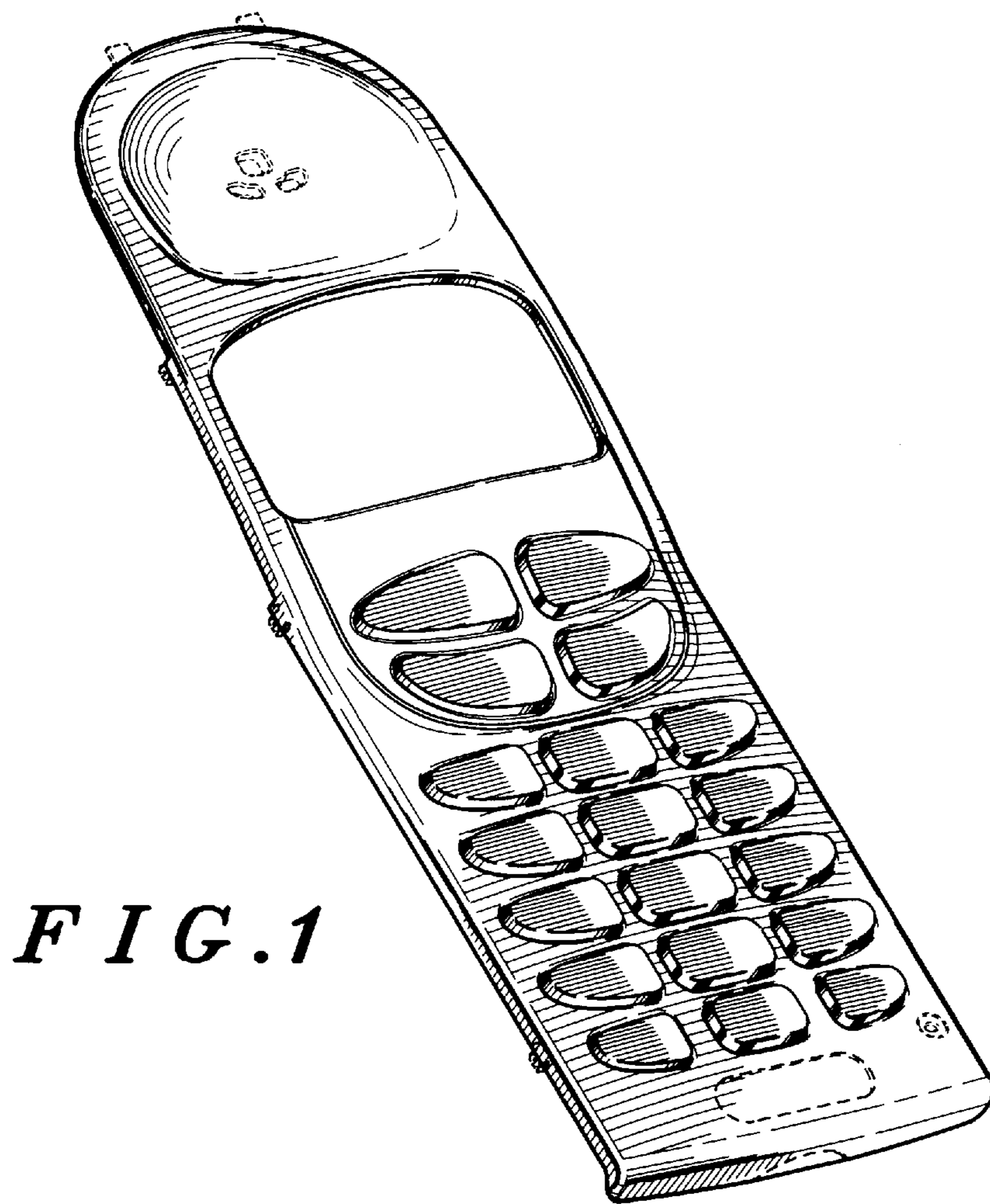

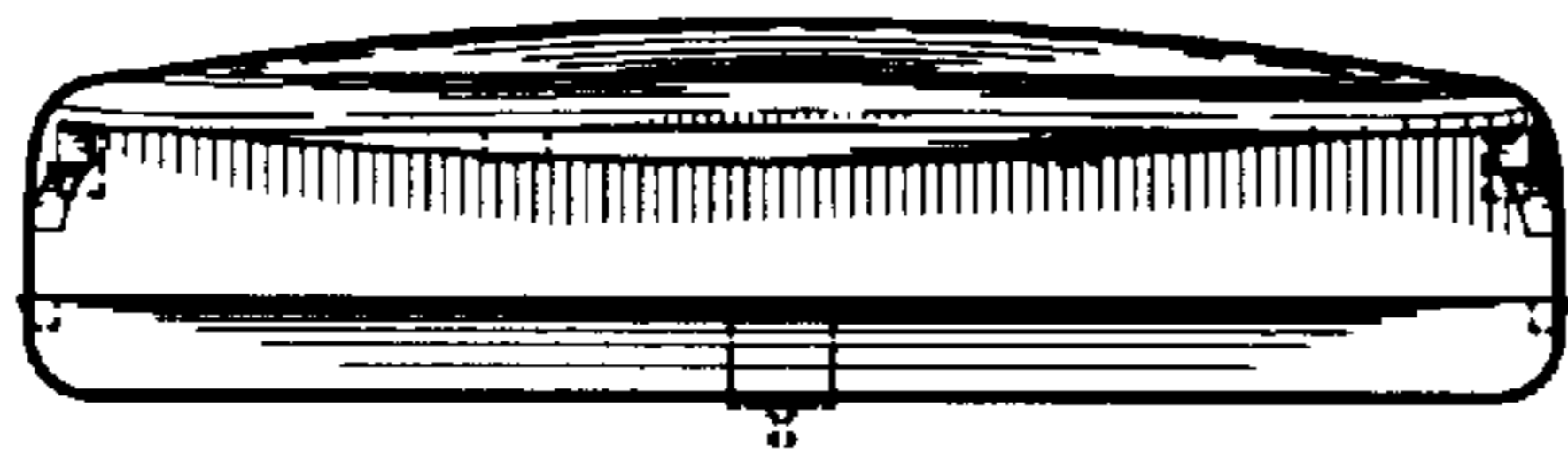

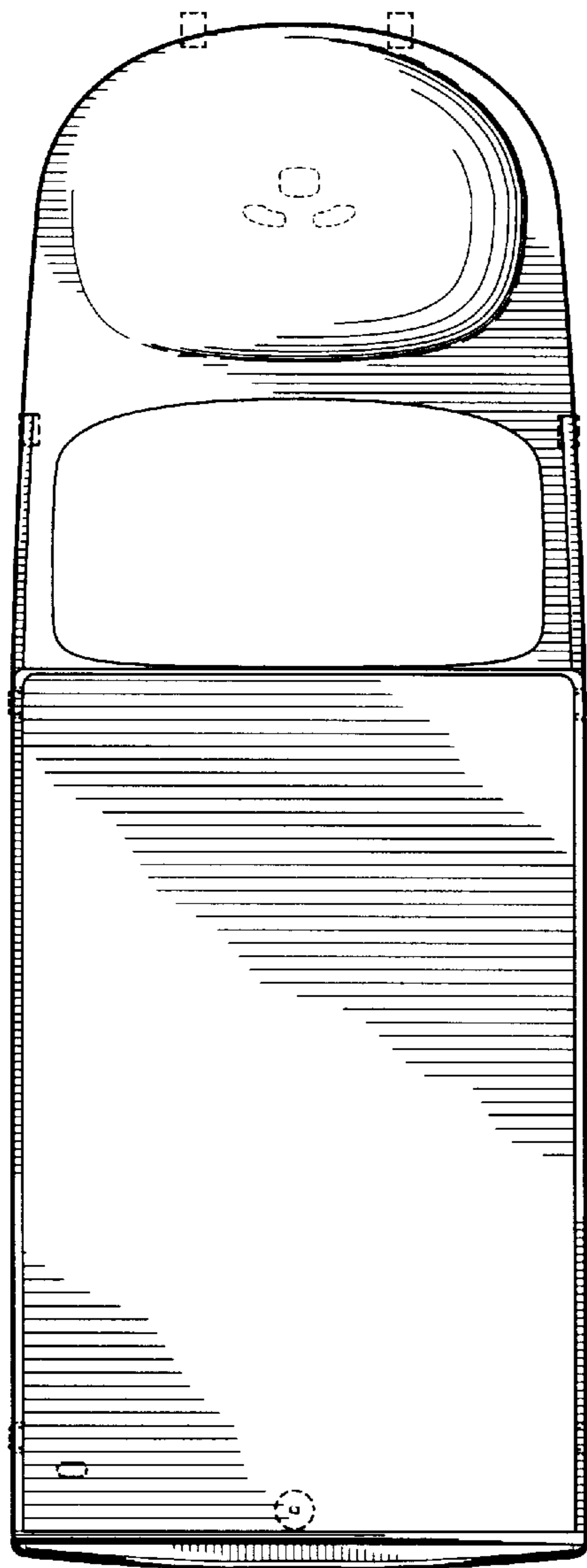

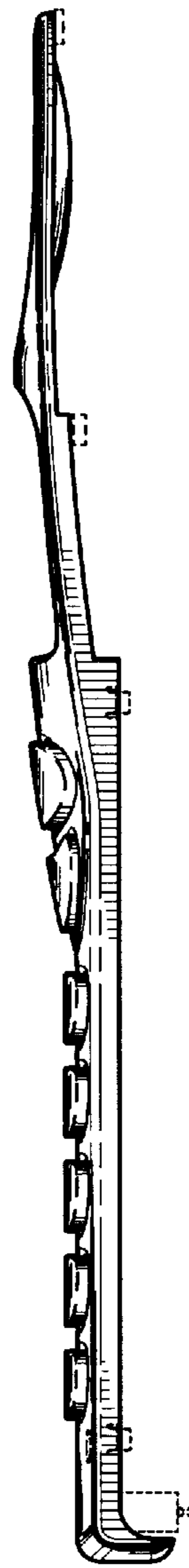
