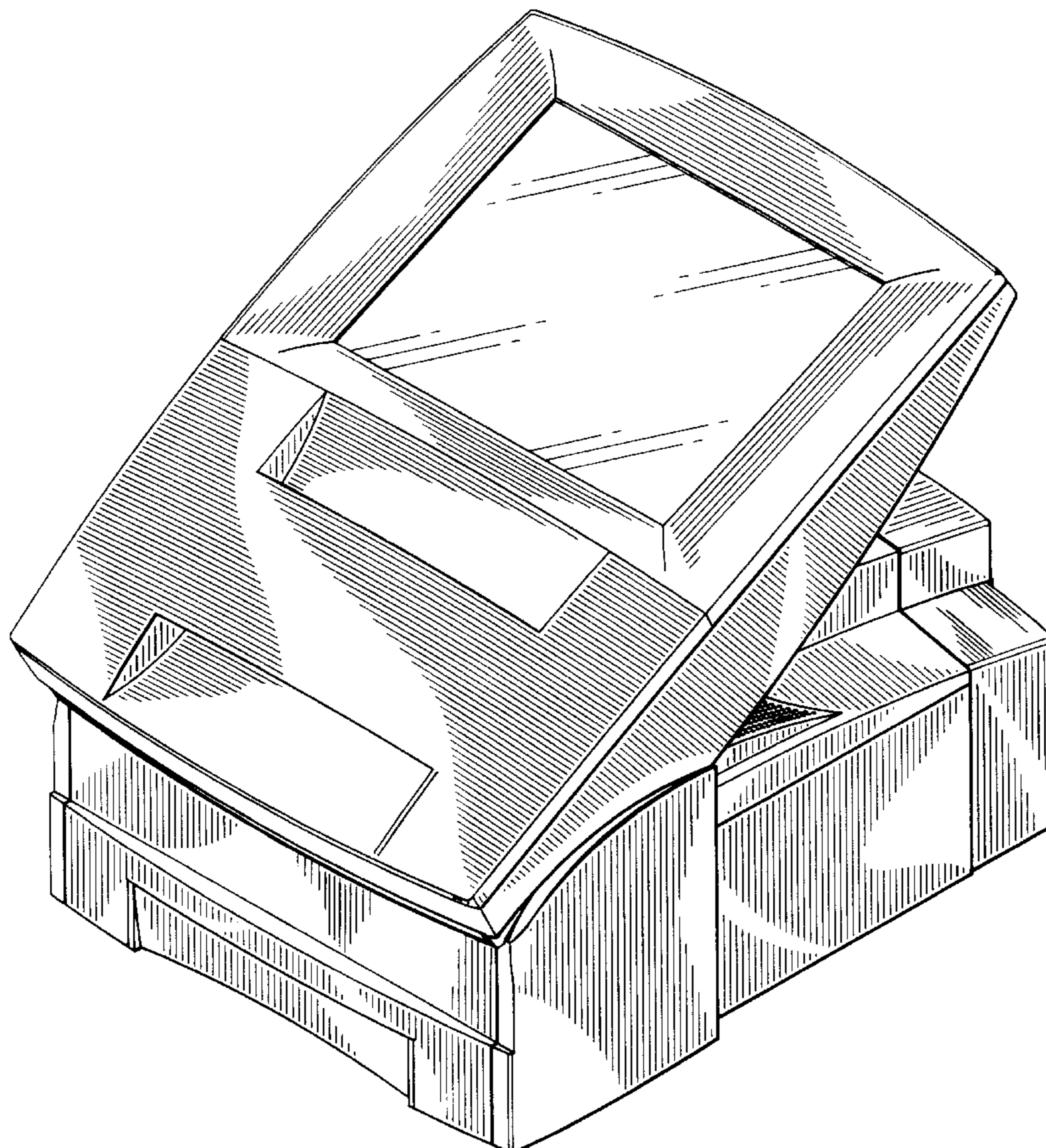
## [57] CLAIM

The ornamental design for a gaming terminal, as shown and described.

## DESCRIPTION

FIG. 1 is a perspective view of a gaming terminal embodying the new design;  
FIG. 2 is a front elevational view of the gaming terminal of FIG. 1;  
FIG. 3 is a back elevational view of the gaming terminal of FIG. 1;  
FIG. 4 is a top plan view of the gaming terminal of FIG. 1;  
FIG. 5 is a bottom plan view of the gaming terminal of FIG. 1;  
FIG. 6 is an elevational view of one side of the gaming terminal of FIG. 1; and,  
FIG. 7 is an elevational view of the other side of the gaming terminal of FIG. 1.

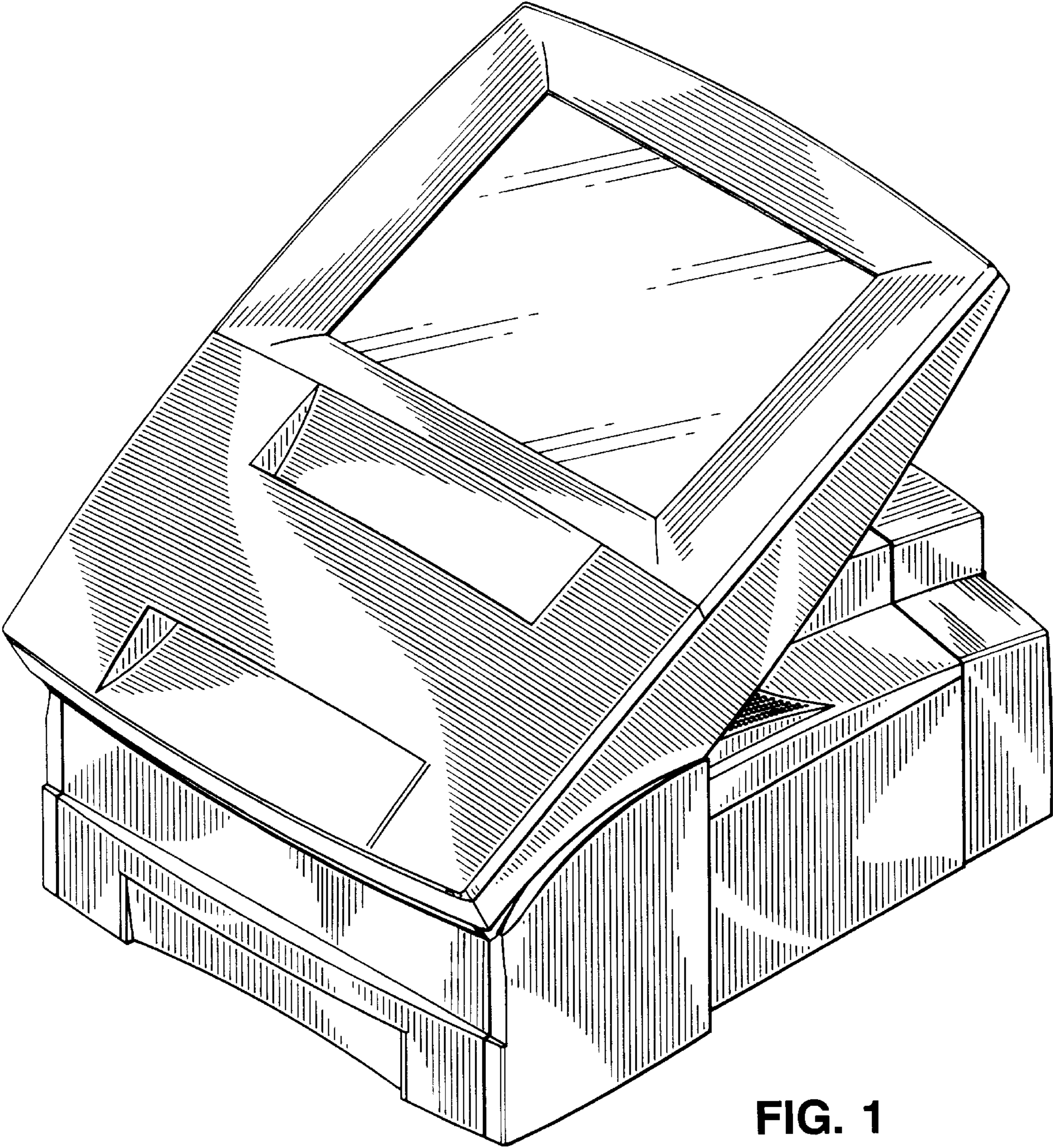

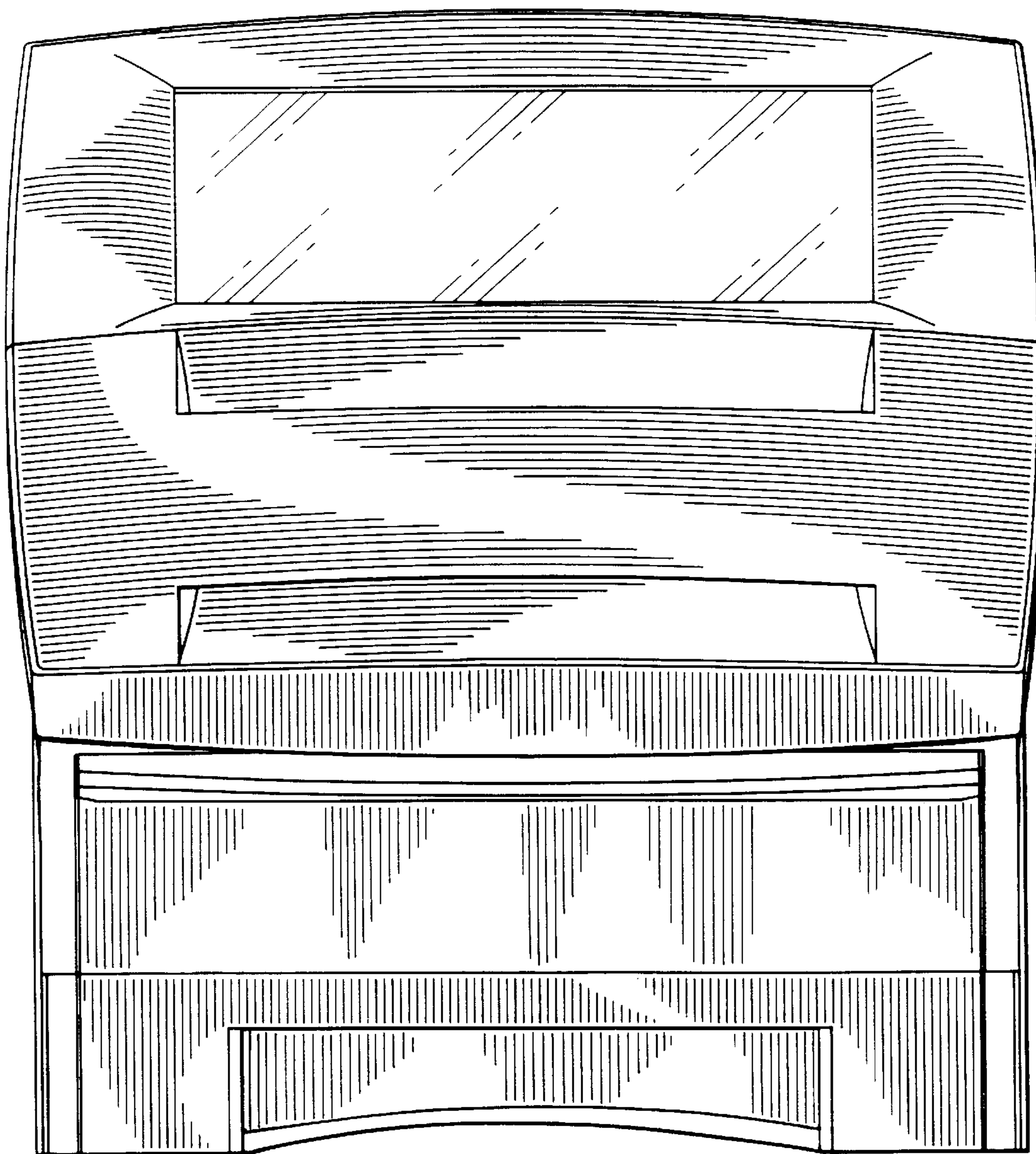

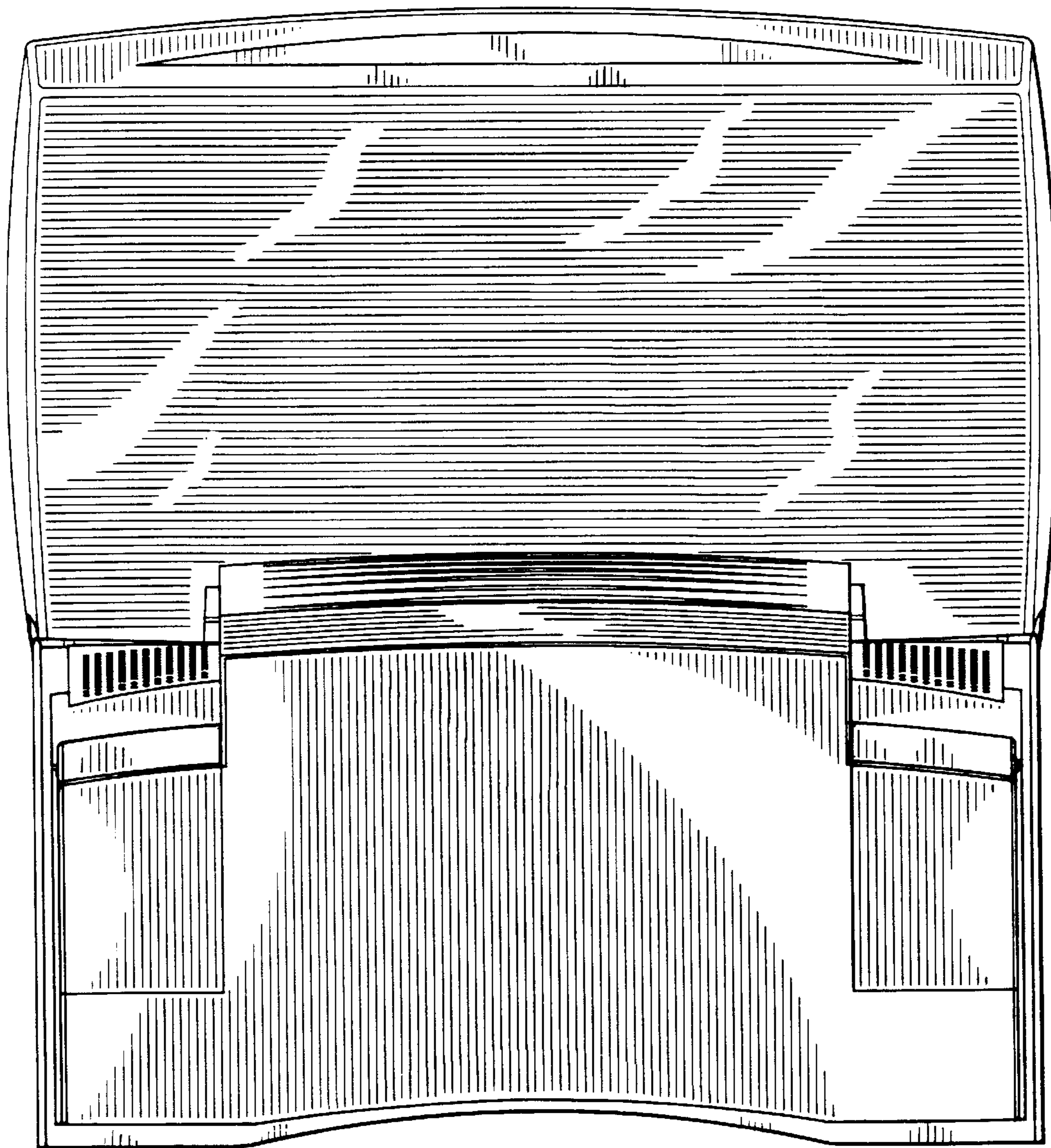

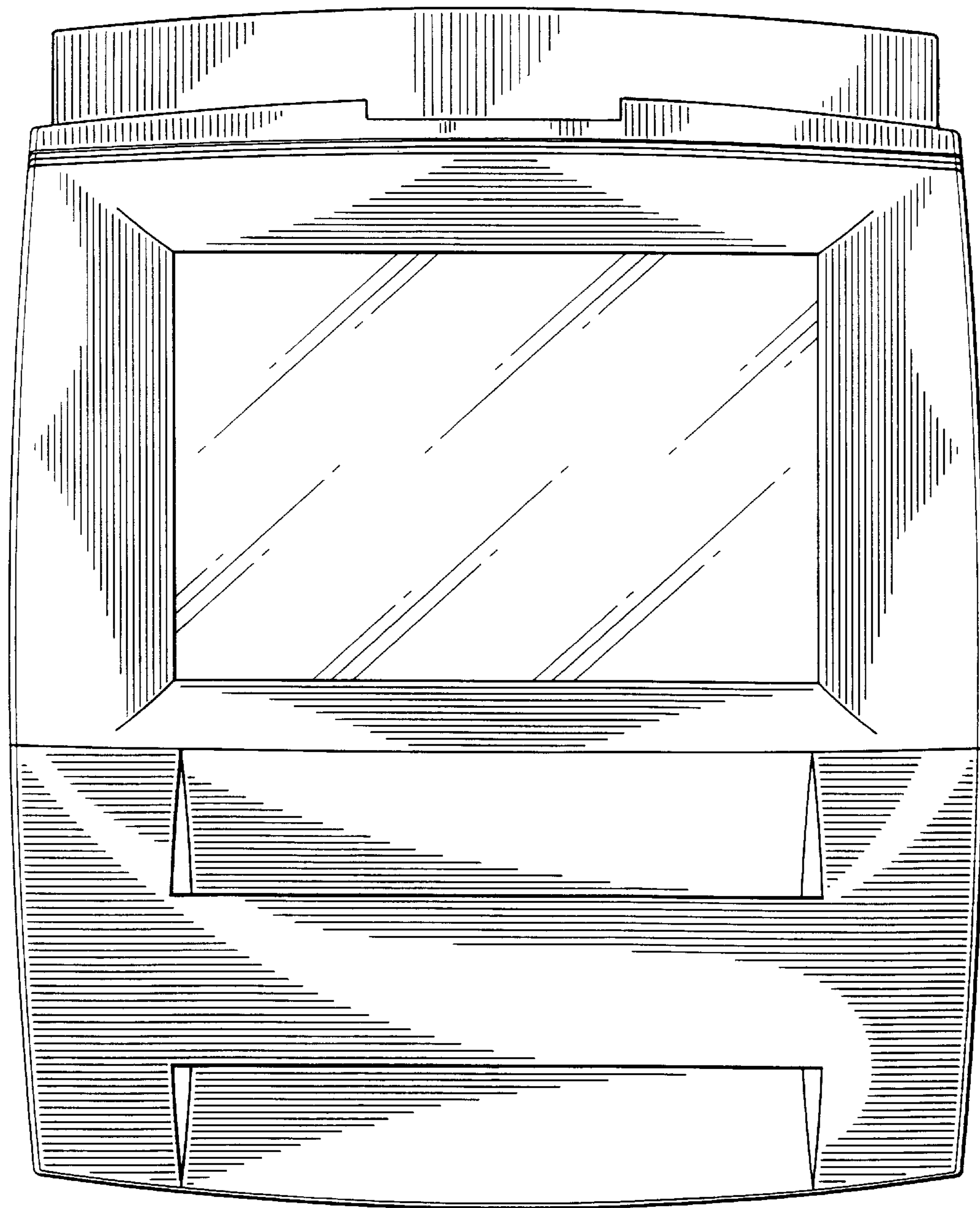

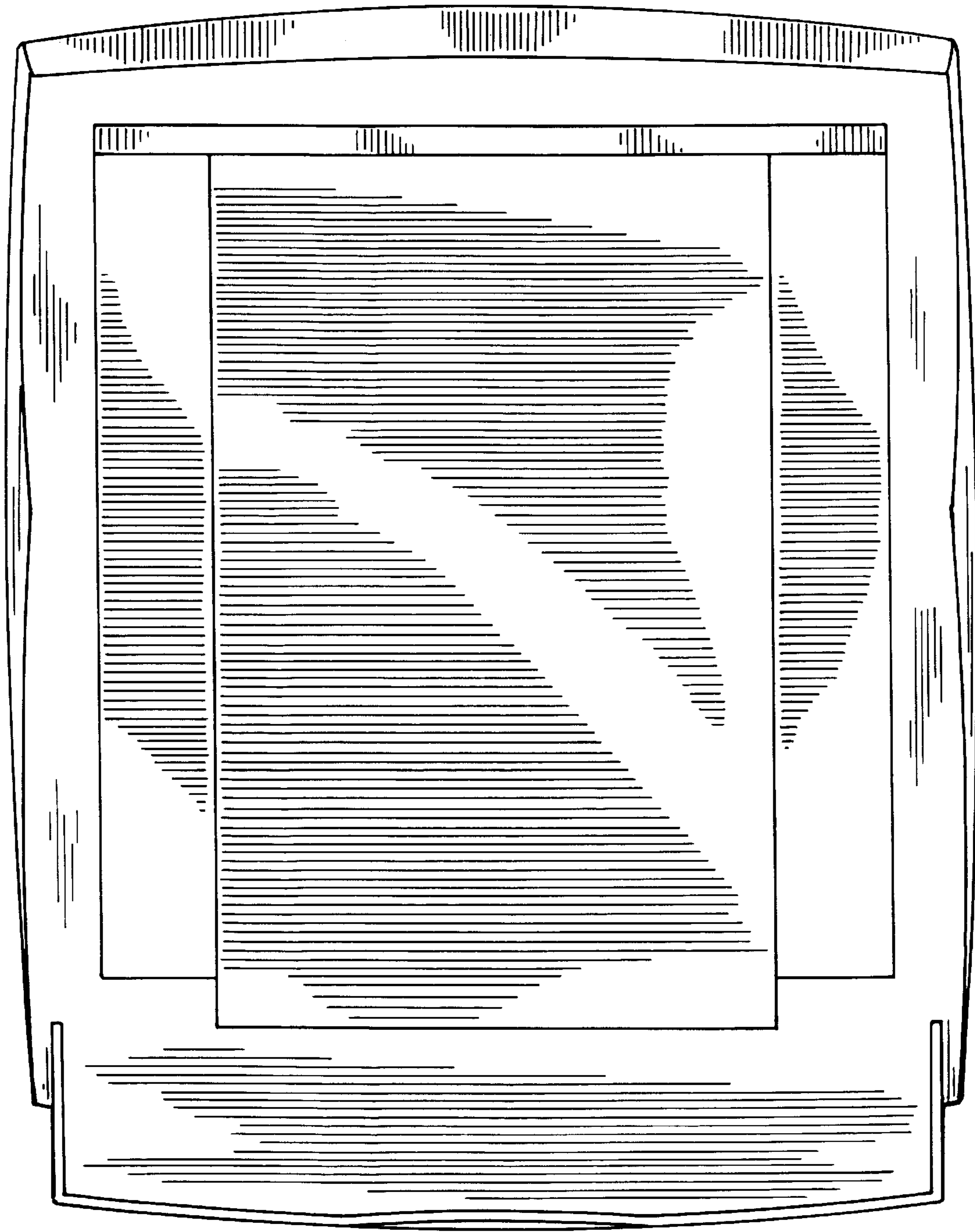

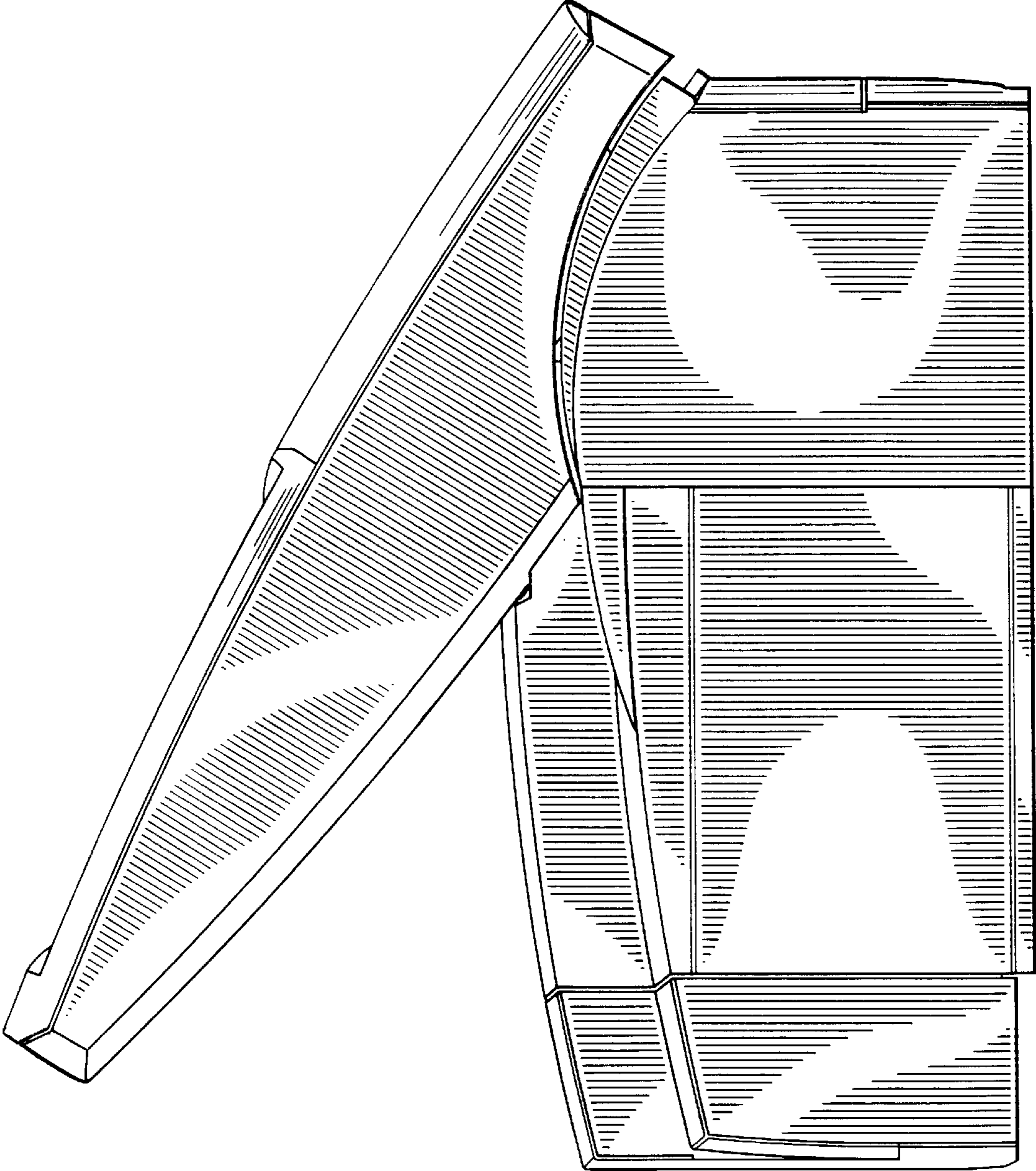

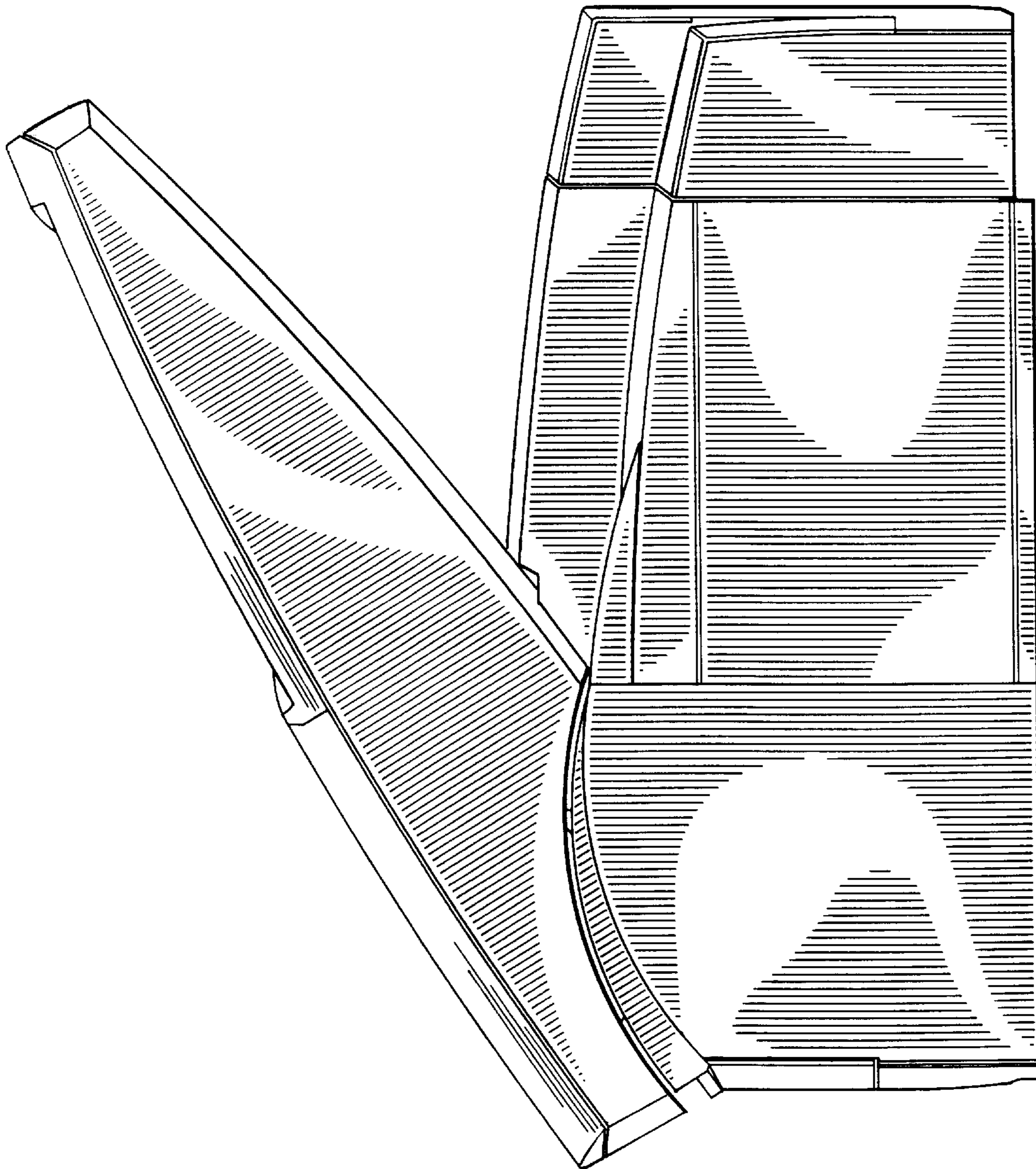
