FIG. 7 is a bottom plan view of FIG. 2.

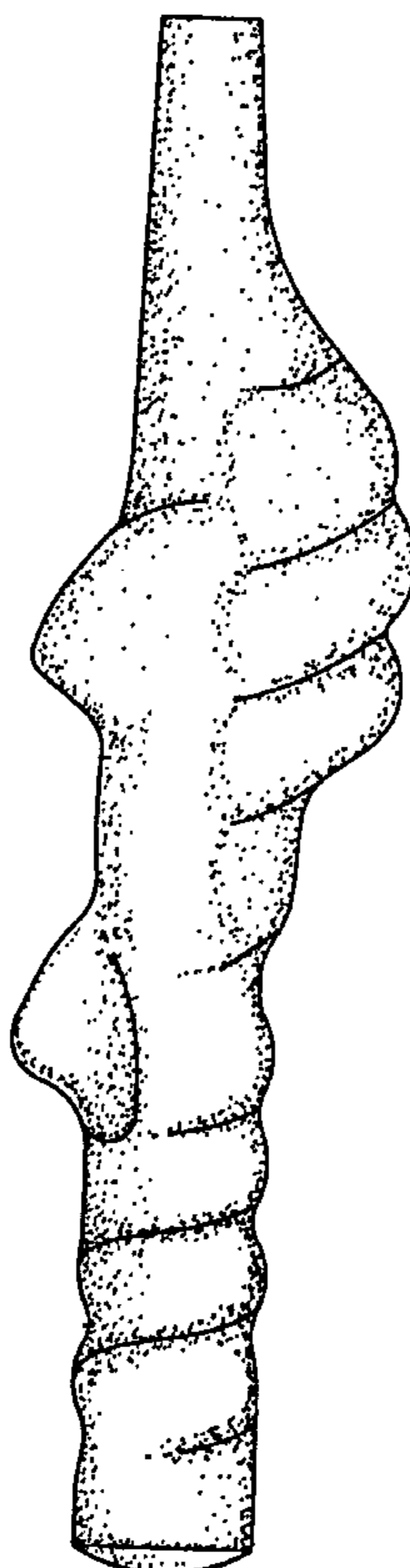

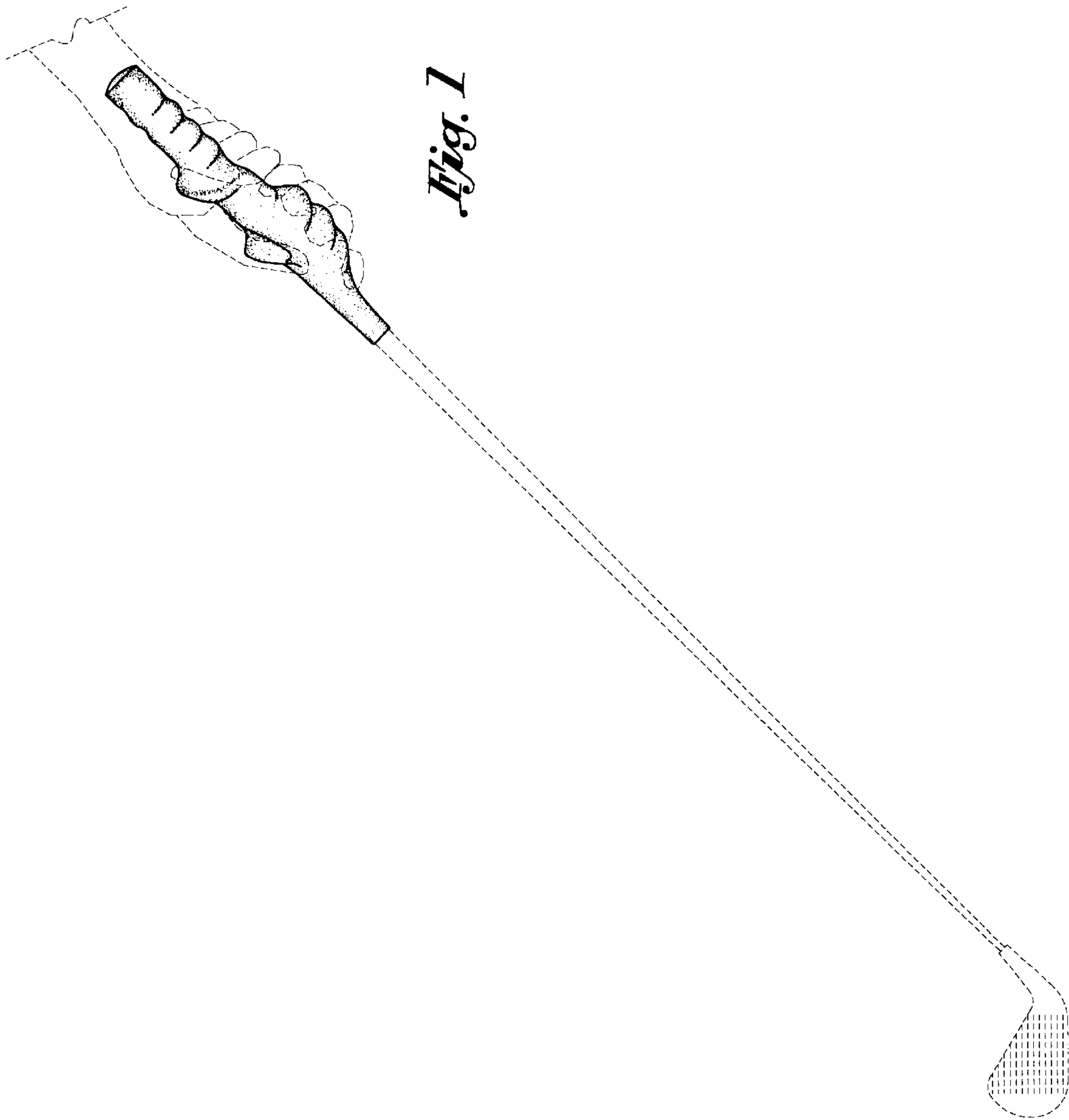

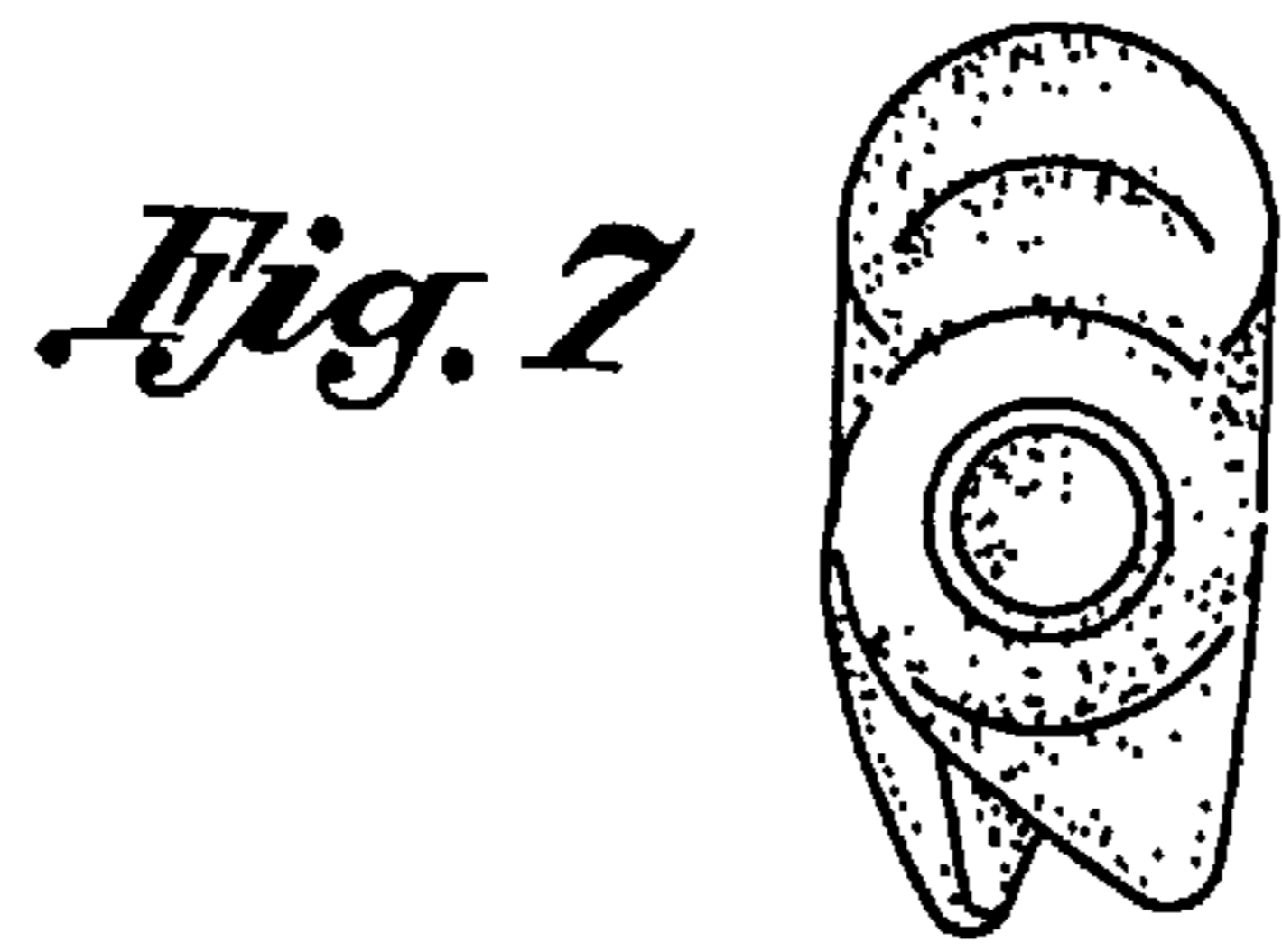

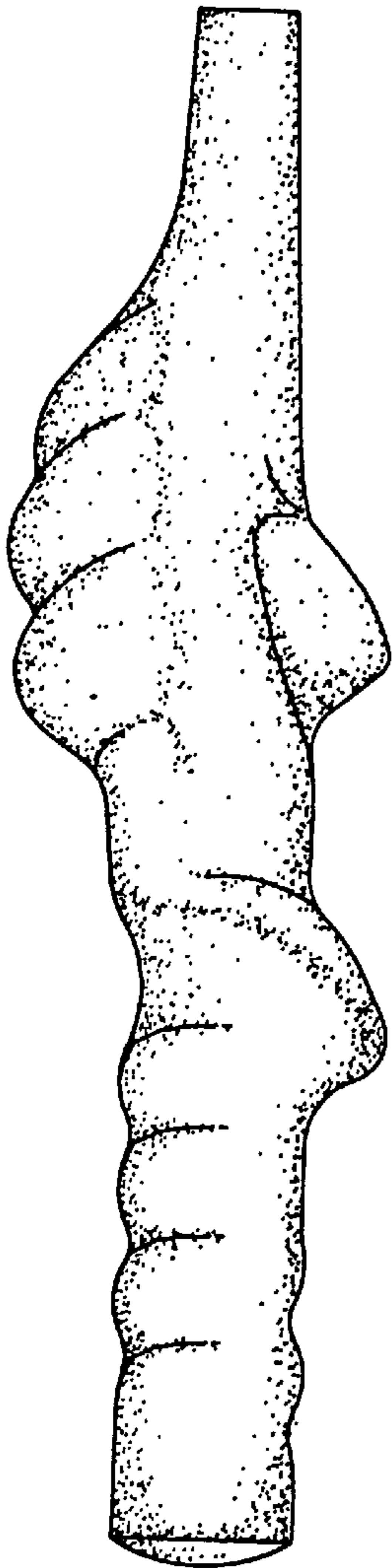

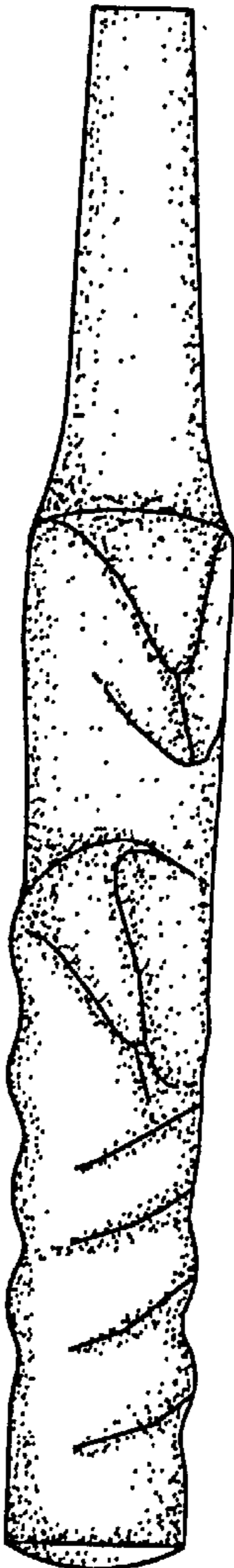

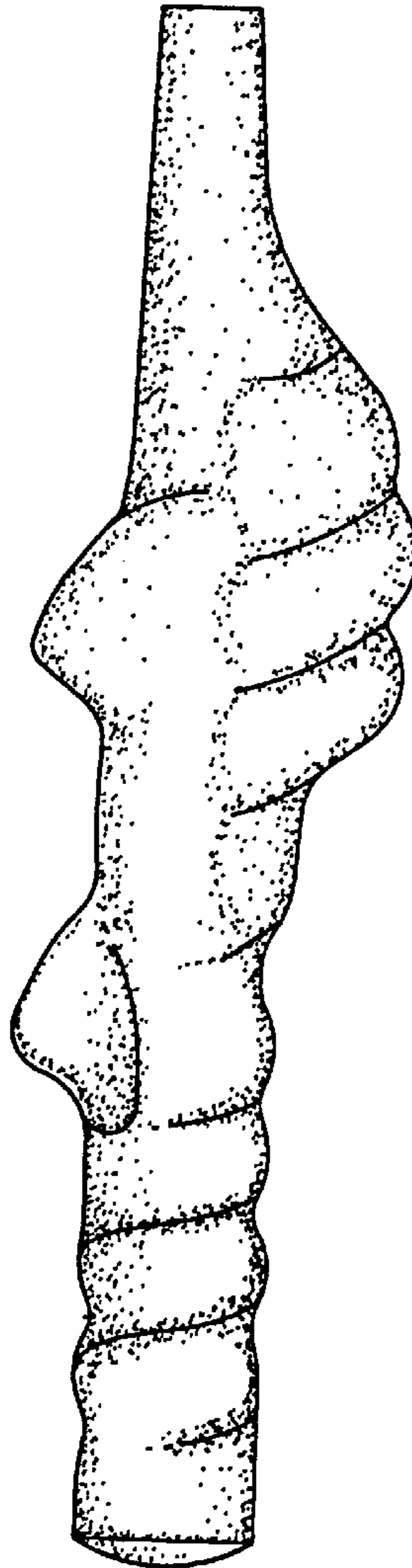

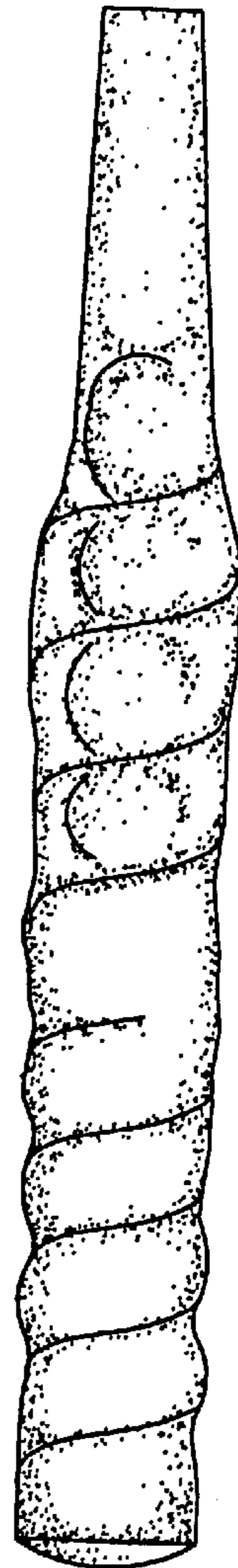
