[57] CLAIM

An ornamental design for a combined two piece neurodiagnostic test instrument with disposable test head and weighted reusable handle, as shown and described.

DESCRIPTION

FIG. 1 is a front view of the combined two piece neurodiagnostic test instrument with disposable test head and weighted reusable handle;

FIG. 2 is a rear view of combined two piece neurodiagnostic test instrument with disposable test head and weighted reusable handle;

FIG. 3 is a top view of the combined two piece neurodiagnostic test instrument with disposable test head and weighted reusable handle;

FIG. 4 is a bottom view of the combined two piece neurodiagnostic test instrument with disposable test head and weighted reusable handle;

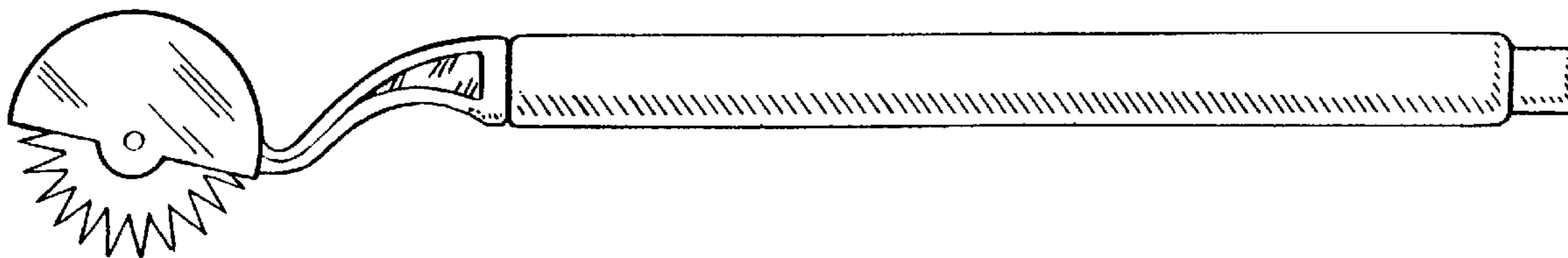
FIG. 5 is an end view of the combined two piece neurodiagnostic test instrument with disposable test head and weighted reusable handle;

FIG. 6 is an opposite end view from FIG. 5 of the combined two piece neurodiagnostic test instrument with disposable test head and weighted reusable handle; and,

FIG. 7 is a perspective view of the combined two piece neurodiagnostic test instrument with disposable test head and weighted reusable handle.

A patient's hand and arm shown in dotted lines and a doctor's hand shown in dotted lines holding the test instrument are shown for environment purposes only and forms no part of the new and original design.

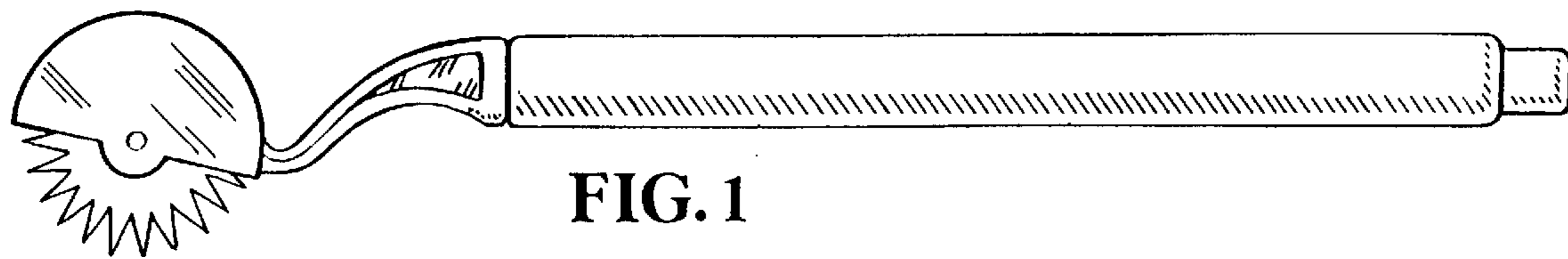

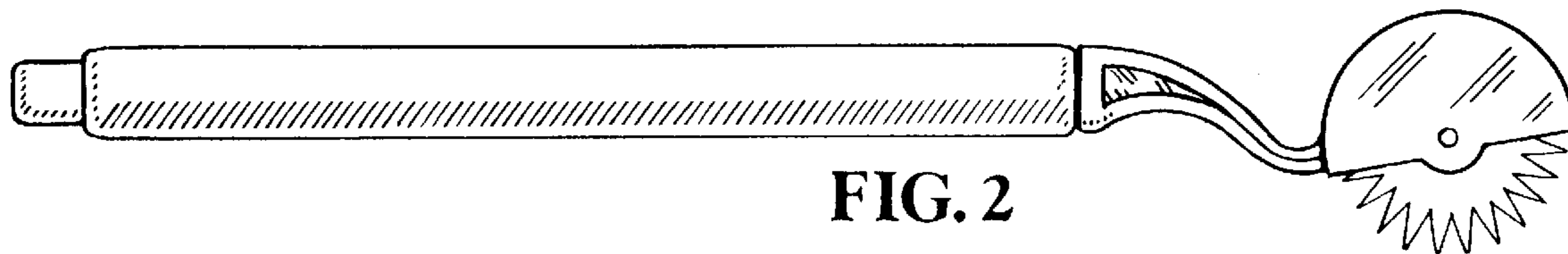

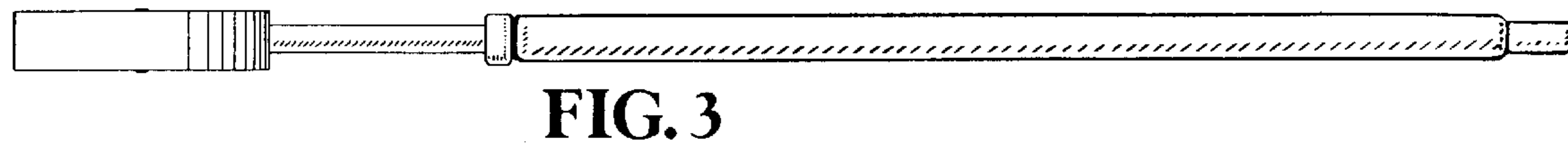

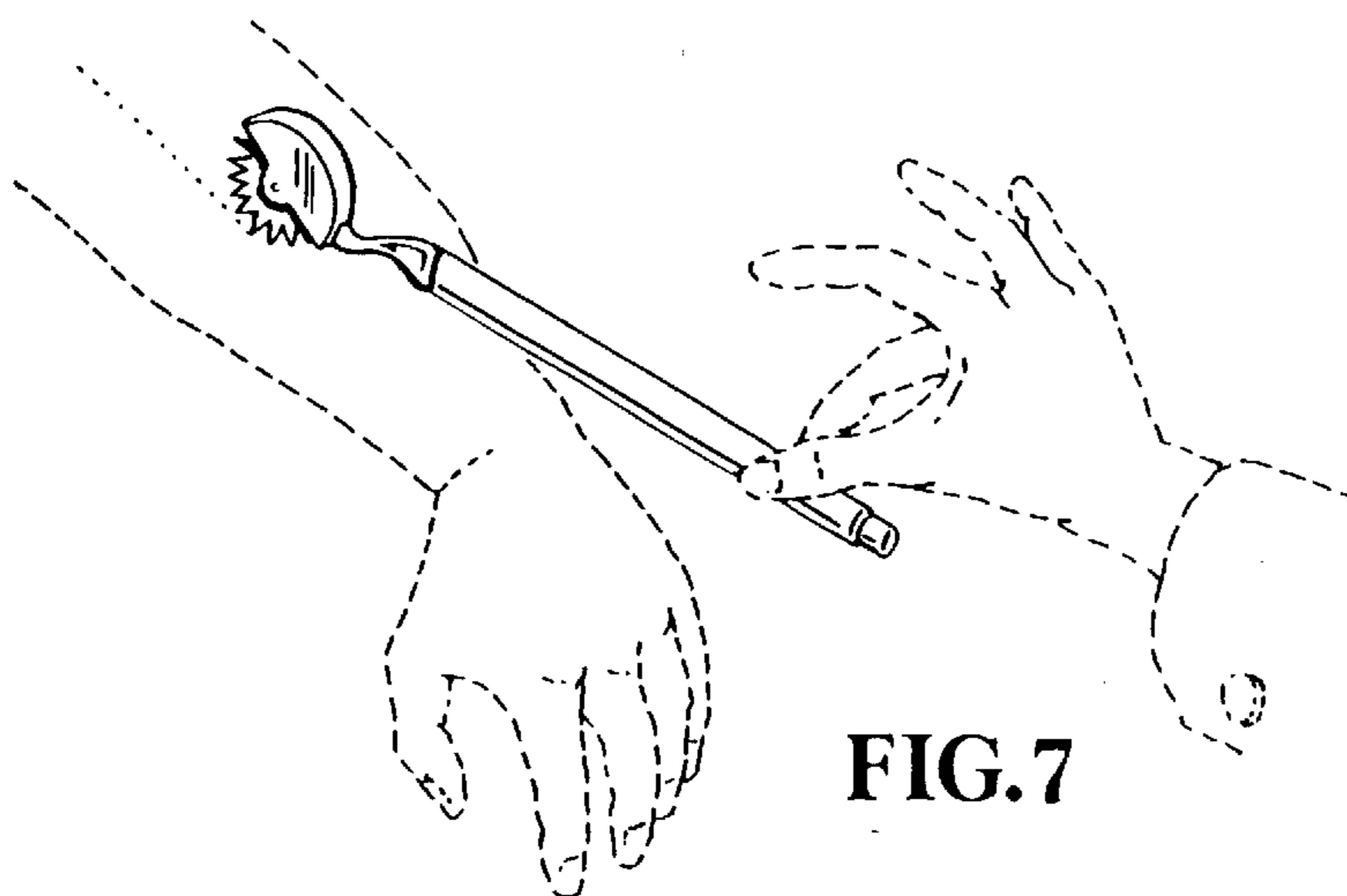
