FIG. 2 is a back elevational view of the gazebo of FIG. 1;

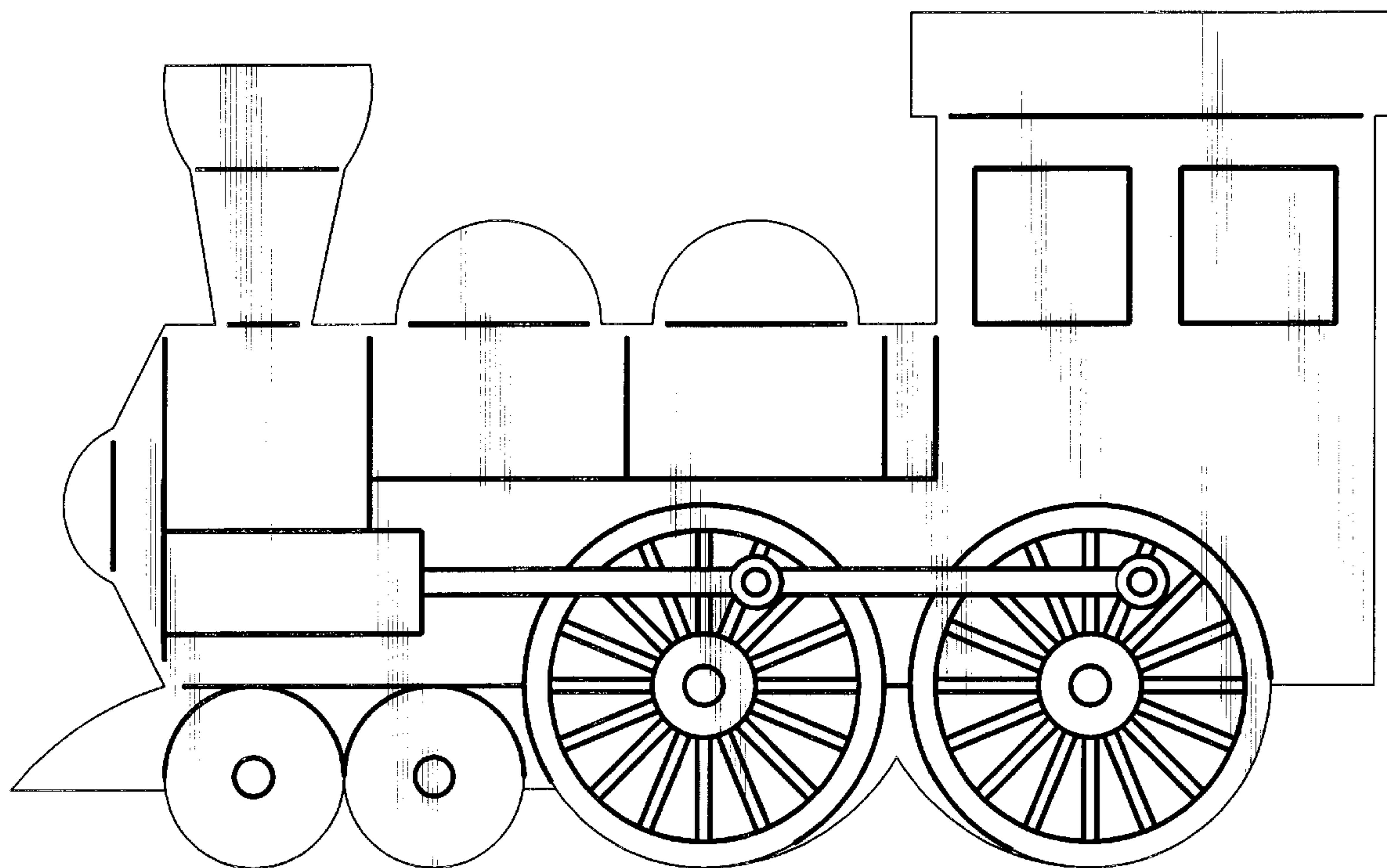
FIG. 3 is a left side elevational view of the gazebo of FIG. 1;

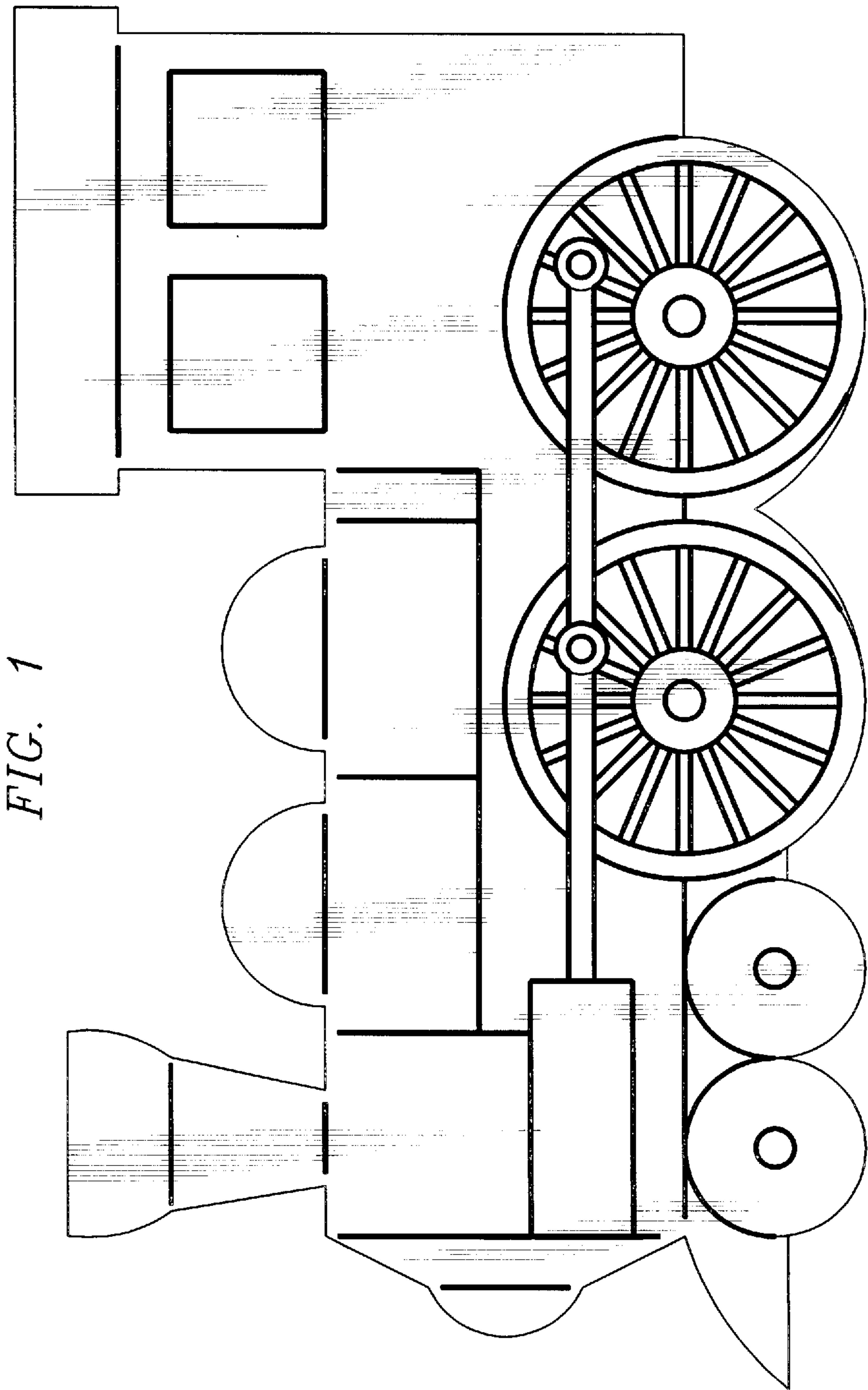

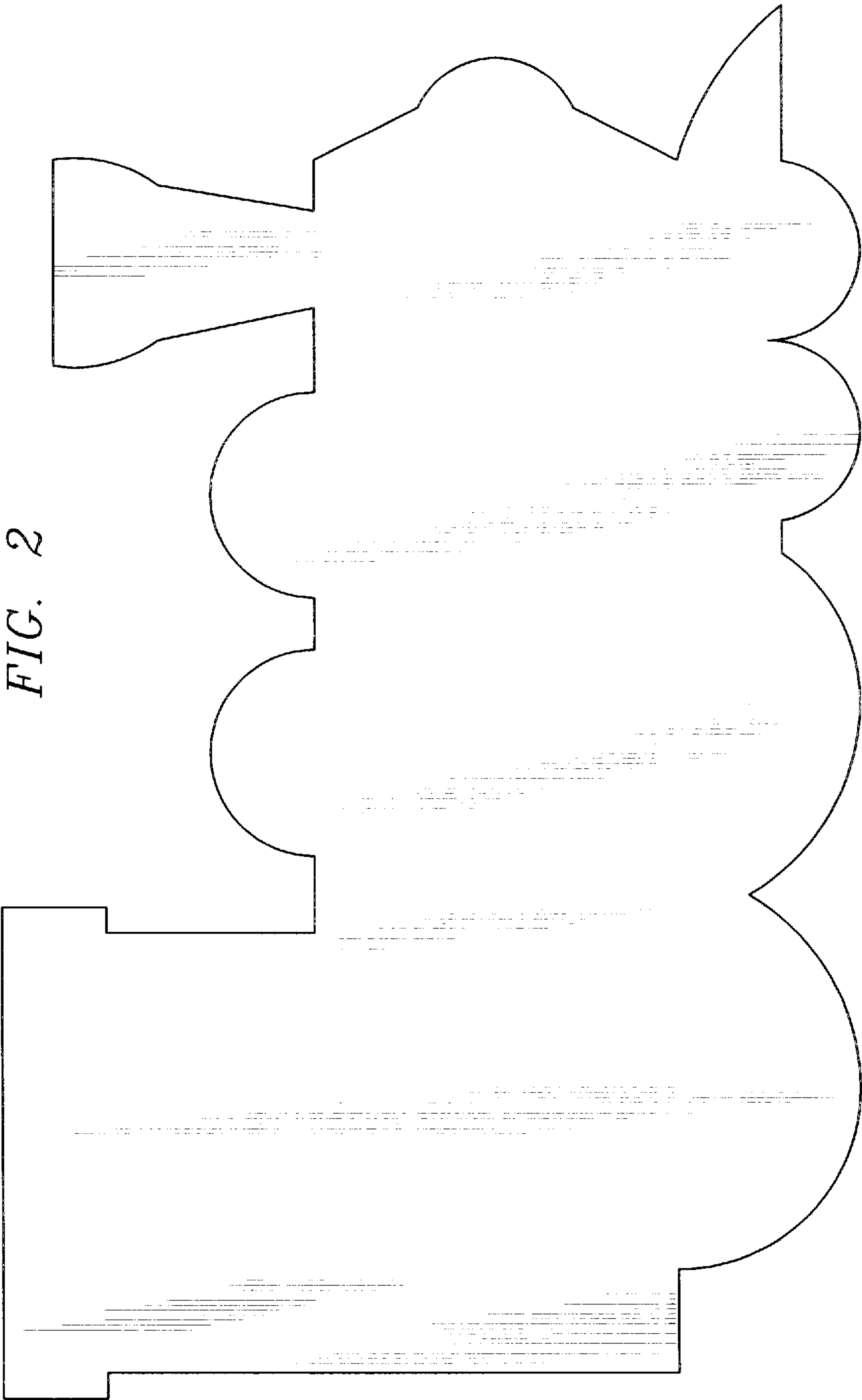

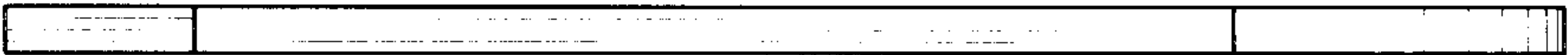

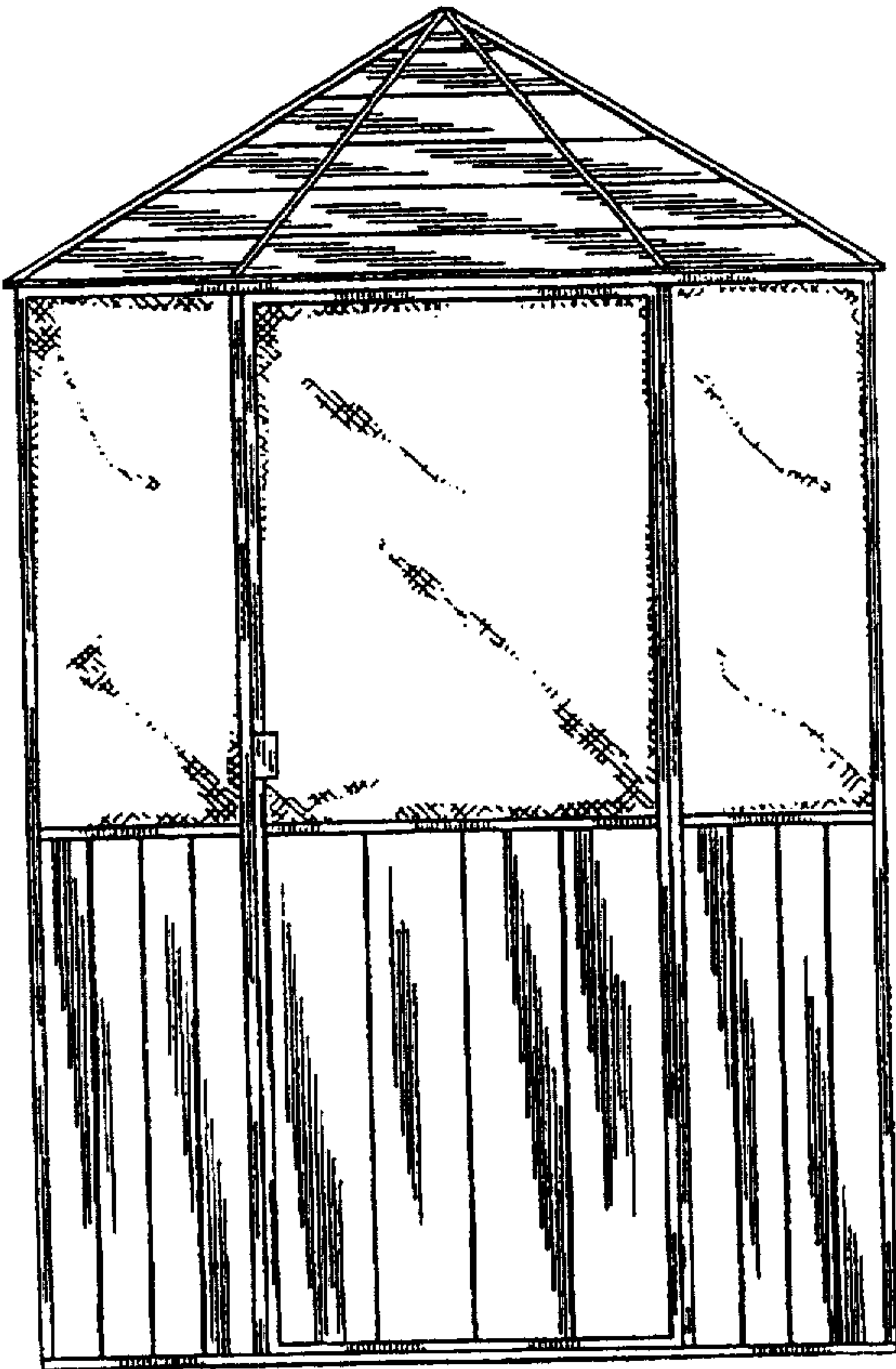

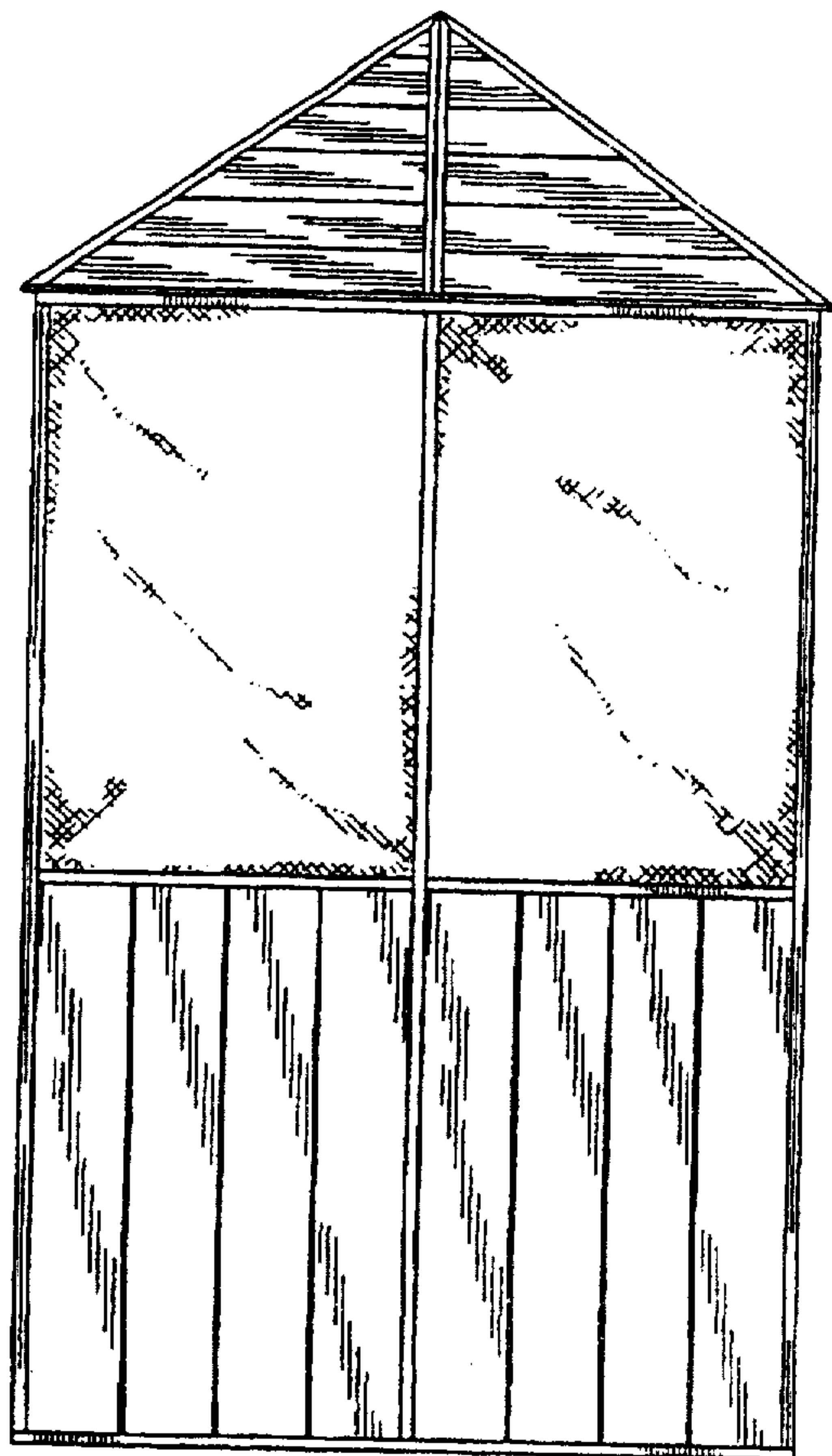

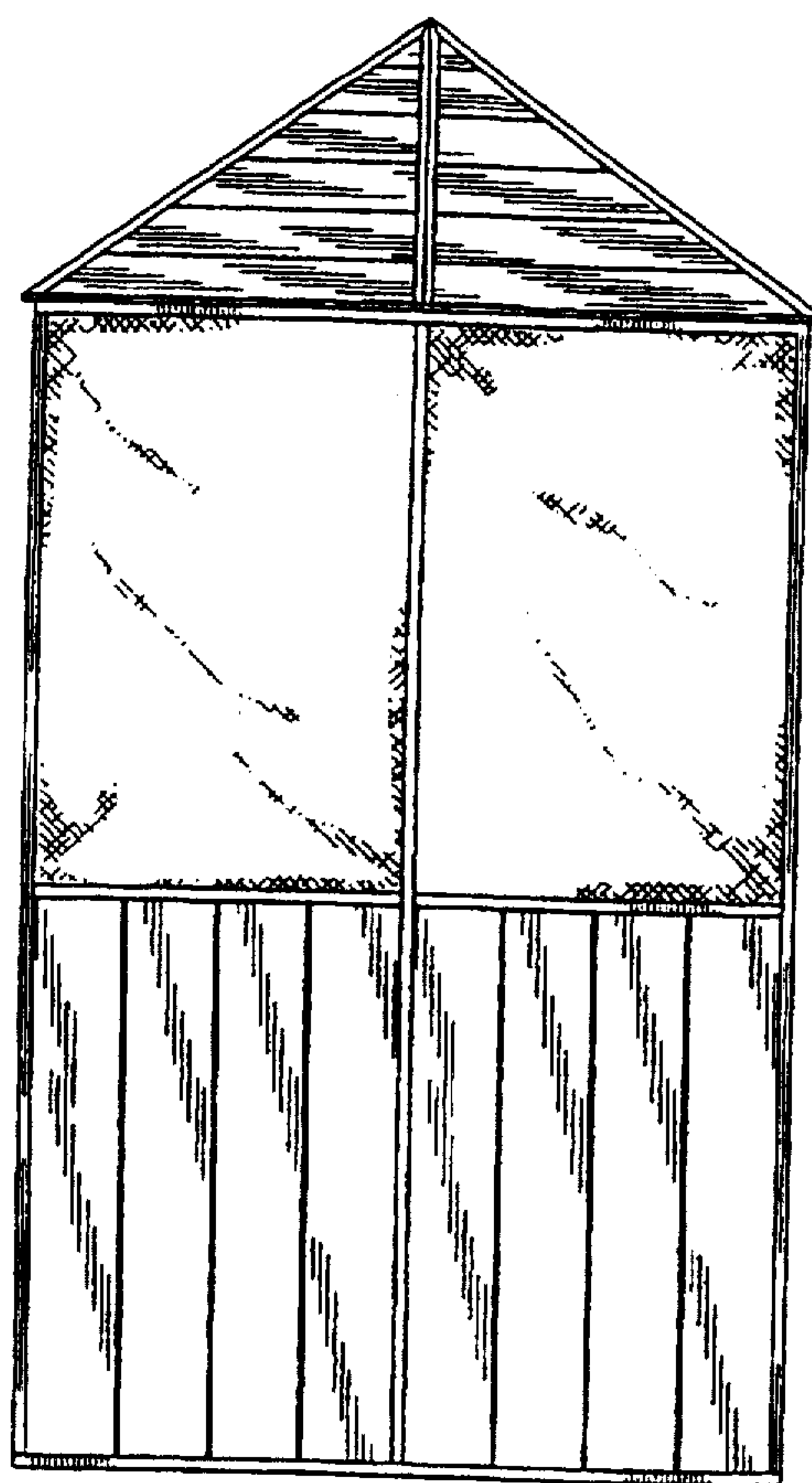

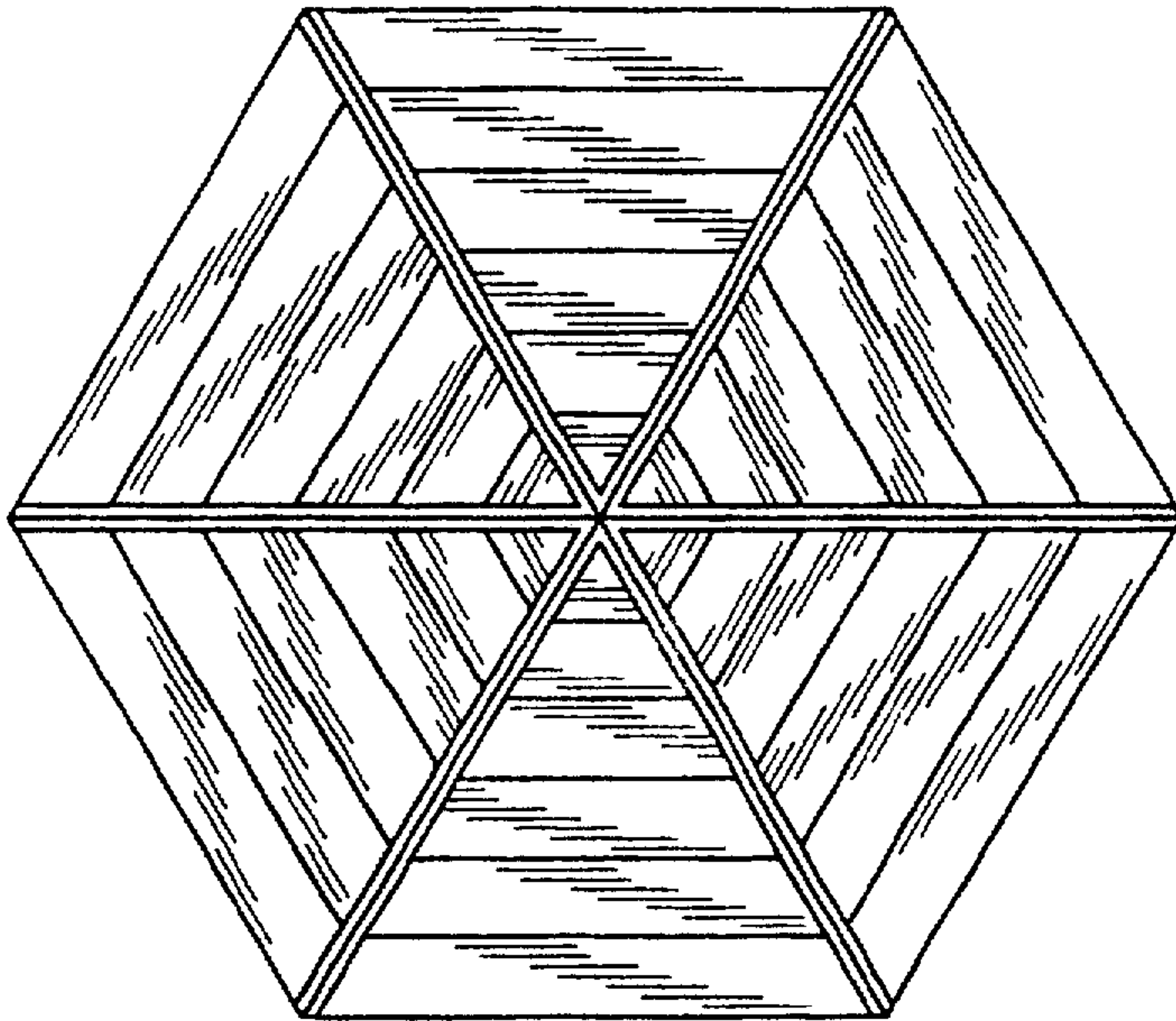

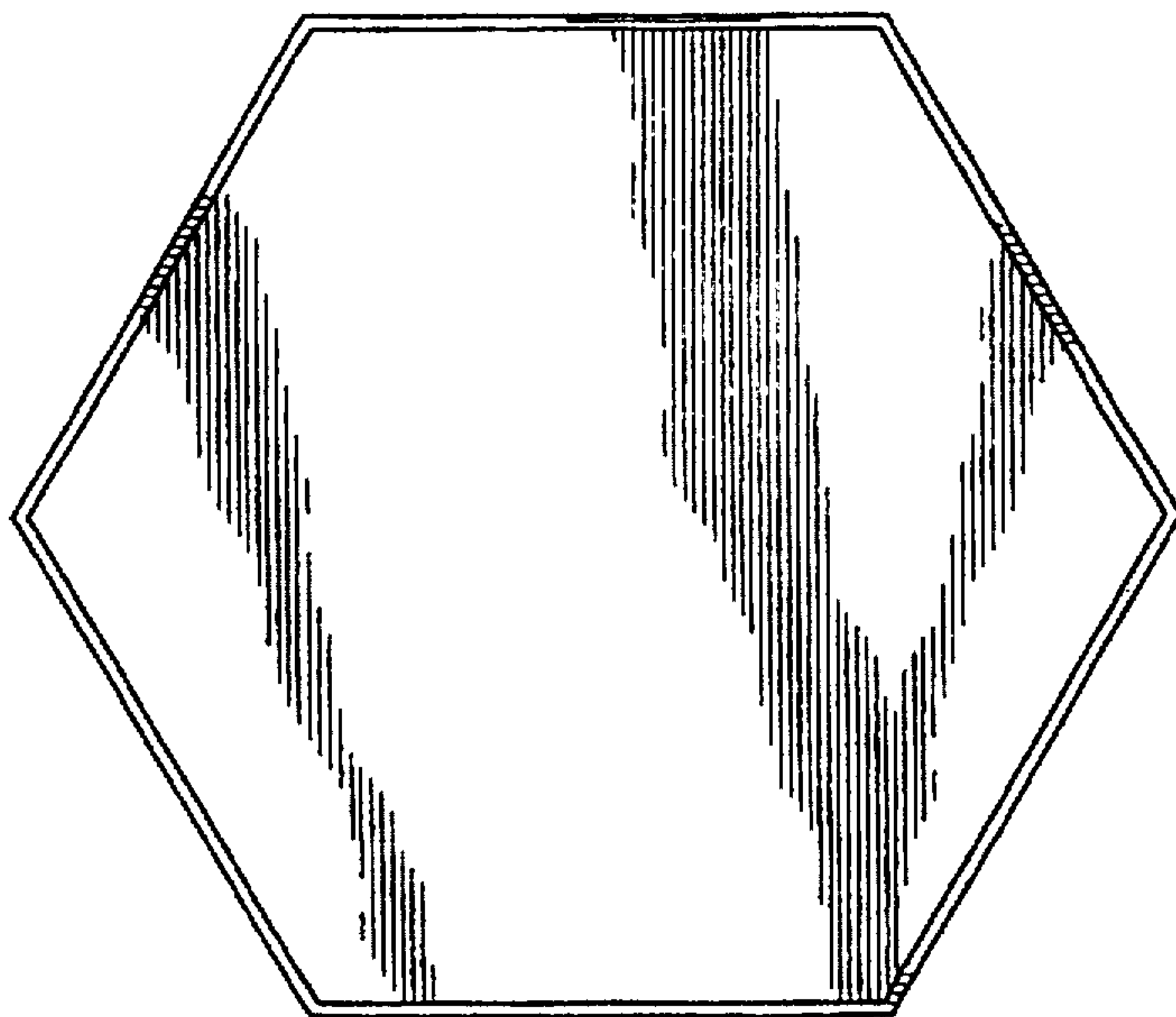
