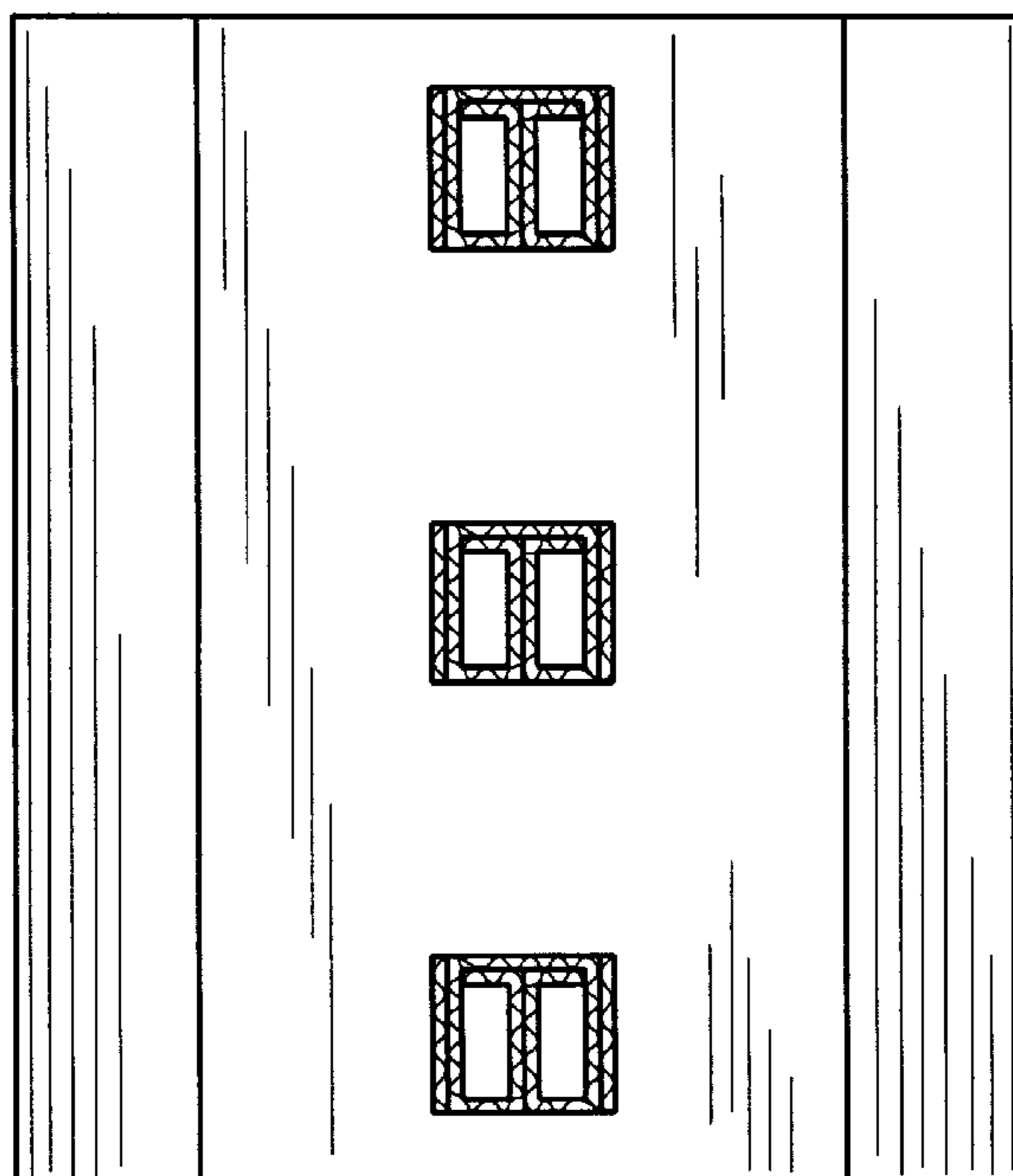

DESCRIPTION

FIG. 1 is an inverted perspective view of a corrugated pallet made in accordance with the present invention;
FIG. 2 is a top plan view thereof;
FIG. 3 is an end elevational view thereof, the opposite end being a mirror image thereof;
FIG. 4 is a bottom plan view thereof; and,
FIG. 5 is a side elevational view thereof.

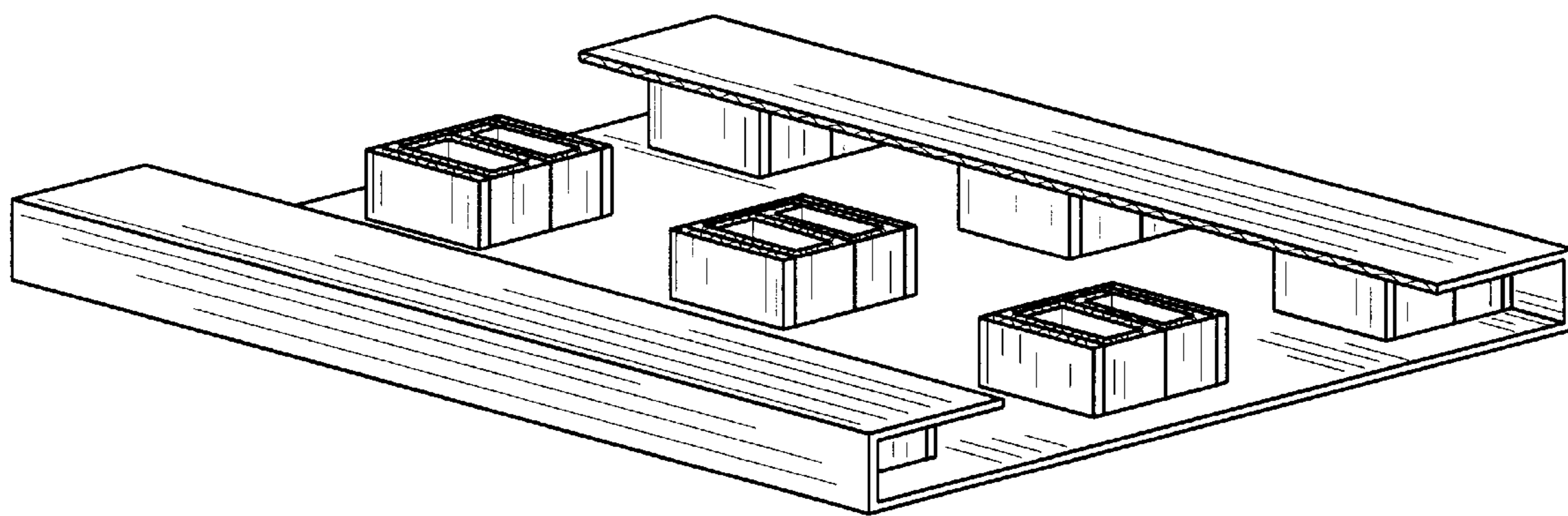

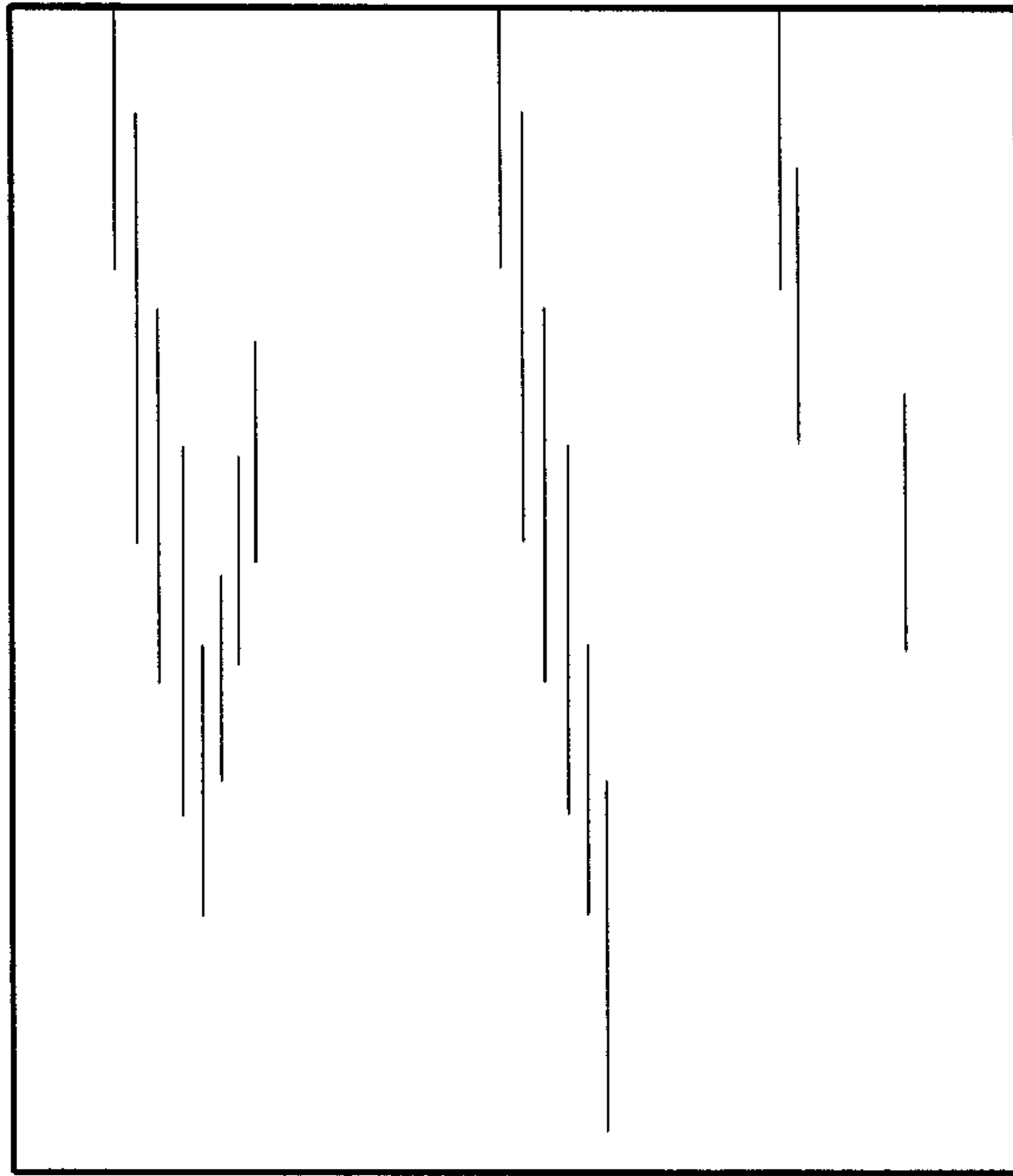

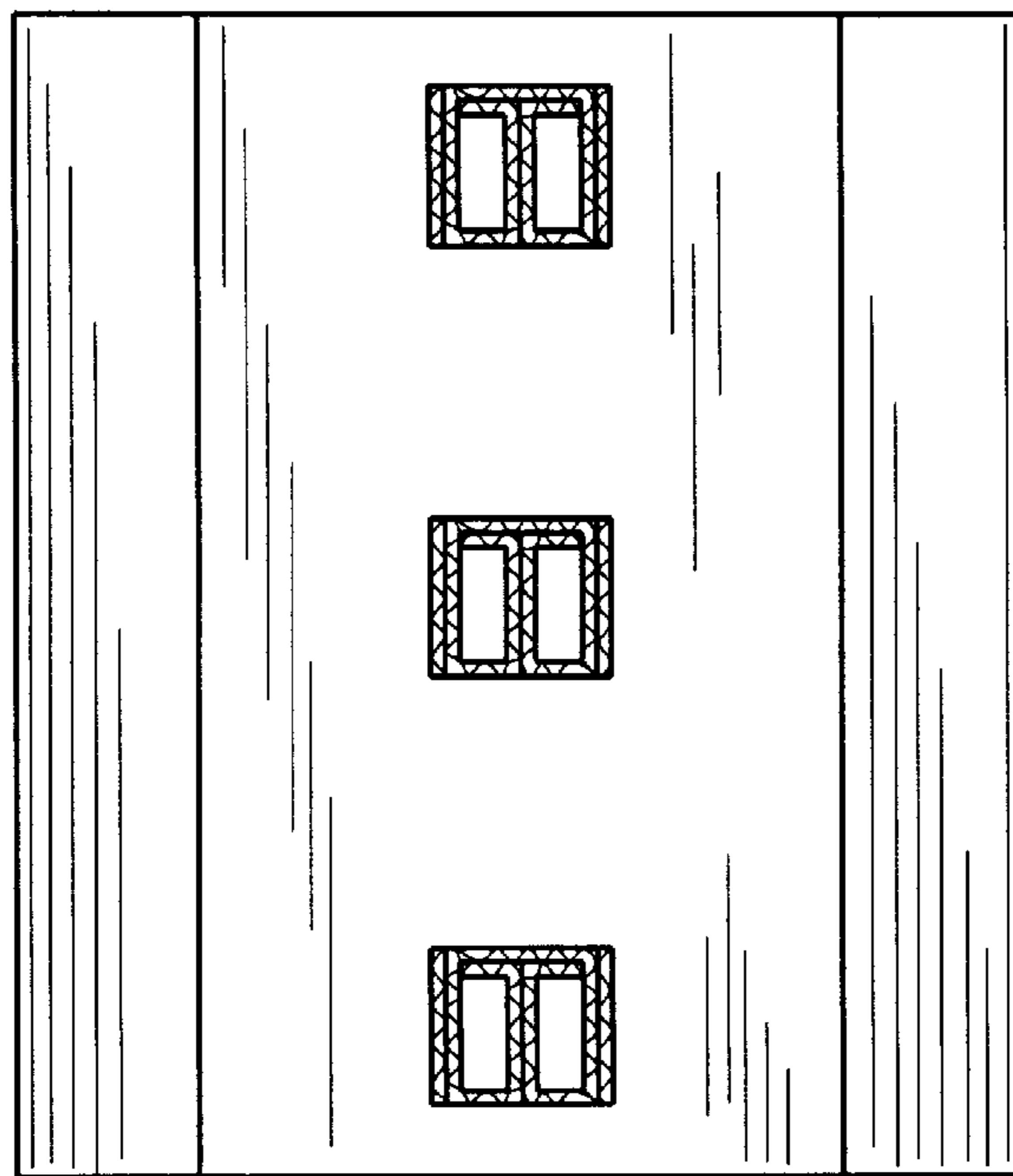
