[57] **CLAIM**

The ornamental design for a hand and wrist weight, as shown and described.

DESCRIPTION

FIG. 1 is view in perspective of one embodiment of weight of this invention, as worn;

FIG. 2 is another view in perspective of the weight of FIG. 1;

FIG. 3 is a third view in perspective of the weight shown in FIGS. 1 and 2;

FIG. 4 is a fourth view in perspective of the device shown in FIGS. 1-3;

FIG. 5 is a view in perspective on the other side of the hand of a wearer, of the device shown in FIGS. 1-4;

FIG. 6 is a top plan view of a second embodiment;

FIG. 7 is a bottom plan view of the device shown in FIG. 6;

FIG. 8 is a view in end elevation in the direction from top to bottom of FIG. 6;

FIG. 9 is a view in end elevation in the direction from bottom to top of FIG. 6;

FIG. 10 is a view in end elevation view from top to bottom of FIG. 12;

FIG. 11 is a view in end elevation viewed from bottom to top of FIG. 12;

FIG. 12 is a top plan view of the first embodiment of a weight, unmounted;

FIG. 13 is a bottom plan view of the weight shown in FIG. 12;

FIG. 14 is a view in side elevation, viewed from left to right, of FIG. 6;

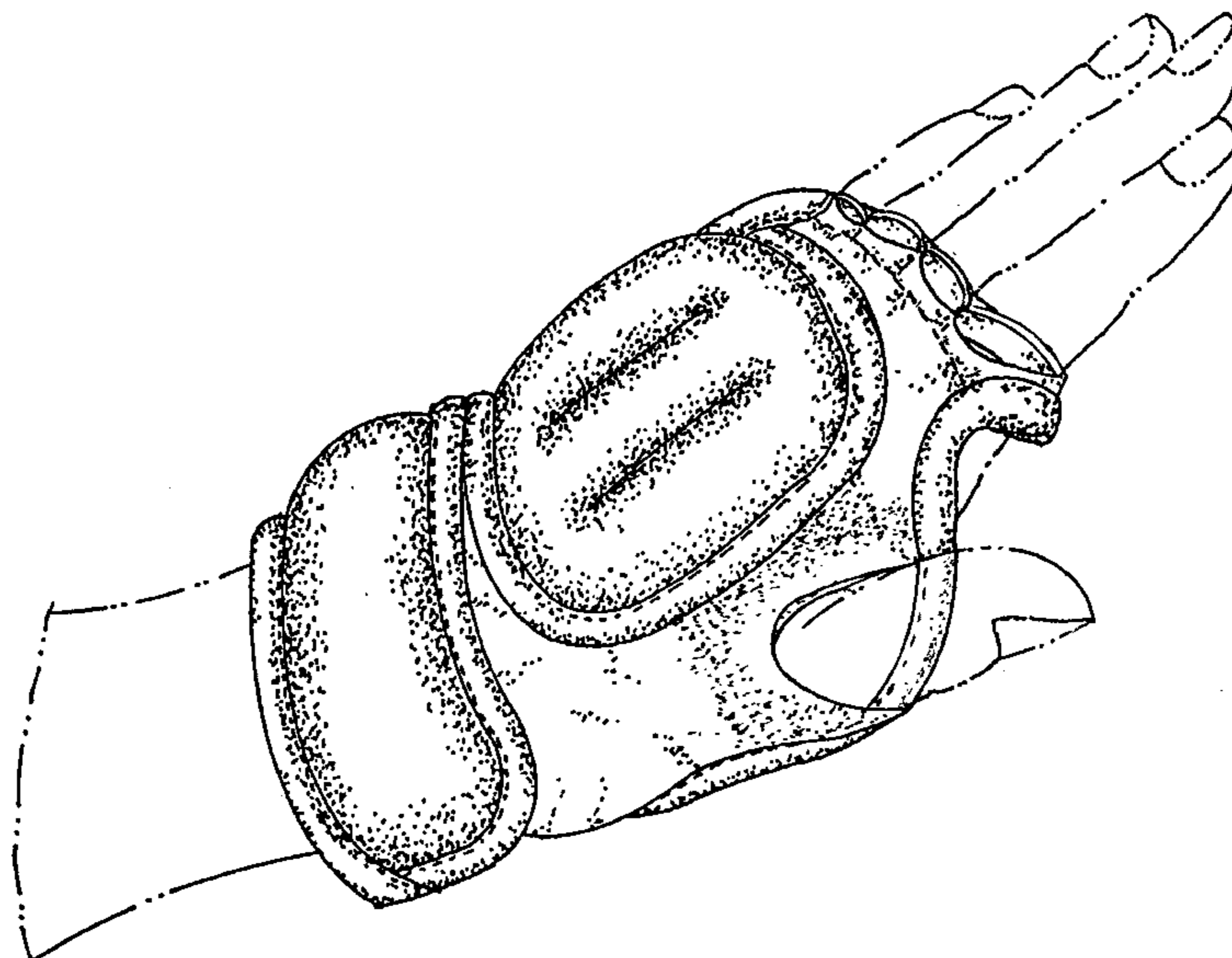
FIG. 15 is a view in side elevation, viewed from right to left, of FIG. 6;

FIG. 16 is a view in side elevation, viewed from right to left, of FIG. 12; and,

FIG. 17 is a view in side elevation from left to right of FIG. 12, a buckle being obscured by the raised margin of the weight, as shown in FIG. 12.

The broken line showing of the hand and wrist is for illustrative purposes only and forms no part of the claimed design.

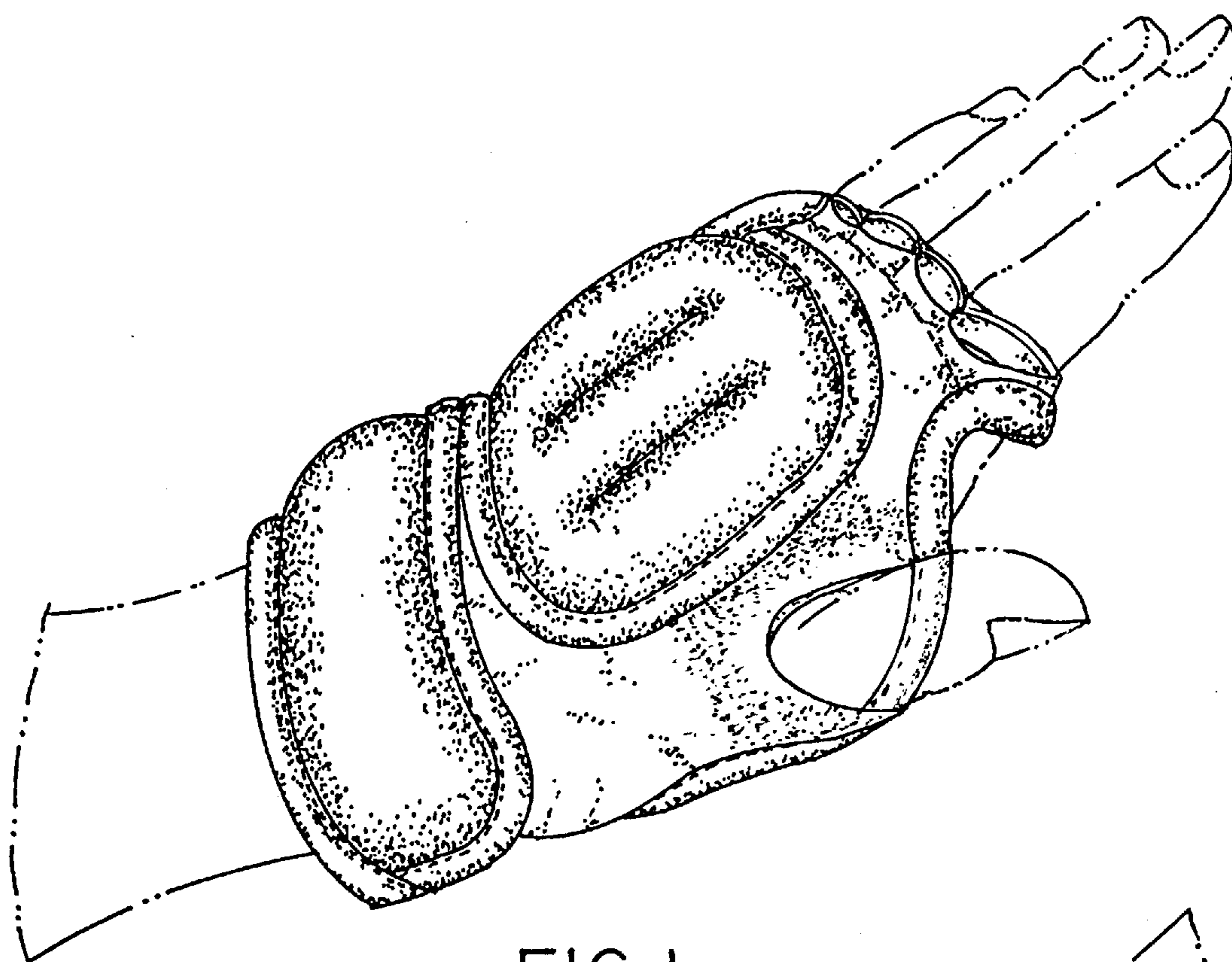

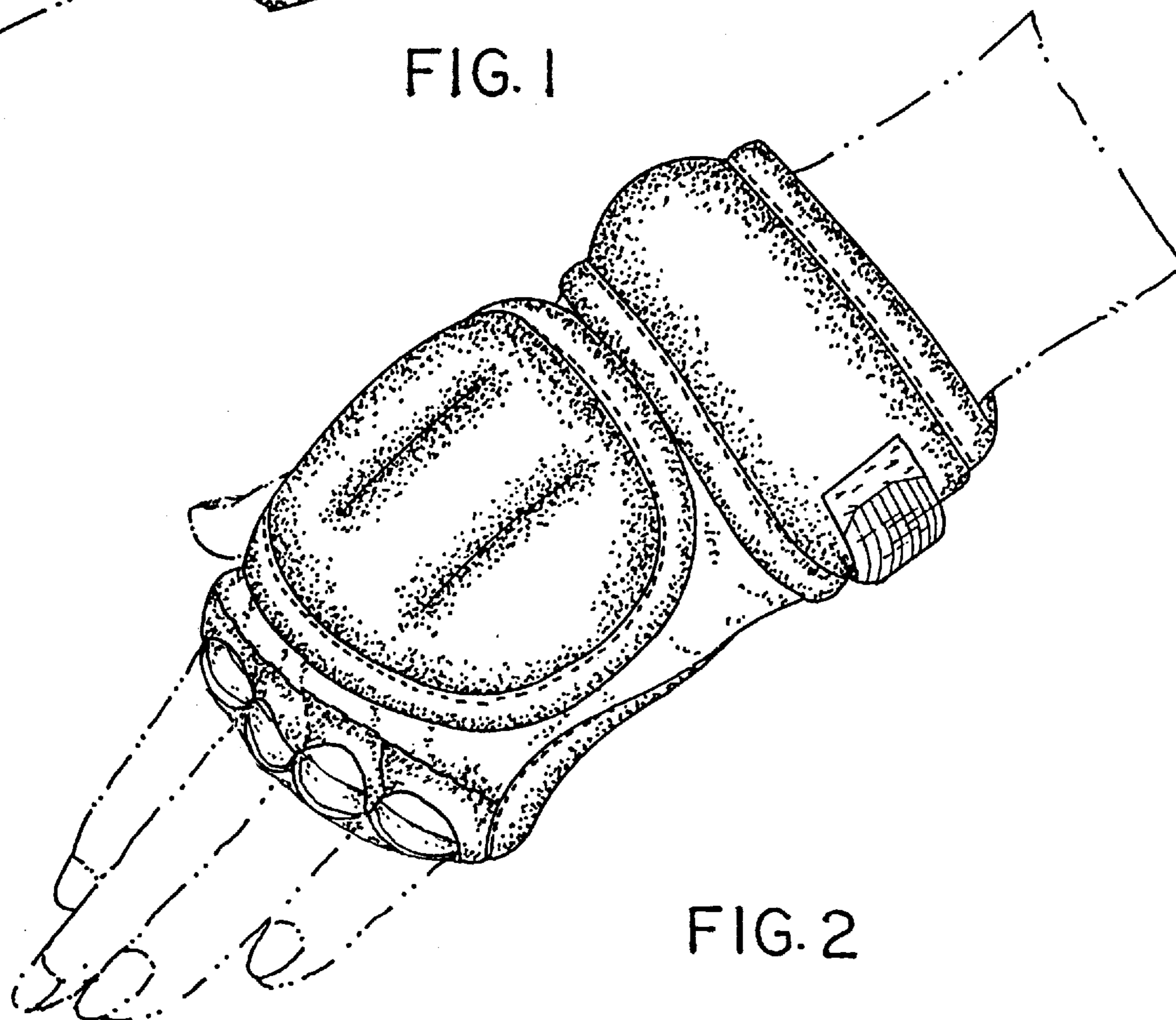

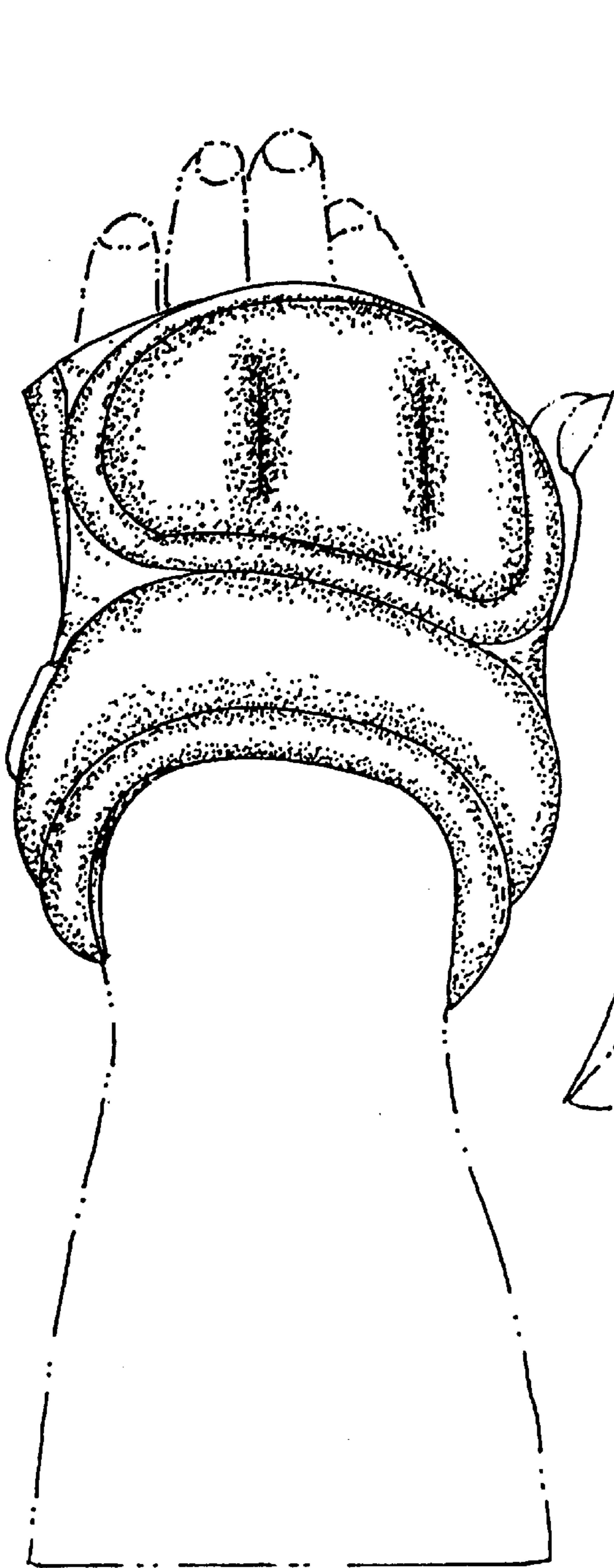

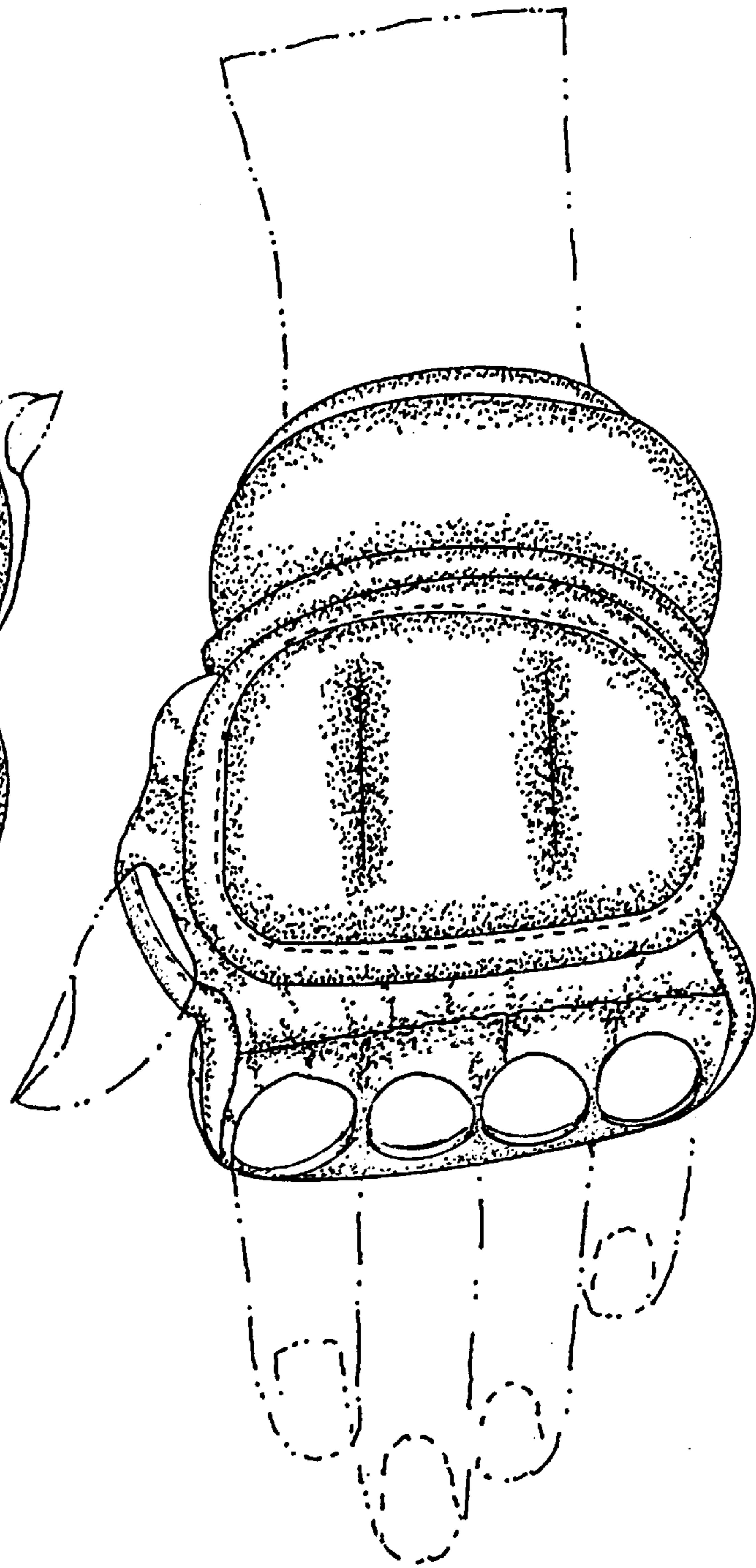

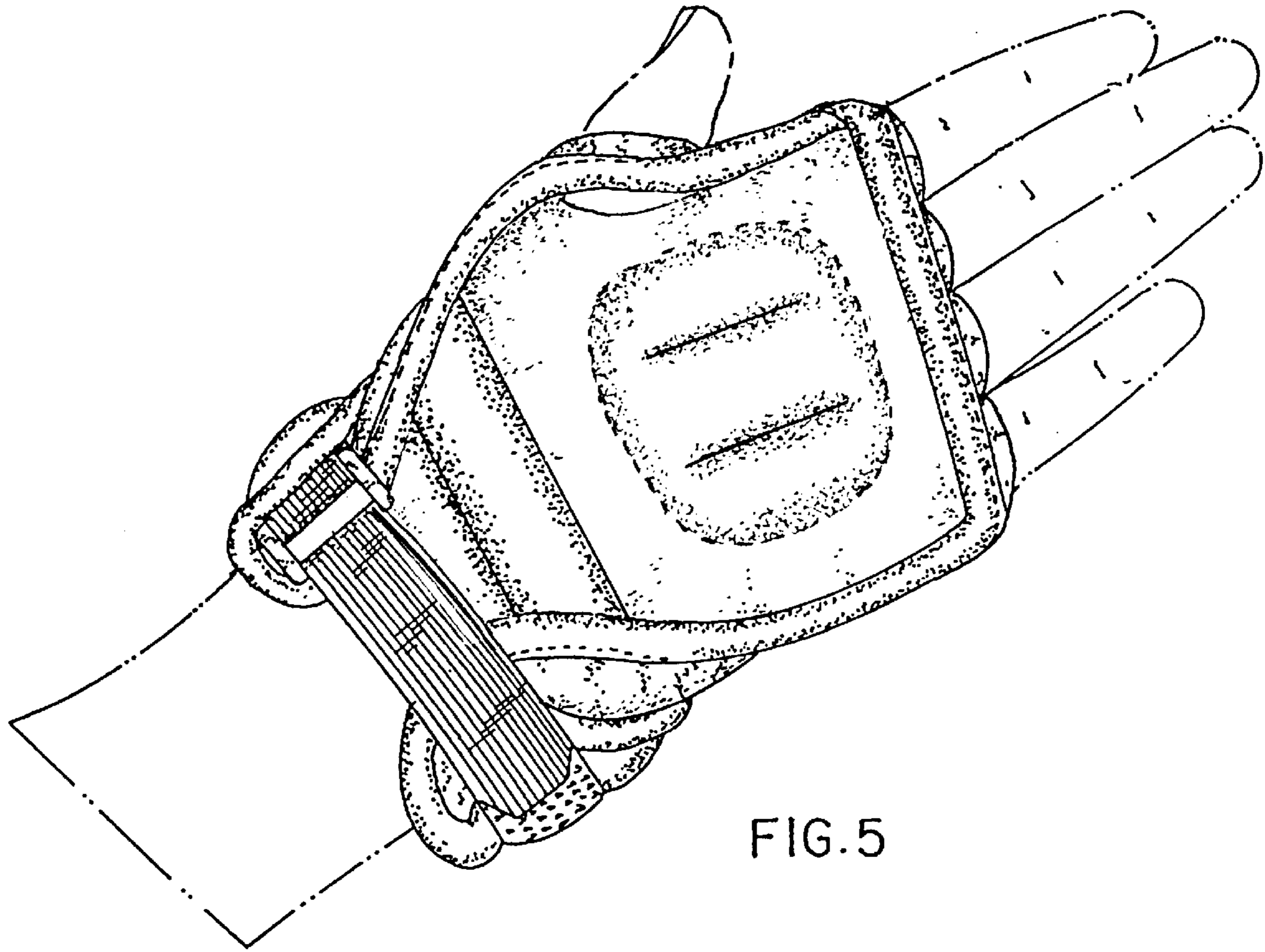

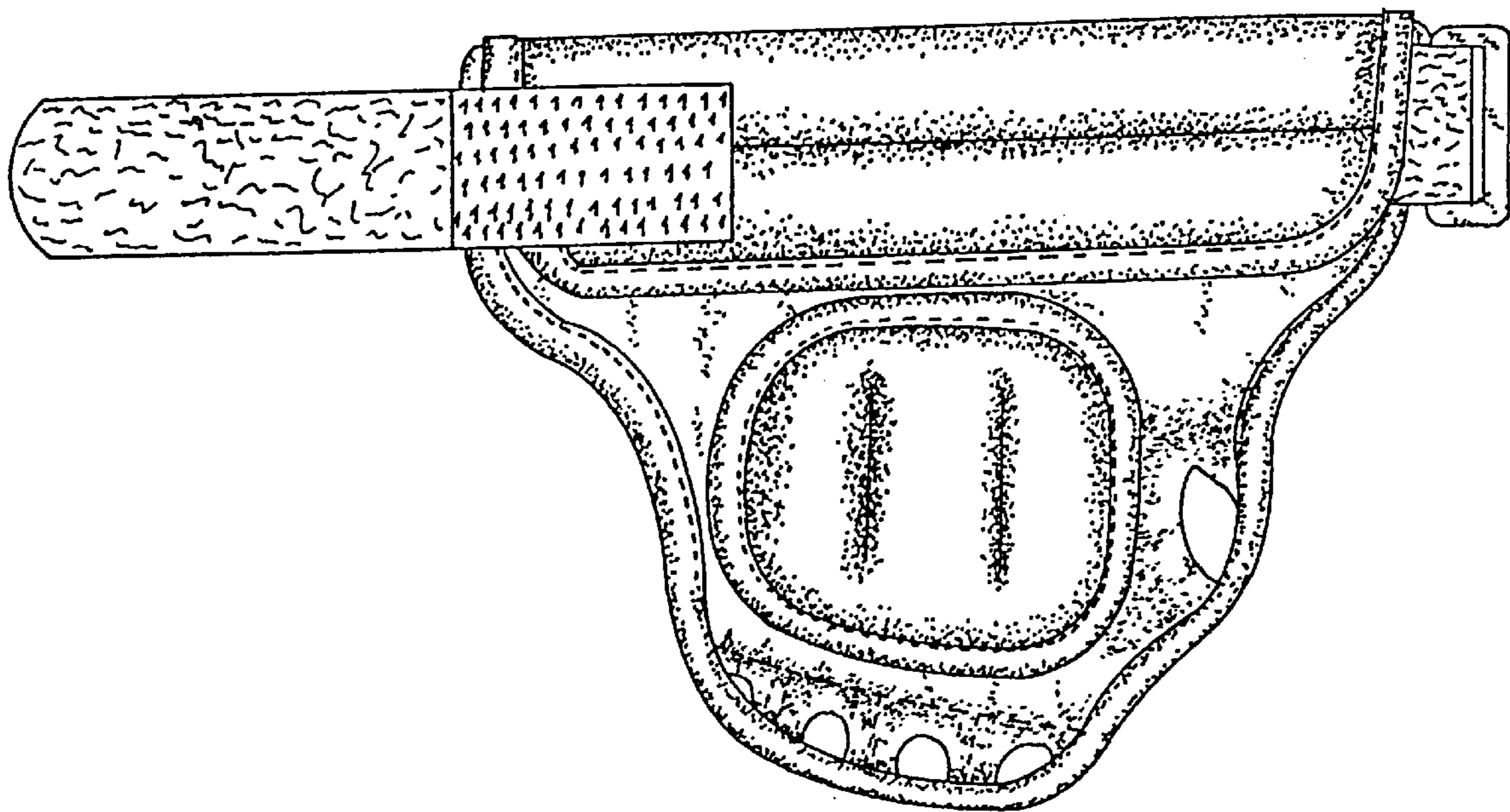

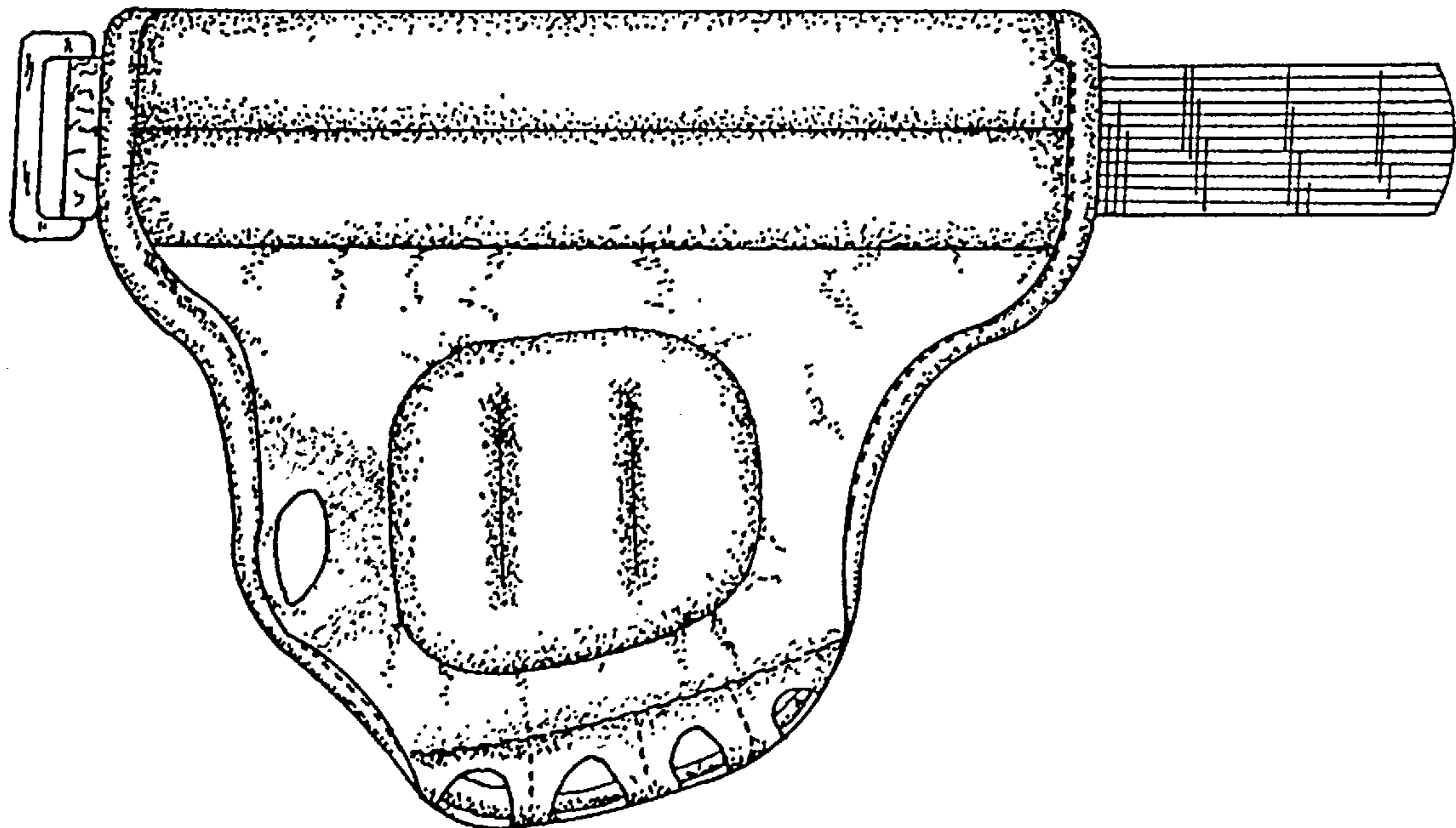

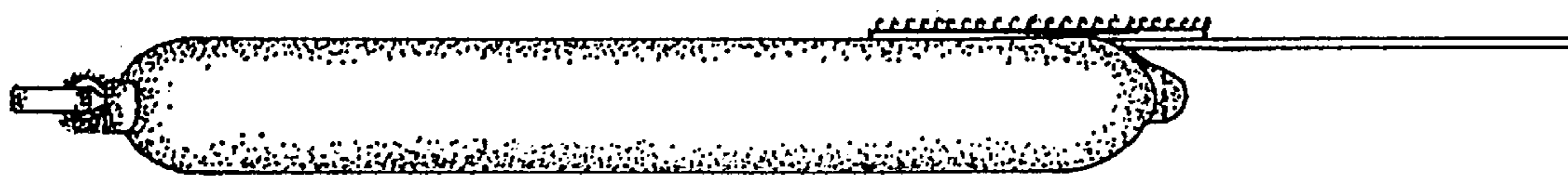

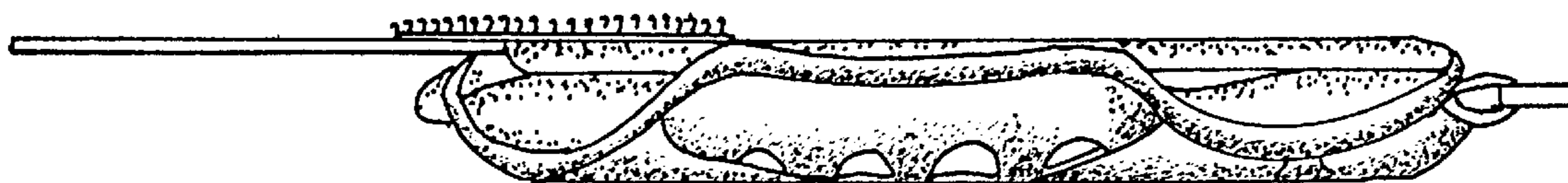

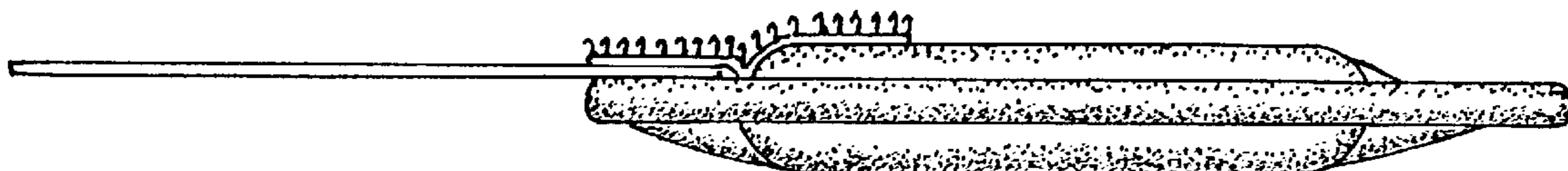

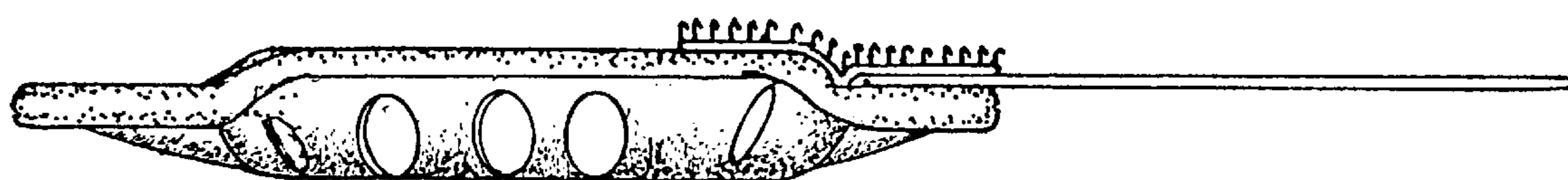

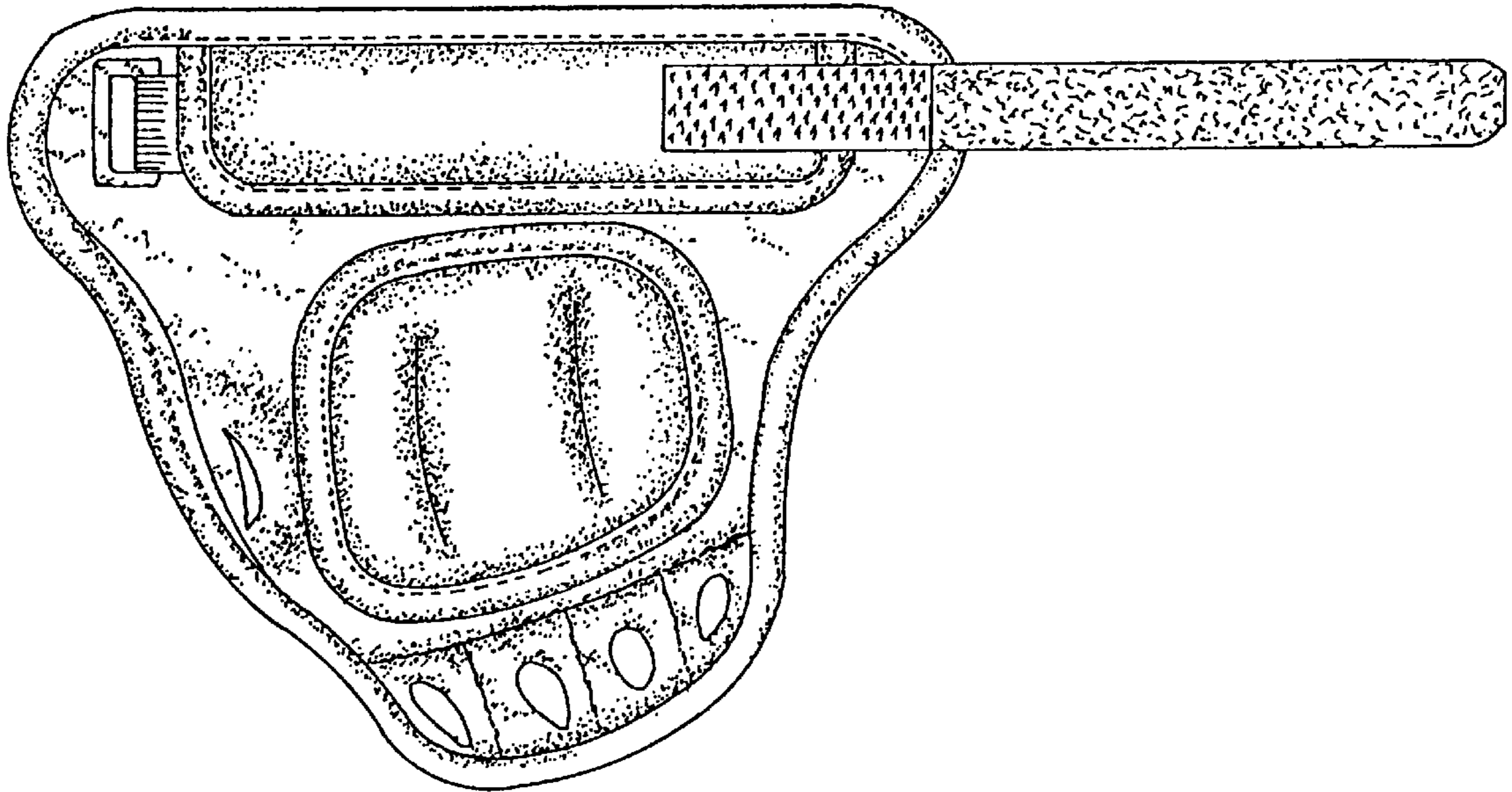

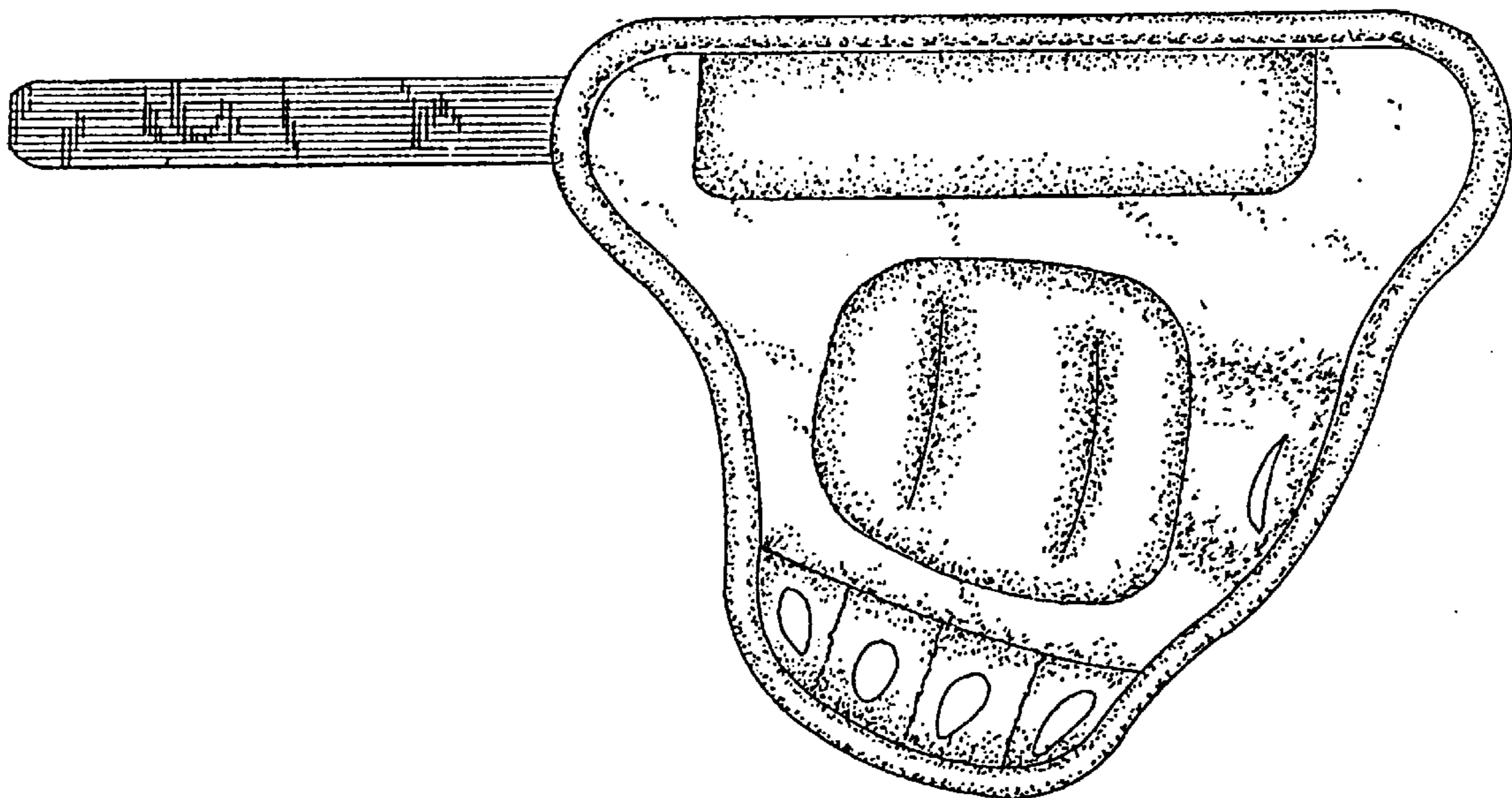

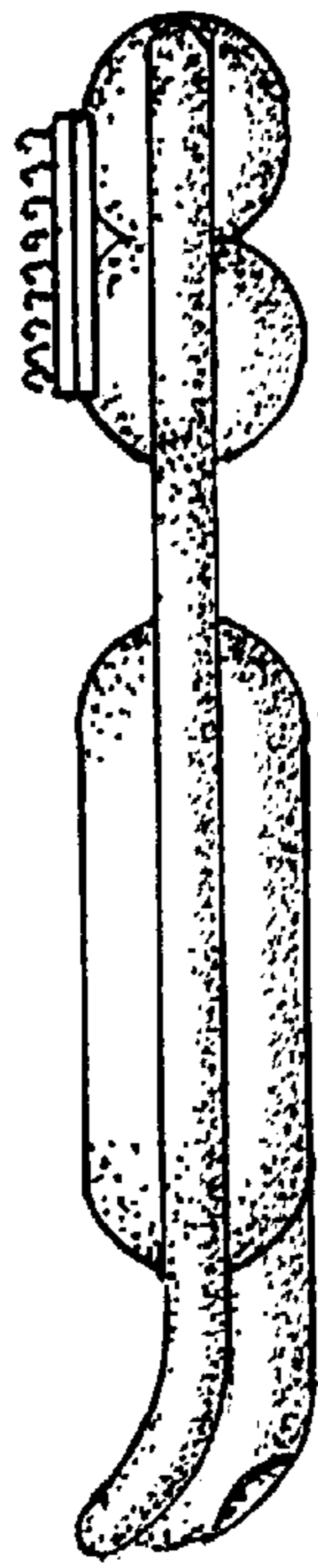

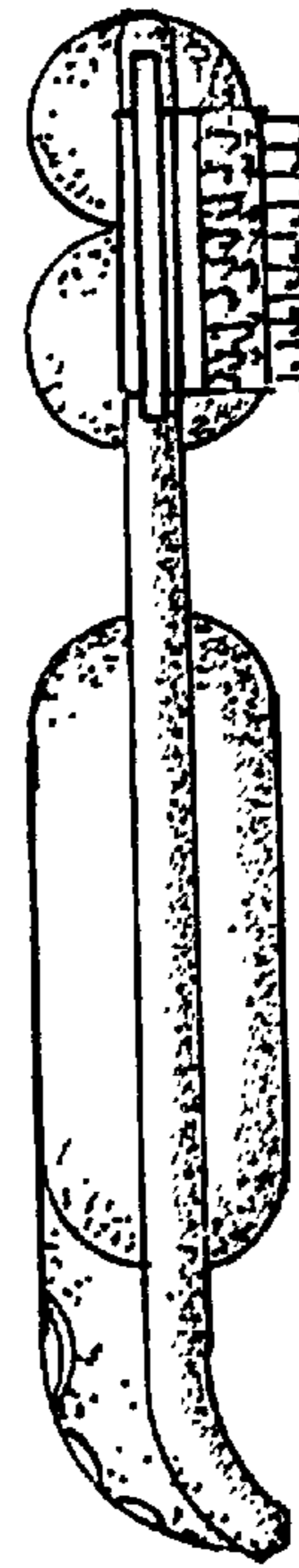

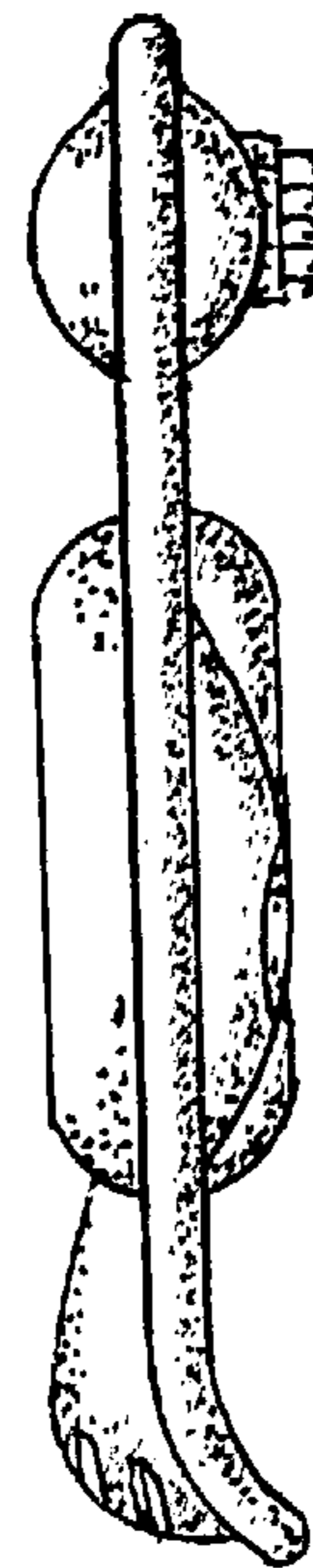
