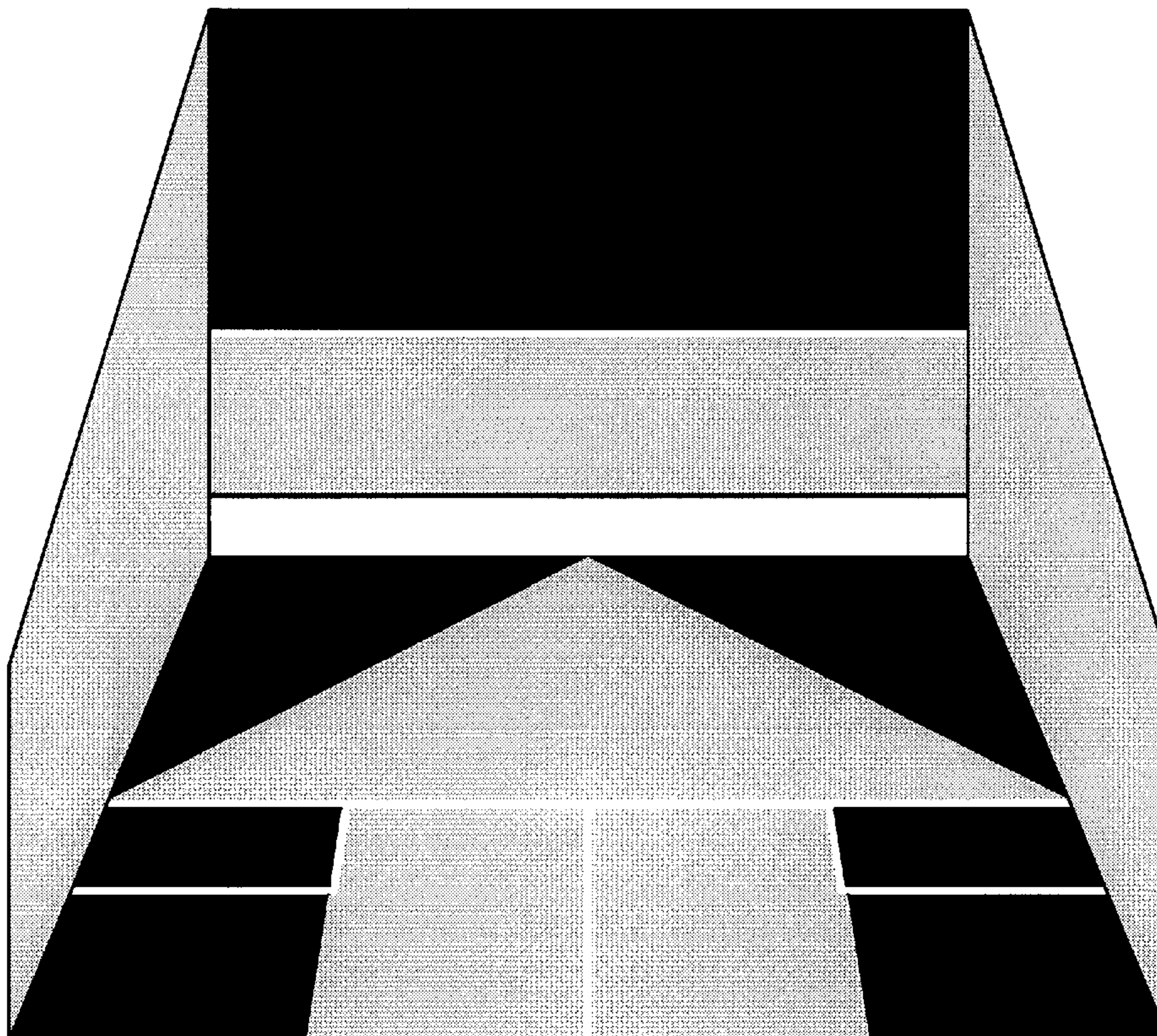
FIG. 1 is a perspective view of an interior surface for a squash court showing my new design;

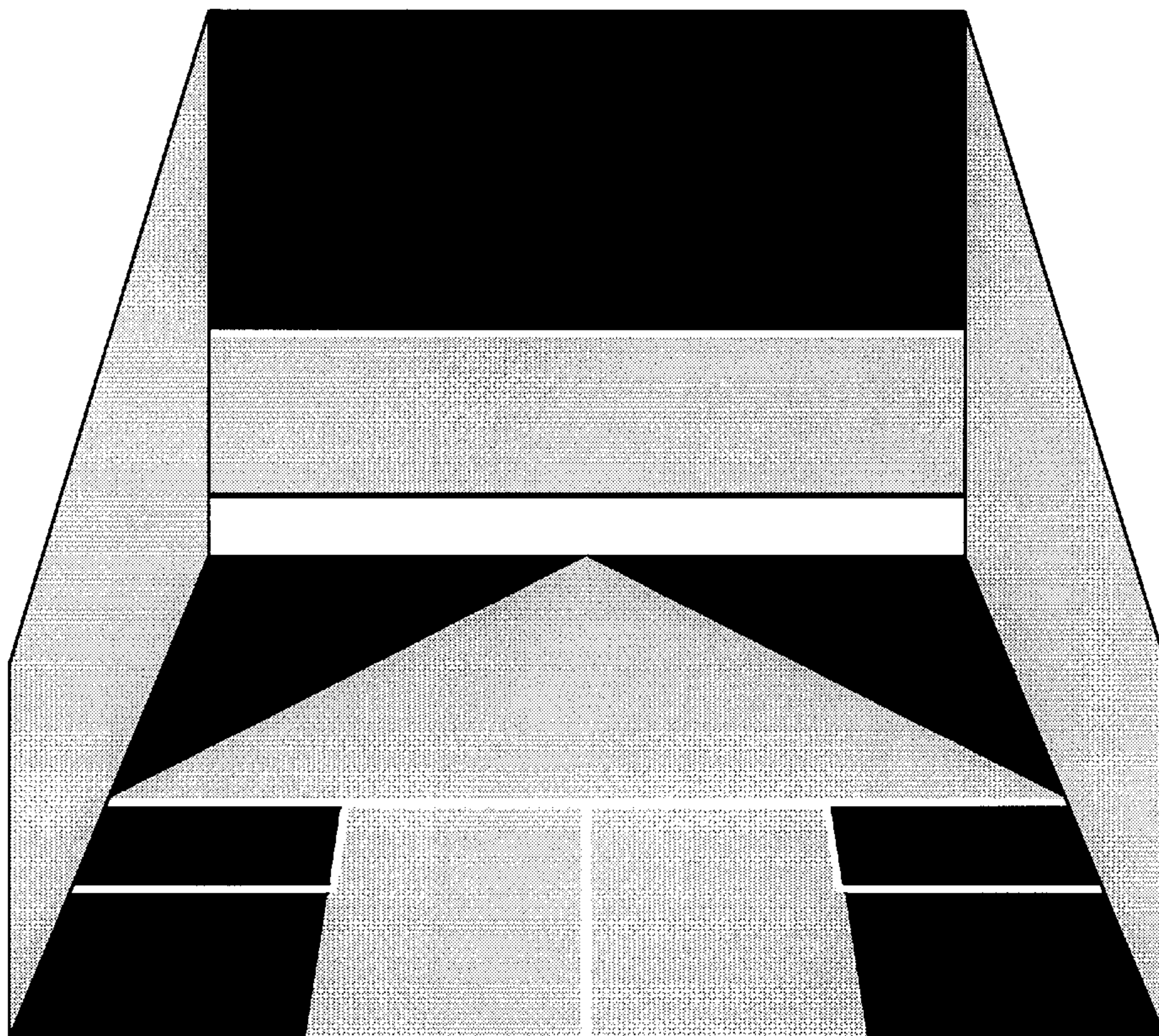

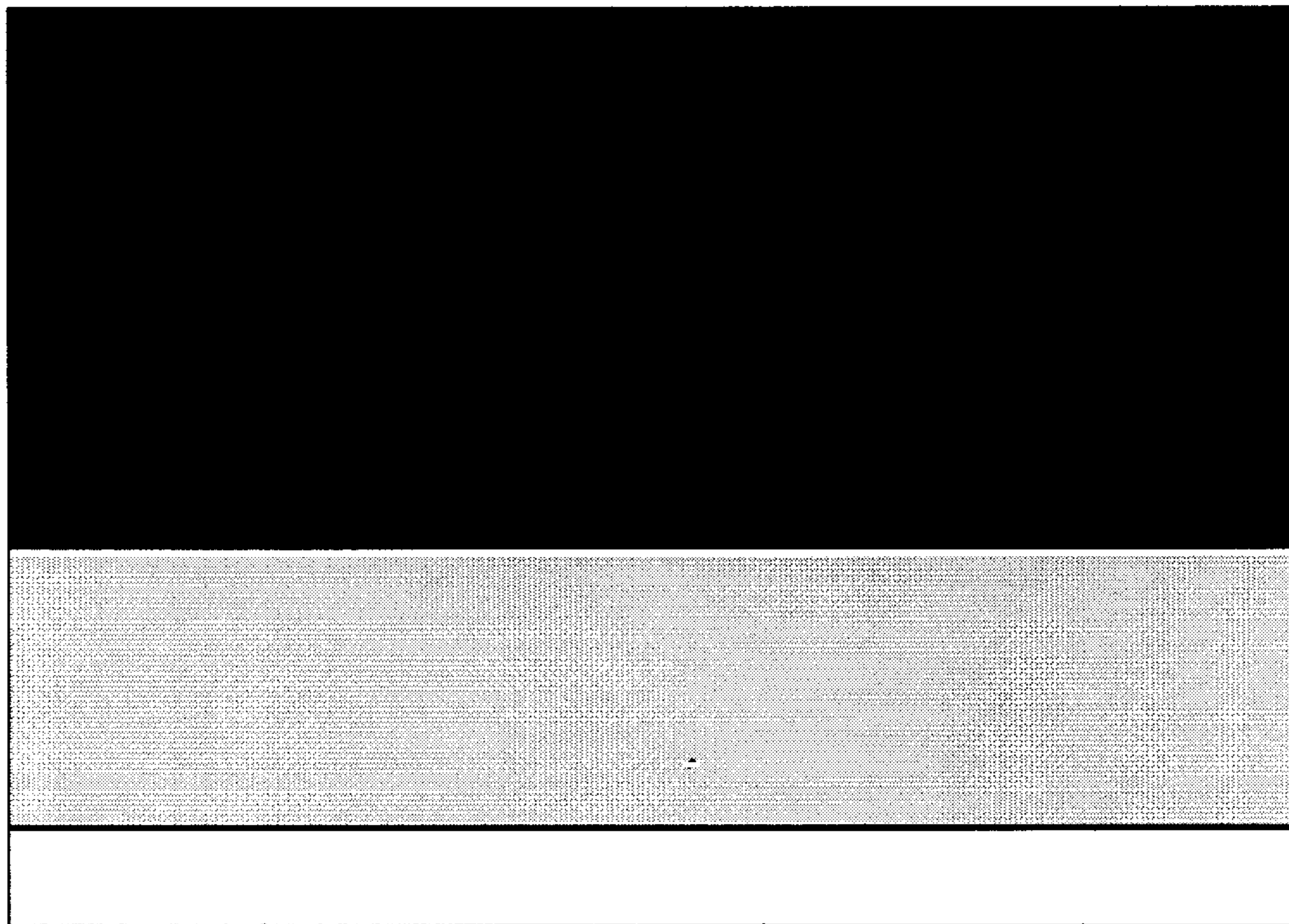

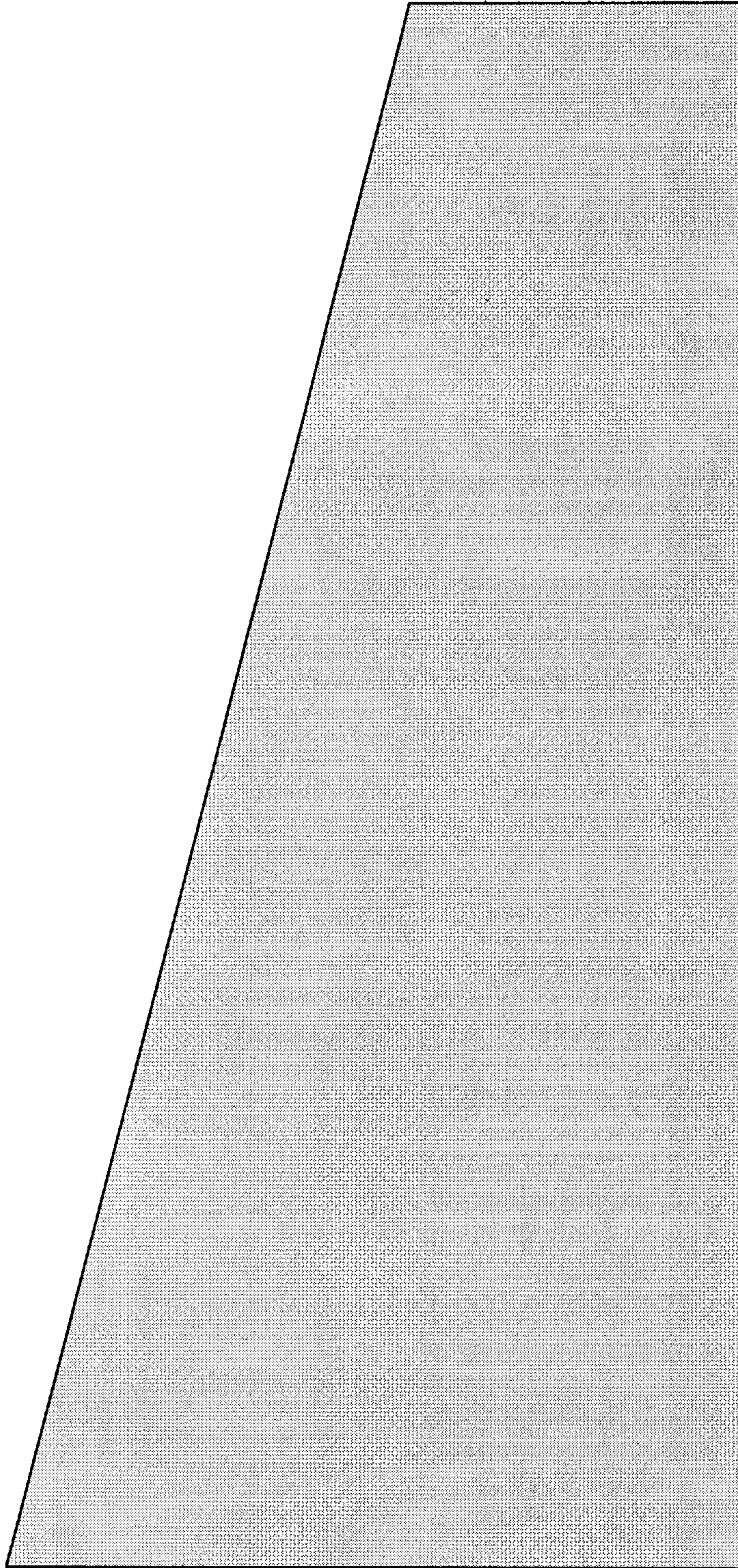

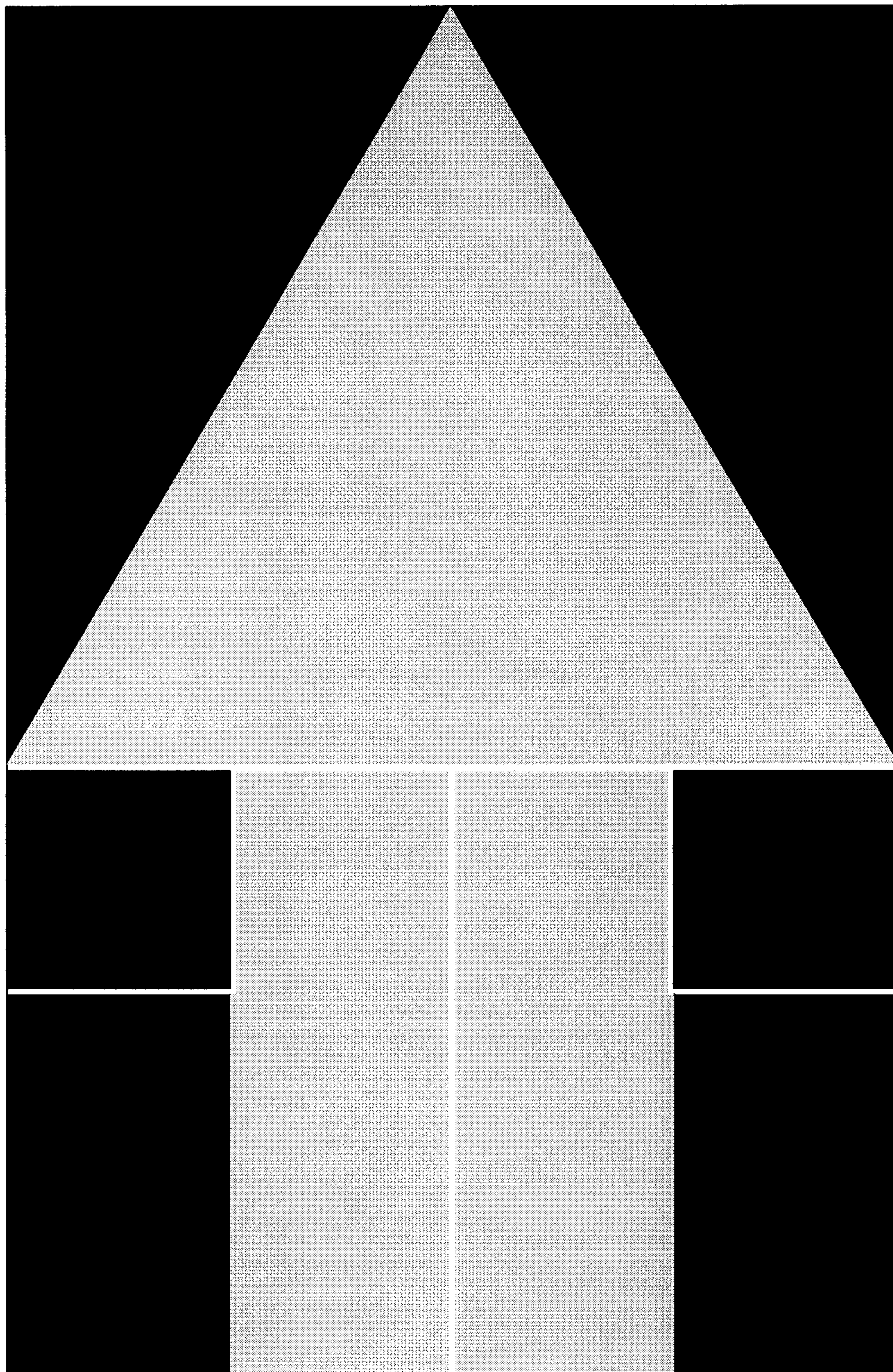
