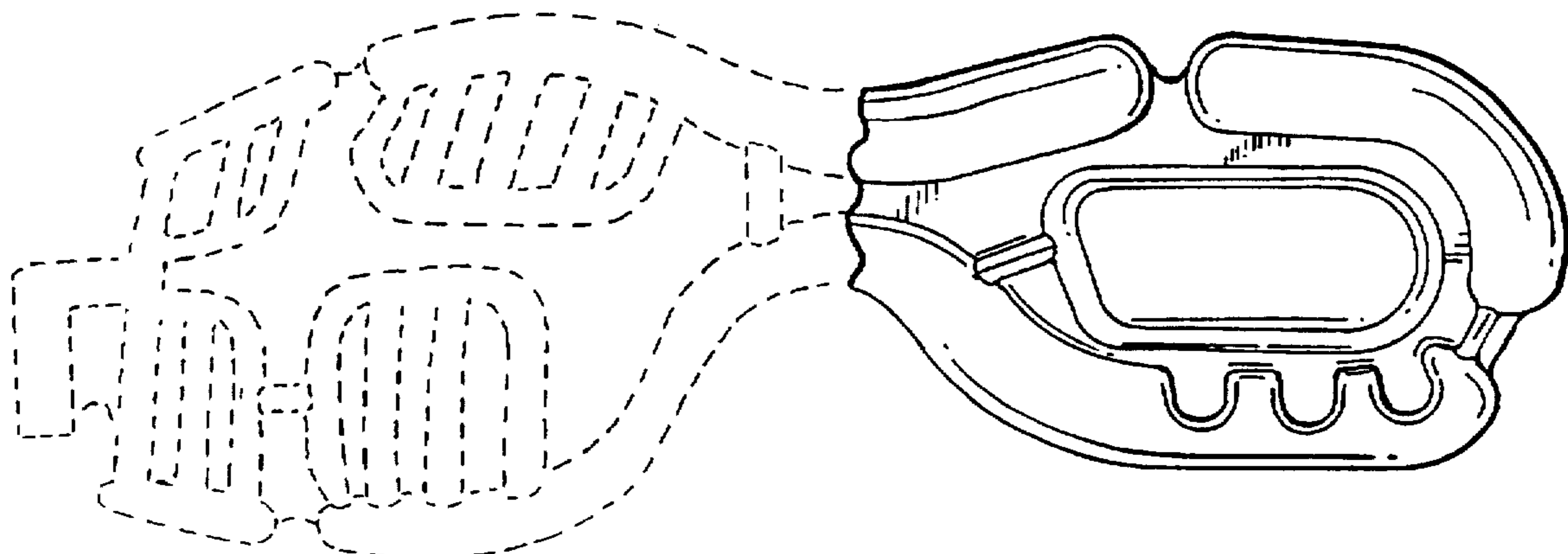

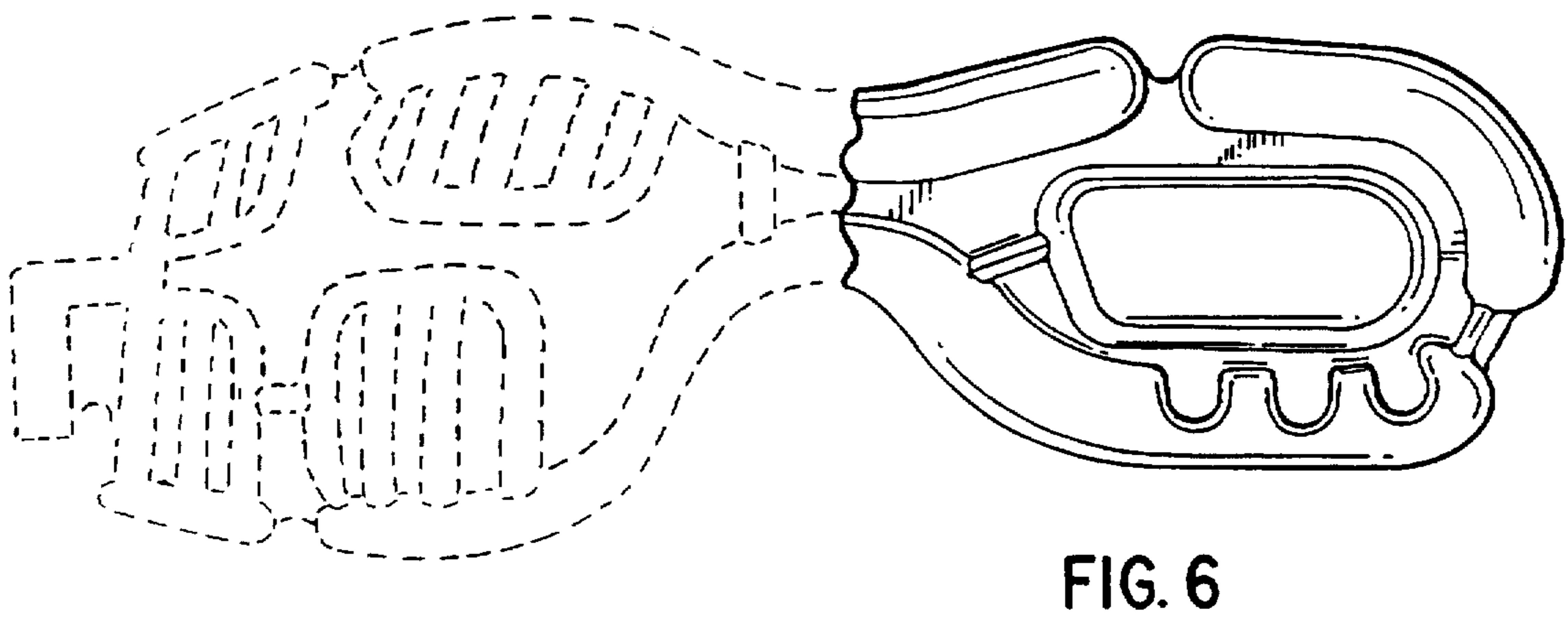
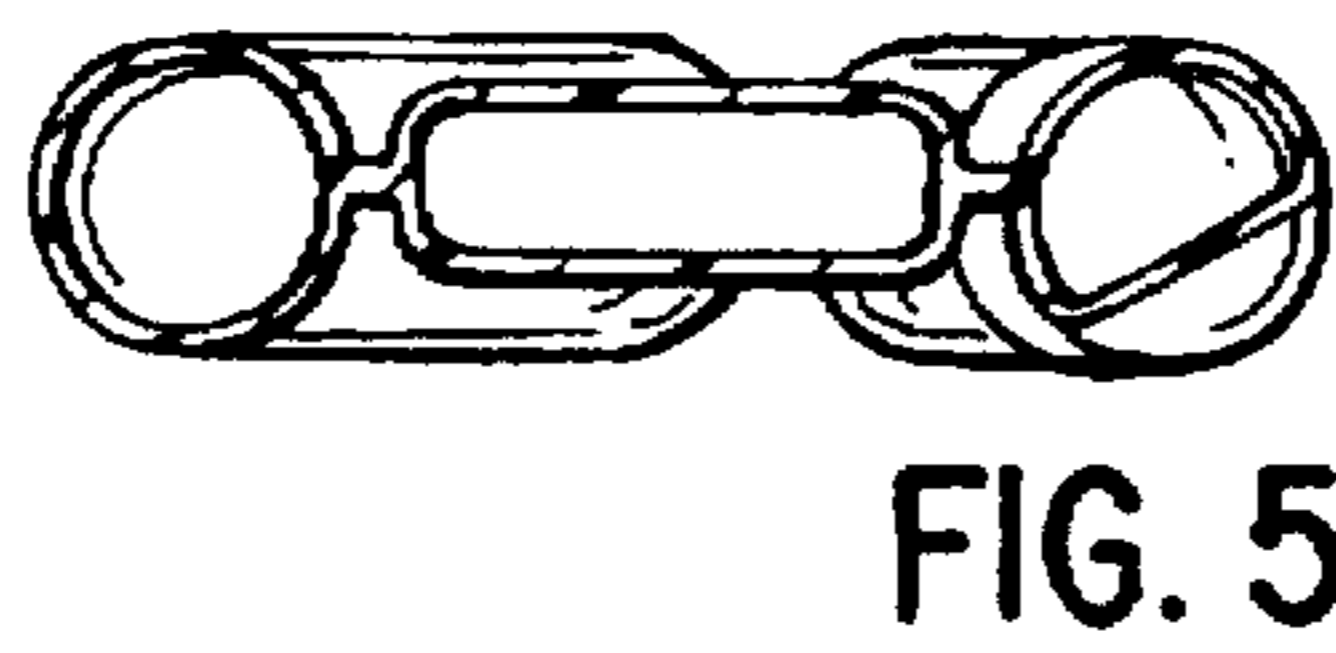
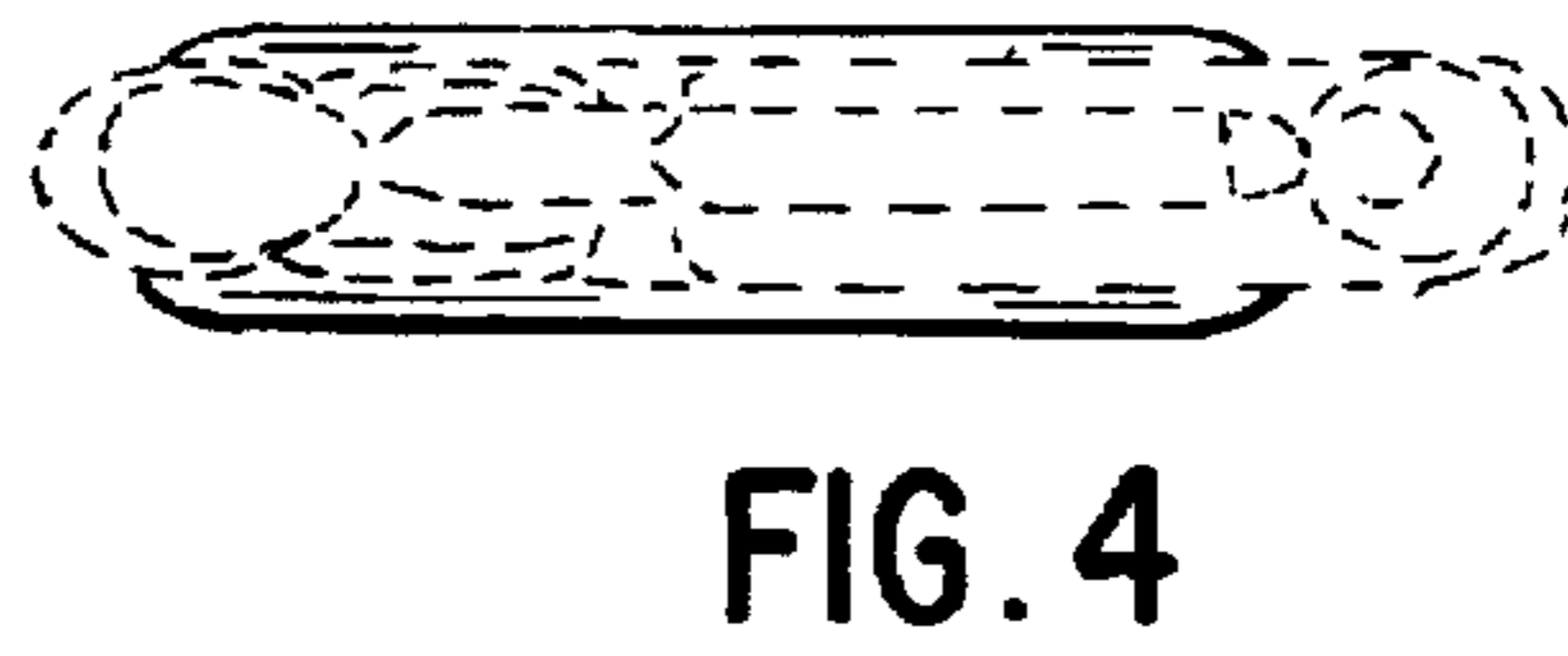
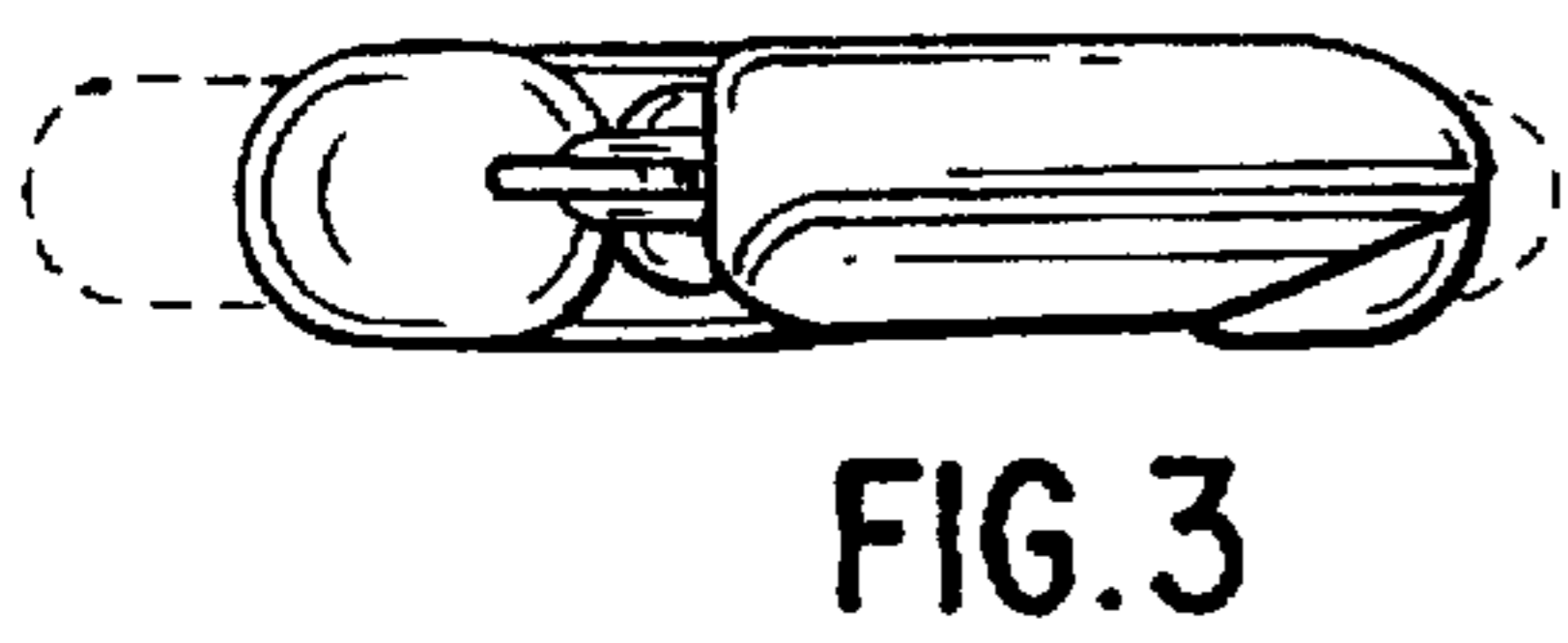
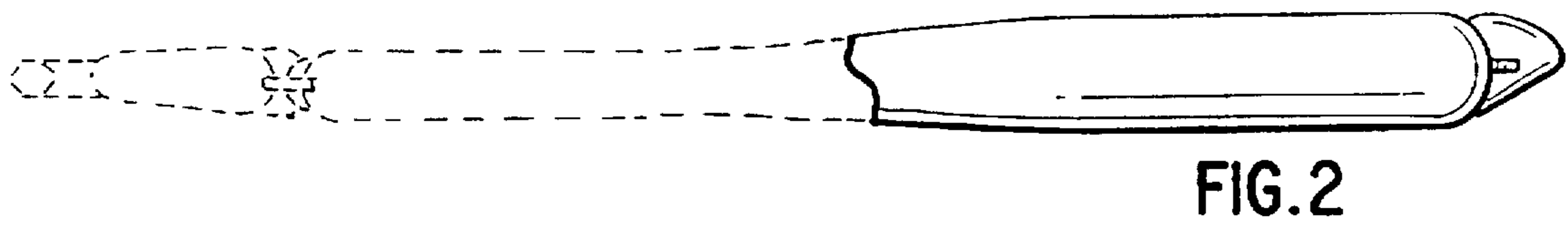
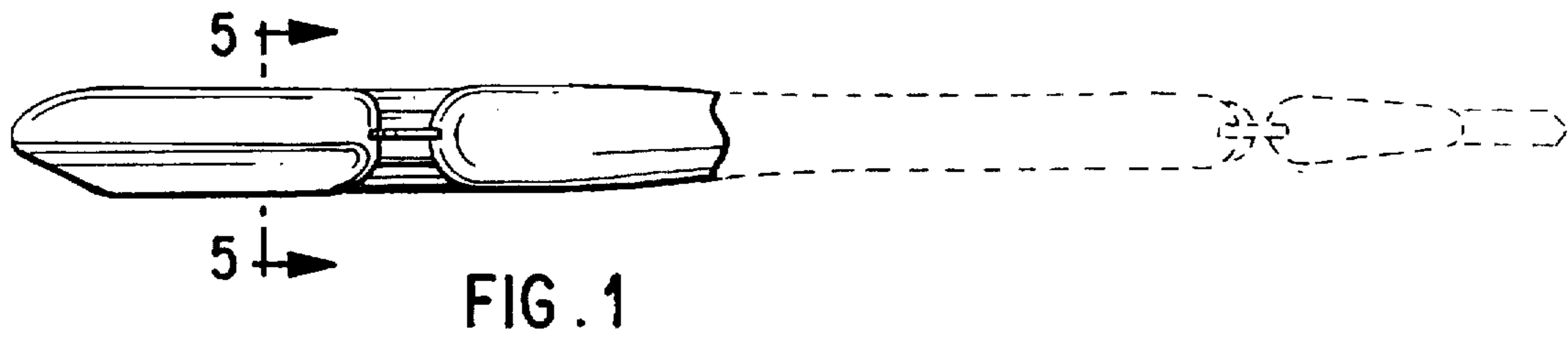
The ornamental design for a portion of a bladder for a shoe sole, as shown and described.

DESCRIPTION

FIG. 1 is a side elevational view of one side of a portion of a bladder for a shoe sole showing our new design; FIG. 2 is a side elevational view of the other side thereof; FIG. 3 is a rear elevational view thereof; FIG. 4 is a front elevational view thereof; FIG. 5 is a cross-sectional view taken along line 5-5 of FIG. 1; FIG. 6 is a top plan view thereof; and, FIG. 7 is a bottom plan view thereof. The broken line showing of the remainder of the bladder in FIGS. 1-7 is for illustrative purposes only and forms no part of the claimed design.

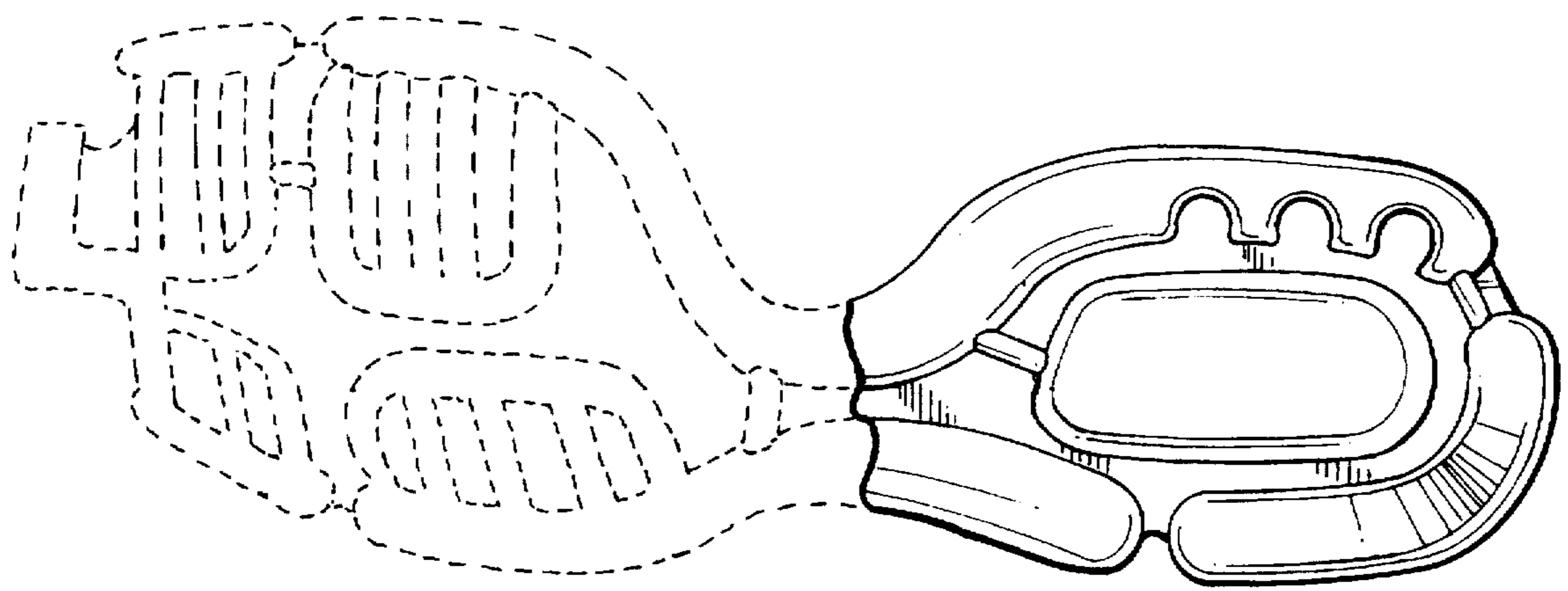
