The ornamental design for trailer for personal watercraft and support rack therefor, as shown and described.

DESCRIPTION

FIG. 1 is a side view of a trailer for personal watercraft and support rack therefor showing our new design, the broken lines are for illustrative purposes only and form no part of the claimed design;

FIG. 2 is a rear view thereof;

FIG. 3 is a front view thereof;

FIG. 4 is a top perspective view of the support rack portion thereof;

FIG. 5 is a side elevational view of FIG. 4;

FIG. 9 is a top perspective view of the trailer for personal watercraft portion thereof;

FIG. 12 is a rear end elevational view of FIG. 9;

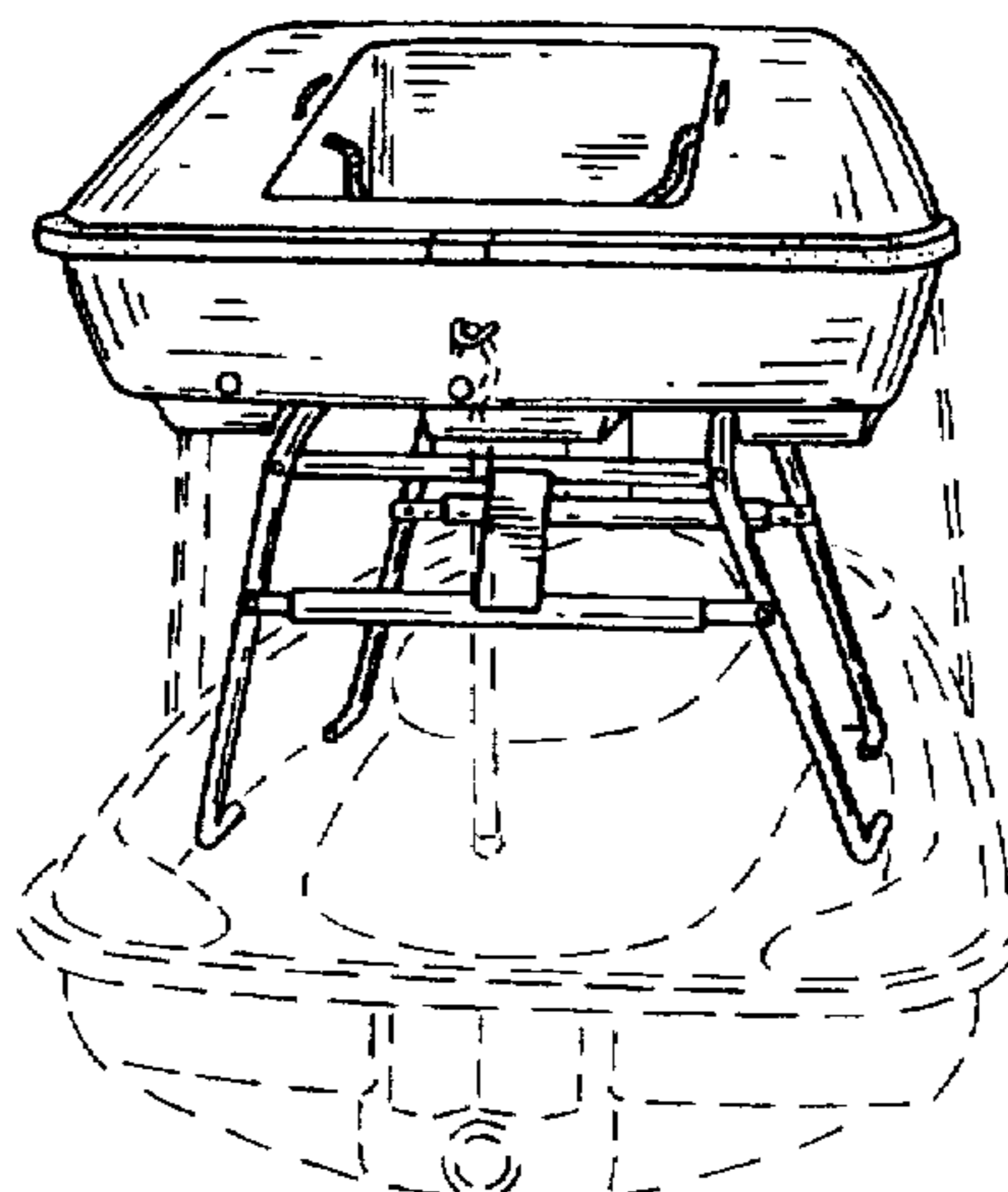
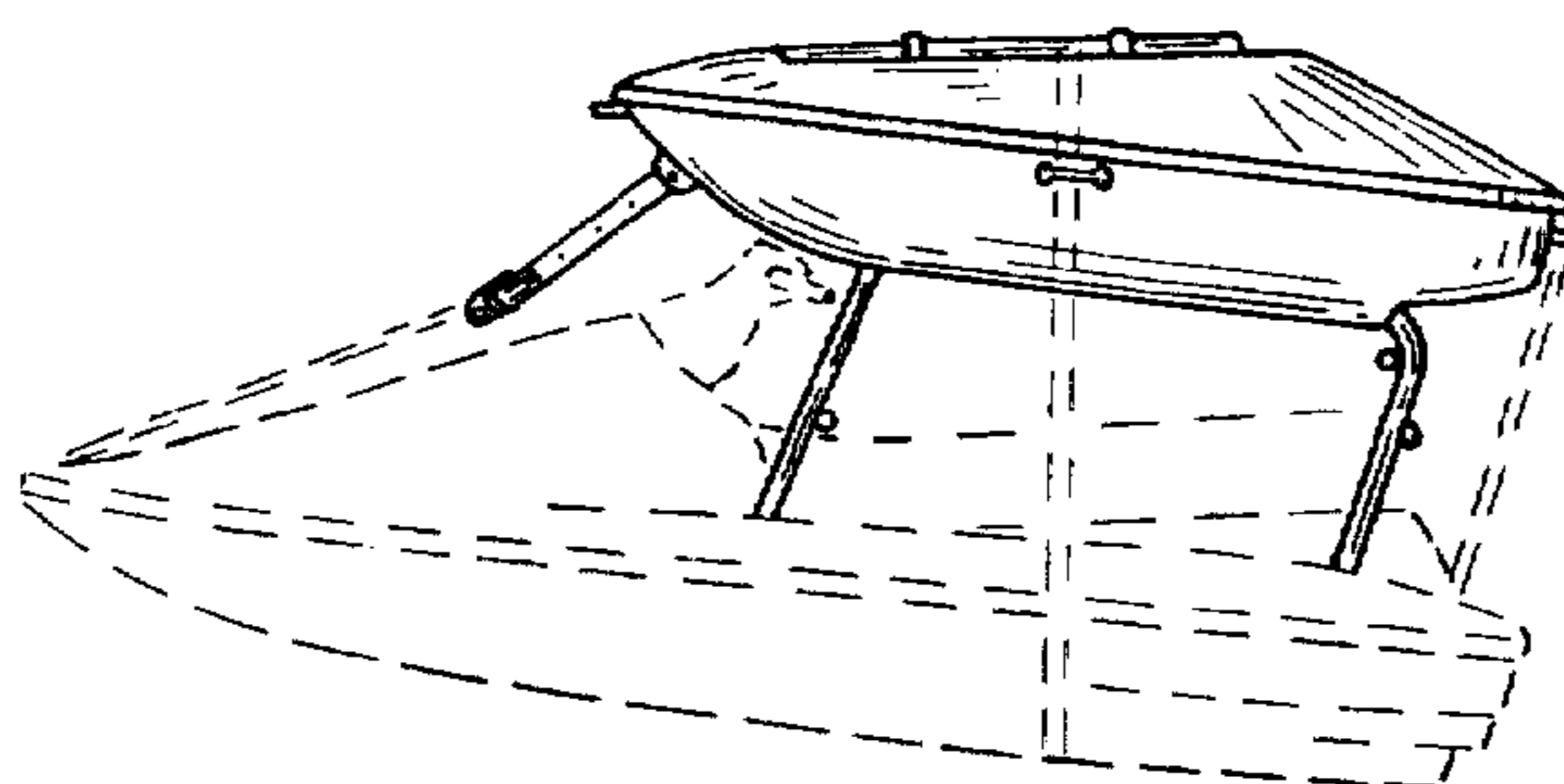
FIG. 13 is a side elevational view of FIG. 9;

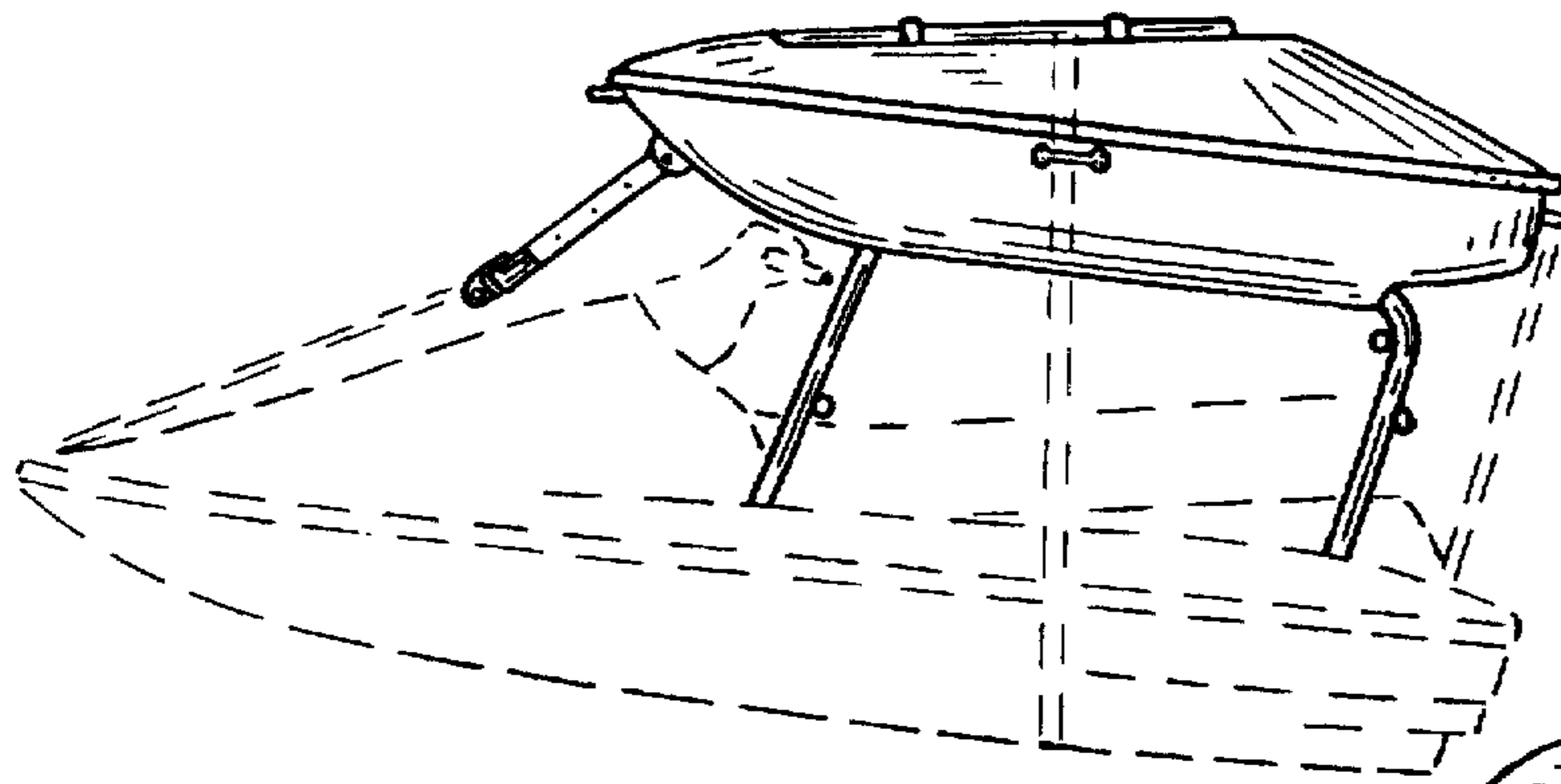

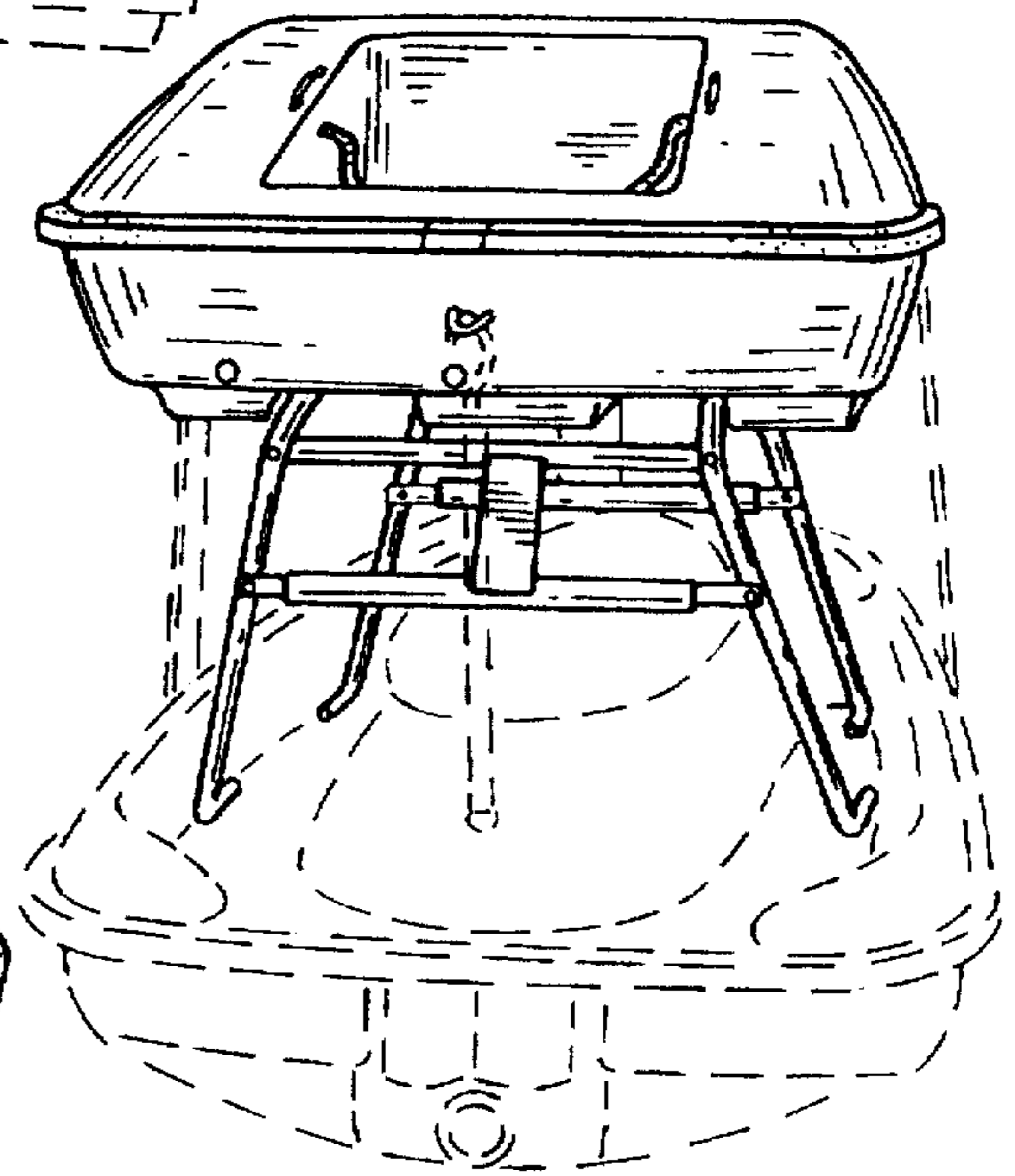

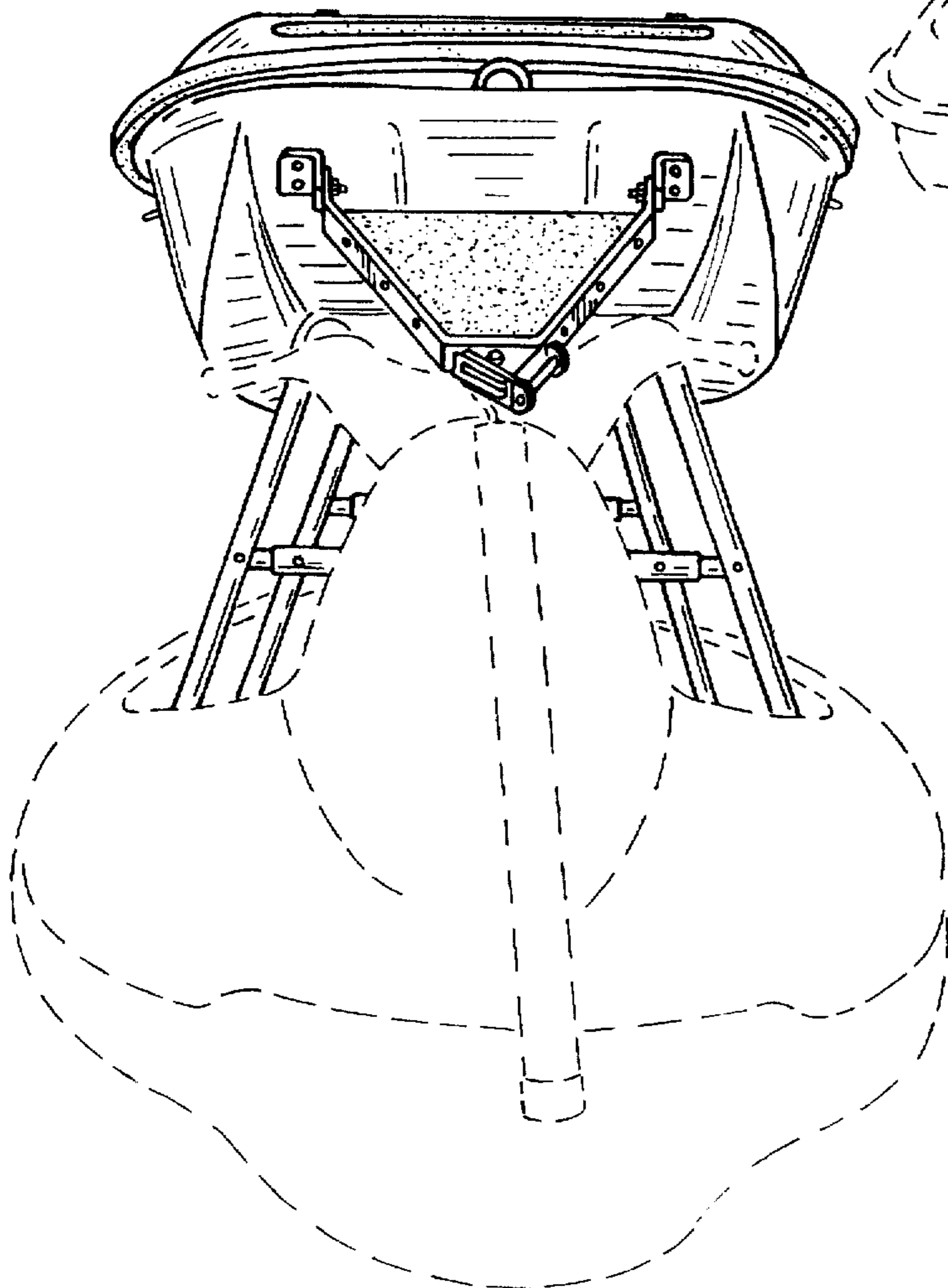

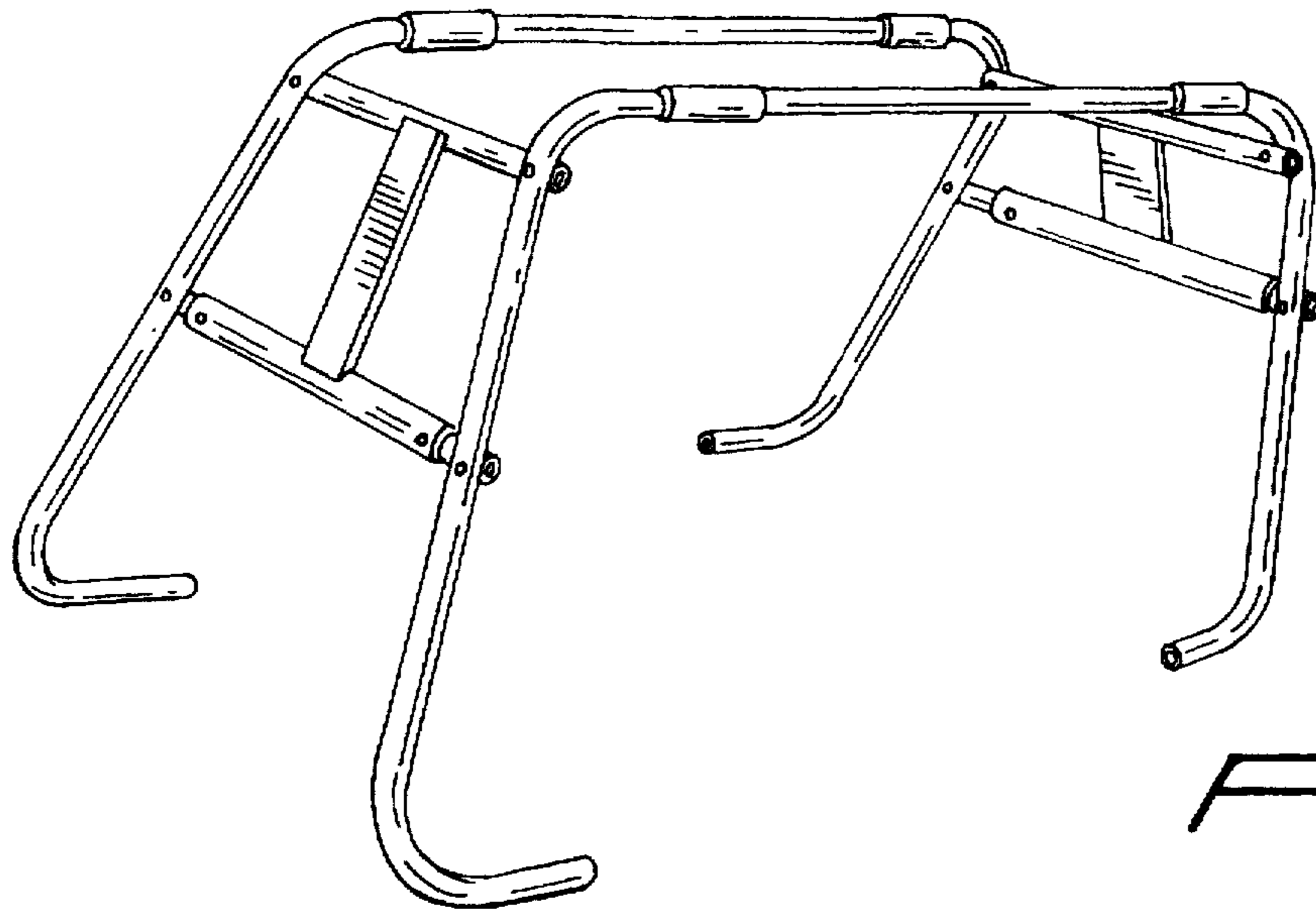

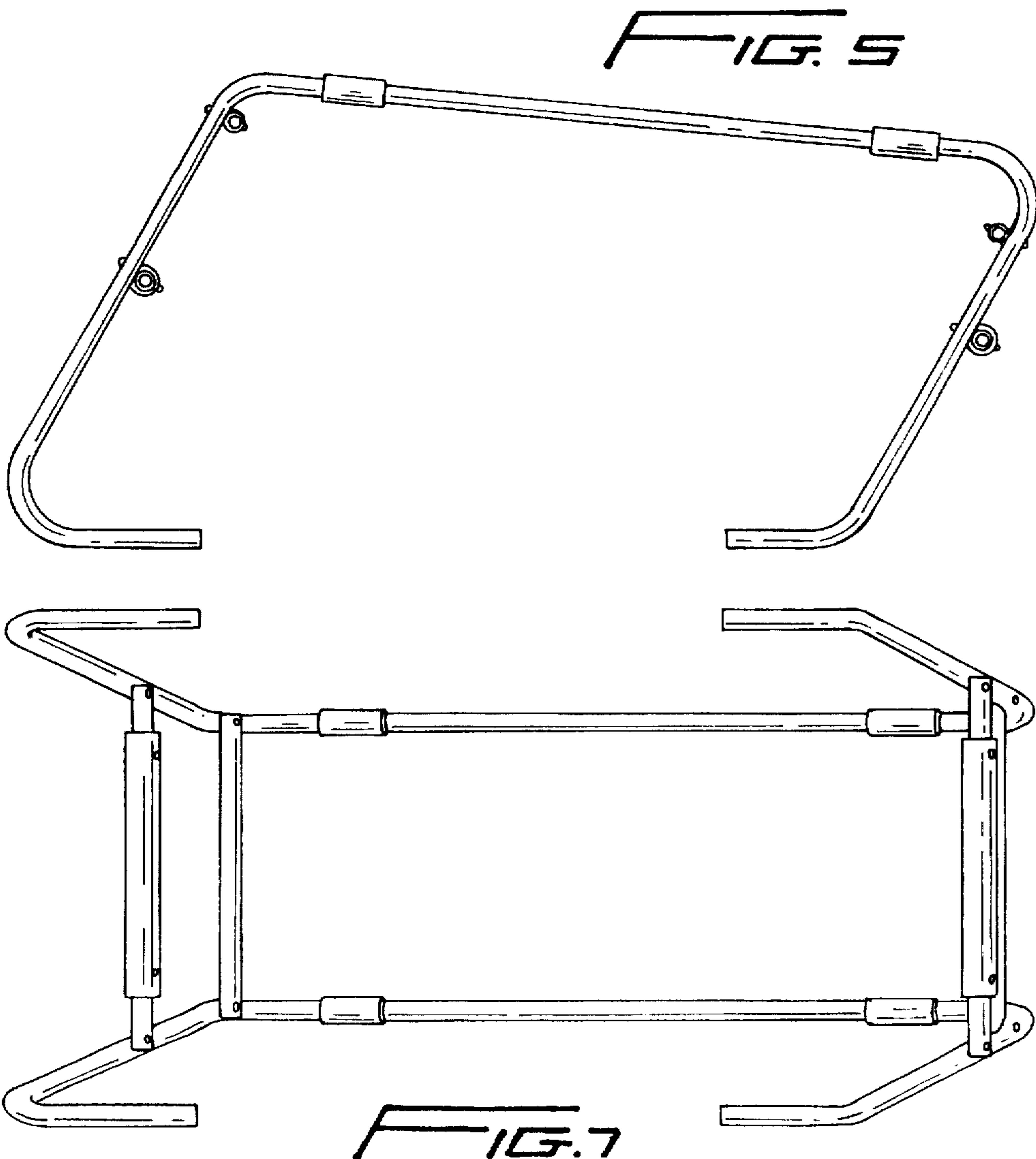

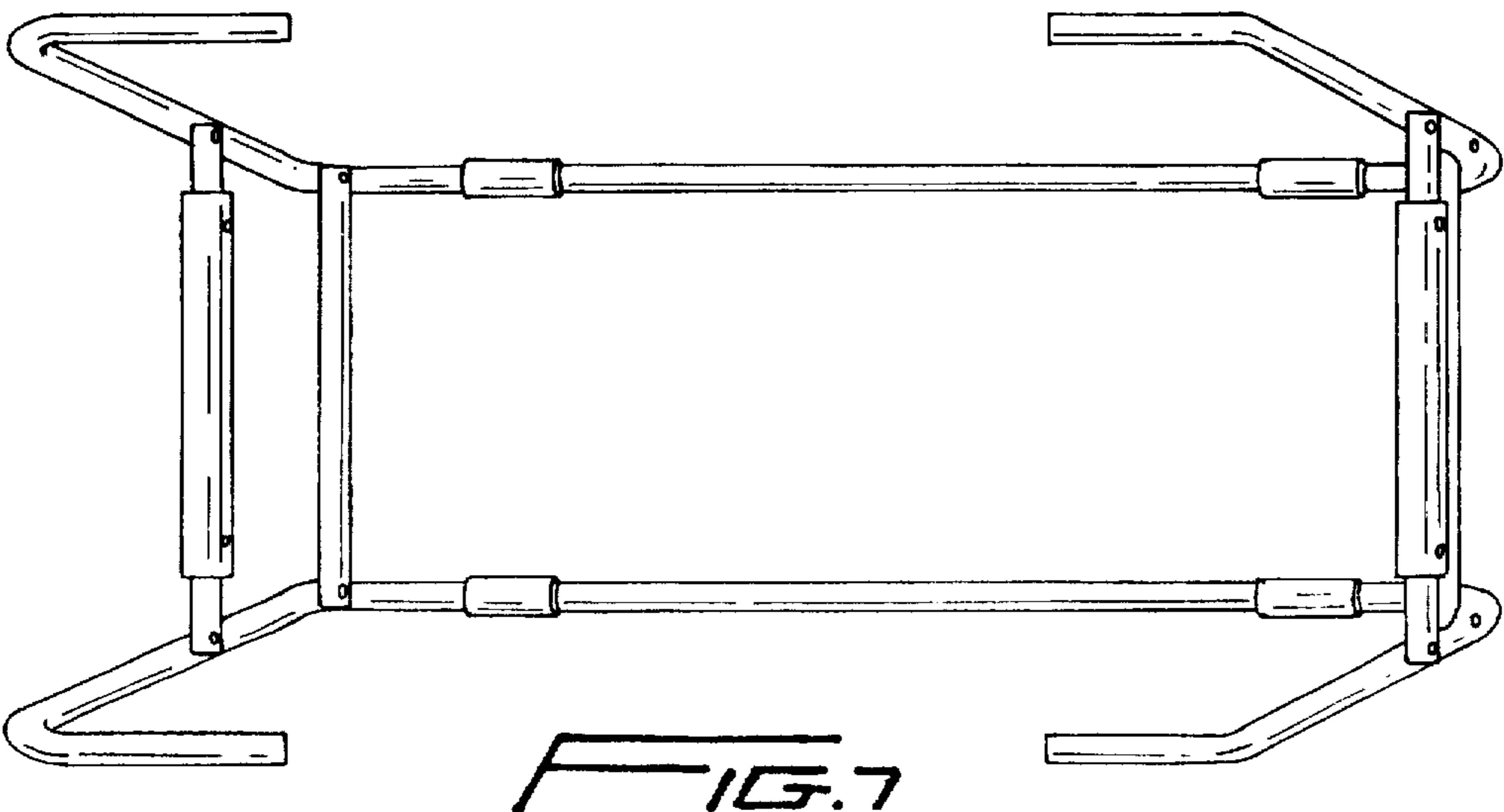

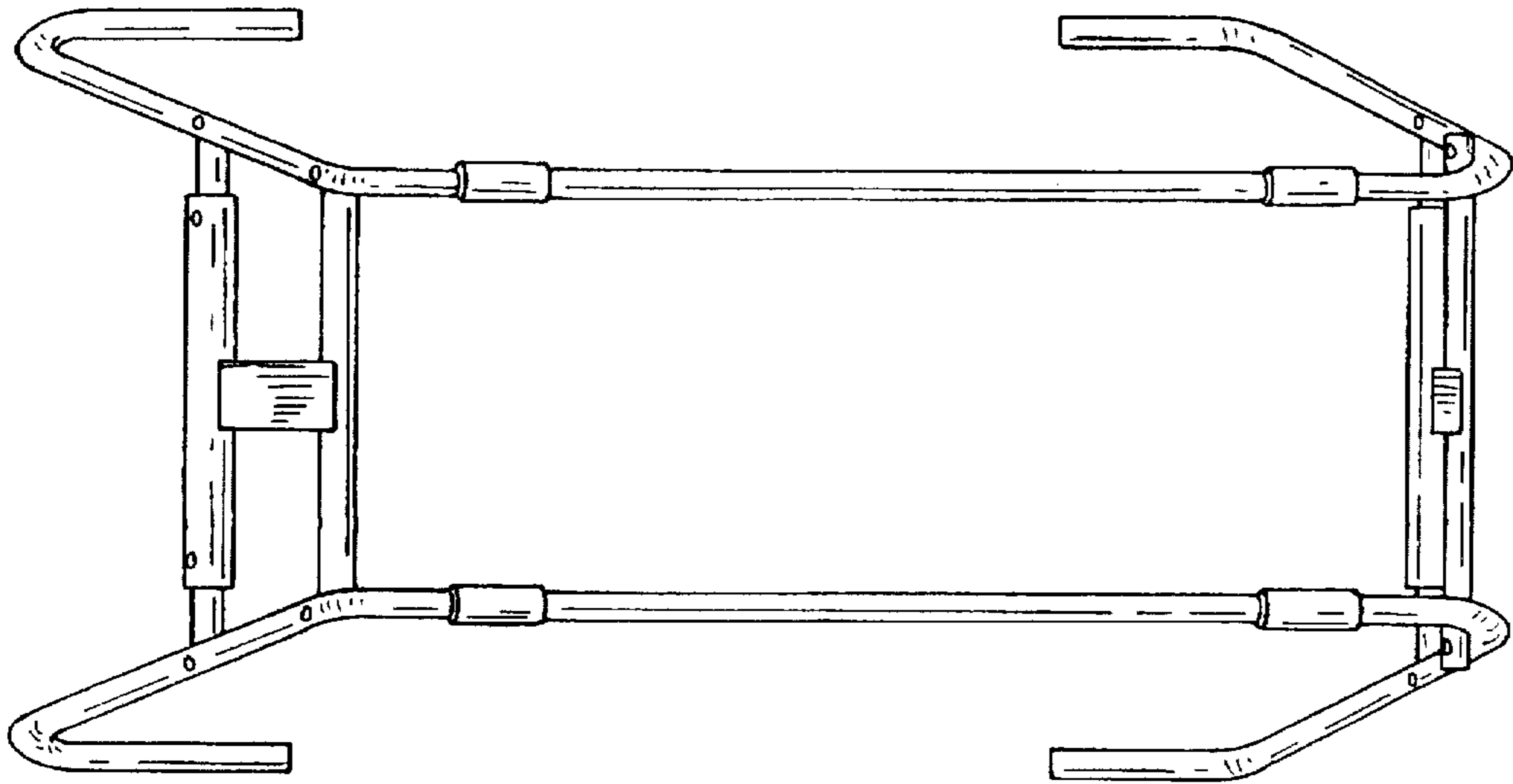

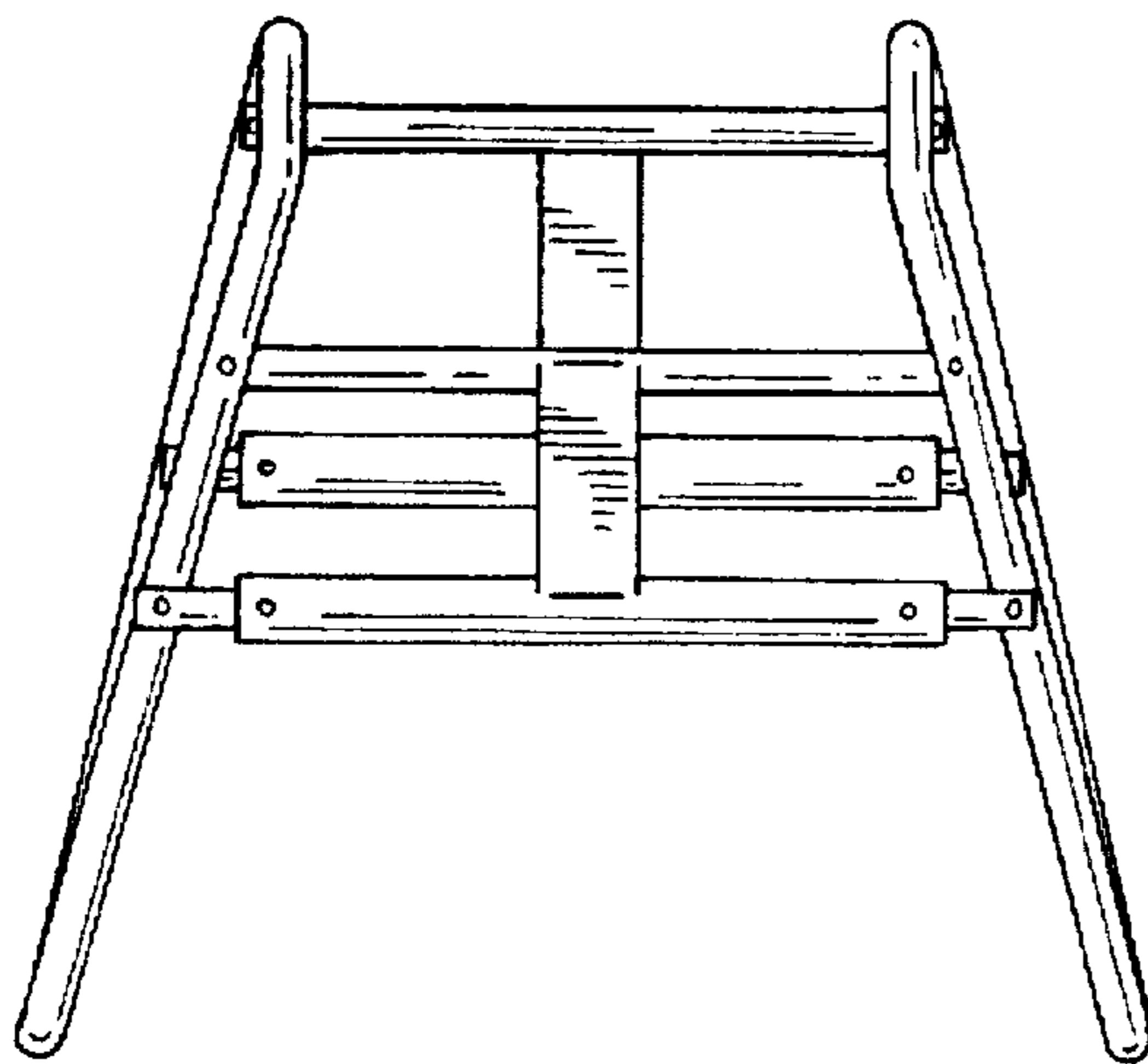

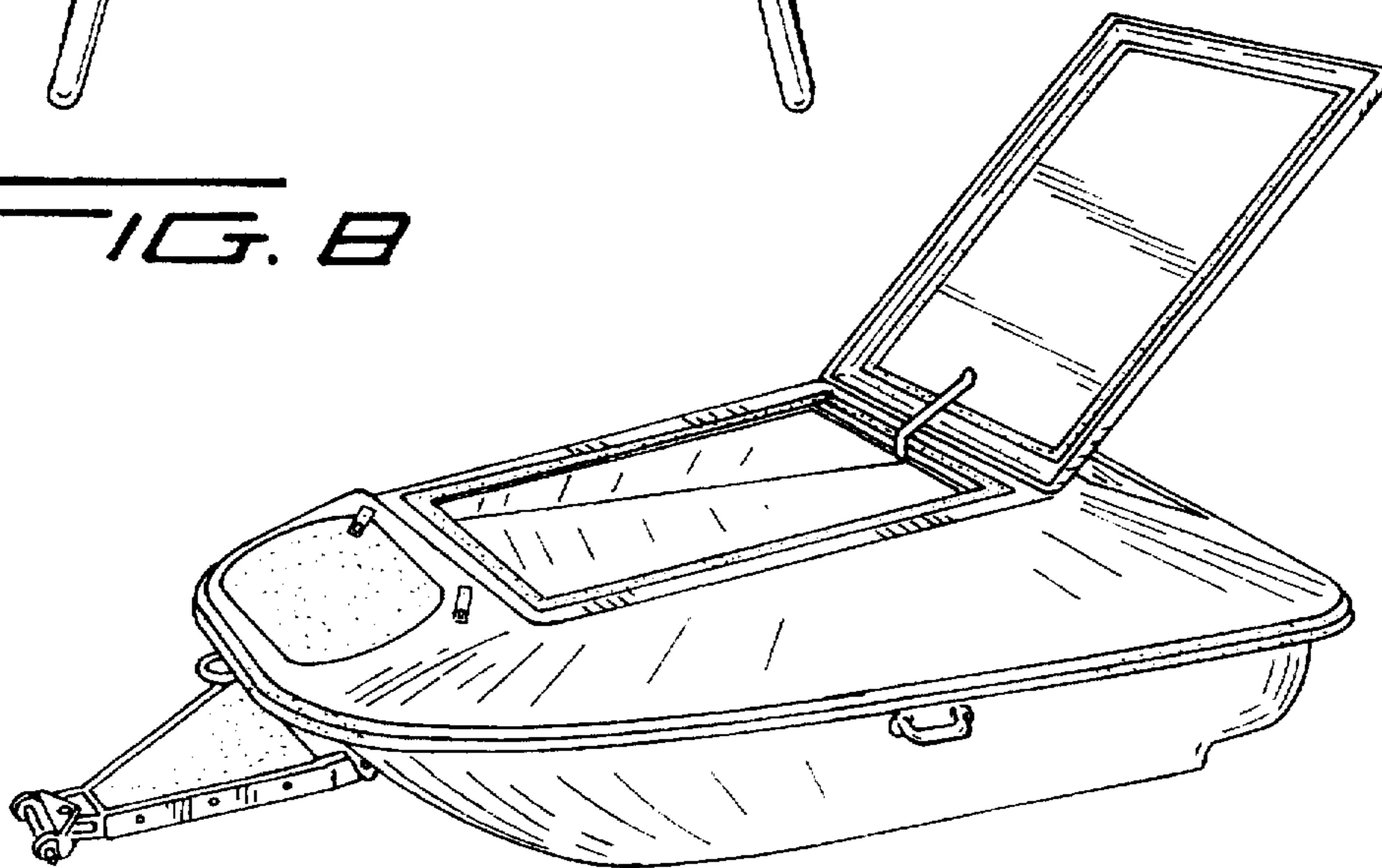

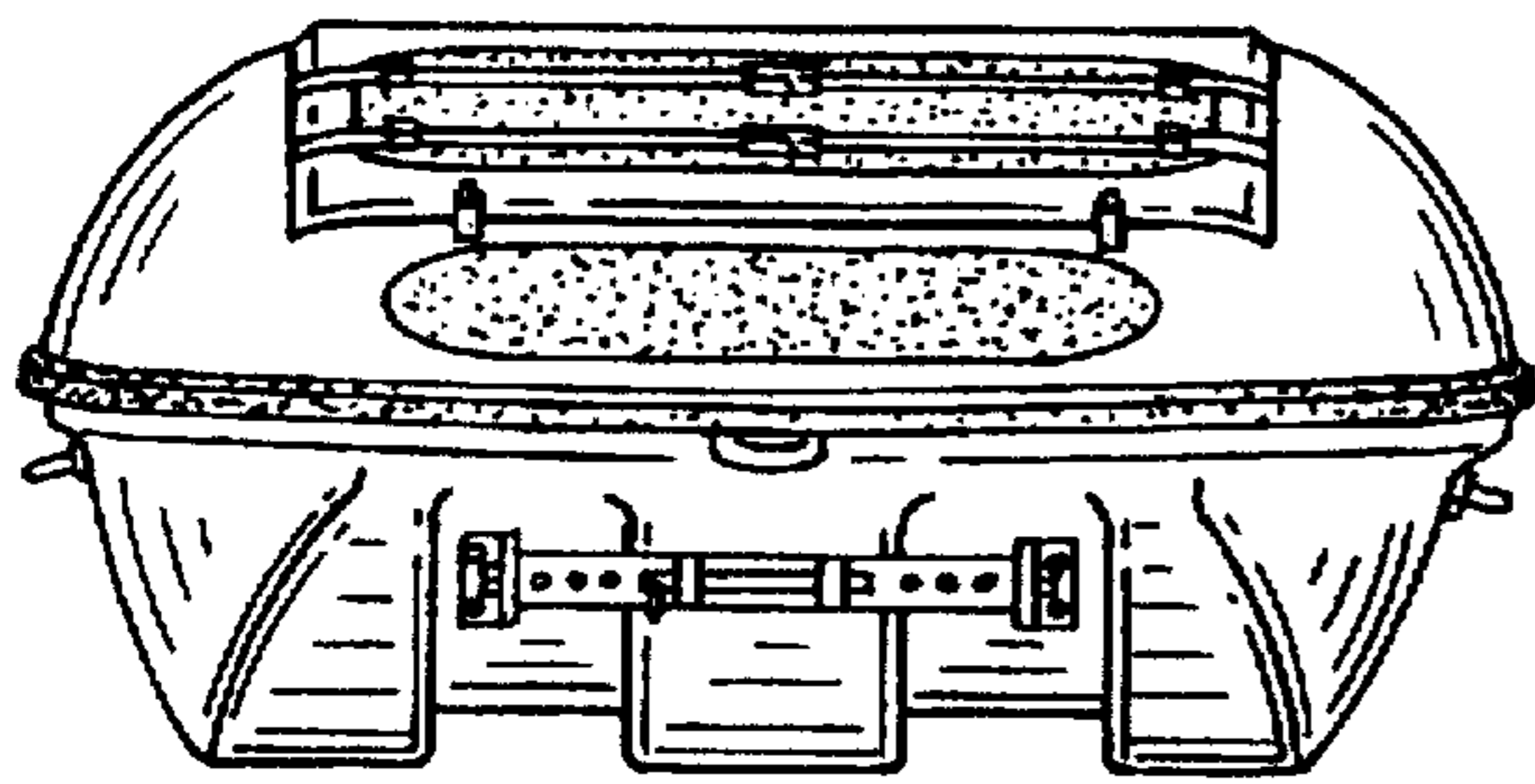

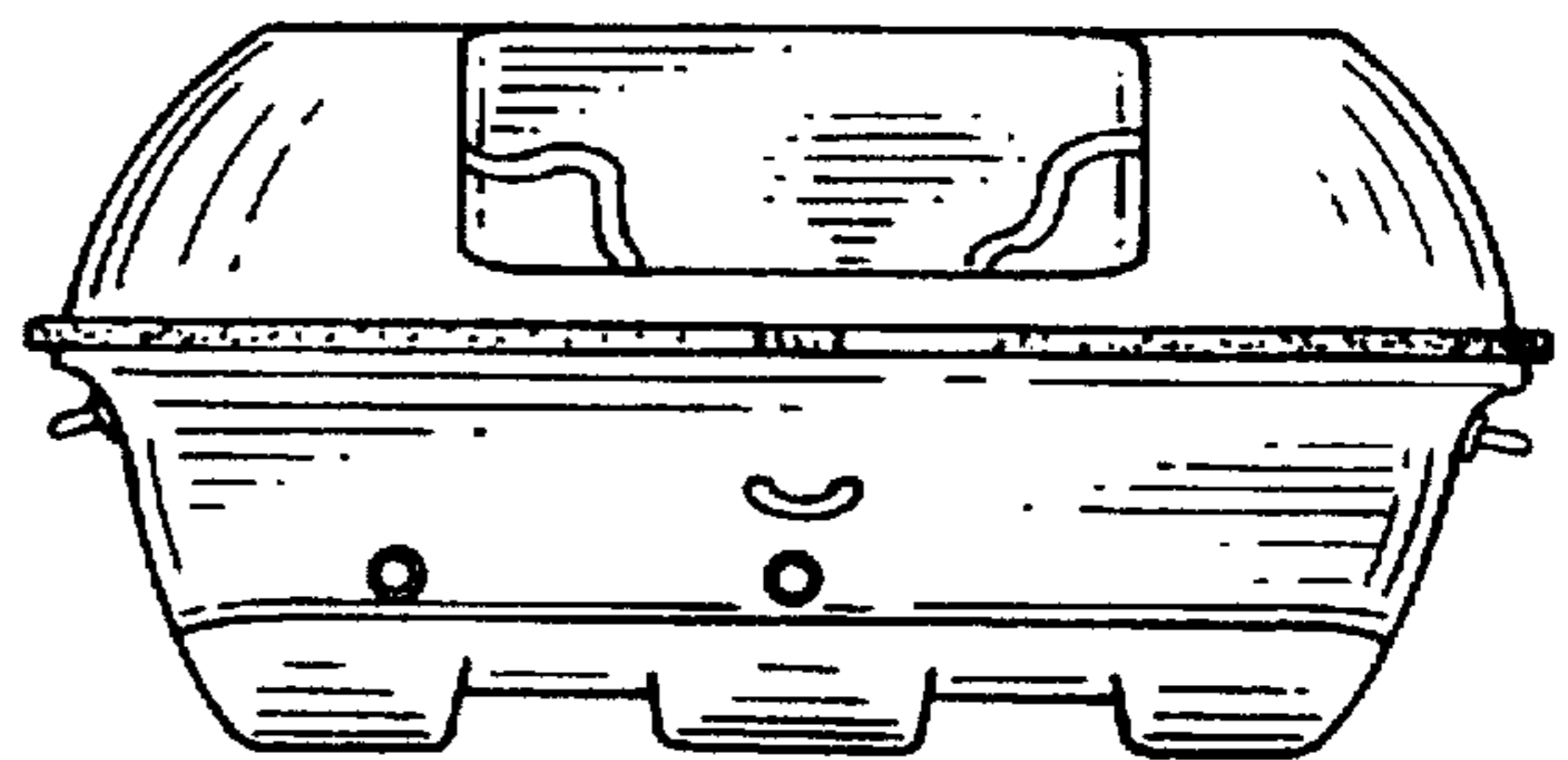

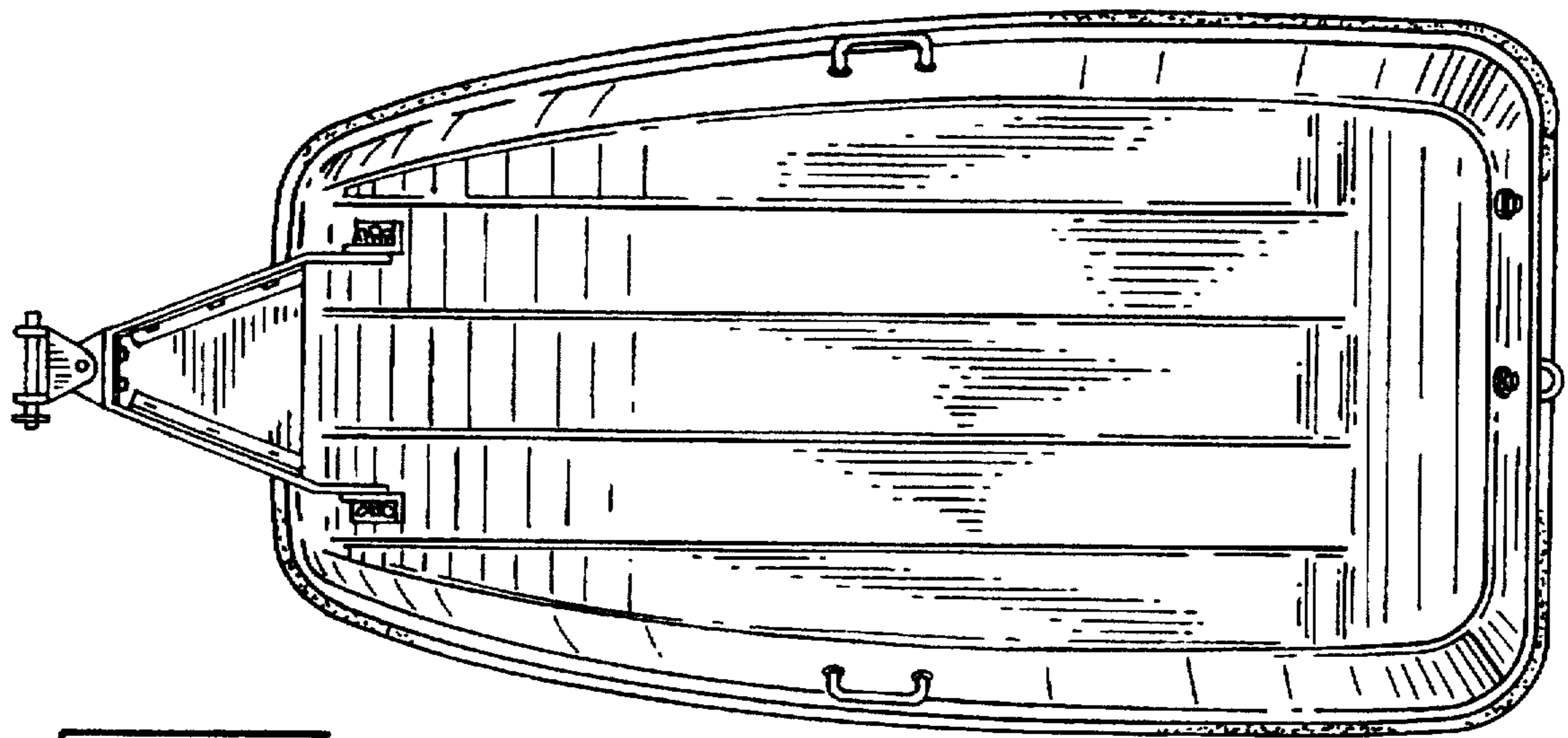

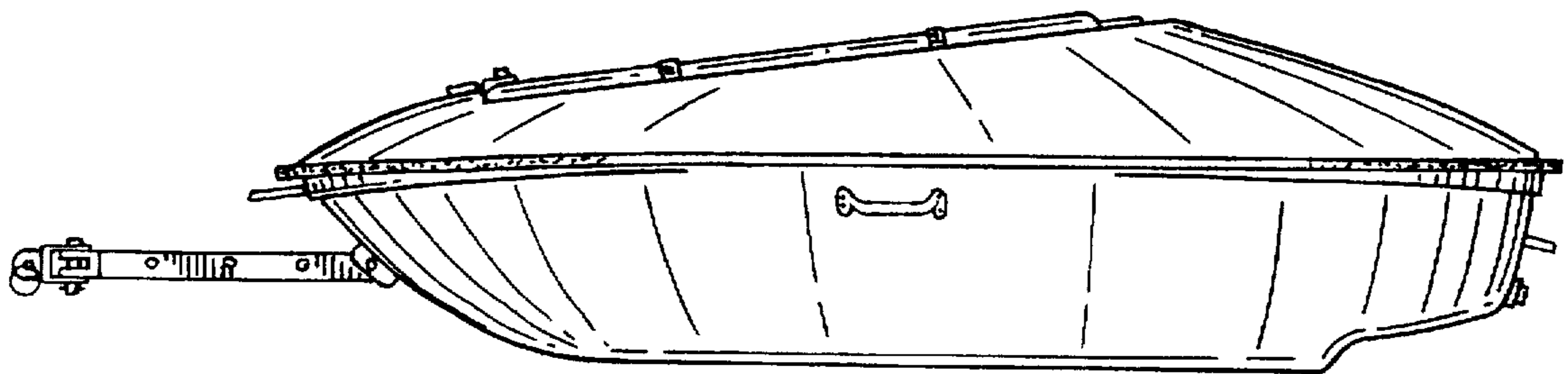

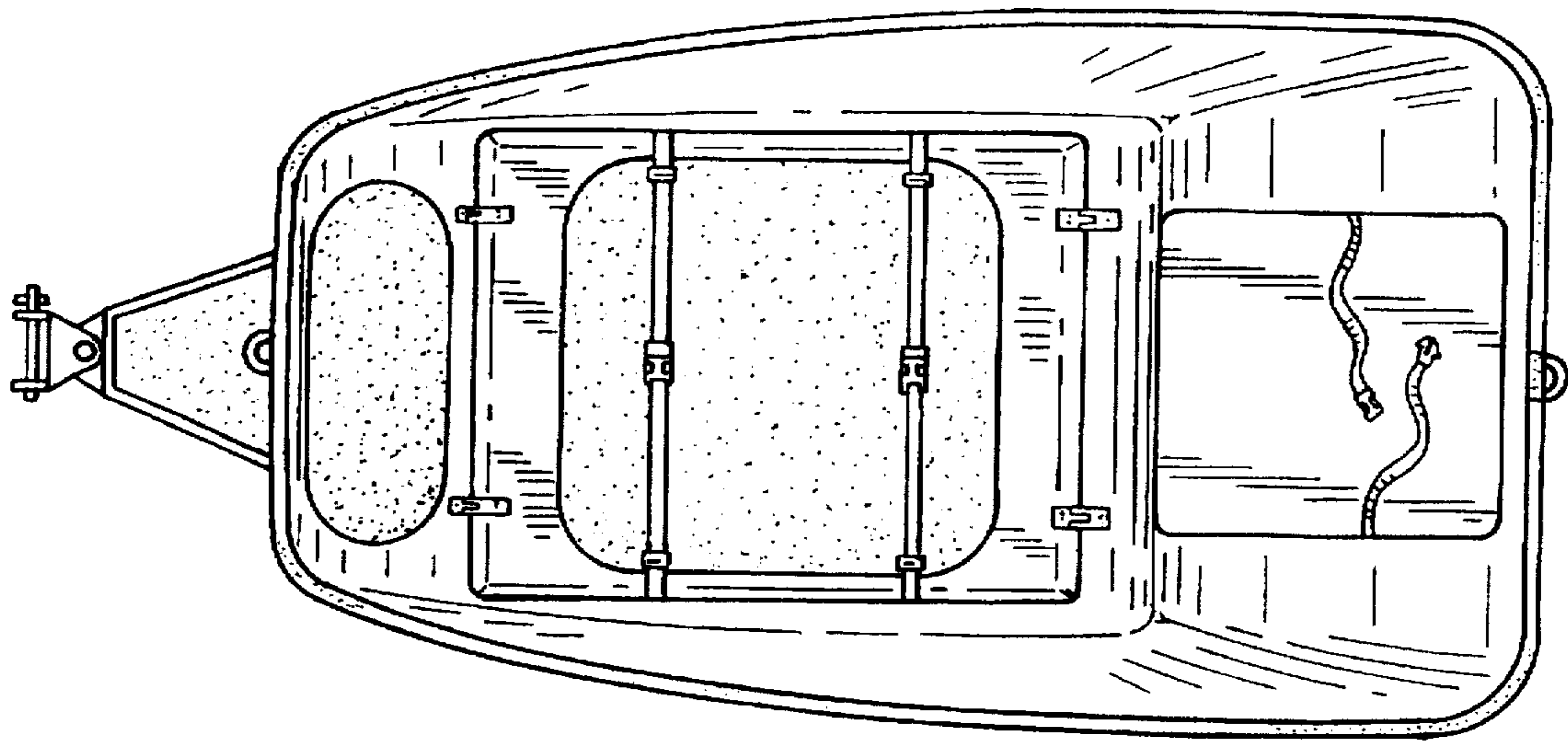

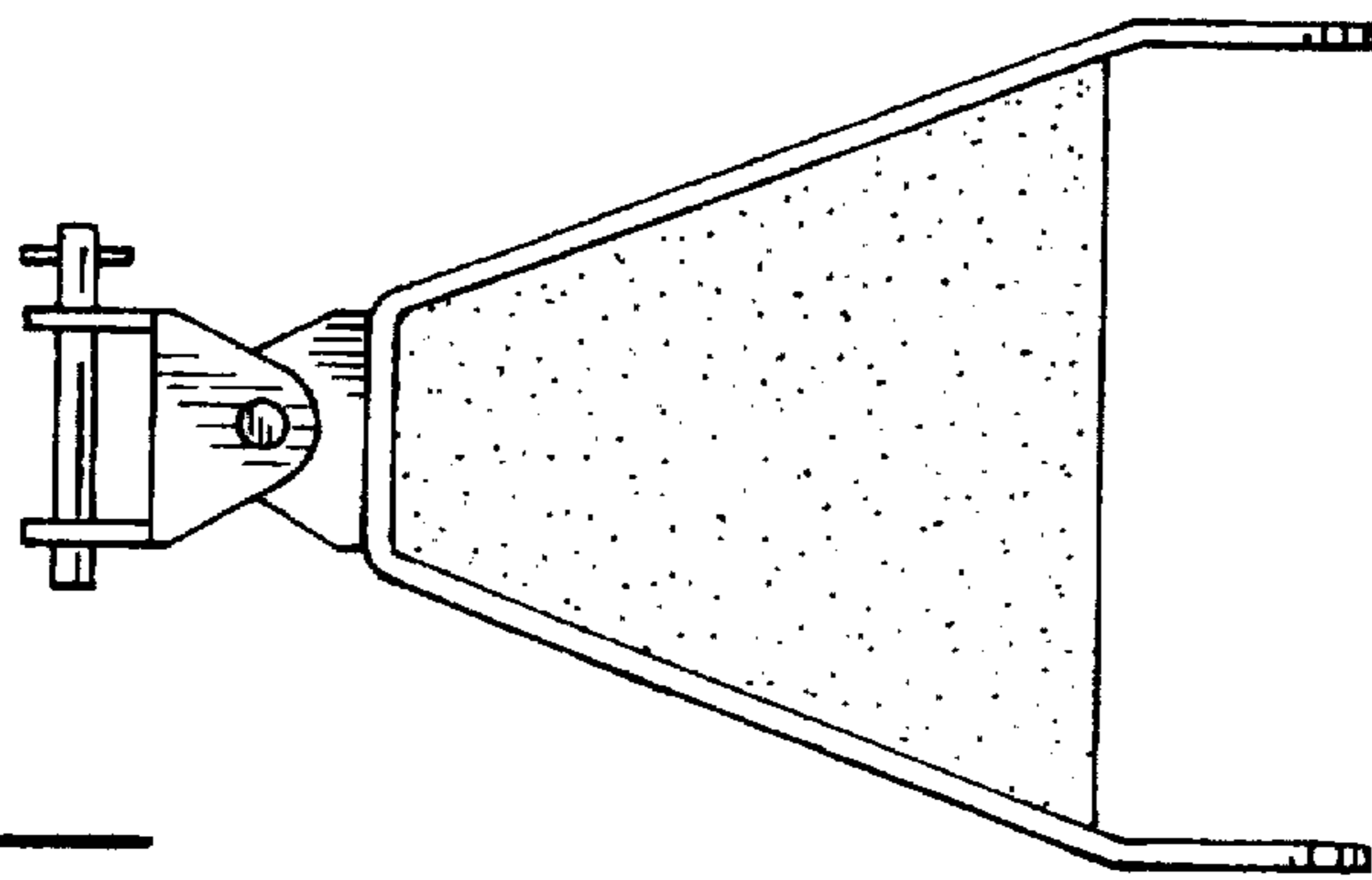

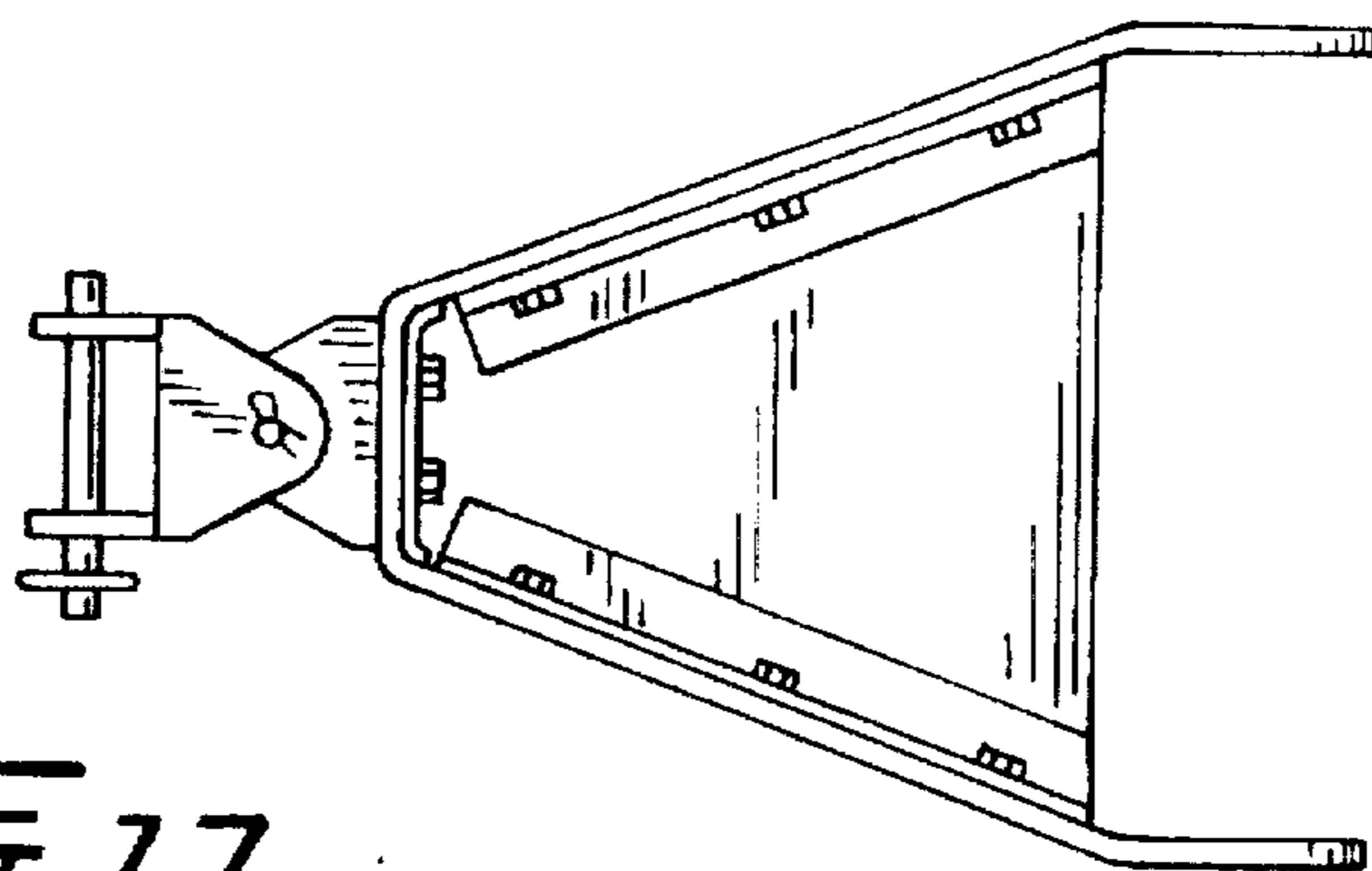

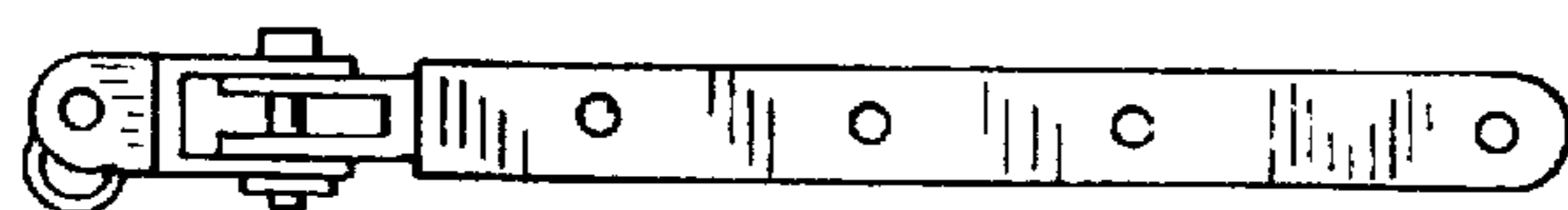
