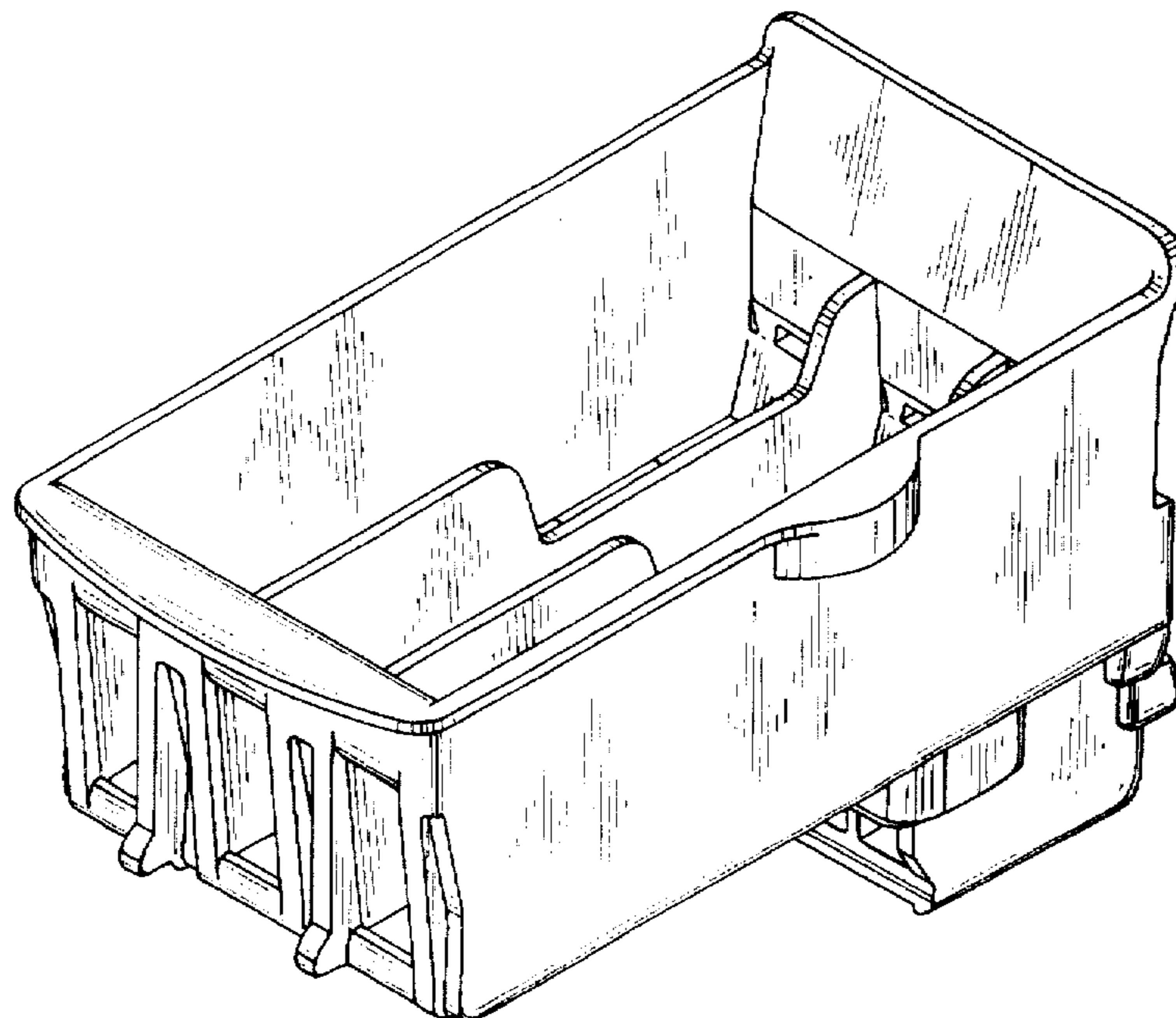
### [57] CLAIM

The ornamental design for an combined ink tank holder and printing head for printer, as shown and described.

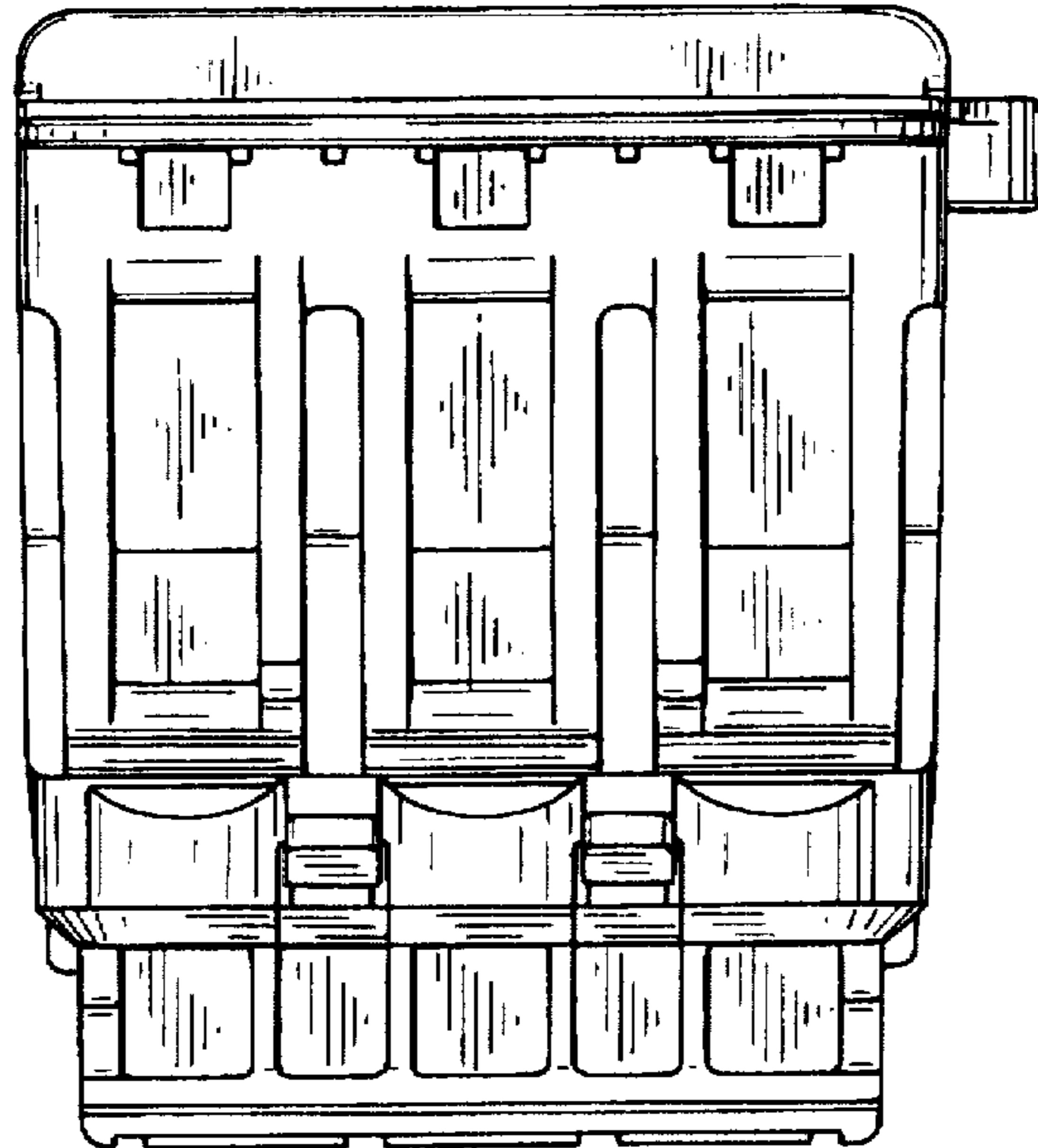
### DESCRIPTION

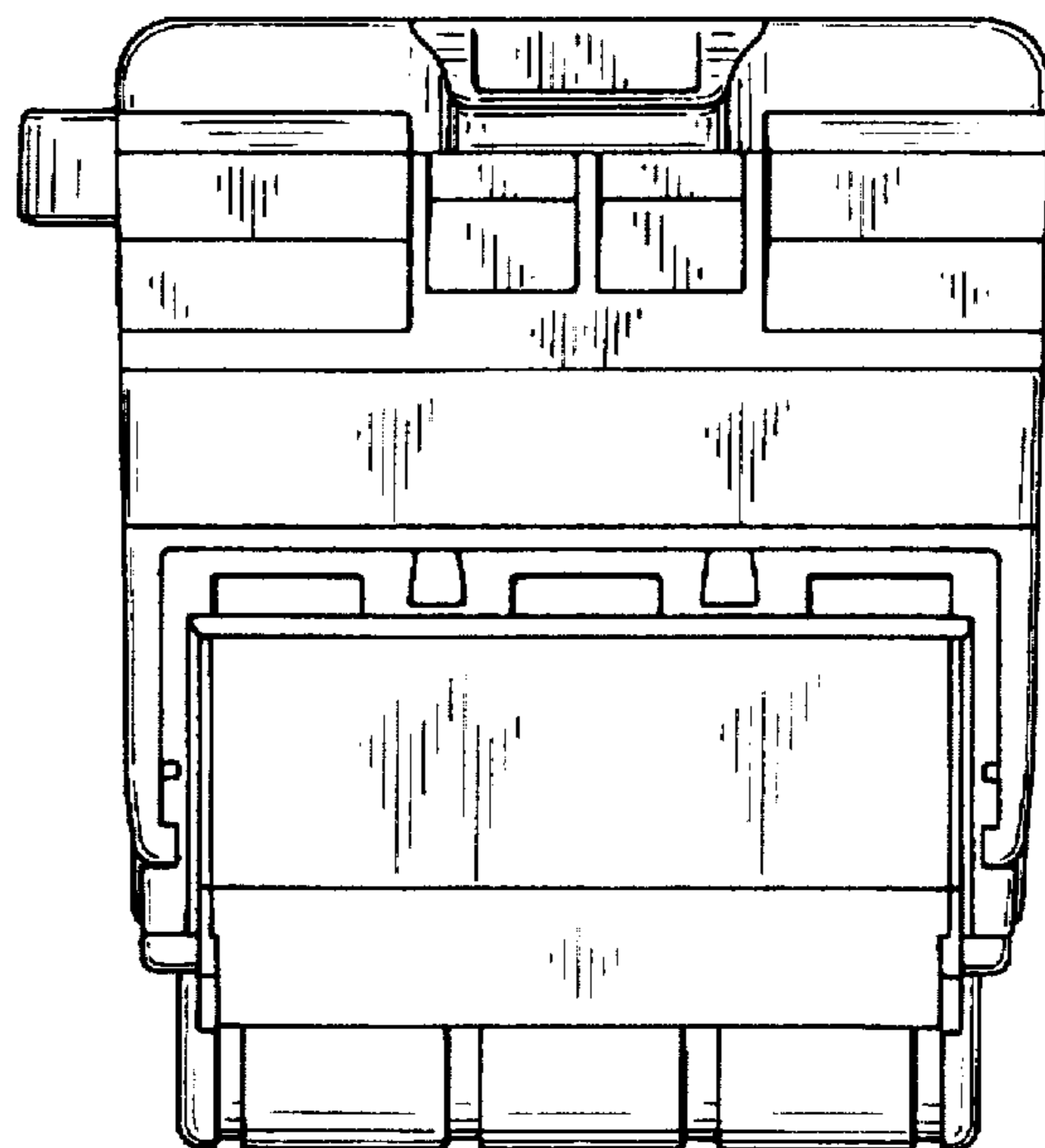

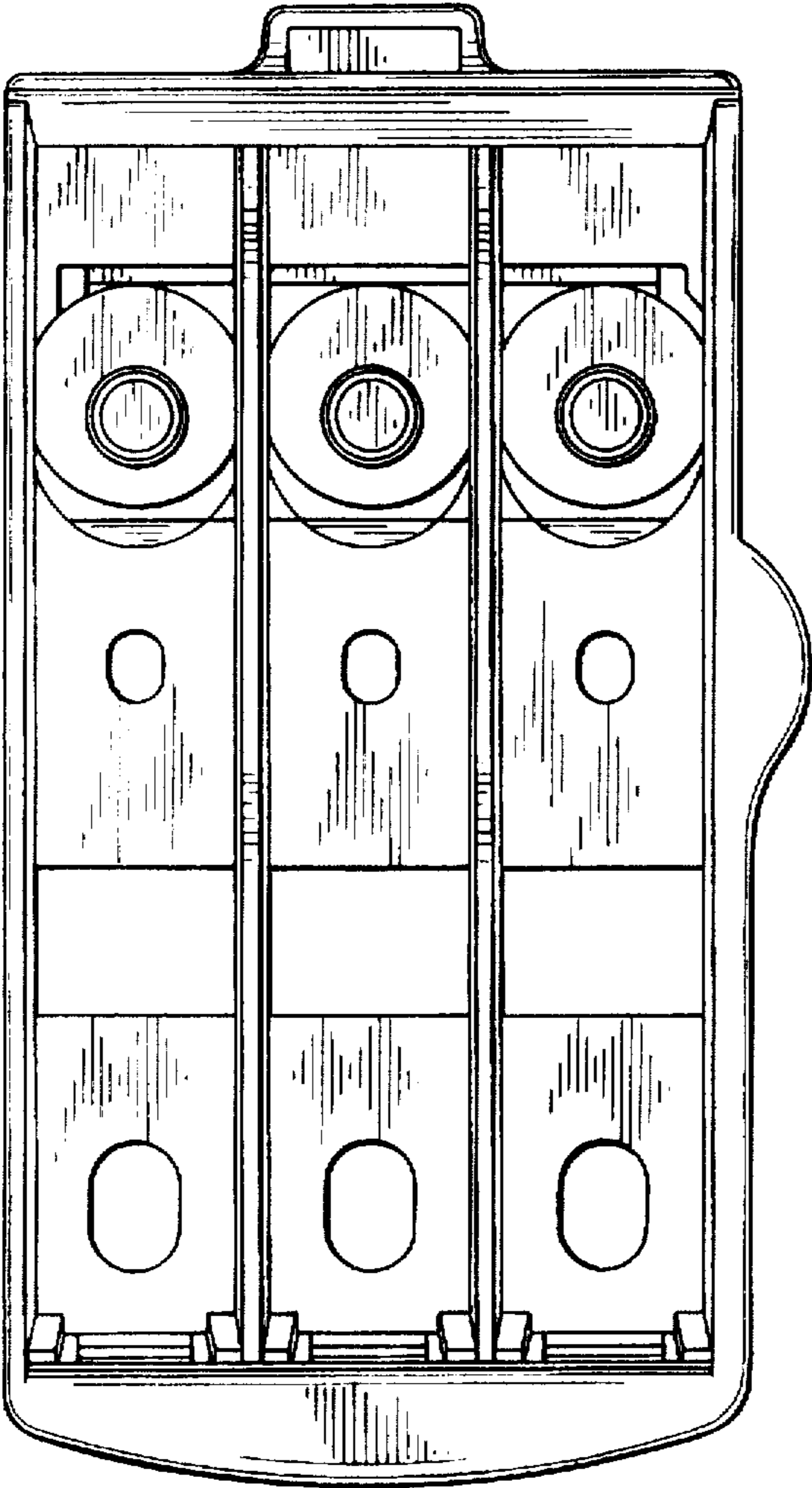
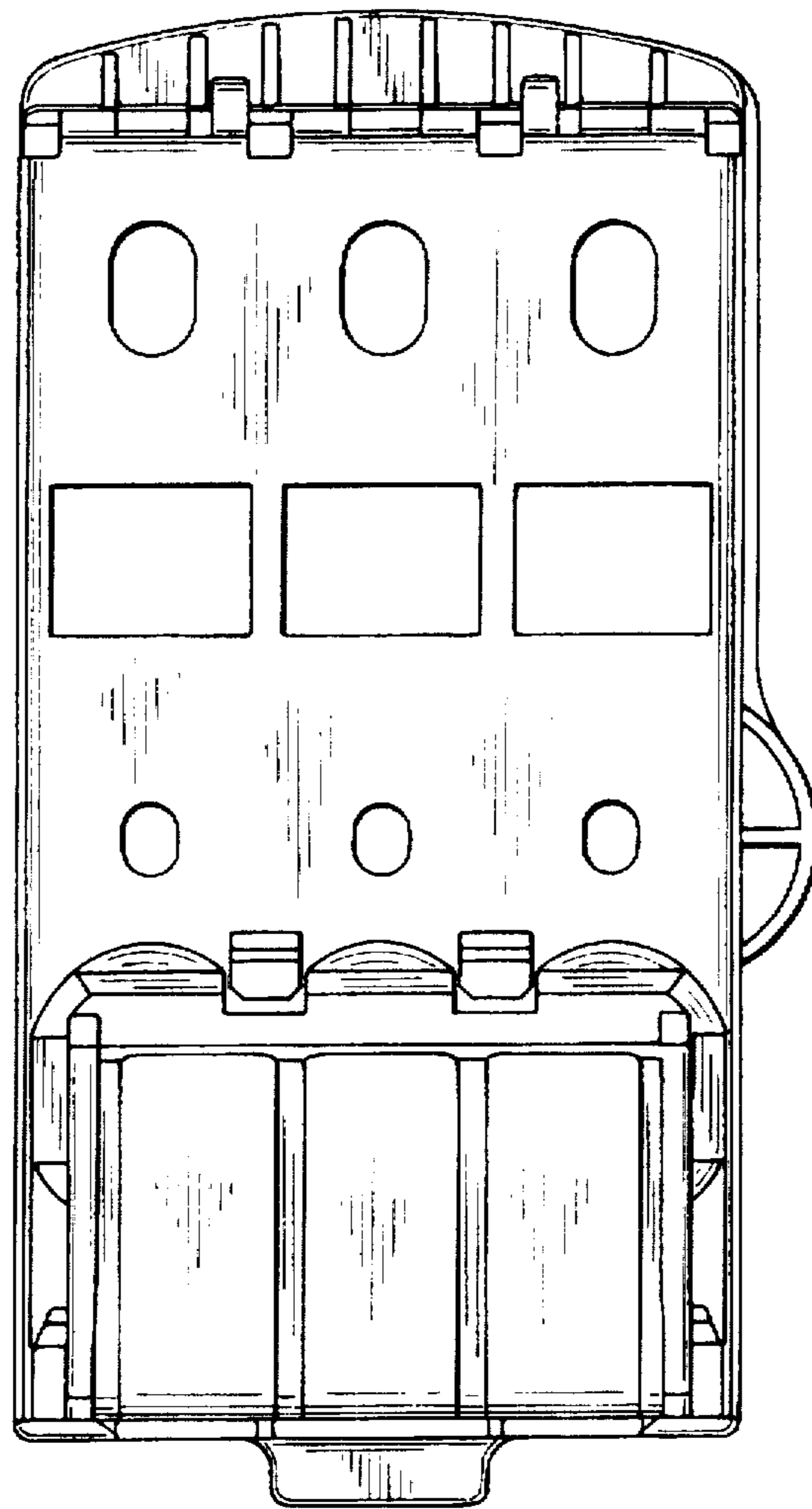
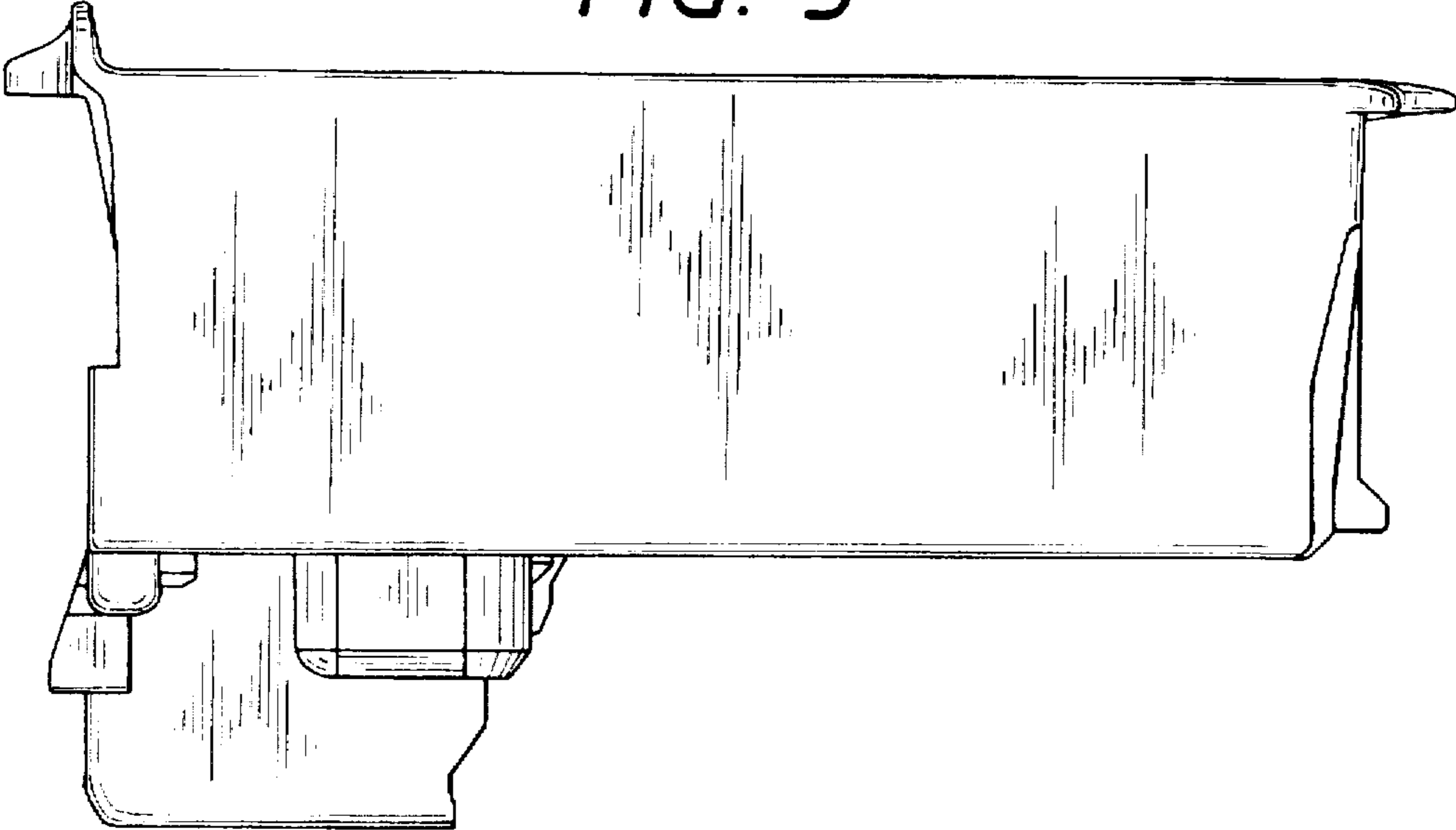


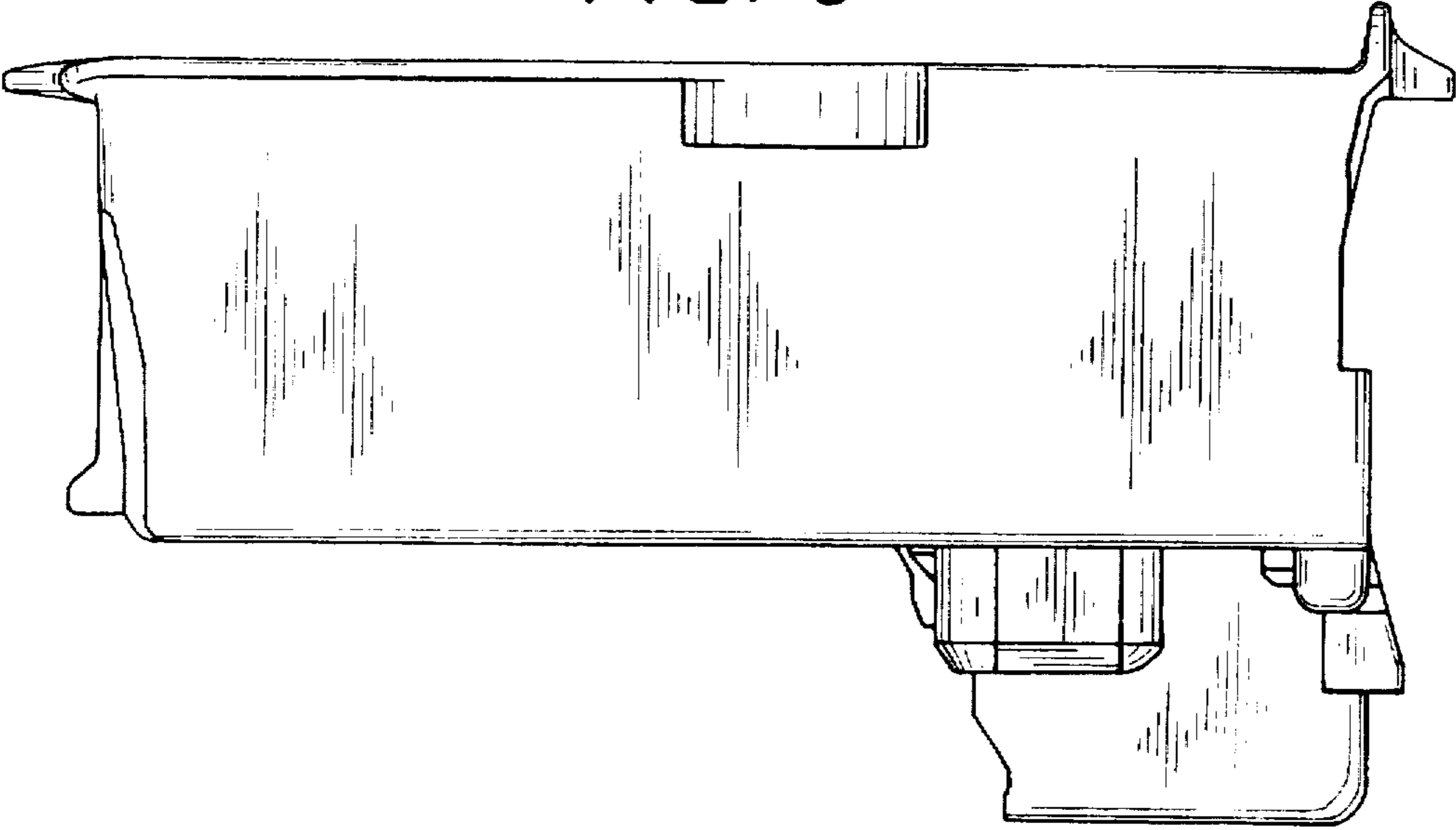

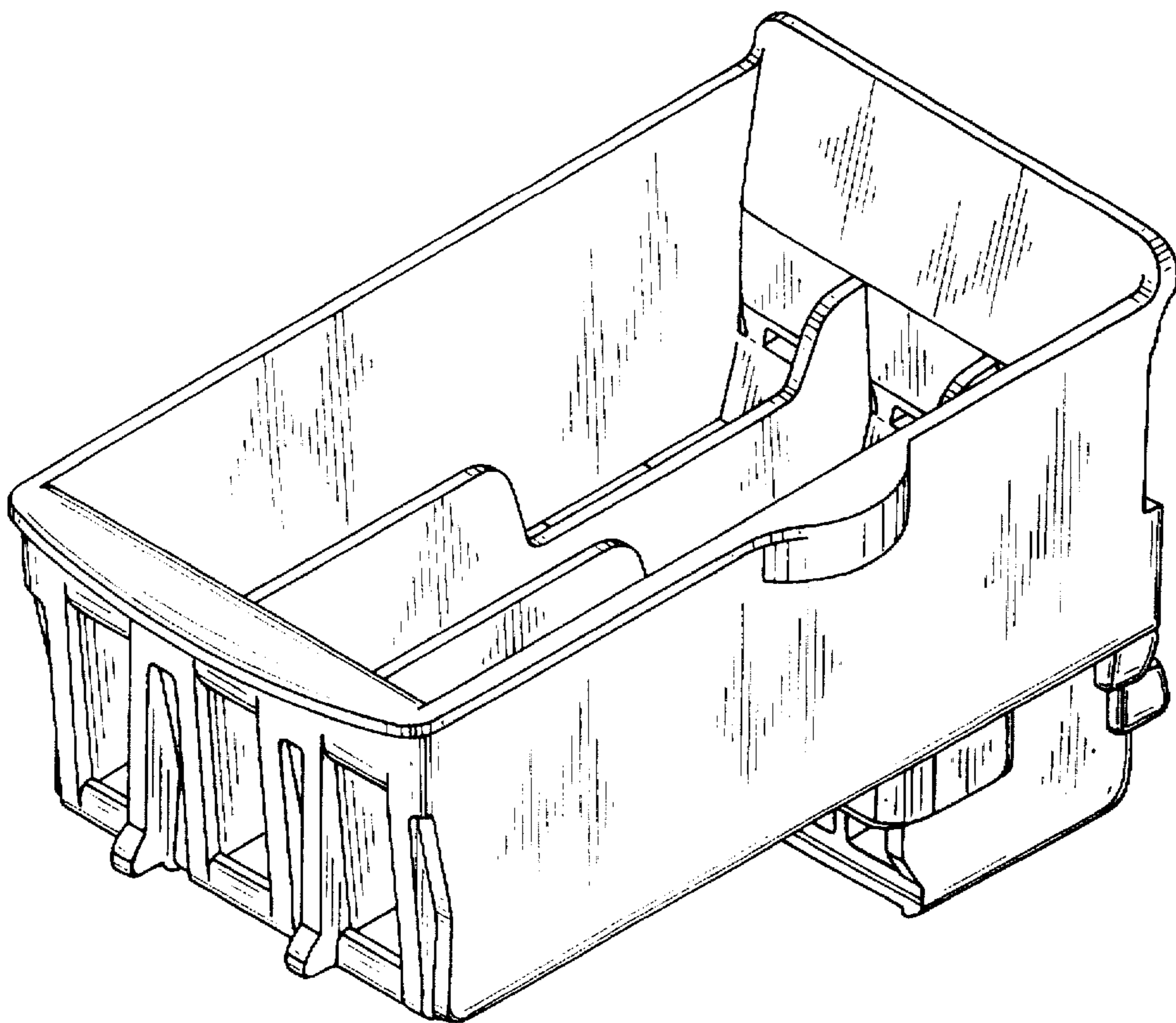
