[57] **CLAIM**

The ornamental design for a shoe upper, as shown and described.

DESCRIPTION

FIG. 1 is a left side elevational view of a shoe upper showing our new design;

FIG. 2 is a right side elevational view thereof;

FIG. 3 is a top plan view thereof;

FIG. 4 is a front elevational view thereof;

FIG. 5 is a rear elevational view thereof;

FIG. 6 is a left side elevational view of the shoe of FIG. 1-5 with a lacing margin in an alternate position;

FIG. 7 is a right side elevational view thereof;

FIG. 8 is a top plan view thereof;

FIG. 9 is a front elevational view thereof;

FIG. 10 is a rear elevational view thereof;

FIG. 11 is a left side elevational view of a shoe upper showing an alternate embodiment of our new design;

FIG. 12 is a right side elevational view thereof;

FIG. 13 is a top plan view thereof;

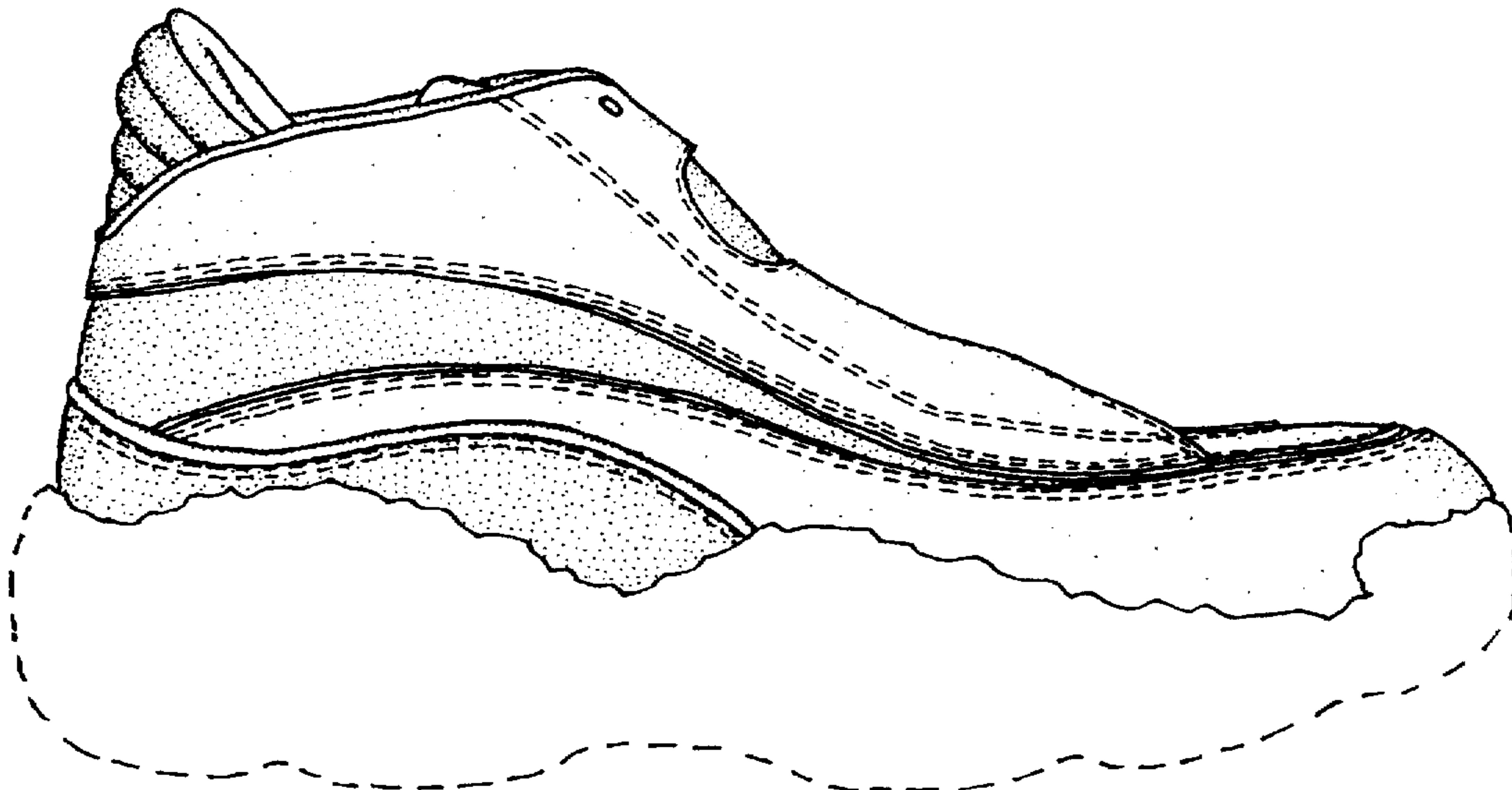
FIG. 14 is a front elevational view thereof; and,

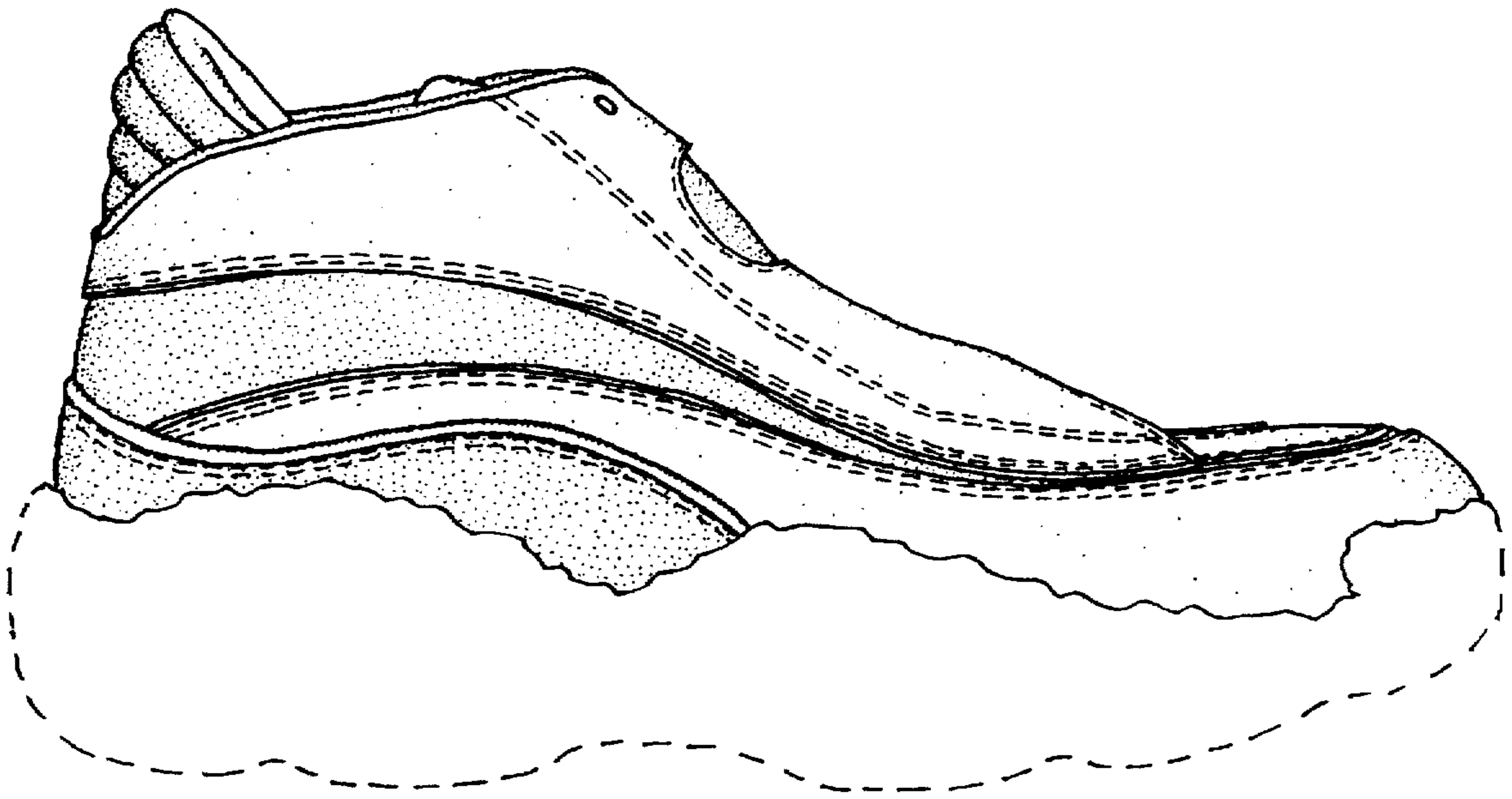

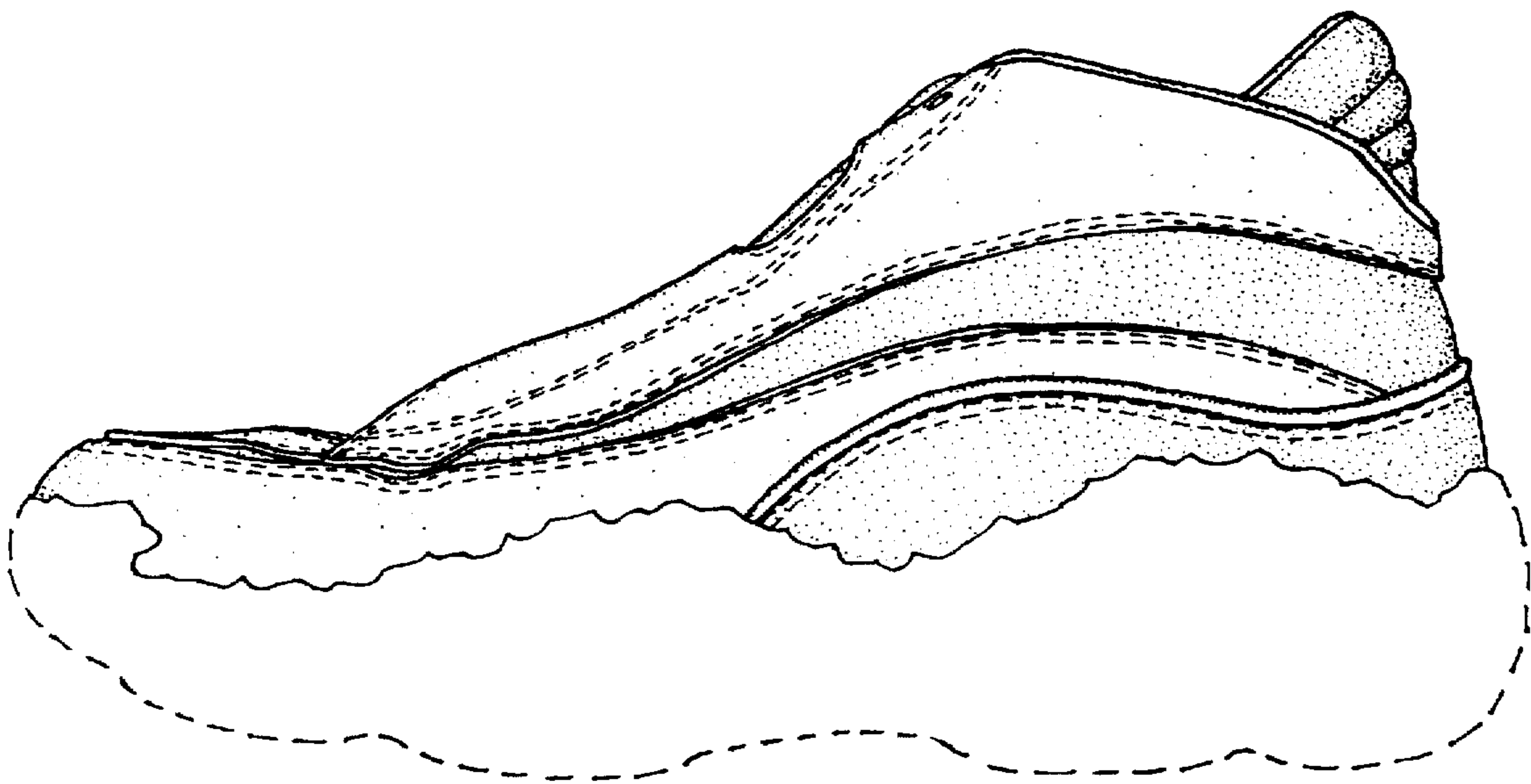

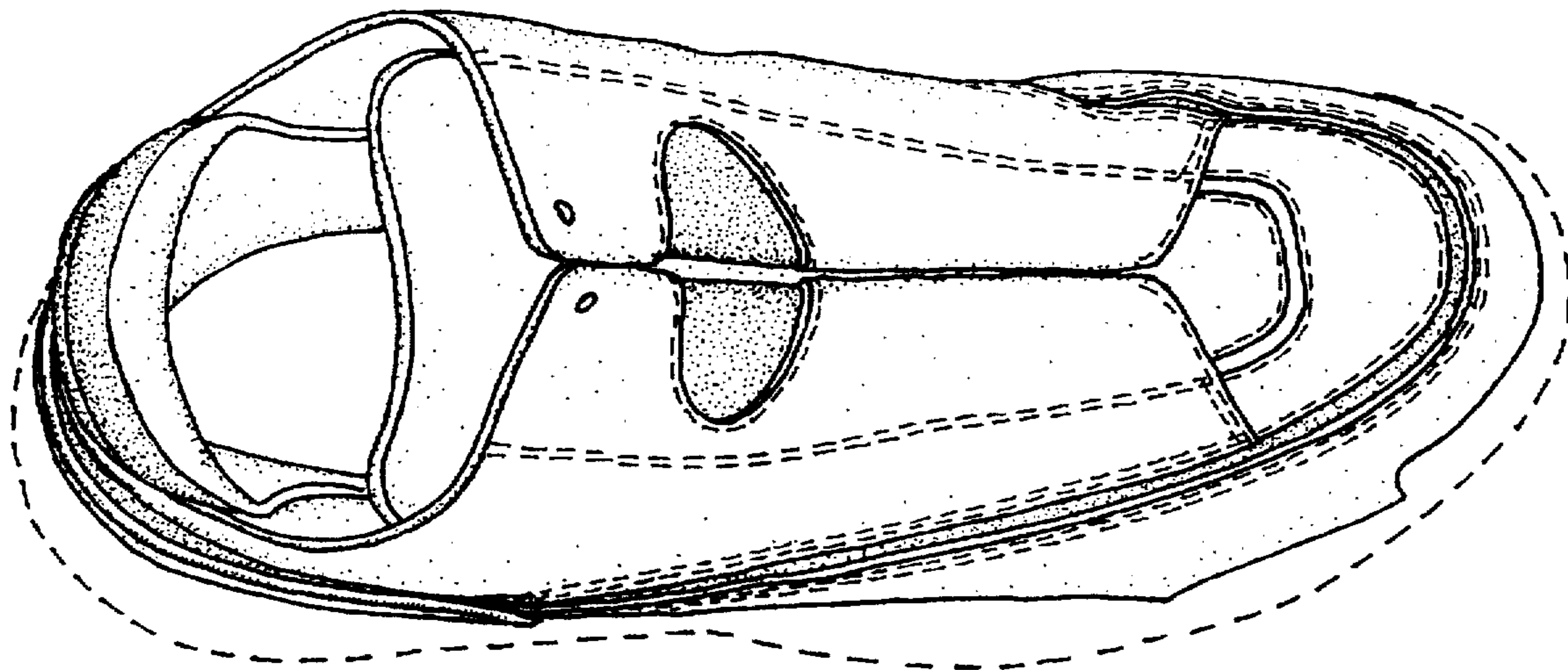

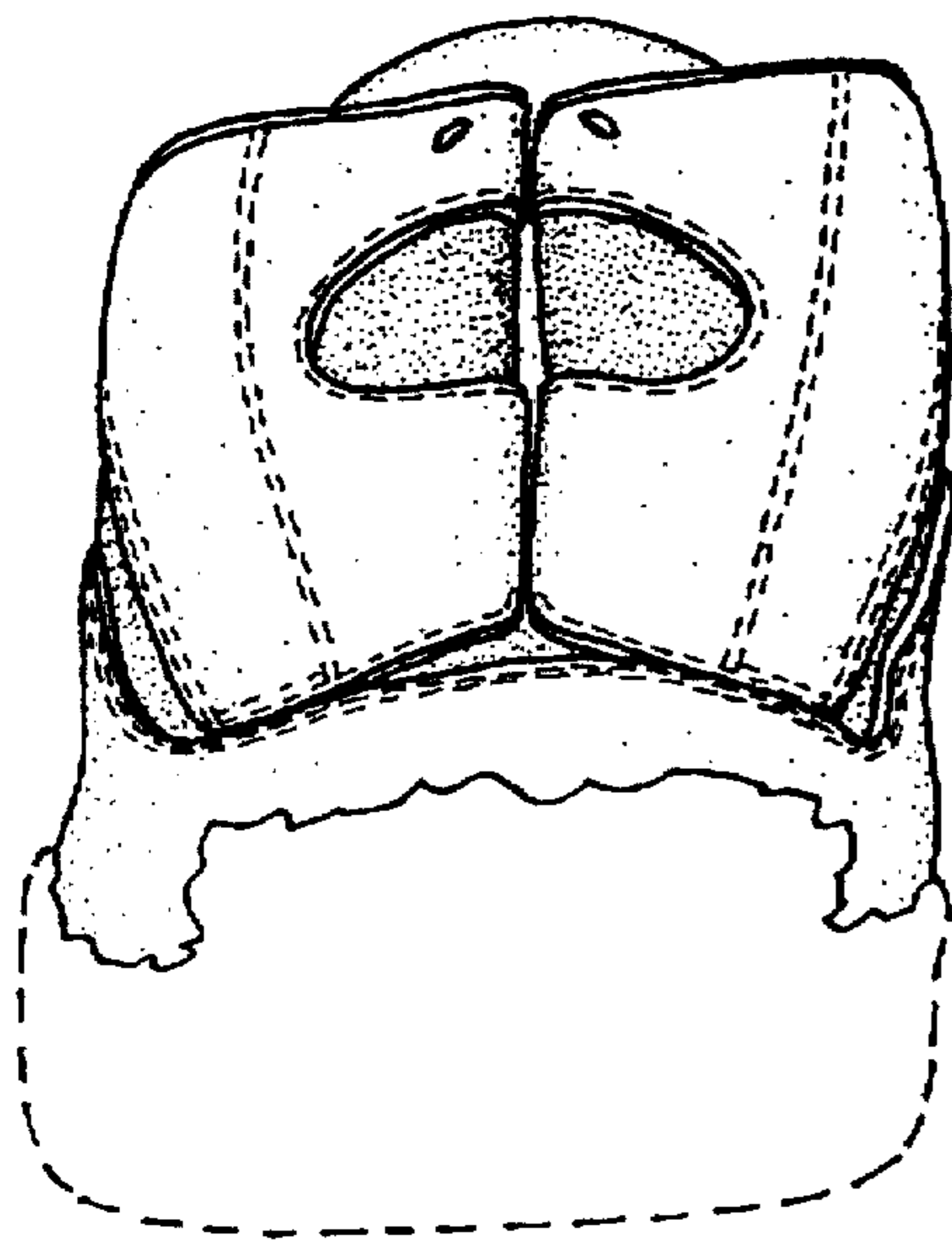

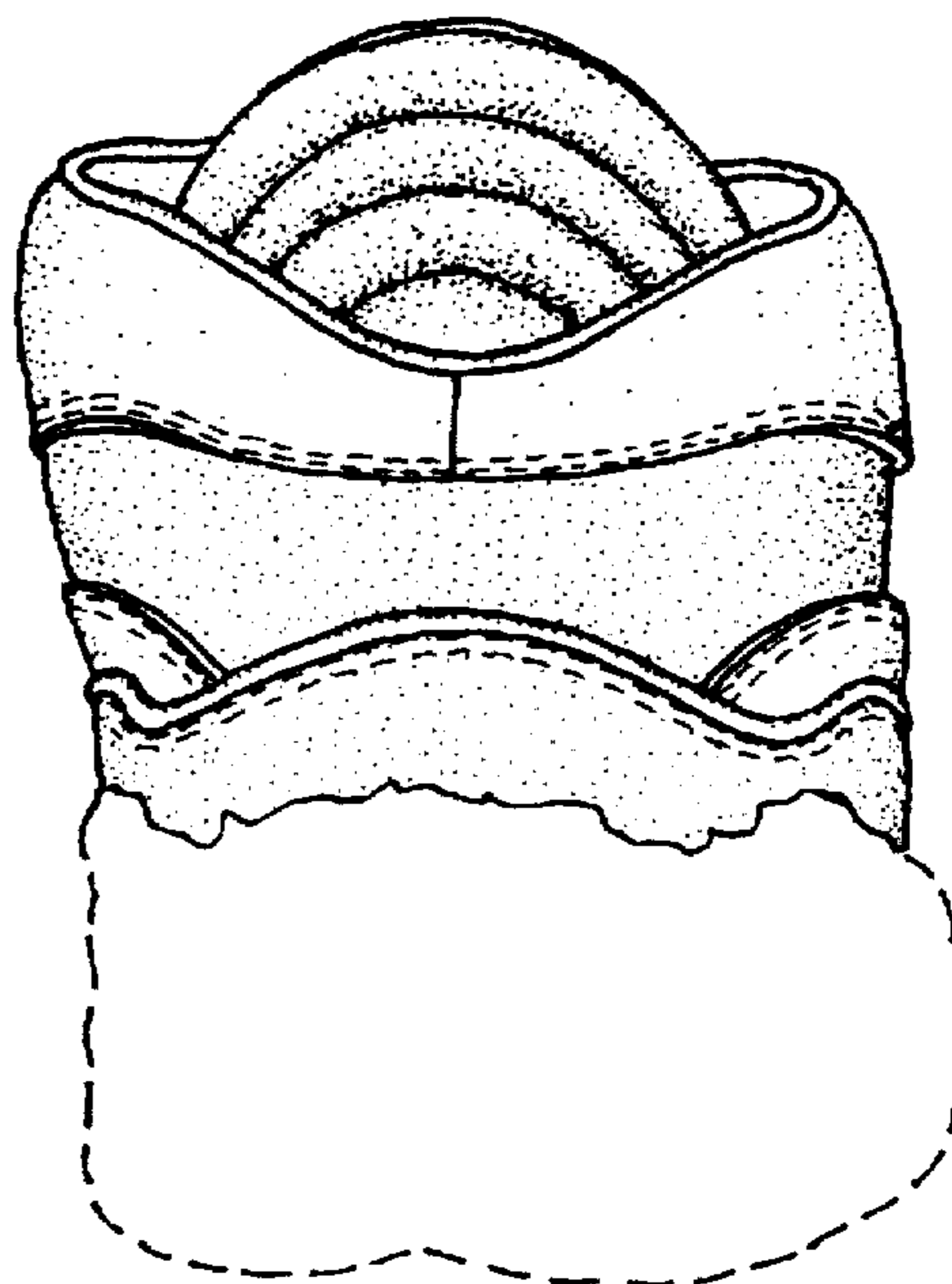

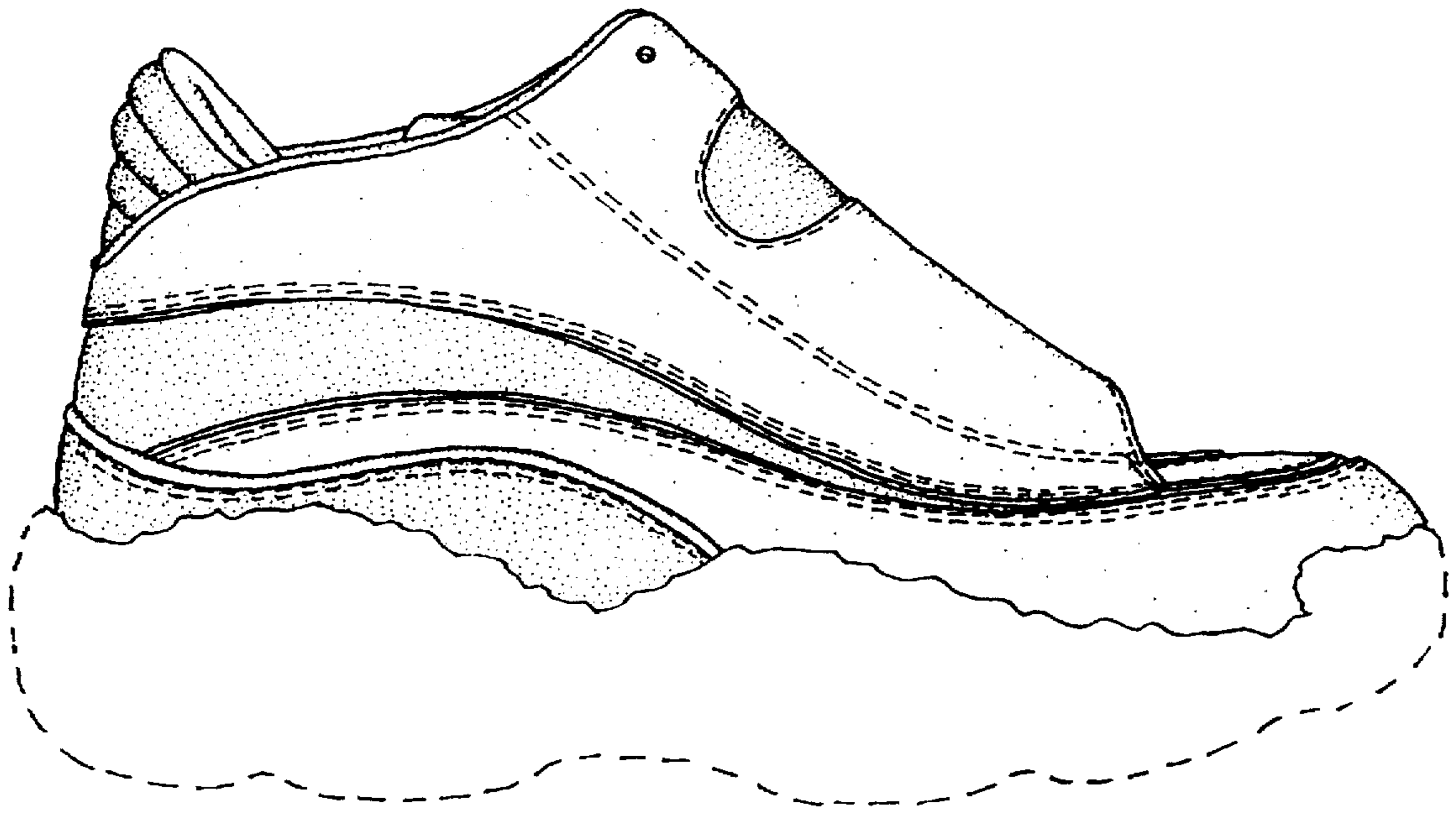

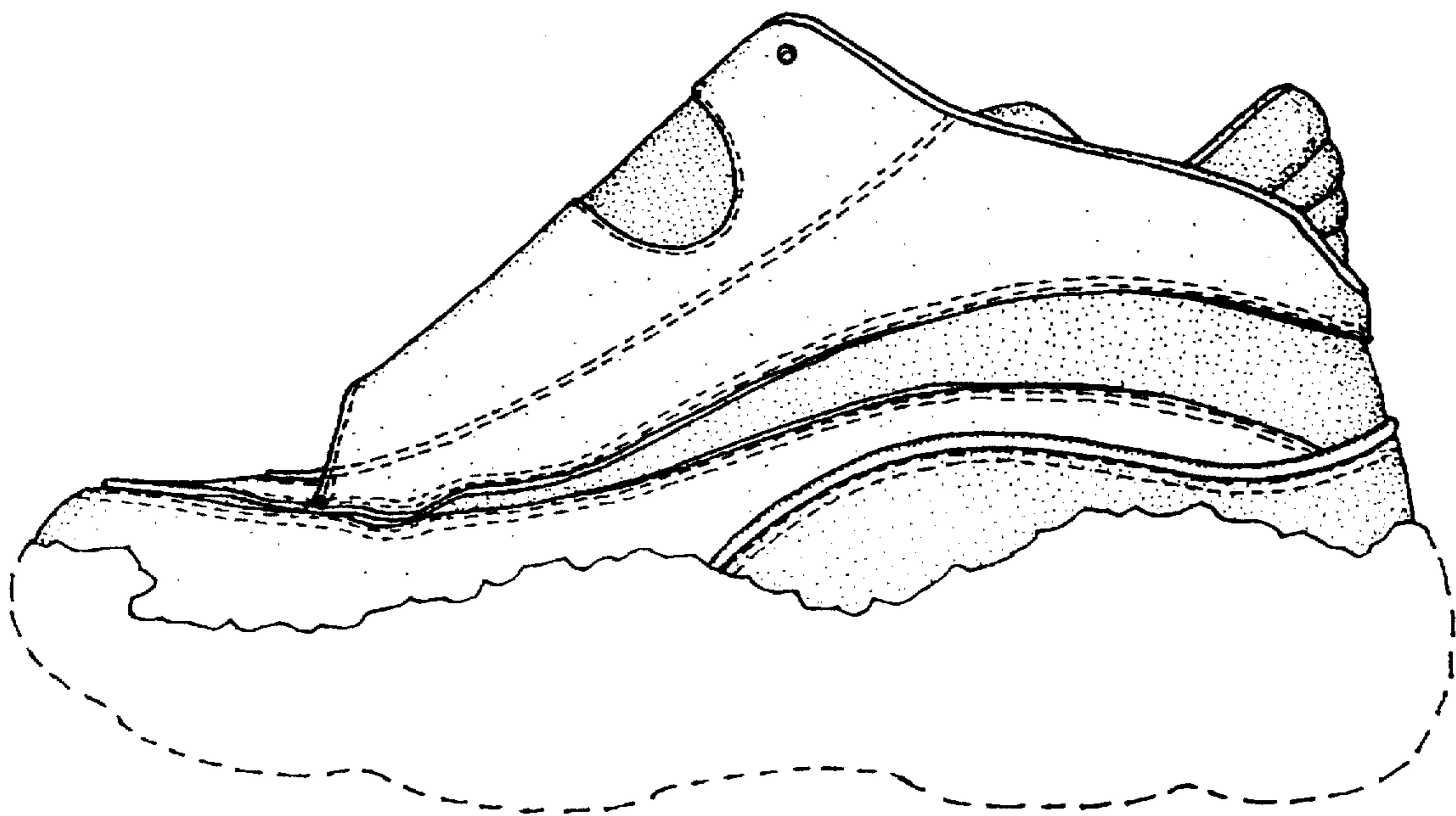

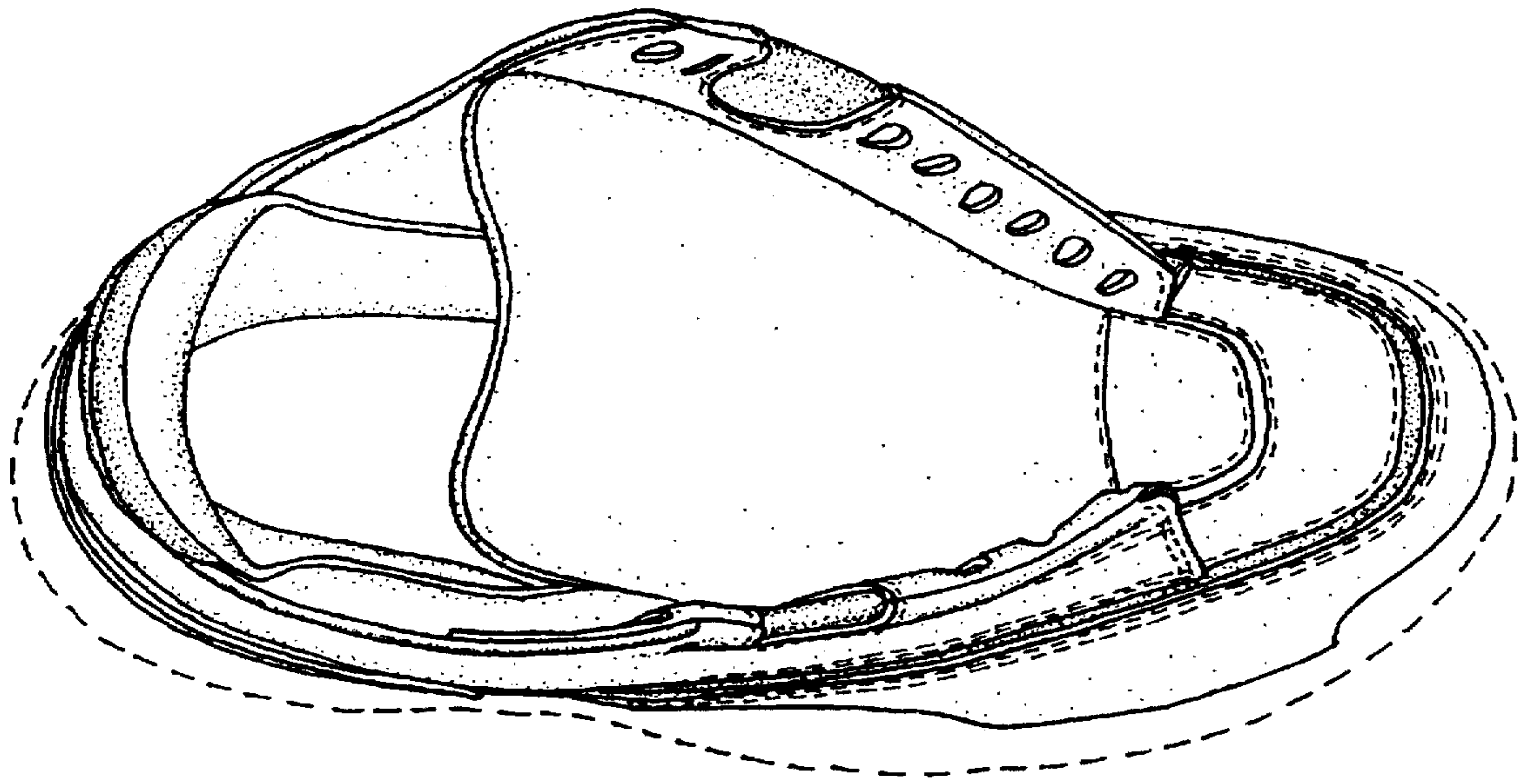

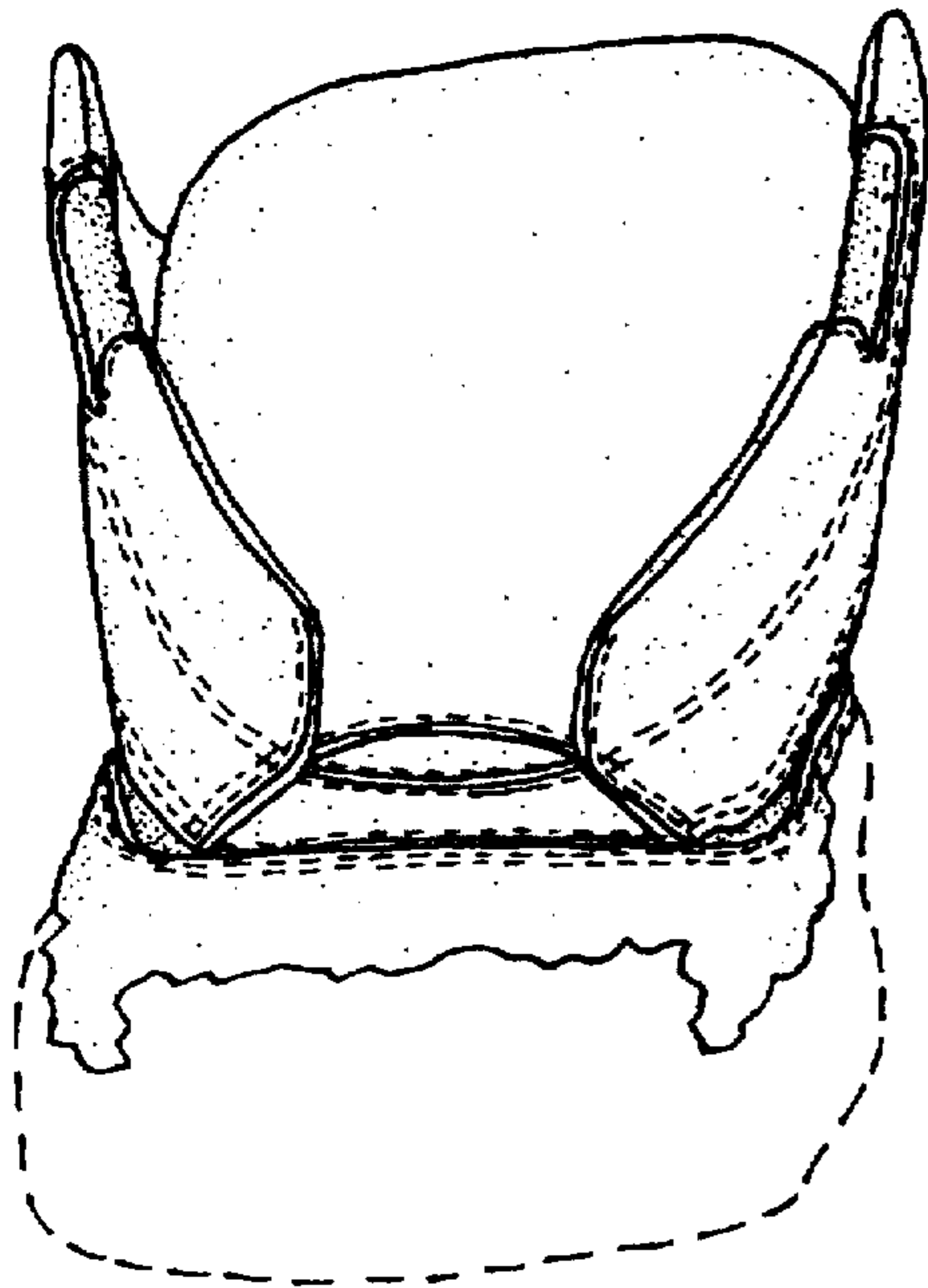

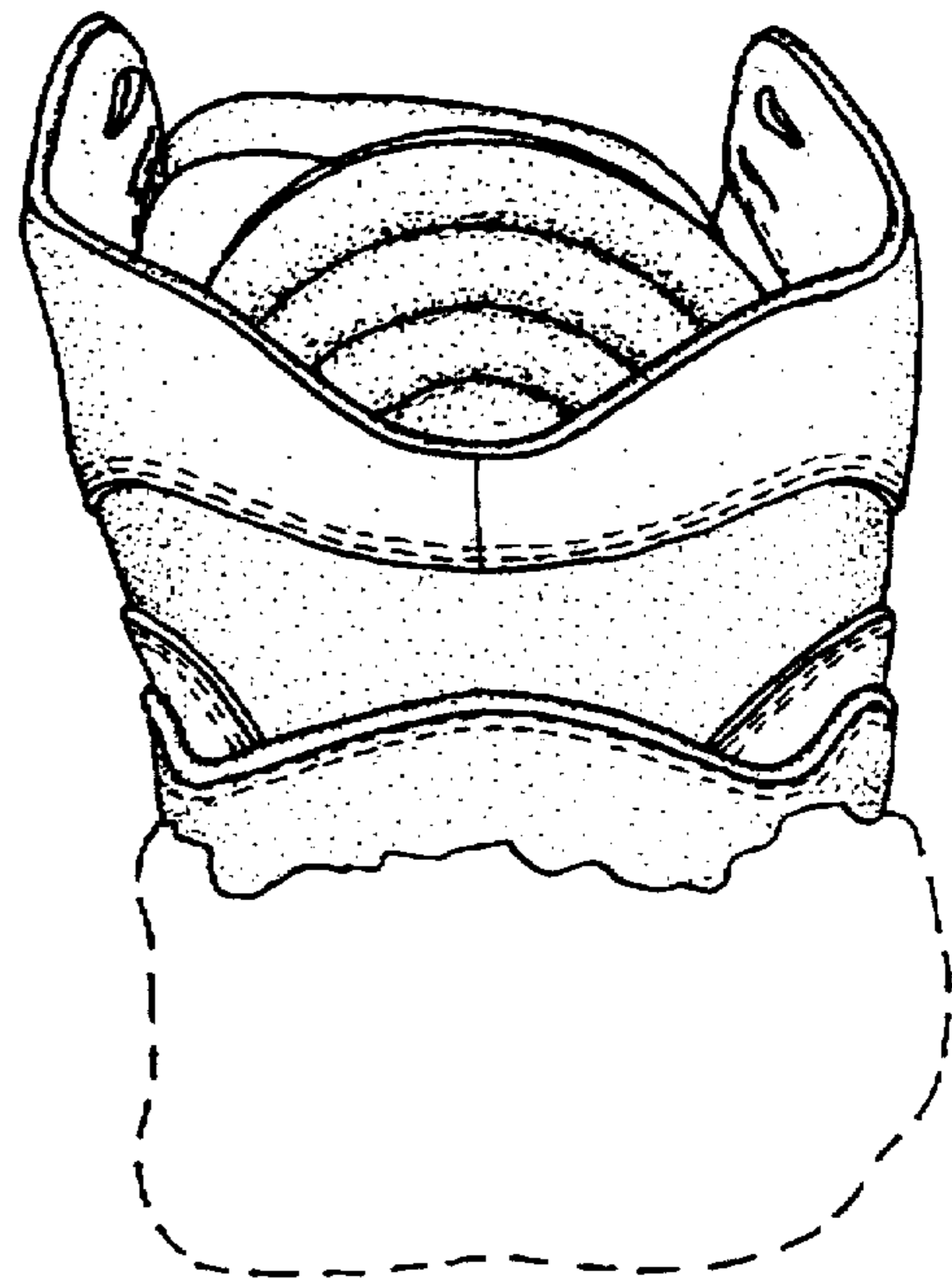

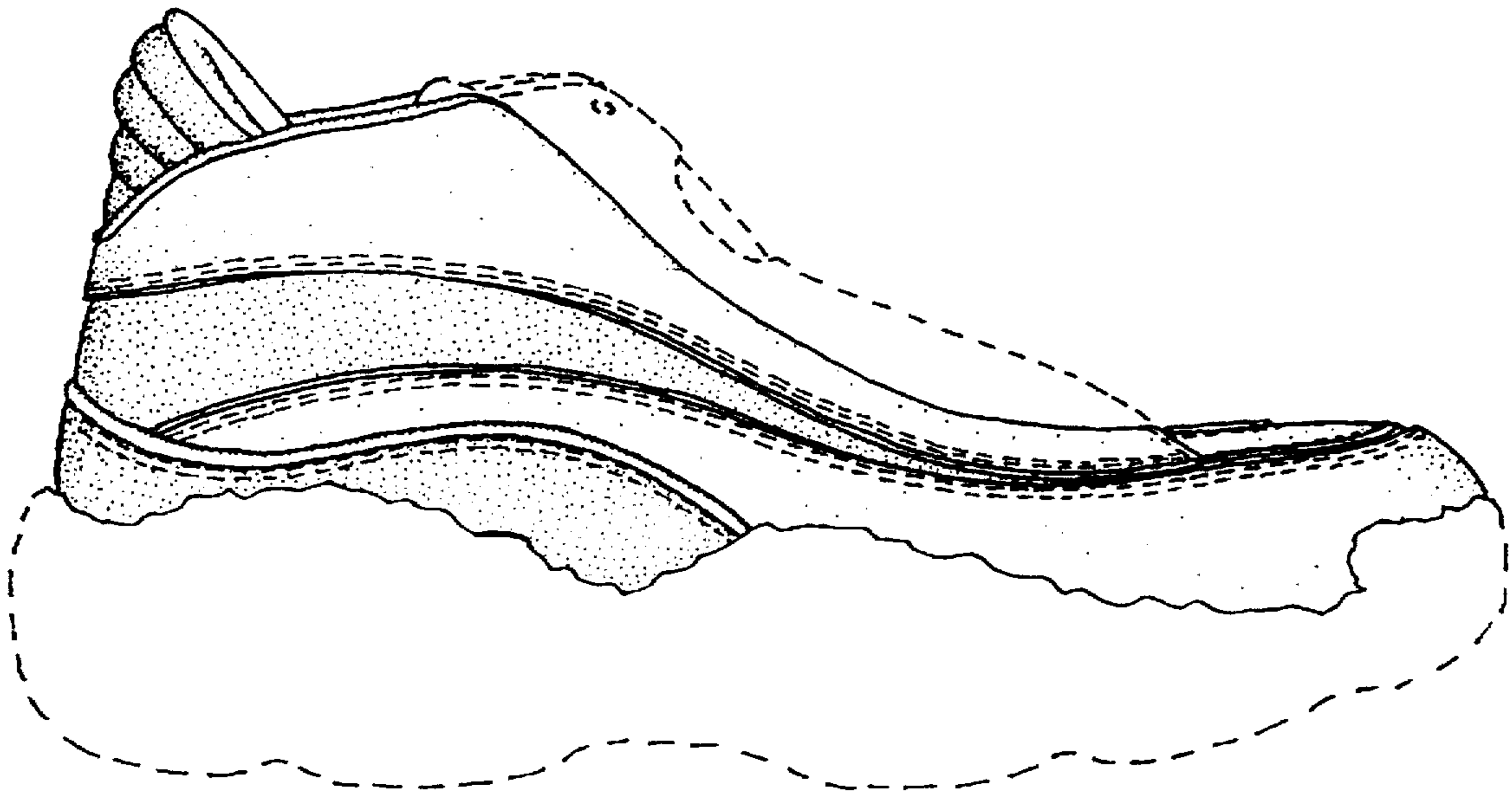

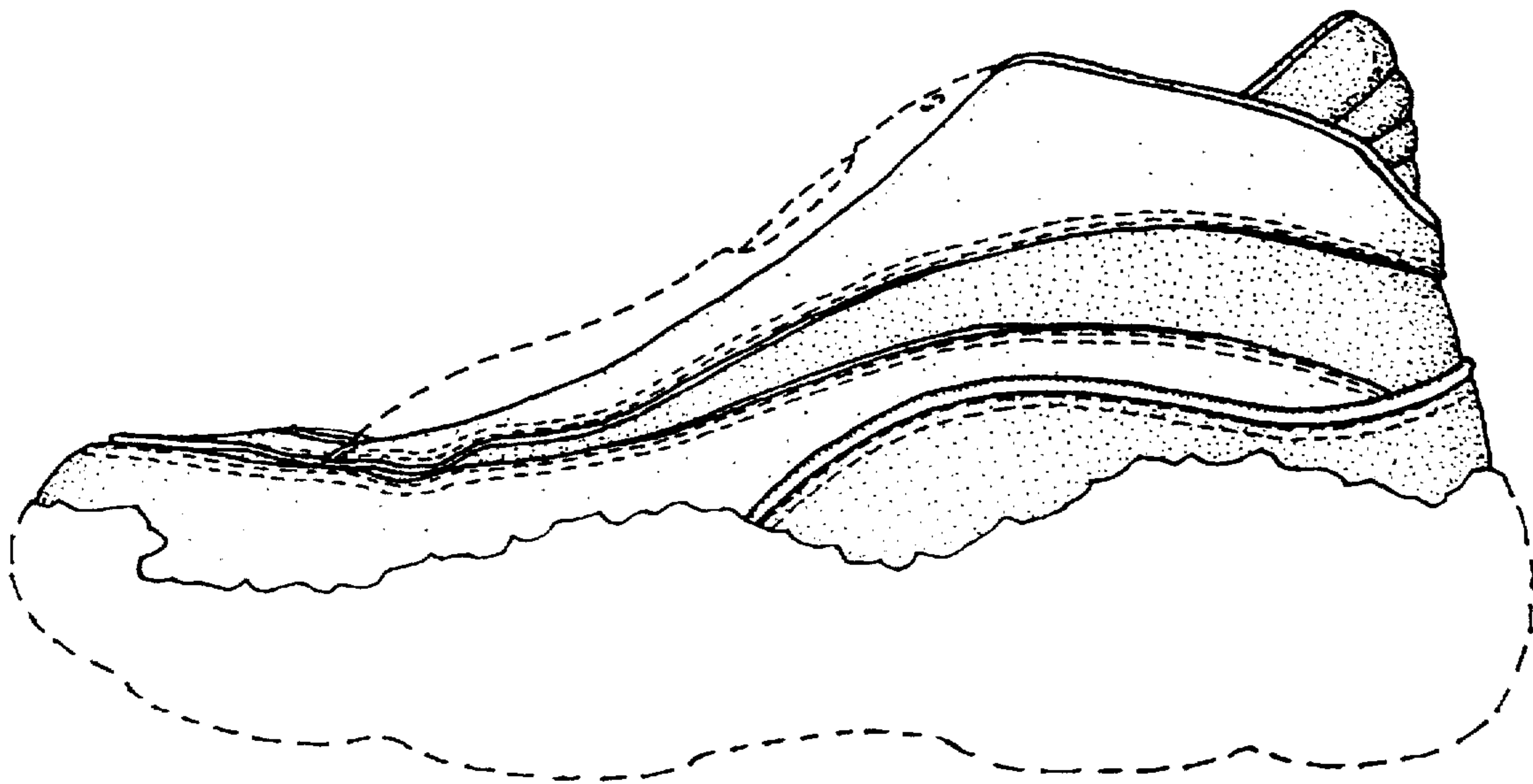

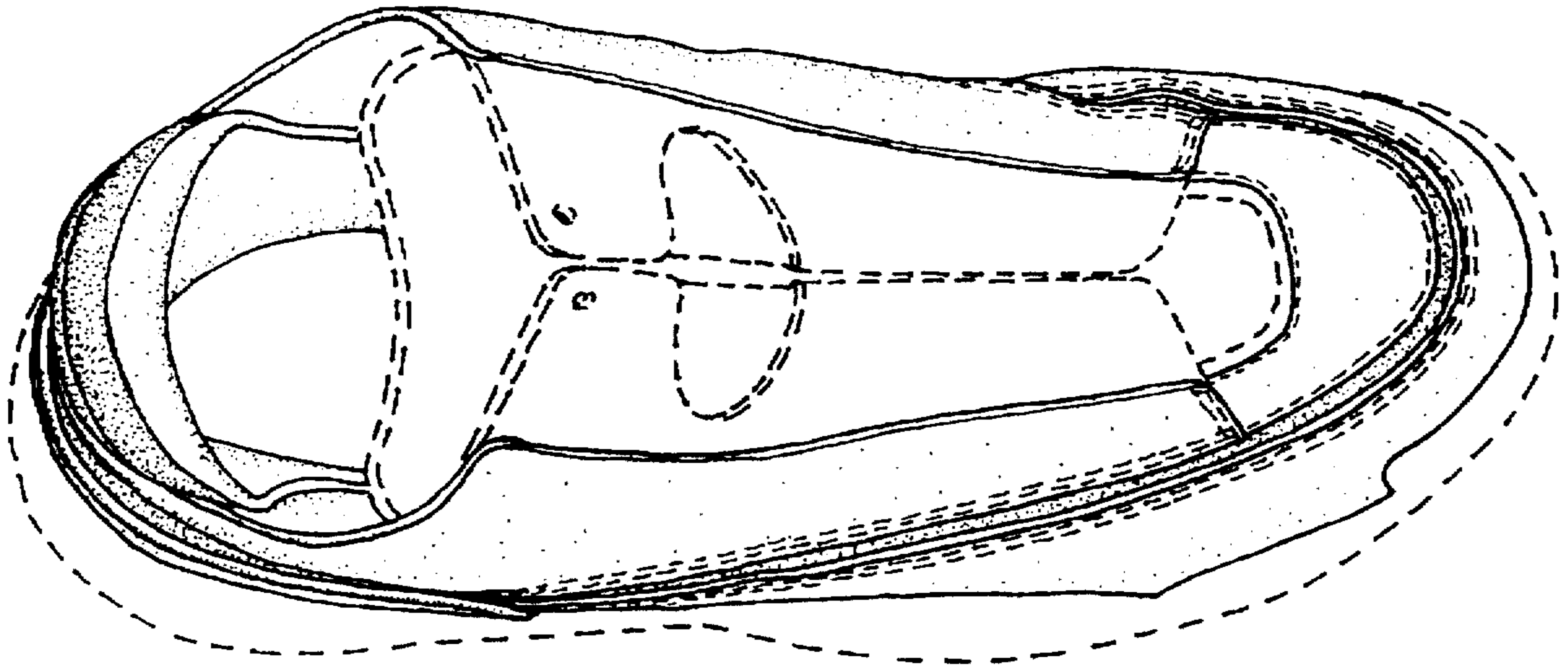

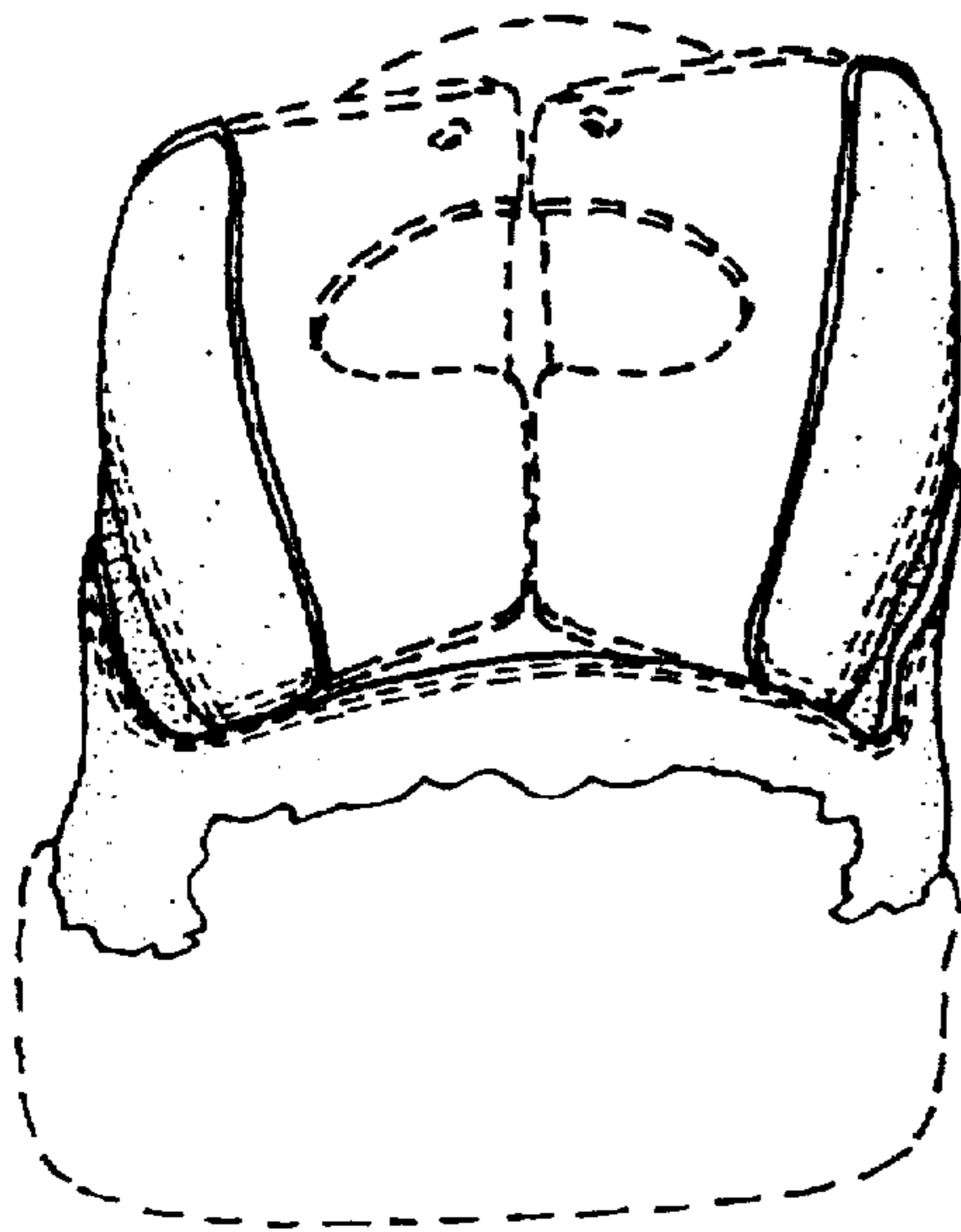

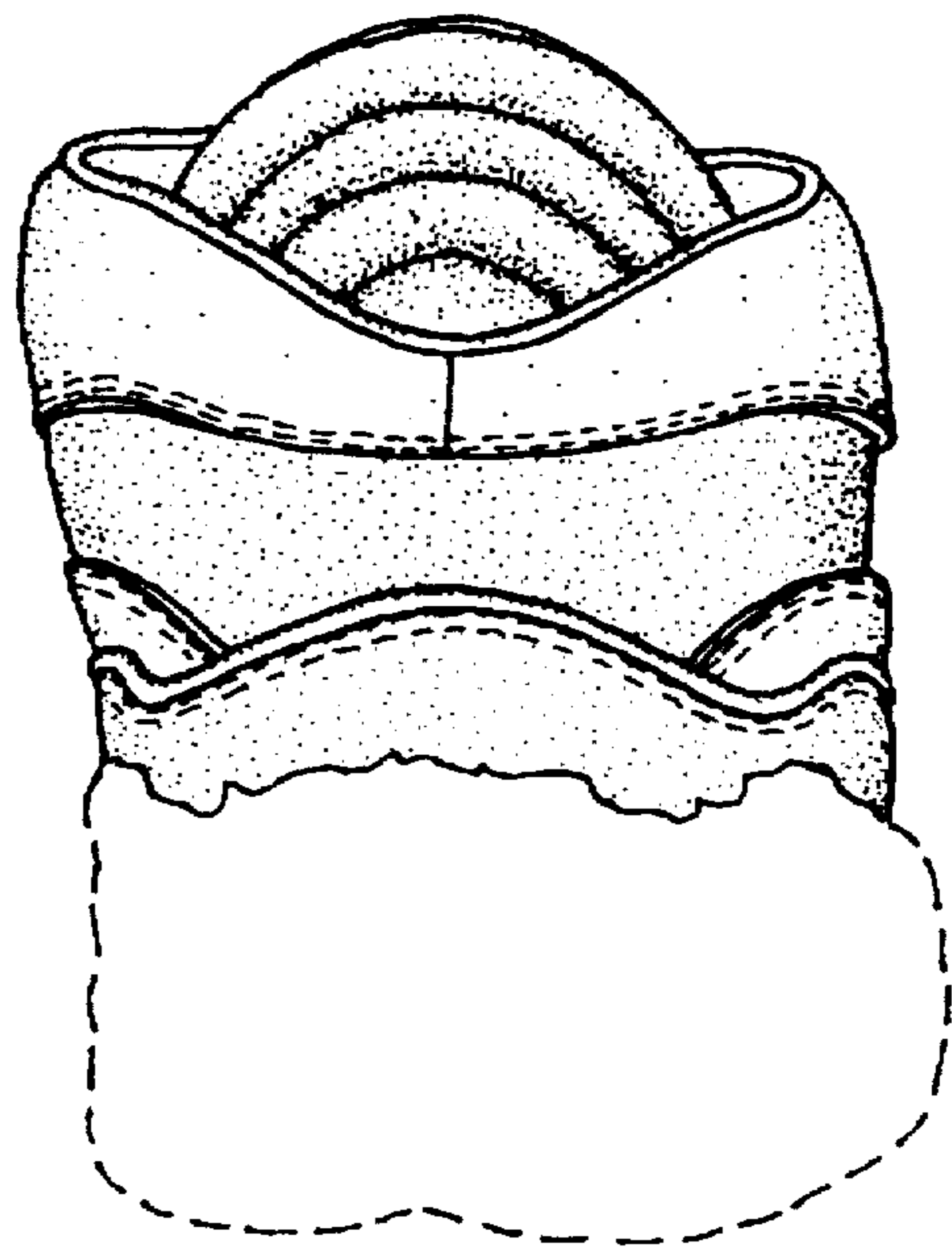
