FIG. 14 is a sectional view along line 14—14 as shown in FIG. 13; and,

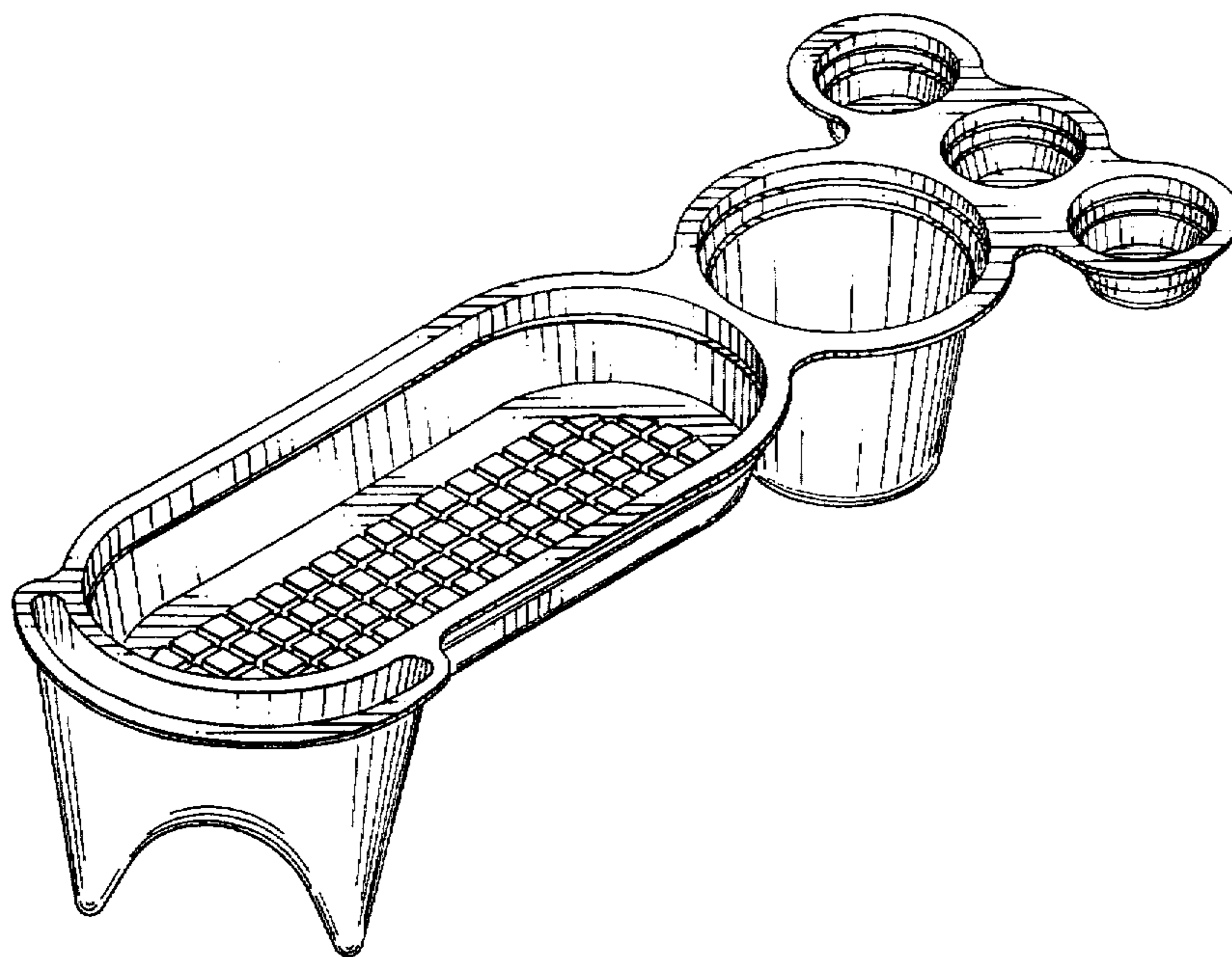
FIG. 15 is a bottom plan view thereof.

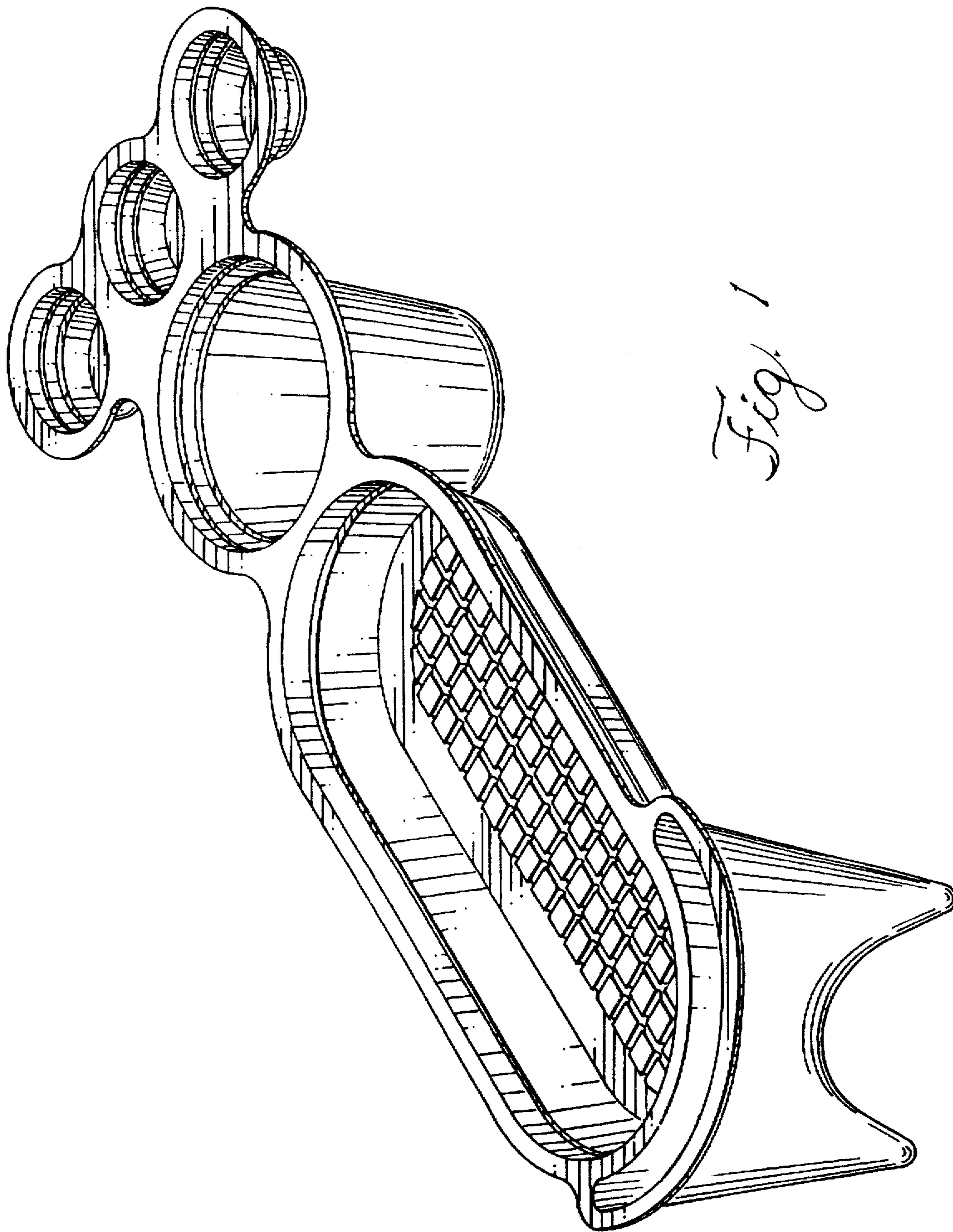

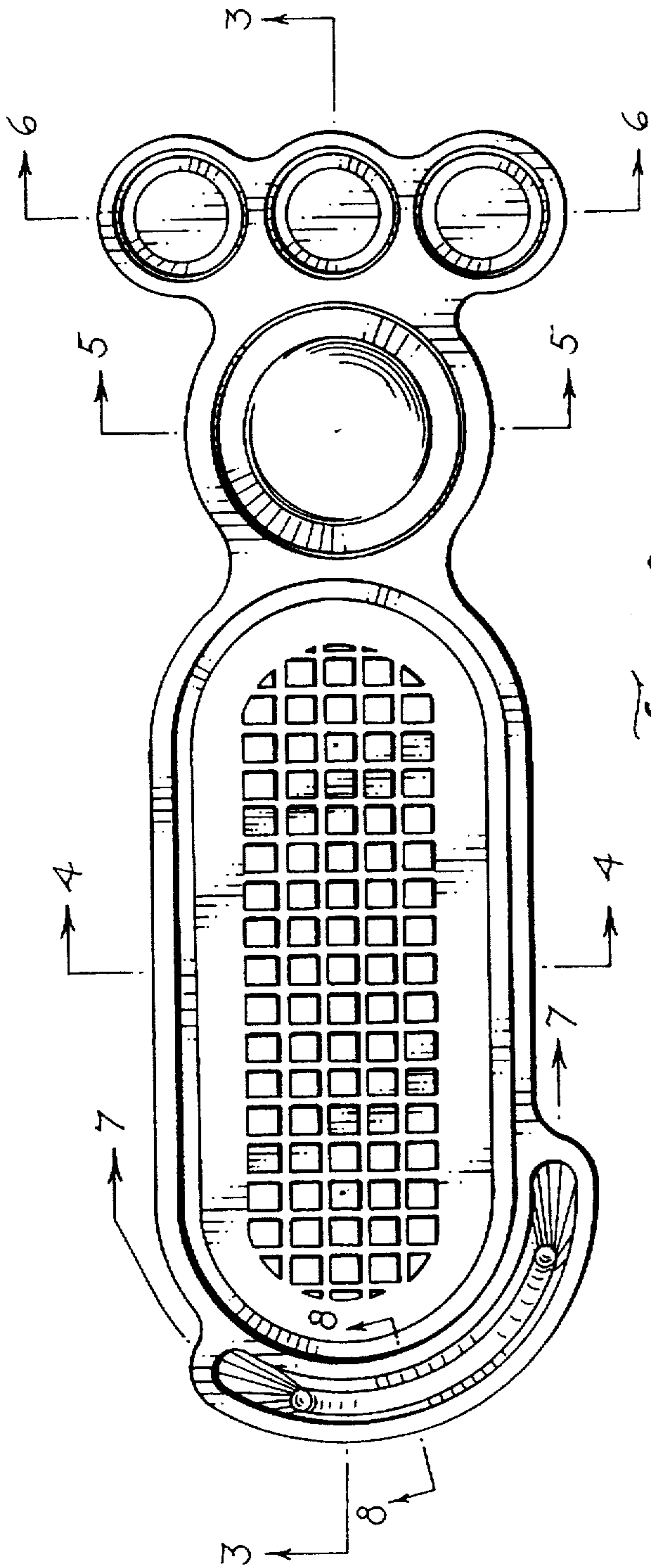

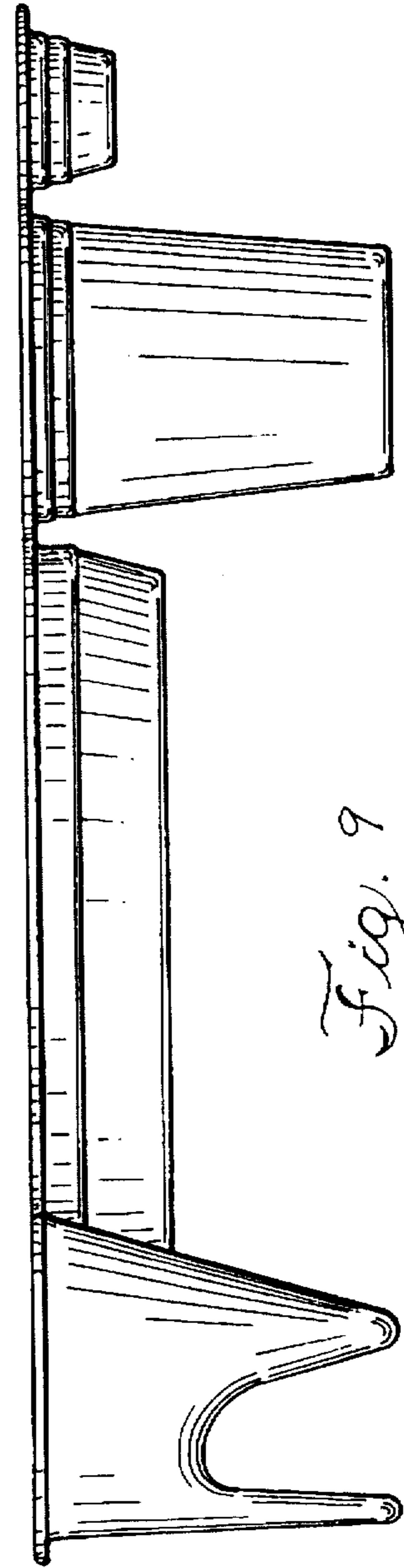

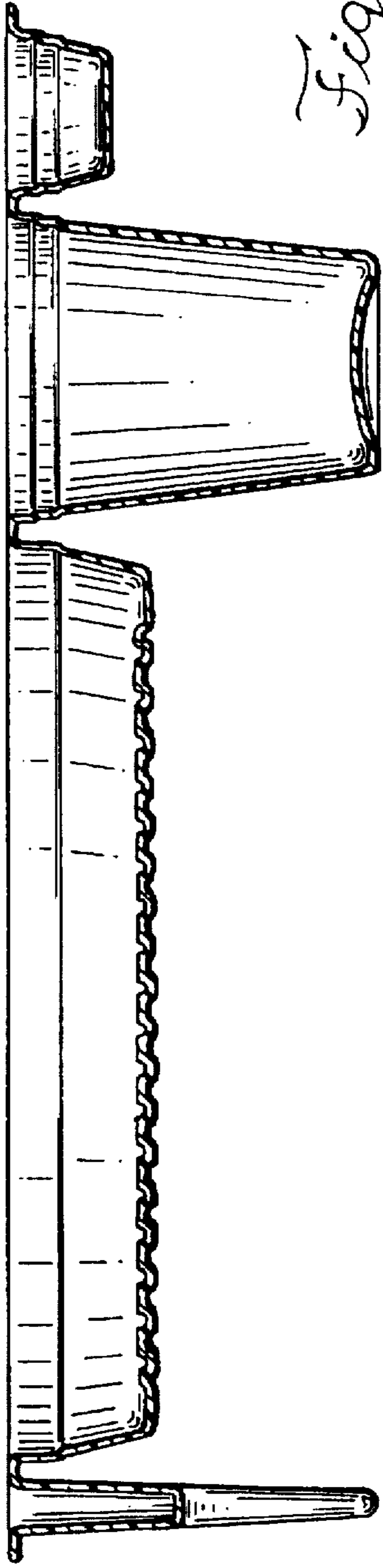

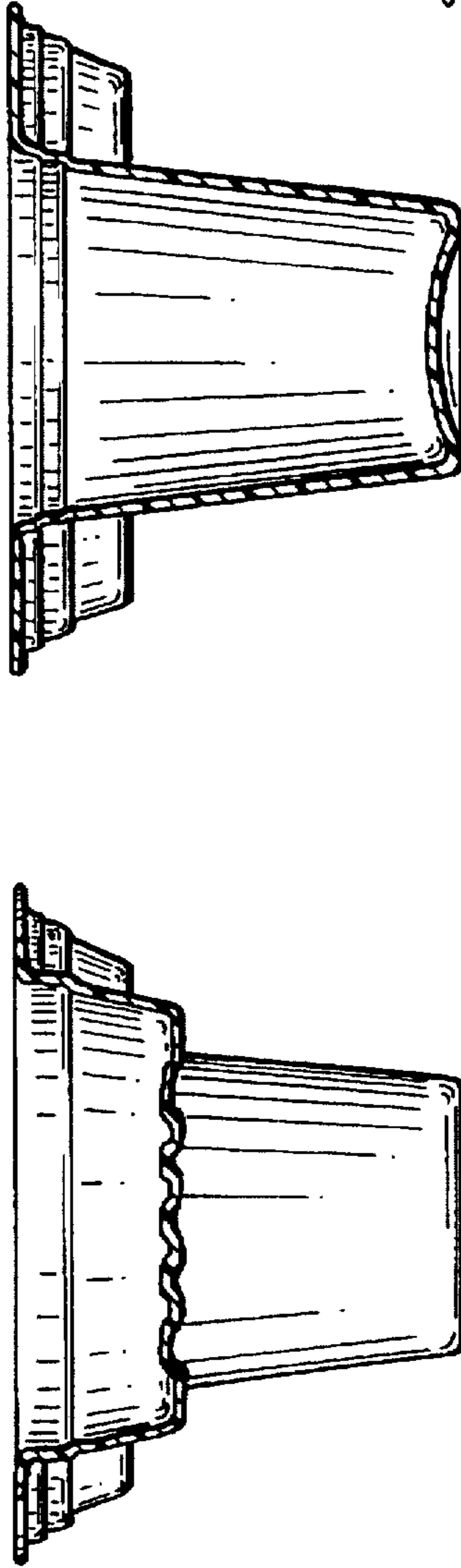
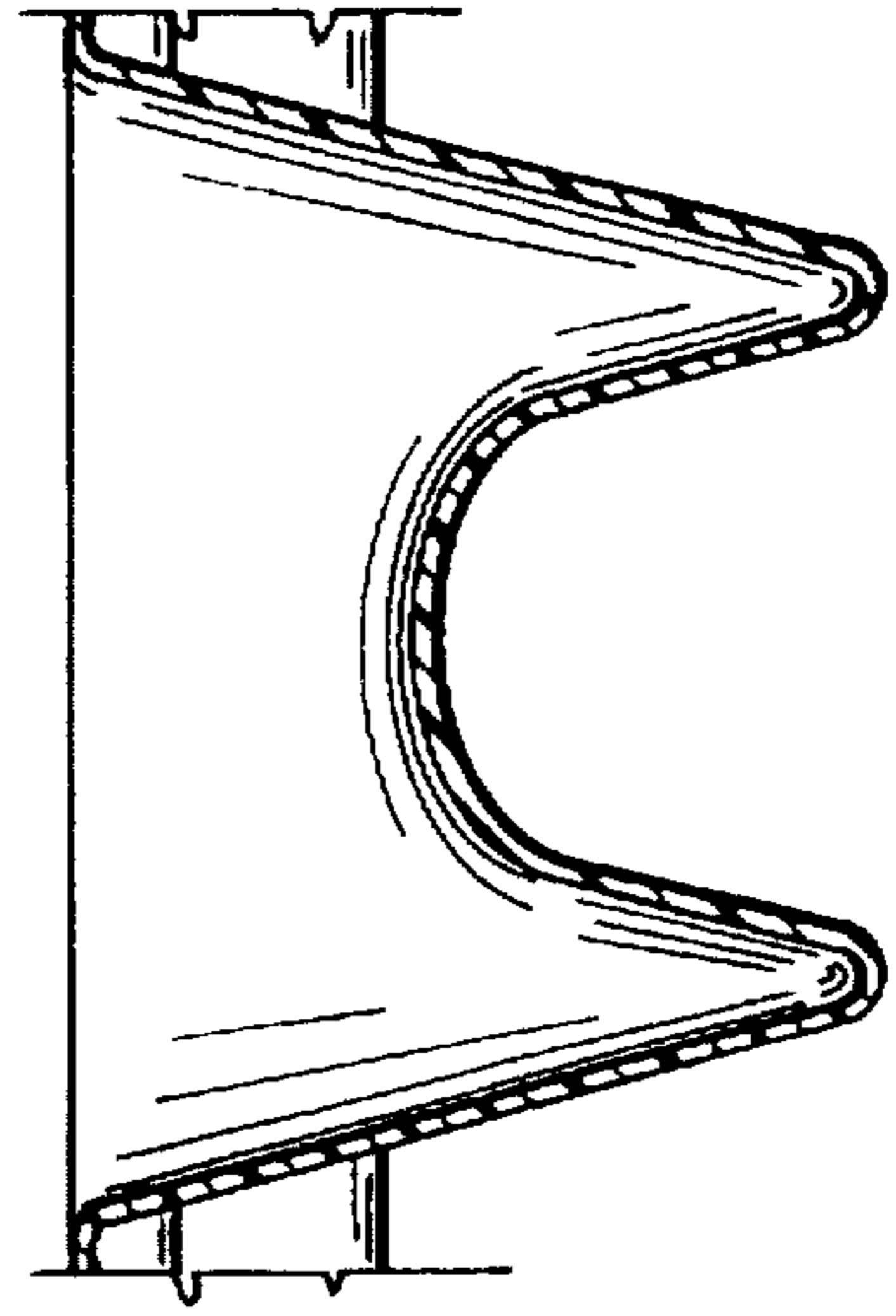
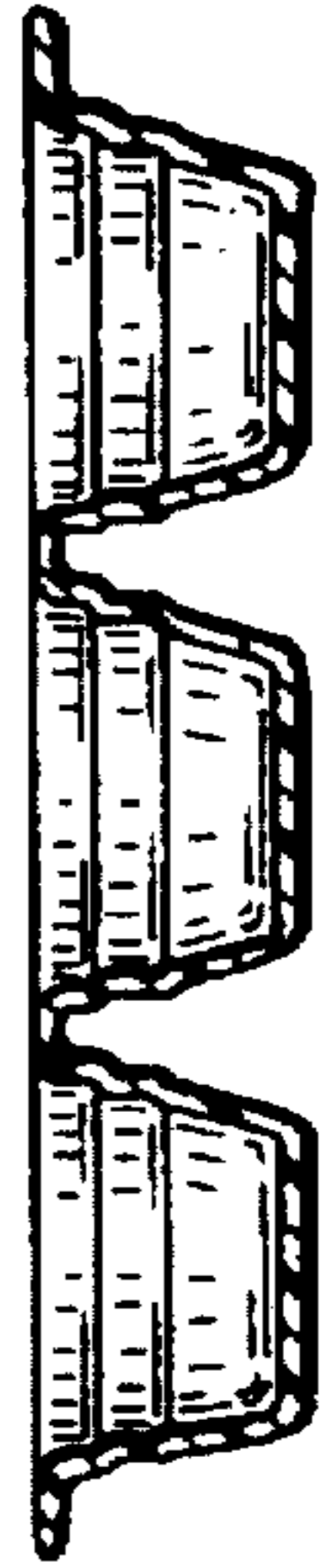

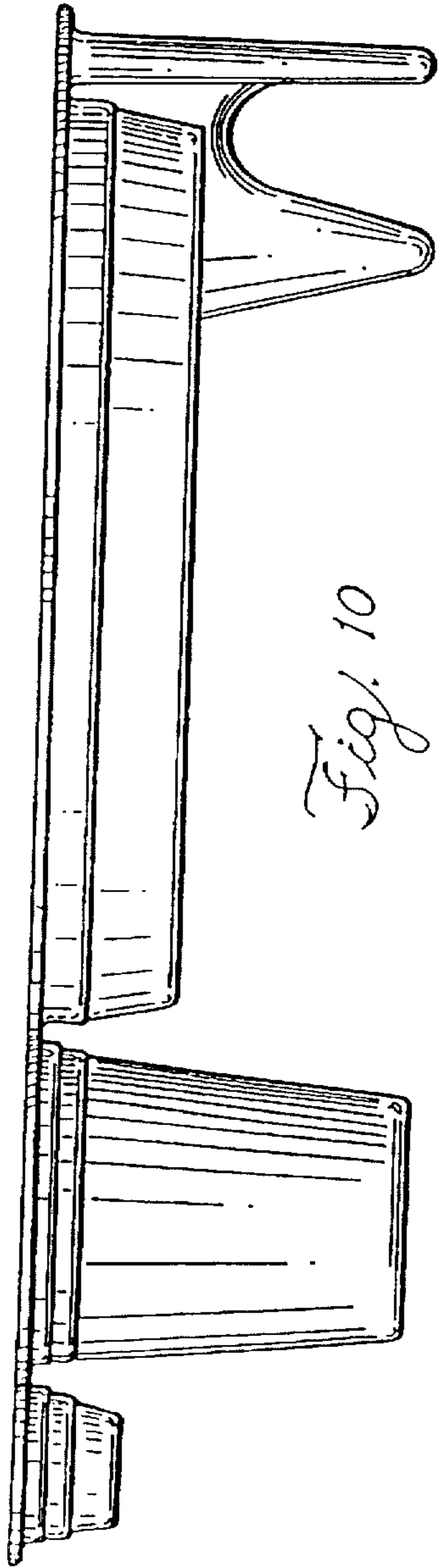

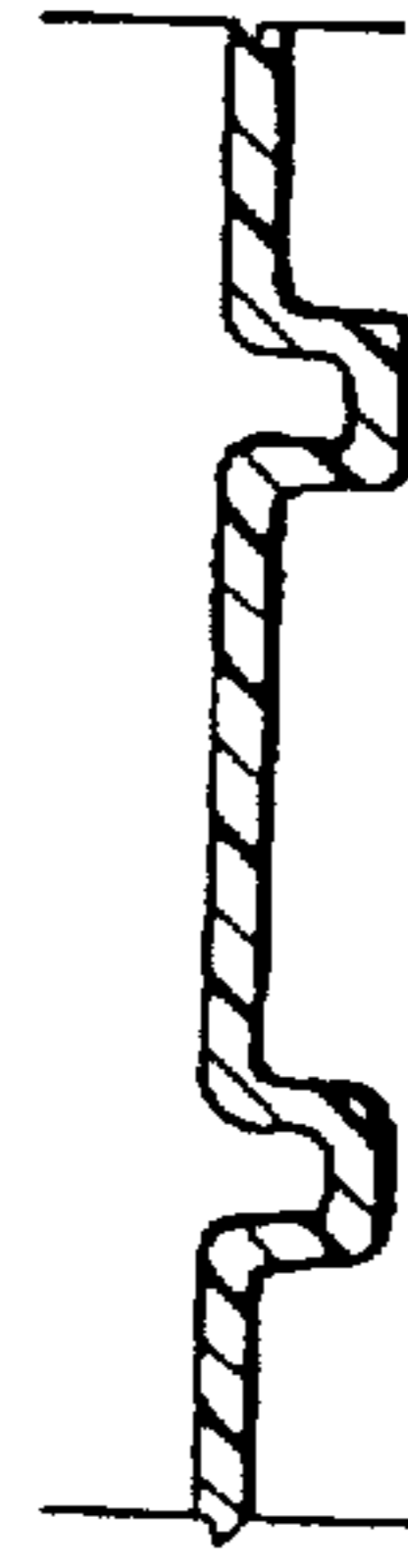
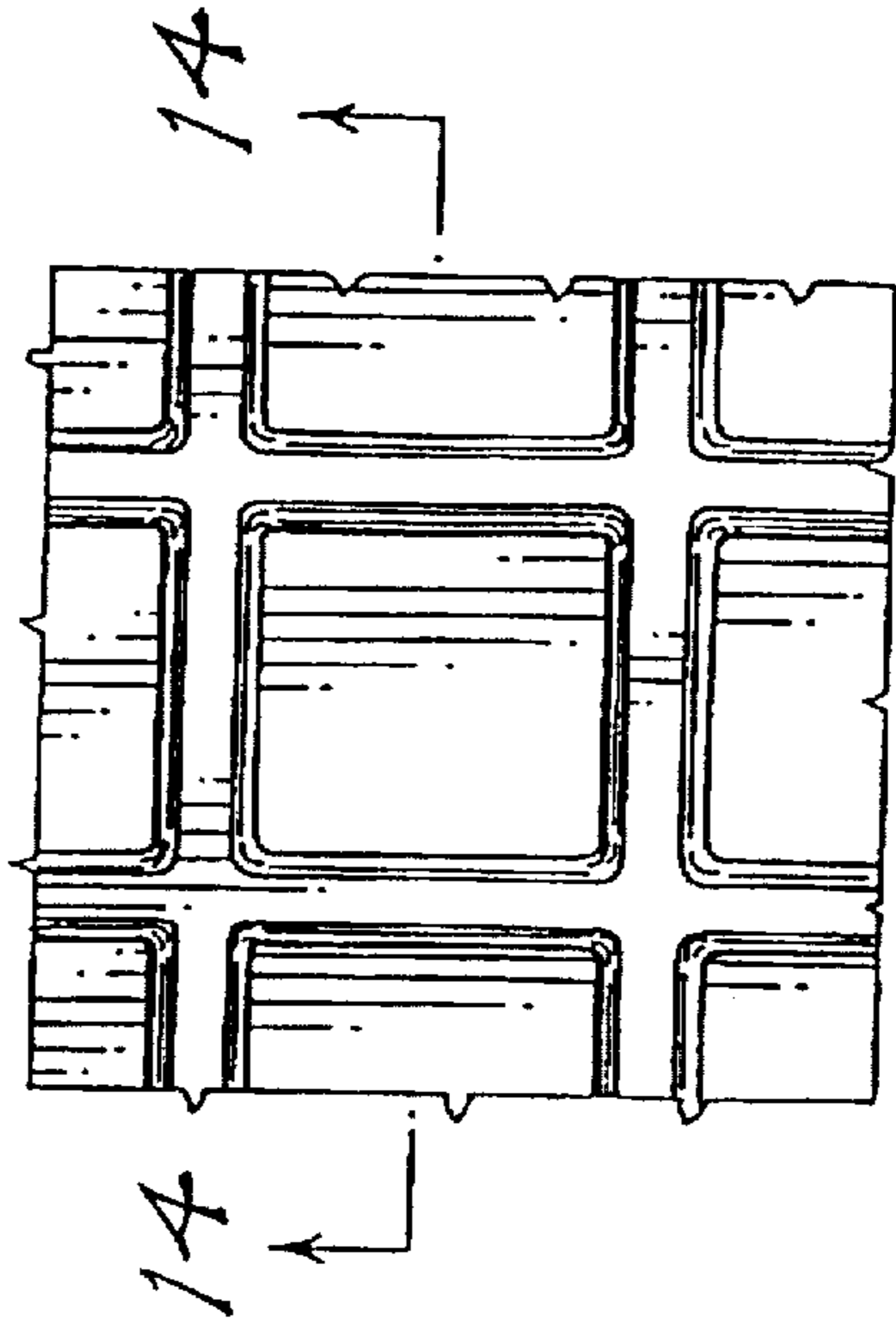

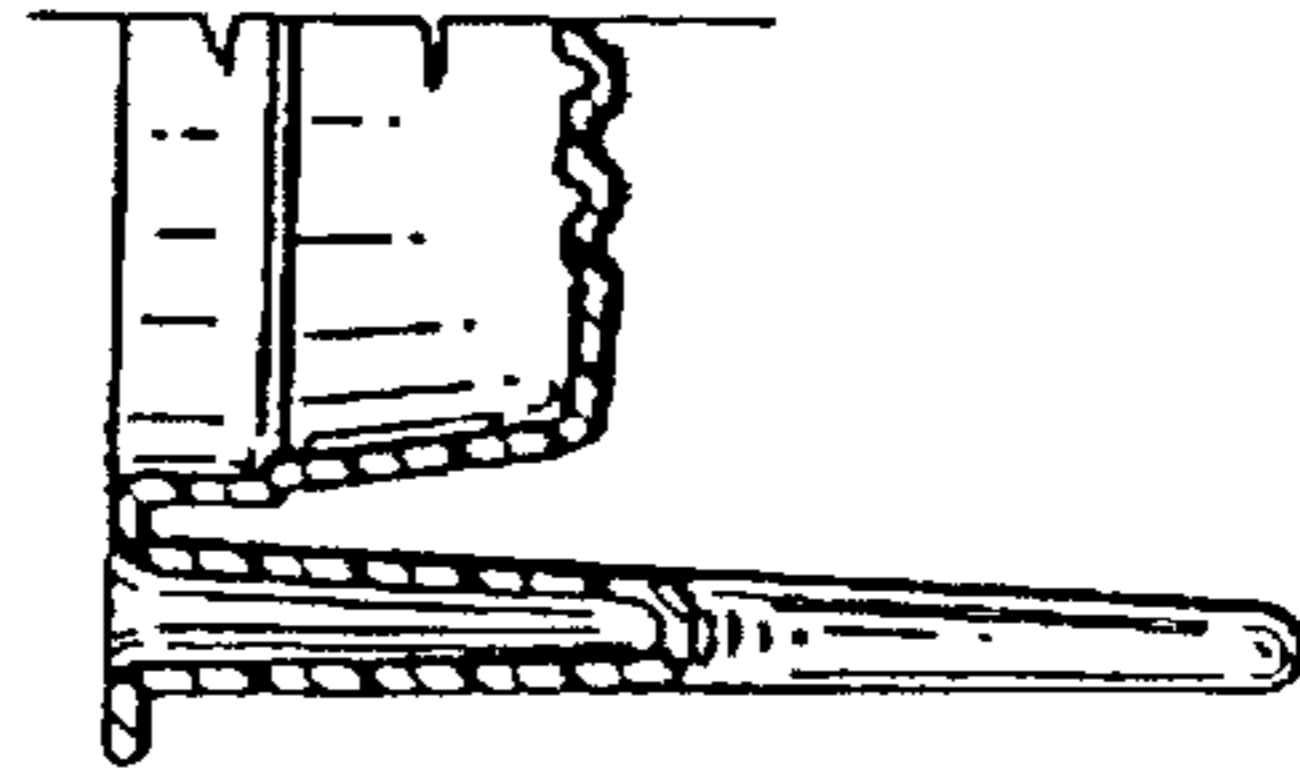
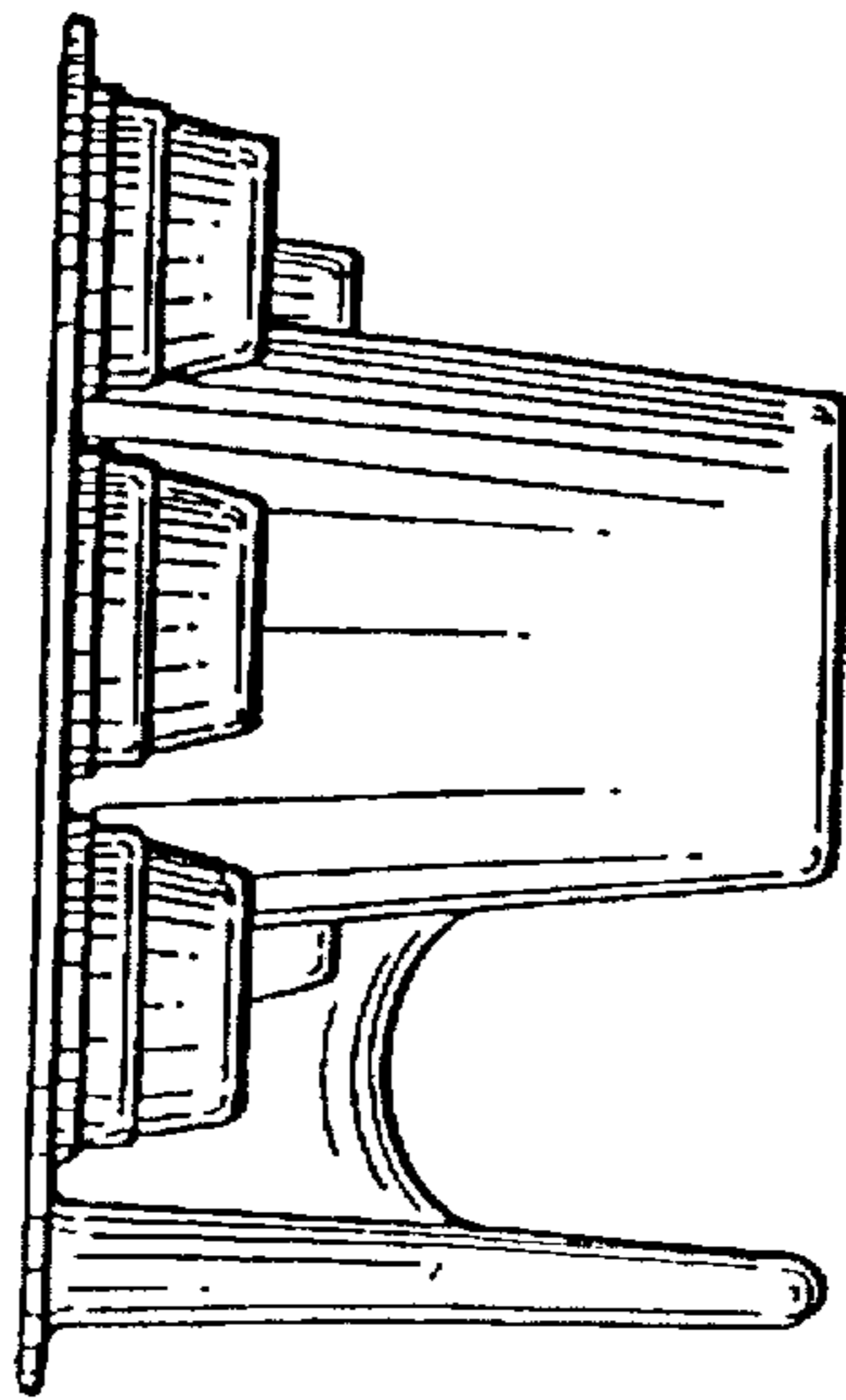
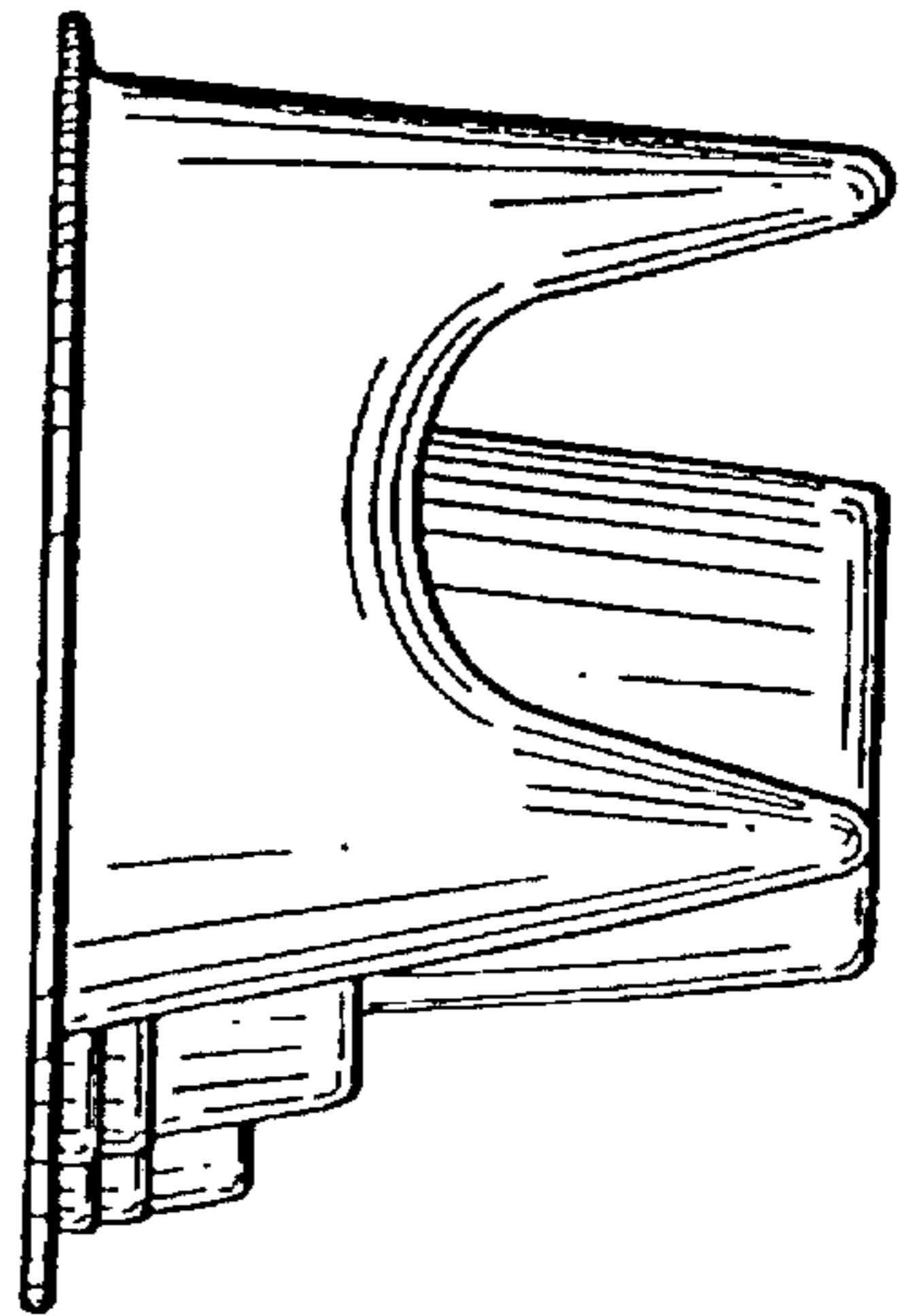

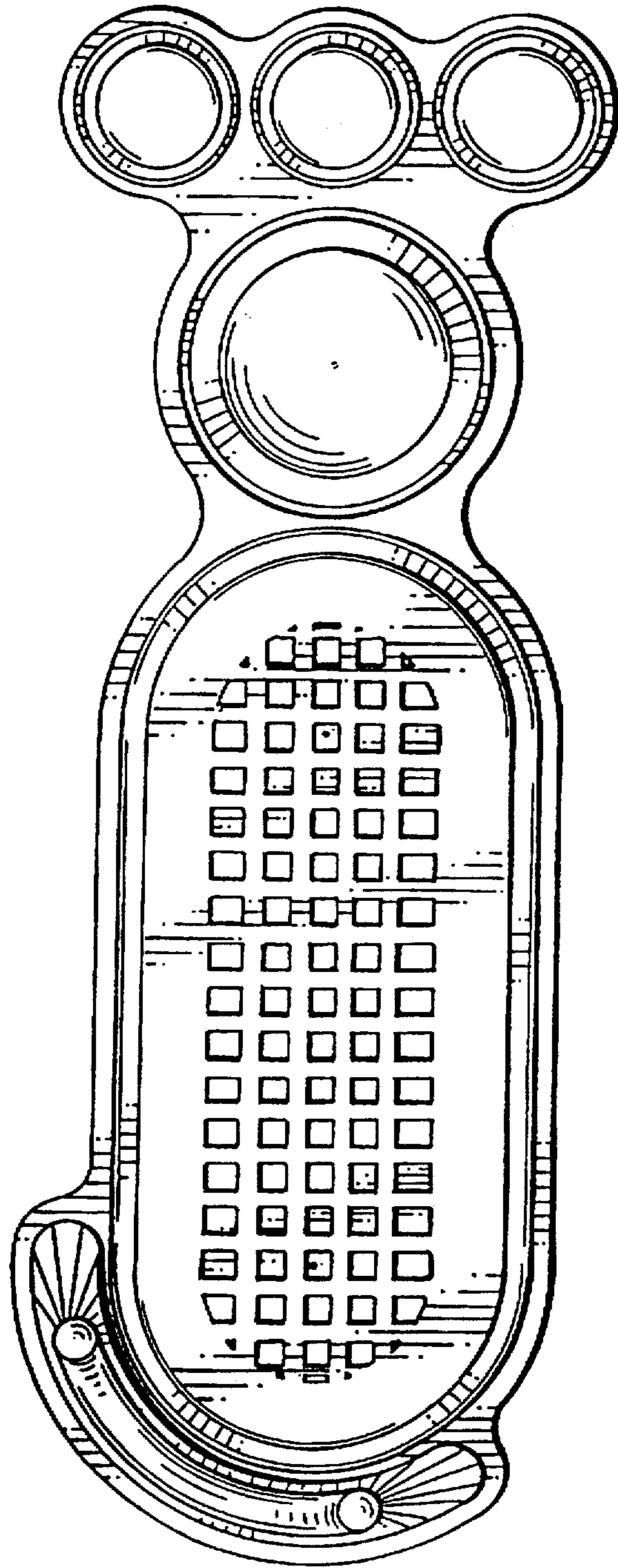
