[57] CLAIM

The ornamental design for a garden playset with panels for decoration, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the garden playset with panels for decoration showing our new design; FIG. 2 is a perspective view of the playset of FIG. 1 with backing panels collapsed to show the fold lines;

FIG. 3 is a perspective view of the playset of FIG. 1 showing rotatable features extended and top and front of cabinet opened to reveal interior;

FIG. 4 is a perspective view of the playset of FIG. 1, top and front of cabinet closed, plus snap-on fence and hinged gate piece;

FIG. 5 is a front elevation view of the playset of FIG. 1, detailing left unit, top and front of cabinet closed, rotatable features retracted;

FIG. 6 is a rear elevation view of the playset of FIG. 1, showing the means of attaching the backing panel, rotatable features retracted;

FIG. 7 is a right elevation view of the playset of FIG. 1, detailing left unit, top and front of cabinet closed, rotatable features retracted;

FIG. 8 is a left elevation view of the playset of FIG. 1, detailing left unit, top and front of cabinet closed, rotatable features retracted;

FIG. 9 is a top elevation view of the playset of FIG. 1, detailing left unit, top and front of cabinet closed, rotatable features retracted;

FIG. 10 is a bottom elevation view of the playset of FIG. 1 detailing left unit, top and front of cabinet closed, rotatable features retracted;

FIG. 11 is a front elevation view of the playset of FIG. 1, detailing left unit, top and front of cabinet open, rotatable features extended;

FIG. 12 is a left elevation view of the playset of FIG. 1, detailing left unit, top and front of cabinet open, rotatable features extended;

FIG. 13 is a top elevation view of the playset of FIG. 1, detailing left unit, top and front of cabinet open, rotatable features extended;

FIG. 14 is a front elevation view of the playset of FIG. 1, detailing left unit, top and front of cabinet open, rotatable features retracted, with fence and gate in place;

FIG. 15 is a right elevation view of the playset of FIG. 1, detailing left unit, top and front of cabinet closed, rotatable features retracted, with fence and gate in place; and,

FIG. 16 is a top elevation view of the playset of FIG. 1, detailing left unit, top and front of cabinet closed, rotatable features retracted, with fence and gate in place.

The snap-on fence and hinged gate are shown only in FIG. 4, 14, 15 and 16 for ease of illustration only.

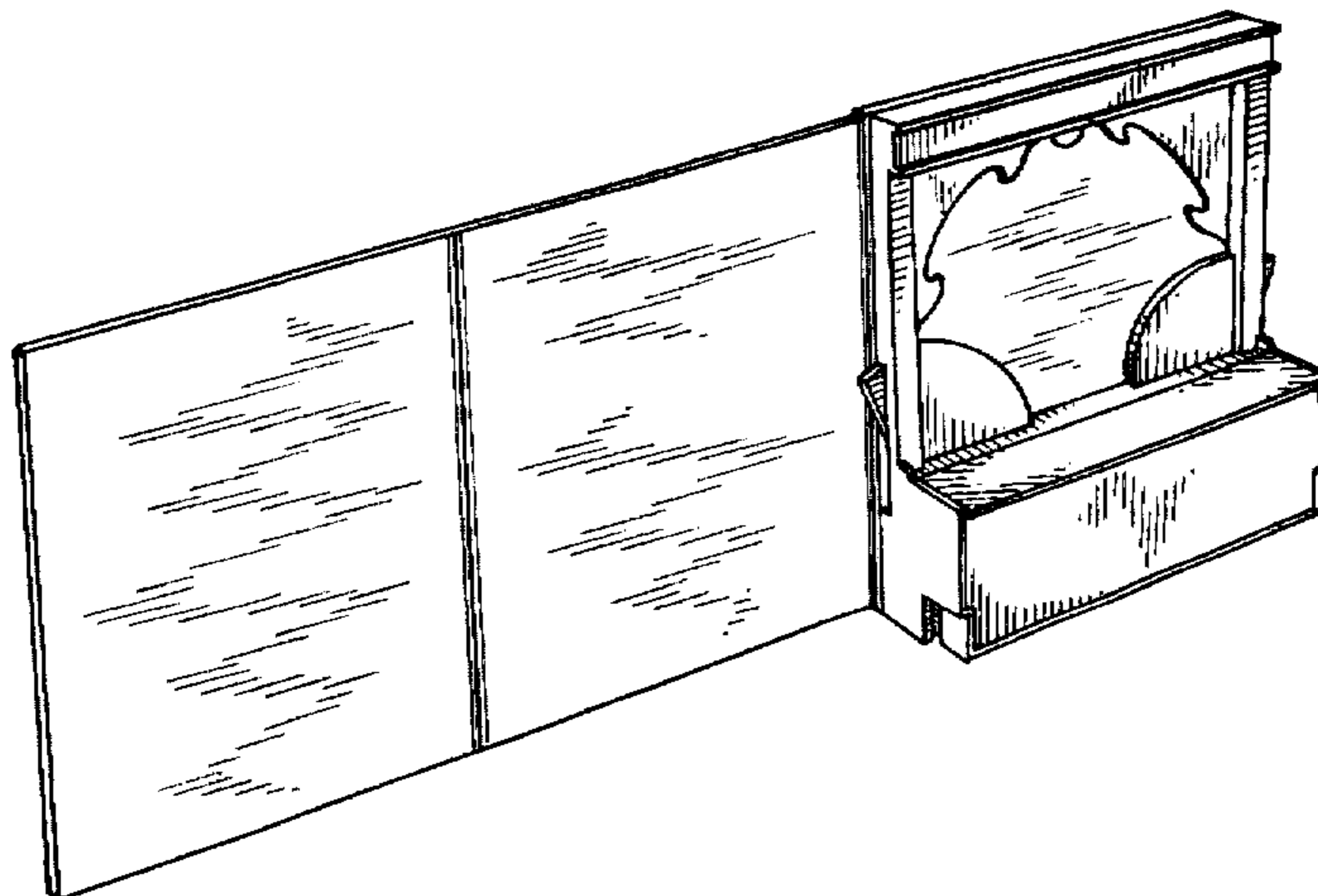

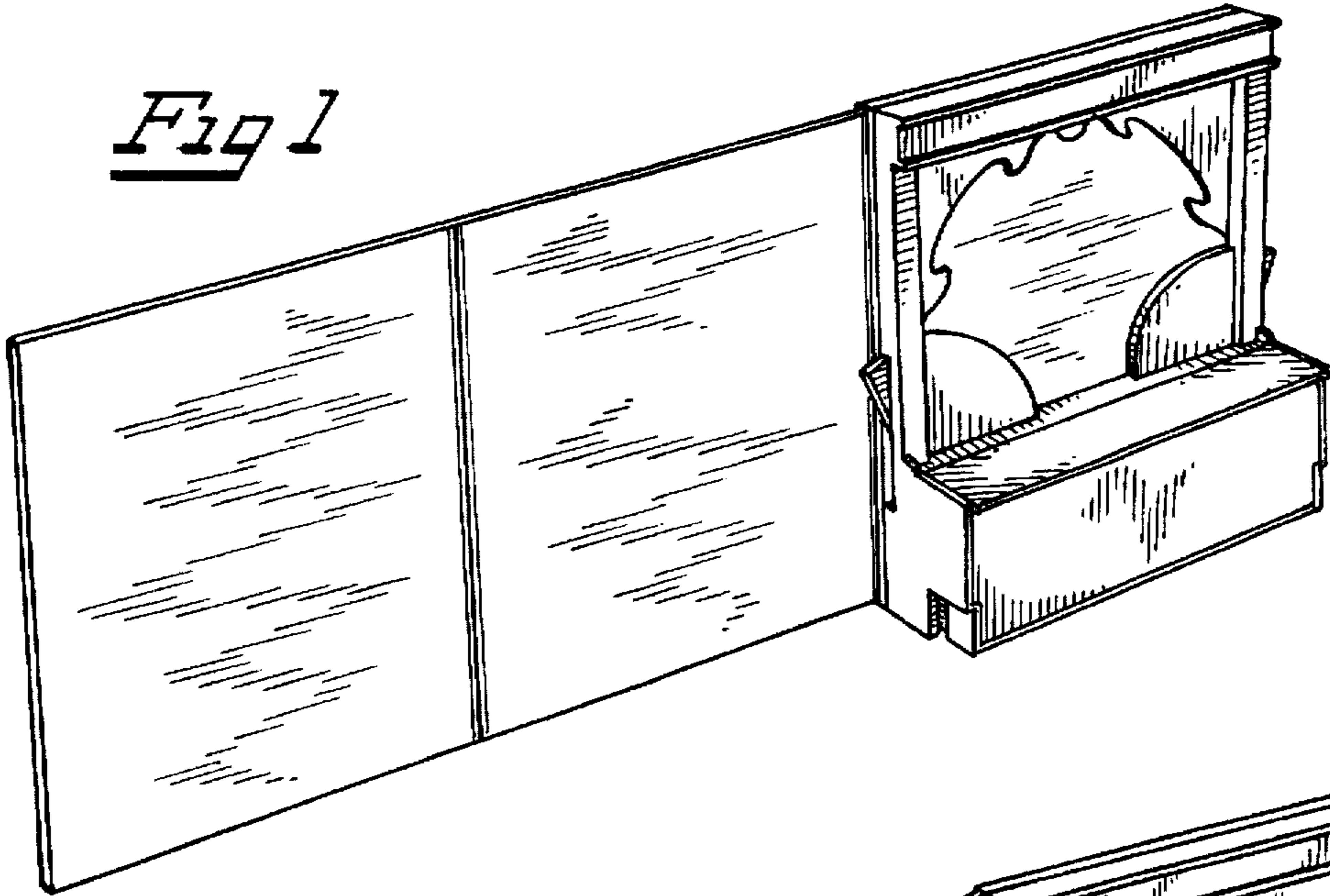

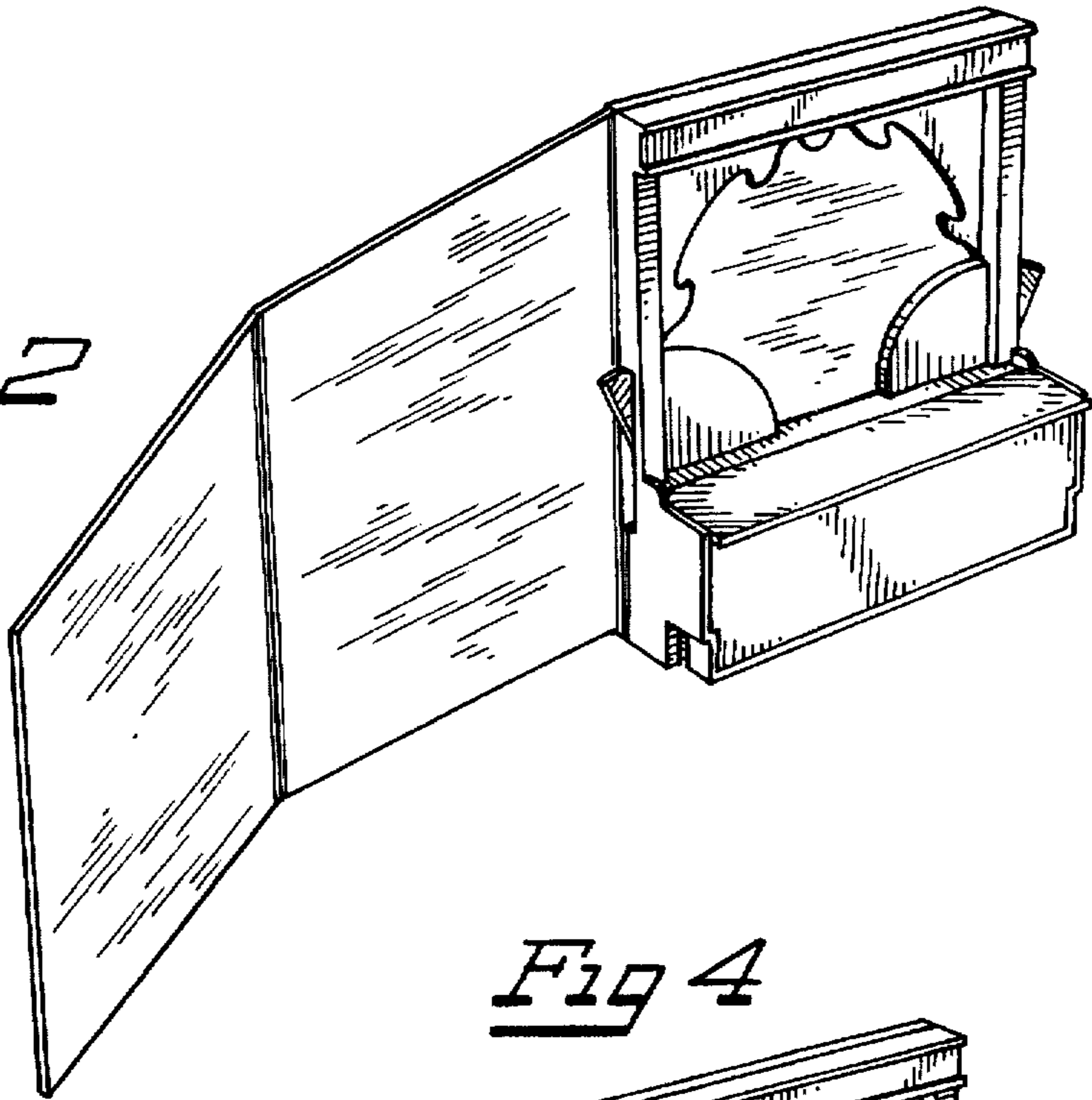

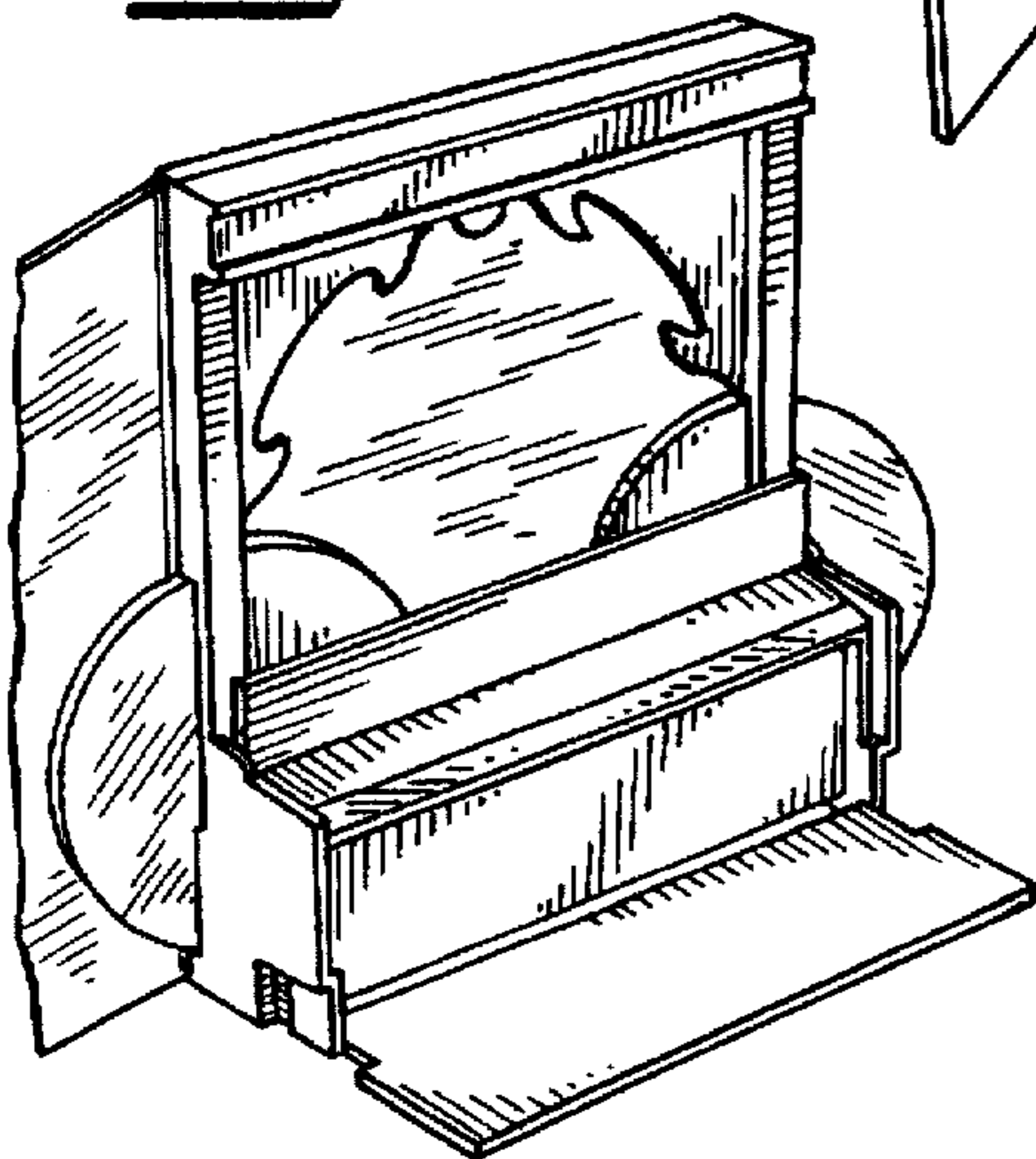

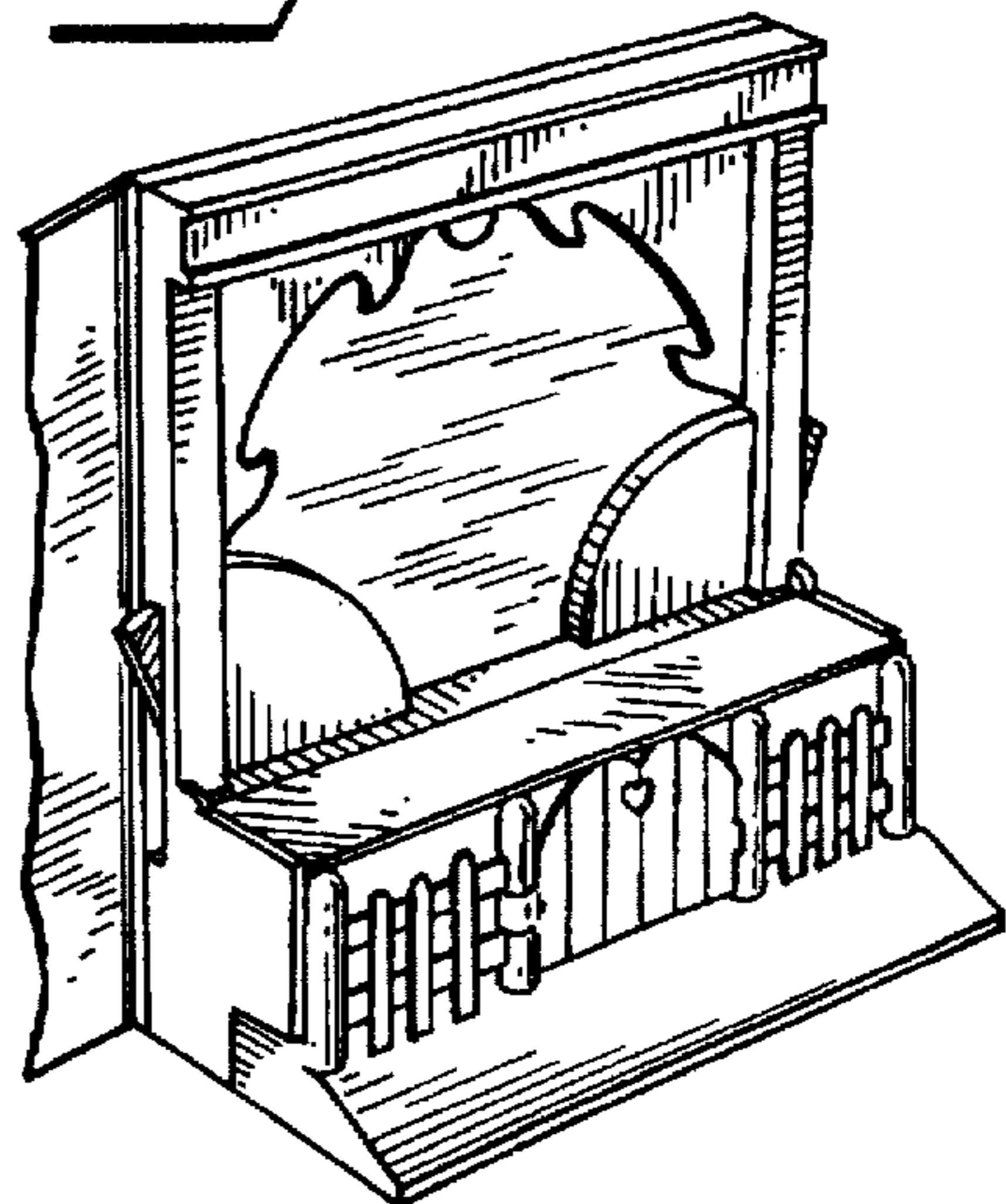

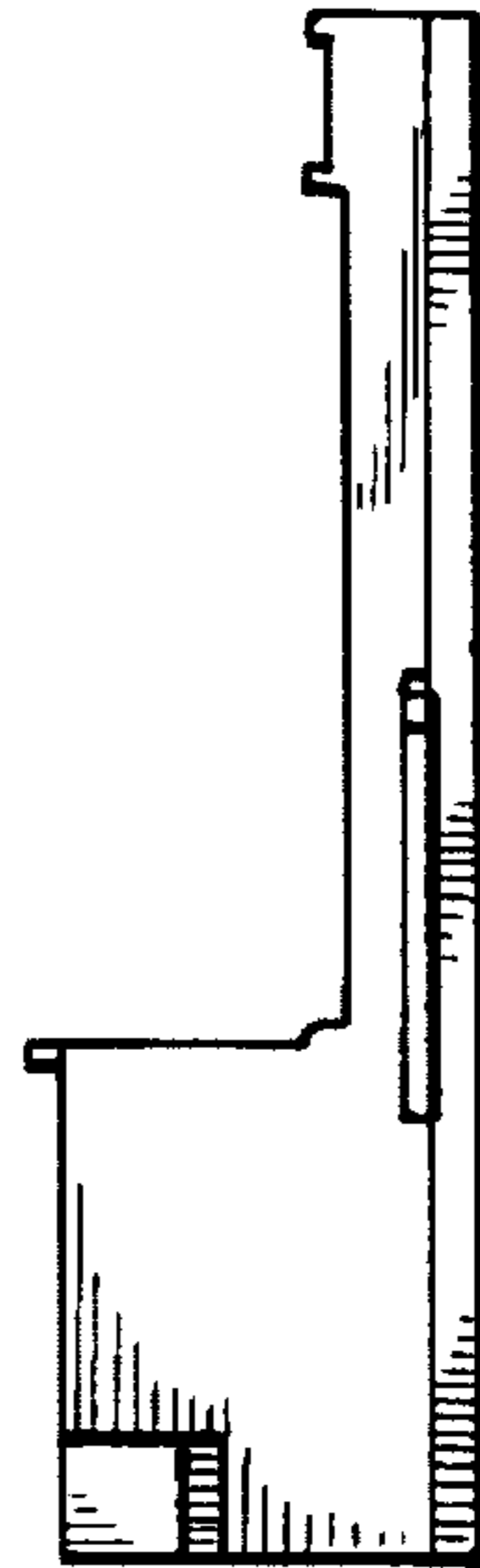

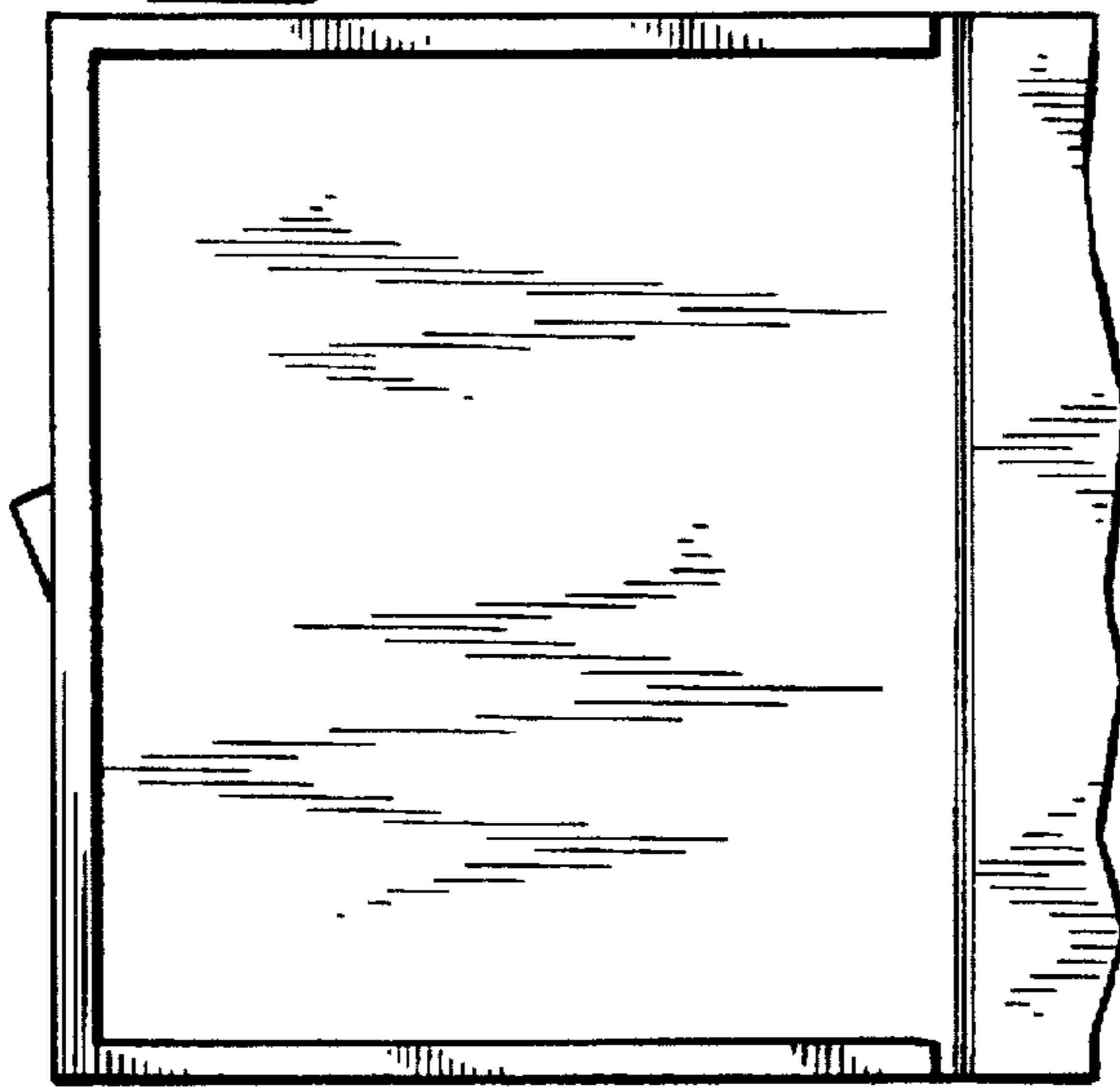

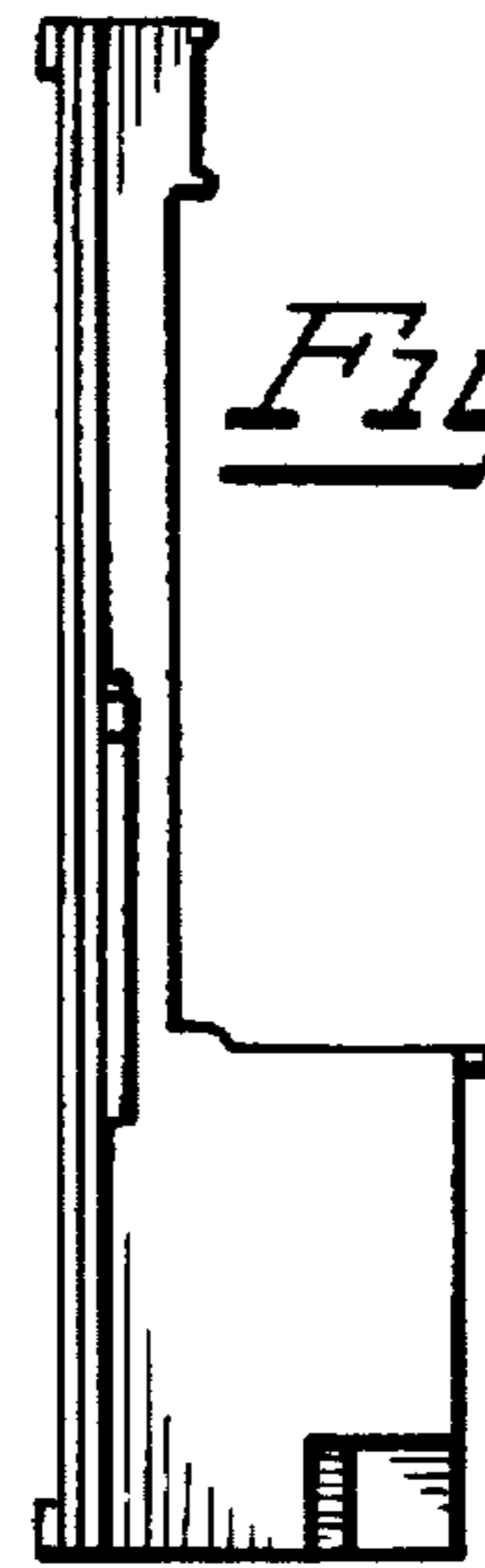

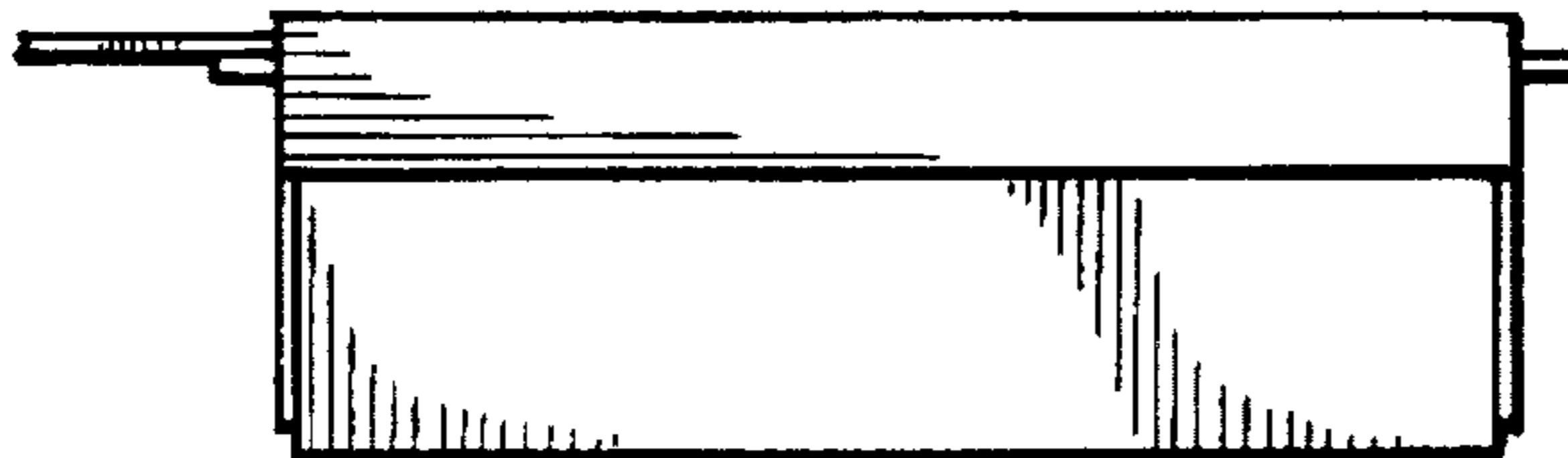

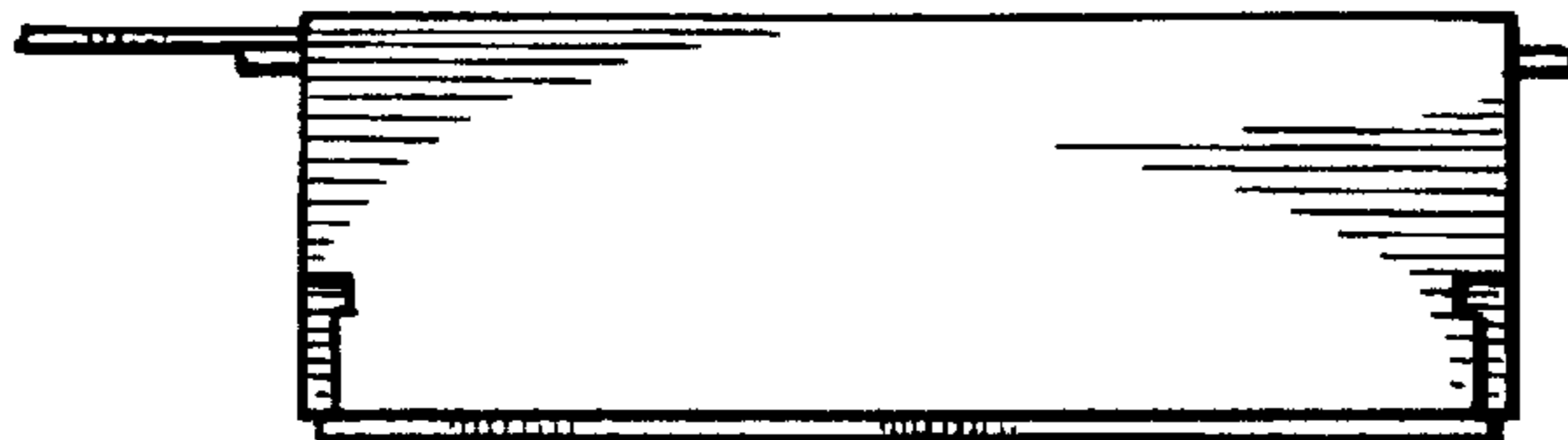

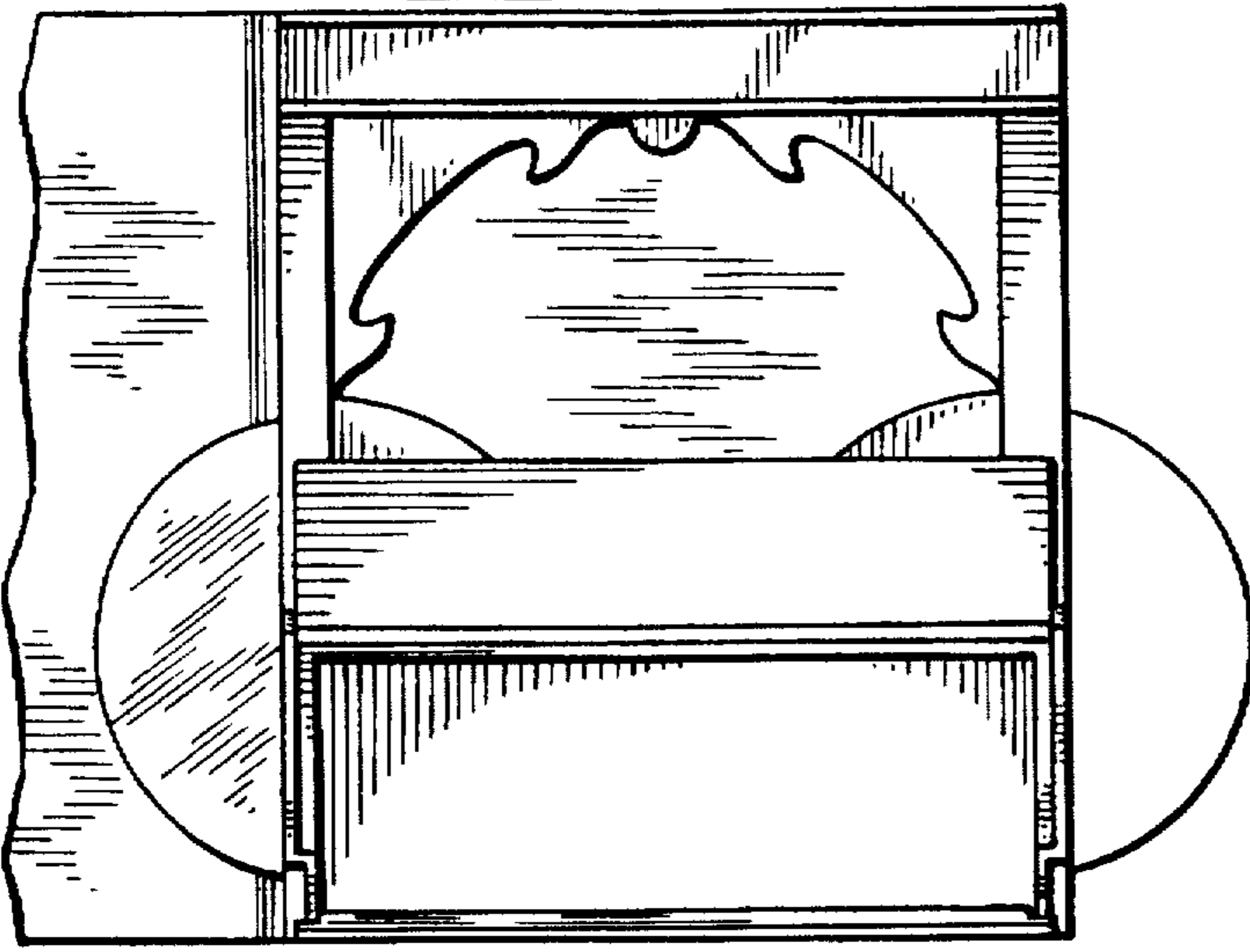

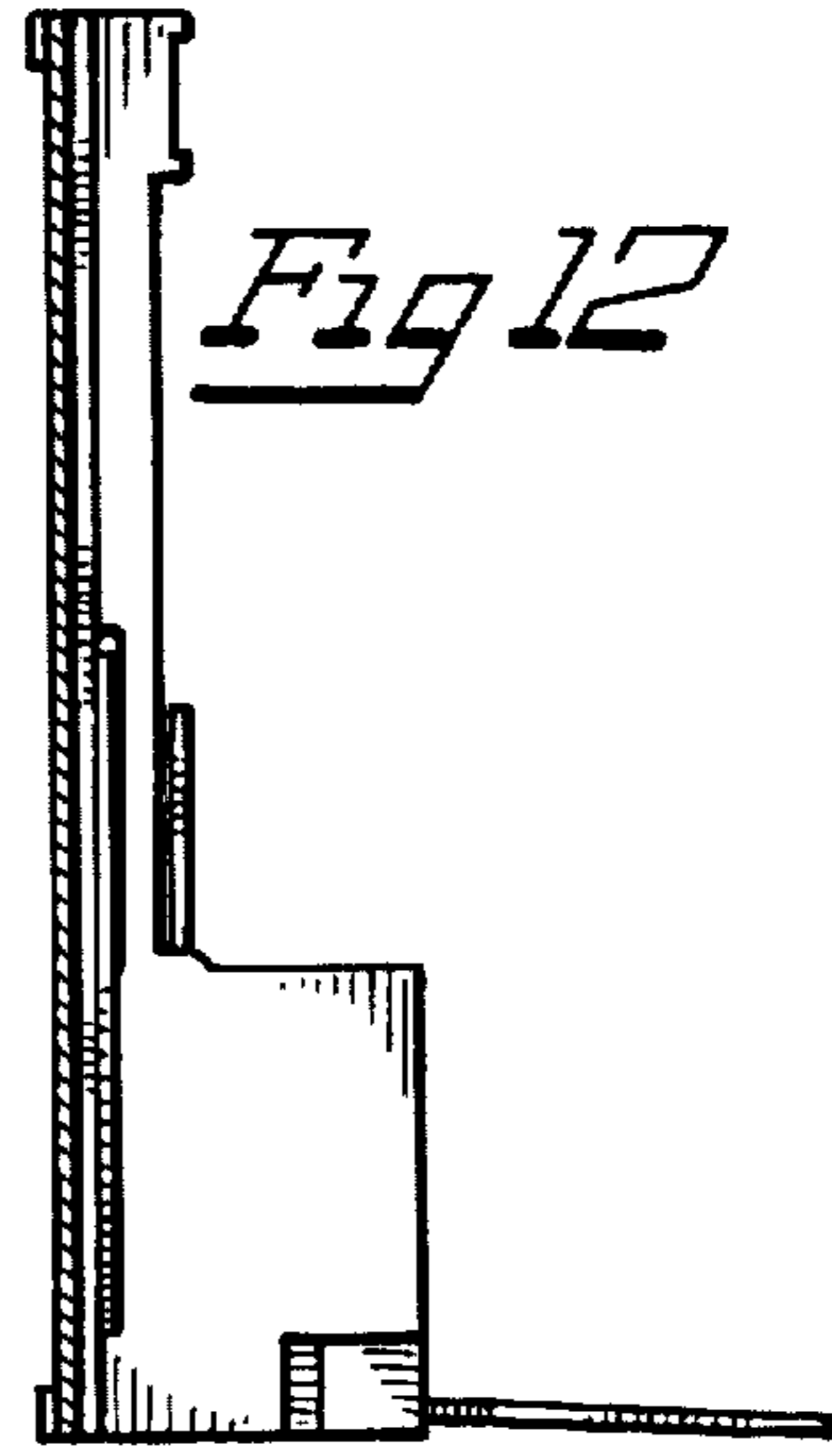

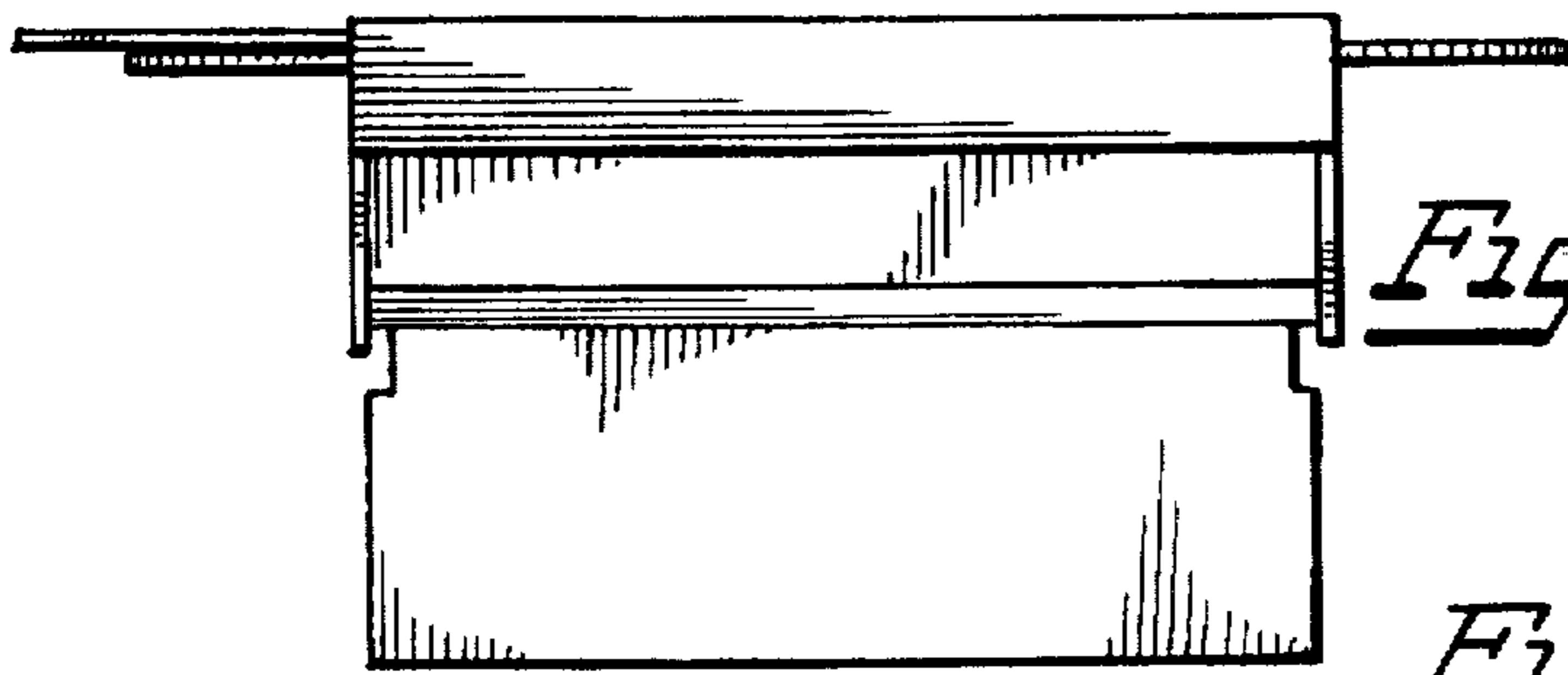

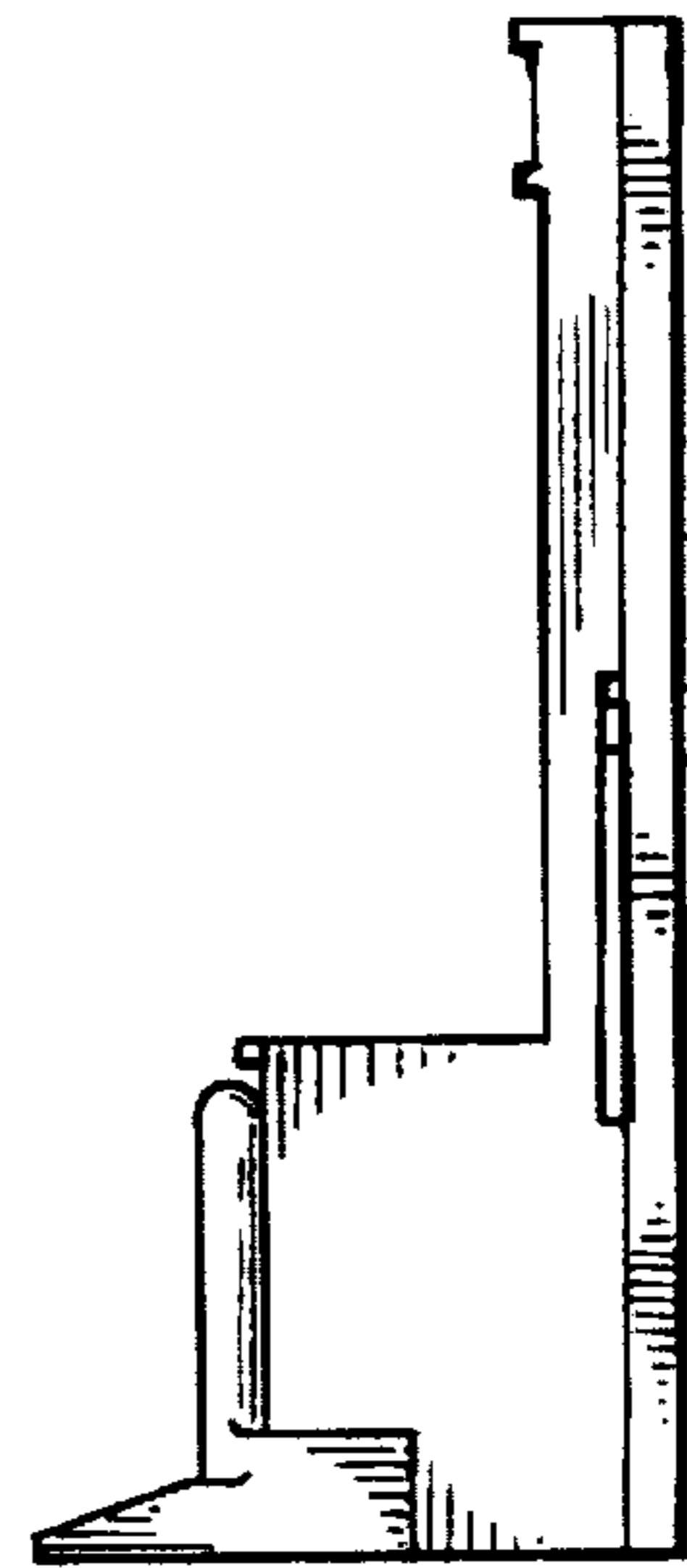
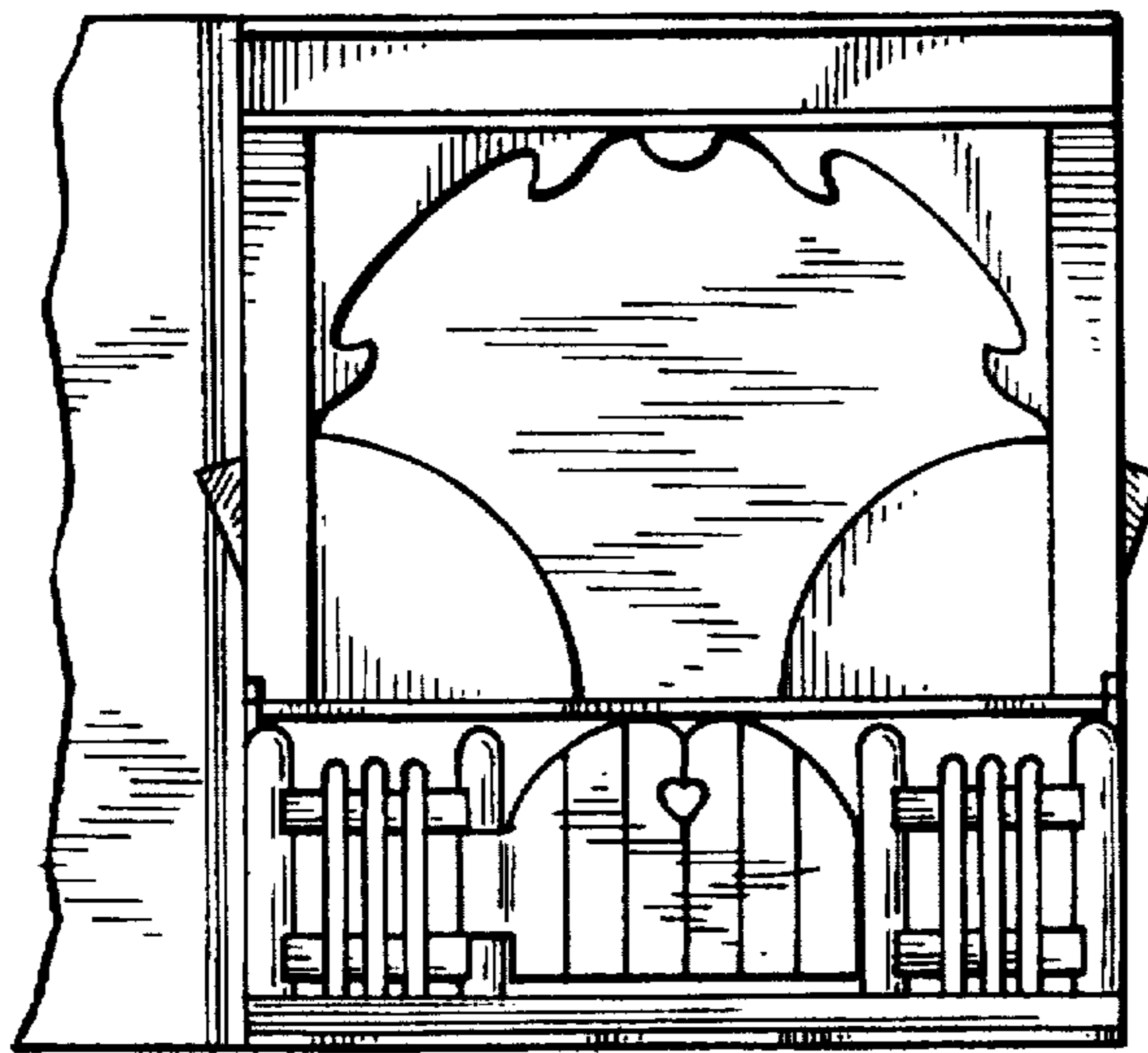
