[57] **CLAIM**

The ornamental design for a portion of a shoe upper, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a portion of a shoe upper showing our new design;

FIG. 2 is a front elevational view of the portion of a shoe upper shown in FIG. 1;

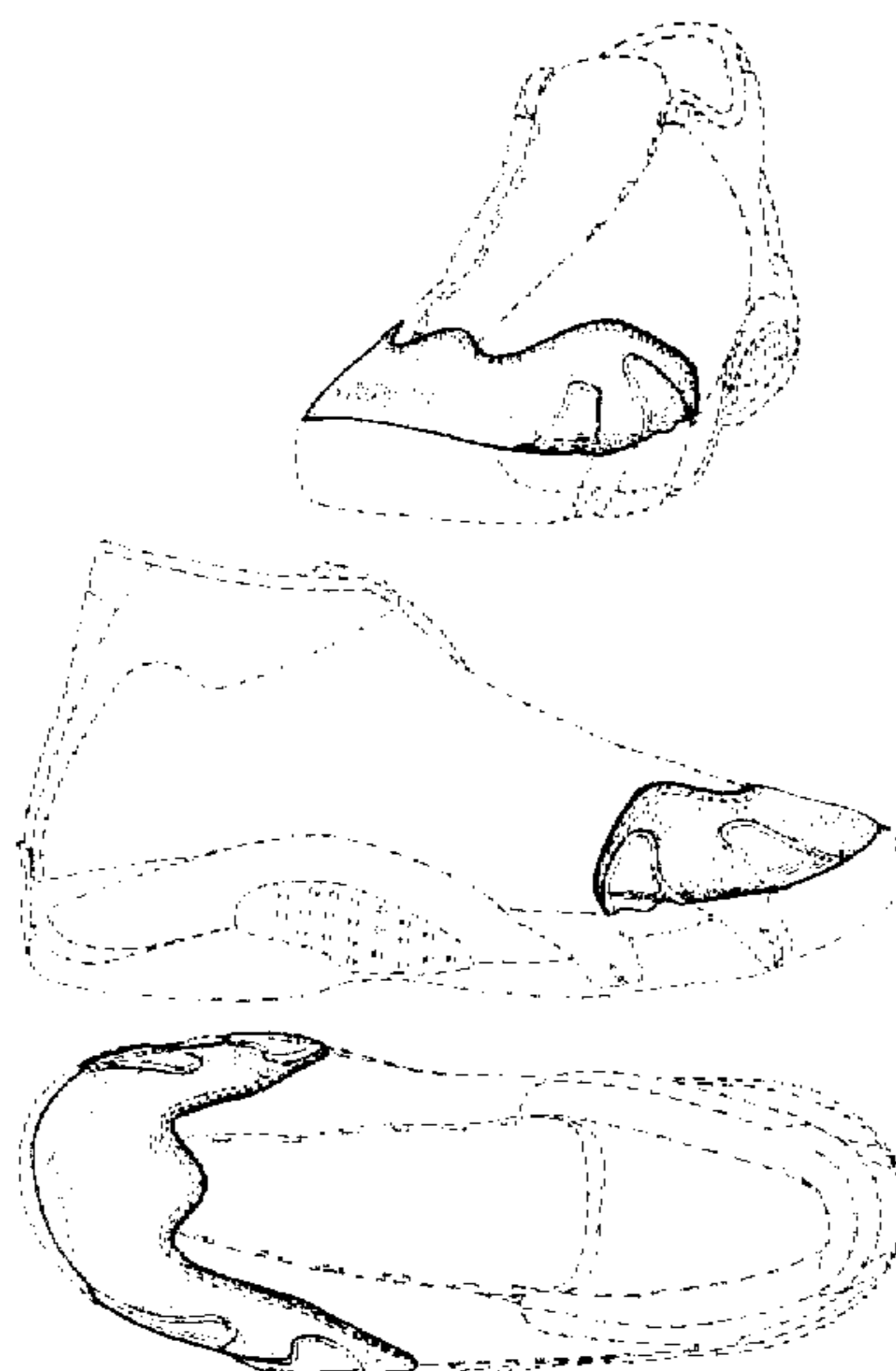
FIG. 3 is a side elevational view of one side of the portion of a shoe upper shown in FIG. 1;

FIG. 4 is a side elevational view of the other side of the portion of a shoe upper shown in FIG. 1; and,

FIG. 5 is a top plan view of the portion of a shoe upper shown in FIG. 1.

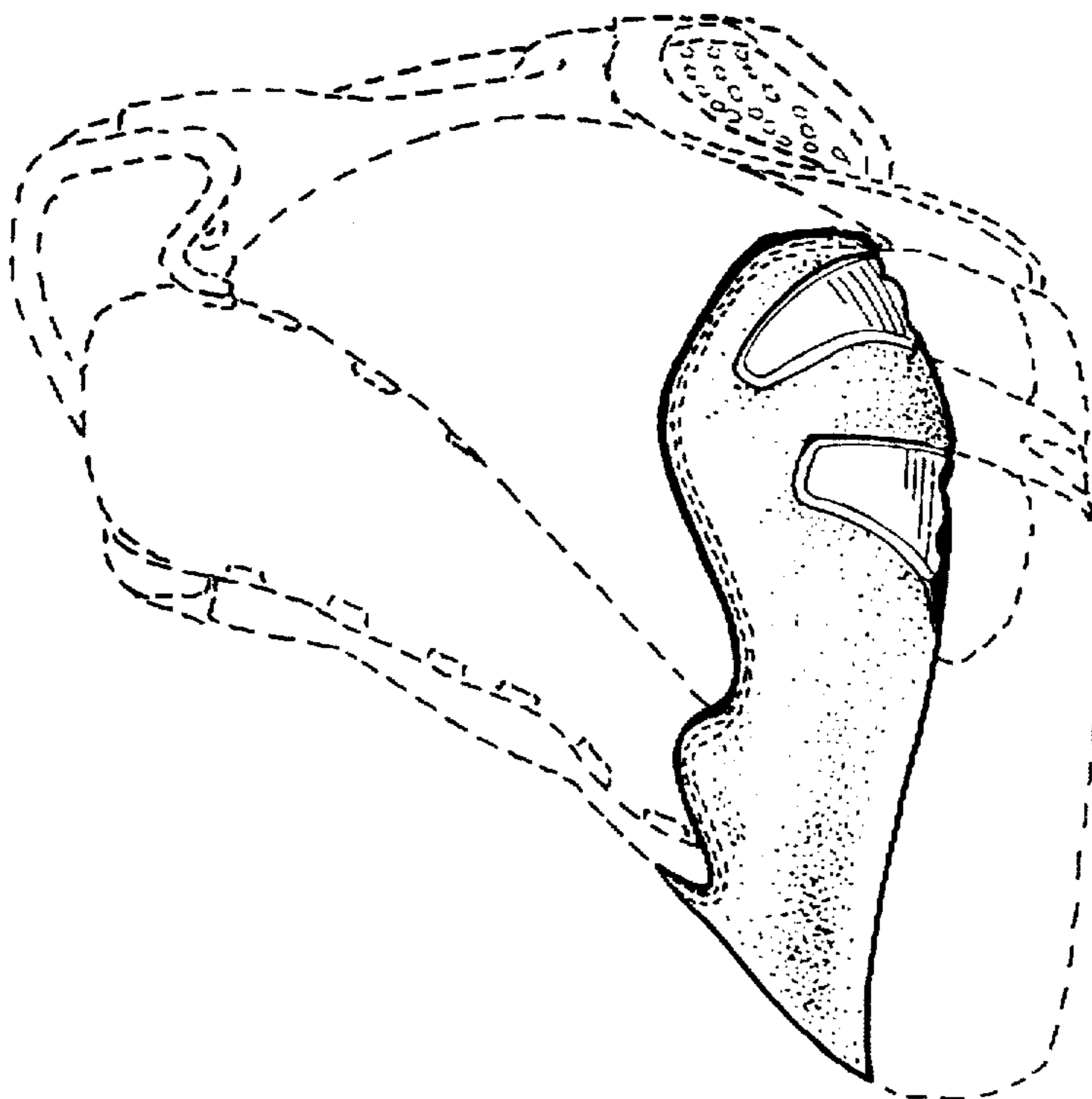

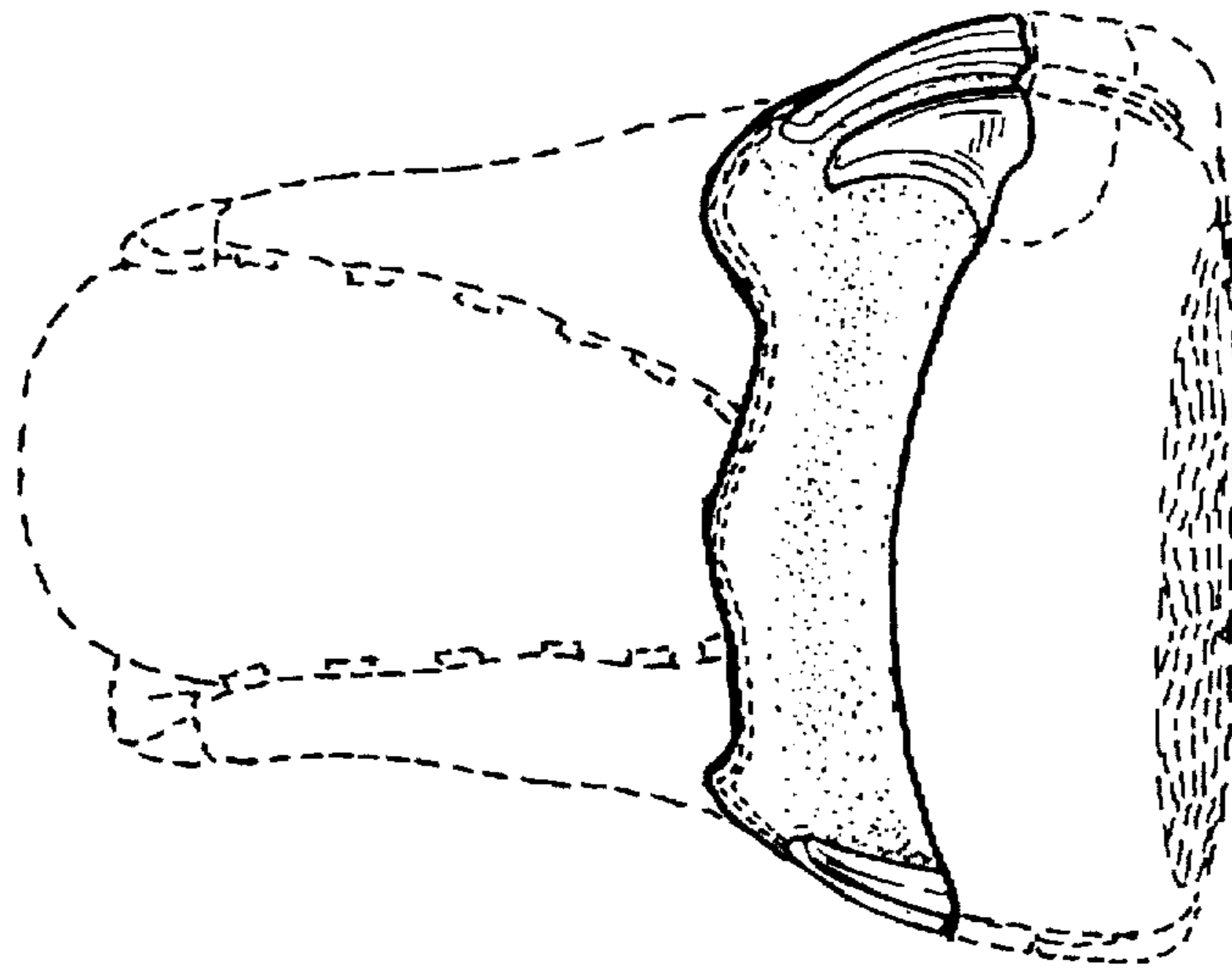
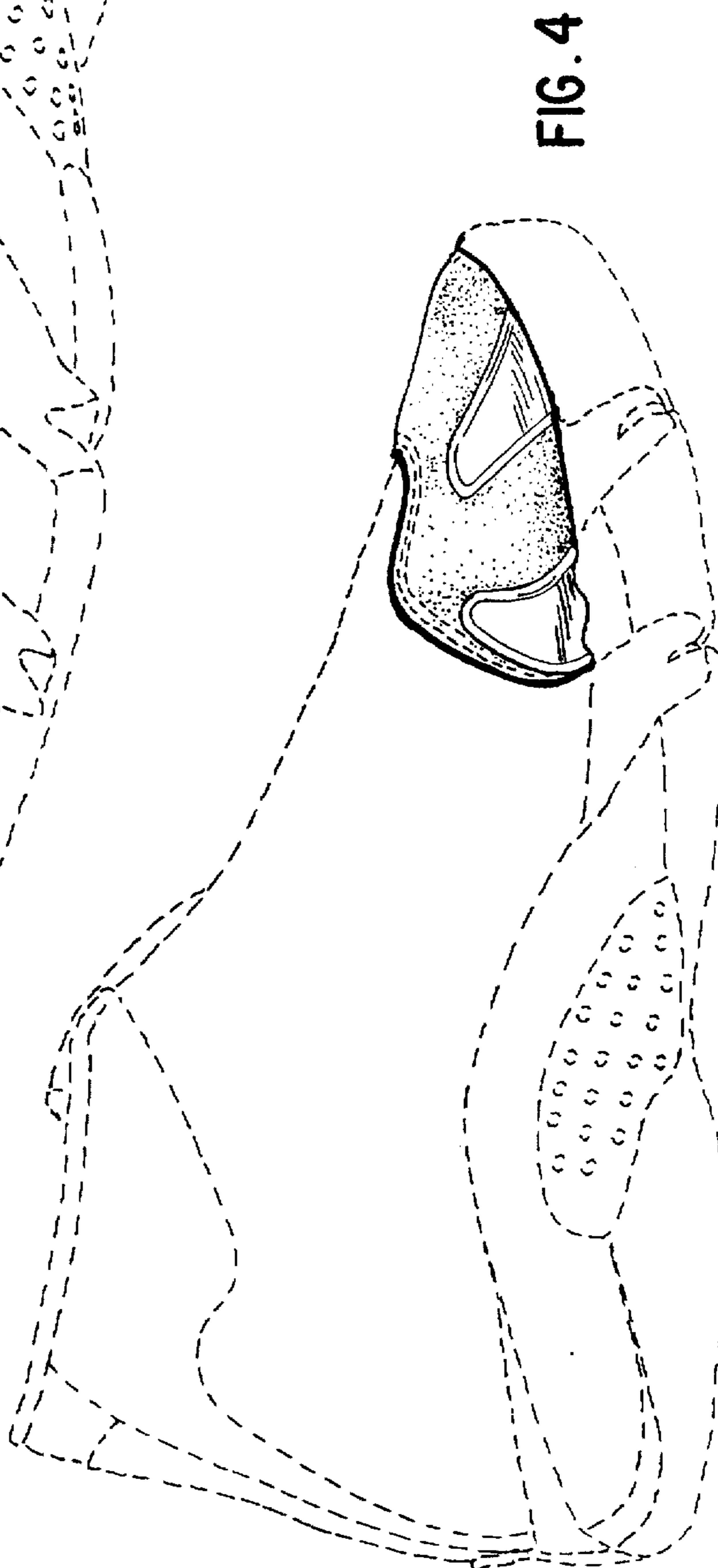
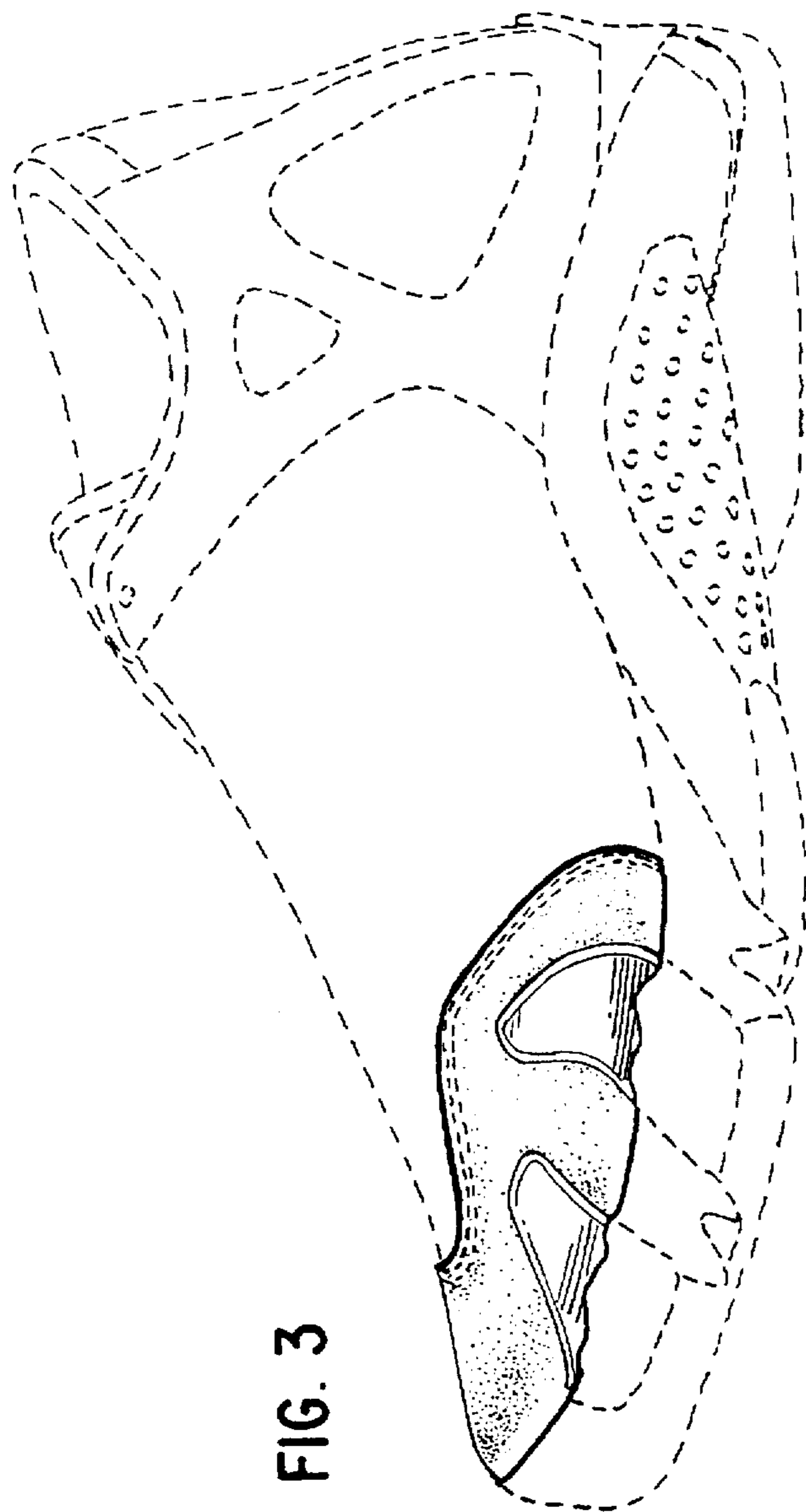

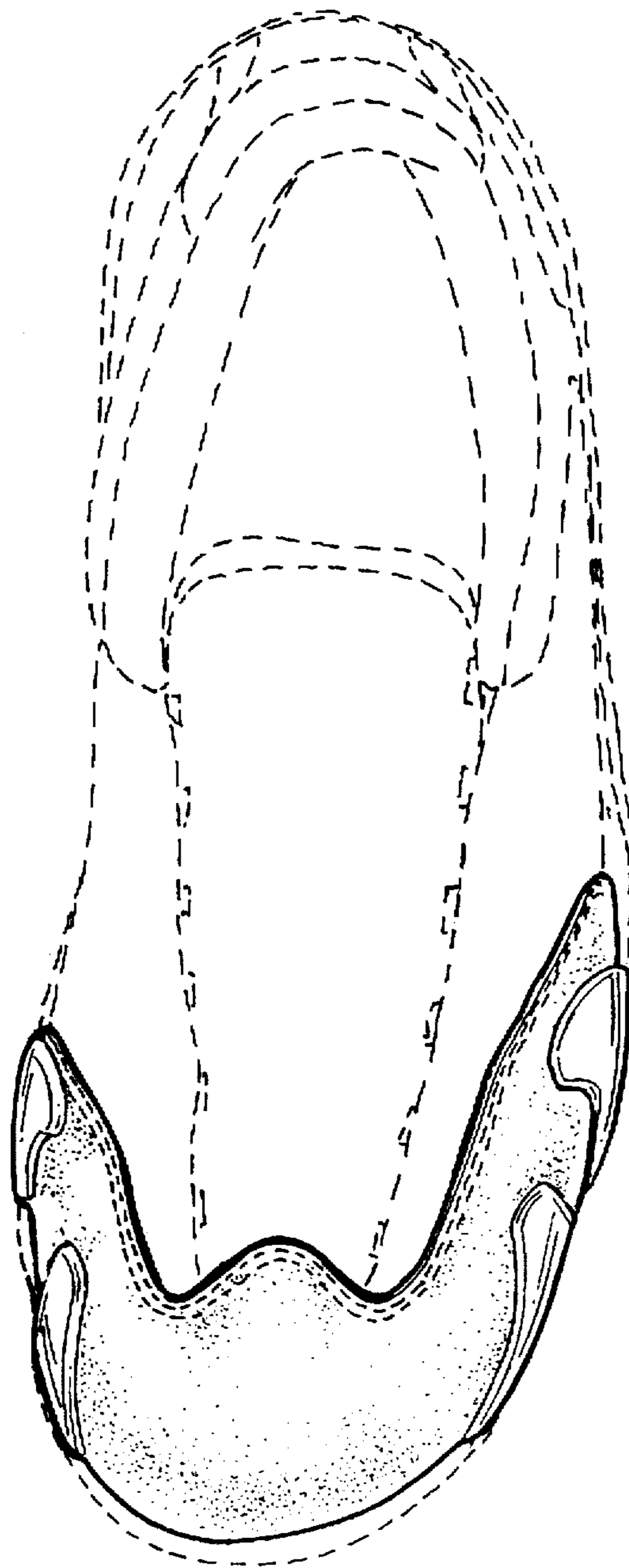
