[57] **CLAIM**

The ornamental design for an ornamental plate and candle holder display, as shown and described.

DESCRIPTION

FIG. 1 is an isometric view showing the front, top, and side of an ornamental plate and candle holder display according to the new design;

FIG. 2 is a top plan view of the design of FIG. 1;

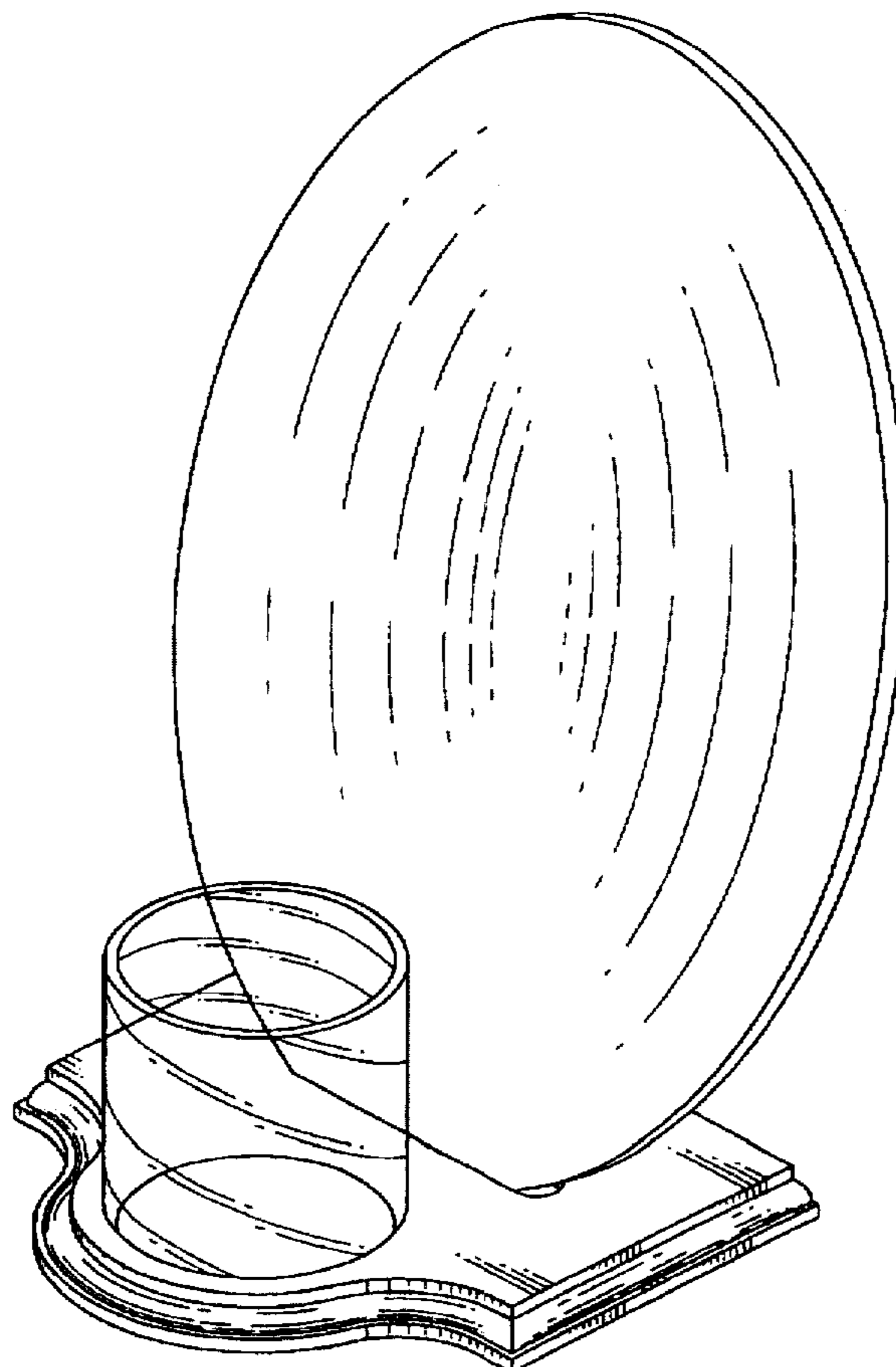
FIG. 3 is a bottom plan view of the design of FIG. 1;

FIG. 4 is a front elevational view of the design of FIG. 1;

FIG. 5 is a rear elevational view of the design of FIG. 1; and,

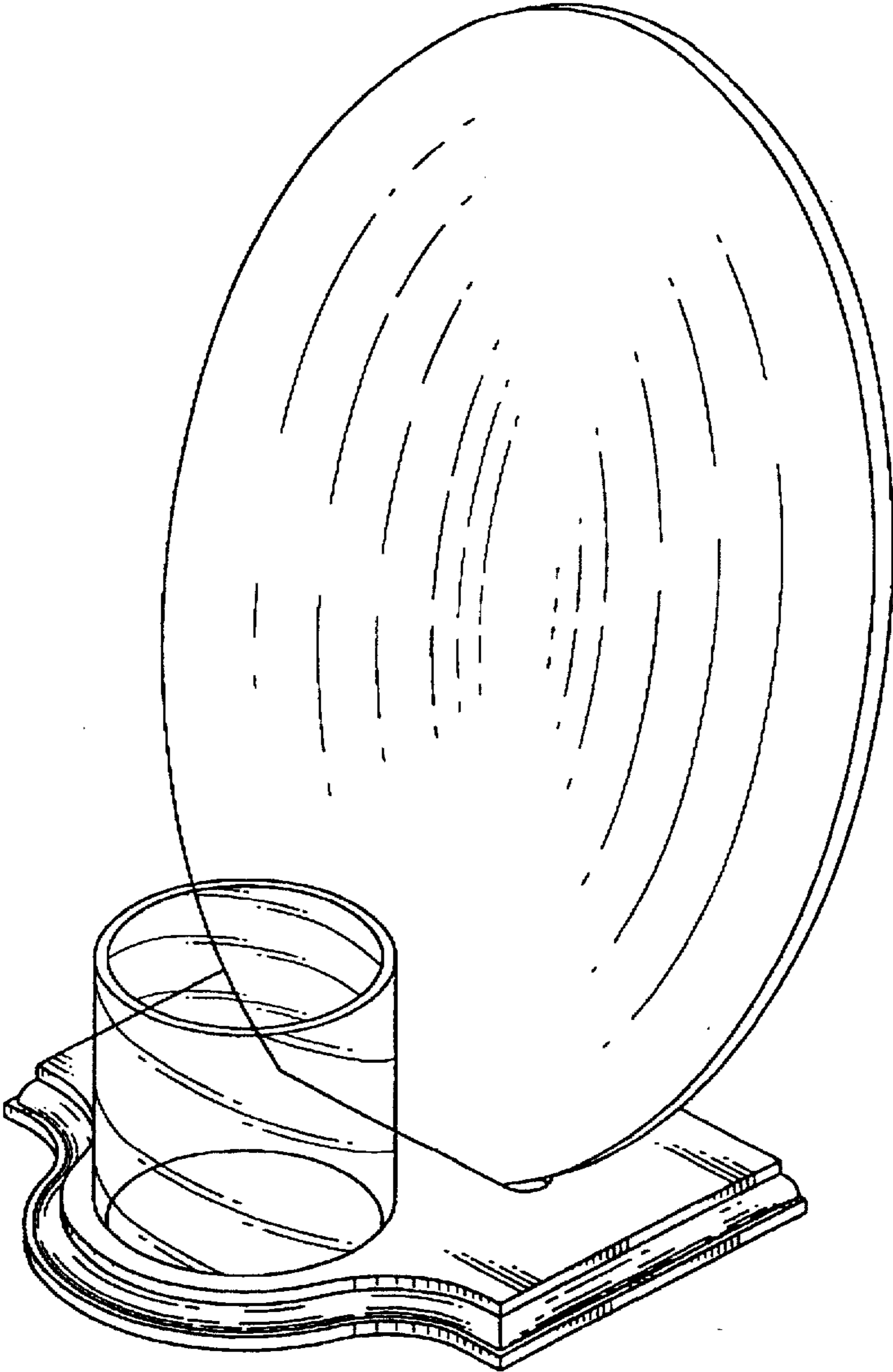

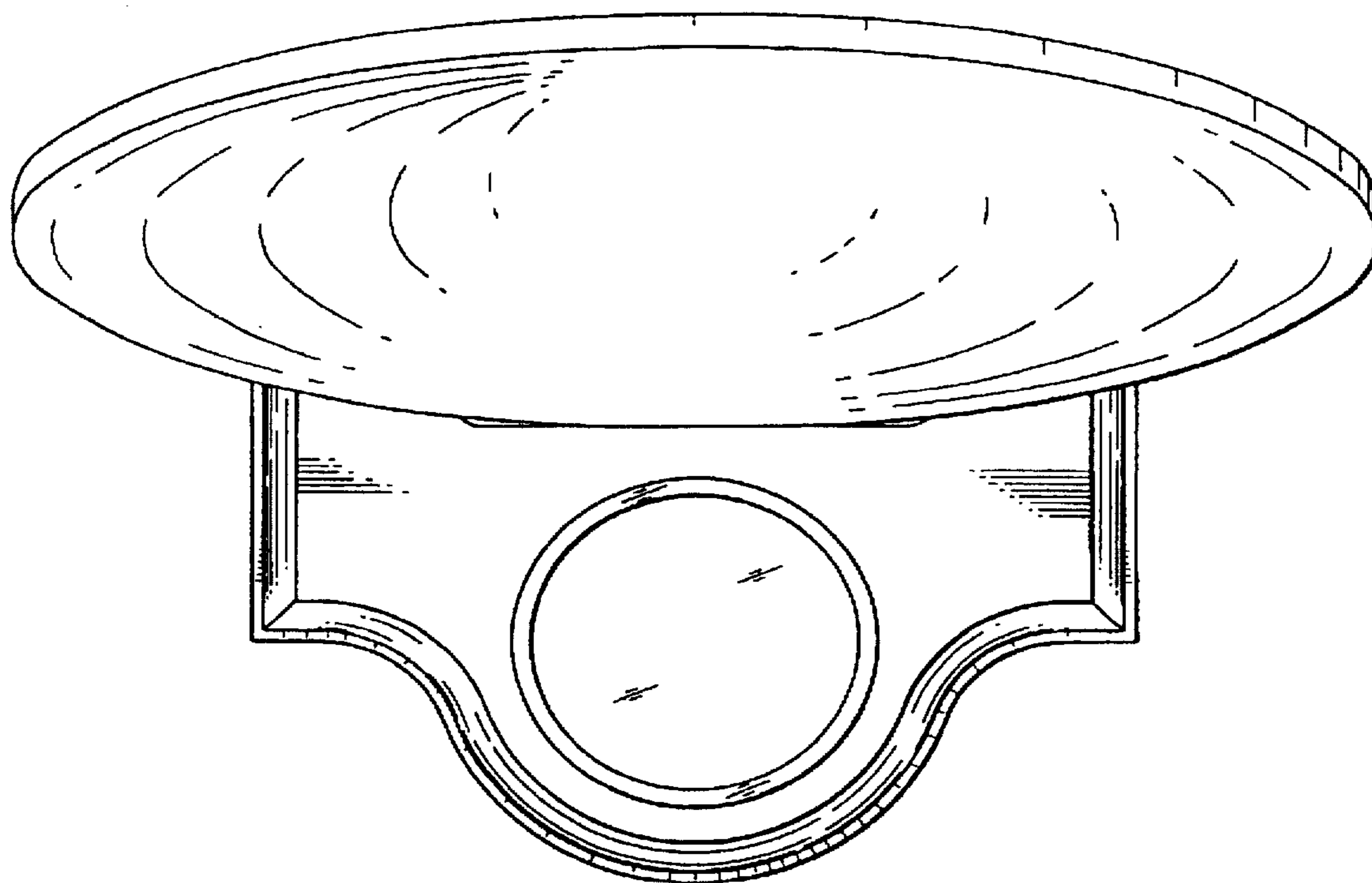

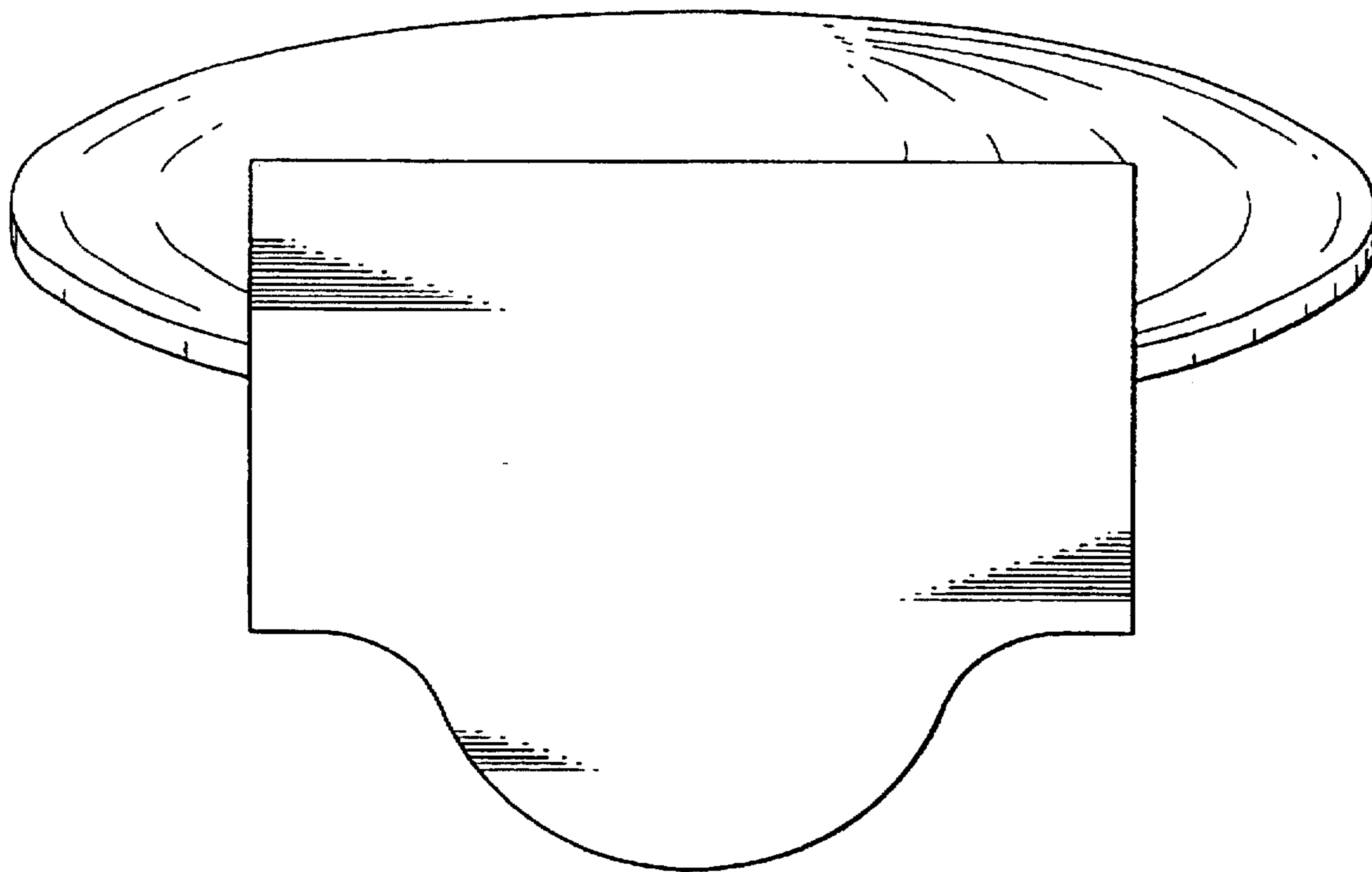

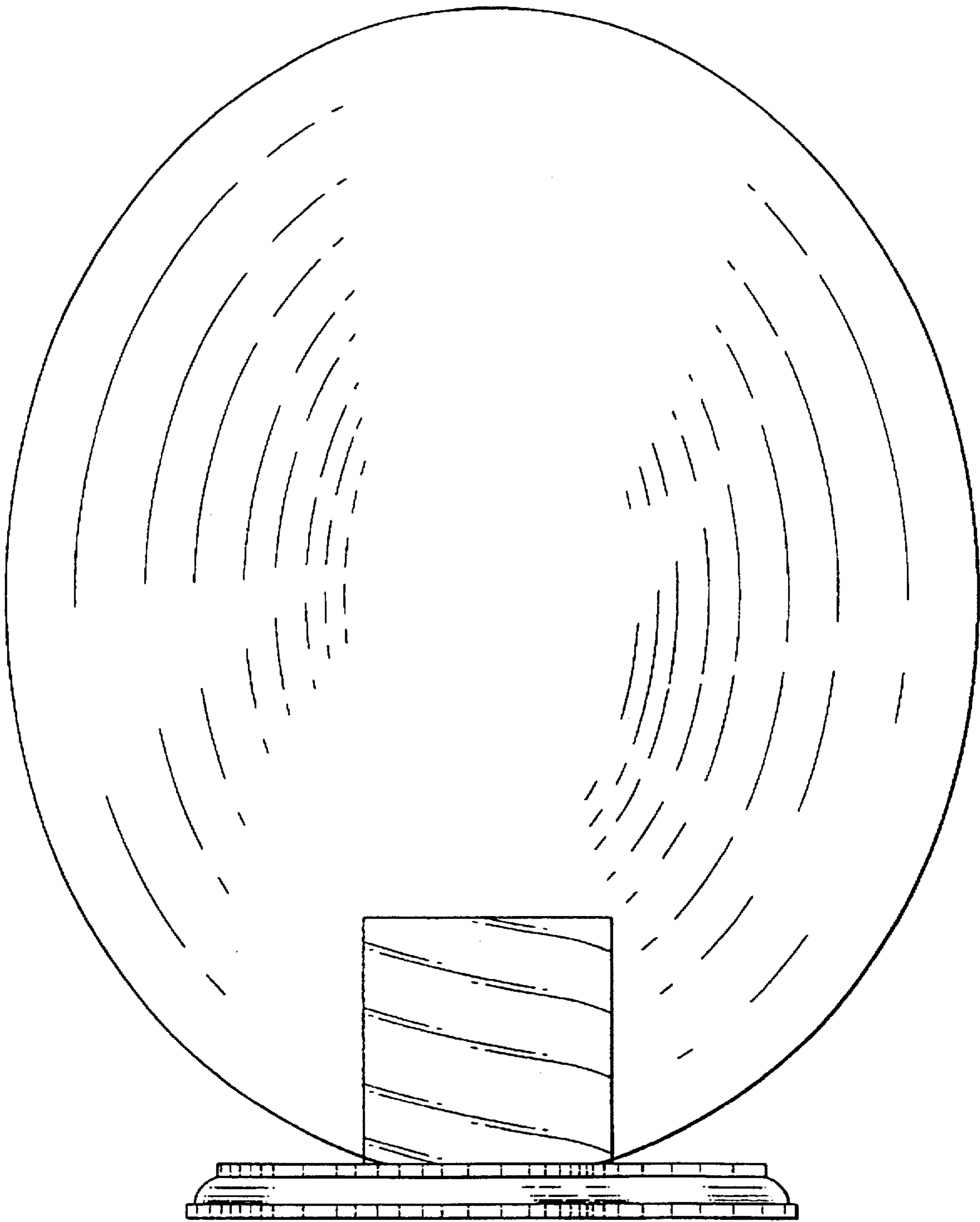

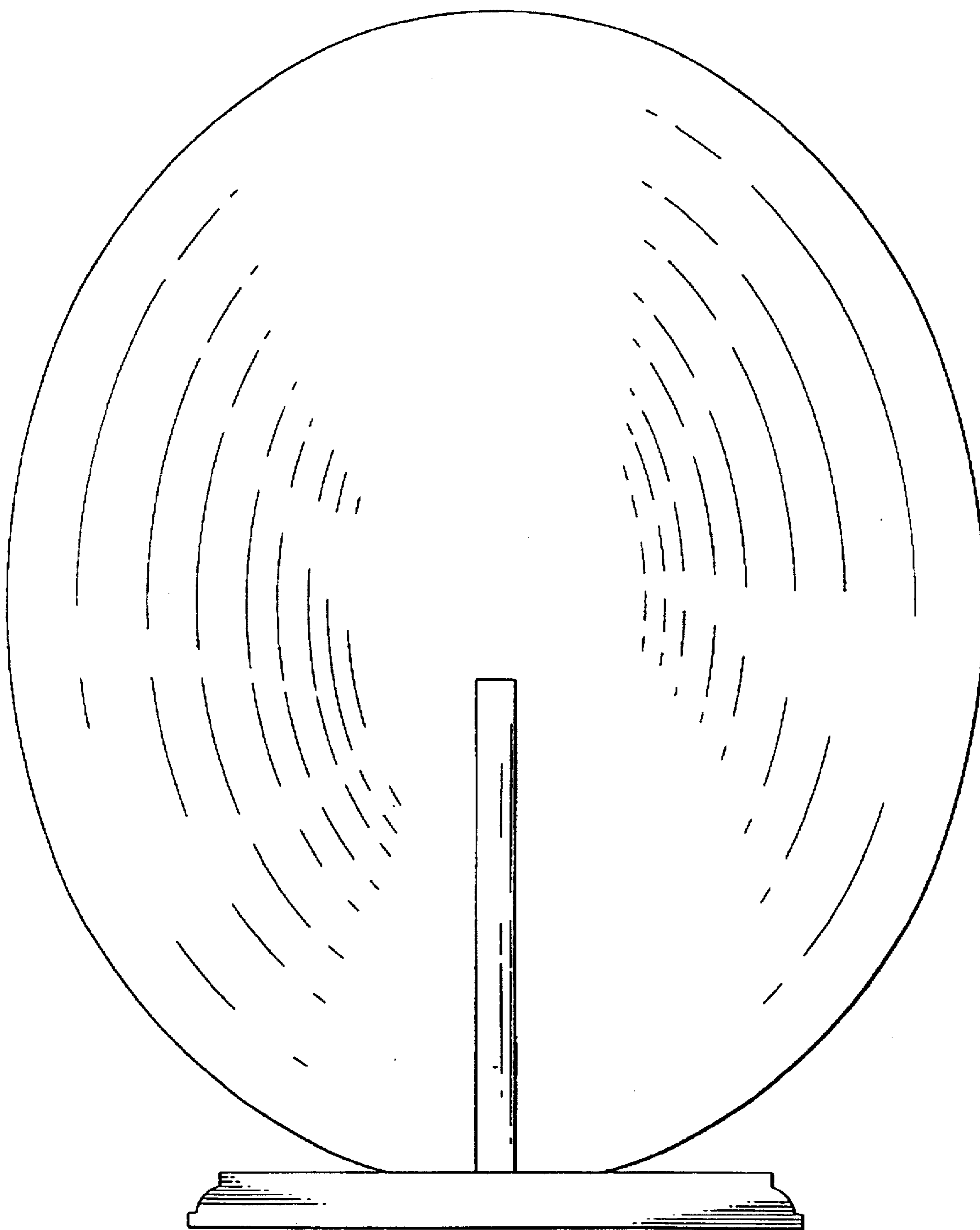

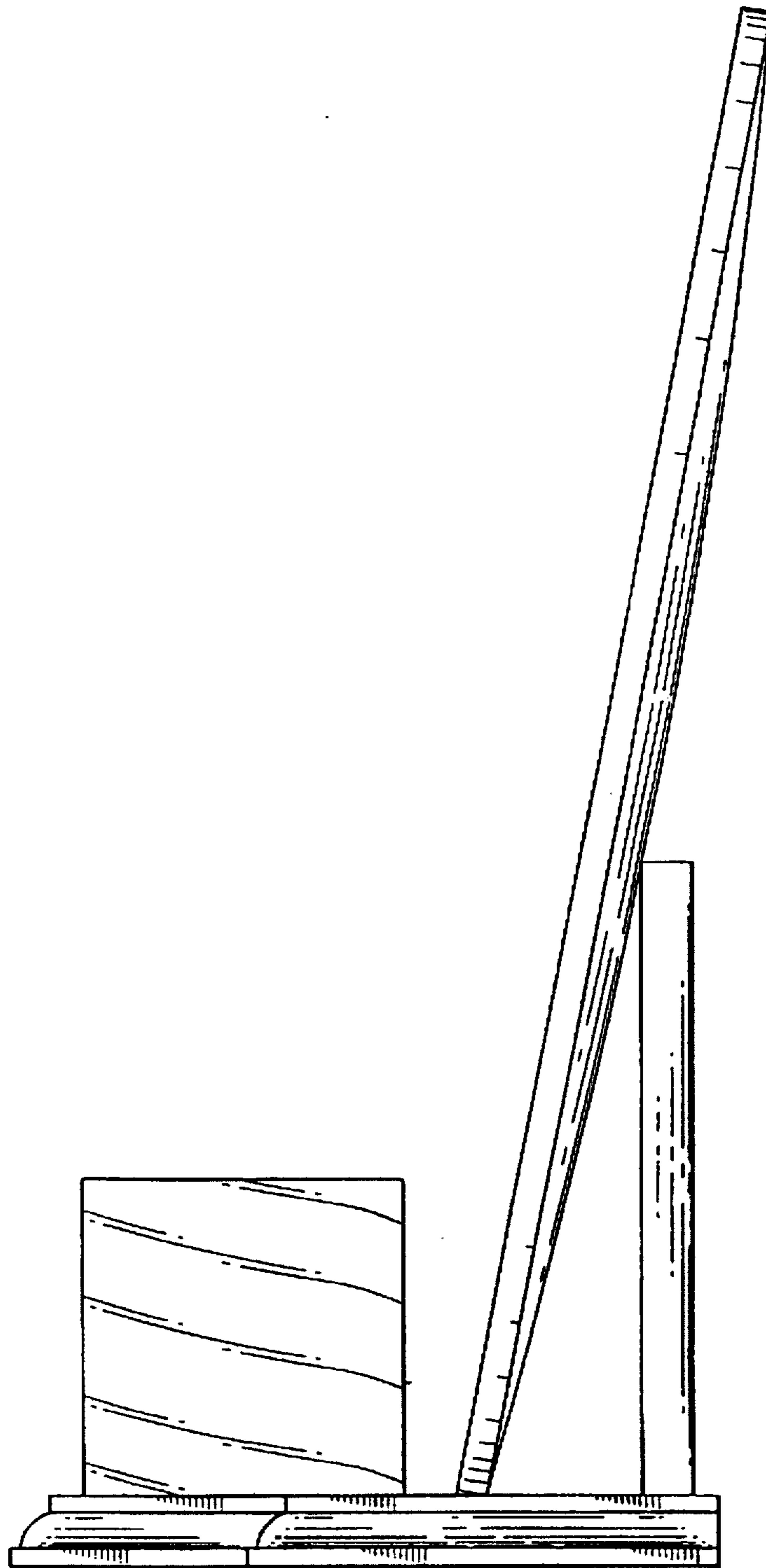
