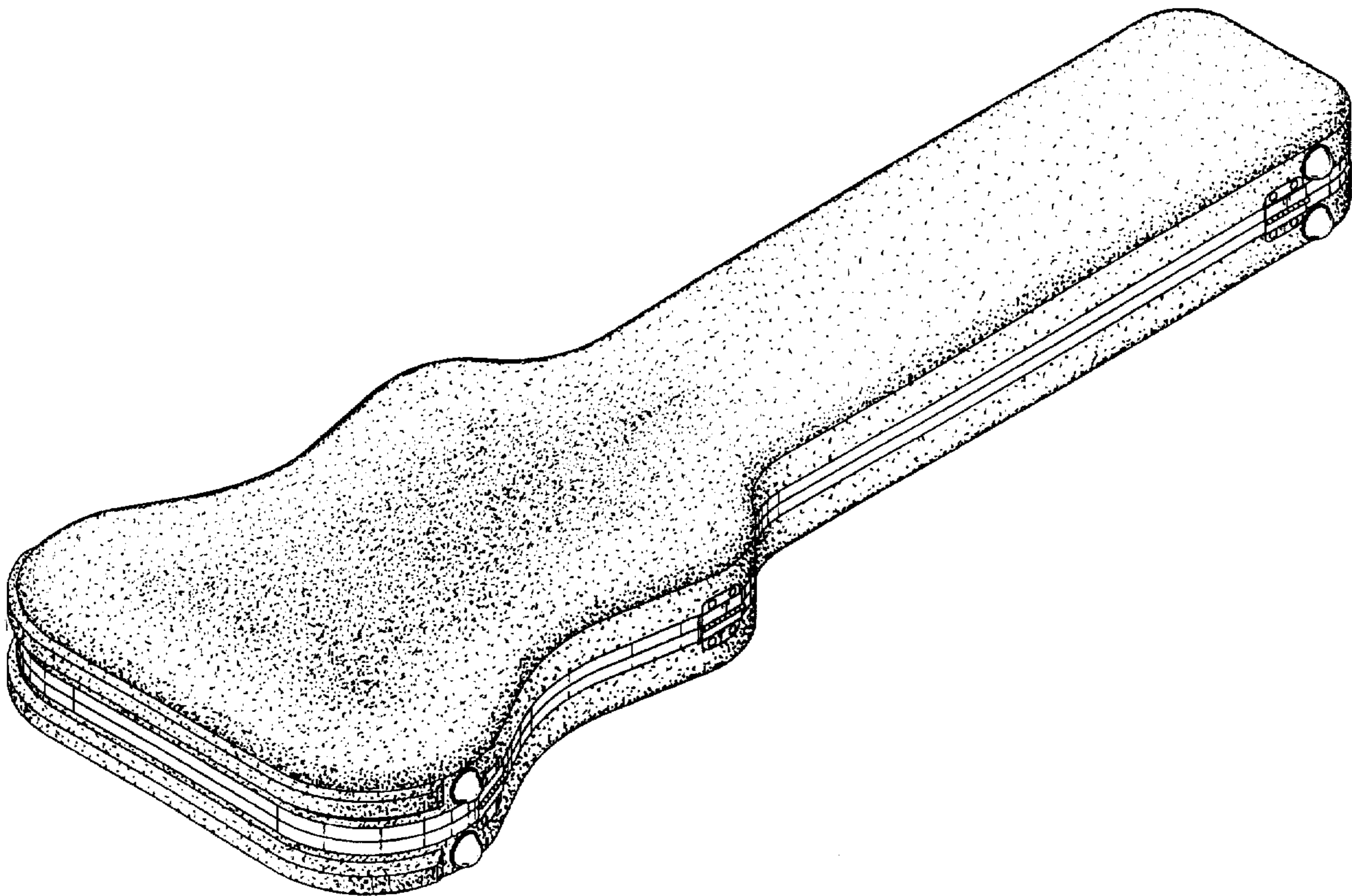
FIG. 1 is a perspective view showing the lower bout end (large end) and one side of the new guitar case;

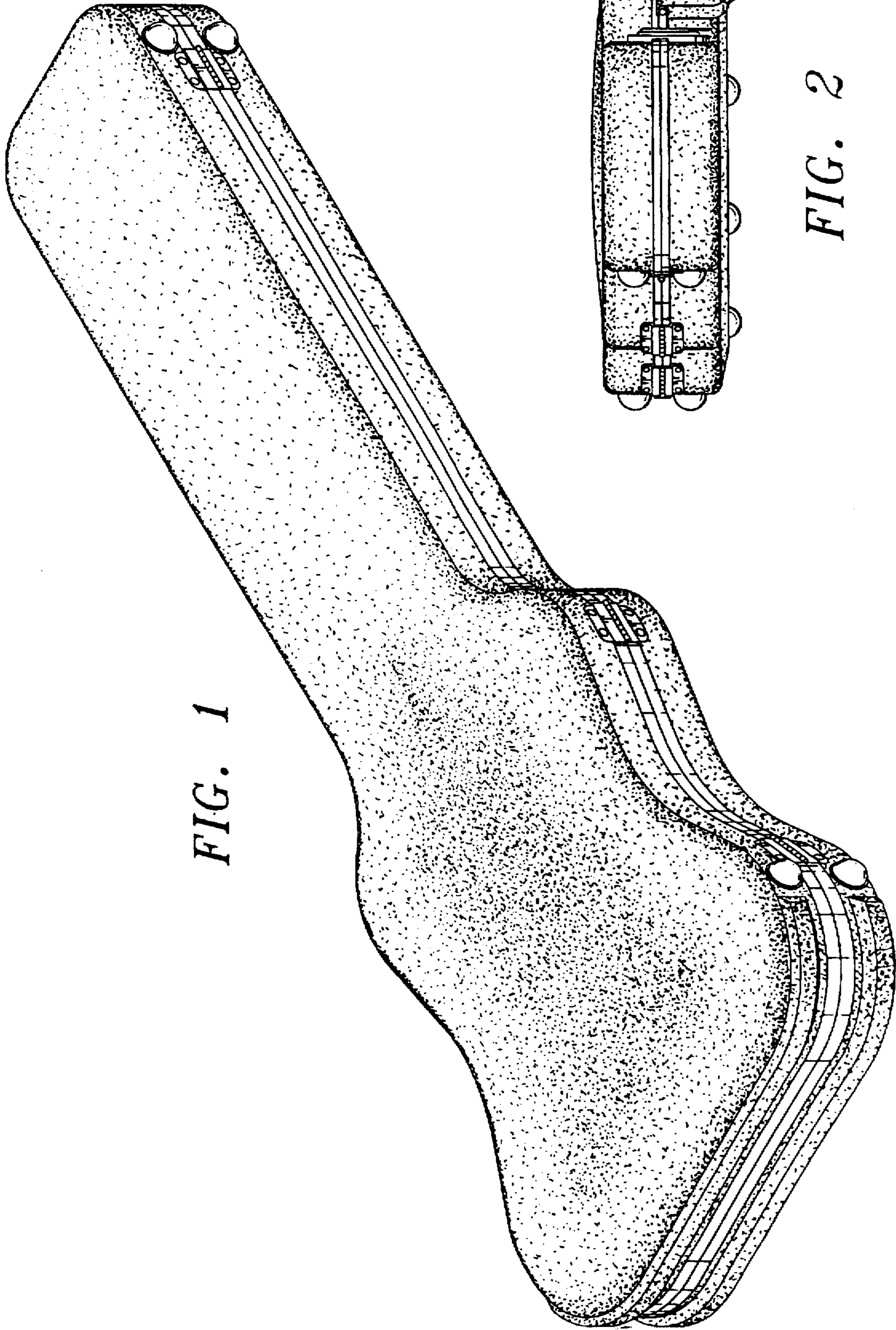

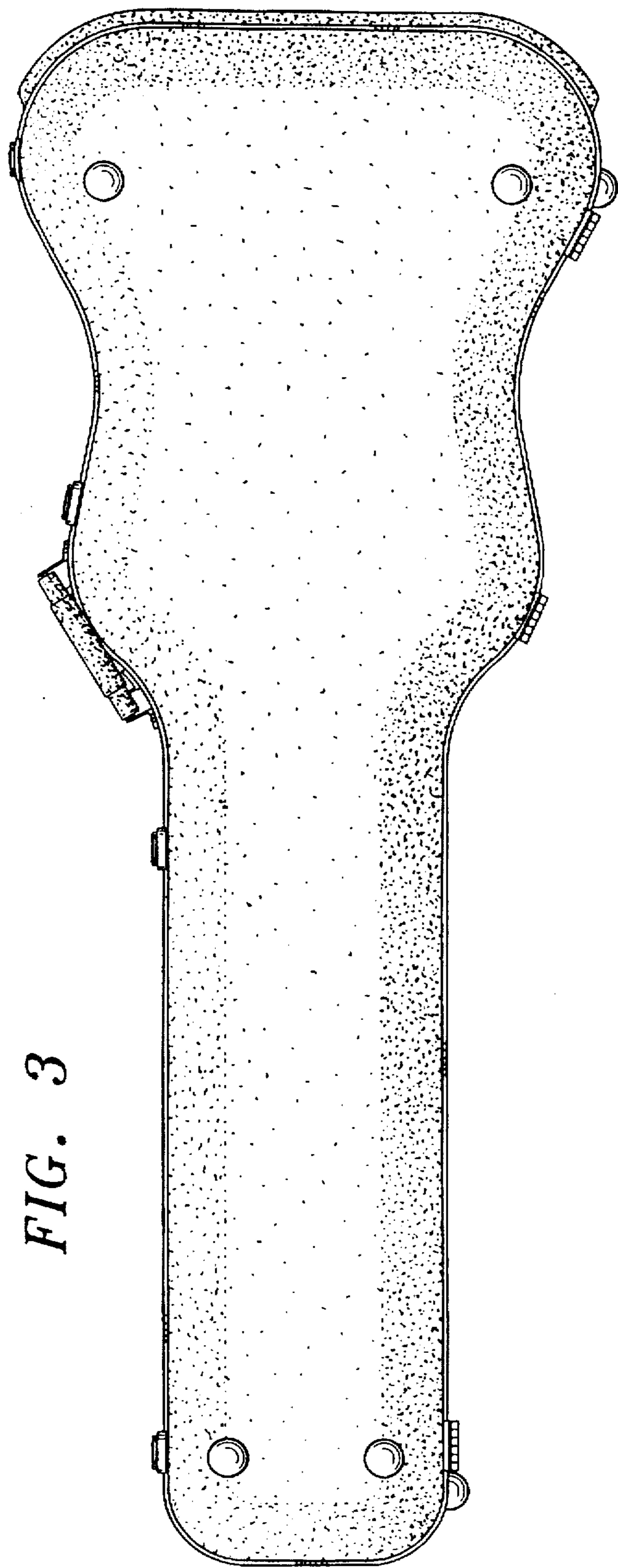

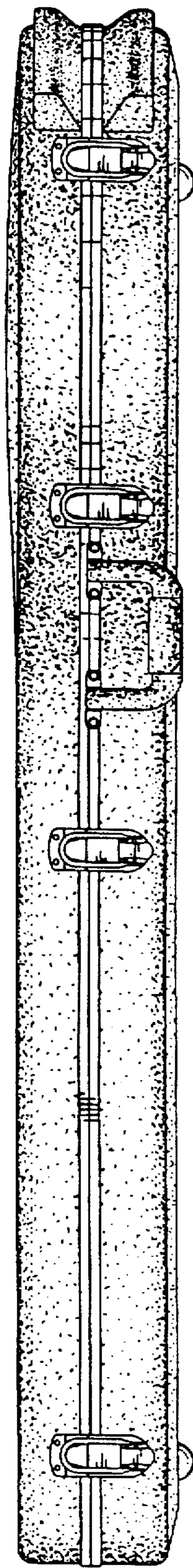
