DESCRIPTION

FIG. 1 is a front perspective view of the first embodiment of "a kettle" showing my new design;
FIG. 2 is a rear perspective view of the first embodiment thereof;
FIGS. 3 & 4 are side elevation views of the first embodiment thereof;
FIG. 5 is a front elevational view of the first embodiment thereof;

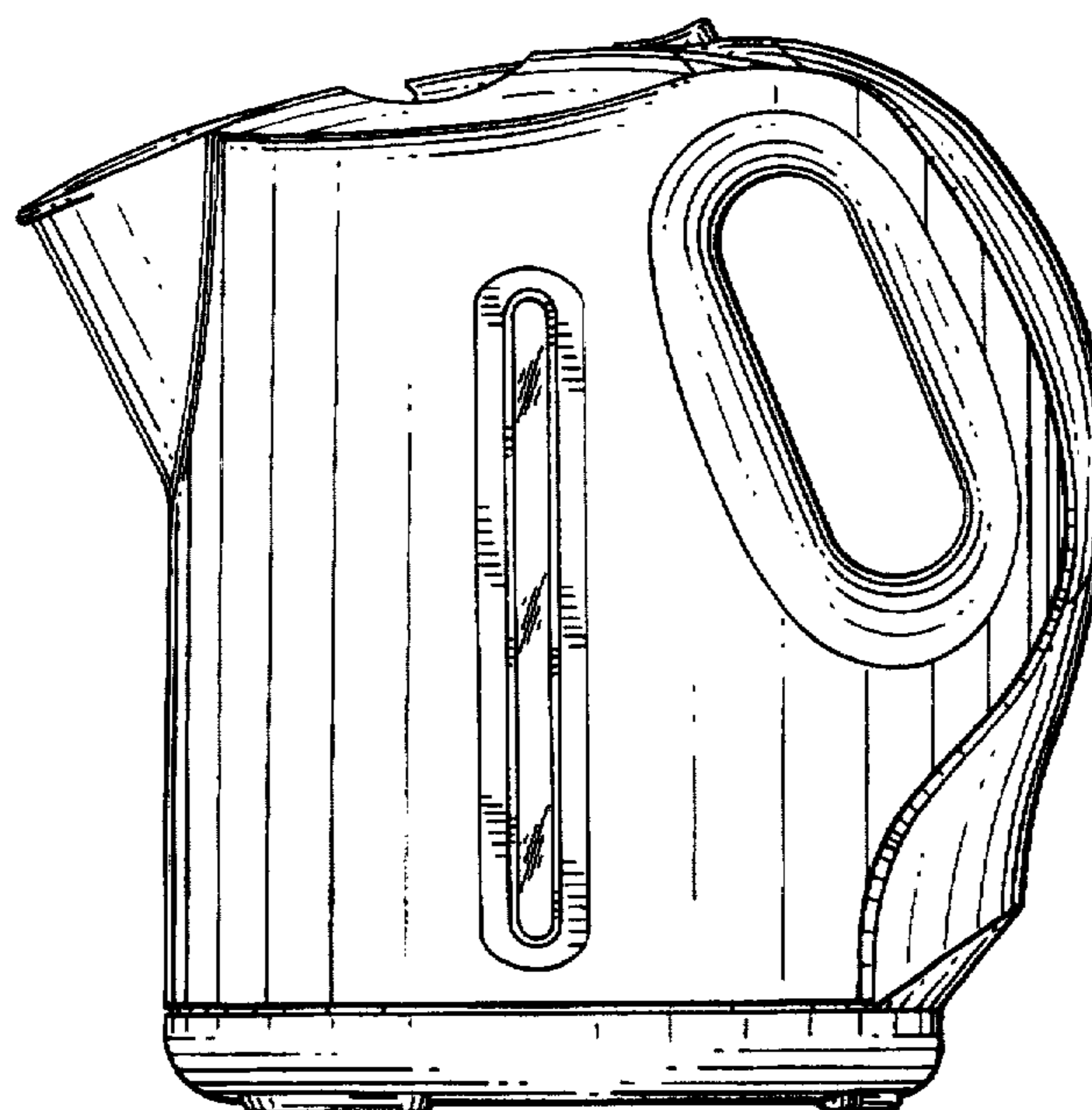

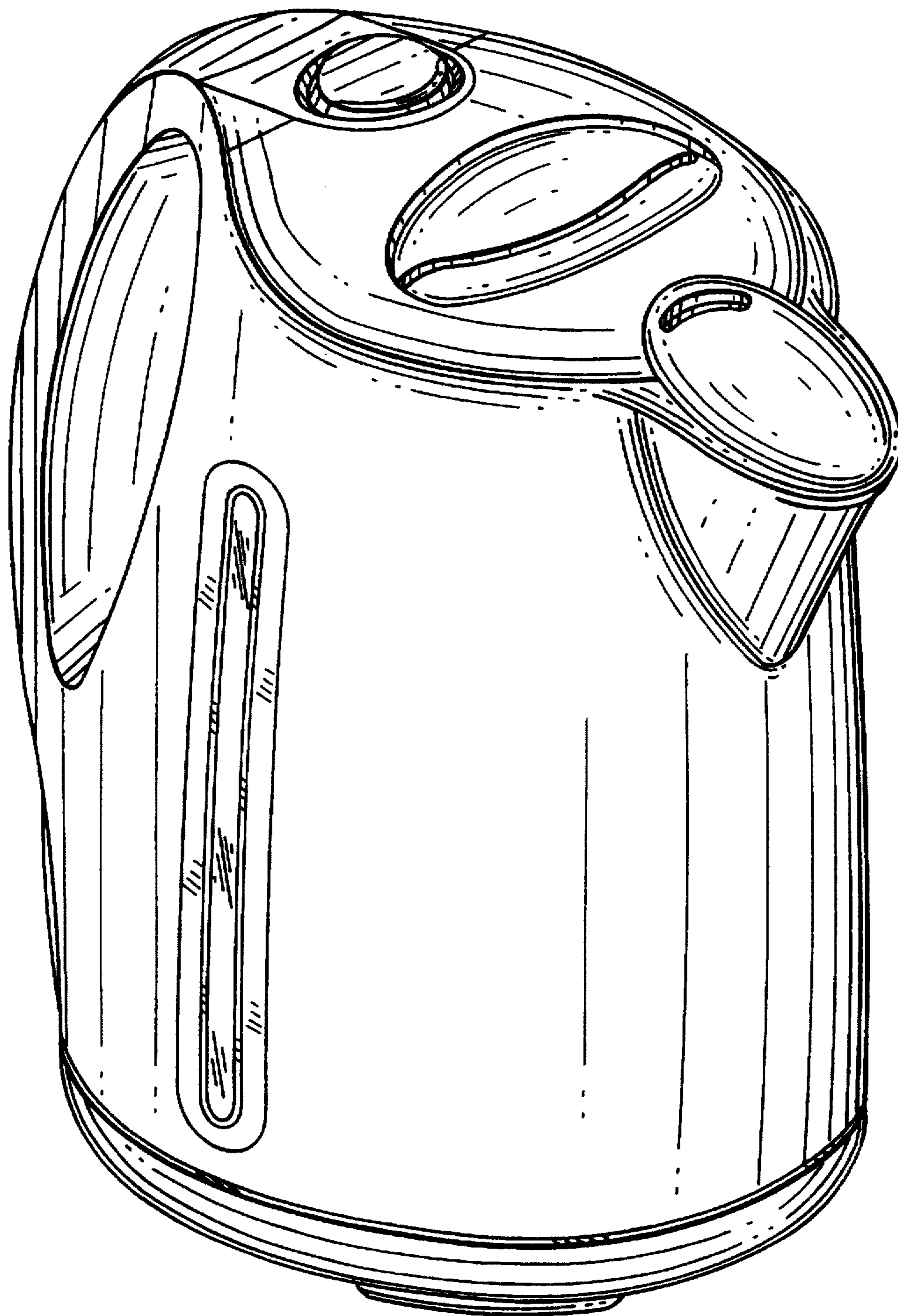

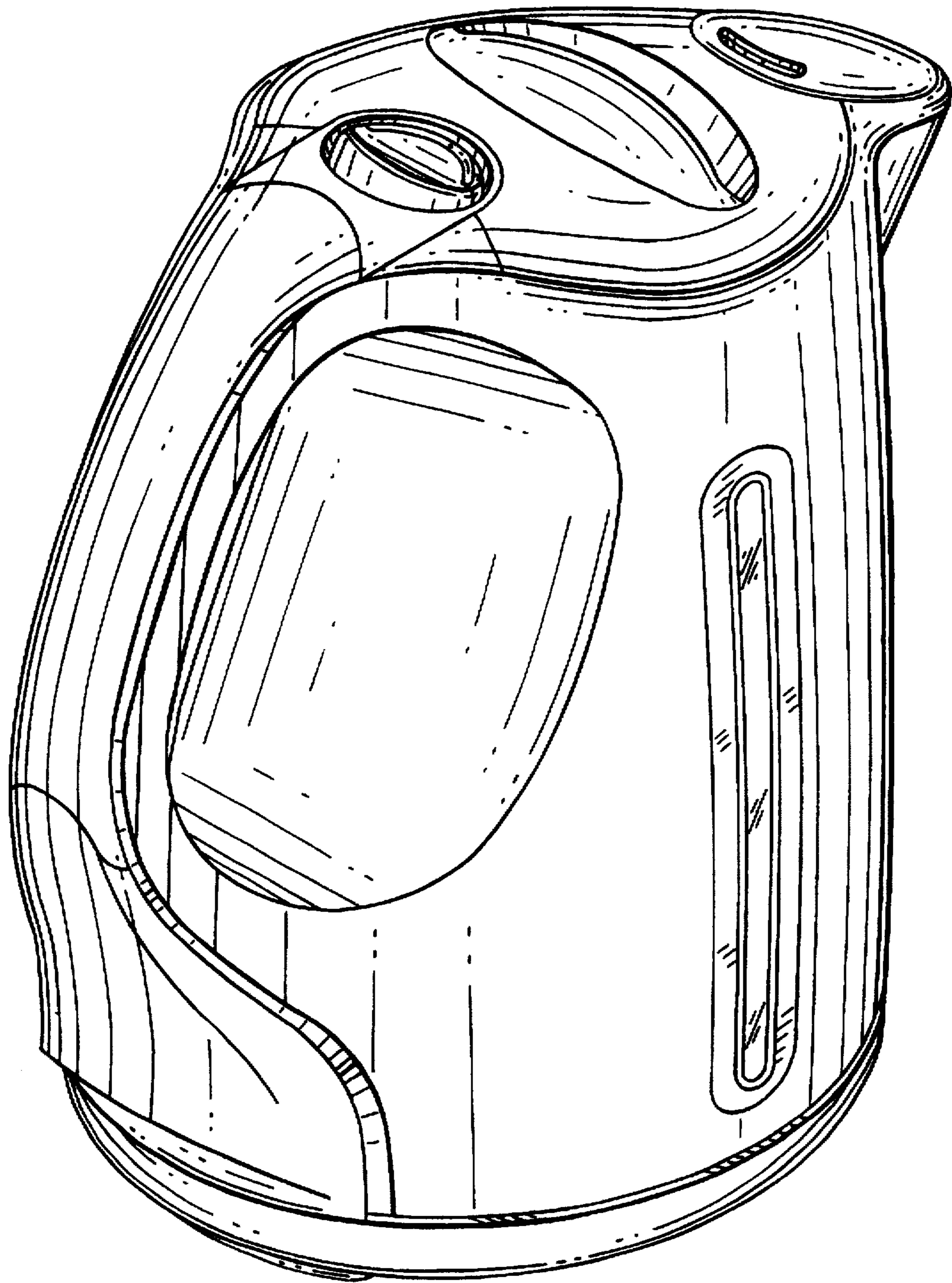

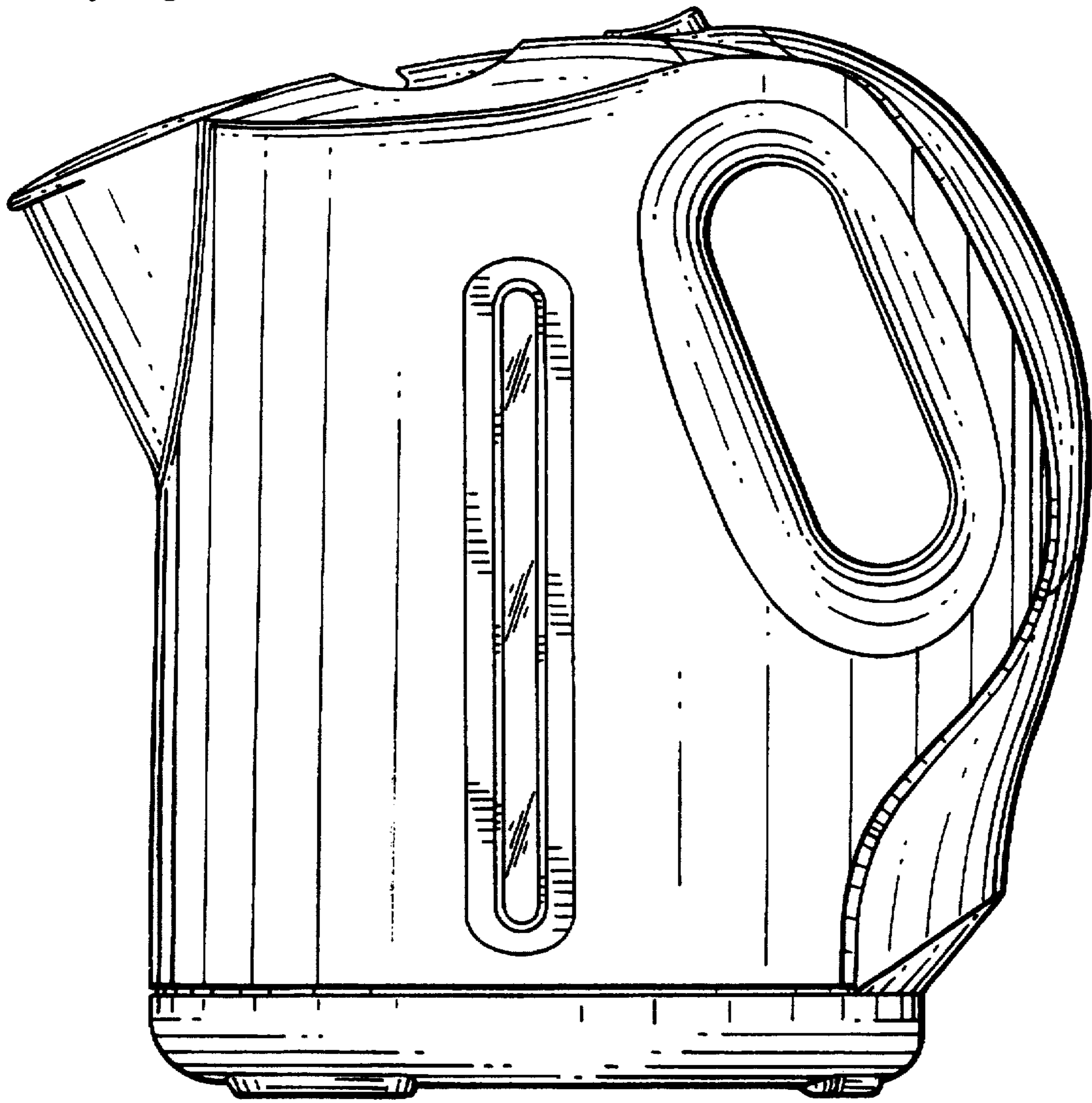

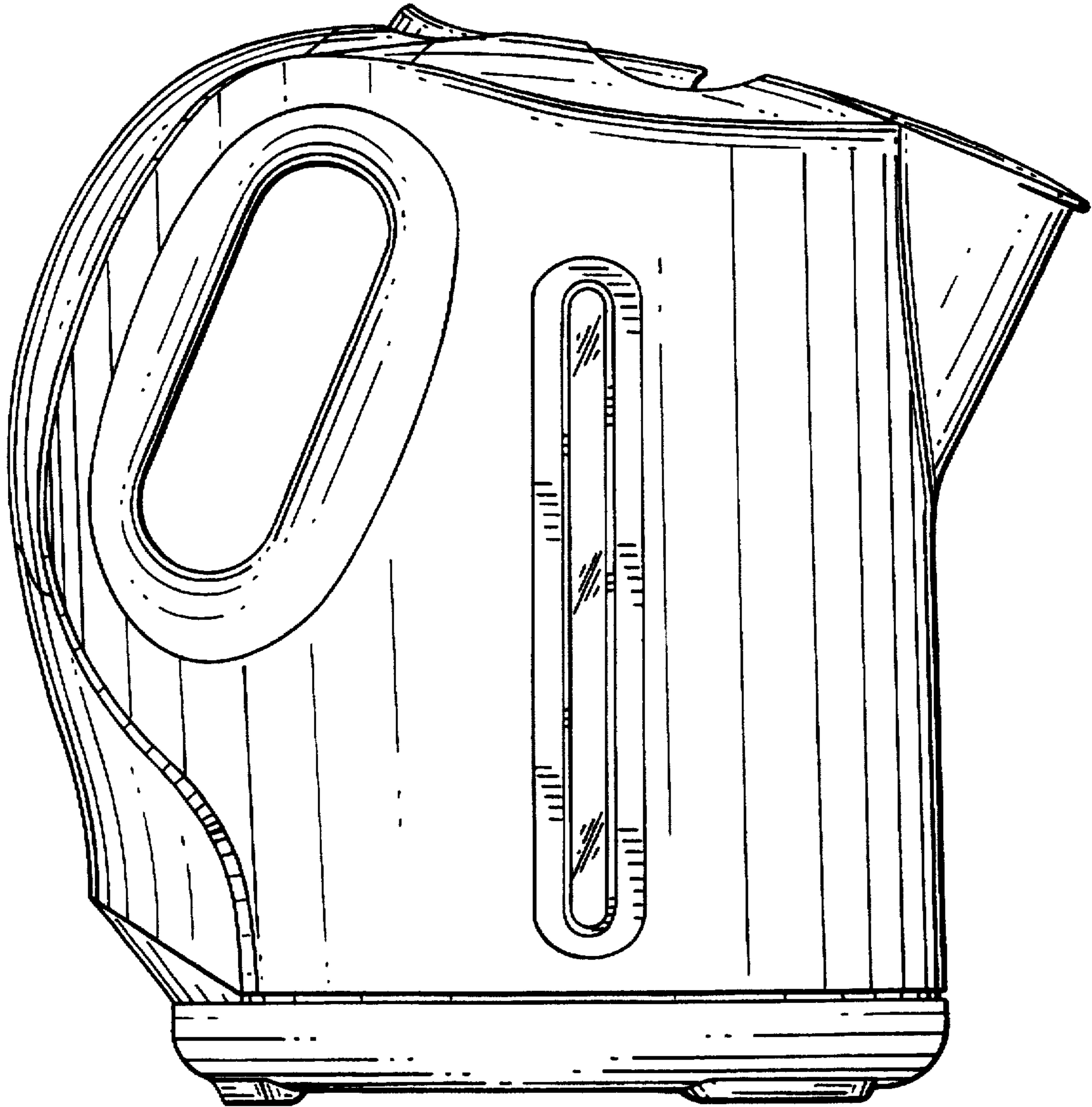

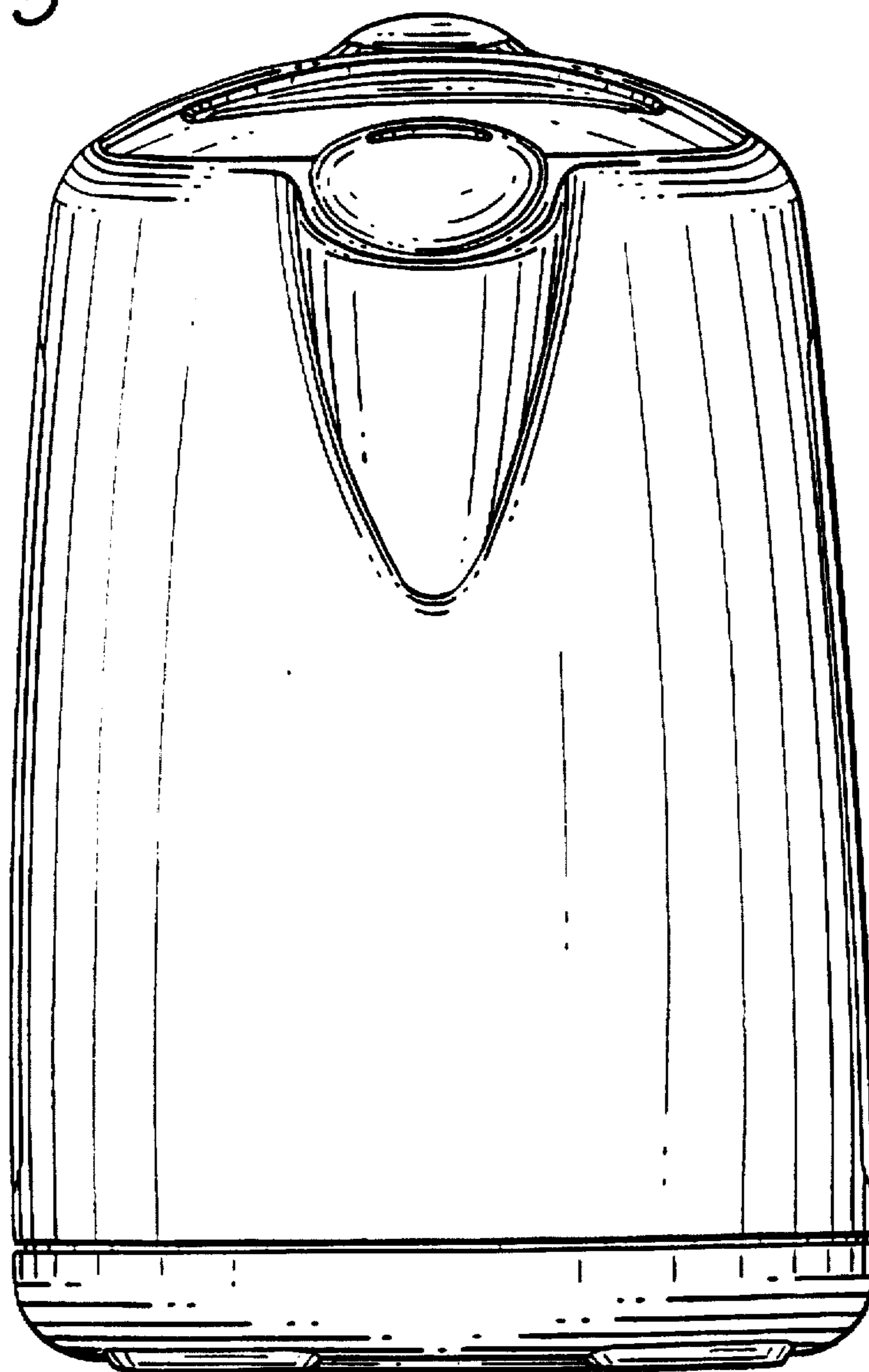
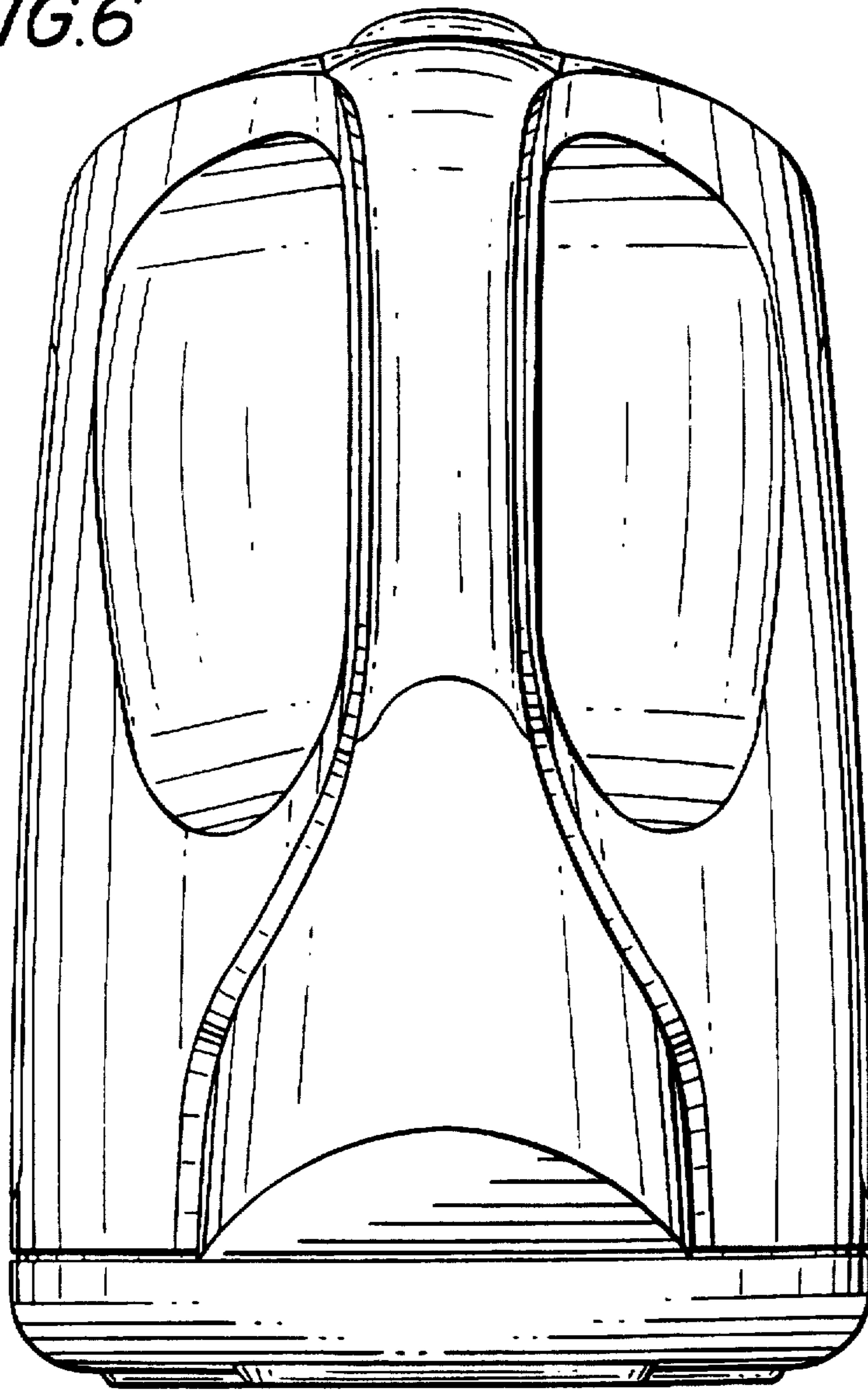

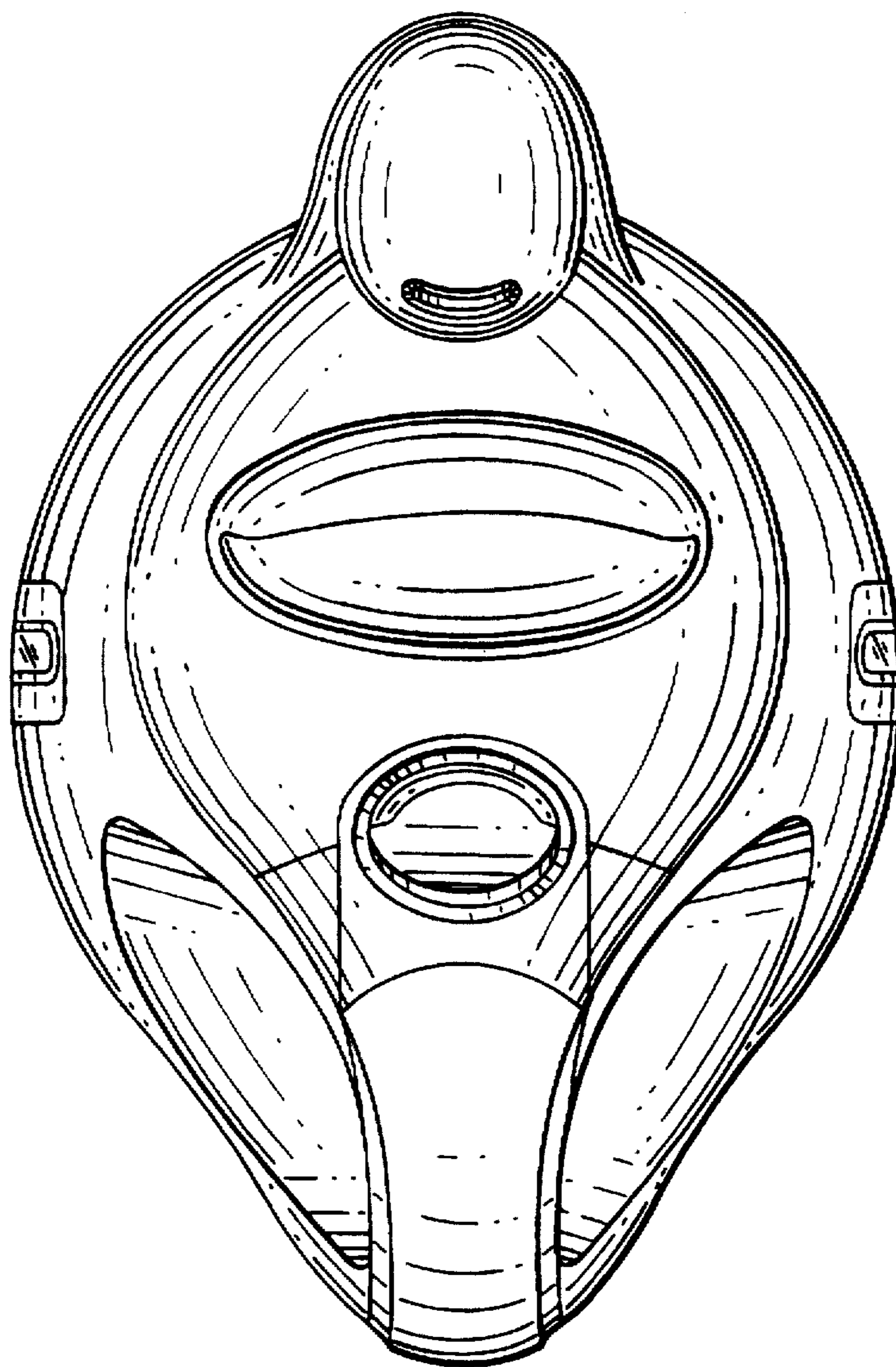

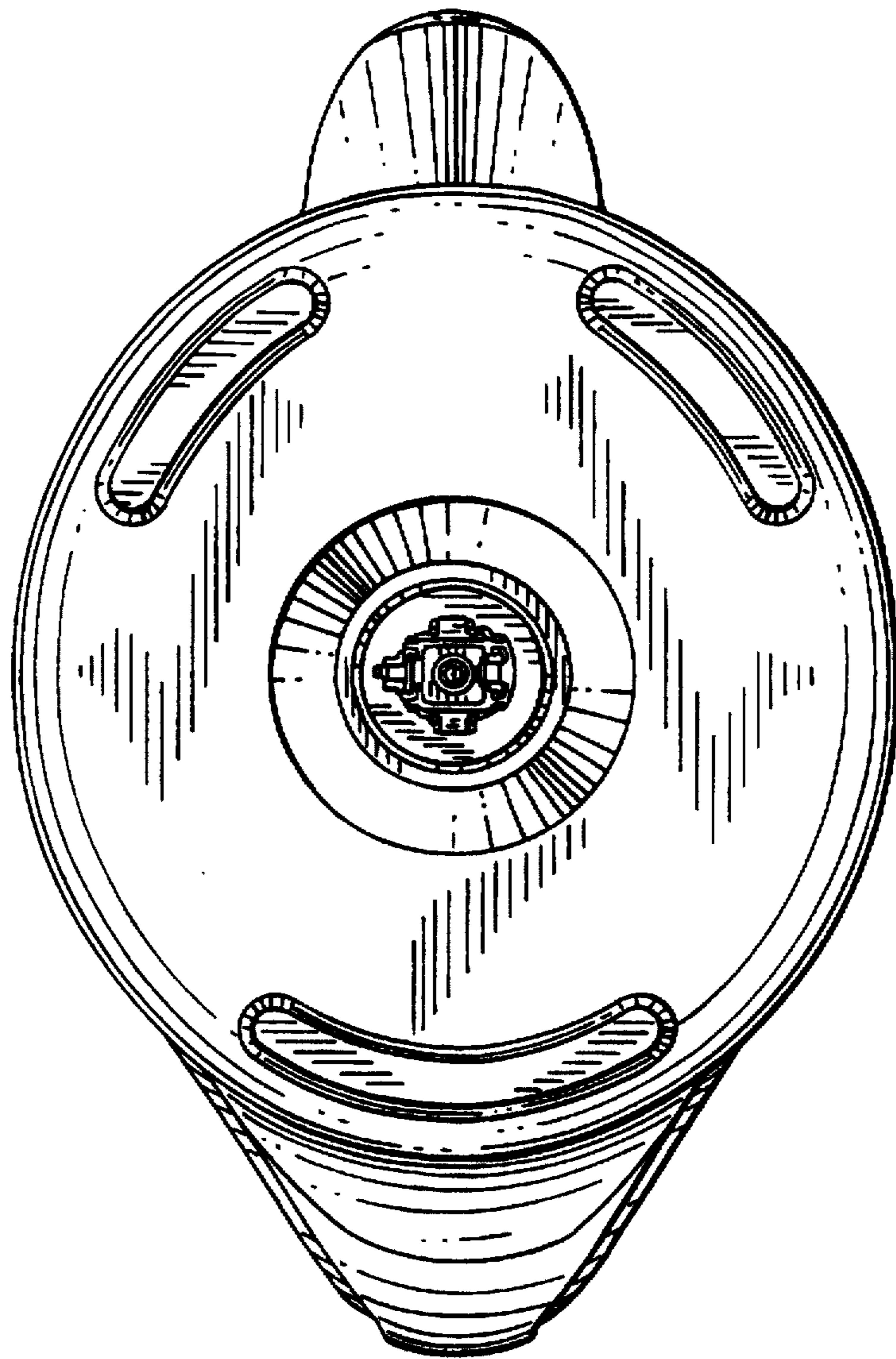

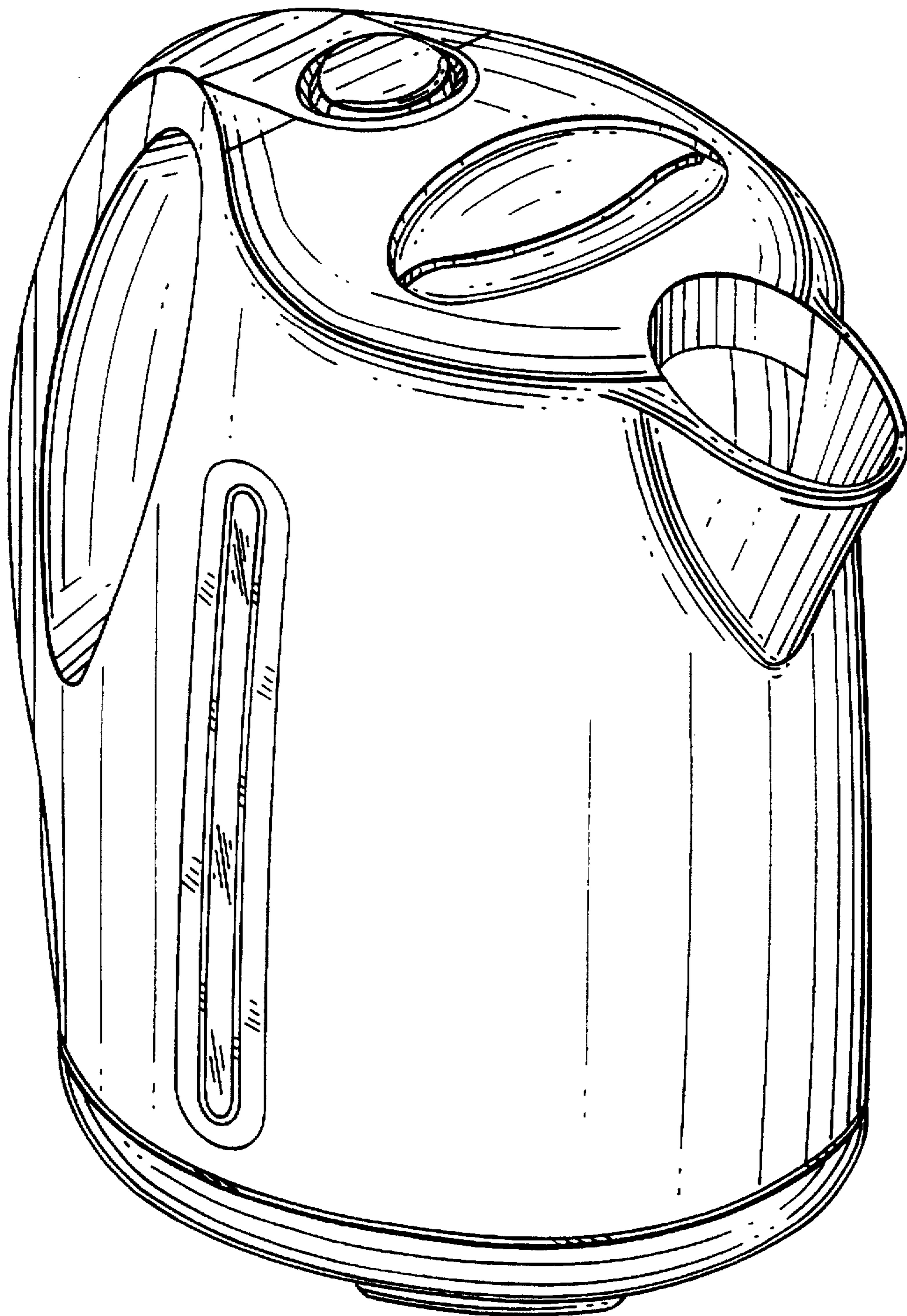

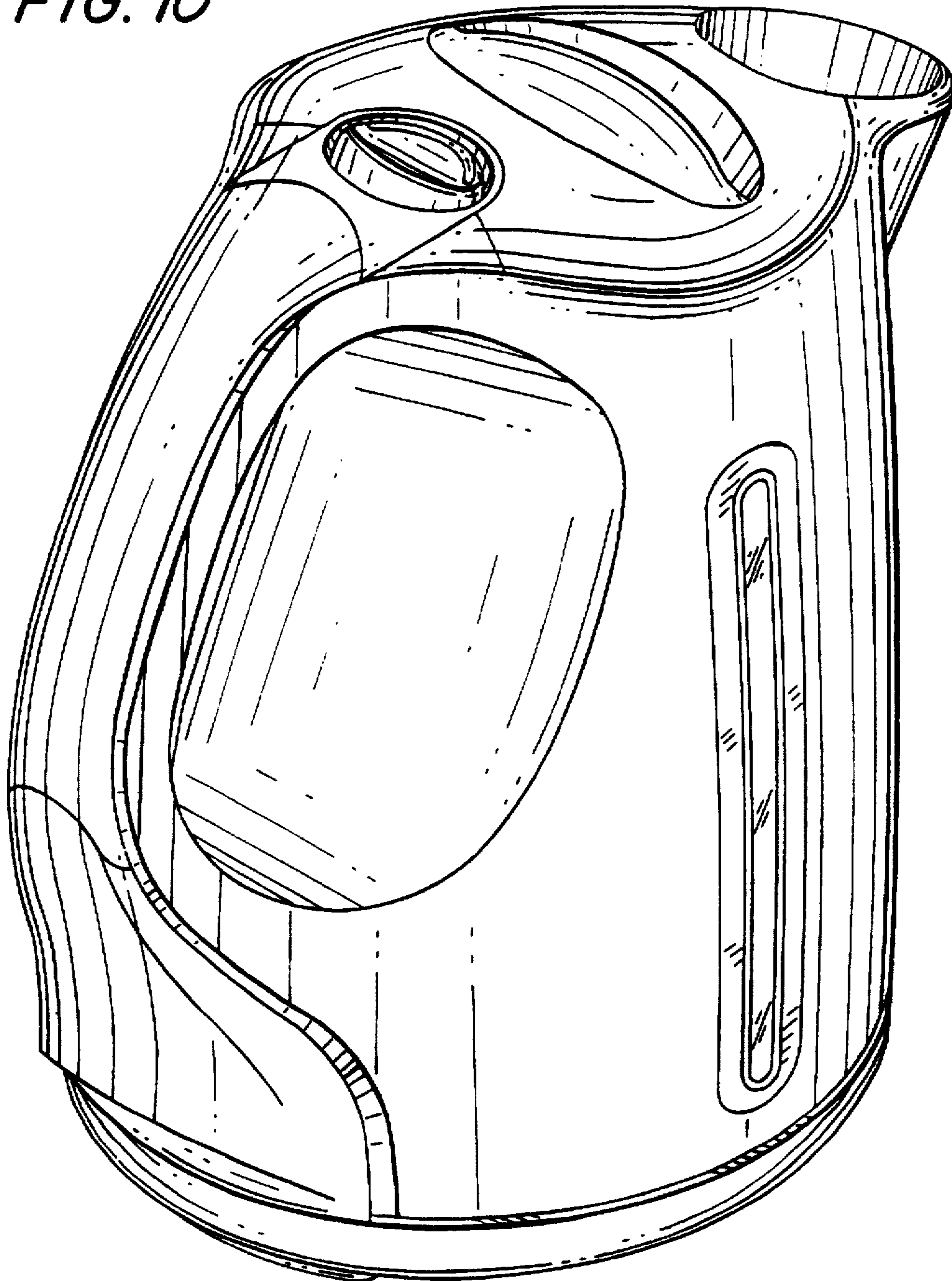

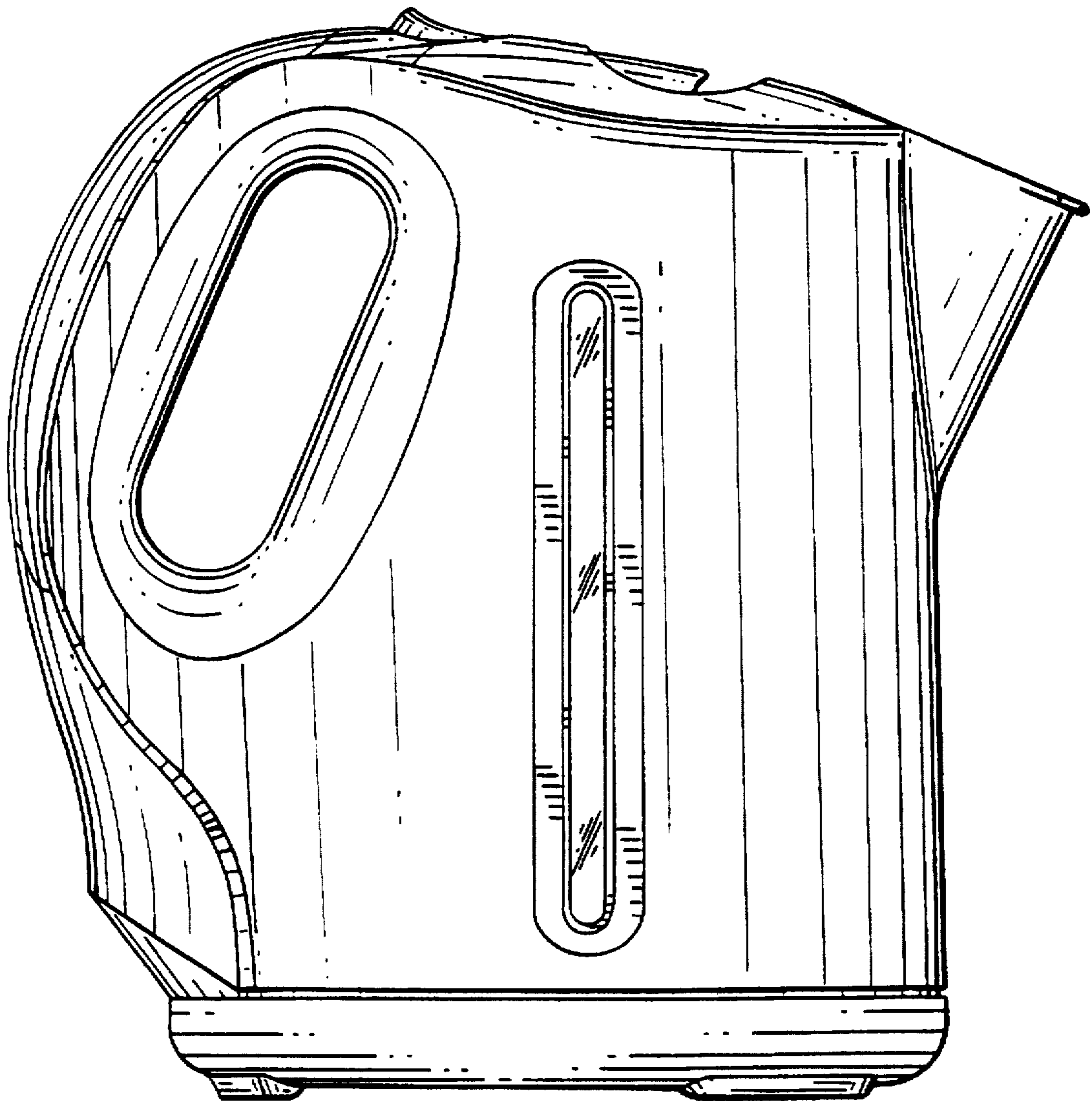

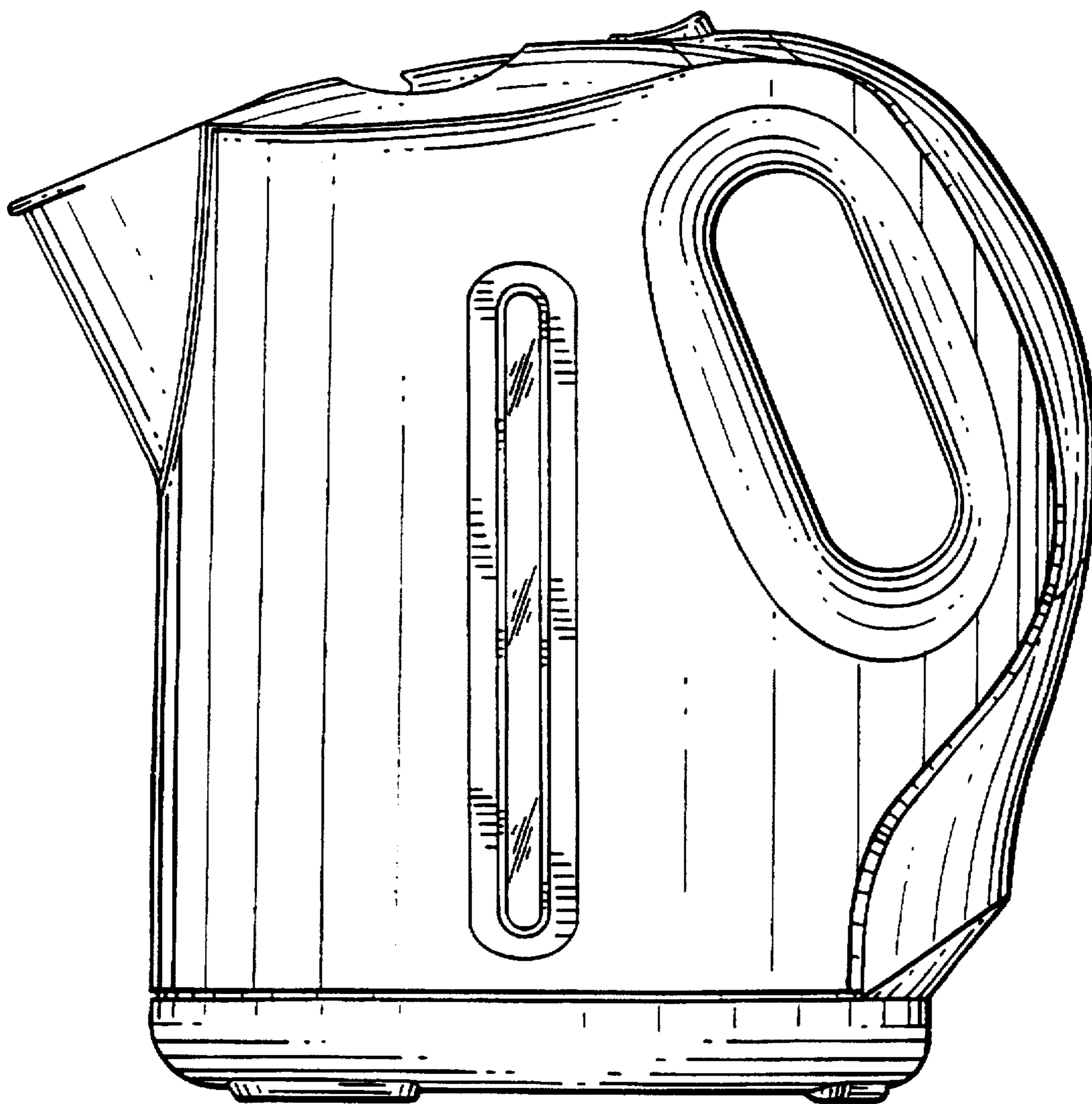
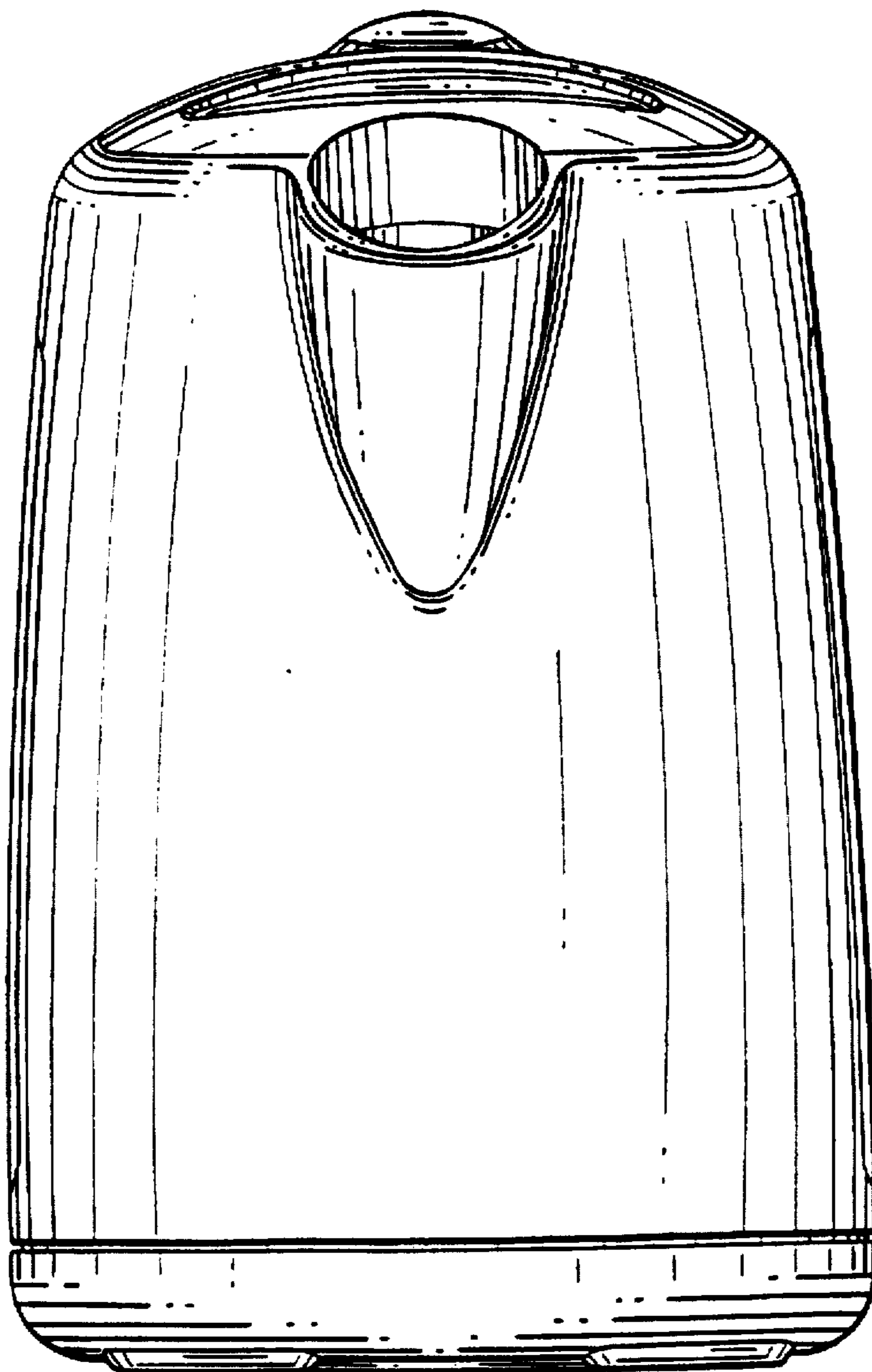

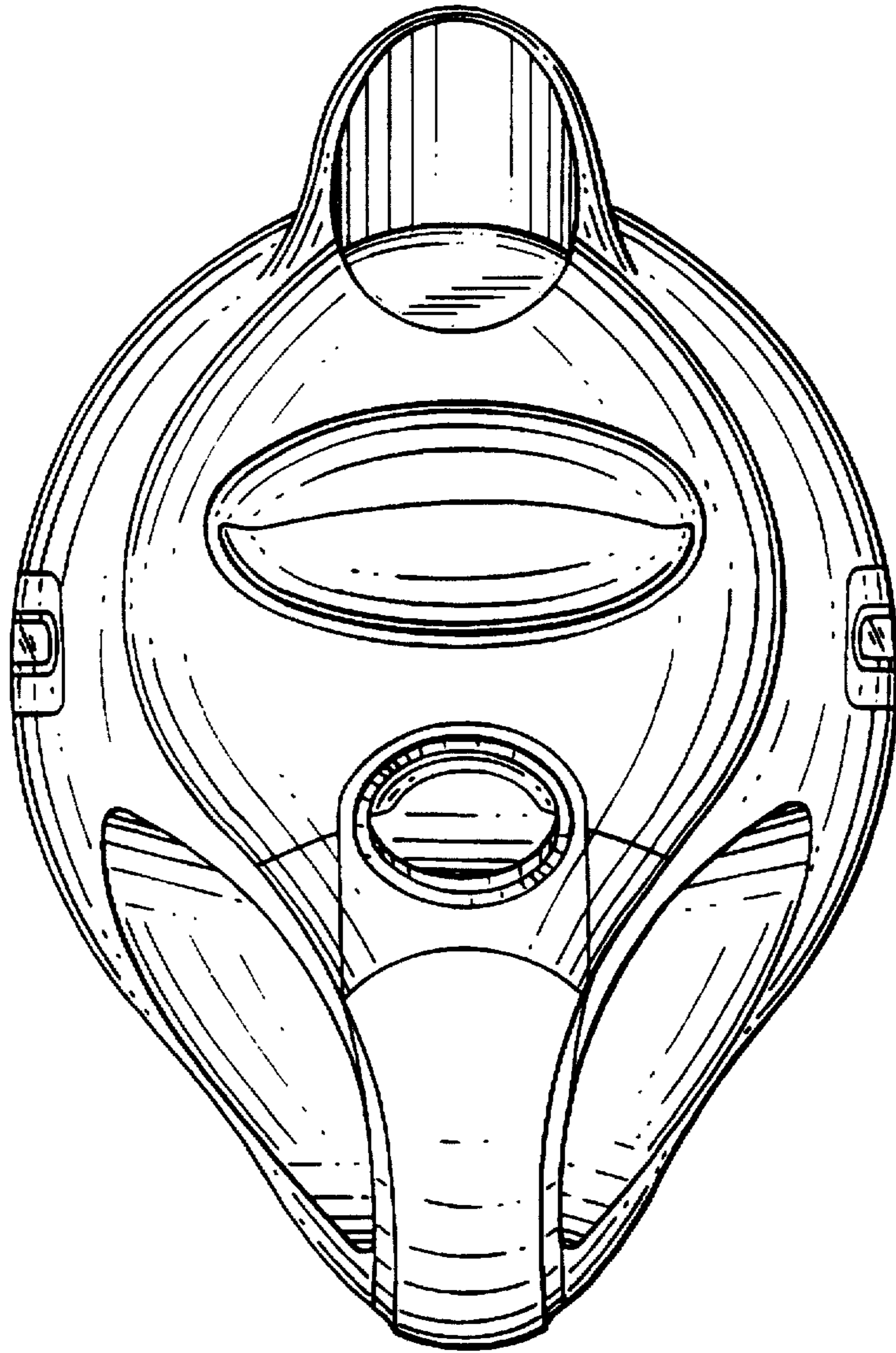
